Mention will be made of the club often during the three hours. The station would very much like to receive tape recordings; however, none can be returned so keep this in mind when sending them. Signal reports should, if possible, compare KSON's signal with that of KMBY, KROY or whatever the listener usually heard before KSON went NSP. Also, KSEA-FM, KSON's FM affiliate, will simulcast. KSGE will conduct an exclusive f/c dedicated to IRCA from 0120 to 0230. They will be testing with very low frequency tone (60hz) and not regular 1000hz, so DXers be advised that extensive hum levels are to be desired in hearing this rare catch. A special part of this test will come between 0230 and 0440 when this powerful station will be off completely. -A special 2-phase system will be tested during this period in place of the normal 1-phase, non-directional system so use only battery operated gear to detect the subtle change in array. Cyprus The BBC relay on 719 kc has extended its schedule, with s/off now at 1815 instead of 1600. The additional time is being used, experimentally, for the World Service. This is due to continued interference problems on 1421 kc. While its a little late in the season for really good TA reception during this sunset period, IRCAn on the extreme East Coast might have a chance for BBC Cyprus at its new s/off time. (C.M. Stanbury)

Changing Times Department According to information just received, even non-classified equipment has now been developed which brings the construction time for a portable station down to a period at leasting that one day miracle-- to be specific, a complete 300 foot antenna system which can be made fully operative in 72 hours. The system is manufactured by British Insulated Callendars Cables (presumably there is also an American version available commercially). In 1967 it was used by the BBC at Daventry while their regular 750 foot mast on 647 kc was being altered for the Radio 3 service. The BICC system was not only just erected in three days, but also tuned and powered in that time. It seems that the only remaining technical problem preventing any high powered station from going on the air anywhere is an effective ground system which the BICC gear does not solve for all locations. (C.M. Stanbury II)

Art Peterson Asian ID Tape According to Art's note which accompanied the tape, I was the first to get a copy. Believe me, I was fascinated by this three hour tape which is divided into three sections: almost two hours, first of all, of various stations and their IDs; then a section of languages, and lastly, a selection of IS, etc. A tape like this would cost about \$8, if Gilfer put out one like this. You can get this for the bargain price of \$1. Just send a blank 7" 1800 foot tape and \$1 in check or money order (no cash) to Art Peterson, 2726 Rollingwood Dr., San Pablo, Calif. 94806. There is a special postal rate for tapes, so it should cost you about 12¢ for postage on the tape. No serious foreign DXer, especially one living on the WC, should be without this tape. You might have to wait for a while, since Art's job takes him away from home quite a bit.

Non-English Domestic List Several people have asked me if I want lists of all static broadcasting in non-EE, since it has been pointed out that in metropolitan areas, there are many stations which devote at least a portion of their time to such programs. I would like to compile as complete a list as possible. Primarily I would like those who broadcasts are primarily in a foreign language. JEP, I think I have a list of the Canadians broadcasting in FF, but I don't know if it's complete.

According to what I have been able to discover, sunrise in Bogota on March 11 would have been at 6:03 AM EST, well after AMG's reported reception. I'll try to come up with more information on SR-SS times worldwide, comparable to Ernie Wesolowski's maps for the US and Canada. I'm trying to get hold of an article that appeared in the ASWIC bulletin describing one of their members' calculations of the times of Sunset for Far Eastern stations.
