Hi Gang. And welcome to the very first Questions and Answers column yours truly has ever attempted. First, if you have any questions relating to DX'ing, IRCA, or whatever, send them to me at the above address and I'll do my best to answer them. However, please be sure to include return postage or (even better) a self addressed stamped envelope. And be patient. I'll try to answer everyone as quickly as possible but you may have somewhat of a delay if it takes a while to find the answer to your question or problem or if you caught me at a particularly busy time. Also, any articles you may care to write are also welcome, if they deal with one of the following areas -

- 1) Articles of interest mainly to beginners. How to write reception reports, how to log Latin Americans, etc. etc.
- 2) Articles relating to the "skill" aspect of DXing, such as how to drag yourself out of bed at three A.M.
- 3) Simple technical articles or equipment reviews. I'd like to use this column to present receiver reviews, as well as perhaps simple construction projects that just about anyone could make. So why not write a short review of your receiver and send it in. Another thing you might do is write a review on your tape recorder. These are a very valuable piece of equipment which most DXers have or would like to have. Keep in mind tho, that your tape recorder review should focus on it's use as a piece of DX equipment.

By mutual agreement with Bill Hardy, I'll be handling the above areas while Bill will continue to focus on articles about stations, FCC rules, history of DXing, etc. So, without further ado, lets get into a couple articles.

HOW TO LOG LATIN AMERICAN STATIONS

Someone asked in DXM recently how to go about hearing and identifying Latin Americans. Actually it's pretty easy once you get the hang of it. The following suggestions should help, and some are useful for hearing stations in other parts of the world as well.

The first step is to read DX Worldwide very carefully. Check and see what is being heard in your area, at what time it is being heard, how well and how often. Make a mental note of them or write them down on a sheet of paper and keep it near your receiver. Keep in mind which frequencies are usually blocked by strong domestics. However, don't rule these frequencies out entirely as oftentimes auroral conditions can block out strong northern stations and let you hear Latins you would normally not hear.

The best places to listen are between the domestic channels (stations on these frequencies are called "splits"), on domestic channels clear of really strong domestic stations, in the null of domestic clears such as WGN, WLW, etc., or on a small number of regional channels. The Cubans on 590 and 600 are examples of stations you can hear in the latter case. There is no "best" time to listen for Latin American stations. On the east coast they start to come in around sunset and can be heard all evening and all night until local sunrise. Likewise in the midwest or west coast, although stations heard near sunrise are usually just Mexicans.

The important thing to watch for is Latin American music or Spanish talk. Don't be discouraged if you don't hear anything on your first few tries. Conditions can change radically from day to day and some evenings latins will be pounding in where nothing was heard the night before.

Once you've latched on to a station stay with it, even if it fades out. Like domestics, they have a habit of fading back in again (at least sometimes.....). Anyway, the problem now is to hear an ID. Even though you probably won't understand 99% of what you hear, the other one percent is usually an ID. Somehow ID's stick out like a sore thumb. Sometimes you can recognize an ID by the "big production" sound to it or by a change in announcers (if the ID is prerecorded). Probably the best way to recognize an ID is simply by listening for a few key words. Many ID's begin "Este es.." (ESS teh ESS), "Aqui..." (ah KEE), or "Transmite..." (trahns MEE teh), and follow this with the call letters or slogan. At other times just the call or slogan is given.

Most slogans begin with "Radio..." (RAH de yo), "La Voz de ..." (La Bohss deh), "La..." (lah), "Ondas de (or del)..." (OHN das deh (dehl)), or "cadena..." (Kah DEH nah). Cadena is usually associated with a network, since it is the Spanish word for chain. You may also hear the location, frequency, or other information about the station during the ID. Keep in mind that hearing a slogan sometimes is not enough to definitely identify a station. For example, there are about five "Radio Mil"'s on 1000 kHz. And hearing a city mentioned may not be enough. It may be part of a news item or the address of a sponsor. So be reasonably sure you really have a station before you count it.

Don't be discouraged if you don't ID the station. It happens to everyone, and every seasoned foreign DXer has a long list of mystery stations that haunt his dreams because he couldn't ID them. You may also misidentify a station, for any number of reasons. While this can be a cause of embarrassment if you report the wrong station to the bulletin, it doesn't mean your reputation is washed up. Unless you start reporting a whole string of catches like Tierra del Fuego on 1400, hi. Most of us have made blunders based on hasty conclusions at one time or another. Just don't think you have a station because it's the most powerful one listed or the closest one listed.

Once you've heard a station, send a report of it to DX Worldwide, even if you can't identify it. If you send as much information as possible on an Unid station, someone else may be able to tell you who it is.

As for reference material, the following all list call letters and slogans of stations you are apt to hear:

IRCA Foreign Log - Lists all the stations reported last season. Available for \$2.75 from Father Jack Pejza. And worth every penny of it!

NRC Latin American Log - Presently unavailable, but when and if it again becomes available, it should be a very worthwhile reference.

World Radj. TV Handbook - You might be able to locate this in your neighborhood electronics store. It lists nearly every station in the world, although the Latin American section may be a bit inaccurate.

Broadcasting Stations of the World - Part II - available from the U.S. Government Printing Office, this is the FBIS log you've been hearing so much about.

The following is a list of some of the most frequently heard Latin Americans and when you can hear them:

- 540 XEWA "Radio X-E-W", San Luis Potosi, Mexico. Evenings if Canadian interference isn't too bad.
- 590 CMW "La Voz de Cuba", Habana. East Coast evenings, Midwest & West Coast all night and Monday mornings.
- 640 CMQ "La Voz de Cuba", Habana. Evenings on east coast & midwest, Evenings & AM to NW w/KFI nulled. To Calif. whenever KFI goes off (not too often.....).
- 655 YSS "R. Nacional de El Salvador", San Salvador. Evenings to 0500 GMT s/off w/ William Tell Overture.
- 660 XERPM R. Juventud, Mexico City. Evenings. Plays lotsa U.S. rr.
- 670 CMKP "R. Enciclopedia", EC w/WMAQ nulled, WC after KBOI s/off.
- 750 YNX "Estacion Equis", Managua. Evenings. Strongest LA in Seattle at night. Good in midwest, on EC w/WSB nulled, in Calif. w/KCBS or KFMB slop.
- 750 HJDK "L. Voz de Antiquia", Medellin. All night after YNX s/off.
- 800 PJB "R. Transmundial", Bonaire. To EC w/CKLW evenings. To MW & WC w/XEROK & Canadian QRM evenings or mornings. Also broadcasts in English & other langs.
- 840 HJBI "Ondas del Caribe" or "Radio Libertad", Santa Marta, Colombia.
- HOL80 "R. Libertad, La Voz de la Revolucion", Panama. Both stations can be heard with WHAS QRM evenings on the WC & MW, or w/WHAS nulled or off on EC.
- 1040 HJAI "R. Tropical", Barranquilla, Colombia. Sunday mornings with WHO off.

The preceding list is by no means a complete one but it does give the beginner a few things to try for. These stations were picked because they are heard often and with good signals coast to coast. Whether or not you get them depends on your own local interference problems. Good Hunting!

HOW TO PRONOUNCE WHAT YOU SEE IN PRINT

B,C,D,F,M,N,P,T,X are pronounced the same as in English

A is always AH

N sounds like the blending of n & y in "can you"

E always EH

CH always as in choose

QU is like K in key

G before A,L,O,R,U, is like g in "go"

R is like R in three

G before E & I is like J in Jose

RR rrrrrrrrrrr

H is always like H in "honor"

S sounds like S in son except when followed by B,V,D,M,N,L,G,R when it's as in rose

I is like I in police

U like u in rude or oo in fool

J has an H sound, like in Jose

V like B in band

L is like L in light

Y like Y in yawn

LL sounds like Y in yard

Z like S in sign

O sounds like O in "low"

Words ending in a vowel, n, or s are accented on the next to last syllable.

Words ending in a consonant other than n or s are accented on the last syllable.

Vowels with an accent mark over them are always stressed.

Syllables are divided as follows: when consonant and vowel alternate, the division is after the vowel (ie- ma-ma, mu-cho). Syllables are divided between consonants except for pl,pr,bl,br,fl,fr,tl,tr,dr,cl,cr,gl,gr. Three adjacent consonants are always divided, the last two going with the following vowel (i.e.-hombre).

-----The above info should be of use to everybody. It was based mainly on info in the University of Chicago English/Spanish dictionary, plus my own very limited knowledge of the language. Any really gross errors in the guide? If you speak Spanish well and noticed some let me know.

ODDS AND ENDS

Larry Cowles comments on remote to studio links. These generally operate between 1600 and 1630 and relay programming from a remote to the stations main studios. DO these count in totals? Can they be used in contests, etc?

I would say yes, by all means, count them. It's okay according to the club constitution. And I certainly would permit it in DX Records. My own personal belief is to go ahead since they are stations broadcasting in the 510-1630 kHz BCB; tho I suppose others would disagree and say don't count them, for whatever reason they might have. I don't think they're countable in contests since they don't broadcast on one of the standard BCB channels. However, if you're sneaky and/or lucky you might be able to count one from Alaska or Hawaii in the foreign contest. The contest manager would have final say on that matter, of course. For awards they would be countable. Does anyone have any opinion one way or the other about them (or any other utility station)?

Dave Christensen asks, why does the porridge bird lay its eggs in the air? The answer is a bit complicated and a detailed discussion would take up too much space, more than could be justified. However, in brief, it is so guys like Dave can ask questions that will take up space in the bulletin.

Do you have a question about DXing or IRCA, or an article that would be of interest to beginners, or a review on your receiver, or a comment (good or otherwise) about this column. Whatever it is, send it in. It might even get printed! 73 for now. bp.
