Special Notes: This Report combines February and March Board letters and subsequent balloting. Bill Lipis had not been elected for the Board in time for the February letter. Strictly speaking, the March Board letter predated the public announcement of his election in DX Monitor so perhaps he was ineligible technically for that one too. However, in the interests of fairness I decided to count his vote. He had received no Board letter but voted on 5.2-34 and 5.2-36 in his own words. I trust I have interpreted his vote correctly.

Glenn Hauser voted for the February proposals (5.2-26 thru 5.2-31) but his ballot was not received in time for the March ones (5.2-32 thru 5.2-36).

\*The President, to break the deadlock, voted in FAVOR of 5.2-34.

- 5.2-26 Resolved, that the IRCA include in a future bulletin for one time only a one page offset-printed flyer from the National Radio Club advertising that Club's Pattern Book. The flyer would be supplied pre-printed free to the IRCA Publisher. In return for this inclusion, the National Radio Club would run, in future, one page (two sides) of credit for any IRCA project which the IRCA might be running at that time. The material could be run one page at a time or both pages at one time, with the NRC arranging for publication as soon as possible after receipt of the material from the IRCA. Submitted 25 December 1972 by Gordon P. Nelson.
- 5.2-27 Amend the Editorial Policy to read: (add a new item as follows) "Article II, Section B Part 1, d. (5) reading, "DXR editors shall have the right to require their reporters to follow specified guidelines when reporting." Submitted 14 January 1973 by Richard C. Evans.
- 5.2-28 Amend By-Laws Article V, Section 3, Part 5 to read: "Should the Chairman of the Board resign, or the office become vacant for any reason, a special election among the Board of Directors shall be conducted immediately in accordance with the procedures outlined in Article III of these By-Laws." Submitted 9 January 1973 by Richard C. Evans.
- 5.2-29 Amend By-Laws Article III, Section 6, to read: "The President shall ballot the Board of Directors soon after each regular election to determine the Chairman of the Board, who will be the spokesman for the Board, and will be responsible for assuming the President's office in case it is vacated during the current term. In the event the Chairman of the Board becomes club President, he shall be required to resign his Board position. Should the position become vacant through resignation, or any other reason, the President shall then ballot the Board of Directors again to determine the new Chairman of the Board" Submitted 9 January 1973 by Richard C. Evans.

- 5.2-30 I propose that we set a time limit on the amount of time that can be allotted for special elections of officers who have, for whatever reasons, resigned their post. I propose a limit of three (3) calendar months for the ballots to be enclosed in DX Monitor, the period will begin the day the President is notified of the resignation. If DX Monitor is to be published weekly less than half of the three (3) month period (45) calendar days) then the ECC shall have four (4) months in which to get the ballots into DX Monitor for voting. This way we can keep the members of the club's administration complete and all the offices filled. Submitted 30 January 1973 by Dave Christensen.
- 5.2-31 I propose that we begin a fund to expose radical subversive com-symp and other naughty members of IRCA who are out to discredit the administration or any of its members. The funding shall be rather inexpensive with very few expenses, the insignificant ones (expenses) can be absorbed by the individual members. In memory of the fine job Lynn Brooks did along this line, I propose we name the fund after him. Submitted 30 January 1973 by Dave Christensen.
- 5.2-32 Confirm the appointment of Allen Denny to the post of Sports Network List Editor.
- 5.2-33 A proposal to establish a column, appearing irregularly in DX Monitor, to be devoted solely to the subject of verifications. This column is not for the purpose of listing veries, but to examine different aspects of the subject and give suggestions on how to obtain verifications. Submitted 18 February 1973 by Richard C. Evans. (Note: Proposal abridged to conserve space.)
- 5.2-33 Confirm the removal of Bill Lipis as Western DX Forum Editor.
- 5.2-34 Confirm the removal of Andy Hecker as Western DX Roundup Editor.
- 5.2-35 I propose that the election held in the January 27, 1973 issue of DX Monitor for the position of Board of Directors be declared null and void. The election results are unfair to the candidates involved due to the circulation of a postcard (reproduced elsewhere in this President's Report) allegedly from former IRCA members Paul S. Lotsof and Steve Kamp. The content of the card was designed to deliberately mislead voters, especially new members, into thinking that Dave Faulkner and John Zondlo held views compatible with those of Paul S. Lotsof and Steve Kamp. Submitted 4 March 1973 by Donald E. Erickson.

### Commentary

Father Jack is currently preparing material advertising the IRCA Foreign Log for inclusion in DX News (the NRC's bulletin). It is our intent to use one side of a page now and another page, perhaps in the fall when Volume II of the Log is published. (See 5.2-26)

With regard to 5.2-27, it is felt that editors already have this discretion.

Proposals 5.2-25 (see DX Monitor, February 24, 1973 page 3) and 5.2-28 will appear on the ballot for member ratifications along with the regular election of officers.

On 5.2-29 the Board felt, as I did, that the Elections Committee Chairman should handle this matter.

It was felt that it would be difficult to enforce 5.2-30, though the idea is quite sound.

The Board regrets the waste of its time with 5.2-31.

Allen Denny (5.2-32) was formerly the Sports Network Editor. He did a superb job and has an advantage as manager of the Midwest Sports Bureau. Allen quit because of lack of time, then reapplied when his work load shifted and become bearable. The Board is pleased to have Allen back again and regrets any inconvenience to those who applied for the position.

See Miscellaneous for remarks on 5.2-33.

Mr. Lipis begin his WDXF column quite well. Unfortunately, his stencils missed deadlines; one contained a fraudulent report and a 30-line report (it was returned); finally, the stencils stopped altogether. They reappeared again in March, but with material which was very old and which should have been printed weeks ago. The

claim has been made that Mr. Erickson held the stencils over or that they were lost in the mail, but the date, put on the stencils by Mr. Lipis himself, indicates them to be typed recently with old material used. Speaking personally, the report about my verification from CBAQ-540, which I sent in in very early January after receiving the verie on January 4, was printed only just recently in the March 17 DX Monitor. Other complaints concerning this matter have reached publisher Don Erickson.

Mr. Hecker has been removed for failure to provide stencils to meet deadlines, failure to observe technical guidelines in the matter of dates, etc., and for submitting material (not all of which was published) which tended to debase the character of a certain former IRCA member. In general, Mr. Hecker's attitude in the comments following DX Roundup has been unacceptable to myself and certain of the Board.

Many of you are not aware of what has happened since and during the January 27, 1973 election for a replacement Board member. I should like to present that story now.

Shortly after the ballots went out in that January 27th DX Monitor a postcard was sent out to various members. The sample I have is postmarked U.S. Postal Service OK (Oklahoma) and is dated February 2, 1973. The card has a return address sticker which reads "PAUL S. LOTSOFF, 4309 South Owasso St. #8, Tulsa OK 74105". As far as can be determined, the card appears to have been sent to newer members who were not in the Club some time ago when a certain Paul S. Lotsof and Steve Kamp were expelled from the IRCA. Older members know all about that incident and have drawn their own conclusions. It should be pointed out that this Club is a friendly one and expulsions are rare. The whole story behind the expulsions is a long one, but suffice it to say here (for the benefit of newer members) that a majority of the Board of Directors felt the charges against the members were serious enough to warrant the action. As far as can be determined, the card seems to have been sent to new members without any knowledge of the incident mentioned. (Where the mailers obtained the list of new members is not known as neither receives DX Monitor.) Here is the text of the card:

Dear IRCA Member:

You may recall that about a year ago we were expelled from the IRCA for daring to disagree with Publisher Don Erickson and his Personal Puppet Percy Kesteven. Although we're no longer mentioned in DX Monitor, we are still determined to rid the club of Don's Dictatorship. That's why we are vitally interested in the present election for a new Board member. We would like to see either DAVE FAULKNER or JOHN ZONDLO elected. Both have fine experience as editors and above all, we have reason to believe that both Faulkner and Zondlo will work to put Erickson and Kesteven in their proper places.

Reinstate democracy in IRCA. Dump Erickson and Kesteven. Vote for FAULKNER OR ZONDLO. Decide for yourself but be sure to vote when your ballot arrives.

A new member, not knowing the background of Mr. Lotsof and Mr. Kamp, would be led to believe that Dave Faulkner and John Zondlo were in league with them. Having met both Dave Faulkner and John Zondlo I would say this is somewhat unlikely. In fact, John stated very negative views on these two publicly in DX Monitor February 14, 1973 page 17. A Board candidate elected (or with the possibility of having been elected) by a fraudulent trick such as this one would not uphold and/or protect the reputation and dignity of the IRCA. Hence my positive vote on 5.2-36. Note then that Bill Lipis' election is null and void and the seat is vacant again. I would suspect that it will remain this way until September 15, 1973, when the new Board of Directors steps in. However, I will have to consult with Dave Prather, Elections Committee Chairman, on this matter.

Proposal Going to the Board of Directors in June, 1973.

5.2-42 That individual DX roundup editors be permitted to include local time, in

conjunction with the required ELT.

Comment: Current Editorial Policy states that times shall be Eastern Local. Does the membership wish their roundup editors to include local times for their area (e.g. PLT, CLT, ELT, ALT) in addition to the mandatory ELT? Please write in your comments on this matter in the next few weeks so that the Board can make a decision in June.

WHEN YOU MEET ABIE NATHAN IT IS PLAIN HE IS NEITHER AN INNOCENT OR A LUNATIC. A JEW, BORN IN PERSIA, EDUCATED BY JESUITS IN INDIA, BRITISH ROYAL AIR FORCE FIGHTER PILOT, EL AL CAPTAIN, PROPRIETOR OF A SUCCESSFUL RESTAURANT IN TEL AVIV, ART COLLECTOR, INTERNATIONAL PLAYBOY, RACONTEUR, NOVELIST--YOU NAME IT, NATHAN'S DONE IT. THE LAST TIME HE HIT THE HEADLINES WAS 2 DAYS BEFORE THE OUTBREAK OF THE 6-DAY WAR IN JUNE 1967. FLYING AN OLD AUSTER WITH PEACE 1 EMBLAZONED ON IT, HE LANDED AT PORT SAID IN EGYPT TO PLEAD WITH GAMAL ABDEL NASSET NOT TO PROVOKE THE ISRAELIS TO WAR. THE EGYPTIANS GAVE HIM LUNCH AND ALLOWED HIM TO REST BEFORE PACKING HIM OFF BACK TO ISRAEL, WHERE HE RECEIVED A SUSPENDED SENTENCE FOR INFRINGING THE COUNTRY'S AIR REGULATIONS.

HIS CURRENT PROJECT IS A MUCH MORE SERIOUS AFFAIR. HE SOLD HIS RESTAURANT AND ALL HIS PROPERTY IN ISRAEL AND SANK HIS LAST PENNY IN THE SHIP WHICH HE BOUGHT IN HOLLAND 3 YEARS AGO. THE SHIP HAS BEEN FITTED TO ACCOMODATE 20 PEOPLE AND HAS A 50,000 WATT TRANSMITTER AND A 160 FOOT RADIO MAST.

NATHAN HAS TWO OBJECTIVES. FIRST, HE WANTS TO ESTABLISH THE VOICE OF PEACE AS A CREDIBLE AND PROFESSIONAL RADIO STATION. EXPERIENCED JOURNALISTS AND TECHNICIANS WILL BE USED AND THE RANGE OF PROGRAMS WILL BE BROAD WITH A STRONG EMPHASIS ON ENTERTAINMENT, RANGING FROM POP MUSIC, PRESENTED BY TOP-FLIGHT DISC JOCKEYS, TO CLASSICAL AND ARAB AND ISRAELI FOLD MUSIC. SECONDLY, WHEN CREDIBILITY AND POPULARITY ARE TAKING HOLD, HE WILL DEVELOP HIS POLITICAL FORUM BY INVITING ARABS AND ISRAELIS TO ADDRESS THE AUDIENCE. THE PROBLEMS ARE WHETHER ARABS WILL BE PREPARED TO STICK OUT THEIR NECKS. THEN, WILL HE BE PERMITTED TO GET AWAY WITH IT. THE ISRAELI AND ARAB GOVERNMENTS ARE LIKELY TO FEEL UNEASE, IF NOT DOWNRIGHT HOSTILITY. EVEN THE CYPRUS GOVERNMENT, IS BELIEVED TO BE CONCERNED AT THE PROSPECT OF NATHAN USING THE ISLAND AS HIS BUNKERING

THE VOICE OF PEACE, STILL MUTE BUT ITS GENERATORS ALREADY HUMMING, WILL SET SAIL FROM NEW YORK SHORTLY HOW LONG IT WILL BE ALLOWED TO BE HEARD OR WHAT EFFECT IT WILL HAVE ON THE MIDDLE EAST ARE UNKNOWN QUANTITIES. BUT THERE IS NO DOUBT IN ATHAN'S MIND. "THE RADIO WILL NOT ONLY ILLUMINATE THE PATH TO PEACE, IT WILL ALSO BE THE VOICE OF REASON."
