



THE TED VASILOPOULOS AWARD



Disc Joggy' Spins the Popular

BANJUL, Gambia — Sarjoe "Joe" Barry is one of the most popular people in all of Gambia and in much of Senegal, its West African neighbor.

"The people just love me, they really do," said the 25-year-old "disc joggy," as he calls himself. "And can you believe, I didn't even have any training to be a disc joggy and I have such success like this."

Barry plays the hits from 8 a.m. until 3 p.m. on Radio Syd, this tiny country's only private radio station. He's pleased to have any job at all and said the \$88 he earns each month is quite good by local standards.

The steady stream of American soul hits is liberally sprinkled with the beat of Caribbean reggae and hot African sounds from Nigeria and Zaire.

And, just like its counterparts in the United States and Europe, Radio Syd plays commercials — lots of commercials.

"There is no question people lis-

ten to us," said station co-owner Benny Holgerson. He and his two Swedish partners run the privately owned station, which has been operating here for 17 years under a special license from the Gambian government.

Holgerson complained of last year's government ban on cigarette advertising, which cut into the station's revenues. However, buying commercial space remains a brisk business. During a recent two-hour stretch at the studios, a steady stream of Gambians filed in to buy advertising.

"You've got to get those spots on today and tomorrow. There is no point in our opening at all if we don't get our spots on," one harried Gambian nightclub owner pleaded.

With a 2.5-kilowatt transmitter at 909 on the AM dial, the broadcasts

reach an estimated 800,000 people in Gambia and Senegal.

Radio Syd takes its name from the Swedish word for south. It began life in 1959 on a converted Norwegian freighter as an unlicensed "pirate radio station" that broadcast rock music to Sweden and Denmark.

Denmark.
The operation ended in 1966. The
151-foot steel freighter had a brief
reincarnation as a gambling casino
in the Canary Islands. Then, in 1969,
The Cheeta, as the ship was called,
set sail for West Africa where it
began broadcasting in 1970.

The operation caught on and soon moved ashore to a permanent concrete block building. The ship, sold to a local businessman for parts, now rusts in the tidal flats of the Gambia River.

But Radio Syd lives on.

Happy anniversary to IRCA. Time for a brief re-intro. I am now in my third year in IRCA. 26 and single, I am a student at Furdue University, (THE Indiana University), studying meteorology. (Yes, the ionosphere is a part of the atmosphere.) My main DXing interest is the medium wave band but I also spend a lot of time DXing the shortwave bands. Currently I am at 40 states, 8 provinces, and 17 countries outside the US. As of this writing I have a total of 698 stations logged and should be over the 700 mark by the time this reaches print. I usually confine my DXing to sunset and also try to hear all of the scheduled DX tests. Many times this year I have listened for the tests but have only been successful in hearing two of them. A few observations, First of all, does anyone have any idea who is behind WHAM. I am hearing someone with a talkshow and they also carry NBC news at the top of the hour. Not having my loop I am unable to null out WHAM. Secondly, someone here at Purdue is running a station on 650 kHz relaying WXRT in Chicago and also carrying a dormitory station. I doubt that anyone will hear it since they are running very low power, probably not more than a few watts. That's all for now. 73 and good DX.

Greetings from the Bluegrass State. Well since this is the anniversary issue I figured a short re-intro is in order. I'm 25 years old, happily single, been DXing since 1978, a member of IRCA since 1982. My equipment consists of a Kenwood \$-1000 receiver with a Radio West loop antenna and a trusty GE Superadio as a backup. My totals stand at 1195 stations heard in 44 states with 2 new states in 1987. (1) WDEL-1150 DE and (2) VT with 2 stations (1) WVMT-620 and (2) WDOT-1390, 295 stations verified in 36 states. My 5 best catches are (1) WYNZ-970 Portland, ME (heard in 1979 before I knew about IRCA and when local WAVG-970 was off MM), (2) KNMX-540 Las Vegas, NM, (3) KATL-770 Miles City, MT, (4) KOGO-600 San Diego, CA (heard on Beverage at 1982 NRC convention in Louisville), (5) KLDI-1210 Laramie, WY. I can't dispute that since I wasn't DX'ing then but I can say from my own experience that without question the reception in January was the best month end to end that I'd witnessed since February, 1972. Some of the sunrise and sunset skips were some of the most intense both lasting late into the AM and starting early in the PM that have been had in memory. Examples: WYKR-1100 beating into WWWE before 1630 w/C&W on 1/10, WCAT-700 at 1633 ELT on 1/12. I never thought I'd see the day that another "w" call would be heard on 700. Oh what the FCC has wrought. KJPW-1390 w/C&W & mention of restaurant in St. Robert at 0923. Three stations in at once after 0930 ELT on 1070 (none of the 3 2343 the usual CHOK or WIBC) while unneeded, still unusual to have WTSO/KHMO/KFDI all fighting it out evenly at such an hour, or any hour for that matter. More amazing about 1070, I've had 17 (count 'em 17) different stations in on that channel within the span of a week! New there were KMOM on 1/19 at 1800 ELT, also WSCP at 1615 ELT on 1/12. Thanks Frank Merrill for the tip re KMOM. Speaking of Frank he was in town for a visit just before a lot of snow flew here on 1/19. Before it arrived however Frank set up his amazing long-wire in very nearby Mich. and we DXed inside his van w/his Kenwood R1000. Two very noteworthy catches in the form of KVNI-1080 Coeur d'Alene, ID in for over an hour from 0100 ELT on & kM3N-560 w/C&W just before 0300 ELT, Great Scott er Great Falls that's Montana! My best catch in January and perhaps of all time came in the form of CFRN-1260 Edmonton from 0815-0830 on 1/12 topping a totally buried WBBG (they should have been on day pattern by this time). I was flabbergasted and quickly called Ken Romstadt but he was too slow to respond and didn't hear it. They had Ad-Con format w/at least 2 good IDs. Might this have been one of those rare "donut" type receptions? new ones heard in January, best single month in 11 years, was even better than the 19 new ones of Dec., '86. Among the 23 in Jan. was a Radio Caribbean International on 1090 in EE. Who's this? St. Lucia? How good were the January figures? Well in all of 1982 I managed only 24 new stations for the entire year, hard for me to fathom nearly beating that in one month here in '87! I thought my days of getting more than 20 stations one month here in 'o': I thought my days or getting more than 20 stations in a month were long gone. Some fairly local changes on the dial in recents - WFYC was on 1520, is now on 990 as WWCM, this as of 12/23/86. Per Jerry Starr's tip, yes WBZY is on 1200, finally heard here on 2/9, at 1425 FLT, was never heard on 1140 kHz here. Not too strong on 1200 either. Also on 2/9/87 at 1720 FLT the new (very new I'd say) long-awaited CP for 830 kHz in Michigan is on now, format is oldies-slogan is "The Big Bopper". is WMMI Shepherd-Mt. Pleasant. Of course I took my travel radio along with me to Dallas as well as my habit of waking up in the early hours. My travel radio is the GE 3-5280B, which is the Super Radio combined with a cassette recorder. Only two or three mornings after arriving there I noticed a whistle one morning while idly turning the dial in poor light between 800 and 700. I picked up the radio off the floor, idly turning the dial in poor light between 800 and 700. I realized at once that JOIK had come with me to Texas although I couldn't recall any Dallas area DX'er reporting Japanese reception in recent years. Any communications receiver would have no trouble that morning splitting off JOIK from the 750 stations and getting a readable signal. At least four other mornings while there I found the JOIK het. I hadn't brought my notebook along so took no notes on it except for 20 December. I wrote a note to myself about monitoring this het from 1104 to 1142 UTC.

That same note to myself reports finding a het MM 22 December on the high side of 880 on WCBS and Cuba during the silence of the powerful KRVN. The time was 0748 to 0810. Seemed to me this could only have been a signal from New Zealand. But I couldn't measure it to determine if it was exactly 880 plus 2 as I imagined it was. In any event, you can hear trans-Pacific signals on inferior equipment in the Dallas area, the same as it was for me in Dallas, 1928-32.

In January 1987 back in Denver, JOIK delivered me a signal every day of the month, some days only a northerly carrier revealed by the BFO, other days with a strong audio and hetting its 750 neighbors. On 16 January at 1148 I noted JOIK about equal in strength with the 750 stations.

The first 11 days of February continued the daily pattern of reception of $\rm JOIK$ — every day, sometimes weak, sometimes strong. Summing up, $\rm JOIK$ gave me a signal every day for the first 44 days of 1987. And that's where this accounting ends for I'm writing this on 11 February. 73.

Anniversary time again and another DX season is winding down. DX hasn't been spectacular, but the season has gone by fast (as most time does when we grow older, right?) Am starting my third year with IRCA. Have been DX'ing on and off since the 1950's, in Alaska. My work there with the Federal Aviation Administration required a lot of travel and I visited numerous remote places. Didn't DX much on those trips but if the high quality compact portable receivers of today had been available I might have. Nearly all of my travel was in airplanes including some pre-war types that are now or should be in museums: Ballanca, Howard and Lockheed Vega on floats; gullwing Stinson on skiis, etc. Any old airplane buffs out there?

This season I've used two active antennas for DX: a Dymak DA100D and a Sony AN-1. Both perform well. I rate the AN-1 slightly better in performance but the DA100D is better in terms of human engineering. The indoor control unit of the latter has normal size knobs on the switches. The AN-1 has three tiny slide switches that are best operated with a finger nail. These are within reason on a pocket radio but don't make much sense on a table top unit. My AN-1 outside unit is installed about 15 feet above the ground with the antenna element horizontally oriented. In an area with buried power lines. Sensitivity is surprisingly good. The AN-1 comes with two devices for coupling signal into receivers which have no external antenna terminals. One advantage of an active antenna as compared to a loop is being able to DX and at the same time do something relse. I find myself constantly fiddling with a loop.

ALBUQUERQUE DAYTIME BANDSCAN MARCH 6, 1987

Plenty of wide open spaces in New Mexico. I visited there for the first time in March, spending nearly a week in the Albuquerque area; and generally speaking, radio programming in that neighborhood is as medicore as it is anywhere else these days. The only exception would be KLSK, an FM which is described as "Contemporary/Variety" by the listening guide in the Albuquerque newspaper. KLSK plays an amalgam of eclectic music ranging from jazz to new acoustic/windham Hill-type, mostly instrumental work. In a conversation with one of their employees, I was advised that KLSK is actively shopping for an AM outlet in the Santa Fe area. He said he hoped a deal would be struck within 2 months, so it sounds as if it's a purchase rather than a new frequency allocation. There are only 3 AM's in Santa Fe, so whoever is on the bottom rung of the Arbitron --and you know who you are, darlings-- is a likely target. My guess would be KTEC-lhOO, identified as an "Easy Listening" outlet. It's also the only Santa Fe station I could not pick up and ID in Albuquerque, although I suspect I may have had them weakly one afternoon. The other 2 Santa Fe stations, KAFE-810 and KVSF-1260, seem to be healthy, judging from some extended listening on 3/8/87.

For those of you scratching your heads, wondering why there's no nighttime DI to report here, well, I just didn't have the opportunity or the facilities. The rx was part of a YORX M2666 stereo AM/FM/Tape/Flaster with a poorly calibrated flywheel analog tuning indicator and no serious antenna. It was hard enough figuring out the freqs for the locals; I would have gone nuts at night with the foreign stuff. Next trip down I will plan accord-

ingly.

- 1150 KDEF 1301 Nx from Satellite Nx Net, followed by Frankie Lane's "September in the Rain." Fifties, forties, big band, etc.
- 1190 KXKS 1403 All SS:5-tone IS + "radio noticias" by female ancr, spot for Dial-a-Tool(1), man w/wx "65 KXKS grados", several ID's strung together, incl. "This is KXKS, Alb., 11-90; Kah-Equis-Kah-Esse, Once-Noventa, Alb." plus jx "La Super Equis", "Super Equis, su estacion favorita presenta una practivo mas para su alvitorio (?) palenque (?) musical, Super Equis."
- 12h0 KLTN 1h06 All SS. At least 10 minutes of rap about G&T Auto and Tire Service, maybe a remote. Ment in EE of "I Love KLTN", R. Latina ments, two taped ID's played on top of each other, followed by ranchera mx. Spots for Benton Services, Baca's Mexican Restaurant (great place! I ate there.) Jx ID "R. Latina, mas --- tu preferencia." More ranchera mx.
- 1260 KWSF Santa Fe 3/8 1618+ (Rx in the Cadillac, location Mile 21, Hwy 4 near Battleship Rock) Good AC mx mix w/ Steely Dan, Fats Domino, G. Lightfoot, spot for Sepastat (sp?). NBC wknd sports at 1630.
- 1310 KXAK 1339 wall-to-wall soft pop, AC format, although listening guide in nxpaper lists it as Christian.
- 1350 KABQ 1358 All SS. Spot for Creamland Dairiss, pas for New Mexico Commission on the Status of Women (Title given in EE), ID @ 1400 w/fem. ancr (sounds taped) "Un servicio a la comunidad de KABQ," + live SS/EE ID by fem.
- 1400 Unid 1400 3/10 very weak w/mx. Presumed to be KTRC, Santa Fe.

Rock 108 Concert Line given as 262-0780, sponsored by Senor Bucket's, a local club (apparently). Spots for Miller Lite, Check Mart, Frontier Ford.
- 1580 KZIA 1343 Health talk pgm w/phone-ins, 262-5400. Lengthy live spot for Keller's Farm Stores. CNN Radio Nx at 1330.

 5h0 KMMX Las Vegas, NM (These calls right? I thought it was KNMX.) All SS. ID at 1500 out of medium tempo pop vocal: "KMMX ...para norte de noho(?) Mexico y sud rey(?) Colorado, desde Las Vegas. El punto del mundo en las noticias de la Hispana Americana, KMMX."Then nx in SS. Weak but fairly good.
- 660 KTNN Window Rock, AZ 1505 out of NBC nx, live ancr ID, "You're listening to the mighty 660, KTNN from Window Rock, Arizona," followed by "Job Offerings" bilboard. Pretty weak signal w/gain cranked all the way up on rx.
