For those wondering, "extension of time" is not a concept borrowed from particle physics...it means the new station won't be ready to go on the air by the date it previously promised the FCC, and so is asking to move that date back - meaning the CP is still alive, but isn't likely to be on soon. "CP to reinstate expired permit" is roughly similar, but means the station didn't ask for an extension before it got past the promised date. Both of these are often granted, and even when not granted there are several layers of appeal before the CP is finally cancelled - but it's still useful to know what might or might not be signing on soon.

MISCELLANEOUS NOTES: WKTP-1590 Jonesborough TN is added to the list of stns granted exemptions by the FCC so that a licensee can own multiple stations of the same service (in this case, AM) in the same market. Why bother getting a license to build a synchronous transmitter when you can just buy a competing station and either simulcast it or sign it off (ala the late WGLI-1290)? The main reason the experiment in licensing synch. xmtrs ran aground is that the whole exercise has become moot! And speaking of translators, KGMI-790 Bellingham WA has applied for a translator in Blaine WA to relay the AM; if approved, it would be the first FM translator used to directly relay an AM feeder station.

To follow up on the KTCD-1200-CA app. and RtH's comments a couple issues ago, there's actually ample precedent now for new AM stn CPs picking up and moving 100 miles or more. Most recently, WLJH-1120 Denham Springs LA was originally licensed to Petal MS, and WMMI-830 Shepherd MI was supposed to serve Marshall MI. Again, why bother going through the process to license a new station when you can just buy the languishing CP of someone else in the next state, and move it where you want?

The latest directory issued by Canada's <u>Broadcaster</u> magazine has deleted CBH-860 Halifax NS, CBAF-1300 Moncton NB, and CBD-1110 Saint John NB. It's probably safe to assume that each of these CBC facilities is permamently off the air.

Also off the air are two of last year's crop of new satellite program services. The Financial Broadcast Network (FBN), based with XEKAM-950 Tijuana (San Diego), has folded; XEKAM is reportedly off the air, tho I've gotten no confirmation of this. Only two other stations were carrying the FBN format at the time of its demise. Seattle-based Braiker Radio Services is also reportedly planning to have folded its tent by the time you read this; they have about 15 AM & FM affiliates.

It's spreading...Simulcaster WUSQ-610/102.5 Winchester VA is now also using the "There's only one...WUSQ" slogan. If they're truly serious about the proposition, sign off the AM and let us hear KFRC, hi.

On the other hand, sometimes there's hope that radio will catch up with the rest of the world...a jury in Pittsburgh awarded nearly \$700,000 in damages to the former news director of an FM station there, who was constantly insulted on the air and made the butt of sexually degrading "jokes" by the allegedly humorous morning DJs. I think the FCC's enforcement of obscenity regulations is a bad idea - I don't like any branch of government deciding what's safe for me to hear - but this has to be considered a victory for those of us who don't think sexist, racist, sophomoric radio is an adequate excuse for entertainment or for community service, two qualities AM and FM radio desperately need.



GLEN KIPPEL, 612 WEST AVE., MERCED, CA 95340-6577 Hello and Happy Anniversary to the BEST MW DX club! In case you'd like to know something about me, stay tuned - if not, skip to the next item, hi. I just turned 50, am married with 5 children aged 12, 9, 6, 4 and 1. If that weren't enough to keep me up nights, I'm CE, Music Director and morning drive "air personality" for KAMB, a Contemporary Christian format station (80% music) as well as contract engineer for KSNN, a "hot AC"-format FM. So my interest in Ancient Modulation is strictly a hobby, hi. Actually, I do keep up with AM issues, such as NRSC and while visiting the transmitter site at local KYOS I had a chance to play with their new Delta Splatter Monitor, and it showed that their NRSC conversion definitely helps. Now if only KLOQ would convert! They splatter 60 kHz each side! I'm also a proponent of NFR, the idea of using narrow-band FM instead of amplitude modulation on the MW band. The current thinking on that is to deviate the transmitter by +/-1 kHz, then multiply the receiver's 455-kHz IF 75 times to 34.125 MHz and mix that with a crystal oscillator at 23.425 MHz to get a 10.75 MHz signal deviated +/- 75 kHz, just like a normal FM IF signal. WOYK Seffner, FL has submitted a request to the FCC to conduct NFR tests, and some others have shown interest as well. This might be an interesting new form of DX, especially if you can cobble up a receiver. Remember, this is an FM signal with <u>IF limiting</u> and <u>capture ratio!</u> The idea is to modulate with the same signal in the amplitude domain for compatibility with present sets, but eventually I would like to take it another step and use the NBFM signal for the mono sum (L+R) and amplitude-modulate to get the difference (L-R) signal, just as we do now on VHF FM. If NFR goes over like the proverbial lead balloon, about the only other thing I can think of that might help AM out of its doldrums might be having a dbx processor in front of each transmitter, and a corresponding dbx expander chip in the listener's receiver. In the February issue of Broadcast Engineering magazine, there's a fascinating article on the Scott Philbarmonic receiver, showing receiver technology has really gone downhill in the past half-century. Now, the Scott receivers were frightfully expensive, but I see no reason why anyone can't use a few National Semiconductor LM373 chips and ceramic filters and make quite a good signal inhaler. I haven't had time to experiment with this but have a few ideas. Maybe by the year 2015. 73 and great DX!

As I understand it, this is supposed to be the anniversary issue this year. For a re-introduction: I'm about ready to turn 45, and am employed 1700-0200 CLT as a production rate clerk for Advance fransportation Co. here in Milwaukee. Of all these, I only belong to IRCA and NRC these days.
