News from DX AUSTRALIA this time: Station 5DN-Adelaide goes off the air after 66 years, 3XY-Melbourne (1422 KHZ) has also been closed down after 56 years opf broadcasting. After several years of poor ratings, 3XY was put into liquidation earlier this year. It has been bought by AWA Media Ltd, who has plans to start up anouther station in Feb. on 693 KHZ with a new call sign. Also 3GI-828 KHZ-Sale plans to move to 100,7 MHZ. In the near future 3RN-Radio National has plans to take over the freq. 6PRH-Perth (R. for the Print Handicapped is about ready to come on of either 990 KHZ or 1206 KHZ. 4KQ-693 KHZ-Brisbane is to move to FM instead of 4BH-882. Two other Sydney stations that have plans to convert to FM are 2UW-1107 and 2WS-1224 around mid 92. 4IP-1008-Brisbane has been bought by TAB and have plans to start IDing as Q-TAB from Dec 91 and have a racing format. 

The big radio news locally is that Jeanne Kramer actually met her 1 October deadline and signed on KIDS 1340 with a daily schedule of 0800-1400 Eastern of songs and stories for children 12 and under - though without any paid advertising at present. She says the Kramer family is footing the bills for now. I helped her find sources for childrens' records before she got on the air, and told her they wouldn't be enough - with the lack of syndicated/national kid programming available to her, she'll have to produce some stuff locally, perhaps with the co-operation of the school system, the library, etc. But that also takes money. listened to an hour of it on 2 October and heard nothing but kiddie songs and stories (all off commercial discs/tapes), no announcers, no spots, just an occasional canned call mention or ID by a youngster ("KIDS 1340 Springfield, Kids' Radio"). Also locally: the program schedule merry-go-round continues at KWTO 560 (times converted to Eastern): they've started a morning-drive simulcast with their soft-rock FM (KKHT 98.7, "The Heart") from 0800-1000, then a local hour of gab, followed at 1100-1300 by Dr. Marshall Saper // KCMO 810. Then Paul Harvey, local news, etc. at noon local (1300 ELT); Dr. Dean Edell 1400, and Rush Limbaugh 1500-1800. Then another local news hour (with

Paul Harvey's "Rest of the Story") at 1800, local sports call-in at 1900, and Talknet at 2000 ELT. Other local broadcasting news: after 30 years at 101.5 FM, beautiful music KTXR is moving down 200 kHz to 101.3, to avoid mutual QRM with a Columbia, MO station that's increasing power (presume KARO 101.7 - newspaper article didn't specify). KTXR has a huge signal that easily reaches into central Missouri if the band's up at all. 73. (Edited for length-BH.)

So RIGHT NOW while you are thinking of it - go to your little address book, or giant PC, and make the change. Go ahead. We'll wait right here. . . . Okay, now that you're back (or should I say "Now that you've ignored me," hi?!), we'll continue. . . . The reason for the change is that due to the combination of population increase, and especially the rapid growth of computer modems, fax machines, and cellular telephones, the 213 area code has simply run out of available numbers. So the 213 area code is being split up. A tiny section of downtown Los Angeles (where the heaviest concentration of businesses are located) will remain 213, while most other surrounding areas will become 310. This is the second while most other surrounding aleas will become 310. This is the second time in recent years that the 213 area has been split apart. A few years ago the San Fernando Valley was broken off, and became 818. The way things are going, I wouldn't be surprised if by the turn of the century, the 213 area consisted of just three office buildings, hi. What this means is that to now call a number across town, I must dial 4 additional digits (1 + area code + number). And this situation is likewise happening all over the country. Instead of continuing to create new area codes, I think a much better solution would be to just make basic phone numbers 8 digits, instead of the current 7. That would create more than enough new phone numbers, and it's easier to dial one new digit rather than 4! In any case, my new phone number is now even EASIER than it was before! Jeter, 2115 Scarbrough Road, Stone Mountain, Georgia 30088 welcome to a new DX season, and for me at least, not a lot of DX to report so far. with the cooler air, my nose perks up, and I start thinking..."beverage antenna///!" I am planning to make some DXpeditions this fall/winter, and have already cleared it with my aunt and uncle over in eastern AL. Their farm is several hundred acres, and I can easily go due west to due south from the house, or I can get northwest if I bypass the house and use my car as a shack! In reality, the weather at beverage time will decide which way I go, needless to say. I am also exploring the possibility of a site much closer to home. My son's Cubmaster owns a farm in S. DeKalb Co., about five miles from my house, near what is known as Arabia Mountain—a smaller version of Stone Mountain. If my understanding of ground conductivity is correct, this site should be ideal, as that entire area is layered underneath with solid granite, much of it exposed. That could make grounding the beverage a problem, but there are enough areas where there is softer surfaces, so placement would be critical. The biggest problem with the Eastern AL site are the dreaded "beverage eaters", aka cows... Veries have edged up to 1451 with recent v/1's from WMLX-1190, WHMT-1190, KGHT-880, KIRL-1460, and a v/pp from WFGN-1180. A few notes: WMLX makes no mention of its city of license...that "Cincinnati, Ohio" letterhead looks pretty strange in my "KY" verie album! WMLT says in their letter that when I heard them, they were on due to transmitter repairs (that being about 2200, strong in WOWO's null). Thanks to everyone who gave me info of KGHT! So far in 1991, I have managed a 70% return rate on veries...21 veries for 30 reports. There hasn't been much DX to report, but you know the old saying about quality over quantity: choice loggings so far are KOKK-1210 and KWPN-840, and rounding out a trio of new logs is WATX-1590. Weather permitting, I should be DXpeditioning soon ... 73's to all ... gotta get back to work.

Tom Jasinski, 419 North Raven, Shorewood, Illinois 60435 Greetings. The September issue of IEEE Power Engineering Review magazine has two very good articles concerning effects of solar activity (geomagnetic s rms) on electric power systems and radio communications. To briefly summerize, there are several ways the storms can affect radio broadcasts. 1. Loss of AC power due to disruptions in transmission systems. 2. Disruptions of the reflective layers in the ionisphere. 3. Disruption of phone communications (including land lines) due to strong magnetic field fluctuations. They mention that during rapid changes in the earth's magnetic field a voltage is induced in any electric conductor. Even buried electric and phone cables are affected. As much as 7 volts per mile are induced. Long distance phone cables have been known to arc and short out when this occurs. They expect at least two more years of activity for the current solar cycle (#22). Rich, the transmitter site for WAUR 930 kHz is located near the junction of highways 47 and 71, 2 miles south of Yorkville. The tall tower you saw during your trip down to Sandwich was for the local FM station. (Thanks, Tom, for the info; I was in Yorkville also, but didn't see that tower--rce) As for the new 820 kHz station in Chicago, nothing heard here yet (10/13). (or here on 10/21--rce) DX is slowly picking up here. But many evenings are spent playing "bus driver" for my two daughters (ages 15 and 13). School band activities, girl scouts, church functions, etc., really take up a lot of time for the patents. You single guys don't know what you are missing! While driving our '86 Chevy Celebrity wagon "bus" I listen to the car radio

(10 kHz step tuning). This readio is fairly sensitive. Heard Jamaica 580 with it a few years ago while driving around in Shorewood. But the clock/computer produce a terrible amount of noise on 1050 kHz and a dew other channels, making them unuseable. Latest catch at home is the new Mexican on 1370 (XEMON). They put a good signal up here most evenings. 73's.

Some local items first: WNSH-1570 (Beverly/Danvers, MA) has been silent since late Sept. Sometimes an open carrier appears; most of the time they are off totally, leaving WPEP (Taunton, MA) on top well over CKLM and two NY state stations (Riverhead & New Amsterdam). At noontime, the stations under WPEP are only detectable by using phased longwires. On 740, the WLVG call has been replaced by WWEA. WWEA plays primarily light-rock and uses the slogan "Earth Radio". One announcement stated that they would offer free air time to environmental organizations. Address given is P.O. Box 848, Needham Heights, MA. Operation is "normal daytime". Signal strength seems unchanged, so it sounds like the same power from the same Cambridge, MA transmitter site. Of course, power, schedule and facilities may change later. A correction on 1440 (Worcester, MA): call is WVEI, not WZEI. I've found a great local DXpedition site: Granite Pier in Rockport, MA. There's room there for at least 300' (90m) of wire and its seaside location brings TA's, Caribbean stations, etc. screaming in just after sunset. The location is about a 40-mile, 50-minute ride from the house and from my office in Tewksbury. I'll be getting back from a California business trip by the time this reaches print. While out there I expect to get together with Neil Kazaross and (possibly) other DXers. There is some DXpedition activity planned here in the Northeast on 8 & 9 Nov 1991. If all could "hit the dails" those days and flood the DX columns with loggings, that would be great. International DX is of special interest. Some information relayed to me from a European special interest. Some information relayed to me from a European source ways that there's a Greek station on the clear frequency of 1615. So if Vatican on 1611 is strong, slide up and look for Greek music on 1615. On 10 Oct, I had quite a run of Caribbean and South American stations just after sunset. It was quite auroral, so TA's were limited to North Afrira, with Senegal-765 at local-type strength. Angola-1088 was noted. Hindu music on 600 (Surinam) and 760 (Guyana) made of interesting listening. Receptions were from Rockport, MA with the Sony ICF-2010 fed by two on-the-ground 100' (30m) longwires going through the MWDX-5 phasing unit. It looks like a good season is shap-Dallas Lankford's Drake R8 afticles have steered me away from that receiver, at least until they get the "bugs" out. 73/Good DX.

Ernest Cooper, 5 Anthony Street, Provincetown, Massachusetts 02657 (cont. from last time...) We were without electric power until 8/22, but parts of town went powerless for more than a week. Local WOMR was off for four days, as we don't have a generator, and when the power came back on, the surge did much damage to the transmitter, so that we operated only on the exciter for a couple of weeks till we were able to get the necessary parts and have them installed, meaning we were sending out about 40 watts. But, everything's back to normal once again, and the storm now is only another chapter in the history of Provincetown. (new report) Local BCB news: WVNE-760 Leicester-Worcester is now on the air, apparently daytime only for now. WRCA-1330 has been taken off the Star Communications all Sports network; WEEI-590 now has it 24 hours daily, and WRCA is no longer AN. WFTQ-1440 Worcester has changed calls to WVEI and now is merely a relay for WEEI-590, and the legal IDs are given simultaneously as WEEI Boston and WVEI worcester". The Cape presently has only one AM station; WKPE-1170, which is a relay of their FM on 104.7. WOCB-1240 and their FM on 94.9 have gone dark, and I believe they'll be silent till some time in November when the new owners take over. I've been trying to get enough data from WVKZ-1240 Schenectady, NY for a report - they're all news - but apparently so is WGBB on the same frequency, making it more difficult to tell which is who. WLVG-740 Cambridge has a short sked: 0800-1605 weekdays; 07300-1605 Sundays, with their first five Sunday hours featuring half-hour programs from various area churches. Cx have been somewhat Auroral for the last several days around the end of Sept. and the beginning of Oct. - WMMB-1240-FL often is on top around 0200 with Larry King! On Tuesday 9/17 WBAL-1090 was off and ins was a fairly strong FF which I am 99.44% sure is in Martinique - they give IDs very rarely, and seemed to be the same station I heard on 1090 when I was in St. Croix. Sun. 9/30 I caught the ID of Surfside Beach-Myrtle Beach ID on 1270 at 0300, but the calls sounded like WYMB, not WYAK! Forward - March!

Gary Siegel, 2955 - 115th treet, Toledo, Ohio 43611 Greetings again. Nice to finally be situated at the new homestead and also nice to have the DX season back upon us once again/ Before I cover some of my recent catches I should pass along some noteworthy differences in reception between my former residence and this new location. While only about 3/4 of a mile apart-and perhaps only yards closer to Maumee Bay when figured as the crow flies, I have been amazed at signal level differences between those stations on or near the shores of Lake Erie. Examples -- WERE-1300, a tough, nearly non-existent catch at 106th St. becomes the dominant on 115th St., WOOD-1300 tends to be more dominant on 106th St. Same is true for WHOT on 1390 over WNLF on 115th, WNLF covers 1390 on 106th with no WHOT there! WSLR-1350 booms into 115th St, but on 106th is a week part of a three-prong fight between them and WHMI & WCSM. WHLO-640 which is a virtual noshow on 106th does nicely at 115th. WGR is easier on 115th than at 106th and the Cleveland 1220 & 1260 are also noticeably better. Even this small move closer to the water has its effect on changing my daily reception. Now WLEC-1450 is highly dominant days and always in there at night. I haven't determined yet whether these pick up in signals for the lake shore communities will hinder my DX ability on some of those channels but I would also in turn expect this to create a "window" into the Mid-Atlantic states, New England and eastern Canada. I have noticed at least some aid in ringing up a couple recent stations that weren't had before. On 10/11 at 2015 & 2040 I heard while on 1260 a HS PB game with the East Side Rams. The other HS was Palatka, turns out it was WIYD in Palatka, Fla. The East Side HS is from Gainesville, Fla. The latter time was reserved for WCRE-1420 in Cheraw, SC, caught a couple ads, promos and ID. Interesting that both these were on Cleveland frequencies so the fact that their daytime signal levels are greater does not necessarily translate into no DX territory at night. Those two could represent the kind of "window" I referred to earlier in this forum. My other two receptions of late were on 10/4 at 2115 while sitting in the Rogers HS parking lot in SW Toledo, I noticed the airing of the Ala.St-Troy St game atop 1410: Turns out this one was WSKN in Plattesville, Ala, guess they wanted to make sure everyone heard the game, hi! On 9/28 at 0655 while on 1240 of all places, caught a station coming out of a song, into weather and IDed. It was KICD Spencer, IA. This was a nice surprise to say the least. It points out something very worthwhile for DXers to keep an ear out for especially at those SRS & SSS transitional periods. DON'T ignore the graveyard local channels. They can in brief moments sometimes bring up some very nice DX for very short periods of time-patience and timeliness there can pay dividends. This reception was very similar to the KNHN-1340 KS catch I reported in my last Forum. Good luck with checking these and also watch for the SS coming in this time of the year. 73s. PS--anyone have ideas as to who my Rel. 1370 would be after 0600 during the week? Have noticed this one here with UPI news a couple times. Came in from SE-NW direction. It should also be noted that I've heard KICD again since 9/28, guess when it rains it pours, eh. (Gary, my semi-local WKSH-1370 Sussex, Wisc. is religious, but they run USA Radio network news at :55--rce)
