Another excellent turnout this week, and welcome back, Tom. Since reports lately have been fairly regular, here are the reporting guidelines for the column: Reports are accepted from states east of the Mississippi River in the U.S. and from Ontario and east in Canada. Also, if you live overseas in the Atlantic region, Europe or Africa, report to OXWW-E. Hembers in Central or South America may report to DXWW-W or DXWW-E depending on their own judgement, but I'd expect only Mexico or western S. Am. to go to DXWN-W with the rest going here in DXWN-E. Carribean reporters belong in OXWW-E, also. Back to the U.S., if you live in any of the states bordering the west banks of the Mississippi (LA, AR, MO, IA, MN) your DX is probably still of best use in DXWW-E, so use your own judgement. Wherever you live, once you begin reporting to one of the columns you must continue reporting to that column (i.e. cannot alternate back and forth). I do not usually like to select deadlines since most all international DX material is relevant - if it does not arrive at this QTH in time for a column it automatically goes to the next one. As for material to report, anything unusual that may help others hear and 10 a particular station of an international nature. Everything outside the USA is game excepting Canadian stations which go to the RoundUps. Any and all material relating to foreign DXing including articles, station changes, QSL's, etc. are of interest here also, but keep in mind that OX Monitor hosts columns for both international changes (DXMWII) and all QSL's (Verification Signers). If something is received here that is more appropriate for another column it will be forwarded with delay - so again be selective. Other things like interesting stories or long descriptive writing probably belongs in the Forums. If you have ong lists of loggings please categorize them and put them in frequency order if possible, using the format seen here in the column. It sure makes it easier to organize a column this way.

Glad to meet all you fellow DXers in the IRCA. I have been a DXer for 25 years, yet never joined a club until now. Why? Who knows? Anyway, I am 39, married, 5 kids, repair custodial equipment for a living. You know, carpet extractors, scrubbers, vacuums, etc. I am a born tinkerer, and love to fabricate my own stuff. I use modified Ford car radios for DXing, and homemade loops. This is a good place to DX, out in the country, no cable TV, little interference except 15 kHz markers from that evil eye downstairs which seems to run 24 hours a day! I am not a big verifier, content just to log the station unless it's something really rare. I recently bought a DX-440, and was somewhat disappointed with it, though I love the digital readout. The darn thing gets spurious responses all over the place if you hook up a wire with no antenna tuner. Longwave reception requires an external loop antenna. Using the internal antenna, you get nothing but hash from the synthesizer, and an untuned wire gets you spurious responses from all over the shortwave spectrum. It's a decent performer for BCB, has a fair filter, and the tunable BFO really helps locate sub-audible hetrodynes. For the money it's a good buy, but I still use my Ford radio to DX. If anyone has ever tried an ARN-6 or ARN-59 direction finder for DXing, I would like to hear from you! Anybody else out there love old radios? Drop me a line. I've spent more time the past year learning to use my computer for the hobby than actually DXing. Funny thing is, now that I have the thing set up to log stns. print forms and log sheets, etc., I find that I prefer the handwritten ones! The computer generated forms are too impersonal. WNRV-990, Narrows, VA has changed formats, from AC rock to C&W. No more "Rockin' the two Virginias". (Thank God.) Still daytime only. One of the unique things about this part of the country is bluegrass/gospel (hillbilly) radio stations.
