The verie I got back stated they were on 500 watts PSA power at the time. Forgot to mention last time about an LMA (local marketing agreement) going on here. Since last October. KLAU-1540 and their FM KMBY (107.1) moved from their Monterey offices/studio to Salinas with KHKN-540 and KHKN-FM. KMBY broadcasts live there and leases the studios from the 540/104.3 owner and sells all four stns in combination. It's a new and controversial idea that is being looked at by the FCC right now. I notices just recently on KLAU-1540 they promo San Jose Sharks hockey saying "skate on down to the left of the dial to our sister stn., KHKN, 540-AM" I other news, KEEN-1370 will drop country on 1/31 and go // with KBAY (FM 100.3) and change calls to KBAY-AM. Ruumor is that if they can't sell 1370 by the first week of April, it will go silent. The new KPLS-830 in Orange, CA has taken over 830 overnight here with a good signal. No more WCCO I guess. (1/23/92) Hi everyone! I haven't checked in since November right after Reid took over. Reid, the column looks sensational! Keep up the fine work. We went to Olympia and Puyallup Jan. 19-20, giving us a chance to check out the Country Gold Network, headquartered at KJUN-1450 Puvallup and relayed on KTOL-1280 Lacey-Olympia. Bruce Portzer phoned Jan. 11 with the "flash tip" that KLSY-1540 had split from FM-92.5 and was now "KBLV Bellevue-Seattle" with Country Gold ID's. So I set pushbuttons on 1280-1450-1540 and checked it out. 1450-1280 seem to be mostly simulcast from the KJUN studios on Interstate 5, live deejays of variable talent. Top-of-the-hour ID's on 1450 are for all three stations. We caught KTOL giving a local breakaway ad and a local ID for KTOL only, then going back to the network. However, as of Jan. 20, KBLV is not relaying the others, and gives no ID's for anything but KBLV, just doing what sounds like automated country. I wonder if this is temporary till they're connected to KJUN, or if they will be separate most or all of the time. All these stations play a broad spectrum of new and old country, classics from the 1950's and 1960's, some from the 70's and 80's, and a touch of current music. However, they don't play the same mix of familiar country favorites from current artists (1970's to today) that most country stations play, and they're not "traditional" old country either. They'll throw in offbeat stuff like C.W. McCall's "Wolf Creek Pass" or novelty tunes from old 78 RPM records. In Lacey, we noted KTOL's studios are above a store near South Sound Center, same place where KLDY-680 used to be! Both Lacey stations, 680-1280, came back from silence as relays of out-of-town stations! Up till recently, AM stations relaying each other were common only in Canada (especially B.C. and Quebec), and the 1960's-1970's joint operation of KITN-920 Olympia and KITI-1420 Chehalis was unique. Now this phenomenon is popping up everywhere, even of FM, now that the FCC has encouraged it. The AM band continues to fascinate us! 73 and good DX.

Buy 2 cans of soup and a box of crackers (on sale)—get a free "kit" containing the same, plus a limited edition logo mug. A good deal, I think. Besides, I like to stop at station promos when not too far out of the way. Latest about WNBS-AM & TV in the Courier-Journal (1/11 & 1/18): Troy Cory promised to pay his former employees and called Governor Brereton Jones, asking if he could be allowed to move the Stubblefield remains from Murray, KY to Washington. Cited vandalism of the current grave. Also said Cory abandoning his quest to have Stubblefield recognized as true inventor of radio. Later sued former 'NRS owner for \$12.3 million, charging that fraud was involved in the sale of stations. Cory claims to have sold millions of his records in china. I wonder ... Louisville Tonight on WHA -TV11 recently broadcast a segment about a once weekly TV news program by students at couth Oldham Middle School in Crestwood, KY, called (naturally) WSOM. What impressed me was the teacher/producer and how good the kids were. One of the kids interviewed Sam Donaldson on camera and it was great. There is hope for the species after all:

Mark Connelly, 30 William Road, Billerica, Massachusetts 01821-6079 I tried for the KUAI-720 Hawaii test on 12 Jan, but no luck. At 0950 Z (0450 EST), CHTN was loud and fully in control of the channel. WGN occasionally popped up with equipment testing. By 1000 Z, WGN shut down, as they had promised. That didn't help all that much, as CHTN was still pest #1 on 720. I set up two operating positions. O One consisted of the R-390A fed by two 37-meter wires through the NWDX-5 Phasing unit. When the ohaser was set to null CHTN, a cardioid pattern was produced that had maximum pickup from the west-southwest (opposite to CHTM). That set-up produced a weak religious station that might have been KDWN Nevada. The econd operating position consisted of the Kenwood R-600 fed by the RTL-1 Loop / MWT-2 Option 5 Tuner-Controller. With the loop oriented to null out CHTN, a north/south figure-of-8 pattern was produced. The dominant station on this arrangement was YVOL Porlamar, Venezuela; they roared in with their sign-on with the Venezuelan anthem at 1001 Z. At 1048 Z, WGN popped on briefly with some testing, but (thankfully) cleared off again. Still nothing resembling KMAI was showing as I worked the two set-ups to keep CHTN nulled. At 1100 Z, on came WGN; this was followed immediately bu the sign-on of WWII (PA). WWII steamrolled everybody, including WGN and the now-fading CHTN. CHTN is audible here at fair level all day on groundwave; by 1100 Z, with dawn imminent, they'd almost faded to their day level. With a messy stew of CMTN, WWII and WGN on the channel by 1105 Z, I bailed out in favor of a couple more hours of sleep. Hopefully, some of you did better than I. On another subject, hapless WWSH-1 70 is silent again. The transmitter building of the beleaguered station was damaged by a fire supposedly set late at night by teenage vandals. Semi-local WXLO-960 (Fitchburg) has bitten the dust. Now, a mismatch of CHNS/WELI/WHYL/WEAV is heard days in Billerica (through very heavy WROL-950 slop). At coastal sites (e.g., Scituate, MA), CHNS clearly dominates 960 on groundwave but WROL-950 and WYNZ-970 have to be nulled to get much of anything. My recent listening session from Scituate found some other interesting groundwave catches on relatively open channels: WZYQ (MD) dominating 820 (presumably o/WNYC/WIQT); CBGY (NF) atop WSB (GA) - both ID'ed - and a third station (Baltimore?) under on 750: CPT (NF) o/u WLIX (NY) with WDMV (MD) and CJSB (ON) lurking behind on 540. One thing I noted is how sensitive the DX-440 is

when fed by a good loop: this is remarkable because, on its own, the receiver seems low in sensitivity.

Karl Zuk, 154 Old Post Road North, Croton-on-Hudson, New York 10520
Canada seems to be dominating my DXing lately. I had a very unusual and pleasant reception of CKAP, Kapuskasing, Ontario commutting to Manhattan on Jan. 12 from 0615 to 1730 EST. Although it operates with 10,000 watts, I had never pulled it in before. CKAP identified itself as AM 58 and featured a man and woman morning wakeup team. I heard lots of mentions of Northern Ontario and local ads. The strength of their signals that morning was extraordinary. I enjoyed their show for over an hour, all the way into the caverns of New York City, with local-like copy. I have yet to hear it again! Also heard, was CJCH local-like copy. I have yet to hear it again: Also heard, was CJCH in Halifax, Nova Scotia. I usually don't hear much on 920 of interest. A local station in Kingston, New York dominates the frequency, and there's usually a decent amount of slop from WPAT-930 Paterson, NJ, with their beautiful music format. I heard some interesting mentions of maritime weather and local events that was a nice departure from usual New York content. If you have heard new CIAO on 530 kHz from Brampton, Ontario, here's some added info. on them. I recently interviewed their Operations Manager, Rick Sargent, for Monitoring Times. Read all about it in the March issue! CIAO operates with a sloper wire protecting 540 CBEF Windsor, Ontario, during the day, with an omnidirectional pattern at night. Their 790 facility employs 11 towers for two directional patterns. Digital receiver intermodulation prompted their move to 530. A new station has appeared on 640 in Toronto. Take another local on 1430 and subtract 640 and you get 790. In many places, but only on digital radios, you could hear three signals mixing on 790. They went to the CRTC and begged for a solution. When CJFT, Fort Erie. ON applied for 530 and got a temporary authorization for 250 watts with DA-D. I think everyone has fallen for their wierd ethnic formats at least once. My first reception was strange. They were broadcasting in Sri Lankan, I think, and I thought I had something really exotic, until I heard the English words like "Toronto" in their ads. Very interesting station on a frequency that will travel far! They are working on improving their new ground mat for 530 kHz, before they mail in their final proof-of-performance to the CRTC. They encourage QSL requests, but please send a self addressed envelope and at least one IRC for a reply. Thanks for opening my eyes to such an interesting pastime." Let's make sure WE get him, and not that other club, hi. Testing on the mountainside was quite promising. Logged several new stations on a mediocre night, and IDed Al Merriman's TAS station on 1620. (See FDXR.) I will probably put a couple of wires up there, one NE, one SSF. It's an out of the way spot, yet still frequently visited by humans, so I'll have to start each wire deep in the woods, away from the site and hoop up a "jumper" when I go to "X. Don't want a replay of Gerry Thomas' beverage experience, hi. In response to my query, got an envelope LOADED with stickers and sample uSLs from Dario Monferini, and a sample of the "Play-DX" newsletter. One of the tips was that WCSE-SC is now using its FM call WXTC on AM. I knew that's what they were using when I heard them, but you know how these // stations are. Nothing peeves me more than listening to some unID station for ages hearing them ID as "FM 96". There oughta be a law against it! Hope everyone ishaving great success with their "Xing. By the way, a belated welcome to Keith Short, who has furnied me (for the first time) with an experience I'm sure all of you have had - seeing your own pesty locals reported as DX stations. It's a strange feeling in many ways. Also, thanks to J.D. "tephens and the entire CPC effort. I share rce's feelings - seems like DX season just started, and it's already winding down. Out of room. 73 de LLH.

### THE INTERNATIONAL RADIO CLUB OF AMERICA (IRCA)

The IRCA is a non-profit organization devoted to the hobby of hearing distant stations on the AM Broadcast Band (510 - 1630 khz). DX Monitor, the official publication of the IRCA, is published 34 times a year, weekly from October to March, twice in September and April, and monthly from May to August. DX Monitor contains members' loggings, articles on radio stations, receiver reviews, technical articles, DX tips, and other material of interest to Broadcast Band DX hobbyists.
