A few reports this time around, including some information from Art Peterson: Regarding Gerry Thomas' 1/25 DXWW-E MER-1685 logging, important beacons have a standby xmtr. The variations of ID (MEA, MEN, MEK) indicate that the primary transmitter keyer was having problems, so the standby was actuated. This is indicated in either of 2 ways -- by adding an "E" to the ID (MER E) or by inserting a space bewtween the 2nd and 3rd character (ME R instead of MER). Foreign beacons often use the first methed and US beacons the second. Thanks, Art, for passing along these items. Hope to hear from you again should you have other information.


WJIC operates with a power output of 2500 watts using a Nautel solid state transmitter. The antenna system is a four tower directional array.

Hi everyone, Happy Anniversary IRCA. It has been a long time since I have written a forum. I hope you have not thought I had disappeared, hi hi! I am currently stationed at Seoul, Korea and live on post at the Yongsan garrison with my wife and four children. Hello once again! I hope that this is in time for the anniversary issue, even though it seems to be my tradition to be late. Maybe I can break with tradition this year, hi! OK, the re-intro -- I'm now 52, married, with 5 children aged from 14 to 3. That is at least part of the reason why I've not been doing too much DXing lately, hi! Also, I remember when it was possible to hear a dozen new stations a night, and now it seems like a real struggle to hear even one new station. I began DXing in the early 1950's with a 6-tube Zenith, then built a Heathkit AR-2, got a used Hallicrafters SX-71 from a neighborhood ham, and traded that for a Hammarlund SP-600-JX17 in 1961. I've used other receivers like the Hallicrafters SX-62 as well, but the Super Pro has been the mainstay of my shack until a couple of weeks ago, when it developed a bit of IF instability. I suspect it is just a bypass capacitor going sour, but until I can work on it I put my Collins R-388 in service, with a RAX-1 receiver hooked to the IF output and used as a tunable 500 kHz IF, 160 kHz IF, and audio section. ("Q5-er" is the ham term for that, though a BC-453 is what is normally used.) I was just looking over my logs from 10 years ago and noticed that YVMN 1210 was a nightly visitor; CMAB 880 was almost a pest, but could be nulled well enough to get OBZ4N on 880.1 fairly regularly and TGJ once or twice. On the Pacific side, Kiribati 846, Yanbian 1206 and HLAZ 1566 were so regular that I used them as propagation indicators. My best catches from here would have to be Senagal 765 and Sarawak 873. Also, 891 has been a profitable frequency with Fiji, Thailand, JOHK, 5AN, HLKB and tentative DYSR on there. Thirty years or so ago, from Colorado, it was possible to hear 250-watters KIKI 830 and Bermuda 1235 fairly regularly. Colombian 1-kWers were heard in abundance, ZFY (British Guyana) 660 was almost a pest and even Australia and Japan could be heard on many Monday mornings. In the 1930's it was even wilder. Best time, Leonard, to hear them for you might be at sun-rise skip and at sunset skip. On to other things: in the 2/26 Wall Street Journal, there was an article about a report written by the staffers at the FCC regarding further deregulation of the radio industry--specifically the AM and FM stations. It seems that over the past 12 months, 153 radio stations -- mostly AM--have "gone dark", to use the trade term. The report suggests that the national cap on station ownership (now 12 AM, 12 FM, 12 TV) replaced by a standard based on how many stations are in the local market. The recommendation is that if there are 9 or more stations, that one person (or company) could own any number of stations as long as the audience share doesn't exceed 20% to 25% but that the broadcaster probably wouldn't have to sell stations if they grow beyond that limit over time. In markets with eight or fewer stations, that a single broadcaster could own half the stations in the market, regardless of audience share. Will the FCC adopt the staff report? Time will tell. As for myself, I have done very little lis-tening in the past year. As one person put it, I've been busy with the "new house" things, plus school and the moonlighting--which, of course, has to fall during a good time for listening, hi! I work evenings, 1700-0200+ CLT as a rate clerk figuring out the freight charges on sigments for Advance Transportation, plus moonlighting as a tax form preparer for H&R Block. If you think doing your taxes were fun, I should be doing well over a hundred this season -- and probably the fun ones are those running 6 or 8 different federal forms, hi. started DXing in the late 50's in Michigan. 

A couple of changes to the BPE-C article: First, there's a correction to the orientation of transformer T1 as shown on the BFE-C assembly drawing. I had put T1 onto the card correctly when I did my testing, but its position on the drawing was accidentally reversed. Also, as a result of urban testing, I've set resistors R3 and R4 to 2.21K, 1% rather than 4.75K. For these changes, please refer to the modified drawing below. R3 and R4 should also be changed on the schematic and parts list.

More notes on interference-reducing antennas

Back in the Bad Old Days (when the components parts of a radio occupied a whole table) it was necessary to connect a large outside antenna in order to capture enough signal to rattle the speaker. With the advent of tube sets and plentiful gain the size of antennas shrank until room antennas were common. The increasing use of electrical appliances in the 1920s and 1930s created so much interference with the new medium of radio that something had to be done: eventually legislation was introduced requiring certain standards of appliance suppression. Nevertheless, better antennas were required for reliable daytime reception of even local stations, let alone distant reception and this required that antennas be located where the interference wasn't. Technical writers in the 1930s lamented that the development of plentiful RF gain had led only to inefficient and interference-prone antennas being used. In our time, technical information on antennas readily available to BCB listeners is mostly written for radio hams who often use higher frequencies and much of this information is not directly useful for the BCB.

Investigation of interference showed that it was at its weakest above the house and signal strength at its greatest at this point. Dennhardt (1) gives the following figures for signals, relative to 1m above the roof ridge for a three storey house:

These figures give a clear idea why raising the antenna above a house can make such a difference to the signal-to-interference ratio and also show why even the owner of an active antenna should strive for a location as high and clear of the house as possible, even though it may be more convenient to dangle it out of a window!

Strange as it may now seem, coaxial cable was not readily available in the early 1930s and many improvised screens were tried so that the downlead from the antenna should not pick up interference. Although such "screened antennas" (i.e. antenna + screened downlead) picked up substantially less interference, they were criticised for their lower output, until the introduction of transformers at the antenna and receiver to compensate for the cable capacitance shunting effect. A number of such antenna kits were marketed in England with impressive-sounding names such as "Eliminoise" and "Rejectostat". However, then as now, having bought a radio, many people were reluctant to invest any money in a decent antenna and an "anti-interference" antenna in Germany cost as much or more than the "People's radio" (Volksempfänger VE-301). A constellation of circumstances conspired to improve the situation in Germany: In 1933 Hitler declared listening to the radio to be a civic duty and with his connivance the radio industry quickly organised a production monopoly of receivers and a hire-purchase system of payments for the Volksempfänger. Business acumen and communal antenna distribution systems did the rest: a single antenna was mounted at the highest point on the building (2) or at a suitable distance from the source of interference (3), amplified and then distributed to each household (4). While the provision of a low-impedance ground connection usually improves the rejection of interference, some authors have noted that benefits can be noted when the receiver ground is lifted (5)(6). It should be remembered that interference, when generated with the aid of the mains power supply, may be assymetrical (unbalanced) or symmetrical (balanced) with respect to ground and that the specific characteristics of an antenna system may make it more susceptible to one of these modes of coupling. Experimenters are therefore advised to be aware of this possibility, and to ensure that the connection between the ground rod and receiver is actually low impedance; any wire has inductance and if this cannot be held to a negligibly small value, it can be tuned out (7). Insistance on any specific length or number of ground rods for a ground system ignores the fact that local ground conductivity may be good or poor so that what is good at one location may be poor at another. Information on measuring ground resistance can be found in (7) and (8).

The use of a counterpoise system instead of a ground at the antenna location may amount to the noise-cancelling arrangement described by (9), based essentially on a patent by Beverage. If the counterpoise is correctly dimensioned, it can lead to a substantial reduction of interference, although this may only occur at one frequency, as independently observed by Dennhardt (10). Such counterpoise systems will demand considerable experimental effort, and the improvements may not be in direct proportion. My suggestion (11) that such systems may be tried where the antenna cannot be placed away from interference sources is subject to the restriction that the signal-to-noise ratio may be poor at this antenna site, even when interference has been removed. This was my practical finding from using an active antenna in a poor location (just below the roof) with an adjustable interference-cancelling circuit. However, after you have done the best you can with the location of an antenna, there may still be interference; in these circumstances, interference nulling arrangements, such as described by Nelson (12), can make a good antenna into an excellent one, thereby lowering the effective noise/interference floor of the whole receiving system. This will be most apparent during weak-signal, daytime BCB reception and the serious BCB DXer should not be without one.

What constitutes a "noise-reducing" antenna is a matter of definition, but the description runs the danger of encouraging unrealistic expectations. For Dome (13), a balanced feeder is an essential part, but most of the literature refers to a screened, coaxial cable feeding an antenna located away from interference sources as a "noise-reducing antenna". Balanced cable has practical advantages over screened coax, but I would like to correct the emphasis given in (11) that it is a necessary part of a "noise-reducing" antenna.

A configuration of an interference-reducing antenna described by Strafford (14) and cited in (11) showed the feeder-matching transformer at the junction of the vertical and horizontal parts of an inverted "L" antenna. Strafford argued that this arrangement would bring the best interference reduction when the antenna is subject to a non-uniform interference field. Recent practical tests, and some older ones (3), have shown that there is not always an audible reduction of interference when using the transformer at the vertical/horizontal junction of an inverted L antenna vis-a-vis the base feed. Assuming that Strafford's description of the operation of the antenna is correct, the specific conclusion could be drawn that the interfaring field was not uniform across the antennas investigated, or that the interference was reaching the antenna proper rather than being induced in the feeder. On the positive side, it has been found (15) that an "anti-interference" antenna reduced the effect of strong interference although it was known that the interference source was several hundred yards distant, a distance at which one would expect the antenna to respond to interference in the same way as to wanted signals. It may be supposed that the interference was conducted down the mains and re-radiated near the antenna, since examples of exactly this problem have been reported.

In more general terms, it is likely that at some antenna locations unexpected results will arise and that the causes must be experimentally investigated: Moebes gives such an example that the German Post Office had to deal with and Nelson's book contains many interesting RFI problems. It is hoped that these notes and reference (11) will enable the interested experimenter appreciate what improvements in reception are possible and to troubleshoot his own antenna system.



How I Unexpectedly Spent My Winter Vacation

I really should have planned it better. It was tough enough DXing from Puerto Vallarta and Barra De Navidad last January on a friend's Sony AM/FM/Tape player. No accurate frequency read-outs, no IRCA Mexican lists. In fact, I didn't even ID one of last year's catches til this January, when I finally did get the Mexican list. But see, I didn't really plan to do serious DX. I was going to sit on the beach during the day and identify cervezas in the cantinas at night. Ha. That was before the Monsoons of '92.

I flew into Vallarta January 6th, with the intent of being there 18 days. Bleven days into the trip it had rained solidly for nine-and-a-half, so I bagged the rest of it and came home. In the interim, however, I got to spend a number of intimate moments with my Sony Sports Walkman, model WM-AF54. If you think tuning a large rx is tricky, try it on a Walkman sometime...a micro-hair puts you 50 kHz away from where you think you are, and without an ID for a reference point it's really a crap shoot. But hey, what's DX if you can't roll the dice once in awhile?

I started off in a rather unconventional manner, by booking a window seat on the plane. Some of what follows was heard through the window of an MD-80, travelling 400+ mph at 37,000 feet. The more intriguing stuff is the cluster of FM's from the Phoenix/Tucson area, some audible as far south as Cabo San Lucas at the southern tip of Baja California. I'm not big on FM DX (and neither is IRCA, hi), but I'm including these few as indicators of what's up there, E-skip or no. Here are the location codes:

(PV)...from Puerto Vallarta, Jalisco (ML)...from Melaque, Jalisco (a coastal town 40 miles north of Manzanillo, 130 miles south of PV)

No calls hrd at this point. Ancr's name sounded like Francisco Cortez. "Gracias por su atencion" spot with list of sponsors, including Coca-Cola. Then muffled ID "XEA-(?)...con cinquenta mil... de potencia." The only 50 KW Mexican on this end of the dial is Hermosillo-1580, although this could have been a feed from someone else (or a feed from 1580, but not likely). NOTE: Plane was closer to Hermosillo when signal first heard strong and distinct; closer to Los Mochis when faded.


THE ORGANIZERS
