Greetings to my new friends at IRCA. Two months after I joined our Club last summer. I attended our illustrious Monterey Convention. Steered by Phil Bytheway, the Convention proved to be a notto-be-missed, learning, enjoyable, and very relaxing event. I'm an avid fan of medium wave DX, and also enjoy some limited shortwave DX. At home I DX on an ICOM R-9000, which after a year I feel is STILL holding some secrets back from me! The 9000 is connected to a WAS-50 and AH-7000 antenna. But I travel for a living, so my Sony ICF-SW77 goes with me everywhere. Contrary to the problems reported with the 77, I feel it still "ekes out" my 2010 by at least three hairs. Being an airline pilot the air band on the 2010 is not a plus for me - I much prefer the 77's stereo audio quality. At home I DX my 77 using the Sanserino Box Loop; while traveling, I use a Radio West Great Little Loop which performs superbly. Worth, WOAI-San Antonio, KSL-Salt Lake, KOA-Denver, and a host of coastal stations from British Columbia south to the Spanish-speaking lands. Also pulled in a Japanese-speaking broadcaster, which I had no luck in identifying. While on Oahu, I tried my hardest to pull in something east of the Mississippi - no luck! Actually, I find this difficult to do from Los Angeles, much less Hawaii! Now I'll close with a few personal observations regarding my DX experience in the Los Angeles Basin. I live in Atwater Village, at the east end of a high peak in nearby Griffith Park. Bottom line; it's a real busy mess of an AM dial here. Pulling in the weak ones out of this quite often "mire" is hard work, but it's rewarding. With hills in all quadrants, strong L.A. AM signals are splashing all over the dial, exacerbated by the nearby hills. Suffice it to say, this L.A. area is a far, far cry from my much easier and so-much-more hassie-free glory AM days in the early 60's from my hometown of Columbia, South Carolina. .... NOW we are talking about a different place, a different time! 73's. It's a pleasure to be a member of IRCA. Thank you. Karl Jeter, 2115 Scarbrough Road, Stone Mountain, Georgia 30088 It's been quite awhile since I have appeared in these pages -- the workload during Jan and Feb was hectic to say the least, and most DX was limited to trying for the tests. As is the nature of self-employment, March brought a big drop-off in work, and with more time to DX, I have lousy conditions to contend with, hi. The Test effort this DX season was just superb; I believe between both clubs, there were over 50 tests arranged. I just wish I could have heard more of them; only 10 were heard and/or verified so far. But, there were some great log-gings, like my 2nd Utah station (KMTI test), since my 1969 logging of Delaware #2 (WDOV), since a 1970 hearing of WDEL-1150, and NM #3 (KHAC-880). I have not heard from WIQT-820 to date, although I understand several others have received veries, so a follow-up has already been sent. Other tests heard were: WVVW-630, WSKE-1040, WJIC-1510, WQTW-1570 (unneeded), WGEE-1360 and KMYZ-1570. Most of the other scheduled tests were attempted, unless they were already heard/verified. The verie count is 1478, as I begin to close in on the 1500 milestone-would like to accomplish that by year's end. WSDQ-1190 Dunlap, Tenn. sent me a nice blue logo basball cap that I might save as a future auction item, and WDUF-1120 Duffield, VA returned my cassette with ninety minutes of their excellent bluegrass/traditional country programming. This is a wonderful small-town station that has bucked the trend of satellite or homogeneous programming; they even operate, literally, out of a barn! The owner of WDUF is Jimmy Smith, a former Grand Ole Opry star, and the entire staff (except the C.E.) is the Smith family. The prepared card returned afteral several folow-ups from WRDJ-1560 Daleville, AL included the message: "Be sure to listen on March 30 at 0500 CDT". Well, I forgot to, but wonder if this was either a test (PoP or f/c) or perhaps a reference to their impending call change to WTAN? Indeed, WDGR-1210 Dahlonega, GA is off-the-air now, and can be added to the list of silent locals and semi-locals, which include WLBA-1130 Gainesville, WFOM-1230 Marietta, and WZAL-1410 McDonough.

Alas, Kentucky Educational Television has advised that June 13 open house will be delayed. It became apparent that new studios won't be ready for a June dedication. Got list of affiliated stations from Kentucky Network, Inc. (news) and forwarded to Bill Hardy. Perhaps it will appear in a future DXM or updater. From the Courier-Journal on 3/14: WXVW-1450, Jeffersonville, IN no longer for sale. Had some lookers, but no buyers, according to Charlie Jenkins, co-owner and station manager for 25 years. Sunnyside Communications Corp. had bought WAVG-970 in Louisville last year and couldn't own two AMs in this market. The recent FCC rule changes saved the station from sale. It will keep a commitment to local topics and high school sports/ Next page: the WNBS-AM and LPTV-46 fiasco is still going on down in Murray, KY. Felony theft charges to be dropped against pop singer Troy Cory who agreed to pay \$10,642 to his former station employees. He also agreed to create a \$10,000 scholarship for communications students at Murray State University to honor grandfather Nathan B. Stubblefield, who he claims was the real inventor of radio. Former owner Chuck Shuffett, being sued by Cory for \$12 million, is under a court order to pay two banks more than \$500,000 still owed for the stations. Stay tuned folks!

Mark Connelly, 30 dilliam Road, Billerica, Massachusetts 01821-6079 Local stuff first - WMVU "News 900" is on from Nashua, NH with a news / sports / talk format. It is probably using the facilities of long-silent WOTW: the signal is about the same as that from WOTW's old 1 kw rig. They clearly dominate the channel here days - way over WCLZ can only be brought in clearly by phasing or looping WMVU. WKPE-1170 has been off for a while now; I'm not sure if this is permanent. I miss them as I liked their rock and because they were useful here for judging performance of antenna systems on signal paths to the eastern Caribbean and Brazil. If they were loud compared to stations in "pest" directions (e.g., west), a given Antenna-Under-Test would clean up during an aurora. With both WKPE & WJCC gone, 1170 is now fairly empty here days (line noise is heard). Maybe pre-sunset 1170 TA's will be more likely now. I'll have to check out 1170 (throughout the day) from a good beach / saltmarsh QTH such as Salisbury, MA. WNSH-1570 is still off - maybe forever. WUOK (ex-WOCR) has been on (with CNN News format) for a while: it dominates 1240 with WOON/ WFTN in the background. For the last few months, local WUNR-1600 seems to have dropped power considerably (perhaps to 1 kw or less from former 5 kw). WUNR used to be within 3 dB of WNTN-1550; now it's at least 10 dB weaker. WLNG (NY) can be heard days more easily in a or phaser null. At night, even within 15 miles of the Newton WUNR transmitter, QRM from WWRL (NY) can get bad. Recent activities: WLNG (NY) can be heard days more easily in a loop been more active at DX-project building/testing than dial twisting. Conditions haven't been too impressive: just a few of the highestpowered "routine" TA's have been showing. Of course, after having DX'ed with phased Beverages from Newfoundland, little that can be heard here is likely to be impressive. On another matter, I think all DX columns should use GMT / UTC rather than a mix of local times. That's what the ham and shortwave clubs do. Also, because number-style dates (e.g., 4/2/92) aren't universally consistant, a date with a 3-letter month abbreviation is preferable (e.g., APR 2 or 2 APR). Language abbreviations still differ between MW and SW clubs - is there any real justification for this? Sw clubs typically deal with more different languages, so their abbreviation scheme is more advanced. MW types should adopt it. Comments? As we move from the DX session to the spring/summer antenna construction / test / repair season, don't forget to send in your antenna tips. 73.

Leonard Hyde, 1806 Whipple Drive, #26, Blackburg, Virginia 24060 Today is Monday, April 6. Saturday we got 7 inches of now. Now, it's in the upper 60's, the snow is gone, and I am going Beveraging. Armed with my new phasing unit, my loop, 1725 feet of wire, a hit list of yet unheard stations in the region, and the other necessities, I head for my mountain hideaway. After getting the wire down to the NNE, I settle in for some daytime DXing. Of course, I want to try out the phaser first, so I just happen to hit 1030 as the first frequency. After some fiddling, I manage to phase my local, WGFC-1030, Floyd, VA, and wonder of wonders! There is WBZ, and a station with a male ancr in 35 playing flamenco mx that can only be WOSO-Puerto Rico! No readable ID's heard, but the only other SCANT possibility is Cuba. and there are no other Cubans noted. The hit list dwindles noticably, but the phaser still needs some work, as I am unable to phase dominant WKDW-900 to hear previously unheard WODY-VA. It seems that stations directly in line with the Beverage will just not null. Yet, I am able to phase many of my pests, such as WRVA-1140 and WRT-1110. I probably need a level pot for the Beverage - the signal level is just too high compared to the loop. The phaser is still in the experimental stage, so problems can be expected. I have incorporated features from both the MWDX-5 and the LIL-3, but have no level pots as yet. Later, after dark, Cuba is back on both 830 and 1040 in EE with the usual overpowering signals. The 1040 frequency is being jammed with a low growl and a cycling high frequency whistle. Who says the Cold war is over? On other fronts - enjoyed Jean Burnell's first IRCA Forum. Which "Jean" is it, the EE or the FF? I have never gotten into SW DXing, but the possibility is always there. On the higher freqs TVI is less a problem, and antenna lengths are more managable. I just love the BCB, and always will. Goes back to those AM's when I was a teenasger when I would stay awake as long as I could with that tiny little

I was reading a special advertising section in the 4/20/92 Business Week about cellular phones. With the airline's discretion, cellular phones may be operated at the gate or during longer waits on the tarmac but not while taxiing or in the air. "...for the same reason that cellular phones are prohibited, so too are gadgets that receive adn transmit over the airwaves, such as portable radios and TVs.... I would say radios are still banned, even if people get away with using them in the air. To another subject brought up by Mark, after 27 years in the BCB clubs (and more in the hobby), I still can't see any reasons why a BCB-only club in the US and Canada should go 5 to 9 time zones east of him to let someone else convert the time back some 5 to 9 time zones to find out information. I can understand why a SW club would; most of them probably are listening to several continents, but not the US BCB clubs where perhaps only a few (relatively speaking) are die-hard serious foreign DXers. I can see the European clubs using GMT/UTC but, to them, it's no different that IRCA using ELT as it's standard. Perhaps a couple or three zones different but still something is common use in the area probably. How many times do you hear on TV about programs that will be on at 8PM Eastern and Pacific 7 Central." What are the advantages to most of the members living in the US and Canada if we were to go to GMT/UTC? After all, the foreign section now is GMT. 73. See you in three weeks.
