

Greetings from the Great White North where everything is green, very green. We have had more rain the last two months than we have had in about 4 years. Unfortunately the DX has been the worst in at least 5 years. Two trips to the Valhalla Beach DX site netted only one new catch and enough mud to keep a hard of pigs happy. We had to walk in all of our stuff 1200 feet or so to the bus. The batteries were the worst!! Good exercise though HI!! The PLAM or Phase Locked AM board mentioned previously has been tested out well. The board is well worth the price as it really does make a difference. The New Zealand catch on 756 would have been nothing more than a HET except for the PLAM board. The board is produced by ESKA and EDVIS is Sweden and makes the old ICOM R-70 into a new rig. The board once engaged locks onto the signal when you are in the sideband mode of your choice. By using the PBT on the ICOM you can really make the signals come up out of the mud. Several times now 1555 Cayman Islands has been made quite clear by use of the PLAM board. It can now be called a regular catch at the bus and often here in Winnipeg on the Loop. Once the PLAM is on you can use the RIT or tune in 10 Hz on the rig until the LED used for wide/narrow CW function starts to blink or goes solid. You now have the station locked up and all you do is log them. Easy to use, effective and all of this with the 2.4 KHz band width filter in use to cut down on the splat of nearby stations. This truly is the ultimate add-on for ICOM and NRD users. conditions would improve so I can go after some good DX I will be very happy. Watch out for new loggings once the new season gets underway in Sept. Take care and best of DX to all of vou. 73 Shawn

Back in May, I picked up a small radio put out by Sanyo (model RP42) to listen to at work. It's a "Walkman" type radio but smaller, and I needed something which would fit in a small corner on the desk. My personal feeling is that I could have easily picked a better radio to buy. It's real sensitive on the tuning in the sense that either you're tuned to the station or you're not. Perhaps it's the building I work in or the fact I sit in the middle of it with a lot of truck trailers around the place, but I've found that for locals it's "somewhat decent" but out of town, you can just about forget it. I'm lucky if I can get WMAQ-670 or WBBM-780. When local WDKY-920 powers down and changes

pattern at sunset, they are hard to hear and for about an hour are almost non-existent. After that, I have to make sure the radio is in certain spots on the desk, whereas before the change, it doesn't matter. Their towers are about one mile north and 10-11 miles west of where I work. Last week when I wanted to listen to WMAQ-670 to catch the Tigers/White Sox BB game, I took an old GE radio (model 7-2500A) instead (bought in 1979 and non-stereo on FM) and had little trouble hearing the Chicago station and after WOKY made its change. In fact, later on in the evening, an hour after my sunset I was listening to the postgame show on WJR. I was surprised to hear all the southeastern Michigan spots on WJR, such as Hillsdale stores. My advice: stay away from the Sanyo, if possible. It was sealed in a plastic wrapper so it was impossible to check it out in the store, and probably a store check would have been misleading anyway in the middle of the day. It is a convenient radio however to carry while I walk to the PO or the store on Sunday to get the paper so I don't really regret all that much buying it. It's small enough and light enough to hang on my shirt pocket next to the pens and glass case. I just feel I could have done better with a different brand. Cost: about \$20 (earphones come with it). It goes thru a single AAA battery for me about every 2 1/2 weeks with it on about 6-7 hours a night five nights a week. There is no built-in speaker so earphones are mandatory unless you use a separate speaker. Sorry I can't make it to the Huntsville convention this year. I've used up all my vacation time. The annual Alabama trip was made in the middle of May. Next year, it probably wil be towards the end of April. 73.

SUBJECT: City of Santa Cruz Traveler's Information Station KPD 607, 1610 AM

Dear Jim,

You did, in fact, pick up a 2.5 mile range AM visitor information station installed by the City of Santa Cruz. The station went on the air the week before Memorial Day weekend. It has a 10 watt transmitter. Both the transmitter and antenna are located on Ocean Street, 300 feet north of Water Street. The antenna is mounted on a streetlight located in the Ocean Street median. The antenna was designed by Dick Adler, who works at DLI in Moneterey. The ground system includes radial copper leads which were laid in 2" saw cuts in Ocean Street. These radials extend out from the antenna base and are spaced 15 degrees apart. The transmitter is located on the west side of Ocean Street in a pedestal mounted traffic controller cabinet. The transmitter enclosure includes a telephone hookup and a digital voice recorder. The digital voice recorder stores up to 250 individual messages and can be programmed for day of week and time of day playlists. With the use of a remote broadcast console, we can record messages and program the playlist from our offices at City Hall.

We will soon include information about the Convention and Visitors Bureau, special events and traffic conditions. Thank you for listening to us. DXING WITH A WINNING GAMEPLAN By Leonard Hyde

NON DIRECTIONAL TARGETING

1. The "concentric ring" or "banding" approach is a good way to log your local stations, and start on your regionals. By the way, the definition of "local" and "regional" varies, depending on where you live. In the West, stations 100 miles away may be heard as locals during daytime. In the East, reception of stations 75 miles away may be difficult. Regional stations may be heard in the daytime, or not at all. A 250 watt station at 120 miles may be impossible to hear in the daytime. This is a regional station by definition, but a skip station in actuality. Such stations may come booming in for a short period during sunset or sunrise.

Technique: A station list (such as the NRC Log) is needed, as well as a map. Concentric rings are drawn on the map at intervals of 25 miles out to 150 miles, using the DXer's QTH as the epicenter. In many cases, the rings will overlap into adjoining states. This may cause difficulties. Highway maps, which are best for such plotting since they contain much detail, often use different scales for each state. A solution is to use a regional road map for the master, and individual state road maps for the detailed plotting of the stations within each band.

Once the rings are laid out, the station list is used to locate every radio station within the 150 mile radius. List the stations by frequency, according to the band the station is in, starting at 25 miles, and progressing to 150 miles. It is not necessary to actually plot the stations on the map itself. Such information as power, hours of operation, and antenna pattern will be greatly useful as well. We now have a "hit list" to work from.

Now, we begin to log the stations on the list. The 25 and 56 mile bands will go quickly. These are your locals, and you may already have all of them logged. Of course, if you receive stations in the other bands during this period, log them too. It will save time later.

Starting with the 75 mile band, things get a little harder. Low power stations in the East will be harder to hear now. Some of these stations may actually be competing with signals from stronger stations farther away. You may have to resort to SSS/SRS DXing to hear some of these. As mentioned before, these stations may briefly come in very strongly during these special times.

You will reach a point when all of the stations within 100 miles, and many of the ones out to 150 miles are logged. Now is the time to add the 175 mile band, and so on. Add the bands one at a time past this point - adding too many may overwhelm you.

As you add bands, you will get easy loggings, such as 50,000 watt stations many miles away. By and large though, the loggings will get harder, to the point that you may have to resort to more involved methods to hear them. These other methods will be discussed in later installments.

The banding method is viable only to a certain distance. Each ensuing band has more and more stations, and covers a larger area. When we reach the saturation point, where banding becomes overly cumbersome, other methods become more useful.

I originally prepared a Board letter back in November of 1991... and put it on the back burner until the 1992 convention bid was received. For various reasons, the convention bid form wasn't received until May 1 1992... the Board letter went out right away... and here are the results. I have also had many other personal committments, including taking over as Publisher/Editor-in-Chief of 'DecalcoMania', increased 'radio/TV' sticker trading activity, 'IRCA Bookstore' manager, publisher of the 'Pacific Northwest, British Columbia DX Club' and various family and church activities. In January 1992, I realized that I needed to organize my activities better, so I made up a 3 week calender which budgets my time so I deal with specific activities each day. It has been quite effective in providing the time for me to complete several projects (the IRCA Reprint Updater for one). All proposals passed. 15.1.1, 15.1.10 and 15.1.20 are declaired moot since the folks filling these positions have resigned (I already have a replacement for Registered Agent in CO). 15.1.21, Albert Lobel and Duncan Shaw also volunteered for WDXF. 15.1.23, Dale Park also volunteered for SportsCentre. The exact text for the By-Laws change required by proposal 15.1.25 will be voted on by your Board in August... membership vote will be taken in September-October... new By-Laws expected to be in effect by the next general election in 1993, which starts in October.

STATE OF THE CLUB. Membership has been fairly stable at approx 200 members. The club has NO outstanding debts and efforts are being made to generate funds sufficient for deferred membership. As expected, sales of the recent 'Almanac' has brought in enough funds to pay off the large debt mentioned in times past, as well as changing 'DX Monitor' publishing over to photocopy (from offset printing). A dues increase is not expected in 1992-93. A new Publisher is being sought since Ralph plans to step down in the summer of 1993... dues may need to be adjusted at that time. I am in the process of generating a financial statement for year 1991-1992 which will be published sometime this fall. The IRCA had a super CPC season last fall... due to the superb efforts of JD Stephens... please support him again this fall with postage and target lists. Thank you.

My humble apologies to those members that responded to my request for tapes in last year's 'DX Monitor'. I was contacted by someone that wanted to do an 'on air' presentation of AM DX and thought some exotic AM DX IDs would be appropriate. In advance of being interviewed for the program, I asked the IRCA membership for AM DX IDs. Several of you responded. Unfortunately, the person preparing the 'show' failed to contact me again... the project is probably moot... I won't be needing any AM DX IDs. A big 'thank you' to all those that volunteered their services for the club.

I am in the process of drawing up an agreement for information exchange with the National Radio Club (NRC). This document, after approval by BOTH club's Board of Directors, will address such information exchange as CPC test activity, club publication advertising, etc. An initial byproduct of the agreement is the availability of the new NRC AM log to IRCA members at the NRC member price.

Most of you have noticed my 'one-liners' that have appeared on the front page of 'DX Monitor' over the last year. I have used this to attempt to fill club positions that have been vacant for many years. I will continue to use this technique to keep club members informed. Folks holding club positions are asked to notify me FIRST when resigning... Ralph is busy enough without having to fuss with that. I really shouldn't find out about resignations by reading it in 'DX Monitor'.

Ralph plans to publish a membership list in the September issue. Any member who does not want his name (or address) listed MUST contact Ralph ASAP. Records that indicated members preference on this issue were lost in 1991... the demand for a printed membership list has required that we regenerate this information before publishing the list.

Plan is for the next Board letter to go out this month. I will also be attending the 1992 IRCA convention in Huntsville... any matter that you want discussed at the business meeting must be in my hands by August 17.
