

TRANS-PACIFIC

AUSTRALIA: 2WL-1314 switched off their MW xr 7/31, now FM only. 2KO-1413 and 2KA-783 will move to FM in Sept. 2UW-1017 & 2WS-1224 probably won't move to FM until early 1993. The new owners of 2SM-1269 sacked all their staff, as of July was playing nonstop EZL mx w/stn IDs& slogans only. Songs are automatically selected by a computer. Studios are being renovated, so pgms are originating from xr site. Station reports their audience has increased by 40% as a result of the changel 2RG-963 2DU -972 2VM-1530 & 2RE-1557 relay 2UE all night. Proposed new stns: 4RO relay at Gladstone on 1125, 4CC relay on 1584 inRockhampton, both 500w stereo. 2TM Tamworth has been awarded a supplementary license for FM, to start in summer 1993. There is a network of low powered xrs at 6 hospitals in Newcastle. The Hospital Radio Network is on 24 hrs w/medical anmts & mx 6am-7pm local time, background mx the rest of the time. IDs are inserted every hour 'This isNetwork HRN, Hospital Radio Newcastle, where good mx makes a good day*. The xrs operate in parallel, and are ex drive in theatre units w/10watts, antennas range from 6' whips to wire run alongthe gutters. Has been on the air about a year, address: Network HRN, 70 Dawson St. Cooks Hill NSW 2300. Manager Brian Blacklock likes getting

reception rpts. (Australian DXers are hearing these stns up to a few hundred miles away. They would be a real long shot up here, but not impossible given the signals the RPH stns have sometimes produced, bp) [All the above from DX Australia]

GUAM: KUAM-567 is requesting 10/10kw. [NZDXL]

NEW ZEALAND: Goldfields Radio-765 in Lawrence was expected to hit the air in July with 100 watts. Will have local pgms 0600-1800 local time, with Radio New Zealand pgm at night. [NZDXL] Access R in Nelson began 7/3 on 1440 & will operate mainly on weekends, slogan *1440AM, Your Share on the Air*. [NZDXL] National Radio has new xrs asd of 8/10: 1188 Rotorua, 1071 Masterton, 918 Timaru & 729 Tokoroa, all 2kw. [NZDXL/DXA] 4ZE Wanaka moved from 1359 to 1179 on 8/30 [DXA]

PHILIPPINES: VOA Poro MW xr was heard by Australian DXers in late Aug on 1148 kHz, 5 kHz off nominal 1143. [DXA] (Nick Hall-Patch heard them on 1147.5 in September. The freq exactly halfway between the normal 9kHz channels, plus VOA's high technical standards indicate that the move is obviously intentional. The move was apparently made to avoid co-channel interference, although it probably violates the international agreement on frequency assignments. Intentional split frequency operations like this are becoming a thing of the past in this age of digitally synthesized receivers, most of which don't have fine-tuning controls on MW. However, most of the VOA's target audiences in SE Asia & China probably use radios with the old fashioned analog tuning and wouldn't notice the shift (except for maybe less QRM). This was undoubtedly the station I heard 9/27 rather than China as originally reported bp)

RUS SIA: Radio Oumo Shinri-kyo, operated by a Japanese religious sect, broadcasts 1400-1500 on 720(Yuzhno-Sakhalinsk). Address: 381-1 Hitoana, Fujinomiya, Shizuoka 418-01 Japan. [Arctic]

THAILAND: An English BC for UN workers in Cambodia is scheduled over VOA-1575 xr 1200-1230 M-F [NZDXL]

TRANS-ATLANTIC

ALBANIA: Durres-1089 has been operating on 1098 for several weeks. [Arctic] Transworld Radio will begin transmitting over MW freqs of Radio Tirana in October. Apparently the contract calls for 1-3 hours of pgms in Albanian and other languages used in the region. Chuck did not mention any specific freq but it is probably going to be one the regular 500kw MW freqs of R. Tirana. The TWR people regard this a quite a coup because R. Tirana traditionally reflected the previous government's philosophy which was highly anti-religious. [SW Echo]

AUSTRIA: Now that FM coverage of Austria is

complete, engineers at ORF have been debating whether to switch off 1476kHz. During the evening there are regular anmits in GG asking for listeners to 'register their existence'. There is a contest with a prize of compact disks for the most distant reception report. If there is no response or if the range of listeners stops just outside the Austrian border, ORF may silence the xr. [Media Network]

BELGIUM: BRT1 is back on 927. R Donna is now FM only. [Arctic]

CYPRUS: CBC1-963 is being heard in Europe w/strong signal. Geneva plan says they can use 600kw. [Arctic]

GERMANY: RIAS has added Schwerin xr on 999 w/50-100kw, well hrd in Sweden. [Arctic] Radio D T64-1044 now here via the MDR Dresden xr. Addr: DT64, Nalepastrasse 11-50, 0-1160 Berlin. DT64 is still on the air despite at least 3 attempts by German govt to close it, which have always led to massive demonstrations supporting the stn in Berlin. [Euronews]

IRELAND: N Atlantic Radio has been hrd on 845.5 plus harmonics 2536.4 & 3382.5. R Star Country- 981 has been hrd on 1962. [Euronews]

ISRAEL: The US State Dept has recommended scrapping plans for a VOA relay here & plans to construct in Kuwait instead. [Arctic]

RUSSIA: Latest R Ala freqs: 684 1386 1494 3995 5040 6015 7315 7370 7400 11685 11965 12030 15255. [Euronews]

SAO TOME: The VOA is building a new SW/MW xr site here to replace the one destroyed in the Liberian civil war. The MW xr will be on the air 3/93 w/100kw & will boost to 600kw by 1995. [Media Network]

SPAIN: RNE5-567 Murcia is now 50kw, new addr Callejonolma 27, 37005 Murcia. [Arctic]

TAJIKISTAN: Radio Payk-i Ajam is a new independent commercial strusing the facilities of Tajik Radio on 0500-1500 on 972/1143 in the Tajik language. [Arctio]

UNITED KINGDOM: BBC-198 will become a news & current affairs outlet when Radio 4 has full FM coverage (projected for 1994). [Arctic]
