[12/3] Hi Everybody: I have been reading the reviews by Dallas Lankford and others on the Drake R8. Since I am now the owner of one, I would like to add my comments. I decided back about a year ago to buy a new receiver. Since I have been DXing since the early 60s, I have never owned a new communications receiver. I thought it was about time. Living in a quiet area, free of strong locals (We have 3 1KW locals in our county. Only one is 24 hours KVAS-1230. The closed is about 6 miles away. KGO-810 is stronger most nights here than any of the locals). So what I really wanted was a receiver with good sensitivity and selectivity and a low noise figure (no receiver noise). I looked into Kenwoods, ICOMs, and JRCs. All have some digital readout noise. Even though, reports claim that with a shielded co-ax to the antenna, you cannot hear the noise, I wonder how much gets into the circuit without you noticing it. The Drake R8 caught my eye. At first I didn't like all the bad comments on the receiver when it came out, so I held off for a while before I bought the set. In the meantime, Chuck Boehnke in Hawaii got a chance to check out an R8 and said the noise level was better than his R71A. A couple of the Honolulu stations from his location near Keaau, on the Big Island, was clearer. That impressed me. I bought my Drake from Grove instead of the factory, as I wanted someone to check the receiver out before sending it to me. They did, and I feel I got a good one. When I first got it, I did notice the sensitivity was a little lower than my Hammarlund SP-600, but I soon discovered that it was an antenna impedance mismatch, as certain antennas worked better. The antenna tuner I was using did help, but it didn't quite work as well as I had hoped. I then ordered a Grove TUN4 tunable preselector, which really made a difference. I did have a little bit of birdies and other stuff I couldn't figure out that my SP-600 doesn't have. I did expect a few anyway because it is a solid state receiver with dig. readout. The TUN4 took them all out. I haven't heard a birdie since buying the TUN4. I see now why Drake doesn't want the pre-amp to work on MW as it probably would cause some problems, especially in a metro area. The TUN4 adds amplification, but peaks the antenna directly to the frequency and cuts out any other QRM. I don't know how it would work in a metro area, but it really works well here. To close, one reason I am really sold on the unit is the fantastic Noise Blanker (it took out some electric fence noise I was having) and the sideband. Currently I have a report out to Shillong, India on 864 KHZ. The report is tentative, but if it comes back definite, it is the only radio I have ever been able to hear India on MW from here. The cost alone for that is worth it! 73s, Patrick

The KSUR-700 CE here also consults for KNOB-1050,

Frazier Park, CA to serve the Bakersfield area. He went down there in Sept. to help put up their three towers. Not on yet. Will be 25 kw, the last daytimer to be licensed before FCC put a freeze on daytime only stns. The proposed sale of KIDD-630 fell through. Format still the same and still //KXDC-FM. They were AN a few Sat. and Sun morns. in Oct. and Nov., but now are silent again after 0400, as they are also on weeknights til 0800. KTOM-1380 was overmodulating badly, splattering from 1320-1450. They ruined a lot of SSS DX in Sept. and Oct., but seems to have fixed the problem. KSCO-1080 has special temporary authority from the FCC to use 1,000 watts non-directional at night to improve night coverage in Santa CRuz County. It even gets into San Jose at night now, which didn't happen with the 5 kw night DA! KSCO now airs Joy Brown 2200-0100 s/off in place of Tom Snyder, whose last live show for ABC was 11/25. He will do a new TV talk show soon for CNBC on cable. KNRY-1240 here had a funny thing happen over the summer. A man paid to put his show of Hawaiian music on Sun morns, from 0300-0600 ELT. After a few weeks, it all came to an abrupt end. The host sat in the talk studio and the board operator ran the controls and played the music. But this guy (who had been fired and rehired) hadn't had much sleep before coming to work - too much partying! Less than an hour into the show, the board op. fell asleep! The host went into the control room and tried everything he could to wake him up, but no luck. So, he walked out, understandably angry, and never came back. KNRY had dead air all night, and of curse the board operator was fired. Finally, for history buffs, I recommend the book "Border Radio" by Gene Fowler and Bill Crawford, published in 1987. Very thorough details on the powerful BCB border stations in Mexico from the '30s through the '60s, and all the characters including John Brinkley, Norman Baker and Wolfman Jack. It's a great read. Well, it's been a long time since you've heard from me, I'm sure. I'm in the middle of relocating from the San Joaquin Valley, where I've lived for 16 years, and am in the process of establishing a new radio station here in Palm Desert. The address above is the station's -- I hope that my new home will be complete soon and that will be at 31-712 Robert Road, Thousand Palms, CA 92276. I had hoped to find a house in Palm Desert but none seemed to suit my needs. That includes having room to set up my receivers. Another criteria, of course, is a low-noise RF environment. Desert Hot Springs is good in that regard, and one can find houses in the Lido Highlands area that are right up against the Little San Bernadino Mountains, with room for 10 miles of beverage antenna off the back yard. If you just want to get as far away from the local AM transmitters as possible, I found that Palm Desert Country Club is best. La Quinta actually is farther, but has mountains close on three sides, which should inhibit lowangle DX. The Panorama area of Cathedral City is close to all the Palm Springs AM's; KDES and KPSI combine to put a strong spur on 530. Not a good DX location. Powerline noise in Thousand Palms is low, and that was the only location I heard Anguilla 1610 on my car radio. Just for the fun of it, I tried poking around north of the Indio Hills and found Sky Valley to be a promising DX location also, but too far from my work for me to live there. Trying for some terrain shielding, I went up a bit into Berdoo Canyon and found that the usually dominant XEWA 540 was being wiped out by CBK. I wanted to do some more DXing there, but apparently the area is a very popular condom testing site and my presence seemed to be disturbing the research. KPSL 1010 is back on again, still classical music and they splatter quite a bit on load passages, which, mercifully, are not too frequent. I have just been informed by Phil Bytheway, IRCA President, that it was he who did the retyping because he noticed some errors and felt they should be corrected. There wasn't much time so he did it himself. Ralph: My public apology to you! On another subject: There has been much about the possibilities that if IRCA & NRC Bulletins are published by the same person, Paul Swearingen, that it could spell out the end of IRCA. My opinions published in the board newsletter specifically state that in no way should the two bulletins actually be merged into one bulletin. DXMonitor should remain DXMonitor and DXNews should remain DXNews. The two club bulletins will only be published at the same place and both bulletins mailed only to those who are members of both clubs. They will be placed in the same wrapper and mailed together. If this is done each club will save 6 cents on each additional ounce; IRCA one time and NRC the next time, and so on. #### TALK PROGRAM NEWS - from Bill Hardy

In the process of preparing IRCA Almanac Updater 5.6, our complete guide to radio talk shows, we've uncovered some important and interesting news about the rapidly changing world of radio talk.

The biggest news: Larry Kinq is moving to daytime. King, a staple on Mutual since Jan. 1978, is moving to afternoons on Monday, Feb. 1, 1993. He will be heard 1500-1800 Eastern time. Jim Bohannon, who presently does Mutual's Saturday night show in the Larry King timeslot, will move to Larry's weeknight slot 2300-0200 (repeated 0200-0500, plus West Coast replay 0500-0800). "Best of Bohannon" will run in the present "Best of King" timeslot Sunday night 2300-0500. Mutual will have a live Saturday night show in Bohannon's present timeslot, with the host to be announced later.

<u>CBS</u> introduced its first national radio talk show, the <u>Gil Gross Show</u>, Aug. 17. It covers varied topics 2000-2300 weeknights.

ABC has dropped its two weeknight talk shows. Tom Snyder's last show was Nov. 27. Deborah Norville left on Sept. 30, and ABC had been filling the timeslot with other hosts including Claire Carter until Nov. 27. ABC's only remaining national shows are on weekends - Home Sense with Mike McClintock, Garden Hotline with Ralph Snodsmith, and Moneytalk with Bob Brinker. However, three other networks - EFM (Limbaugh/Edell), Daynet, and ESPN Radio - originate programs from ABC Radio's studios in New York.

Talknet and NBC Radio moved operations from New York to Arlington, VA (jointly with Mutual) on Aug. 30. (Have you noticed? Overnight and on weekends, except for commercials and the first five seconds, Mutual and NBC newscasts are now simulcast!!) Talknet dropped Lee Mirabal on that date, bringing about a game of network musical chairs:

Lee Mirabal, formerly Talknet 0100-0400, moved to Daynet 1000-1200.

<u>Dr. Joy Browne</u>, formerly Daynet 1000-1200, moved to WOR Talk Network 2200-0100.

<u>Daynet</u>, in addition to replacing Dr. Joy Browne with Lee Mirabal 1000-1200, has added a new weeknight program with <u>Leslie Marshall</u>. She has the 2200-0100 timeslot formerly occupied by Tom Snyder on ABC. Daynet's other shows are Alan Colmes 1500-1700 and Barry Farber 1700-1900.

WOR Talk Network, besides adding the weeknight show with Dr. Joy Browne in September, offers two weekday programs from WOR-710 New York: "Smart Money with the <u>Dolans</u>" 1300-1500 and <u>Gene Burns</u> 1500-1700. WOR

Talk Network went on the air in Jan. 1992.

Business Radio Network and American Forum Radio (formerly American Radio Network) are now co-owned and operating from Colorado Springs. BRN has added more weekday talk, including Art Bell's syndicated show from KDWN-720 Las Vegas, and no longer has BRN News on the hour or half hour, running USA News instead. AFR continues its daytime talk and nighttime sportstalk, with Sports Final and related shows now airing from 1900 nightly until 0900 weekdays, 1000 Saturday, and 1300 Sunday. Some AFR shows now originate in Las Vegas, including "Insomniac Sports with Lee Pete" and a few others recruited from SEN.

All times above are Eastern. Programs begin about 6 minutes past

the hour.

All the above changes, plus full details on all the talk networks and programs on American radio, will be included in Almanac Updater 5.6, coming soon. \$2 U.S. and Canada, \$3 elsewhere, payable to IRCA in U.S. funds from Bill Hardy, 2301 Pacific Ave., Aberdeen, WA 98520-4527.
