I still occasionally fire up the R-390A or R-393 and do some "tube" DX, but most of my DX these days is done with a timer, so the solid state sets are the ones that get the most use. I have tried to scan the "new" band at least once a week after 11 PM local time... and have heard nothing to report. There are a few unidentified signals here and there, but no real audio to firm up any IDs. Local KPOZ and KRIZ (both of which have been granted frequencies in the new band) are not planning anything at this time... I'll keep you posted. Anyone else have any better luck? Greeting from the home of University of Missouri, alma mater of such celebrities as Sheryl Crow and Brad Pitt - and nobodies like myself, hi. Columbia's Hickman High School is gearing up a low-power station on 840 kHz, to debut on March 20. The call is KEWP, inspired by their school mascot, the kewpie. According to an article in the Columbia Daily Tribune, the station will broadcast live for five hours a day, and will play a "format tape" (whatever that is) to fill the empty time. The format is slated to include news concerning Columbia School District, and music of various sorts. Broadcasts will be simulcast on the district's public information channel on the city cable system. The faculty advisor is KOMU-TV meteorologist Randy Wright, who three years ago helped lobby the district for a \$50,000 budget to start a radio and TV lab. Although the station's budget was eliminated last year to cut the district's deficit, local businesses donated \$18,000 in equipment to construct KEWP, including what appears in the accompanying Tribune photograph to be a very nice Harris Allied MX series console. I was listening to KMOX the other morning when the conversation turned to, of all things, Columbia's KFRU-AM. It seems that one of the KMOX staffers is working on a graduate degree here at MU, and reported to his colleagues that KFRU's programming bore a striking resemblance to that of KMOX. After a commercial break, they came back with KFRU morning man Simon Rose on the line, who in turn put them on the air at KFRU. Several few minutes were spent discussing how both stations had a call-in program called "The Morning Meeting", carried Rush Limbaugh in the early afternoon, and used the slogan "Total Information." All painfully ironic. I doubt that KFRU intentionally used KMOX as a template for its own programming, but at any rate, the whole episode bears witness to the saying, "if you've heard one, you've heard 'em all." On a somewhat related note, the Kansas City weekly New Times' "Media Watch" columnist James McKinley has for two issues promised a forthcoming "definitive survey of Kansas City's non-music AM radio," in which he will examine the "large number of uniformed, low-minded, trash-talking citizens out there in AM radioland who like to call up programs and empty their minds of the precious little stored therein." Zowie! But AM is drawing listeners again - that's undeniable. Talk was a shot in the arm for AM, yet at the same time has given the band a lousy image. I remain convinced that talk shows, be they political, medical, sexual, or horticultural, saved AM but what are broadcasters going to do when the fad dies out or the conversation shifts to the Internet? Although I am not sure of the specific reasons I can imagine that declining membership and lack of support were major causes of their having to shut down. I think that this is a time for the IRCA to look to itself and think not only of ways to improve itself, but to increase its membership. Even though IRCA

is a Broadcast Band Mediumwave Club, it would seem to me that this would be a good time to consider some expansion in the frequencies covered. No, I'm not advocating complete Shortwave coverage or TV/FM coverage. However, I would hope that we could have some Tropical Band coverage in the columns from time to time. Actually this has happened on occasion I have noticed. It would be nice to see some 120-meter DX being reported on a regular basis and even up to 90 or 60 meters if possible. This is something the BOD should seriously think about! After all, those bands are primarily Broadcast bands aren't they? Most activity in those bands is of a local or regional nature and there is very little "International" broadcasting done in them. Many stations in Latin America have Tropical Band transmitters along with their AM and FM operations plus higher frequency Shortwave. So, I can see no reason why IRCA, in the interest of improving and increasing it's use to members, couldn't start carrying DX reports in those bands. The club would still be "Broadcast Band" oriented although it would be stretching the term in many people's minds. This I realize. But, I do believe it would be to the overall good and would add a little incentive for members to report their DX catches. Aloha and good DX to all from the BIG ISLAND of Hawaii.
