'94-'95 IRCA CPC DX TEST RECAP

The '94-'95 DX season was both the most successful and most difficult season to date. The most successful because, out of 352 DX test request letters sent out, DX tests from 61 different stations were arranged - a record 17.3% success rate.

This season was also the most difficult since IRCA's CPC was revived a few years ago because of the higher-thanusual number of: no-shows (even repeat no-shows), late deliveries of Morse code tapes, station personnel leaving a station before a scheduled test date, stations running an equipment test on the same frequency at the same time as a DX test, and - to top it all off - very strange propagation for most of the season.

As always, each DX test is confirmed by telephone on usually the last business day before a scheduled test date, but, as you can see from the test recap, even this is no guarantee that a test will run.

Some of you have raised questions about whether or not stations understand the verification process. As part of our normal routine, the verification process is explained to each point-of-contact with whom we schedule a DX test, they are asked if they plan to verify the reception reports received (we have yet to have anyone say "no"), and are even sent a sample verification letter to use as a guideline in preparing their own verifications.

The following is a summary of each DX test arranged during the '94-'95 DX season by the IRCA CPC:

MONDAY, OCTOBER 3, 1994 - KKAR-1290, OMAHA, NE. This test included Morse code, tones, polkas & big hand music, and was heard well over most of the U.S. It even made it to both coasts.

MONDAY, OCTOBER 3, 1994 - KWEY-1590, WEATHERFORD, OK. Despite a reminder telephone call, this test was a no-show, and was rescheduled for April 3rd.

MONDAY, OCTOBER 10, 1994 - KA2XAU-1620, RICHLAND, PA. A couple of years ago, the sister commercial outlet of this experimental operation tested for the NRC. For whatever reason, the proposed test from KA2XAU didn't make it off the ground then, but they were only too glad to test this season when contacted by your CPC! With Morse code and test tones, this station was heard all over the country - even as far West as Colorado and Idaho. The 'est even made it to Jamaica! Not bad for only 250 watts.

MONDAY, OCTOBER 10, 1994 - WZZZ-1300, FULTON, NY. With Morse code, polkas & other easily-identifiable music, this test was a difficult catch even in surrounding states, but did make it as far as Illinois.

MONDAY, OCTOBER 17, 1994 - WPMR-960, MOUNT POCONO, PA. There's an interesting story here. Despite what you may have read in some DX bulletins, this test DID run and WAS heard by some DXers. WPMR was silent for some time, having been installing a new transmitter - yet they reactivated for the DX test. Due to technical problems, the test started 15 minutes late and was run using a weaker standby transmitter. Nonetheless, it was heard as far East as Illinois and as far south as Georgia. A special thanks to Chief Engineer Jeff Woerhle and Program Director Mason Hall for going above and beyond the call of duty to hastily rework the transmitting system so that at least a portion of the test would run. Now, if I could only get Mr. Hall to verify my report.....

MONDAY, OCTOBER 17, 1994 - WILY-1210, CENTRALIA, IL. Despite a telephone reminder, this test was a no-show, and was rescheduled for November 14th.

MONDAY, OCTOBER 24, 1994 - WGEA-1150, GENEVA, AL. Station Manager Doc Parker ran this test which included Morse code and polkas. The test was not well-heard. Despite many phone calls and letters from your CPC chairman, and an offer to print a batch of QSLs for his use (which was declined), Mr. Parker has yet to verify the reception reports, despite many assurances that he will do so.

MONDAY, OCTOBER 24, 1994 - WNAM-1280, NEENAH, WI. This test consisted of Morse code IDs. test tones, and the Glenn Miller classic "In The Mood" repeated over and over, and was heard all over the Eastern U.S. The Chief Operator was so pleased to have received so many reception reports, that he has asked to do another test for IRCA in the future.

MONDAY, OCTOBER 31 - NOVEMBER 7, 1994 - CJSB-540, OTTAWA, ON. This station was slated to leave AM for good, and move its operations to the FM band. Thinking this might be a good opportunity for a Canadian DX test. the CPC contacted CE Jeff Ruck, who told us that, although he wouldn't be able to alter the programming, he could program their system to transmit a Morse code ID several times an hour, 7 days a week, 24 hours a day until



they left the AM band sometime in December! Due to the code, CJSB was heard in parts of the South and Southeast, even though they were using an antenna pattern which directs much of their signal away from the U.S. at night.

MONDAY, OCTOBER 31, 1994 - KOIL-1180. This station tested for IRCA as KKAR a year or two ago, and they were only too happy to do so again. At a power of 25 kw and a test format similar to that of KOIL (see October 3rd), they were heard coast-to-coast.

MONDAY, OCTOBER 31, 1994 - KSDO-1130. This test included Morse code IDs, and was run at a power of 10 kw. Even though the station was on their directional night pattern, the code was heard by several DXers East of the Mississippi - even Virginia! Chief Engineer Jack Rabell remarked that he was amazed at the large volume of reception reports received.

MONDAY, OCTOBER 31, 1994 - RADIO VISION CRISTIANA-535, TURKS AND CAICOS ISLANDS. A noshow, despite a reminder telephone call a few days before. CE Bob Janney called me during the day on Monday to say that everything was ready to run "that night" - which would have been TUESDAY morning! Mr. Janney graciously offered to reshedule, and it was for November 21st.

MONDAY, NOVEMBER 7 - NOVEMBER 14, 1994 - CJSB-540, OTTAWA, ON. The second week of CJSB's 24 hour "test". See October 31st info.

MONDAY, NOVEMBER 7, 1994 - WVLD-1450, VALDOSTA, GA. A no-show, due to the fact that the CE with whom the test was scheduled left the station prior to the test date.

MONDAY, NOVEMBER 7, 1994 - KYCA-1490, PRESCOTT, AZ. This test included Morse code and test tones, and was another gravevarder heard well - making it as far East as Georgia and several other Southern states.

MONDAY, NOVEMBER 14 - NOVEMBER 21, 1994 - CJSB-540, OTTAWA, ON. The third week of CJSB's 24 hour "test". See October 31st info.

MONDAY, NOVEMBER 14, 1994 - WGNY-1200, NEWBURGH, NY. Based on information supplied from the station, this test was to have been run using their 10 kw non-directional pattern. As it turned out, the station didn't even have that capability! With test tones and code, and using their high power of only 750 watts, they were still heard over a large portion of the Eastern U.S. (and as far West as lowa), thanks to a relatively uncrowded channel.

MONDAY, NOVEMBER 14, 1994 - WRIB-1220, EAST PROVIDENCE, RI. Chief Engineer Craig Healy (a member of IRCA and NRC) ran this test which included Morse code, voice IDs and instrumental music, and was heard well all over the Eastern Seaboard.

MONDAY, NOVEMBER 14, 1994 - WILY-1210, CENTRALIA, IL. This rescheduled test included Morse code, and easily identifiable classical music, including "The Wedding March". Despite our sending him a sample verification letter, Program Director Eric Decker sent out extremely vague veries, which consisted of nothing more than "Thanks for tuning us in" - type comments, handwritten on the back of coverage maps.

MONDAY, NOVEMBER 21 - NOVEMBER 28, 1994 - CJSB-540, OTTAWA, ON. The fourth week of CJSB's 24 hour "test". See October 31st info.

MONDAY, NOVEMBER 21, 1994 - KDDD-800, DUMAS, TX. Including Morse code and test tones, this 250 watt station was not well-heard on its DX test. although it did make it to Illinois.

MONDAY, NOVEMBER 21, 1994 - RADIO VISION CRISTIANA-535. TURKS AND CAICOS ISLANDS. A noshow for the second time, due to the fact that CE Bob Janney was called away at the last minute for an emergency repair at another station he is the engineer for. This test was rescheduled again for April 1st.

MONDAY, NOVEMBER 21, 1994 - WFRM-600, COUDERSPORT, PA. IRCA member Cary Simpson is the GM for this station, and he agreed to run another DX test for IRCA this season. The test was not well-heard, even in surrounding states, and was simulcast over WTRN-1340 (see below), as well as a couple of co-owned area FM stations

MONDAY, NOVEMBER 21, 1994 - WTRN-1340, TYRONE, PA. See WFRM-600 (above).

MONDAY, NOVEMBER 28 - NOVEMBER 30, 1994 - CJSB-540, OTTAWA, ON. The final days of CJSB's 24 hour "test". CJSB ceased AM operation a little bit earlier than we had originally been told, leaving the AM band for good on November 30, 1994.

MONDAY, NOVEMBER 28, 1994 - CJGX-940, YORKTON, SK. This test included test tones. Morse code, and country music, and was run at a power of 10 kw using a non-directional antenna pattern. In a strange quirk of propagation, the test was not heard by DXers closer to Saskatchewan, but many further away (TN, AL, KY) had good copy of the test. Chief Engineer Kelly Osmak verified reports with a very attractive QSL card.

MONDAY, NOVEMBER 28, 1994 - WMAM-570, MARINETTE, WI. This station tested with Morse code and tones, and was heard poorly in surrounding states - no doubt due to low power and the use of a directional antenna pattern for the test.

MONDAY, NOVEMBER 28, 1994 - KFJM-1370, GRAND FORKS, ND. This station tested for IRCA last year, but was run at low power. Chief Engineer John Aasen agreed to run another test at full power this season. Despite less-than-desirable propagation conditions, the test was heard in much of the Central U.S. Interestingly, another station on 1370 started an equipment test, with test tones, halfway through the DX test, making reception of KFJM more difficult. Reports were verified with an attractive OSL card.

MONDAY, NOVEMBER 28, 1994 - WVKO-1580, COLUMBUS, OH. This station tested with Morse code and Urban Contemporary music, and was heard mostly only in the surrounding states, although the test was heard weakly in North Carolina.

SATURDAY, DECEMBER 3, 1994 - KGTL-620, HOMER, AK. This test included Morse code, test tones, and patriotic music. No positive loggings of this one were noted in the DX bulletins.

MONDAY, DECEMBER 5, 1994 - WHBY-1150, APPLETON, WI. Although their Chief Engineer did not want to run Morse code or anything different than their normal format programming, he did switch between their 5 kw daytime and nighttime patterns (both directional), as well as their 1250 watt emergency transmitter with a non-directional antenna pattern. The test was not well-heard outside of surrounding states.

MONDAY, DECEMBER 5, 1994 - KGLE-590, GLENDIVE, MT. This test consisted of Morse code, test tones, and Christian music, and was well-heard throughout the West, and even made it East to Alabama. Illinois, and Wisconsin. Once again, another station was on with an equipment test - running tones - while a DX test was airing on the same frequency at the same time.

TUESDAY, DECEMBER 6, 1994 - KLTC-1460, DICKINSON, ND. Senator Ray David ran this test, which consisted of polkas, march music, and Morse code IDs. Due to poor propagation conditions, this test was not well-heard.

SUNDAY, DECEMBER 11, 1994 - CKQR-760, CASTLEGAR, BC. Yet another Canadian test, and this one running 20 kilowatts non-directional, it was heard well throughout most of the Western U.S., as expected, and even made it as far East as Texas, Iowa, and Illinois. The test included Morse code, and was simulcast over co-owned CKGF-1340 (see below) and a network of low-power FM repeaters.

SUNDAY, DECEMBER 11, 1994 - CKGF-1340, GRAND FORKS, BC. See CKQR-760 (above).

MONDAY, DECEMBER 12, 1994 - WEAQ-790, EAU CLAIRE, WI. This test included Morse code, test tones, and instrumental music, and was heard over most of the Eastern U.S., including Iowa, Alabama, Ohio, Missouri, and North Carolina, and joined the ranks of IRCA tests to be heard in Jamaica. Reports were verified with a QSL card and a very attractive QSL sheet.

MONDAY, DECEMBER 12, 1994 - WSPA-950, SPARTANBURG, SC. This test, which included Morse code, was very well-heard all over the Eastern and Central U.S., and even parts of the West (including all the way to the West Coast!).

MONDAY, DECEMBER 19, 1994 - WIBW-580, TOPEKA, KS. This test also included Morse code, and was well-heard over most of the country and points in Canada. It also punched out to the West, with positive loggings in California and Idaho.

MONDAY, DECEMBER 26, 1994 - WNOM-1300, NASHVILLE, TN. A very well-run test, and done at 10 kilowatts non-directional. Including Morse code, the test was heard coast-to-coast, including California. Oregon, and Idaho, Incidentally, WNOM is the sister station to shortwave broadcaster WWCR.

MONDAY, JANUARY 2, 1995 - WWSW-970, PITTSBURGH, PA. Chief Engineer Phil Lenz was so pleased with the number of reports received for the test (over 20), that he has indicated a desire to run another test for IRCA in the future, but at a later time, when reception for Western DXers will be better. The test included Morse code.

MONDAY, JANUARY 2, 1995 - CHEF-1450, GRANBY, QUEBEC. This test was run at 10 kilowatts using their daytime antenna pattern, and included Morse code. In one of the strangest cases of propagation for a DX test this season, the test was inaudible in the Northeastern U.S., where it should have been strongest, yet there were definite loggings of the test in Alabama, and even Oregon! Reception reports were promptly verified by CHEF's Chief Engineer, who speaks little, if any, English.

SATURDAY, JANUARY 7, 1995 - KIUP-930, DURANGO, CO. With Morse code included in the test, KIUP was heard well all over the Western U.S., and even made it to many states in the Central and Eastern U.S., including Tennessee, Iowa, and Alabama.

MONDAY, JANUARY 9, 1995 - WSUI-910, IOWA CITY, IA. Those who tuned in to this one were treated to one of the best DX tests in recent years. The test included Morse code, and lots of "antique" station IDs from the early days of the station's existence. The test also included vintage radio comedy skits, and was heard coast-to-coast. Program Director Dennis Reese was very pleased with the number of reception reports received - over 2 dozen, and 6 from Canada - and verified with a very attractive QSL card.

MONDAY, JANUARY 9, 1995 - KTNS-1090, OAKHURST, CA. The test from this low-powered station included Morse code and was not well-heard outside of California. In fact, we're not sure if it even was heard outside California!

SUNDAY, JANUARY 15, 1995 - KUAU-1570, KUAUI, MAUI, HI. This station's test included Morse code, and received only one verifiable report from the U.S. mainland - from Pat Martin in Oregon. The station also received a few reports from some of the other Hawaiian Islands, and other points around the Pacific Rim. This test was repeated on January 16th.

MONDAY, JANUARY 16, 1995 - WVWI-1000, ST. THOMAS, U.S. VIRGIN ISLANDS. Thanks to the regular Monday morning WMVP silent period, DXers all over the Eastern and Central U.S., and parts of Canada were able to add a difficult "radio country" to their logbooks. The test included Morse code and reports were quickly verified.

MONDAY, JANUARY 16, 1995 - KUAU-1570, KUAUI, MAUI, Hl. A repeat of their January 15th DX test. (See January 15th).

SATURDAY, JANUARY 21, 1995 - KICY-850, NOME, AK. This test was run at a power of 10 kilowatts using a non-directional antenna pattern. The test included Morse code, yet no positive loggings of this one were reported.

MONDAY, JANUARY 23, 1995 - KSYG-1010, LITTLE ROCK, AR. Another test which was run at 10 kilowatts, the station also switched to their daytime antenna pattern, and aired Morse code IDs, unique test tones, and many voice IDs notifying listeners that this was a "Worldwide radio reception test". This one was heard all over the U.S. - including both coasts - and many parts of Canada. KSYG received over 25 reception reports for the test. By the time you read this, KSYG may have already left the air - they are scheduled to go silent for good sometime in August.

MONDAY, JANUARY 30, 1995 - CFRY-920, PORTAGE LA PRAIRIE, MB. This test was run at a power of 25 kilowatts using their daytime antenna pattern, and included Morse code, country music, and many voice IDs and announcements mentioning IRCA by the on-air test host - "Rosa". The test was heard in many parts of the Central and Eastern U.S. - including Illinois, Tennessee, Ohio, North Carolina, Alabama, and Iowa. Due to yet another case of strange propagation, many DXers closer to the station were unable to hear the test.

MONDAY, JANUARY 30, 1995 - WAMR-1320, VENICE, FL. IRCA member Lee Freshwater arranged and conducted this test, which included Morse code, sweep tones, and music by Fleetwood Mac. They received over a dozen reports from the Eastern half of the country. Lee promises more DX tests from Florida stations in the future.

MONDAY, FEBRUARY 6, 1995 - KIYU-910, GALENA, AK. This test included Morse code IDs. No positive loggings of this one were seen in the DX bulletins.

SATURDAY, FEBRUARY 11, 1995 - WWOL-780, FOREST CITY, NC. A no-show on a DX test last season, this one was a no-show this season as well! According to CE Julius Blanton, their automated broadcasting system malfunctioned. Seems that he programmed the system before he left work the previous day and, while the cart machine with the DX test program activated, the transmitter didn't turn on! This test was rescheduled for April 8th.

SUNDAY, FEBRUARY 12, 1995 - KNZZ-1100. GRAND JUNCTION, CO. Despite a reminder phone call, this test was a no-show and was rescheduled for April 16th.

MONDAY, FEBRUARY 13, 1995 - KGYN-1210, GUYMON, OK. This test was a no-show, due to the fact that the Morse code tape didn't arrive in time. The test was rescheduled for April 10th.

TUESDAY, FEBRUARY 14, 1995 - WREN-1250, TOPEKA, KS. This test included Morse code IDs, as well as many voice announcements mentioning IRCA, and was heard coast-to-coast and all points in between. The station also announced their phone number and Fax number over the air. A very well-done test from this historic station.

SATURDAY, FEBRUARY 18, 1995 - KWRE-730, WARRENTON, MO. This test was a no-show, due to the fact that the station's GM nixed the idea of a DX test after it was scheduled with their CE.

MONDAY, FEBRUARY 20, 1995 - KERR-750, POLSON, MT. This test was run at 50 kilowatts using a nondirectional antenna pattern, and was heard coast-to-coast, over much of Canada, and even Hawaii and Alaska! During the test, which included Morse code and country music, a 1-800 number was announced for folks to call. Special thanks to IRCA member Tom Bryant, who is friends with KERR's owner and helped arrange this test.

SUNDAY, FEBRUARY 26, 1995 - KUJ-1420, WALLA WALLA. WA. The test from this 3-letter call station was supposed to have included Morse code, but, unfortunately, the code tape arrived at the station after the test. Nonetheless, the test was heard well all over the Western U.S., and even punched out to the East, making it to lowa. Tennessee, and Alabama. The test included many voice IDs and test tones, and was simulcast on KTCR-1340 (see below). Program Director Kevin Culbertson moved to another station before verifying reception reports. We are working on getting some verifications from him, so watch your mailbox.

SUNDAY, FEBRUARY 26, 1995 - KTCR-1340, KENNEWICK, WA. See KUJ-1420 (above). This graveyarder was not well-heard outside the immediate area.

SATURDAY, MARCH 4, 1995 - KFDF-1580, FORT SMITH, AR. This test consisted of Morse code IDs and gospel music. Due to technical problems, the test was run at low power, yet was still heard as far away as Wisconsin and Alabama. Chief Engineer Stuart Rowland asked to repeat the test at a later date, and this repeat was scheduled for April 15th.

MONDAY, MARCH 6, 1995 - WKBR-1250, MANCHESTER, NH. The DX test from this rare state included Morse code, test tones and "beautiful music", and was heard as far away as lowa. Chief Engineer Peter George is to be commended for his dedication to DXers. The Morse code tape he had requested did not arrive in time, so Mr. George, whose keying ability is severely limited due to health reasons, improvised by punching out those dots and dashes on a touch-tone phone! Reports were verified with a very attractive QSL card.

MONDAY, MARCH 6, 1995 - KZIM-960, CAPE GIRARDEAU, MO. This test was a no-show due to a death in the responsible station personnel's family, and was rescheduled for April 3rd.

MONDAY, MARCH 13, 1995 - KWOC-930, POPLAR BLUFF, MO. This test was well-heard in many parts of the country, and included many voice IDs and TV & movie themes. Thanks to Director of Engineering Dave Obergoenner, who also ran a test for IRCA from KSD-550 in St. Louis back in 1993.

MONDAY, MARCH 13, 1995 - WTMT-620, LOUISVILLE, KY. This test included Morse code, test tones, and polka music, and was heard over much of the Eastern and Central U.S., and parts of Canada. A very well-done test.

MONDAY, MARCH 20, 1995 - KSIM-1400, SIKESTON, MO. Despite a reminder telephone call, and the best efforts of Director of Engineering Dave Obergoenner (who is headquartered at Cape Girardeau, MO), station personnel at KSIM ran the test after midnight Monday, which was actually TUESDAY morning. Thus, a no-show on the date and time scheduled.

MONDAY, MARCH 20, 1995 - WZEP-1460, DEFUNIAK SPRINGS, FL. IRCA member Lee Freshwater scheduled this test, which included Morse code (thanks to Lee for making the code tape), and was not well-heard. In

fact, they only received 2 reception reports. Again, many DXers closer to the station reported not hearing the test. It did, however, make it to Pat Martin's Beverage Bungalow in Oregon. More strange propagation.

SATURDAY, MARCH 25, 1995 - KVAK-1230, VALDEZ, AK. This test included Morse code, and no loggings of this one were reported in the DX bulletins.

SATURDAY, APRIL 1, 1995 - RADIO VISION CRISTIANA-535. TURKS AND CAICOS ISLANDS. This test was heard in all 50 states as well as 26 countries in all continents! Chief Engineer Bob Janney promptly answered all reception reports received with an attractive QSL card, and has promised to run more tests from RVC in the future. April Fool! Despite a telephone confirmation a couple of days before this second rescheduled test date, RVC was again a no-show. For those who tried for the test, heard the regular programming, and sent a reception report, QSLs are now issued very sporadically. Don't hold your breath for any RVC tests in the future.

MONDAY, APRIL 3, 1995 - KWEY-1590, WEATHERFORD, OK. If it hadn't been for IRCA member Pat Martin, this test wouldn't have run! After listening for 15 minutes and hearing nothing, Pat phoned the station, and talked with the board operator, who had not yet left for the evening. It seems that their CE had called earlier and told him that, for whatever reason, he was staying in bed and wouldn't be in to run a test. Pat talked the operator into staying a little later than normal, and airing the test for 15 minutes at least, which he did. No positive reports of this one were noted in the DX bulletins. Perhaps everyone had given up on this one by the time the test actually started.

MONDAY, APRIL 3, 1995 - KZIM-960, CAPE GIRARDEAU, MO. This rescheduled DX tests was heard well in many parts of the U.S., and even made it to both the East (Massachusetts) and West (Oregon) coasts. The test include Morse code, many voice IDs and TV & movie themes. Yet another well-run test from Director of Engineering Dave Obergoenner.

SATURDAY, APRIL 8, 1995 - WWOL-780, FOREST CITY, NC. Despite a reminder telephone call less than 8 hours before the test, and the assurance from their CE that the test would indeed run this time, this one was a no-show for the second time this season, and the third time overall. Three strikes and you're out - we won't attempt to schedule a test with WWOL again.

MONDAY, APRIL 10, 1995 - KGYN-1210, GUYMON, OK. Program Director Bill Weldon, with whom the test was originally scheduled, left the station a few weeks prior to this rescheduled test date. The new Program Director couldn't locate the Morse code tape, and was unable to track down Mr. Weldon at his new job to inquire as to its whereabouts. Thus, yet another no-show, although their new PD said he would love to do a test next season. Stay tuned!

SATURDAY, APRIL 15, 1995 - KFDF-1580, FORT SMITH, AR. This rescheduled DX test include Morse code and gospel music.

SUNDAY, APRIL 16, 1995 - KNZZ-1100, GRAND JUNCTION, CO. No reports of this DX tests were noted in the DX bulletins, so it's possible that this rescheduled DX test was again a no-show, despite a telephone confirmation 2 days earlier.




[7/16] Greetings! The Boise convention was another great one, with high attendance. Many thanks to IRCA members Frank and Mark, as well as other area DXers, for arranging the interesting events and superb banquet. The auction netted the treasury over \$300. One particular interesting topic surfaced at the business meeting: the possibility of expanding the DX Monitor coverage beyond the 510-1720 range kHz. The purpose would be to attract new members so we could remain financially viable and achieve some economies of scale. A few months ago, Chuck Boehnke suggested including tropical-band coverage in the DXM, which would extend up to about 3.5 or 4 mHz. The consensus at the business meeting was that this is a worthwhile idea for the new BoD to explore, perhaps initially on an experimental basis. Earlier I wrote in the DXF that I thought such a proposal would require an amendment to the Constitution, entailing a virtually impossible affirmative vote of 2/3 of the IRCA membership. Article II of the Constitution states, "The purpose of the IRCA shall be to promote the hobby of radio listening on the AM broadcast band." However, the tropical band might be considered part of the AM spectrum, so a liberal interpretation would seem to require no amendment. If that is the case, a Bylaws amendment could effect the change, requiring only a simple majority of those members voting. Another suggestion was to include FM DX in the summer issues of the DXM, but the Constitution would clearly need to be amended to permit that change. Again, this would be next to impossible. A final suggestion was to encourage more bulletin reporting on the long wave band (already permitted by the Bylaws). I believe most stations on that end of the spectrum are beacons. If you have an opinion on extending DXM coverage, let everyone know via the DXF. Well, good DX to everyone in the new season and 73.
