Greetings. Time for another column. The biggest news this time is some new expanded band activity from Australia. Pat Martin has already heard one of them and more are apparently on the way. These would be good targets for those of you on the east coast, as the print handicapped stations which operated on 1620 and 1629 were heard in ON & MA a few years ago.

Since this is around the club's anniversary, here is a quick re-intro. I've been an IRCA member since 1966 and have served as editor-in-chief, president, DX Worldwide editor, and various other functions. I currently use a Drake R8A with a Kiwa loop, plus a Yaesu FRG-7 and Radio West loop as backup. Due to the large number of Seattle locals, plus the noise level at home, most of my serious DXing these days is done with Beverage antennas along the coast, and most casual DX is done on the car radio going to and from work. In real life, I'm an electronics engineer and work for a consulting firm designing various types of communications systems. My wife Evelyn and I have two kids, Theresa, 8, and Steven, 5, who occasionally show brief periods of interest in radios before moving on to other activities.

TRANS ATLANTIC

BOSNIA-HERZEGOVINA: The station which was widely heard testing from Ft. Meade, MD on 1670 in early February is on its way to Bosnia, where it will operate on 1143 [Arctic]

GERMANY: Radio Ropa has left MW/SW and is now LW/FM only. MDR will probably leave MW for FM. Evangeliums Rundfunk will start on 4/1 24 hr with 700/120 kw [Arctic]

IRAQ: Radio of the Iraqi Army is reported on 1527 1900-2300 [Arctic]

IRELAND: United Christian BCers moved from 864 to 549 kHz on 1/6 to avoid QRM from Paris [Arctic] The Irish Government is questioning the need for LW BCer Atlantic 252, since it is owned mainly by R Luxembourg and its target audience is in the UK. It

has been suggested that the transmitter would be better served by relaying RTE Radio One. [MWC] RTE Radio One is facing a major shake up because it is losing listeners to commercial stations. It has started 24 hr operation, & is introducing new pgms & presenters to appeal to persons aged 25-40. [BDXC]

HONG KONG: The BBC relay will be dismantled before China takes over the colony in 1997, in order to prevent the Chinese authorities from using the station. They are presently jamming the BBC [Media Network]

KIRIBATI: The Island government has decreed that all the islands in the country shall be on the same calendar day. This would move the International Date Line 30 degrees to the east to bring the Line Islands and Phoenix Islands into synchronization with the rest of the country. The New Zealand Minister of Communications has stated that NZ will not participate in the band expansion to 1701 kHz, in order to protect expanded band users in Australia & the US as well as cordless phone users [NZDXT]

The RNZ Network is for sale. There are currently 4 contenders for the 41 AM/FM stations, advert bureau, production studio & sports service, one each from Canada, the US, Britain, & Australia. [NZDXT] (It's interesting that they're all foreign investors, especially when you consider the size of the network they're trying to buy, bp)

PHILIPPINES: DWOO-774 in Quezon has changed calls to DWAT. It operates with 25 kw AM stereo, and will install a new antenna system in Feb 96 [Arctic]

GEOCLOCK

I don't recall ever seeing it mentioned in DX Monitor. but there is a very good software program called Geoclock, which a lot of members would find useful. Basically, it is a collection of very impressive maps, which includes a continuously updated display of areas in daylight and night. The maps range from various projections of the entire world to continents, groups of countries or states, and even portions of states (for instance there is one of Western Washington and southwest B.C.). The program also has the ability to calculate and display sunrise & sunset times for any place on the planet, as well as great circle bearings and distances between any two locations. It also includes a data base with the latitude and longitude of an enormous number of places (for example it lists three places in Luxembourg, and a couple dozen in the Northern Territories of Australia).

The program is available as Shareware. You may be able to find it on bulletin boards, or from ham-related Web Sites, or on-line services. You can also download the shareware version with about four maps from the Geoclock BBS at 703-241-7980. The cost for the program and a few maps is \$35 (DOS & Windows versions are available), about 100 other maps are available either from their BBS (after you register) or by ordering from them. A ham package is also available for another \$30, which includes an azimuthal map centered on your home town. [continued from last issue] A few issues ago, Larry Godwin mentioned that he reports to WDXR because of a clause in EP which states to the effect that if a person in near a DXR boundary they can report to whichever DXR reflecting their DX. This is true! There is such a clause. However, Larry is in WDXR country as the border between WDXR and CDXR is the Mountain/Central time zone which went into effect Nov. 1981! If you have a DXM from Nov. 1981 check it out! By an oversight, that was not written into EP until Phil Bytheway became el presidente. There was much confusion abut this in 1989 and 1990. So, it was put back to vote by BoD and was re-affirmed in 1990 although the concluding remarks of the affirmation were made in error. The confusion still exists. In recent DXMs, I've seen statements to the effect that the boundary is "The Continental Divide" or "The Boundary is the Pacific/Mountain Time Zone". I wouldn't mind reporting to either, but the question I ask myself frequently when I read DXM is "When did the boundary change this time?" Phil Bytheway has assured me via E-mail that WDXR territory is everything in the Eastern Time Zone. Time zones are easy. Everyone knows which time zone they are in, but not everyone knows if they live east or west of the continental divide or the 110 degree line. DX here does have a "Central Flavor" to it, but logging a "W" east of the Mississippi is pretty rare.


