John notes that WKWM and WEPG will use "Voice, music and the following digital modes: RTTY 45.45 baud at 170 Hz shift, BPSK31, MFSK, THROB, (1 kHz bandwidth, long interleave) and SSTV Scottie DX mode. Hopefully the other modes will be of interest to someone, if nothing else hearing a teletype style signal on the AM broadcast band will be good proof it was us! By the way, the center frequency for the teleprinter modes will be 1900 Hz." Here's the results of the most recent DX test that has been received here:

WFNY-1440, Gloversville, NY 12:00-1:00 am ELT - tested Sunday, February 23, 2003 from 1 2:00-1:00 am ELT: According to Ron Musco of NRC's CPC, the CE reported to him that the test ran as scheduled, with full day power of 800w, but no one called the station during the test. Ron reports that he probably heard some CW from the test and was having the CE check on the timing - I believe Ron was in Poquonock, CT during the test. Reports from Madison, WI (Tim Noonan and Bill Dvorak), Helena, AL (Les Rayburn), Ft. Wayne, IN (Blaine Thompson), Springfield, VA (Andrew Lisowski), and east of Troy, NY (Gordon Bell) - just about 50 mi from the station - all confirmed that the test wasn't heard by them. Ron mentioned that the test was run during a storm, with thunder and lightning and noise abundant, so perhaps that had something to do with it...

The move of CKVM Ville Marie Quebec to FM (93.1 MHz, 18.4 kW) was approved by the CRTC today: <u>http://www.crtc.gc.ca/archive/ENG/Decisions/2003/db2003-81.htm</u>

It seems that the move was at least in part forced by complaints of QRM by WOR. Rather ironic considering what the WOR IBOC operation will do to WLW and WGN.

KDZR-1640 has an app for 10/10 U4, so probably directional to the West. I called around and got a local phone number for KDZR-Portland. I phoned the number and first the guy answered the phone "hello". I could hear all sorts of noise in the background, like a rooming house. I asked if this was Radio Disney. The guy said hold on. Came back and said I had the wrong number. It just did not seem right. I checked the number again and called with the area code in front, just in case. We live in the (503) area code as does Portland. This time another guy answered the phone want dead. I called back and someone else answered the phone "Radio Disney" and I started to ask, and he said "Please stop calling me" and hung up. That has to be one the the oddest phone calls to a station I ever heard. I was shocked, from Radio Disney. I don't know who the people were, but you know they could have said, we don't have any info, please call back later or something like that. They were downright rude. No wonder the broadcasting industry is in the shape it is! I'll have to try back later on...

They apparently just changed recently as Don Kaskey had told me about them and I tuned in to find "AM 1640, KDZR Lake Oswego-Portland" ID at 8:58 AM (PST) 2/25. The last time I checked a week or so ago they were still rel., but maybe when Curtis heard them they were testing the new format? The FCC has an app for them to go directional and go 10 KW fulltime according to Patrick Griffth too. There is also an app for 1 KW in Oklahoma now on 1640 too.

1640 has been sold to ABC. They are at a different location and number. Crawford has nothing to do with them. They have an app for 10 KW day & night on 1640 too. Directional.

Report: San Diego About To Get A New Sports/Talker

Rumors have been hot and heavy for a few weeks that veteran broadcaster John Lynch — the man who launched Southern California's "XTRA Sports 690" a decade ago — is about to fire up another locally staffed Sports/Talker from south of the border on XEPRS-AM at 1090 kHz. The San Diego Union Tribune reports that the new station, which will be called "The Mighty 1090," will launch early next week and be programmed by former XTRA-AM programmer Bill Pugh and include a number of former local XTRA-AM hosts, including Scott Kaplan, Billy Ray Smith, John Fricke and Steve Mason. R&R's calls to Lynch's San Diego office had not been returned at press time.

Dan Sys of Langley, BC. passes on the following re 850 Abbotsford, BC.

The CRTC approved the application for 850 Abbotsford. They will simulcast the new Vancouver aboriginal station on 92.3. 850 has been silent for over a year after moving to 107.1. They do seem to be quite rare down south, although I recall Larry Godwin reporting them a couple times a few years ago when they were CKMA.

I was reading Doug Pifer's Forum in Reid Wheeler's column in DXM 40-23. The news of Lowry Mays' grilling by a Senate committee was all over the press, even on the AP wire. I also agree that Clear Channel is so impersonal these days, unfortunately, so is the rest of corporate radio. For that reason, I stopped sending for AM and FM veries in 2000, and was one of several reasons why I stopped looking for on-air work in commercial radio in 2001. I've pretty much stopped listening to commercial radio, preferring to listen to noncommercial and shortwave broadcasters. I would like to encourage all IRCAns to write their elected officials, and express opposition to further deregulation of the commercial media. The current wave of deregulation has been destructive for commercial radio: nearly 13,000 jobs have been lost, the legitimate, "play by the (FCC) rules" DJs have been replaced with illegal, sex-driven and bloodthirsty "shock jocks" of dubious talent, the talk radio scale has been tipped to the extremes, commercial radio program quality and listenership have declined (they've allowed NPR and PRI to pass them up in program quality), fewer owners, increased employment discrimination (especially against people with disabilities), increased negative attitudes on the part of station management (in other words, station management should be willing to try talent new to commercial radio, even those who are currently working in, or have worked in, public radio, instead of shutting new talent out of the field altogether), and far fewer chances for homegrown talent (born, raised and/or trained for the radio business in the city a particular station is in) to be successful in the radio business at any level. Worst of all, AM and FM are being desecrated by IBOC-DAB, an unproven technology that is incompatible with our current analog radios (proven by the nighttime IBOC tests in November 2002). We have lost a lot of our freedoms since the Telecommunications Act of 1996 took effect. Further deregulation would complete the transformation of the U.S. media system from an independent and impartial system into more of a Soviet-style media system, but with only the rich in control, and only one view disseminated. Therefore, we will lose whatever freedoms on programming choice, as far as AM and FM are concerned, we may have left. The only winners, if the commercial media is further deregulated, are the illegal media monopolies like Clear Channel. Who will lose from further deregulation? One segment of the population that will lose is the DX community, which has already lost a lot of representation in commercial radio since Deregulation was implemented, will stand to lose even more from further deregulation, as fewer and fewer of our fellow hobbyists are still working in commercial radio. More and more stations will refuse to verify reports from distant listeners (a group that is larger than many radio stations think). Ethnic minorities (such as African-Americans, Asian-Americans and even Arab-Americans), which have already been hurt by the current wave of deregulation, will be almost totally shut out of ownership and have their chances at employment hurt. The largest

minority, people with disabilities, already totally shut out of station ownership opportunities, already have very little representation in the commercial media. They will be hurt most by the proposed reckless moves of Powell's FCC. Further deregulation will most likely eliminate the remaining radio workers with disabilities (even those with minor disabilities). Musicians, which have already lost a lot in the current wave, will lose even more in a less regulated and more hostile environment. Many struggling musicians in certain genres are shut out of commercial radio airplay by the renewed use of payola by corporate broadcasters, not to mention standardized playlists which have homogenized radio programming. "Play by the (FCC) rules" DJs will also be severely hurt; further deregulation would mean that the DJs that do radio that's safe for our children would be fired at a more rapid rate, and result in an increase in illegal "shock jocks" like Howard Stern. Bubba "The Love Sponge" and Don and Mike. Most of all, it will hurt the listener, who will be looking for alternatives. I don't think XM and Sirius satellite radio provides much of an alternative; the only other alternative available is shortwave radio. Reregulation will bring discipline back to a business that has been lacking in it in recent years. Ownership limits, taking the illegal "shock jocks" off the air forever, balancing out the politics of talk radio, ending discrimination, improving existing technologies, and returning control of playlists to the local level are just a few of the things that I believe will return discipline and sanity to commercial radio. I have been one of those hurt by the current wave of deregulation, having lost my commercial career four years ago. Further deregulation will cost more people the careers that they have worked so hard for. I've already contacted my elected officials, asking them to oppose further deregulation of the commercial media, 73 and good DX from Eric (NOUIH).
