Monday, April 11, 2004 - WNNR-970, Jacksonville, FL tested 12:00-1:00am EDT:

A pretty good number of DXers from all over tried for this test - DX season isn't quite over just yet! The test was heard mainly by those in the Eastern part of the US, as might've been expected for a FL test. Hearing the test were Bob Foxworth in Tampa, FL, Gerry Bishop in Niceville, FL, John Hunter in Rossville, GA, Barry McLarnon in Ottawa, ON, Bruce Collier in York, PA, Russ Edmunds in Blue Bell, PA, and Tom Jasinski in Shorewood, IL. Jim Renfrew in Byron, NY mentioned he heard the test amid some WZAN-ME QRM; Mike Hardester in Jacksonville, NC and Steve Francis in Alcoa, TN both said they heard the test with lots of difficulty or just barely. In Largo, FL, Greg Myers wasn't certain if what he heard was actually the test. Andersson Sigvard in Sweden commented that he thought he didn't hear the test and described what he heard; Ron Gitscher, who hosted the test, read those comments and responded that Andersson might've heard the test, but he'd need to hear a recording of what Andersson heard to be sure!

WNTD 950 Chicago IL and KBLA 1580 Santa Monica/Los Angeles CA have flipped from Air America talk back to Radio Formula Spanish talk, amidst a dispute between the network and the stations' owner over an allegedly unpaid bill. Meanwhile, Air America adds WTWK 1070 Plattsburgh NY, WKIZ 1500 Key West FL and KBZC 1300 Colorado Springs CO as new affiliates.

WFLL 1400 Fort Lauderdale FL will flip from business talk to sports as "1400 the Fan" on May 3.

WLCR 1470 Shepherdsville/Louisville KY has completed its move to 1040 and its change of community to Mount Washington KY, another Louisville suburb. WLCR goes from 760 watts to 1500 watts, daytime-only.

KIGO 1400 St. Anthony ID returns to the air with regional Mexican.

KSQR 1240 Sacramento CA has gone silent; it's expected to return April 15 with a new format.

KWOM 1600 Watertown MN changes calls to KZGX. (currently silent- ye ed.)

KTIQ 1660 Merced CA drops its "Ticket" sports format to pick up Radiovisa's Spanish talk format.

WFJY 660 Wilkinsburg-Pittsburgh PA has signed on with IBC network talk programming; this station was formerly located in the Johnstown market, on 1470 Portage PA.

KQQA 1530 Creedmoor/Austin TX changes calls to **KZNX**, reflecting its sports simulcast with **KWNX** 1260 Taylor TX.

WWCZ 1210 Bartlett/Memphis TN changes calls to **WMPS**, just a few days after changing calls from **WTCK**. The WMPS calls (heritage to the market's 680, now **WJCE**) come from 107.5 Germantown/Memphis, which recently flipped to another set of heritage calls, **WHBQ-FM**.

WKNX 1250 Bay City/Saginaw MI is being sold to Meredith; it'll become news-talk.

KFXX 910 Vancouver WA/Portland OR and **KOTK** 1080 Portland OR swapped calls and formats Friday (3/19/04-ye ed.), with **KOTK** 910 going talk as "Max 910" and **KFXX** 1080 going sports as "The Fan."

ALL COMEDY RADIO WILL BUY KCKN KANSAS CITY

(Los Angeles, California) All Comedy Radio, the Hollywood-based radio network today announced agreement with Carter Broadcast Group, inc. of Missouri to purchase the assets of KCKN AM 1340, Kansas City. All Comedy Radio is the managing entity of a new company, KCKN, LC, a Missouri limited liability corporation. The parties entered into an LMA effective April 1, 2004. Purchase price was not disclosed, and sale will be pending FCC approval. Further announced is the format change of KCKN AM 1340 to All Comedy Radio's 24/7 stream of comedy programming, effective April 1, replacing the station's sports-talk format. Elliott Threatt, KCKN, LLC, Partner is named as General Manager of KCKN. Elliott is a distinguished Kansas City minority business entrepreneur, standup comedian, and talk-radio personality. (AB-CA)

Dennis Gibson sends along the following: 1400 Santa Paula is KUNX. (DG-CA)

Art Blair sends along the following:

TRAVERSE CITY - Local fans of sports talk radio are under a curfew - there's nowhere to go on the dial after sundown. But not for much longer. Midwestern Broadcasting Co. has approval from the Federal Communications Commission to boost WCCW-AM 1310's signal and start 24-hour broadcasts of its sports-talk format. Company president Ross Biederman said the boost to 15,000 daytime watts - triple its present signal - will require a four-tower transmission setup to prevent the stronger signal from interfering with other area stations. (AB-CA)

Pat Martin sends along the following from Martin Beu of Austin, TX:

I can confirm that the Fort Worth station on 1630 is using the call KKGM. The format has changed to rock music programming (from the 80's, 90's and current releases). I'ts rare to hear a US medium wave station running this format (more like fm programming). (PM-OR)

CFPS-1490 in Port Elgin, ON is the latest to apply for a flip to FM: http://www.crtc.gc.ca/archive/ENG/Hearings/2004/n2004-3.htm#12 AND in what has to be a first here (really bucking the trend) the CBC has applied to flip their FM station in Dawson, Yukon from 104.9 to 560 AM: http://www.crtc.gc.ca/archive/ENG/Hearings/2004/n2004-3.htm#31. KXRE-1490 Manitou Springs, ČO is now simulcasting KBNO-1280 "que buena" (bueno?). Was Unica. Legal ID at the top of the hour includes these two stations, plus KAVA-1480 which wasn't audible from my hotel room at the north end of Colorado Springs. (TH-CA)

Tim Hall also sends along the following:

I just got back from a whirlwind (less than 20 hours) business trip to Colorado Springs. Before I left, I noted that KURS-1040 had changed formats to what sounds like WW1 NOS ("America's Best Music"). Slogan is "the new K-10-40" (not very imaginitive, but will probably save money as they only need to remove the "La Super" part of the "La Super K1040" signs and logos on their studio, rucks, etc.). They do give a lot more callsign IDs now. The format change from Spanish to NOS was due to the recent proliferation of Spanish stations in the market. Ironically, the guy who runs KURS also runs XEPE-560 and XESS-780, so he essentially cannibalized his own ratings! (TH-CA)

Ward Jones sends along the following:

The station KSKY (660) here in Dallas has switched from religious to news/talk format. On the air for 60 years with religious programming K-SKY has now switched to a news and talk format with syndicated host's, Bill Bennet, Laura Ingraham, Hough Hewitt, Dennis Prager, Michael Medvid, and Michael Savage. The station is owned by Salem Communications and the general manager for KSKY is Pete Thomson. As a listener here in the Dallas area I must say it is nice to hear syndicated talk shows for a change, the stations here are almost all local until the late night. (WJ-TX)

CJRL-1220 in Kenora, Ontario received approval today to flip to FM:

1520 is now SS, sounds regional Mexican, Ranchera and other stuff. They are "KGDD Oregon City-Portland". Five SS stations now in metro Portland! 940, 1010, 1150, 1230, and 1520. Plus 88 in Dallas that comes in well. (PM-OR)

Art Blair sends along the following:

Sixteen lowa and South Dakota radio stations will soon be under new ownership, pending Federal Communications Commission approval, as the result of agreements between three regional broadcast companies. The deals involve trades, cash and local marketing agreements. Omahabased Waitt Media acquired nine stations it had been operating under local marketing agreements with Dean Sorenson of Sioux Falls. These stations include: KVFD and KUEL, Fort Dodge, Iowa; KJJQ and KKQQ, Volga-Brookings, S.D.; KDBX, Clear Lake-Brookings, S.D.; KWAT, KIXX and KDLQ, Watertown, S.D., and KKSD, Milbank-Watertown, S.D.; all of which were all subsequently sold to Three Eagles Communications for \$9.45 million. The CRTC rejected the application by CHOR-1450 in Summerland, B.C. to flip to 94.5 FM. The possible impact on the neighbouring Kelowna & Penticton market was the prime reason given. - CFLD BC, Burns Lake 4/12 1019-1030 John Mellancamp song, ads, "Fortunate One" with CCR. (ML-BC1)
- CFCW AB, Camrose 4/12 0503 with end of news and sports, then CFCW Weather, ID "Your favorite country CFCW" and into C&W music. Fair signal on top of the mess. First time heard in Utah. (DN-UT)
- CKKY AB, Wainwright 4/7 0100 C&W music with many "Key83" ID's and fair signal above KNCO:. NC-109 with Sanserino loop. - 1040 KURS CA, San Diego 4/5 1033-1037 San Diego traffic, followed by ads. Call ID "K-Ten Forty returning to Imus in the Morning." First time. No carry-over of KTNQ-1020 and KNX-1070 at that moment. (RA-CA)
