WB3XNN 1620khz Milford, PA TEST. Date(s): About December 15th thru end of January. Time: Non-Critical Hours 09:15AM EST until 1445PM EST. Modes of Operation: 1KW Daytime Non-Directional. Programming: Un-Modulated Carrier with ID's at TOH.

Test is being conducted by Digital Radio Engineering for field intensity experiments concerning area ground conductivity. A full DX Test will be conducted (hopefully at night) before the competition of measurements in January.

Below is the full text received from Dave Schmidt:

WB3XNN - 1620 kilohertz should be on the air about December 15th. This station licensed to Milford, PA (near Port Jervis...) is being operated for field intensity measurements of the ground conductivity in the area. This will be operating during non critical hours (approx. 0915 til 1445) with an unmodulated carrier, ID's given on the hour. Power will be 1000 watts into a 50 foot top loaded single tower. (For those in to tower currents, that adds up to 8.8 amps at 14 ohms!) Tests should continue through the end of January.

If you can, try to observe how the signal changes strength as the power is reduced and include that information in your reports.

Due to programming commitments, test will be limited to commercial breaks only during regular programming. ID's will consist of both Morse Code at 10WPM. 1000hz and phonetic voice announcements... such as:

KAGV 1110 Big Lake AK signs on with religion as "Alaska's Gospel Voice."

WEMP 1250 Milwaukee changes calls to WSSP; it'll flip to sports January 3.

KZNY 1010 Milwaukie/Portland OR flips from standards to Spanish oldies "Recuerdos," simulcasting KMUZ 1230 Gresham/Portland OR.

KBME 790 Houston TX flipped from standards to ESPN sports on Monday.

KFI 640 Los Angeles is operating on reduced power after a small plane crashed into its tower Sunday morning, killing the pilot and his passenger and toppling the 760-foot tower.

KKHT 1070 Houston TX flips from religion (now on KKHT-FM 100.7 Winnie/Houston TX) to Salem's conservative talk format as KNTH, "NewsTalk 1070."

WZXY 790 Thomasville NC changes calls (again - this is its third change in just over a month, after WIST and WFIK) to WBLO; WSVM 1490 Valdese NC returns to those calls after just over a week as WBLO.

WSCC 730 Charleston SC flips to Air America and Ed Schultz progressive talk. New calls are pending on the AM side; the "WSC" news-talk format continues on WSCC-FM 94.3 Goose Creek/Charleston SC

WCTN 950 Potomac MD/Washington DC drops its temporary oldies format to go Spanish; it'll be simulcasting with WYRE 810 Annapolis MD.

WPLC 1050 Silver Spring MD/Washington DC flips from business talk to "Federal News Radio," a companion service to all-news WTOP 1500 Washington DC, today. (The flip comes several weeks ahead of schedule; new calls WFED have been requested.)

KXYZ 1320 Houston TX will flip from Spanish religion to business talk as "Businessradio 1320" in early 2005.

KMSR 990 Farmersville/Dallas TX requests new calls KFCD; that stands for "FC Dallas," the pro soccer team for which the station is the flagship.

WWRC 1260 Washington DC will flip from sports to liberal talk on Jan. 20.

KNWX 1210 Auburn/Seattle WA will flip from business talk to Spanish on Saturday, taking new calls

WSAI 1530 Cincinnati OH will flip from oldies to Air America talk by the end of the month.

WCBG 1590 Chambersburg PA has signed off for good, the result of a settlement with the city over the construction of a new water tank a few hundred feet from the WCBG towers.

KJON 850 Carrollton/Dallas TX flips from Spanish tropical to regional Mexican "La Pantera," simulcasting with second-adjacent KFJZ 870 Fort Worth TX.

Clear Channel's KKAA 1560 Aberdeen SD drops news-talk and goes to Family Radio, which will put it back on the air with religion (it's temporarily silent), while CC's KQAA 94.9 Aberdeen SD goes to EMF, which flips it from oldies to contemporary Christian "K-Love." Family also gets KQKD 1380 Redfield SD from Aberdeen Radio Ranch, which is buying the remainder of Clear Channel's Aberdeen cluster. KQKD will flip from a simulcast of country KGIM 1420 Aberdeen SD to religion. But wait - there's more: Aberdeen Radio Ranch will flip KSDN 930 Aberdeen SD from CC's "KFAN" sports format to news/talk, mainly local. It'll keep the classic rock format on CC acquisition KSDN-

FM 94.1 Aberdeen SD and the AC format on CC acquisition KBFO 106.7 Aberdeen SD. And the existing Radio Ranch stations that will remain part of the cluster will see some changes, too: KGIM 1420 Aberdeen SD adds talk (Rush Limbaugh and Ed Schultz) to its country format, KNBZ 97.7 Redfield SD flips from hot AC to oldies as "Kool 97.7," picking up the format abandoned by KQAA: and KGIM-FM 103.7 Redfield SD remains country.

KTXV 890 Frankston TX signs on with regional Mexican as "La Gran D."

WJRO 1590 Glen Burnie/Baltimore MD changes calls to the heritage Baltimore callsign WFBR, and flips from religious to ethnic.

WBTB 1060 Monroe NC (recently changed from WKRE) changes calls again, to WXNC

KVDL 1150 Quanah TX returns to the air with classic country.

WBIX 1060 Natick/Boston MA drops its local business talk for syndicated talk.

KDTA 1400 Delta CO flips from sports "Team" to contemporary Christian.

WRWD 1370 Ellenville NY flips to country, simulcasting WRWD-FM 107.3 Highland/Poughkeepsie

WVKZ 1240 Schenectady NY flips from talk to 50s-60s oldies.

WWNZ 1400 Veazie/Bangor ME has signed on with news/talk.

WSNW 1150 Seneca SC returns to the air with oldies.

WCGB 1060 Juana Diaz PR flips from Spanish religion to English religion as "The Rock."

With this issue I feature a very interesting topic, PROPAGATION. These conditions govern what we do and do not hear and the subject isn't always easily understood. The solar index and A & K indexes tell us what reception conditions are on a daily basis. Here's a few websites that I hope will guide you and help you to understand 'propagation':

- 1. http://dx.qsl.net/propagation/greyline.html. This is a straightforward greyline map that refreshes itself every 5 minutes. It is briefly and sufficiently explained at the top of the page. Used mostly by HAM's it is useful for MW'ers too.
- 2. http://dx.qsl.net/propagation/. The current solar indices (including the A and K indexes) are prominently displayed in a box at the top of the page. The indices originate from WWV in Boulder, Colorado. If you scroll down the page, much more detailed information is available to you, should you desire it. But if not, the indices at the top of the page are invaluable for ascertaining reception conditions on a day to day basis.
- 3. http://www2.rnw.nl/rnw/en/features/media/practical/solar.html. Titled "The Solar Guide" NOAA provided the information for most of this site that helps you to more easily understand the solar indices shown in the 2nd website this week.

With this issue I feature a very interesting site called: "Old Broadcasting Equipment and Memories." Although it's BBC related I think you'll find it interesting. Find it at:

WESTERN HEMISPHERE

ALASKA. A new medium wave station has begun broadcasting in Alaska on 1110. KAGV in Big Lake began testing on November 16-17, partly using a backup transmitter of 2.5 kW. "On Thursday and Friday (November 18-19) we fired up our main transmitter at 10,000 watts. This transmitter is a Harris DX10 Solid state transmitter. We currently have two bad modules in the transmitter which will be fixed shortly. This should increase our modulation a bit," says KAGV Station Manager David Horning. DXpeditionists in Lemmenjoki, Finland, have reported to **DXing.info** that KAGV was first picked up on November 20 by Hannu Niilekselauml;. The station identifies as "Alaska's Gospel Voice", and "I AM Radio Network".

Horning tells **DXing.info** that they have been working on this station for almost three years and their construction permit from the FCC times out on December 19. "This radio station is owned by Voice For Christ ministries (VFCM) in Nenana, Alaska which also owns and operates KIAM 630 AM, and KYKD an FM in Bethel, Alaska," Horning explains. VFCM is also a satellite network and will be feeding some of the programming from KIAM to KAGV via satellite.

Horning says that he hopes to begin regular broadcasts on December 14 or 15. According to Horning, the broadcasts will be primarily religious in nature with news and information programming and also music. "Our power will be 10,000 watts 24 hours a day." KAGV is located just north of Anchorage. The station can be contacted by calling at +1-907-892-8820, or by email **Dave@vfcm.org** (DXing.info)

ANGUILLA: Radio Anguilla left 1505 in Nov 1999 (as far as I remember) and up till 2003 the station still had plans about reactivating this frequency. These plans have now been given up, and the station has no plans of using medium wave again. (Stig Hartvig Nielsen for WRTH 2005 via HCDX)

ANTIGUA & BARBUDA: The island of Barbuda now has its own radio station. It's called 'Abundant Life Radio' and operates on FM in Barbuda as well as the main island Antigua. The station originally had plans for a medium wave transmitter in Barbuda, but chose satellite instead which - according to station mgr. Clifton Francois "is much better". FRENCH GUIANA: R.F.O. Guyane, Matoury, is definitely off the air on SW as well as on MW (1070). I checked these two frequencies several times from Cayenne and Sinnamary (110 km to the west) without hearing anything. Furthermore I passed five times Matoury which is located 9 km south of Cayenne and saw only the R.F.O. FM- and TV transmitter mast on a hilltop. When departing by aircraft after sunset I noticed that this mast was clearly lit with a red light whereas no other masts were seen lit within several kms. Furthermore local people confirmed to me that only FM and TV is transmitted from Matoury. 1060 MW, R.F.O. Guyane, St. Laurent du Maroni, at the western border was checked from Sinnamary 150 km away, but never heard. Previously it only used 50 watts, thus I cannot say for sure that it also was off the air. The following Guayanese MW-stations were inaudible 6 Dec at 0840 before sunrise: Fr Guiana 1060 1070, Guyana 560 760, Suriname 600 725 820 914. If operational, they must be low powered. NB: During daytime the MW-band was completely empty in both cities even when listening away from buildings! (Anker Petersen, visiting French Guiana, DSWCI DX Window Dec 14 via DXLD)

GREENLAND: Although it apparently never has been reported outside Greenland, KNR continues to use short wave from Tasiilaq on the Greenlandic east coast. The frequency is 3815 (USB) and the current schedule is: 1500-1615 and 2100-2215 UTC. The power is 200 W and the aerial used in an omni-directional cage aerial. (Stig Hartvig Nielsen for WRTH 2005)

JAMAICA: RJR94 now on reduced power: 1.5 kW on 550, 580, 700 & 770, while 720 remains on full power 10 kW. All transmitters are on the air 24 hours a day. (Stig Hartvig Nielsen for WRTH 2005 via HCDX)

NETHERLANDS ANTILLES: On Curaçao, Radio Hoyer 1 and Radio Hoyer 2 were using medium wave on 1010 and 1500 respectively. However because of theft of the air-conditioning of the transmitters they decided to refrain from medium wave and to continue only on FM. Radio Caribe 1100 medium wave also left medium wave. The only station left on medium wave is 860 PJZ-86 Radio Curom. Listening to the FM band was completely different from last year. A year ago I heard about 3 stations from Venezuela; this year I could easily identify 15 stations, mostly from Punto Fijo and Coro. ASIA AND PACIFIC

AFGHANISTAN: An Afghan radio station has appeared on 1602 and has been heard all the way in Europe. Martti Karimies from Finland was the first to pick up the station on November 20. Later the station has been identified as Radio Khost. According to previous station listings prepared by Internews, Radio Khost has earlier operated on 1200 kHz. Radio Khost was launched in 2002 (see **DXing.info** news in June 2002 for details), and first broadcast on 1300 kHz. Radio Khost is a government-run station for Khost (also spelled as Khowst) and its surrounding areas in eastern Afghanistan, near the border with Pakistan. (DXing.info)

AUSTRALIA: ABA media release today had some interesting news for MW. See full version at: http://www.aba.gov.au/abanews/news_releases/2004/160nr04.htm. In its BCing policy released in the run up to the recent election, the Government said it would develop a policy for the introduction of digital radio in conjunction with existing radio broadcasters. In light of this the ABA is now considering whether or not to allocate vacant MF and VHF Band III spectrum pending clarification of the digital radio policy and its implications for spectrum use. Accordingly, the ABA has decided to hold off auctioning the AM frequencies identified in Round 11 - Price based allocation of transmitter licenses for open narrowcasting services. These frequencies are in Albury, NSW, and Manjimup and Northam, WA. Whether these frequencies will be made available for allocation at a future date will depend on the details of the digital radio policy that is developed. (David Onley, mwoz Dec 6)

ABA revises Launceston (Tasmania) Plans Under new plans just announced, 7NT 711 AM moves to 91.7 (192kW), 7EX 1008 AM moves to 90.1 (5kW), 7LA 1098 AM moves to 89.3 (5kW) and an SBS retransmission station is planned for 104.5 FM (3.5kW). Changes are likely fairly early in 2005, so if you haven't added these three AM's to your collection, now's the time to log them. (David Ricquish, mwoz Dec 19)

INDIA: 72 new radio stations are proposed to be set up in the country. Of these eight will be in Uttaranchal; seven in West Bengal; five in Arunachal Pradesh; four each in Bihar, Chhatishgarh and Orissa; three each in Andhra Pradesh; Assam, Jharkhand, Maharashtra, Mizoram, Nagaland, Rajasthan, Tripura and Uttar Pradesh; two each in Gujarat, Karnataka, Manipur and Punjab and each in Haryana, Kerala, Madhya Pradesh, Meghalaya and Tamil Nadu. At present, 215 All India Radio stations including 14 in Uttar Pradesh, are functioning in the country. This information was given by Minister of Information & Broadcasting and Culture, Shri S. Jaipal Reddy in written reply to a question in Lok Sabha. (PIB,Govt of India via Alokesh Gupta, New Delhi, dx india, 20 Dec)

NEW ZEALAND: In a short media release, a large part of the regional radio landscape in New Zealand has gone west. The fifteen individual regional AM and FM stations of Local Radioworks have all been rebranded as MORE FM. The stations all started off with individual ownership since 1970 and their local branding had remained intact through ownership changes and eventual acquisition by Canadian media conglomerate CanWest.

Familiar stations such as KCC-FM in Northland, Fifeshire FM in Nelson and Foveaux Radio in Invercargill are amongst the stations finally losing their own identity to become part of the growing MORE FM network.

The move follows the November demise of Radio Otago in Dunedin, XS-FM in Palmerston North and Lite-FM (descendent of Radio Avon) in Christchurch. In just a couple of weeks, over 30 years of New Zealand radio heritage has been swept aside as the newly listed CanWest moves to strengthen its ability to deliver dividends to shareholders, including its Canadian parent in Winnipeg. Manitoba.

For the record, the following regional radio stations are understood to disappear from the dial between now and January 2005: KCC-FM Northland, Coastline 93.4 Tauranga, Lakes 96FM Rotorua, KIS-FM Taupo, Energy FM Taranaki, Hot 93 Hawkes Bay, 92.8 STAR FM Wanganui, HITZ 89.3 Wairarapa, 95FM Levin, 2XX Kapiti, Fifeshire 93 FM (+ 990 AM) Nelson, Resort 99 FM (+ 1359 AM) Queenstown, Radio Central (+ 531 AM) Alexandra, Big River Radio Balclutha and 89.2 Foveaux FM (+ 1224 AM) Invercargill.

Whether the AM outlets will carry MORE FM isn't clear. They may flip to The Breeze brand instead. CanWest says 'Aside from the name change, listeners will notice minimal differences, except they will have greater opportunities to participate in even better contests and see their local station involved in national sponsorships such as the Super 12'. Daytime broadcasts continue to originate locally, at least for now. However, the new MORE FM stations now join a nationwide nighttime program hosted by NZ Idol's Dominic Bowden.

TAIWAN: The government is planning to integrate the resources of the two state-owned radio stations to set up a multilingual "Voice of Taiwan" radio network to serve foreign nationals in Taiwan, the Government Information Office director-general said Saturday.

Lin Chia-lung unveiled the plan while addressing a Mandarin and Taiwanese story-telling competition for foreigners hosted by the state-owned Radio Taiwan International (RTI). Lin pointed out that the RTI, which receives NT\$500 million (US\$15.6million) in government funding every year, is mainly responsible for overseas broadcasting.

To serve foreign nationals residing in Taiwan and help them better understand the island, the government will set up a new radio network by combining the resources of the RTI and the other state-owned radio station, Voice of Han Broadcasting Network, Lin said. The "Voice of Taiwan" will broadcast programs in a number of different languages, including Mandarin, Taiwanese, English and Japanese, he said. (Y.F. Low, Nov. 27 CNA, via Mike Terry, DXLD)

EUROPE. AFRICA. AND MIDDLE EAST

BENIN: Additional information received from TWR about the new relay station which is going to be constructed near Parakou during 2005: the transmitter will be operating on 1566 with 100 kW. Cf. http://www.twrafrica.org/0055.asp for other details about the project. (Bernd Trutenau, mwdx)

CHAD: Following a discussion by DXers Martin Elbe, Thorsten Hallmann and Rick, on the German language A-DX mailing list, I monitored 840 kHz. Indeed, I could see a carrier, s/on at 04:25, s/off at 22:31 which corresponds to Chad's schedule according to WRTH 2004. The frequency is variable and drifting 839.97 - 839.99 kHz. It is only a 20 kW tx but it should be possible to capture some modulation as well. Last night, the signal was quite strong from 21:00 on, and as 846 is free, tuning into USB should reduce QRM from 837. It may be possible that the program is in // to 6165 where Chad is heard almost every evening. (Guenter Lorenz, Freising, Germany mwdx Dec 1)

CONGO: At 2030 utc am now getting ID of "Republique Democratique du Congo" with FF programming on 945 KHz. Anyone else ID this station? Is it Congo Brazza or Congo Kinshasha? It is not listed in my 2004 WRTH. (John Plimmer, South Africa, mwdx Nov 26)

CROATIA: Croatian tx on 1134 is off already since last week. I expected a short failure or maintenance only so I did not report it. Now when I did it, the tx surely goes on the air very soon, HI (Sod's Law) (K Honzik mwdx Nov 23)

A very strong wind with speed over 220 km/h had caused damages on two of 4 antenna mast in Zadar. They have damaged base insulators. Unfortunately power distribution is coming from TX and later being distributed through one of them. Base insulators are ordered from RIZ factory which delivered and installed the antenna masts at beginning of this year. We are expecting to start transmission during next week with omni antenna system and two weeks later with directional antenna system as it was before this storm.

In mean time transmitter Deanovec 100 kW is tuned from 1125 to 1134 kHz instead, because our listeners are usually on this freq because 600 kW TX site in Zadar has better reception in Europe.

Waiting for insulators is quicker way how to start transmission again, instead doing complex bypass through mast 1 and tuning one of good antenna mast to receive power of 600 kW with proper impedance matching. (Nikola Percin, HRT - Technical Director, e-mail to Wolfgang Bueschel)

Since yesterday [Nov. 23rd] before, I noted HR signal on 1134 again, B U T with decreased power, (Wolfgang Bueschel) (summarized from World of Radio & HCDX postings)

CZECH REPUBLIC: Radio Prague may carry its program in English and German on longwave in the future. In answer to a listener's question on Sunday's Mailbox program, Radio Prague Director Miroslav Krupicka said: "It is not reality at this moment but we are considering going on longwave in English and German. It's a longwave that is used by a domestic channel of Czech Radio, Czech Radio 1 - Radiozurnal, which broadcasts on the FM network and on LW [270, 750 kW]. We are in talks with this station to give us a certain space on longwave in order for us to be heard beyond the border of the Czech Republic in, say, Germany, Austria and Poland because longwave travels further than medium wave, for instance, or FM, so we would be heard in Central and Eastern Europe on longwave quite well. Of course, this is an addition to shortwave broadcasting. We are always on shortwave, we will stay on shortwave, but in addition we are looking for tools in order to be heard both in the Czech Republic and in Central Europe. In the Czech Republic we are currently on FM in Prague in English, this is a service for tourists, people visiting the Czech Republic, businessmen and so on. It's quite appreciated by the audience from what I have heard. And to expand on longwave would be quite nice, so we are working on it, but it is not yet reality." (http://medianetwork.blogspot.com/ via mwdx Dec 16)

FRANCE: RMC Info have started transmissions via their Mulhouse relay on 1584 and the relay in Strasbourg is now operating at full power. Daytime reception in the coverage area is good but at night the signal is only fair to poor due to skywave interference. (Rémy Friess mwc Dec 12)

The latest in a series of new French commercial stations probing the medium wave dial, Radio de la Mer from Paris has been broadcasting on 1080 since Nov 26. The station was reported first by Christian Ghibaudo in DXLD 4-179. Radio de la Mer plans to launch its remaining two MW transmitters in Brest and Montpéllier during the first half of 2005. According to the station website, initially most of the programming will be music, but talk and features will be added gradually. (DXing,info, Dec 7)

GERMANY: A station broadcasting country music - a rare phenomenon in Europe - has been launched in Germany. TruckRadio is broadcasting on 702 (in Jülich) and 855 kHz (in Nordkirchen). The station signed on at 1620 UTC on December 6, and was immediately heard by several German DXers. The company behind TruckRadio plans to cover entire Europe with DRM transmissions some time in 2005. (DXing.info, Dec 7) New German station Truck Radio now being heard with good signals on 702 and 855 with C and W music and IDs via DXTuner receiver in Rommele in Sweden (Tony Magon, mwdx, Dec 12)

Browsing the Telefunken website brought up that they installed a new 100 kW tx at Deutschlandradio's Berlin-Britz site already in summer 2003. Frequency not mentioned, but this appears to be the new main tx for 990. T-Systems ordered new txs for Deutschlandradio sces: For longwave 2 x 500 kW, for mediumwave 1 x 100 kW, 1 x 200 kW, 2 x 800 kW. Delivery and installation are provided for 2005/2006. No further details given, so one can only guess about the destinations of the mediumwave equipment. A single 800 kW is meant for Braunschweig-Koenigslutter of course, and probably the mention of 2 x 800 kW in fact just describes this very pair of TRAM400 txs since I have no idea where else 800 kW could be used. 100 and 200 kW would match the 549 sites (Nordkirchen and Thurnau- Tannfeld, respectively). [Heusweiler-Saar 1422 kHz DRM replacement?, wb.]

Some details about the new (rather: refurbished) 177 kHz antenna at Zehlendorf: www.telefunkensendersysteme.de/int/Press/DRM_and_lw-antenna/drm_and_lw-antenna.html. I think the 153 antenna at Donebach has a quite narrow bandwidth as well, also resulting in the muffled-sounding modulation? If so a new tx alone wouldn't make the facility DRM-ready... ("As well" referring to the triangular hammock used for 177 during the nineties which had to be replaced by the main mast again because its bandwidth was insufficient for DRM operation.) (Kai Ludwig-D, BC-DX Nov 28, via Worldwide DX Club Topnews)

Freiburg 828 and Baden-Baden 1485 are no longer on air around the clock but only Mon-Fri 0400-2200, Sat-Sun 0600-2200 anymore. See http://www.swr.de/frequenzen/hinweise/index.html. There are plans to switch off Südwestrundfunk medium wave transmitters at night. Only Mühlacker 576 will stay on air overnight in case this concept will be fully implemented. (Kai Ludwig 26 Nov and 2 Dec via Arctic)

Extensive changes at the Braunschweig/Königslutter site as noted on a recent visit: The 630 transmitter (ex Megaradio) has been dismantled. At present the installation of two new Telefunken TRAM400 transmitters is under way, one of them is already completed and runs 756 with 200 kW at present, the smaller TRAM transmitters previously used on 756 are off air now. It is still planned to run DRM in simulcast mode here, probably starting next year when the second TRAM400 will be complete. Pictures of the current installations: http://www.do1oli.de/dlf/. HUNGARY: The Hungarian government has given the green light to the privatization of national telecommunications and broadcasting company Antenna Hungaria Rt (AH) in an open tender. According to press reports, six foreign investors have expressed interest in taking part in the privatization tender: France's Telediffusion de France, Portugal's Portugal Telecom, Retevision of Spain, Italy's Telespazio, the Czech Republic's Ceske Radiokomunikace, and venture capital firm Advent International. (Media Network Mike Terry via HCDX Oct 29. via Arctic)

Changes in Szolnok: the 5 kW transmitter for Radio Szolnok on 1350 was closed in May 2004 and replaced by an FM outlet on 101.2 MHz. This was necessary in preparation of the launch of Magyar Katolikus Rádió via a 135 kW transmitter in Szolnok (and Siófok 150 kW) on nearby 1341 which is due in April. There are no plans to close or move the transmitter for Radio Györ on 1350 (Györ, 5kW). (Source: official info) (Bernd Trutenau, Lithuania, MWDX)

IRELAND: Irish public broadcaster RTE has announced that maintenance on its 500 kW mediumwave transmitter at Tullamore has been completed, and the station will resume broadcasting on Friday 5 November. The transmitter has been off the air since July. (media network weblog via Mike Terry, MWDX Nov 22)

The signal on 567 is coming in well in this part of London just before 0300 on 6 Nov. The main test will come once the sun rises around 0700 or so. Prior to the closedown, the signal could be heard in London throughout the day, if somewhat weak, despite adjacent channel splatter from Spectrum 558, and I would expect the same to apply now, assuming that the signal characteristics, i.e. power and antenna set-up, are the same. During the night the signal, as well as the audio quality, is better on 567 than on LW. It will be interesting to see whether RTE offer any alternative programming on 252 as opposed to 567. I would assume that alternative programming is offered on FM whilst sports in on the other outlets, but of course the FM signal will never reach London. (Paul David, mwdx)

Religious radio station Solas AM has handed their license back to the BCI. The station was awarded a license to broadcast to Dublin on medium wave in April 2001 but have not managed to get on air. The station cites prohibitive expenses involved in AM broadcasting when compared to FM. They also are unhappy that they have not been given the option to take a license for FM broadcasting. Solas AM ran in to many difficulties in their attempts to get on air. They had claimed as recently as last July that they were not yet ready to call it a day. 189 RAI longwave in Caltanissetta is currently operating with a 1 kW reserve transmitter. This may be the first step towards a final closure. (tnx A. Borgnino) (Roberto Scaglione, http://www.bclnews.it Nov 8 via WORLD OF RADIO 1252, DXLD)

693 RAI Milano will conduct DRM tests from January. (Dario Monferini, MWDX 22.11.2004)

567 RAI Radio 1 is using Caltanissetta's 567 MW transmitter for regional programs at 6:20; 11:20; 13:30; 18.26 UTC. Target area: Mediterranean and Central Europe.

(Nino Marabello, Treviso, Italy, Nov 28 DXLD)

Radio 1 from the Bologna/Budrio transmitter is switching from 1116 to 567. Both frequencies are presently on the air in parallel, but from next week, according to RayWay, 1116 will be closed down. (Stefano Valianti, mwc Dec 17) Transmissions from Bologna on 1116 have ended today. RAI Radio 1 from Bologna is now on 567. (Stefano Valianti, mwc Dec 21)

LATVIA: Radio Nord, the local station in Riga on 945, started regular 24h transmissions on 22 October at 0700 UTC. (Bernd Trutenau via MWDX Oct 20)

LUXEMBOURG: From the beginning of next year Luxemburg will run DRM transmissions on 1440 kHz. No clue, at what hours, I suspect, that they will use it during their own programming only and if the clients renting the transmitters want to use DRM. Let's hope, that at least they switch off the beast at nights. I'm pessimistic concerning the future of MW-DX, I'm afraid that next year at this time we'll see a lot of channels occupied by DRM and reduced chances for TA reception. I don't have a problem with DRM on shortwave, it's a nuisance, but I think, we DXers can live with it. But on MW DRM is absolutely lethal. (Martin Elbe, mwdx Nov 25) Telefunken will provide BCE's Marnach site with a new TRAM/P 600 unit, consisting of two 300 kW transmitters. The system can be easily switched between DRM and AM operation. Press release http://www.telefunken-endersysteme.de/News_Presse/RTL_digital_mw.html in German. Meanwhile WRN stated on enquiry that for the time being no changes for the AM transmissions of CRI on 1440 are planned. (Kai Ludwig, Germany, Nov 28, DXLD)

Re: Telefunken transmitter deliveries --- This morning I intercepted RTL 1440 with a 2 kHz tone at 0200. At 0205 the signal switched to digital and this went on until 0220, when there was a 5 minute break, apparently without carrier, before the digital signal continued. No RTL ID, but who else could it be? So it seems the new TRAM transmitter is already in place and testing. The worst situation now would be if the owners decide to fill hitherto unused night hours with DRM. (Olle Alm. Sweden, Dec 18. DX LISTENING DIGEST)

MACEDONIA: International electronics and systems group Thales has announced that a new world record has been reached in Macedonia for Digital AM Broadcasting. PE Makedonska Radiodifuzija (MRD), the national public broadcaster [sic, this is the national transmitter operator, the country's public broadcaster is called Makedonska Radio-Televizija (MRT) -BT] in collaboration with Thales and Deutsche Welle (DW), succeeded in transmitting 720 kW mean power in Digital Radio Mondiale (DRM) mode from the medium wave station Ovce Pole, the highest DRM power ever broadcast by a single transmitter, reaching exceptional coverage and quality of reception.

Transmissions were done on 810 with the Thales' S7HP 1200 kW solid-state medium wave analogue transmitter, in operation at Ovce Pole since its inauguration in June 2002. For the tests, Thales provided front-end equipment from its Skywave 2000 DRM Digital Product Line.

The necessary measurements of the signal quality and coverage area were performed by DW using their measurement van and various fixed control and measurement centers in Europe. Measurements were carried out twice a day: 3 hours during day time -groundwave propagation- and 3 hours during night time - skywave propagation- while transmitting the program of Macedonian Radio. The DW measurement van confirmed a coverage area during daylight of up to 300 km, whereas by night the DW centers recorded reception over larger areas of Western Europe. The audio quality was excellent and disturbance free. (Media Network Blogspot 16 Dec via mwc)

NORWAY: Radio Netherlands' Ehard Goddijn drew our attention to a very strong SSB signal on 7360 noted in progress at 1230 UTC, carrying the NRK domestic service in parallel with 1314 mediumwave. The SSB was replaced by a silent carrier at 1240, then the modulation resumed at 1251 UTC. More details at http://medianetwork.blogspot.com/. (Mike Terry, HCDX)

SERBIA & MONTENEGRO: 981 SRT Cacak has left the MW. 1215 Radio Mladenovac is now back on the air with full power, 1 kW. 1296 Radio Podrinje has left MW for FM 104.8 MHz. (Svetomir Cuckovic via Bengt Ericson, Arctic)

SPAIN: RNE 1 on 738 seems to be on full power again since Monday 29 NOV. It is again the strongest Spanish MW signal here in my location. According to Spanish sources, the 300 kW TX unit has been replaced by a new 600 kW one. (Karel Honzik, mwdx Nov 30)

UNITED KINGDOM: As of Monday this week, BBC Radio Leeds is carrying local programming during the period 0100-0500 on all its AM and FM frequencies (774AM, 92.4MHz, 95.3Mhz, 102.7MHz, 103.9MHz). Previously the station relayed BBC 5 Live between these times. NB nothing on station website http://www.bbc.co.uk/england/radioleeds/ about this apart from 0100-0300 on Saturday (Gavin Robertson & BDXC, via Ray Browell mwc Nov 25)

UK media regulator Ofcom is today launching a consultation on the future of UK radio. Amongst the proposals under consideration are the use of the following medium wave frequencies (subject to negotiations with the BBC) for a mixture of local/regional commercial and/or community services across the country. Frequency/current users/area served 1116 BBC Radio Derby (Derbyshire), Valleys Radio (South Wales valleys.)

1368 BBC Radio Swindon (Swindon), BBC Southern Counties Radio (Reigate), BBC Radio Lincolnshire (Lincolnshire), Manx Radio (Isle of Man)

1377 Asian Sound (Manchester)

1431 Classic Gold 1431 (Reading), Classic Gold Breeze (Southend), Fresh Radio (Ilkley & Settle), Long-term restricted services located south of the M4 motorway.

BBC Southern Counties Radio (Brighton), BBC Radio Merseyside (Merseyside), BBC Radio Humberside (Humberside), Classic Gold 1485 (Newbury)

1521 Classic Gold 1521 (Reigate & Crawley), Forest of Dean Radio*

1530 BBC Essex(Southend), Classic Hits(Worcester), Pulse Classic Gold(Huddersfield & Halifax)
