Programming: Normal Radio Disney Format ONLY. No codes, tones, etc. are permitted due to the stations contract with Disney.

Notes: Listeners are cautioned that WDSS, Ada MI also runs the Radio Disney Format. So ID's, local spots, etc will be needed for a QSL. A cassette or CD included with a report will be much appreciated, as it will be easier to tell for sure they heard KAVT, rather than WDSS. #### WAPI 1070 kHz & WJOX 690 KHz Test Results

Recently our hobby had its first chance to test the concept of a sixty second long DX test that could be inserted into the commercial advertising inventory of a station and ran over several nights. This idea was the creation of former National Radio Club test coordinator Fred Vobbe...and by all accounts, it was a darn good one!

Our thanks again to Fred Giardina and the staff of both stations for this holiday treat.

### TEST RESULTS

Test began promptly on December 27th, with the first report coming in from Steve Francis of Alcoa, TN who reported WAPI codes and sweeps.

Rick Shaftan in New Jersey reported the sweep tones on WAPI to be "booming in", followed by a successful reception of WJOX just eight minutes later. Les Rayburn of Birmingham logged both local stations, mainly to insure that things worked without a hitch.

DX'ers John Hunter in Rossville, GA pulled in the test, along with the first Canadian reception reported by Barry McLarnon of Ottawa, Ontario. Barry reported WAPI "in like gangbusters".

WAPI put an "excellent signal" into the home of Tom Jasinski in Shorewood, IL, and both stations were logged in Central PA by Brett Saylor on his Drake R8.

Dave Hochfelder in Highland Park, NJ logged WAPI using an unattended radio and his computer to do the recording. Bruce Winkelman logged the test in Tulsa, OK the old fashioned way using his ears and a Drake R8 with a Quantum Phaser to null the locals.

R.C. Watts pulled in "weak CW and sweeptones" from WAPI in Louisville, KY, adding Kentucky to the list of stations hearing the test. Texas wasn't going to be left out of the fun, with James Niven of Moody, TX logging WAPI despite a strong signal from nearby KFTI.

Peter Jernakoff logged WAPI from his home in Northern Delaware, adding a "new one" to the log. And Russ Johnson reported WJOX "very easy copy" from his home in Lexington, North Carolina.

Eric Breon caught "pieces of code and sweep tones" from WJOX in his Middletown, PA shack, and James Wallace pulled in the sports talk station from his home in West Virginia using only a Radio Shack AM loop.

The furthest catch for the test was that of Curtis McMenamin of Vacaville, California! This is a distance of nearly 2000 miles! His cassette recording revealed successful reception of both WAPI and WJOX, proving once and for all that the "inventory insert" concept has real merit. Great catch Curtis!

Also logging both stations during the test was Gerry Bishop of Niceville, FL. John Sgrulletta of Mahopac, NY copied WAPI despite lots of competition from WINA and CBA. Other loggings included George Sherman in MN, who logged WAPI, and Phillip Cheillo who pulled in the 1070 test from his shack in Elk Grove, WI.

And as would be fitting, Fred Vobbe of Lima, Ohio benefited from his own idea by logging the test successfully using a Yaesu FT-857D and a low band folded dipole.

By my count, that means that at least one of the two stations was logged in at least 17 states and a Canadian providence! Not bad for one minute worth of audio and night time power!!

Of course, there were DX'ers around the world who tried for the test without success...among those were Wade Smith of New Brunswick, who couldn't pull out WAPI over the dominant signal of CBA.

Martin Foltz in Southern California did combat with two powerful stations KNX and XETRA, but lost the war. While Martin Hall, editor of the UK publication, "The Medium Wave News" couldn't hear anything over dominant CBA from his shack in Clashmore, Scotland.

Pete Taylor used a Sony 2010 and a Kiwa Air Loop but couldn't find anything in the null of his locals on 1070 kHz. Tacoma, Washington would have been nice DX for this test. Better luck next time, Pete. Also disappointed were Curt Deegan of South Eastern Florida, Scott Fybush of Rochester, NY, and

#### Shawn Axelrod of Winnipeg.

It was a rare miss indeed for Patrick Martin of Seaside, Oregon who usually can pull in a milliwatt signal on that beverage antenna of his. Also no "joy in Mudville" for Phil Bytheway, Bruce Portzer or Saul Chernos. Likewise disappointed with our holiday treat was Glen Hauser of Enid, OK, who heard the Marine Corp March (Unid) on 690 kHz, but no codes and sweep tones. **SOAPBOX** 

WAPI signal sounded like full day power! -Tom Jasinski, Shorewood, IL

Might have easily heard them [on the first night] if I hadn't fallen asleep! The last time I can remember looking at the clock it was 0043. -John Hunter, Rossville, GA

In like gangbusters here too. CW ID, sweeps, then one more CW ID. -Barry McLarnon, Ottawa, Ontario, Canada

This was a great idea for a test, probably not very "invasive" from the stations perspective. -Eric  $\ensuremath{\text{Breon}}$ 

No sign of the 1070 test in Seattle last night. Just the usual mix of KNX, CFAX, and electrical noise. -Bruce Portzer, Seattle, WA

Alabama is not particularly well heard in the UK - the only MW stations I've logged are 1590 WVNA (rare!), 1620 WPHG (not easy, now silent), and 1700 WEUV, which is the most common, being heard on several occasions each season. **-Martin Hall, Clashmore, Scotland** 

To those who doubted 60-second tests, "see, told you so!" -Fred Vobbe, Lima, Ohio

The sweeps and tones really get out. The tests have also made me a believer in overnight recording. -Dave Hochfelder

Pounding in here in NW New Jersey with ESPN Radio, Sweep tones, code, etc. -Rick Shaftan, New Jersey

Conditions were best during the first day, which was characterized by many strong signals, low noise, and much flutter (rapid, shallow fading). -Phillip Chiello, Elk Grove, WI

Again, our sincere thanks to Frank Giardina for running this test. Don't forget our upcoming test with KAVT 1680 kHz in Fresno, CA on January 21st!

#### Proof of Concept Are Inventory Inserts the future of DX Tests? By Les Rayburn, N1LF Broadcast Test Coordinator

The "inventory insert" concept was the brain child of former NRC test coordinator, Fred Vobbe. Faced with more and more resistance to running traditional DX tests as part of scheduled maintenance periods, Fred searched for a way to encourage more stations to run tones, Morse Code and other unique identifiers that aid DX'ers.

Fred's original idea was to create sixty second long recordings that would include the stations voice ID, Morse Code identifications, and the NRC sweep tones. No change in the stations power level or antenna pattern would be required. Instead, the engineer would simply insert the "test commercial" into their overnight inventory of available local spots. The test could run several times each night for a number of days.

While these types of tests will lack the advantage of day power and patterns, they possibly gain the advantage of providing a better chance for good propagation and/or low noise. We've all seen past tests that were ruined by aurora conditions, thunderstorms, or poor conditions.

Our first operational test of the this new concept came last week, when Chief Engineer Fred Giardina agreed to run the test on both WAPI 1070khz and WJOX 690khz for three nights.

In terms of what we hope for, this test was not ideal. Local inventory was limited to the spots airing only twice per night on each station...and the test period was limited to three nights. It's worth noting that the test occurred during one of only two periods of each year when Arbitron ratings are not kept for radio stations in the US.

Despite the restrictions, the test was very successful. Complete details of the test are available in this issue, but in summary the test was received in 17 states, and Canada. Best DX was nearly 2000 miles away in California, and in that case, both stations were received during the test period.

### **Test Format**

The test consisted of computer-generated voice ID using text to speech software. A female voice was chosen, with a slight British accent. The Voice ID consisted of the following phrases:

"This is WJOX conducting transmitter testing. Whiskey Juliet Oscar X-Ray Testing".

This was followed by Morse Code ID's transmitted at ten words per minute, using a 1,000 Hz tone. The station identification was repeated three times.

Following these identifiers, we inserted about twenty seconds of the NRC "Sweep Tones". These tones are commonly used to test various parts of the audio chain in a transmitter system, and have proven to be the most effective audio source when heard at a distance. Outperforming Morse Code, marching band music, and other program material that has been tried in the past. In many cases, these were the only identifiable part of the transmissions. While DX'ers can debate if successful reception of just the sweep tones would qualify for reception of a station, I believe that if the tones can be correlated with exact time of transmission that would provide enough data to verify a successful logging.

What are the odds that any other station on that frequency would be running such a unique tone, at that given moment? I'd suggest so small as ruling out all other stations, and verifying the logging. That is for each station and/or individual DX'er to determine. In any event, the tones are very effective.

This pattern continues for the duration of the sixty second tests, and can be changed for each test to avoid people being able to "guess" what was transmitted. After creating the file, we further enhance the material for distant reception by boosting the 2-3 kHz range using Sony's Sound Forge 7.0 software. Compression is also applied to the file to insure maximum drive levels to the transmitter without clipping. We then send the file to the station as either an MP3 file or a .WAV file on a compact disc.

### History

In recent weeks, it's come to my attention that the concept is not totally new. In the past, radio stations have added a single Morse Code ID to their normal top of the hour station identification. Sometimes this was by way of a "signature" for the station, and other times it was at the suggestion of DX'ers.

Even today, some stations transmit unique sound effects, tones, or other signature sounds at the top of the hour, which can aid identification. Fred Vobbe's concept really just expands on this idea.

### Why change at all?

The relationship between distant listeners and broadcasters is changing rapidly, and no where that is more obvious than with tests. By law full power tests or nighttime operation on daytime antenna patterns can only be performed as part of a scheduled maintenance operation.

Station owners are more and more concerned about legal liability if such a test causes interference to other stations, and loss of revenue even at night if the station is not running its normal programming. In addition, many program providers such as Radio Disney have strict contractual agreements that preclude the station from running tests.

Add to that the need for an engineer to be on site or in the studio in the middle of the night, and a general lack of interest in our hobby among broadcasters, and you can see that the landscape is changing.

We've taken pro-active steps to help combat some of these issues. We regularly attend Society of Broadcast Engineering meetings in this region, and contribute posts to e-mail lists devoted to the broadcasting industry to help educate stations about our hobby. We've started relying more on telephone calls and personal contact with our members and less on random mass mailings to stations to request tests.

We post our cell phone number widely in engineering circles, asking them to contact us at anytime twenty four hours a day if they intend to be off the air for maintenance. And our formal requests are now accompanied with a CD of Morse Code ID's for the station, programming material, etc. to make it easier for stations to say "yes" to our requests.

We've also offered to handle reception reports, QSL's, etc for stations that agree to run tests. All these steps reflect a better understanding of the pressures that stations operate under now, and are designed to minimize our impact on their resources.

### The Future of DX Tests?

Does this mean that we can't look forward to any future full power, daytime pattern tests? Quite the contrary, such tests are always our goal. The hobby remains fortunate to have a number of engineers and other station staff who are themselves active DX'ers, and enjoy putting on such tests when their stations have maintenance to be performed. And members continue to surprise me with their success in reaching out personally to their local stations to do such tests.

But I suspect that the "inventory insert" concept will be a popular choice for many broadcasters, and we can look forward to more of them. One test alone does not prove the concept, but if the WAPI-WJOX test is any indicator, these tests may rival their full power counterparts in terms of success.

These test results suggest that the greatest benefit will be for listeners within a 700-800 mile radius, where the change in programming may compensate for the low power or directional pattern. Results at greater distances are likely not to be as good as the full power/pattern tests, even if the DX'er concentrates on the test for an extended time.

But the nearly 2,000 mile reception of WAPI and WJOX indicates that long distance receptions will not be impossible, and are still aided greatly by the change in programming.

New techniques will need to be embraced by DX'ers to take full advantage of the test. Overnight, unattended recording using software like Total Recorder will be the best arrow in your quiver. Second to that will be the use of Phasers and loops to null other stations on the frequency, and possibly post recording audio processing to help reduce noise and pull out the desired signal.

The broadcasting industry is changing, and if we wish to be successful, we'll all have to embrace new technology and techniques to do so.

### What can I do to help?

Individual DX'ers can do much to help the hobby in regards to DX Tests. We now encourage members to use their contacts at work, church, and civic organizations to get to know station managers, engineers, etc. If you ask around, you'll be surprised how quickly you can meet most of the people involved with radio in your area.

Find out if the Society of Broadcast Engineers (SBE) has a local chapter, if so, see if you can attend their meeting and give a short talk about our hobby. By contacting the NRC or IRCA, you can usually obtain plenty of back issues of our printed publications to hand out, and if you play some recordings of your best catches, you can give an entertaining talk for a half hour or so.

To find out if there is a chapter in your area, visit the SBE web site at: http://www.sbe.org/chapter\_find.php

Usually these clubs struggle to find speakers for their meetings at least once or twice a year, and will welcome something that will be a change of pace from their usual material.

One little tip that has worked for me, if you're invited to speak at the meeting, ask to see which local AM stations have engineers that are members. Send me an e-mail in advance, and I'll supply you with CD's full of station ID's, inventory inserts, sweep tones, etc. for you to give them directly. You're not likely to be turned down flat if you request a test in this fashion!

### Stop playing cop

Another way that DX'ers can help is by being very careful about all contact you have with the broadcasting industry. The majority of stations are now owned by groups, and any tales of a bad experience with a radio hobbyist quickly spreads throughout the industry.

Some of us seem to delight in reporting stations to the FCC if we suspect them of "cheating" on their daytime power at night. I've heard all kinds of justification for these actions, but frankly, none of them benefit the hobby enough to offset the potential damage.

Even the term should be banned from our language... usually a station that is running at daytime power at night is the result of an automation problem, human error, or other technical issues. We should presume that the situation is unintentional and innocent.

If such operation continues for extended time, other stations on the frequency will notice and either contact the offending station directly or file a complaint with the FCC. Such complaints are given much more weight than those of "hobbyists" and by allowing the industry to police itself we avoid any ill feelings towards DX'ers.

Recently, I had a DX'er who frequently takes it upon himself to "play cop" attempt to justify his actions by saying that he never identified himself as a member of the National Radio Club or the International Radio Club of America. Instead, he complained to the station's owner stating that he was a "radio hobbyist"... for me; this is a distinction without a difference. The damage to the hobby is done.

In the mind of that owner, radio hobbyist now equals pain in the rear end. How much luck do you think we'll have with that station if we approach them about a test or ask for a QSL?

Radio is a business. The people involved it in are motivated by a desire for profit... listeners outside their local market are not measured for ratings purposes, and as such they are not very interested in your concerns. Fewer chief engineers these days are amateur radio operators or even shortwave listeners, so our hobby can seem strange and foreign to them. A QSL card may be the most important thing in the world to you, but to the station it may just mean "more work, with no benefit".

Be polite always, and if you don't achieve the desired result, be that a reception verification or acknowledgement of a transmitter problem, then give up. Get out of your shack, take a walk around the block and cool off. Becoming rude, or worse reporting that station to the FCC can only do harm to all of us.

Frankly, I resent even having to write these words, but my brief tenure as BTC as taught me that our numbers contain more of these types of "sea lawyers" than you might suspect.

### **Final Thoughts**

Fred Vobbe is to be congratulated for a novel approach to getting more stations to conduct tests that benefit all of us. I'm happy to report that Fred was one of the DX'ers fortunate enough to log a new one during the recent WAPI-WJOX test... it's only fitting that he directly profited from his own imagination.

Thanks also to the dedicated members who have volunteered to help us set up tests in their area. Most of the tests in the past two seasons are the results of their efforts more than my own.

More TA DX this week around. So away we go.

## TRANS ATLANTIC DX ROUNDUP

153 **NORWAY**, with a man speaking in NN. Good signal at times. 1/4 This along with 189 Iceland, is the most frequent TA heard here. (MS-AB)

- 162 **RUSSIA**, 0355 1/4, with a large group of people singing which followed by 2 men speaking in RR. There was identical programming on 171, so this was possibily the Radio Rossii Service. Good signal at times. (MS-AB)
- 162 **FRANCE**, with man reading the news in FF heard after the Russian faded out around 0400. Fair signal. (MS-AB)
- 171 RUSSIA, 0355 1/4 with identical programming to 162, though a much noisier signal. (MS-AB)
- 177 GERMANY, 0421 1/4 with man and woman in GG, Fair signal. (MS-AB)
- 180 **CARRIER**, no audio detected (MS-AB)
- 183 **GERMANY**, 2341 1/4 with 2 women speaking FF. This is the Europe 1 station at Saarlouis. Fair signal. Unfortunately I missed the closedown anmts at Midnight. (MS-AB)
- 189 **ICELAND** with an excellent signal 1/4 0330. (MS-AB)
- 198 **UNITED KINGDOM**, First noted 2333 1/4 with two men discussing family gene traits. At 0000, I heard the Westminster chimes from Big Ben and a BBC Radio 4 ID, Poor signal. (MS-AB)
- 198 RUSSIA assumed here at 0249 1/5. Music and singing heard and a male speaking what could have been RR, a very fadey signal, o/u BBC with a third station under these two. (MS-AB)
- 207 ICELAND, 0021 1/5 with faint mx under beacon noise. Could only be Iceland as it // 189, Poor signal. (MS-AB)
- 216 **RŬSSIÀ**, at 0015 1/5. Radio Rossii here with Perry Como record. Identical programming to 171. Fair at times. (MS-AB)
- 225 UNID, 0347 1/4 with two men speaking in what sounded like the Russian language, Not // to 162 and 171, so possibly Poland. If so, then this is the first time I have heard it since I logged it back in November 1984 when it was on 227. (MS-AB)
- 252 IRELAND, Clarkestown 0251 1/6 with light Classical mx, followed by male voice speaking EE. In spite of an S-6 level, it was quite difficult to understand everything that was being said due to the low modulation level used. No ID at TOH, but right in to news read by a woman. At TOH + 2 minutes I heard "This is Radio 1 in ?? and Belfast". Good signal at times. (MS-AB)
- 279 **UNID**, faint audio heard here 0341 1/4. Too faint to get the language used. Possibly Belarus, though it could have been one of the 4 Eastern Russians on this frequency but not // to either 162, 171, or 225. (MS-AB)

Just booming in most of the time at armchair copy o/KERI with various romantic ballads, at 1240 ID "recuerdos con el corazon, en Radio Amor" (recordds from the heart, on Radio Love) SS version of "Where Oh Where Can My Baby Be" at 1252, full ID by woman at 1300 as "equis-eh-deh-ceh-ache" mention of Radio Amor and emisora (transmission)in "Ciudad Delicias, Chihuahua, Mexico" Best signal on this one to date. (RW-CA)
- 1560 MEXICO, Ciudad Juarez, Chih. XEJPV Radio Viva 12/25 0636 with KNZR 1560 running OC at lower power and heard this playing what sounded like rel. songs in SS. Radio Viva ID's. KNZR back on at 0657 and after was on/off running OC at higher power. Fair to poor signal. (MF-CA)

#### DXing on the Cruise! Walt Salmaniw

I hope that this is not being too far out of line, fellas, but I thought that I might share a little bit of my travels the past couple of weeks. We left Victoria on the 19th, and returned last night 1/1/2006. We spent a week aboard the Costa Mediterranea, a 980 foot, 85,000 tonne behemoth. Luckily our cabin had a small deck where I was able to do a modest amount of DXing. In tow with me was my most recent receiver, the Kaito 1103 portable. 99% of my listening was on the AM and FM bands using the built-in ferrite rod and telescopic whip. Despite this drawback, I was most impressed with the performance of this receiver. I brought along my i-River 795T MP3 player/recorder and taped some 10 to 15 hours of programming. Guy Atkins clued me into this receiver. I did find that it produced some noise in certain modes (when paused for instance) within a meter or so of the receiver, but while recording, this didn't seem to be much of an issue. I loved the fact that it would record up to some 80 hours or so at a bit rate of 16 kbps at 16 kHz Mono. What an advance over cassette tapes (what I used to use... the Sony 1000T), or MD recorders. The Costa Mediterranea set sail from Ft. Lauderdale heading south/south-east to Puerto Rico, and then to the US Virgin Islands, the British Virgin Islands before returning to Nassau and back to Ft. Lauderdale. Not at all as extensive a cruise as my last between Tahiti and the Marguesas a couple of years back, but nonetheless still fascinating from a radio perspective. I was unaware of the ship causing any significant RF to my reception. I focused especially with the split frequencies on the MW band, and was pleased with the reception, but rather peeved at the paucity of IDs. I found myself leaving the receiver and MP3 recorder on the balcony while going to dinner, shows, etc, in hopes of snagging an ID. I'm still having to review the recordings to see whether I was successful or not in this regard.

Regarding the three MW Bahamian transmitters, 810 ZNS3 was by far the easiest to hear, and was usually heard day or night wherever we were on the cruise. It ID'd as "810, the Service in the North" heard at 04:50 on Dec 24th. ZNS1 on 1540 was next easiest to hear with the following ID at 0259 on Dec 25th: "Covering the entire Bahamas, this is ZNS, Nassau". The final outlet, ZNS2 on 1240 was the most difficult to hear, except when in Nassau. This is a religous outlet, IDing as "Inspiration 1240", and "Excellence in Christian Broadcasting". I was not able to monitor this one very well outside of Nassau. I believe that all 3 of these stations are government owned and operated. I also heard many FM (mostly private) Bahamian stations.

As we sailed south the first 36 hours, I attempted to monitor AFN from Guantanamo. A few years ago, I recall picking them up quite well in the middle of the night as our Holland American ship sailed westward to the south of Cuba on our way to Jamaica. This time, the best I could hope for was sailing to the north of the waters separating Cuba and Haiti. Neither AM 1340, nor FM 102.1 or 103.1 yielded anything definite this time. Interestingly, as we sailed by Haiti, I did pick up an English language FM station from Port au Prince called Signal FM on 90.5. I wasn't expecting to hear any English, of course.

I then aimed my sites on the US Virgin Islands and Puerto Rico on the X-Band, 1660 from San Juan IDs only in Spanish as "Gigante 16-60". The legal call is WGIT, and the IDs were usually heard a couple of minutes after the top of the hour. WDHP on 1620 was guite a powerhouse in the Caribbean. They never ID'd at the top of the hour, but usually after cutting away from network news at 6 minutes past the hour, with a local ID, but not always. The news feed was always USA network news. The IDs were usually full legal IDs "1620 WDHP St. Croix, US Virgin Islands", but at least once instead I heard only "non stop jamming on your hometown radio station". I didn't bother with any other Puerto Rican stations, and instead concentrated on the US Virgin Islands which were all heard, 970 WSTX ID'd frequently, as did WSTA 1340 (one of the reasons that the tiny AFN Guantanamo transmitter was not heard, I think), WVWI 1000 was well heard but didn't seem to ID much (It was one of the stations I left my recorder running in hopes of an ID). I did hear ID's as "Radio 1 AM 1000". CBS news on the hour. 1090 WGOD was obviously also religious and well heard only in the immediate vicinity of the Virgin Islands. They were in parallel to a much stronger FM transmitter on 97.9 (50 kw vs 250 watts), and would ID as "98 FM, 1090 AM WGOD". 1290 WRRA rarely ID'd, and ran southern Baptist style religious programming. Christmas carols continued as well even 4 days after the 25th. There were times of open carriers up to 2 minutes, but no IDs. Gonna have to listen to the MP3 to find an ID there.

The British Virgin Islands, I believe, only have a single MW transmitter on 780, ZBVI. They were widely heard with totally local programming and Christmas greetings and mostly mentions of the "BVI". Ads for "Cable and Wireless", the "BVI Social Security Branch" and the like. The closest thing to a real ID is usually at the bottom of the hour when they present the "weather for ZBVI".

As we sailed towards the Virgin Islands, I also checked the various split frequencies and heard all of them to a greater or lesser degree. 895 from St Kitts, Nevis, and Anguilla was heard with a local ID at 00:30 on Dec 27th with "895, 10000 watts, The Voice of Nevis, covering the whole Caribbean". Well not quite, as they were quite weak at that point, but did improve later in the evening with local holiday greetings, carols, and Auld Lang Sye at 01:57, but no ID at the top of the hour (seeing a pattern yet?).

555 ZIZ Radio St. Kitts had rather weak voice modulation compared to music, and somewhat muddy audio. Despite listening for over an hour, not a single ID was heard. Mostly stronger than 895, and very good by 00:55 on the 27th. They would mention St. Kitts and Nevis, though. Splatter from 550 was a problem. Despite my 2005 WRTH saying they signed off at 02:00, they were still going strong after 03:05 on the 27th.

535 Grenada GBN ID's as Klassic (or Classic) Radio and was heard with the "Twelve Days of Christmas" at 01:43 on the 27th at mostly fair, but occasionally good levels.

As we sailed north to the Bahamas on our return leg, I switched over to check for Bermuda (our cabin was on the starboard side of the ship, and faced north on the cruise northward). I was able to hear the BBCWS co-channel and weakly on 1160, and possibly 1280 with "FRN news" at 03:03 on the 29th. No luck on ZFB 1230, ZBM 1340, or 1450 AM Gold.

So, as you can see, I didn't do a whole lot of DXing (too much happening on the ship and on shore for that), but still some fun in listening to something virtually impossible to monitor back home in Victoria. If you care to see the ship, here's a link:

Haquoli Makahili Hou from the east side of the big Island. To reintroduce myself, I am a native of Dundee, Scotland, U.S. citizen since 1984, and became a DXer in Newcastle upon Tyne. England in 1957, always primarily a MW DXer with SW second and occasional FM and TV third. I am a retired professor of European Languages and general linguistics and have also worked as an interpreter and teacher of ESL, mainly in Šaudi Arabia (where I also DXed). For years, I commuted from East HI, a good DX location, over to Kailua-Kona, West HI, a poor DX location, where I operated Richard's Fruitstand in the Aewist capital, Kailua-Kona. I have now closed the physical stand and my main income is now from mail order sales of 100% pure Kona coffee, the world's best: www.richardsfruitstand.com (operated by a webmaster. I have no computer). After about four years' inactivity, I am now fairly active again, using the same FRG-100 as before, and a SW-NE shortwave here in the middle of Hawaiian Paradise Park, a subdivision 9 miles north of Hilo, where that fine DXer, Chuck Boehnke, also lived. The enormous real estate boom has brought big new houses on every side of me, and some of my longwires were cut by bulldozers. Man-made noise is also up. But my impression is that plenty of DX is still available, though I haven't heard Europe or Africa for the last year or two (but I didn't try hard then). Two stations which acted as beacons for conditions on the x-band seem to be absent now and I haven't seen lots of them in recent DXM's: the U. of Baia on 1630 and Winter Haven, FL on 1680. Are they off the air? But one addition with a powerhouse signal from BCN is XEPE-R. Cash-1700, with its many San Diego ads. Does anvone know what power it runs and whether it is directional nites? If it beams west from Tecate to San Diego, it would extend this way and explain its powerhouse signal, the loudest XE here. (Richard, the FCC website shows it as 1000 watts, non-directional day and night--rce) My most wanted North American stations are KBRT-CA-740, which is, I believe, my closest unheard active station. KRML-CA-1410, my closest unheard non-GYer, and KBRW-680. My most wanted graveyarders is KIFW-1230. They Grayland results are fascinating. Looking at Chuck Hutton's list on page 11 of DXM 43-14 (Dec. 17, 2005) of the AK stns which the combined Grayland team missed, have been heard, in the past, all of them here. This is based on memory alone, as many of my past logs are lost. But I well remember that I heard 910 on the morning it first came on the air, and the QSL conformed this fact. If 1230 is the only GYer in AK, a clean sweep of all AK stns should be possible here in east HI, though not at my current crowded, noisy mid-subdivision location. I am working on finding a less crowded place where beverages are possible. As I want to live there, not just do DXpeditions there, it takes money for real estate! It was good to note the last Bappahayden DXpedition heard West Coasters like KOMO-1000. I had noticed the absence of West Coasters on previous NFLD. Logs. Now on to the Pacific, the only global region not so far reported from Bappahayden! I have heard CBA-NB-1070 here, so it should be possible. It's not that far from arctic Sweden and Finland where numerous Hawaiians like KKON-790 and KHBX-1060 produce powerhouse signals. Recent DXpedition to Sheigra in NW Scotland produced KFI-CA-640 and other West Coasters, but HI hasn't been heard in the UK or Europe south of Scandinavia since 1945. (That's what it looks like--rce) Any tips on DX I should look for are welcome, now that I'm getting active again. Aloha and 73.

It's interesting what some of the memories are that get stirred by Forum reports. When we were looking for a place to live here in Indy, back in 1999, I had noticed line noise on the car radio perhaps four or five blocks from here on the main road along the east side of the subdivision. In here, though, the lines are buried and I don't notice the line noise. One thing Frank Merrill and I were commenting about when he was here in May was that my radio doesn't really react much to the computer being on, even though it is only about five or six feet from the CRT screen. The only frequencies it produces a buzz on are 580, 870, 920 and 970. It might once in a while on another but very seldom. Still hearing new stations. Seven new ones since the column last week. Details have gone out to Lee and EDXR. Best ones were probably WOYK-1370 PA with ESPN and the Rose Bowl and WWLS-640 OK with spots and ID during SSS. Seem awfully late for a football game as the Rose Bowl game was over around 0100 EST, but then I remembered it was played in California and the time difference is three hours. I'm told I will be working a lot more evenings at the tax office this year. So much for a lot of SSS these four months but then, looking back at last year, I didn't do much then and I was mostly days back then. I am listening to 1680 right now but it is mostly Radio Disney, with a SS looping east/west. Personally, I would rather it be the station out in Seattle, hi.
