WNAR 1620 KHZ Lansdale, PA is still conducting a DAILY DX TEST at 0300 ELT. The test consists of code ID's between 0300 and 0305 and will continue until further notice. Reception reports with RETURN POSTAGE can be sent to **David McCrork**, WNAR-AM, Box 18, Tylersport PA 18971-0018. WNAR operates with a power of 100 MILLIWATTS! (The station was heard almost 5 miles from Lansdale on a recent trip to the area so it does get out very well).

KXTO 1550khz Reno, NV DX Test. Date(s): January 22, 2006-March 2006. Time: 01:00 PST (0900 UTC) & 04:00 PST (1200 UTC). \*\* Program format varies. Test will run as close to TOH as possible. :60 Second long tests in duration. "Inventory Insert" format. Modes of Operation: Normal-"Inventory Insert." 94 Watts. Non-Directional, Programming: Morse Code ID's, Sweep Tones, Voice ID.

Notes: Test will continue for an undetermined amount of time, possibly several weeks so hopefully many DX'ers will find favorable propagation at least one or two nights prior to the end of the test. The station has also stated that they will be doing transmitter maintenance at some point within the next two months, and may be able to accommodate a full power (2.5KW) test at that time. More details as they become available. Nevada is a rare state for many of us in the East, so enjoy this rare chance!

KEVT results. With apologies for the delay, here are the results for the KEVT 1030khz test. This test was conducted on February 6th starting at Midnight and running for a few hours. The test was conducted at full day power of 10kw during a scheduled maintenance period by Chief Engineer Frank Luna.

Unfortunately, the test produced poor results...being heard by only two DX'ers in nearby states. The reasons for this lack of success can be attributed to at several factors:

- 1. The station operated in Spanish language mode, with no Morse Code, sweep tones, or other unusual programming to make it stand out.
- 2. 1030khz is populated by other powerful Spanish language stations including XESDD BCN Ensenada, which was widely heard during the test period.
- 3. Monster signal from WBZ in the East making things for folks on this side of the Mississippi to hear anything else.

Our sincere thanks go out to Frank Luna for conducting the test, and Paul Lotsof for arranging it. Perhaps we can convince Frank to try it again next year with some sweep tones and Morse Code!

Among the fortunate few who logged the test was Martin Flotz of Mission Viejo, CA. He was joined by Kevin Randolph in Gilbert, AZ who notes that the station is a "semi-local" to him.

Leading the large pack of Sad Sack's who didn't manage to hear the test despite their best efforts was Tom Jasinski of Shorewood, IL who struggled with a "oddball" signal in the null of WBZ. It turned out to Polish station WNVR. Art Peterson of Richmond, CA fought with "La Tremenda" in Baja, California but couldn't pull

Willis Monk, K4APE in Old Fort, TN heard a lot of Spanish on the frequency, but could never make out enough for an ID. Les Rayburn, N1LF in Birmingham, AL also had two SS stations on frequency during the test, but never managed to ID either.

Mike Hardester managed to null WBZ with his Quantum Phaser, but never pulled out KEVT from his home in Jackonsville, NC. A Drake R8B and a Kiwa Loop proved no match for the mix of stations heard by Doug Pifer, KE6GMM of Albany, OR. He logged an assortment of stations including XESDD, KDUN, KMÁS, and KTWO but no sign of our test station.

Pete Taylor in Tacoma, WA gave it the old college try with his Sony 2010 and a Kiwa loop as well, but with the same results. Another disappointed DX'er was Don Kaskey of San Francisco, who could only manage lots of QRM from XESDD.

Mike Stonebridge made sure that Canadian DX'ers were also broken hearted. He managed to null KTWO from his shack in Alberta, but that left only KMAS underneath. Other's who went home unhappy included Jim Renfrew of Byron, NY, J.D. Stephens of Hampton Cove, AL, and Eric Berger of Detroit.

Again, our sincere thanks to Frank Luna and the staff of KEVT! Even when we don't log them, they are still lots of fun!

WDAB results. The February 27th test of WDAB in Traveler's Rest, SC may have been the most successful test in several seasons. Widely heard across the US and even into Europe, this test was one for the books. Our special thanks go to Paul Walker who arranged for the test, and also to Glenn Hauser who sent out reminder e-mails to most of the lists just prior to the test. And of course thanks to Bill and the staff at WDAB!

First to report hearing the test was Scott Fybush of Rochester, NY who caught both voice and Morse Code ID's right away, this was quickly followed by reports from Paul Walker who logged the test from his home in Decatur, Alabama,

Mike B. in Enfield, CT put a new one in his log. Also successful was Jim Pogue of Memphis, Bob Foxworth of Tampa, FL, and Les Rayburn near Birmingham.

Using only a YB400 and a Select-A-Tenna, Rick Tuner of Bemidji, MN managed to pull in the Morse Code ID's. While a box loop and a Drake R8B allowed Shawn Axelrod to put another station in his log all the way from Winnipeg, MB in Canada.

The West Coast wasn't left out of the party either...Patrick Martin heard the signal clearly from his spot in Seaside, OR. Mike Hardester used his Icom R-70 and a random wire to log them in nearby Jacksonville, NC, and Fred Nordquist added South Carolina to the list of states hearing the test.

A mere "table top" radio with no external antenna was tool enough for Clark Ingram of Pittsburgh, PA to hear this test. Keith McGinnis pulled the test in from Hingham, MA, and Joe Veldhuis added Michigan to the totals. David Larrabee used his Ten Tec 340 with a DX Engineering active whip to log both voice and code ID's from his home in Columbia, MD.

Craig Barnes of Wondervu, CO didn't manage the voice ID's but did hear both Morse Code and sweep tones. Dan Malloy of Everett, MA did a little better, pulling out both English and Spanish voice IDs using only an indoor wire, 20 feet long. Pete Jernakoff reported the test LOUD on his barefoot DX-398 in Wilmington, DE. Craig Healy in Providence, RI had no trouble either with his R8B, and indoor loop.

With a bit of overkill, Bill Swiger in West Virginia logged the test using a 1,000 foot N/S beverage antenna! Bill Bock of Prescott Valley, AZ heard sweep tones and code in his Western home, and Scott Levitt said the signal was "completely dominating" from his shack in Bath, PA.

Jerry Bond also logged the test in Rochester, NY, where WDAB may have put a dent in the local Arbitron logs! John Bolduc reported the test "strong" in Derry, NH. And Nigel Pimblett hung around long enough to finally pull out both Code, Tones, and Voice from his spot in Dunmore, Alberta, Canada.

Chris Carter successfully ID'ed the test, but unfortunately, we have no idea where from! Please be sure to include your full name and location when you're reporting a test... nice catch Chris! Mike Prindle was another DX'er who logged the test, but didn't say from where...got the MP3 Mike.

Steve Ratzlaff logged the test from Elgin, OR using his AR-7030 (nice rig!) and reported WDAB fighting it out with KBLA. While RC Watts needed only a plain vanilla CC radio to pull it in from his home near Louisville, KY. Saul Chernos of Toronto, Ontario heard the test easily, and also successful was Patrick Griffith of Westminster, CO.

Gerry Bishop heard the sweep tones clearly from his home in Niceville, FL, right on the Alabama line. Frank Aden of Boise, ID heard tones at his shack, and Curt Deegan reported the test "loud and clear" from Boca Raton, FL.

Brett Saylor in Central PA used a Drake R8 with a 100 foot sloper to snag the test, while Murray Carl Mann used an R8A and a Quantum Loop to pull it in from his home in Omaha, NB.

Greg Myers of St. Petersburg, FL noted that it had been a long time since hearing WDAB from his location. Dave Pyatt was happy to add the station to his log in Burlington, Ontario, Canada, as was Tom Laskowski of South Bend, IN.

Vermont got into the party when Steve Howe used his Sony 2010 to pull in Code, Sweep Tones, and voice ID's. Doug Smith logged the test on his car radio from Nashville, and Christos Rigas pulled magic from the ether near Wood Dale, Illinois.

Wayne Heinen added SC#2 to his log in Aurora, CO despite some QRM from XERF on the adjacent channel and KQRL in Waco. Also hearing the test was Lee Freshwater of Ocala, FL, and Thomas Connatser

Shaun Curry was another Rhode Island DX'er who heard the test, and James Beer added Wisconsin to the list of states who received it. Bert New used only a Sangean ATS 909 to log the test from his shack in Watkinsville, GA, A. MacKay heard the test using similar equipment from Atwood, Ontario in Canada.

Using an R8 and Quantum Phaser, Bruce Winkleman of Tulsa used this test to put South Carolina station #1 into his log...we all know what a great feeling that is! John Sgrulletta heard the test from his home in NY and had nothing but praise for Paul Walker for arranging the test.

Another happy camper was Joseph Miller of Troy, MI as was Tom Jasinski of Shorewood, IL. California

DX'ers also got into the act, including Art Peterson of Richmond, CA and Curtis McMenanmin of Vacaville, CA. Art reported a long duel with nearby KMIK but the code and sweep tones managed to make it through.

I talked on my cell phone with Curtis McMenanmin while we both listened to the station... couldn't make out much from his end except for the sweep tones which really came through even on the cell!

George Sherman of Michigan pulled in the test, noting the song "Baby Come Back" that was played during the maintenance period. Glenn Hauser proved that no good deed goes unrewarded... he reminded many of the test and found his own treasure when he pulled the test in using his FRG-7 from Enid, OK. Thanks again

John Wilkins of Wheat Ridge, Colorado noted that the WDAB test was only his second logging from a SC station in over 25 years! Congratulations John! Jim Chenard of Blairstown, NJ noted that this had been on his 1580 "wish list" for quite a while too.

Rounding out our list was Phillip Chiello used a Sony 2010 to nab the test from Elm Grove, WI. We have reports that the test was heard into Europe, but as of this report, I'm still awaiting details.

Despite the awesome signal and conditions throughout the US, there were some folks who went to bed disappointed. Among these was Kevin R. in Gilbert, AZ who couldn't hear anything over nearby KMIK. Most

remarkable was that this was the only report we received of a DX who attempted the test without success.

Totals for the test were amazing. The test was heard by dozens of DX'ers in 23 states and three districts of Canada! Receptions ranged literally from Coast to Coast, with voice ID's being reported at distances that I've never seen before. We may all long remember the conditions near sunspot minimum in the winter of 2006 and this test only adds to the legend of this incredible season. Congrats again to all who heard the test and to those who helped to arrange it.

QSL cards on on their way, but please be patient. I've got a large stack of CD's, cassettes, etc to wade through.

Art Blair sends along the following: Sonics end 21-year partnership with KJR AM

Radio broadcasts for the Sonics will move from KJR (950 AM) to KTTH (770 AM) next season, the NBA team announced Tuesday. The Sonics signed a multi-year agreement with Entercom Radio Group, a corporation that also owns KIRO (710 AM). The announcement ends a 21-year-old partnership between the Sonics and KJR. "It was a difficult decision to change stations," Sonics president and CEO Wally Walker in a news release. "The Sonics are proud to have been a part of KJR's emergence as one of the country's premier radio stations. We're looking forward to 770 AM KTTH as our new home of Sonics Basketball. KTTH and its six sister stations align the Sonics with our ticket buyers and listening-audience demographics. This partnership offers us a more broadly based marketing platform for our broadcasts and greater opportunities for promotions." The new partnership between the Sonics and Entercom Seattle will mark the end of the team's longstanding simulcast arrangement and will create two separate broadcasts. Sonics play-by-play announcer Kevin Calabro, with the Sonics for 19 years, will continue to handle the television play-by-play duties with Sonics partner FSN Northwest. The Sonics organization will add broadcasters to handle the radio responsibilities. Calabro will remain the primary play-by-play broadcast talent for radio-only regular-season games and Sonics playoff games. The agreement includes Sonics pregame and postgame shows accompanying KTTH's radio broadcasts, as well as a weekly head coach's show, (AB-CA)

If you have not noticed yet, but it is official. WTOP is now on 820 (ex-WXTR) and WTWP is now on 1500 (ex-WTOP). (PM-OR)

Pat Martin sends along the following from Deane McIntyre of Calgary, AB:

An application has been submitted to the CRTC for a new AM station in Calgary AB, using 700 kHz (the old CKRD Red Deer AB frequency) at powers of 50 kW Day/20 kW night: http://www.crtc.gc.ca/archive/ENG/Hearings/2005/n2005-11.htm#n1

Calgary, Alberta, Application No. 2005-0885-6

Application by Touch Canada Broadcasting Inc. for a licence to operate an English-language AM commercial (religious) radio programming undertaking in Calgary. The new station would operate on frequency 700 kHz with a transmitter power of 50,000 watts day-time and 20,000 watts night-time. The applicant proposes to offer an English-language Gospel music service. The Commission will only proceed with this application at the public hearing if advised by the Department of Industry, at least twenty days prior to the hearing, that it is technically acceptable. I have placed the map showing daytime contours on my website: http://deane.bio.ucalgary.ca/Calgary700.pdf. As you can see there are sharp nulls to the east and southeast. It seems that the nighttime contour map was not included in the application. Of course they would have to protect WLW. The transmitter location is a few miles south of the village of Black Diamond (named after the former coal mines in the area). This would be the first new AM in southern Alberta since CFFR-660 Calgary went on the air in January 1984. Of course many have moved to FM since then, the most recent being CHAT-1270 Medicine Hat which moved a few days ago. (The 1270 transmitter is still operating in parallel for the time being however) (PM-OR)

Pat Martin sends along the following from Nigel Pimblett of Dunmore, AB.: CHAT's official switch to FM (94.5 MHz) will happen on Monday, January 9th at 8:00 am local time. It's nice to see they appreciate some of the history, as they'll be having voices from the past that morning in the countdown to the change, with the final voice fittingly being that of Orv Kope, CHAT's first announcer, from 59 years ago. In a way it's a bit sad, being the end of the AM radio era in this part of Alberta, but it'll certainly help my DXing, as 1270 has become a very messy signal over the last year. Of course 1270 will continue to be on the air for up to 3 months after Monday, but will be simulcasting the new FM. (PM-OR)

MYSTERIOUS INTERFERENCE IN THE SAN DIEGO AM BAND

On Wednesday night, January 11, 2006, unidentified wideband interference blanketed the AM broadcast band in San Diego "with peaks all over the dial" according to one report. The interference was heard from 150 kHz to over 5 MHz and obliterated weak out-of-town AM broadcast signals. KNX was said to be 90% covered by static and noise. These observations were made along Highway 52. A second report (this from an experienced broadcast engineer) noted RFI "from 540 kHz through 5 MHz [that] came on after 6 PM, 1/11, Wed evening. In the morning the hash was gone and [the] band was back to normal Thursday night.... The RFI could NOT be nulled out and was as strong OUTSIDE as inside a house. This is using battery portables with circuit breakers on the house pulled. Also noticed on several radios and driving in [a] car. Pretty widespread. So strong a slight hash was heard under KOGO." We could be dealing with military interference,

spurs from a powerful broadcast transmitter or some peculiar kind of in-power-line device or devices. The FCC has been notified. (PM-OR)

WORLDWIDE OUTPOURING OF SUPPORT FOR RADIO LEGEND Ramona Bell dead at 47 ART BELL IS IN SECLUSION, ASKS FOR PRIVACY AND NO FLOWERS, By GINA B. GOOD, Pahrump Valley Times

Ramona Bell, 47, wife of Pahrump's most renowned resident, Art Bell, died unexpectedly Thursday after an asthma attack. Over the years the internationally known radio talk show host of Coast to Coast AM has reduced his duties on the show to Sunday nights and hosting specials, such as his annual Halloween and New Year prediction shows. However, Bell remains the gold standard by which other hosts are measured. His wife of 15 years occasionally appeared on the show, which is broadcast between 10 p.m. and 2 a.m. from the couple's Pahrump home. More than 400 radio stations broadcast the program. Although extremely outgoing on air. Bell is one of the town's most reclusive citizens and he requested through a spokesman that no obituary be published or flowers sent. Ramona's funeral will be held in Pahrump in a private service. It was announced on Coast to Coast AM, the popular overnight radio show Bell created, that he has been deeply touched by the outpouring of sympathy and love shown by listeners. He has already received thousands of cards and e-mail messages. The Pahrump Valley Times received in excess of 400 e-mails from listeners around the world who also offered condolences. Several phone calls were made to newspaper employees on Tuesday reporting Art Bell had been found dead that morning. Fortunately, those reports proved false. Coast to Coast AM is hosted during the week by George Noory, who took the helm when Bell semi-retired. The show can be heard locally on KNYE radio, 91.5 FM from 10 p.m. to 2 a.m. It is replayed in its entirety from 2-6 a.m. and is very popular with long-haul truckers, graveyard shift workers and insomniacs. Bell created the show's free-ranging format, which welcomes interviews with rocket scientists to ghost busters. On Sunday, the show repeated one of Bell's interviews from Nov. 17, 1997 in place of his usual live show. KNYE, whose slogan is "Where things go Pahrump in the night," has been in operation for the past three years. Establishing their own radio station in Pahrump had been a longtime dream of both Art and Ramona's that they accomplished through years of perseverance. According to information on the Coast to Coast AM Web site, the exact cause of Ramona's death has not been determined. She apparently died in her sleep. Until her death. Art and Ramona Bell had not been apart a day since they were married. She had suffered from asthma for years and took her normal steps to control the attacks, but one might have occurred in Laughlin where the Bells were taking a brief vacation - that led to her demise. Bell has announced his retirement from the show several times, including in October 1998 when he said he needed to leave because of a "terrible event" affecting his family. Bell did not return e-mail correspondences or a phone call made to the KNYE office. Katz's Fall Format Report Card, Feb. 09, 2006, Billboard Radio Monitor, By Katy Bachman, Mediaweek SOURCE: Mediaweek

A new study of radio formats from Katz Media Group found a shifting radio programming landscape. In the past year, classic hits and Spanish-language radio have gained stations and audience share, while modern rock has declined. The Katz study was based on Fall Arbitron ratings for 4.428 radio stations in 294 markets. Despite certain format shifts, country remained the most programmed radio format with 544 stations, up from 539 a year ago. The average country audience share was also up to 14.2 from 13.9. The number of stations programming classic hits, Jack FM, or other "play anything" formats nearly doubled from last year to 155 stations from 89. The average listening share also increased from 4.4 to 4.6. Conversely, the number of oldies stations declined from 256 to 216. Spanish-language radio continued to grow with 351 radio stations programming Hispanic formats, up from 314 a year ago. The average listening share also increased, up to 8.9 from 8.5. Other formats showing gains in stations or audience share are: adult R&B, rhythmic adult contemporary, and rhythmic top 40. News/talk and talk stations showed little change. (DP-HI)

After attracting world-wide attention, Clear Channel talk KFI Los Angeles morning man Bill Handel and Clear Channel have apologized to Muslims for comments Handel made on his Jan. 12 show. The Southern California office of the Council on American-Islamic Relations (CAIR) announced that Handel and the station have apologized for mocking the deaths of Muslims on Hajj, or pilgrimage to Mecca. Handel has also been reprimanded in writing by the station for his "insensitive remarks." As previously reported, CAIR had demanded that Handel apologize and be disciplined. At issue is a parody that Handel did on the same day of the stampede in which 350 people were killed. Handel imitated people screaming and then joked that the Muslims at the pilgrimage should use a helicopter to monitor pilgrimage traffic. "KFI AM 640 does not condone making light of the deaths of people engaged in religious observances," regional VP Greg Ashlock wrote in a letter to CAIR. "On this particular program, we crossed the line in reporting the Hajj incident in an insensitive manner. We have discussed the content and timing of this 'bit' extensively with Mr. Bill Handel and his crew and are confident that everyone now understands the gravity of the situation. Mr. Handel expresses his sincere apology for the insensitive remarks." Handel also apologized on his show, saying while he regularly lampoons many different nationalities and religions, he realized that the parody was poorly timed. "The wound was very fresh for a lot of Muslims and the comments were out of line and for that I am sorry," he said. Handel had previously announced that he would only apologize if CAIR, which he says has ties to terrorist organizations, would denounce all terrorist attacks, recognize Israel as a sovereign nation and

declare that it had no ties of any sort, financially or otherwise, to any terror organizations or individuals. (DP-HI)

Spanish-language radio station interfering with calls, By The Associated Press Sunday, January 29, 2006 CHEYENNE, Wyo. (AP) -- Two Spanish-language radio stations have been interfering with phone lines at homes and businesses, and the cause of the problem is a mystery. Sheri Anderson, with Schroll Cabinets, said employees in her fabrication shop haven't been able to pick up a phone without hearing the station. The signal is so loud, she said, the phones aren't useable. The sources of the interference are KIJL and KKWY, which were bought by La Familia Broadcasting in April. Company owner William Neidig said the company has been unable to trace the problem back to its equipment. "We have heard from everybody that it's the wiring in the houses," he said. "This is one of those freaks of nature that's not controlled by us or the telephone company." He said people can buy a filter to keep the noise off their phone lines. "That seems to have eliminated the problem," he said. Mike Ceballos, Qwest president for Wyoming, said Qwest has received a number of calls about the problem over the past several months. Talk radio takes lean to the left, Area gets liberal voice

Right-wing loudmouths Michael Savage and Rush Limbaugh now have political counterparts on local airwaves. The Charlottesville Radio Group, the very firm that airs a fair number of conservative talkers on WINA, including Savage and Sean Hannity, has launched WVAX 1450, progressive talk radio featuring liberal vakkers such as Al Franken and Lionel. The Charlottesville Radio Group is owned by Saga Communications, a Michigan-based firm with radio holdings throughout the country. In addition to WINA and the new WVAX, the station owns Lite Rock Z95 and the rock station 97.5 WWWV. Charlottesville Radio Group's vice president and general manager, Dennis Mockler, said the company is simply tapping into a market that's not being served. "There's a lot of media companies out there in a variety of different forms, but really no local station targeted to the people with a liberal slant," Mockler said. "We saw a huge void." Although music-driven programming dominates the area's commercial radio ratings, WINA and Clear Channel-owned WCHV are the top-rated local news and talk stations. In addition to local programming, both stations feature a steady diet of syndicated conservative talk, with WCHV home to the likes of Rush Limbaugh and Laura Ingraham. While liberal talk has struggled to gain traction in most markets, Charlottesville's reliably left leaning citizenry may prove more welcoming. Local Democratic activist George Loper, for one, plans to listen. "It's been a long time coming. People for years have been asking for progressive programming," said Loper. "We'll see if it creates the kind of audience they need to carry it, but I'm looking forward to it and I think other progressive Democrats are as well." Beyond Franken, the station's daily lineup includes Randie Rhodes and Ed Schultz. An hour of Schultz's program has been airing on WINA; the full three hours will air on the new station. Weekend fare offers more issue-oriented programming such as Mother Jones Radio and Ecotalk. In addition to syndicated shows, Charlottesville Radio Group reporters will provide local news. Although still in its infancy, the station has found interest among advertisers, according to Mockler. The station, which has been on the air since Thursday, was initially operating on a half-strength construction permit, although the signal is now up to its full 1000-watt strength. Officials at KFGO-AM said Wednesday that Schultz would be replaced by the "Jack and Sandy Show," named for hosts Sandy Buttweiler and Jack Sunday. The show will take Schultz's slot from 2 to 5 p.m. on weekdays. Schultz had no comment. Schultz's producers said he is syndicated on nearly 100 stations, and recently was added to the American Forces Radio lineup. He will continue to broadcast from the KFGO studios, station officials said. Buttweiler and Sunday were fired by KFGO in December 2004, after 12 years with the station. They were then hired by WDAY-AM in Fargo. In June, Schultz announced that Randy Michaels, former CEO of Clear Channel Radio, and Stuart Krane, former vice president of ABC, bought the program from Democracy Radio. (DP-HI)

Changes coming to Aberdeen radio dial. More local shows, ESPN added; less political gabbers. By Jeff Bahr American News Writer The boosting of ESPN Radio to 24 hours a day, the loss of Rush Limbaugh and the addition of more local programming are part of a flurry of local radio changes that will take effect

Wednesday. One of the changes will result in KSDN-AM 930 being "local and live" from 6 a.m. to midnight seven days a week, said Brian Lundquist, general manager of the Aberdeen Radio Ranch. KSDN-AM will be the kind of full-service local station that Aberdeen hasn't had in some time. Lundquist said. Further down the AM dial, Rush Limbaugh and Ed Schultz will give way to ESPN Radio on KGIM-AM 1420. ESPN Radio will be heard around the clock on KGIM-AM. ESPN afternoon, nighttime and weekend programming is now heard on KSDN-AM. After Wednesday, the Limbaugh and Schultz talk shows will no longer be carried in Aberdeen. Limbaugh currently airs from 11 a.m. to 2 p.m. and Schultz, based in Fargo, N.D., from 2 to 5 p.m. "Bob & Sheri," currently heard each morning on KGIM-AM, will return to KBFO-FM 106.7, known as The Point. It'll be heard from 5 to 9 a.m. Monday through Friday. The Point will have local programming from 9 a.m. until about 7 p.m., Lundquist said. Scott Solberg and Lundquist will be on the air on KSDN-FM 94.1 weekdays from 6 to 9 a.m. Les Cummings, who is currently in that shift, will be heard on KSDN-FM from 9 a.m. to noon and in the afternoons on KSDN-AM. Fans of Limbaugh and Schultz can easily listen to their shows on other stations in the region, Lundquist said. What does the Radio Ranch's decision to drop them say about the shows' popularity here? Lundquist said "they're very well listened to but from a financial standpoint, it's a harder sell." In the meantime, ESPN shows hosted by Dan Patrick and Erik Kuselias, now heard on KSDN-AM, are popular, and many have asked to hear "Mike and Mike in the Morning," another ESPN show. That program will now we heard on KGIM-AM. Also, more news and other local programming, including music and talk shows, will be broadcast on KSDN-AM. "Agritalk," now on KGIM-AM, will move to KSDN-AM but remain at 10 a.m. No jobs will be lost as a result of the changes, Lundquist said. The station has recently added some part-time employees, he said. Among the personalities who'll be heard each day on KSDN-AM, in addition to Cummings, are Denny Pitman, Doc Sebastian, Mike Johnson, Curt Campbell and Scott Allan, whose real name is Scott Sundberg. "Coast to Coast," a show dealing with the paranormal, will occupy the overnight hours on KSDN-AM, moving from KGIM-AM. (DP-HI)

From Reuters: Latin radio formats keep flipping for oldies, Fri Jan 20, 2006 9:06 PM ET By Leila Cobo

MÍAMI (Billboard) - As Spanish-language radio continues to grow and diversify, the hottest trend for the new year is one hooked on the past. Oldies stations are making a strong comeback in Latin radio, fueled by the growth of such formats as Jose (Entravision's Latin version of Jack radio, a popular DJ-less format), Univision's Recuerdo and Clear Channel's La Preciosa. In the past three months, more than a dozen Nielsen BDS-monitored radio stations switched to Latin oldies formats. The growth of different formats "is really about the maturing of Spanish-language radio in the United States," Entravision president Jeffrey Liberman says. "If you go back 30 years, there was only one station and one format" per city, he adds. With time, stations multiplied and formats segmented. In 2005, there was an explosion of Latin rhythmic formats that did not exist before. Now oldies are surging. On January 16, Univision Radio switched KCOR San Antonio to the Recuerdo format. The station had been underperforming as reggaeton/hip-hop La Kalle, a format it switched to only last year. The week before, on January 9, Univision switched another station, KLNO Dallas, from regional Mexican to Recuerdo.

**CROSS-GENERATION APPEAL** 

The Univision flips follow the successful expansion of Clear Channel's La Preciosa format, which plays hits from the '70s, '80s and '90s. Since its launch in 2003, the format has grown enough that this week Clear Channel officially announced the La Preciosa network, with plans to add to its 13 stations and to broadcast the format through other radio companies. "The popularity comes from the fact that these radio stations play a real broad catalog of music, so they aren't as repetitive," says Alfredo Alonso, Clear Channel senior VP of Hispanic radio. Popularity also hinges on the Latin demographic's eternal love affair with romantic music and an attachment to multigenerational songs. While Univision has switched from other Latin formats to Recuerdo (which literally translates to "memory"), Clear Channel has moved mostly from English formats to La Preciosa in cities that already had other Latin formats in place. Also exploding is Jose, which plays music from the '70s to today's modern hits. Launched in October with five stations, Jose has grown to seven outlets.

POP TAKES A HIT

The loser in this flip flurry appears to be pop, at least for the moment. Several Latin pop stations have switched to rhythmic or reggaeton formats, and now to oldies. Out of 98 Spanish-language stations Nielsem BDS was monitoring 12 months ago, 39 were pop. Today, there are only 29 pop stations. In comparison, the number of regional Mexican stations has stayed stable at 51, compared with 52 last year, while tropical stations, already in decline, went from 15 to 12. The dropout of pop stations is troublesome for label executives. Already, pushing new pop acts in conservative U.S. Latin radio -- where many pop stations play mostly recurrent hits -- is a struggle. When a pop station flips, "we lose a captive audience," says Pietro Carlos, VP of promotion for EMI/Televisa. "I just have to look for different avenues of promotion." But Liberman calls the latest flips "just a cycle of competition," noting that two-thirds of the Hispanic population is under the age of 34 -- an unlikely base to sustain growth in oldies formats. "Pop and regional Mexican," Liberman says, "will have tremendous success going forward." Reuters/Billboard. (DP-HI)

KALL-AM to be sold to sports impresario, By Paul Beebee, The Salt Lake Tribune

Bowing to federal rules governing how many media outlets corporations can own in a market, Clear Channel Communications will sell KALL-AM radio in North Salt Lake to a company directed by sports impresario David Checketts. UT Radio Acquisition has agreed to pay \$4.1 million to buy KALL (700) from Clear Channel, pending Federal Communications Commission approval. Stuart Stanek, general manager of Clear Channel's group of seven Salt Lake-area stations, said Friday. The deal is expected to close in April. "Clear Channel is being forced to [sell KALL] because of FCC ownership limits. When Clear Channel, which owns [KTVX-TV] Channel 4, agreed to buy WB [KUWB-TV, Channel 30], it put us over the ownership limit cap," Stanek said. KALL's format is news, talk and sports. The sale will cut Clear Channel's local radio holdings from seven stations to six. Stanek said he didn't know why the eight-employee station was chosen to be sold. "That was a corporate decision," he said. Checketts is president and chief executive officer of UT Radio Acquisition. Checketts is also chairman of Sports Capital Partners, a sports, media and live entertainment company he founded in 2001. Through the business, he also owns the Real Salt Lake professional soccer team, UT Radio and Sports Capital executives, including Checketts, were unavailable for comment. Stanek said no major programming changes are likely at KALL. He said the station's night-time signal will be upgraded this summer to reach listeners as far south as Cedar City. The station's night-time coverage is limited to Wasatch Front communities from South Ogden to Provo. "Ít's a big change," Stanek said. During the day, KALL's signal blankets the state. pbeebe@sltrib.com (JJ-MT)

Additional note on above from Tim Hall of Chula Vista, CA: XETRA-690 is now running Spanish news (and talk?) from the "W Radio" network. One word of caution: "W Radio" is one of those networks that frequently mentions the call letters of various affiliates (last night they mentioned XECK-620 and XEDB-860, for example). Often, when a widely-heard station like XETRA picks up a network like this one, we get a lot of mis-IDs from DXers hearing the call letters of affiliates other than the one they are actually listening to. **AFGHANISTAN:** Both the 400 kW MW transmitters --- R. Afghanistan on 1107 and IBB on 1296 --- are strong enough to put a daytime ground wave signal into Islamabad. RA now also remains on 1107 during the evening, rather than switching to 1278 at 1400 as was once the case. 9325, 9345 and 9365 were checked regularly for the reported US psyops transmissions, but none were heard. (Chris Greenway, Pakistan, Feb BDXC-UK Communication via DX Listening Digest 6-028 (11/2-2006))

**KASHMIR:** Azad Kashmir Radio heard at various times on three frequencies --- 792, 936 and 4790. All three at times have separate programming. 4790 was heard as early as 0300 and closes after relaying 1700 Radio Pakistan news (but not on continuously between those times). 936 closes after relaying 1800 Radio Pakistan news. Listed 7265 not heard. V. of Jammu and Kashmir Freedom, 5102 heard closing as scheduled at 1430. Very strong signal, suggesting from Islamabad site, as indicated in WRTH 2006 page 527. Usual poor Pakistani modulation. (Chris Greenway, Islamabad, Pakistan, Feb BDXC-UK Communication via DX Listening Digest 6-028 (11/2-2006))

**NEW ZEALAND:** TRN [The Radio Network] is testing a new frequency, 1278kHz for a possible new service to the southern Taranaki region in the western North Island. The transmitter is located at Rotokare, near the small town of Eltham. Maximum permitted power is 6.3kW. The tests have been reported as a series of tone tests. TRN already operates NewstalkZB from Napier on 1278kHz in the Hawkes Bay region on the eastern North Island coast. The license is valid until November 1 2006. (David Ricquish 16 Feb)

## **EUROPE. AFRICA & MIDDLE EAST**

FAROE ISLANDS: The medium wave transmitter at Akraberg on 531 kHz has got a new transmitter tube and is now heard much better with their 100 kW signal (except during their news broadcast at 18.30-19.00 UT when the power is up at 200 kW). An Italian lady living in the Faroes, Anna Lachino, has a show in English every Tuesday night at 20-21 UT called Soul Nation. If you live too far away from the Faroe Islands try a DX Tuner receiver or their live stream at: http://www.portal.fo/?uf=play - click out left on UF LIVE (Media Pl.) (Erik Koie, Copenhagen(DXLD) via mwdx)

**GERMANY:** Antenne Saar (Saarbrücken, Germany) can still be heard on 1665 kHz. I found this in late December while in North-Germany and just checked again (0800 UTC) and it is still there. It is a spur and nobody really cares anymore. I wonder do they ever make measurements at their Tx site? (Jurgen Bartels, mwdx 14 Feb)

This year Evangeliums-Rundfunk is in its tenth year of broadcasting over the Mainflingen station on 1539. In 2005 a new antenna was built to reduce local interference to electric appliances and to enhance reception Europe-wide. Unfortunately for the Christian broadcaster, their programs are still broadcast via the old antenna. Because the WRTH 2006 does not mention it, it might be of interest for QSL-hunters, that there are foreign language programs on Mainflingen 1539. Currently, there is the following line up (UTC):

Kaj Ludwig writes: German public broadcaster WDR plans to start DRM tests on 1593 kHz in the summer. They will be run with 20 kW and are scheduled for a period of 18 months. The objective is to gather experience with the system in order to find out if it has a future. DRM receivers are expected (by WDR it seems, but the actual source of this statement remains unclear) to be available in summer of this year.

Two new Transradio (ex Telefunken) transmitters of 100 kW each are to be installed at WDR's Langenberg station where 1593 can be used again after IBB's Holzkirchen transmitter went to Kuwait. In the nineties WDR let IBB have 1593 after shutting down the 2x600 kW transmitters at Langenberg by the end of 1993 (due to PCB and asbestos in them) and got in exchange fulltime authorization for the ex-Holzkirchen channel 720 (previously available at Langenberg during daytime only). *IRELAND*: Irish Christian Broadcasters (ICB) announces on its website that it has turned off the 549 AM Transmitter in Monaghan that was heard across Ireland and much of the UK. The transmitter has been rebroadcasting UCB Europe for the past 5 1/2 years. ICB says plans are well advanced towards obtaining a national license. This week, it had a visit from officials of the Commission for Communications Regulation (ComReg) who instructed ICB to cease the mediumwave transmissions. (Media Network)

The Russian Federation and their Regulators - who allowed us to use their Frequencies of 549 AM and 846 AM - during the past 10 years for Christian Broadcasting to Britain and Ireland, and who have not objected to the transfer of these frequencies to Ireland, on ICB's initiative in 2002, for the purpose of Christian Broadcasting in Ireland UCB for providing us with a EU Regulated and Licensed Christian Service, which we could 're-transmit' in Ireland, while the prohibition on Christian Advertising exists and there continues to be an absence of licensed Christian Services available in Ireland. Of course

Russian regulators cannot assign frequencies to other countries and UCB always claimed that they did not authorize these relays. (Mike Barraclough via Paul David mwc 9 Feb)

NETHERLANDS: The public radio network currently known as 747AM will revert to its old name, Radio 5, and undergo a major change in profile. That's the most significant change in the radio strategy document published today by the Board of Management of Dutch public broadcasting. The changes to 747AM will account for around half of the 13 million euro per year savings that must be made across the public radio networks. The Board of Management describes the 'new style Radio 5' as a "colorful network in which outlooks on life, education and accessible music will be heard. It's hoped this will reach a bigger audience - the current 747AM rarely gets above 1 percent audience share - and make it more attractive to those aged 55 and over with a lower level of formal education. From the start of discussions over the new radio strategy, it was always clear that most of the savings would have to be made by 747AM, as spreading savings equally across all five networks would damage all of them. Two options were initially considered: setting up a "carousel of repeats" or make major savings on the existing 747AM programming. The management decided that neither of these options would deliver more listeners, so chose this third one. As far as the other networks are concerned, news and talk network Radio 1 will see hardly any changes. Radio 2 will undergo minor tweaks, and 3FM will continue its present schedule. Radio 4 will be re-profiled, and as well as a broad range of classical music it will also include jazz, world music, and programs on art, culture and science. The Board of Management is now asking the various public broadcasting organizations for their reactions to the radio strategy by 15 March. (R Netherland Media Network Weblog, via Steve Whitt. mwc 10 Feb)

**SOUTH AFRICA:** I have received the following reply from Sentech who operates the TX's (Talk Radio 702 is now operating on 540 KHZ temporarily)

"The 702 transmitter consists of 2 x 50kW plants that operate in active-parallel producing 100kW. One of these plants was destroyed by a fire that ignited inside the transmitter cabinets on 4 February, the cause of which is not apparent. The other plant is contaminated with carbon, soot and fire extinguishing powder and is not operational. The building is internally fire and smoke damaged. The 702 antenna is comprised of a 4-mast array in a quad configuration producing a directional beam aimed due south of the site at Garankuwa. The two front masts are energized and the 2 rear masts are passive reflectors. The 540kHz transmitter is 100kW and operates into a 2-mast directional antenna array (one mast is energized and the other is a reflector) located at Garankuwa and which is also aimed due south of its location. Curtain arrays are commonly used for SW purposes and monopole radiators used for MW broadcasting." (John Plimmer 15 Feb)

Receivers in use: Winradio G313i software defined receiver on a PC card, a modified Yaesu FRG-7 (general coverage plus LW through a converter) and a WWII surplus Bendix MN-26C (150 to 1600 khz). Antennas in use: R. West ferrite loop, a homemade 10-meter ground plane, and 300 feet of longwire strung around the periphery of my lot. At various times I tune LW beacons, 10-meter ham beacons, MW, SWBC, and utilities. I have verified all states (44 on MW), all provinces except the new territory of Nunavut (9 on MW), and 81 countries (56 on MW). Other interests include long distance bicycle touring, photography, and personal computers. I wrote the program "GCD" for MS-DOS (and DOS mode of Windows-98 and below) that computes great circle distances and bearings and includes a huge database of transmitter coordinates. GCD has been well received by users and is still available w/full registration for just \$20. I am really excited about the Winradio that I purchased in December; good sensitivity across its whole range of 9khz to 30mhz, and the IF bandwidth is continuously adjustable from 1hz to 15khz. Korea, China, Taiwan, Vietnam, Thailand, India, Saudi Arabia, United Arab Emirates, Russia and French Polynesia. Note the absence of any IDed countries south of the equator, except Tahiti. This is typical of winter conditions here; summer should add many Caribbean and South American countries, especially remembering that back in the 1980's, I heard every active country in S. America except Surinam and Guyana. But I expect that the next countries I will add will include more in the Middle East, notably Iran, Kuwait, Oman and perhaps Syria, but bets look like Djinouti and Egypt; from Asia I expect the Philippines (I have several tentative there), Pakistan (heard in the past), North Korea (a jammer already heard) and Indonesia; from Europe I heard 13 countries in the past and I have one tentative already (a familiar IS from Germany, but no spoken ID); typical propagation makes Norway and the UK likely.
