 Friday, August 29 - 31, 2008. 75th Anniversary - National Radio Club, founded in 1933.
 What better way to celebrate the Diamond Anniversary than to get back together in the familiar surroundings of the birthplace of modern broadcasting. And can you believe it? The city of Pittsburgh is celebrating its 250th anniversary this year, too!

The host will be John Malicky; one of NRC's most experienced convention leaders. Just look at what he's arranging. The Pirates baseball team will play on Sunday afternoon against Milwaukee - very appropriate for the 75th diamond anniversary - weather permitting.
 Plan to arrive early enough on Friday to take part in studio tour that afternoon, with a pizza dinner being served in the meeting room that night. The grand opening will be held at 7 pm on Friday with a presentation about the history of Pittsburgh rounding out the evening.

Saturday morning will feature a tour of the Heinz History Center at 9 am, and you are invited to buy lunch at the Sports Rock Cafe if you wish. There will be transmitter tours in the afternoon for those who wish to get out and see what broadcasting in Pittsburgh is all about, and then, at 5 pm, the annual group photograph at the hotel. Dale Park sends along the following from the Roseburg, OR News-Review dated 6/15/08:
 Sports radio expands in Douglas County, ROB McCALLUM, The News-Review
 Sports radio waves reach a lot more of Douglas County than they did last week. That's because Brooke Communications has reorganized formats on three of its radio stations to accommodate for more sports coverage. Starting last week, 101.1 COOL-FM and 1490 KRNR-AM both became KSKR "The Score," dropping a music format in exchange for local and national sports. Sports radio has been moved off of the company's flagship station, AM 1240 KQEN. "It's a little bit radical of a move," program director Brian Prawitz said. "Both COOL-FM and KRNR were underperforming as far as running a successful family of stations. You can get music anywhere and you can get national sports in a lot of places. The only place to find local sports on the radio is right here and we're proud of that." Prawitz said that the reorganization will bring more sports radio not just to Roseburg, but to the rest of the county. "Combining signals gives you a footprint from all the way past Drain down to Tri City and points beyond," he said. "With the two stations in simulcast we can reach a lot more households." The Score broadcasts ESPN Radio feeds, which was previously heard on KQEN from 5 pm to 9 am. Locally, The Score will be home to Roseburg High football and basketball as well as Dr. Stewart's American Legion baseball. Oregon State athletics will continue to be broadcast on 1490-AM and Oregon athletics will remain on 101.1-FM. Having stations on both AM and FM signals will allow for the broadcast of local sports in addition to national events. "One really good thing about the simulcast is that we can run two events at the same time," Prawitz said. "This week for instance we can play the Docs on one station and the NBA finals on the other." This fall, Prawitz said the score will be adding a Douglas County game of the week, with Ken Sherman doing play-by-play of a selected football game in the 4A, 3A, 2A and 1A ranks on 101.1 FM. Prawitz will continue to cover Roseburg football on 1490-AM. Prawitz said that 101.1 is only the second FM station to move to an all-sports format. The Game 95.5 FM hit Portland airwaves on May 12. "Having so much ESPN radio may seem a bit much," Prawitz said. "But it allows us to touch other areas with sports. Our challenge will be to find as many as possible to localize it." (DP-HI)

 True Oldies' outlet to resurrect WLS-FM as station identification, June 19, 2008, ROBERT FEDER, Sun-Times Columnist
 In a real blast from the past, the fabled call letters of WLS-FM are about to ride the Chicago airwaves again. Citadel Broadcasting plans to ask the Federal Communications Commission next week to turn WZZN-FM (94.7), the "True Oldies" station, into WLS-FM. If approved, the change is expected to take effect June 26. In a real blast from the past, the fabled call letters of WLS-FM are about to ride the Chicago airwaves again. The application is considered a formality since Citadel also owns news/talk WLS-AM (890). Mike Fowler, president and general manager of both stations, said the call letter change would be accompanied by a new set of on-air jingles recalling the rock 'n' roll heyday of WLS, along with a new logo. He also hinted at a

few other surprises, perhaps involving some stars from the old days. "We're going to develop this into the Top 40 WLS of old," Fowler said. "We want to make it a cohesive package that presents the music in the framework of when it was all new." The station's local talent lineup already includes two hosts with strong associations to WLS' past. Evening star and Radio Hall of Famer Dick Biondi was part of the station's legendary starting roster in 1960, while morning personality Brant Miller was on from 1977 to 1991. Fowler said WLS-FM would continue to be targeting listeners between the ages of 25 and 54 with Top 40 hits mainly from the years 1964 to 1982. "The goal is to put the excitement back in the music," he added. The switch coincides with the start of Portable People Meters, Arbitron's electronic audience measurement system. Since the new devices do not require listeners to write down a station's call letters, there'll be no chance of confusion between WLS-AM and WLS-FM. Under ABC ownership, the 94.7 FM frequency just went by the call letters WLS-FM in 1995. Since then, it's been called WKXX, WXCD and WZZN. (PM-OR)

 Radio company pulls plug on Geneseo station, By Times staff, Friday, May 9, 2008 8:43 PM CDT
 Regional Radio Group said Friday that WGEN Newstalk 1500 in Geneseo, Ill., is merging its local news and high school sports programming into sister station WJRE Hogg Country 102.5. According to a news release, WGEN's tower site in Geneseo will become the location of new retail development. WGEN's last day on the air will be May 15. (DP-H)

 Chicago radio station may move to Silvis, By David Burke, Monday, February 25, 2008 12:03 AM CST
 A move for more power by a suburban Chicago broadcaster could mean a new AM radio station in the Quad-Cities. Kovas Communications, the owner of Aurora, Ill.-based WKKD, is moving the station's 1580 AM frequency to Silvis, Ill., according to Tim Disa of AirTime Media, a Chicago-based radio broker. That will federal the station's 1590 AM frequency in Evanston, Ill., to increase its power, Disa said. The Federal Communications Commission granted a construction permit for the station, with a three-year window for completion. "Is that imminent? Will it happen by next month? Nope," Disa said. WKKD currently airs national programming from the Health Radio Network. Disa said Kovas likely will sell the license before the station construction is completed. "Either they will sell it to a company that does want another radio station or someone who wants their first station in this market," he said. "When the station eventually broadcasts, it will bring the 1580 AM frequency back to the Quad-Cities. It was the former home of KFQC, which broadcast urban music before signing off in the late 1990s. The station has FCC authority to broadcast at 1,000 watts of power during the daytime and 1,400 watts at night. In comparison to other Quad-City AM stations, WOC-AM 1420 and WKBF-AM 1270 broadcasts at 5,000 watts and WFXN-AM 1230 and KJOC-AM 1170 have 1,000 watts. "It's a nice opportunity for someone else to add a radio station to their group or get their first radio station," Disa said. "Who that'll end up being, I have no clue." (DP-HI)

 WKBF-AM (1270) has new owners, but for the first time in numerous format changes for the Quad-City radio stalwart, it will not be as noticeable to listeners. The station has signed on as "La Jefa," Spanish for the female boss. It continues a format of Hispanic music. Victoria and Emilio Duran of Clarion, Iowa, calling themselves La Jefa Latino Broadcasting, purchased the station for \$680,000 from Wisconsin broadcaster Randy Melcher's company, Quad-Cities Media. "We've had several different parties make offers to us, but this group was able to put together the best offer," said Melcher, who is running for a state legislative seat in Wisconsin. The paperwork was filed this week with the Federal Communications Commission, or FCC, he said, and it will be about two to three months before the sale is officially approved and completed. "La Jefa" began broadcasting earlier this month with Spanish-language music. Eventually, Emilio Duran said, local programming may be added. "Our plans are for Latino music and to just be here doing business," he said. The couple previously was involved with Des Moines radio station KBGG-AM, "La Ley," before it switched formats to sports talk earlier this year. "The opportunity to buy this came up," Duran said. "I like music a lot. For the longest time, we wanted to find a radio station." Melcher announced in April that the station was for sale. In its 83-year history, the station has had a large number of formats. In this decade alone, it has gone from a pop standards format to classic country to liberal talk radio to Christian music and talk to Spanish-language music to Spanish-language religious programming. In October 2006, Melcher purchased the station from Mercury Group, which leased the operation of it to Clear Channel Communications' Quad-City Radio Group. FCC regulations forced the sales of WKBF and its sister station, the former WHTS-FM (98.9). (DP-HI)

 Local radio station KGNB-AM 1420 will soon announce it will abandon its current daytime and overnight sports format and dissolve its association with the Sporting News Radio Network. Station general manager Mattison Rainer said the station, founded in 1950 and owned by New Braunfels Communications, Inc., will continue its emphasis on local news and sports, but accent it with a country music format during the times currently slotted for Sporting News programs. Rainer said the move was necessary because of the listeners' preference for local programming, and hopes they will embrace the new format, which is planned to debut sometime next month. "We're going to go with a country (music) format. Everything that's currently local is going to stay local," he said. "We just want to become more local during the hours that we're not (doing) local (programming), which is Sporting News Radio." According to the station's Web site, KGNB features weekly interviews with the Mayor of New Braunfels, city council members, county commissioners, and representatives from the Chamber of Commerce and TXDOT during its local programming, which airs from 6-9 am; Noon-2 pm and 5-6 pm; Sporting News programs air from 9 am-noon; 2 pm-5 pm; 6-9 pm and during the overnight hours. Rainer said the new format isn't a radical exit from what the station currently features. "It's going to be classic country, from the late '80s and early '90s, and also a Texas-mixed blend," he said. "The only hours that will change is during the Sporting News (slots), but we're not doing anything else." The station is paired with KNBT-FM 92.1, which airs Americana and Texas country and swing music. Rainer said no changes are planned for KNBT's format. Both stations have long aired New Braunfels, Canyon and

Smithson Valley football games, and plan to continue doing so. "We anticipate nothing changing with the last 25 years or so that we've done high school football," Rainer said. "The feedback will continue getting is that being local is what it's all about," he said. "This is what we're going to do." KGNB will continue broadcasting the Houston Astros baseball and Houston Texans football games, and Rainer said it will also air Texas A&M football and basketball games starting this fall. "We'll keep doing the Astros baseball and the A&M football — all the games and sporting events we usually do," he said. Rainer said he hopes to make a formal announcement on the switch sometime next week. "There are lots of things we need to work out," he said. "We're shooting for early July, but things can pop up that could delay it." Sports director Brant Freeman said he was offered to remain with the station but declined a full-time role. Freeman, who has been with the station since 2006, said he will still be an announcer for KGNB and KNTB high school football games this fall. (DP-HI)

CKDH applies for FM license, The Amherst Daily News
WEST AMHERST — After 50 years, local radio station CKDH has applied for an FM frequency. "This is a historic day not only for CKDH but for everyone in Cumberland and Westmoreland community as well," said station general manager Roger White. The station applied with the Canadian Radio and Telecommunications Commission (CRTC) on June 12. The proposed frequency selection is channel 266 at 101.7 MHz. White says radio stations on the AM frequency have faced considerable economic difficulties in recent years. "Listeners now have a multitude of choices from which to fulfill their need of entertainment and information such as cable television, satellite television, newspaper as well as the Internet. Even satellite radio has also provided AM radio with more competition giving listening audiences an enormous amount of programming choices," White said. Since 1957, CKDH Radio has played a pivotal role in the lives of residents of Amherst and Cumberland County. On Oct. 25 of that year, CKDH signed on under the ownership of local businessman Don Hinton with 250 watts at 1400 kHz. CKDH then moved to 900 kHz at 1000 watts in 1964. Since its inception, CKDH has prided itself on supporting new talent in the field of broadcasting with such notables as CTV's Mike Duffy and CBC's Ian Hanomansing being alumni. CKDH has a storied history of community involvement in the Cumberland County, whether it was continuing coverage of the 1958 Springhill Bump that claimed 75 lives or the 50-hour radio marathon by Tony Doucette to raise funds for the Amherst Fire Department. CKDH was there ready to lend its airwaves to the community. CKDH has also provided coverage for the Sackville Music Festival, live broadcasts of Christmas concerts by local choirs, a 12-hour radio Talent Blitz, Maritime Talent Search, Rotary Radio Auctions, High School shows and more during the past 50 years. A decision could come from the CRTC as early as fall and if approved, the switch to FM could be effective in early 2009. (DP-HI)

A KGA POWER REDUCTION:

The owners of KGA-AM (1510) have applied to the Federal Communications Commission to reduce the station's nighttime power from 50,000 watts to 15,000 watts. If approved, this will probably have only a minor effect on local listeners, since 15,000 watts is still plenty of punch to reach the majority of the Spokane market. However, it would mean the end of an era. KGA-AM would have to relinquish its "clear channel" Class A status, which it has held since 1948. The station's power would remain at 50,000 watts during the day -- the maximum for any AM station -- but because it would no longer blast at full power at night, it would become what the FCC calls a Class B station. "Spokane was always proud of KGA for the fact that people could hear the message and news of Spokane all up and down the West Coast at night," said Tom Read, founder and executive director of the Northwest Pioneer Broadcasters, owner of two stations in Spokane and former KGA announcer. "That's something we'll definitely lose." According to an engineering report filed as part of the application, the area covered by the station's primary (i.e., local) signal, will be reduced somewhat at night, especially in North Idaho. Because the signal is aimed mainly west and southwest, coverage has always been sketchy in North Idaho -- even at 50,000 watts. KGA-AM, which switched recently to an all-sports format, carries Gonzaga University's basketball broadcasts -- and most of them are at night. However, Gonzaga athletic director Mike Roth said he does not expect the proposed change to significantly affect local listenership. The real reduction would be in what is called the "secondary" skywave signal -- the signal which bounces for long distances off the night sky. That's the signal that listeners can pick up at night all through Oregon and much of California. As a Class B station, KGA-AM's skywave signal would no longer be protected from interference by other stations. The proposed power reduction would enable Mapleton Communications, which recently purchased KGA-AM, to boost the nighttime power of one of its other stations, KPIG-AM in Piedmont, Cal., which is also at 1510 on the AM dial. Under a related contingent proposal, KPIG-AM would go from its present 230 watts at night to 2,400 watts at night, and thus cover a much larger segment of the Bay Area. The Northwest Pioneer Broadcasters are concerned about this aspect of the proposal. In an e-mail statement, Read said it was "a fair question" to ask if Mapleton would have been interested in buying Spokane stations "if it were not for the fact that by downgrading KGA, they could upgrade their Piedmont, Cal., station." Adam Nathanson of Mapleton Communications said it would be premature to comment since no decision has yet been made by the FCC. "Want to weigh in? The application is still open to public comment by writing to the FCC at 445 12th St. S.W., Washington, D.C. 20554. So how's the man they call "The Mouth" feel about it? "Sure, it's hard to swallow," the liberal Streizin said Monday. "I didn't appreciate it." That's his reaction to being replaced in the 6 am to 10 am Monday through Friday time slot by his biggest rival, conservative Greg Fryermuth. Meanwhile, Streizin has moved to 4 pm to 6 pm drive time. "My wife actually said this morning, 'Do you want breakfast?' When was the last time I had breakfast, you know, 10 years ago?," Streizin said. "Usually I don't eat until 1 in the afternoon." Monday morning it was Streizin's small but vocal liberal audience

who took aim at his replacement and the man who made the move, Vice President and General Manager of Entravision Radio, David Candelaria. "They got blasted, but rightfully so," Streizin said. Fryermuth said there's still room for disagreement on his show. "We don't have to agree, we just have to be polite enough to agree to disagree," Fryermuth said. Candelaria pointed out that Air America, which his station used to carry, basically went bankrupt for the same reason, he said it's all liberal. So ABC-7 asked all parties involved, why won't liberal Democratic radio work in a town that's mostly full of liberals and Democrats? "I guess conservative people own the big businesses in town," Streizin said. "The majority of the business owners are conservative." Candelaria pointed out, "A conservative won't support a liberal talk show." Fryermuth said good radio will bring a good audience, regardless of who is hosting the show. "And a good audience is what you're marketing to the advertisers," Fryermuth said. Catholic talk radio station KYES to launch locally, By Amy Trang, atrang@stcloudtimes.com, June 26, 2008

A group of St. Cloud-area Catholics plans to launch a nonprofit Catholic talk radio station next spring. Former local radio station owner Andy Hilger said Wednesday that he is spearheading the efforts to launch station KYES, which will feature various Catholic talk radio programs. Programming will include nationally syndicated Catholic radio programs mixed with local programs. "It will be positive presentations," Hilger said. The station is part of a larger nonprofit organization that Hilger and about 10 other area Catholics are founding, called the Throw Fire Project. Part of the organization's mission is to inspire, support and celebrate Catholic values. To achieve those missions, the board members also hope to launch a Catholic studies institute, featuring classes and lectures near the St. Cloud State University campus. Launching the station will be the first part of getting Throw Fire started, Hilger said. Throw Fire is asking for permission from Stearns County to build seven 200-foot radio towers in Maine Prairie Township. The planning commission will have a public hearing July 17 about the proposed project. KYES will be a 50,000-watt AM station and will

cover the Diocese of St. Cloud, which is similar in size to WCCO radio's coverage area, Hilger said. It has a potential audience of almost 868,000 people and will reach a 16-county area of Central Minnesota and stretch to the North Dakota and South Dakota borders. The station's headquarters are slated to be on Lincoln Avenue Southeast, near the Regent Communications building, Hilger said. He said the station will rely on donations and volunteers to build the studio and offices. Hilger said the project is expected to cost about \$4 million. About \$1 million has been donated, and board members will continue fundraising in the next two to three weeks, Hilger said. Continuing funding will come from periodic radio fundraisers and radio ads similar to the advertising of Minnesota Public Radio. Hilger owned four radio stations in St. Cloud for several decades before he sold three of them to Regent Communications Inc. in 1999. He donated a Christian radio station, Spirit 92.9, to the Diocese of St. Cloud in 2000. "We're Catholic laypeople. We are ready and able to cooperate with the diocese to assist with their missions," Hilger said. (DP-HI)

In what's shaping up as a year of big change for the Seattle Mariners, the team's radio rights could also be in flux. A source told The Times on Friday that Fisher Broadcasting, the parent company of KOMO-AM, has dropped out of the bidding for the Mariners' radio broadcast rights, possibly leaving KIRO-AM as the lone remaining pursuer. KJR-AM, an all-sports station that holds the rights to the Washington Huskies, is not thought to be involved. KOMO's rights to broadcast the games expire after this season. Fisher paid \$10 million a year before the 2003 season to lure the Mariners away from KIRO, a figure that at the time was thought to be the highest rights fee in baseball history. KOMO used the acquisition of the Mariners to change the identity of the station from primarily nonsports talk shows to 24-hour news. Changing stations does not typically result in changes among the game announcing crew, which is hired by the team. However, pre- and postgame personnel and formats typically change. At the time Fisher acquired the rights, the Mariners were in the midst of four straight winning seasons (2000-2003). But they have had just one winning season and no postseason appearances since then and are off to one of the worst starts in team history. (DP-HI)

Quinn's sports talk radio still on stand-by. Start-up costs, logistic delay return to north state airwaves, By John Ryan, Wednesday, June 25, 2008

Redding sports talk radio probably won't be back on the airwaves by early July, an original timetable set by Mike Quinn, owner of KLXR 1230 AM and KCNR 1460 AM. "I don't think we're going to make it," Quinn said of the projected start-up. Which means it may be three months of no sports in the can. Mapleton Communications' Redding Radio 1670 AM dropped ESPN on April 18 and replaced it with KPIG. Since then Quinn's picked up the mantle of sports radio in Shasta County. He asked potential listeners to send in a dollar -- which he'd donate to the Good News Rescue Mission -- as a way to take the area's sports talk temperature. He received more than \$300 in a month. But the enthusiasm hasn't made it much easier to piece together the necessary infrastructure. "I'm just getting some of the equipment now," Quinn said. "It's a very expensive format and a very time-consuming process." Quinn figured he'd eat \$20,000 in start-up costs before the likes of Jim Rome, Dan Patrick or the NFL playoffs grace north state stereos again. "A new transmitter is probably the biggest thing," Quinn said. "We might need a new satellite dish, too." On top of that, Quinn has to collect different receivers for each network. For example, Premier Radio Networks, which broadcasts Rome's show, requires a different receiver than, say, Westwood One, which broadcasts the 49ers, the World Series and the Super Bowl. Some networks offer their receivers free with the broadcast rights, others charge. "A lot of it's older technology, too," Quinn said. "So it's hard to even find people that have it." Once he has his national programming lineup in place, Quinn said, he'll work on getting local sports broadcast back on the air. Live high school sports haven't been a Redding radio staple since 2004 when KNRO 1670 AM and KQMS 1400 AM -- then both operated by Regent Broadcasting -- quietly dropped their programming because of budget issues. That fact isn't lost on Quinn, who's funding this project out of his own pocket in an economic cycle with fewer advertising dollars to go around. "That is the hard part," Quinn said. "I'm not sure how well it's going to sell. Listeners are one thing. Advertisers are another." (DP-HI)

Baseball Heritage Museum mounts radio exhibit, Saturday, June 14, 2008, Julie E. Washington, Plain Dealer Reporter

Smell the tang of burnt transistors and state oil. Hear the clack of a teletype machine. Listen to the voice of Mel Allen calling the 1948 World Series for NBC Radio. These memories live at the Baseball and Radio Broadcast Exhibit, part of the Baseball Heritage Museum in Cleveland. The exhibit, housed on the lower level of the museum, opens today. Murray "Get Down" Sauti, Larry Morrow, "Fall" Ted Hallaman and Joe Mosbrook are among the radio personalities expected to attend. "Baseball and broadcasting have gone together like cake and ice cream," said curator Jim Davison, 46. His personal collection of radio equipment and memorabilia is the exhibit's backbone. After you learn about the Negro and women's leagues, step into a place where radio's yesterday is today. Peek into a case holding a 1905 cylinder record made by Cleveland Graphophone Co. Maybe you had a WZZP jockey sweater, a 1947 WGAR calendar or a Bill Randle cookbook promoting the legendary WERE AM/1490 lock. A poster of the Moondog Coro nation Ball beckerth all Moonoggles across the decades. Baseball and broadcasting came together when Bob Zimmer, one of the collectors behind the Baseball Heritage Museum, contacted Davison about recordings of Indians broadcasts. Davison noticed the museum's empty lower level. What if it held an exhibit telling how radio took the sounds of baseball from the field to the radio station to listeners' living rooms? Zimmer gave Davison the go-ahead. Davison moved his collection from his garage; other items were donated. Davison has been collecting radio memorabilia since a family friend sparked his interest when he was a boy. Davison went on to work part time as an engineer at area stations. People started calling Davison, who lives in Northfield, for help with radio

history. He supplied props to re-create the 1961 WHK studio when the movie "Telling Lies in America" filmed here in the late '90s. The exhibit is divided into eras. The 1950s-era studio is Davison's favorite. A turntable sits ready to play 16-inch LPs, which look enormous compared to CDs. The discs held only 15 minutes of music, he said. Music carts, which look like small eight-track tapes and were used to hold recorded songs and jingles, are nearby. A reel-to-reel machine was used for interviews and live remotes. "This is your typical '50s studio. This was all you needed," Davison said. A living room from the past needs only a family to plunk down in easy chairs to hear an Indians game wafting from a 1932 Philco radio floor model. Another area shows what visitors would find in an old transmitter room - equipment covered in mysterious dials. A studio from the 1960s and '70s shows how technology had evolved since the early days. The 16-inch records are replaced by cassettes and cassette tapes. A wall of 1,000 carts was salvaged from a Kent station, Davison said. The newsroom includes a typewriter loaded with WERE letterhead paper, sitting near a WTAM AM/1100 state-by-state board with written results from the 1944 presidential election. Davison regrets that, because of corporate takeovers, the business has lost more than equipment with dials. "The jocks had personality back then. Today, who you gonna call to request a song?" he asked. Davison's job at L'Oreal in Streetsboro means he can work on the museum only one day a week. He has relied on a friend and history buff to arrange the displays. Davison would like to add a production studio so radio hosts can broadcast live from the exhibit using its old equipment. "It's never going to be done," he said. "A museum is never finished." (DP-HI)

According to reports from Majuro, capital of the Marshall Islands in the north-west Pacific, supplies of diesel and coconut oil to the private sector could be completely cut within weeks, forcing four private radio stations off the air. RNZI News reports that a state of economic emergency has been declared, to reduce fuel and power consumption, after the national power utility projects a financial deficit representing close to 20 per cent of the entire national budget. The Marshall Islands Energy Company needs US\$8.5m to pay for June diesel shipments and as a down payment for the next shipment, and needs to find the funds within seven days. Steve Clark, manager of The Change 104.1 FM on Majuro says this station has already switched to propane gas in an effort to keep the new Christian radio station on the air. The Change 104.1 FM is in urgent talks with New Zealand based partner UCB Pacific Partners to develop solar and wind power energy generation options. Graham Carter, chief executive of UCB Pacific Partners says "it will take months to raise money, ship the equipment and get it all set up. In the meantime, the four private FM radio stations on Majuro face a bleak and potentially silent future. Radio Marshalls V7AB the government radio station operating on both AM and FM will remain as the only local broadcaster on air on Majuro should this happen. The Central Pacific Network of the US Armed Forces Radio operates an additional four stations on Kwajalein, which although part of the Marshall Islands, are likely to be immune from the crisis because they're US government funded and serve military installations. Major station won't get ABC Radio's Olympic coverage. Print By Glenda Korporaal, July 04, 2008, ABC Radio will not have full Olympic coverage, Broadcaster's Sydney station loses out in deal, First time whole country won't get Auntie's coverage

ABC Radio will be unable to provide full Olympic coverage across its national network for the first time after failing to agree to a deal on Sydney broadcast rights with John Singleton's 2GB. While 702 ABC Sydney listeners will receive Olympic updates, they will be denied full coverage, prompting an angry reaction yesterday from ABC Radio Sport editor Peter Longman. "We were extremely disappointed that despite our efforts to secure access to full Games commentary for 702 ABC Sydney audiences, we were unsuccessful," Longman said. "This breaks the hitherto long-held record of broadcasting commentary from every Olympics in the modern era to the whole country." The ABC and Macquarie Radio - owner of the city's top-rating AM station 2GB - yesterday finalized a deal for the broadcast of the Games, which will restrict ABC Radio's official coverage to its stations outside Sydney. Macquarie, which paid an estimated \$600,000 to the Seven Network for the radio rights for the 2004 and 2008 Olympics, secured 2GB as the main voice of the Games in Sydney. The Sydney blackout will create programming complications for ABC Radio, as it will affect coverage on Radio National and Triple J. "Knocking out a metropolitan market such as Sydney from our national network represents major technical and scheduling challenges," Mr Longman said. Mr Longman said the ABC had offered "what we thought was a fair price" to Macquarie Radio for full national public radio coverage. "But they have made a commercial decision and want exclusive coverage in the Sydney region." He said the full Olympic coverage will be available on 59 metropolitan and regional stations of ABC local radio. (DP-HI)

Application by the Canadian Broadcasting Corporation (CBC) to amend the license of the radio programming undertaking CBU Vancouver, British Columbia. The licensee proposes to add an FM transmitter at Vancouver to broadcast its programming service Radio One originating from CBU Vancouver in order to adequately serve the population of Vancouver. The transmitter would operate on the frequency 88.1 MHz (channel 11C) with an average effective radiated power of 8,900 watts (maximum effective radiated power 19,500 watts/effective antenna height of 567.2 metres). The Commission notes that it approved in part an application for an FM radio programming undertaking at Vancouver in Broadcasting Decision CRTC 2008-117. Licensing of new radio stations to serve the Vancouver radio market (Decision2008-117). As part of the decision, the Commission denied the CBC's request to operate an FM transmitter on Gabriola Island as well as the application to amend the broadcasting licence for CBCV-FM Victoria, to add an FM transmitter to

serve Nanaimo. The Commission further decided that the CBC should maintain the operation of its AM frequency in Vancouver to ensure effective coverage in outlying areas. The proposed technical parameters would be the same as those authorized in Decision CRTC 2008-117. The CBC is seeking to amend the authority for the radio programming undertaking granted in Decision 2008-117, into a transmitter of CBU Vancouver. The CBC would maintain the AM undertaking CBU and add an FM transmitter to address coverage deficiencies in Vancouver. (PM-OR)

A LIKELY LONG BEACH AREA PIRATE ON 1500 KHZ
CGC misplaced an e-mail dated May 18, 2008 reporting a probable pirate station with a strong signal at the 405/605 freeway intersection in Long Beach, CA. The frequency is 1500 KHz. According to the May letter, "this has been going on for over a year and I find it interesting no one has said anything about it or done anything to shut this pirate down." Back in May the station was said to be rebroadcasting WSB out of Atlanta; however, at other times the station was reportedly relaying KSFO San Francisco, KNEW Oakland, and during the weekends a time of day station. New owner to change format at WJEP-AM, By Dave Hodges, DEMOCRAT BUSINESS EDITOR, June 25, 2008
The Thomasville radio station purchased by Georgia Triangle Broadcasting will begin serving a menu of progressive talk radio beginning Aug. 1, a lineup the company's chief executive says will be aimed at listeners age 18 to 34. The new owners of WJEP-AM plan to add a 24-hour FM simulcast at a frequency to be determined, as well as streaming the station's programming on the internet, said Georgia Triangle CEO Woody Nelson. Georgia Triangle announced June 14 it had purchased the radio station from Lifeline Ministries, which had been broadcasting a contemporary Christian format. The sale is subject to final approval of the ownership change by the Federal Communications Commission. The new format includes entertainer Dennis Miller and two locally based shows the company hopes to syndicate nationwide. One is "The Brewed Awakening" morning show that Nelson hosts. The other is the afternoon Veronica Tyler Show, which will be available for market-exclusive syndication beginning Aug. 1. In the meantime, a new transmitter is being installed and other preparations are being made for serving the demographic that includes college-aged adults. Nelson said WJEP's talk-radio programming won't be the typical approach. "We are not intending to be political," he explained. "It's completely entertainment-driven talk." (DP-HI)

WAVO moves to the sounds of Sinatra. Ella, the charlotte observer, MARK WASHBURN
Sinatra's back. Another format change in Charlotte radio launches today, one that returns so-called "adult standards" to the airwaves. WAVO-AM (1150) will switch from Christian programming to the music of Nat King Cole, Ella Fitzgerald and Johnny Mathis at 11:50 am, a time that references its frequency. It fills the niche left behind by the old WNMX-FM ("Mix" 106), which switched from adult standards to an oldies format and became WOLS-FM (106.1) this year to capture a younger audience. "This kind of music never gets old," says Tom Gentry, general manager with the Carolina Radio Network, which operates both WOLS and WAVO. "It's people who still recognize that there has never been better music released." CRN will continue to offer Christian programming on sister station WHVN-AM (1240). Big Band music will also be part of WAVO's sound. "Big Band Jump" with Don Kennedy will air from noon to 2 pm on Sundays. Artists like Glenn Miller and Tommy Dorsey will be part of the music rotation daily. WAVO will also feature Frank Sinatra from 3 to 5 pm on Sundays. Music for the station will be provided by a syndicated satellite service, Gentry says. Meanwhile, jazz fans continue to mourn the loss of WNSC-FM (88.9), which recently switched to the NPR news and talk format. It's unlikely anything will come along soon to take its place, but HD radio – an emerging digital technology that offers stations the option of adding a side channel that can be picked up by special receivers – may be the answer before too long. Jazz fans tend to be passionate and upscale, just the kind of listeners that keep public radio stations in business at pledge drive time. WFAE-FM (90.7) already has a second channel on its digital broadcasts that carries shows usually not heard on the main channel. And classical WDAV-FM (89.9) would be a good candidate, too, when it decides to add an HD channel. (DP-HI)

Hispanic Radio Hits Rough Wave, Ads Decline With Lagging Economy, By Alejandro Lazo, Washington Post Staff Writer, Monday, July 14, 2008
The International Media Academy, a storefront language school located below the studios of Radio Fiesta 1480 AM, shuttered its doors earlier this year. With that, the Spanish-language station lost an advertiser. When the Vilchez & Associates realty company closed its Woodbridge office a few doors down from Radio Fiesta, with an African market opening in its place, the station lost another. The nearby Asesoría Salvadoreña, which helps immigrants get power of attorney and make land transactions in their home countries, saw its customers begin to dwindle last year. It cut out most of its advertising budget, including its account with Radio Fiesta. For years immigrant entrepreneurs have taken over small stations with relatively weak signals, providing what for many Caribbean and Latin American immigrants is a key source of

information about their local communities, U.S. life and politics, and news from the homeland. When Carlos Woodbridge, a native of El Salvador, founded Radio Fiesta six years ago on the second story of a strip mall in Woodbridge, he intended it to play just that role for Hispanics in Prince William County. "The intention was to create a bridge between the Hispanic and the Anglo community, interviewing politicians and informing the community and creating a radio station that serves the community," Aragon said. But these days the suburb mortgage meltdown has hit many Spanish-language radio stations hard. Real estate companies that targeted the Hispanic community have closed their doors or cut back on advertising and sponsorships. Aragon has lost most of the real estate agents who once advertised with him. In Prince William, where authorities are cracking down on illegal immigrants, many Hispanic-owned businesses have also slashed their ad budgets as fewer customers walk through their doors. Radio Fiesta's ad revenue from Hispanic businesses has declined by about 40 percent over the past year; it's down 10 percent from non-Hispanic businesses, Aragon said. Mercedes Hernandez, who used to advertise with Aragon, stood outside her Asesoría Salvadoreña last week as workers began bringing in piles of clothes to a new shop she is opening. "People are abandoning homes, businesses are closing and unemployment is high because people are afraid to walk around," she said. "We are opening a used-clothes store because people can't afford anything else." The Washington area has 11 Spanish-language radio stations, though only El Zol at 99.1 FM, which took over the alternative rock station WHFS three years ago, has a market-wide signal. That station has gained in audience share over the past three years and now captures 3.7 percent of the market. Hispanics make up 11.7 percent of the entire market, according to figures from the research firm Arbitron. Numbers are not available for the other stations. "The rest of the stations are locally focused and depend highly on the business of the communities they serve," said Steve Passwaller, a vice president with research firm BIA Financial Network. As the housing market took off, Spanish-language radio and real estate companies – two businesses that are highly locally focused – became increasingly intertwined. Jose Luis Semidey, a real estate agent who catered to the Hispanic community, ran Radio Latina at 95.0 AM in Potomac and 8.10 AM in Annapolis. He's no longer an agent, and he ceased operating the stations in 2006. The realty firm Vilchez & Associates was a principal sponsor of Radio Universal in Manassas at 1460 AM, which no longer exists. It was shut down last year to be reopened this year as La Kallente, with a new format and a new owner. Peruvian native Ronald Gordon, whose Arlington-based ZGS Communications operates 11 Telemundo television station affiliates and three radio stations, including VIVA 900 AM in Laurel, said the housing bust has hit Spanish-language radio in the area, much like it has hit the whole Hispanic community. I think in terms of the mortgage and real estate industry, we were over-indexed in terms of advertising," Gordon said. With a pair of headphones over his brushed-back black hair, his lips never far from a suspended microphone, Aragon can be found weekday mornings in his studio, pumping out a steady diet of Spanish-language news, talk, and Mexican and Central American tunes on his show "Buenos Dias Washington." Aragon began renting his station's signal from JMK Communications of Los Angeles in 2002, changing its format from country to Mexican regional. Those days, the housing boom was just getting underway and an influx of Hispanics that would change the county's demographic mix had begun. The station began throwing an annual Fiesta Hispana in its parking lot. It promoted Mexican and Central American bands. And when the latest immigration debate heated up, the station served as a place for information about demonstrations and meetings. At the height of the housing boom, Aragon had as many as 15 real estate agents advertising with him, he said. He got his own Realtor's license three years ago and began advertising his services on his show – which he still does today. Only one other real estate agent remains as an advertiser. The Fiesta Hispana has also been canceled for the second year in a row because many Hispanics in the area remain fearful of the ongoing crackdown in the county, Aragon said. Despite the harsh environment, Aragon is optimistic. He said the station remains profitable and that he plans for it to remain a fixture in the community. He is weathering the storm by seeking out advertisers and listeners outside of his Prince William base. The station's 5,000-watt signal can reach Arlington, Fairfax, Alexandria and Fredericksburg, as well as some parts of the District and Maryland. Soccer team D.C. United, which has advertised on Radio Fiesta for four years, finds the station to be a good vehicle for reaching fans along the I-95 corridor. "We try and target that Latin fan base that lies down south," said Boris Flores, director of Hispanic marketing for the club. "We see [Radio Fiesta] as a good vehicle for reaching people in that part of the market." Changes are in the works at Radio Fiesta. In January, Aragon hired his 28-year-old daughter, Melissa Gieras, as the station's business development executive. She has been drawing up revised programming plans and pitching the station to more advertisers outside of the county. She has also been laying the groundwork for a nonprofit group intended to be a resource for the county's minority-owned businesses. Meanwhile Aragon's show remains a venue for the area's Hispanic population to discuss some of the most pressing issues of the day. One recent morning, Aragon hosted Corey A. Stewart (R-At Large), the chairman of the Prince William Board of County Supervisors and one of the county's principal protagonists in the immigration crackdown. Stewart defended the resolution, saying illegal immigrants were still not welcome in the county. But there should be more legal immigration allowed in the United States, and the resolution was not specifically aimed at Hispanics or any other group, he said on Radio Fiesta. "They certainly serve the Spanish-speaking community, and to that extent, it is very helpful to us when we want to reach out to the community," Stewart said of Radio Fiesta. "I know there have been some hurt feelings there." (DP-HI)

CHINA: 837 CNR-5 (Voice of Zhonghua, to Taiwan) on new 837, first noted by me on 25 March around 14:15 listening in Tarakan, Indonesia. According to their Chinese-language website (www.nihaotw.com), the new frequency started operating on 28 Dec 2007. 909 Web sources suggest the new Quanzhou SARTF site is already in operation, with a location near Zhangban in Hui'an County (GE low-res area in the region of 24 53N, 118 48E). The sources specifically mention that high-power transmitting equipment for both MW and SW has been installed at the new site, so the Chinese evidently still want to continue doing whatever they have been doing on SW from the curtain antennas at the old Quanzhou site. It's possible that Zhangban is the site for the new CNR-5 frequency of 837, but I haven't been able to find any confirmation of that. 1323 Chinese sources say there is at least one Harris DX-600 unit at the Huadian site, from which Korean 1323 is the only known frequency, and the CRIV/OR Korean signals can sometimes be heard quite well in SE Asia – presumably it's quite a narrow beam southwards. 1377 On the subject of Chinese sites, I recently found a paper published in 2005 describing the lightning-protection arrangements at the SARTF Station at Xingyang (near Zhengzhou). According to this, CNR-1 1377 is also from a Harris DX-600 using a two-tower antenna with a slightly directional pattern – which must be the rather unimpressive-looking masts at 34 48 28N, 113 23 17E on GE, most likely being a radiator and reflector to give maximum radiation in a direction just north of west. The site also has two Thomson M2W units each operating with 100 kW into single-mast omnidirectional antennas for 630 (CNR-2) and 972 (Henan PBS), which must be the masts at 34 48 40N, 113 23 22E and 34 48 43N, 113 23 07E. The same article also mentions that the SARTF site at Putian for 549/684 has two Thomson S7HP transmitters. The sites for Shandong PBS News Service mentioned in various web sources are: 891: Dongying 918; Binzhou, Dezhou, Heze (10 kW), Jinan-Huangtai (200 kW), Jining, Laiwu, Rizhao (10 kW), Taifan, Yantai (10 kW) 1467; *Beizhen (1 kW), Dezhou (1 kW), *Xin Xian (1 kW) 1485; *Dan Xian (1 kW), Liaocheng (1 kW), *Lu Xian (1 kW), *Pingyi (1 kW), *Tai'an (1 kW), *Weihai (1 kW) 1548; Linyi (7.5 kW), *Longkou (10 kW), *Qingdao (10 kW), *Rongcheng (10 kW), Weifang (10 kW)* = sites not mentioned on Shandong PBS website can't explain the double listings for Dezhou on 918 and 1467 and/or Tai'an on 918 and 1485. Probably there have been frequency changes for these sites. The powers listed for some sites may be out of date, but probably haven't changed dramatically. (Alan Davies via Arctic)

FUJI: Fiji Broadcasting Corporation is expected to modernize its operations and compete in the open market by injecting investment into new gear and equipment worth around \$400,000. Company chairman Daniel Whippy said no external funding would be sought for the new links, and upgrading of transmitter sites would be funded from within the company's financial capabilities. "So, we have to be profitably healthy in order to generate positive cash flows every year. To purchase new links and upgrade transmitter sites will cost around \$400, 000," said Mr. Whippy. He said they expected to increase branding their stations, provide new music mix and create a wider listenership. "There are plans to improve the broadcast signal and obviously, buying better equipment." (Fiji Times Online via ADXN June 08)

INDIA: The latest information on AIR Kargil is as follows. 2 Channels are in use: A Channel 684 (200 kW), Tx. Commissioned on 1 Sept 2006), B Channel 1584 (1 kW). Srinagar C frequency (10 kW) has been changed from 684 to 1224 in order to avoid mutual interference. (Jose Jacob, dx_india 10 June)

INDONESIA: 999 Jakarta sounds reasonably powerful, and probably in the tens of kW at least. RRI seem to be maintaining their MW transmitters better these days than a few years ago. Most of the regional frequencies are regularly active at the moment, and a few have increased their hours – e.g. Samarinda 1215 which is now on throughout the usual broadcast day (approx 2100 or 2200 to 1600), instead of a few hours each day as previously. SAMOA: Samoa Quality Broadcasters have completed purchase of 89.1 FM Apia, the former SBC Radio 1 outlet. CEO is Ms Faesea Matafeo, also the current CEO of SBC and she will be joined by seven other existing SBC staff. Redundancy payments are being made to others. The station will continue the 60 year old tradition of quality broadcasting established by forerunner 2AP in 1948, and serve Samoa in both English and Samoan languages. SQB have also purchased Telewise Samoa from the SBC, and will be operating from the same premises at Muini'u on the harbor front in Apia. The existing SBC1 and SBC2 AM transmitters [540 and 747] are not part of the sale deal and will come under control of the Ministry of Communications for use in emergencies and other times of national interest. FRANCE: Trans World Radio (TWR) is planning to modify the antenna of its 1000 kW transmitter at Roumoules in Southern France to provide a stronger signal in Morocco, Algeria and Tunisia. The current omnidirectional antenna on 1467 will be converted to a directional antenna at a cost of US \$200,000. TWR's John Summerville says the change has the potential of reaching 15 million new people in Arabic and four different Berber dialects. (Media Network weblog 10 June)

GERMANY: Truckradio has stopped his transmissions over all Mediumwave transmitters in Germany. <http://truckradio.de>. (Peter Kruse, mwdx 16 May)

AFN Hessen's AM 873 Power Network transmitter is experiencing a degraded signal due to ongoing repairs and upgrades. The transmitter will broadcast at one-third of its normal power until the work is completed in September. Brief and unscheduled outages can also be expected. IRELAND: Christian station Spirit has been licensed to use the former RTE channel of 612. There has been some conflicting info as to whether they will use Athlone or will have to build their own transmission facilities. This is evidence of them building a new site: <http://lists.radiolists.net/pipermail/broadcast/2007-November/063584.html>. Various discussions indicate that the former RTE mediumwave site in Athlone, shut down in 2004, will be demolished for development. (Kai Ludwig via Arctic)

NETHERLANDS: GrootNieuws Radio, the Dutch Christian broadcaster that took over the use of 1008 from Radio 10 Gold on 1 Sept last year, is in financial difficulties due to the high cost of operating the transmitter. Its website is requesting donations, and says there's a chance that the station may go silent on 1 August. The station says it needs half a million euro to survive up to the end of this year. <http://www.grootnieuwsradio.nl/>. ([RadioFreak.nl](http://radiofreak.nl) via Media Network weblog)

Dutch broadcaster Arrow Media Group has started testing on 828, the frequency that will carry its new service Arrow Talks. The transmitter at Heineoord, near Rotterdam, has a daytime power of 20 kW and a nighttime power of 5 kW. For the tests, it is carrying the programming of Arrow Classic Rock. According to Dutch website radiofreak.nl, Arrow Talks is scheduled to launch on 1 May. (Media Network)

NIGERIA: Developments at Nigeria's premier radio corporation, Federal Radio Corporation of Nigeria (FRCN), are fast transforming the staid image of Africa's largest radio network. In the past one year, Radio Nigeria has been quietly transforming itself with improved signals, captivating programming, web audio streaming, and, the latest, brand new transmitters at Kaduna and Enugu to be dedicated to educational service.

When completely installed in December 2008, the 200 MW KW transmitter in Jaji Kaduna would be one of the most powerful radio transmitters in Africa, and, in combination with the 100KW transmitter planned for Enugu in 2009, the whole country and much of Africa would receive the signals. The transmitters, a grant from the Japanese Government, would be digital ready. A statement by Ike Okere, Head of Communications FRCN, indicated that Radio Nigeria Kaduna has begun the process of dismantling its obsolete, 47-year-old MW transmitter to provide space for the new 200 KW transmitter coming from Japan.

The process of dismantling the gigantic, obsolete transmitter and its antennae component and installing the new one would take six months. To keep its Hausa language listeners during this transition, Radio Nigeria Kaduna recently commissioned a new Hausa language FM station in Kaduna. It also temporarily fixed its old Short Wave channel on the 49 Meter Band. Karama FM, the call sign of the new FM station, and the SW station would both continue to carry the quality programs of Radio Nigeria's famous Hausa Service.

The new, public-minded FRCN began sensitizing its Hausa Service listeners in early April with regular jingles announcing the transition and the continuation of the Hausa Service on SW and FM. In early May, the zonal director, FRCN Kaduna, Alhaji Ladan Salihu, took pressmen round the transmitting station in Jaji to explain the process of de-commissioning. Hundreds of listeners have been calling in to express support for the planned improvement the new transmitters would bring to Radio Nigeria's signals. "The collaboration with Japan through the Japanese International Cooperation Agency (JICA), would enable Radio Nigeria boost its Hausa and Educational Services in the face of competition from foreign broadcasters such as the BBC, VOA and China Hausa Services", said Mr. Ben Egbuna, FRCN's Director General, in the statement. A Yoruba language station, Amulund FM, in Ibadan, began transmission last year, while the Igbo language channel is expected to kick-off at Enugu next year. Last year, Radio Nigeria began live web audio streaming of five of its FM stations in Abuja, Kaduna, Enugu, Ibadan and Lagos, thus enabling millions of Nigerians in the diaspora to receive these stations and participate in interactive programs. A few months ago, it rolled out its VSAT platforms nationwide and thereby started taking the very popular Network News live from across the nation. The VSAT also enabled the corporation to introduce Network Nigeria, the midday, grassroots-oriented, human-angle news and features programmed.

The FRCN is Nigeria's premier radio broadcaster. With four National Stations and an Operations Centre on Short and Medium Wave Bands and Thirty-Two (32) FM Stations nationwide, plus the new Web audio streaming, it is Africa's largest radio network. Its network signals, including those of its State stations which broadcast in both English and 15 local languages, are estimated to reach 120 million listeners daily. SOUTH AFRICA: 657 The Christian Radio Station, Radio Pulpit, has purchased a new transmitter with capacity of broadcasting simultaneously in analog and digital systems. UKRAINE: 594 BBC is heard in Kyiv on 594 with English, Ukrainian and Russian programs on weekday mornings through evenings. It is interesting to note that the north-western part of shortwave and mediumwave transmitter site in Brovary near Kyiv, where the BBC relay transmitter is located, is being gradually dismantled because of its nearness to the Brovary residential area. So, the adjacent mediumwave mast here, which was similar to BBC's one, has been recently destroyed, and now the only operating transmitter in this part of the Brovary radio centre is that of the BBC. (Olex Yegorov, RUJ Whole World on the Radio Dial March 21 via DXLD)

The transmitters carrying UR1 as well as the UR3 Crimean 1242 outlet are still working under the previous schedule (effective 1.1.2008). Virgin Radio will disappear as a brand name under the terms of a £50-60 million sale negotiated by its owner SMG. Talks with Absolute Radio, which is backed by Irish investors and Times of Indian owner Bennett Coleman, are close to ending and will see the AM national and FM London licences sold by STV owner SMG. The sale, expected to be soon, originally envisaged transfer of the Virgin Radio brand. At 500 stations heard on an Ultralight receiver, an extraordinary achievement, a "Master Ultralight DXer Award" is conferred.

If you have yet to experience the renewed thrill of DXing with an inexpensive Ultralight receiver, we invite you to share the excitement and satisfaction that comes from success in pocket radio DX. Emphasizing DXing skill and knowledge over equipment innovation, Ultralight Radio DXing brings special rewards in proportion to the special challenges – and has restored the original thrill of AM DXing to many radio enthusiasts. Public announcements of award recipients will be made on a monthly basis, with an over-all, comprehensive list being published annually.

The Awards certificates are distributed as 150 dpi jpeg files. This is the same format as most digital photographs; thus, the certificate may be printed on a good home computer printer. The awards were designed to be printed at 8.5" x 11", but could be printed successfully at the 8" x 10" or similar size.

AWARD GRAPHICS

All general Ultralight DX Awards carry versions of the classic painting by F.J. Edgins which depicts the mythical radio station operator. The award graphics include the antenna to a receiver speaker of similar vintage. This painting was used for several months in the mid-20s as the front cover graphic of "Radio Broadcast" magazine.

The graphic for all Founder's Awards and Master DXer Awards is from a Culler painting used on the front cover of the Fall Radio Corporation, New York, general catalog, in the mid-30s.

The graphic for both of the Ross DX Challenge awards is from a painting by the artist R.F. Westrauff, "Wireless Age." The artist is R.F. Westrauff.
