F.C.C. FINES

F.C.C. has canceled a \$7,000 Forfeiture to Station WSVX(AM) (formerly WKWH), Shelbyville, Indiana. Filed on behalf of RSE Broadcasting, LLC ("RSE"), former licensee of Station WSVX(AM) (formerly WKWH), Shelbyville, Indiana ("Station"). RSE seeked cancellation of the January 31, 2007, Notice of Apparent Liability for Forfeiture ("NAL") in the amount of seven thousand dollars (\$7,000), for willfully violating Section 73.3539 of the Communications Act of 1934, as amended ("Act") for its failure to timely file a license renewal application and for unauthorized operation of the Station after its license had expired. FCC cancels the monetary forfeiture issued on January 31, 2007, and assesses RSE a 25 per cent late-fee penalty for its late filing. Station was able to prove that the application although filed late, was not filed after the expiration date.

"Autoradio is excited to be partnering with AM 650 for live, simultaneous broadcasts in Vancouver and Russia during the month of February. We will be broadcasting live Russian music and radio shows, including our popular morning show "Murzilki International," says Yuri Kostin, President of Prof Media Broadcasting Corporation, owner of Autoradio. Autoradio and its radio personalities will broadcast from the Russian House "Sochi 2014" at Science World. The shows will air most days from 8 pm to 5 am in Vancouver, and will continue to broadcast live outside of those times in Russia. #### 1300 KYNO CA, Fresno: KYNO TO CHANGE FREQUENCIES ... from the Fresno Bee

Fresno news/talk radio station KYNO (AM 1300) and Spanish-language religious station KWRU (AM 940) will swap frequencies but retain their programming formats in a deal taking effect April 1.The deal, announced Monday by KYNO co-owner John Ostlund, includes the 50,000-watt transmitters that will extend his station's signal as far as Sacramento, Bakersfield and the central coast. KYNO will move to 940 AM, while KWRU will move to 1300 AM. The deal, in the works for four to five months, is pending approval from the Federal Communications Commission. (DP-HI)

Three local radio stations have been sold and format changes are planned by the new owner, Bold Gold Media. The company acquired WCDL-AM, WNAK-AM, and WLNP-FM from WS2K Radio LLC for an undisclosed price, said Vince Benedetto, president of Bold Gold. "We bought those stations yesterday and officially closed on them," Benedetto said Tuesday. A message left with WS2K was not returned. The sale had been in the works for months. (DP-HI)

#### 1530 WCKY OH, Cincinnati FROM: Business Courier 2/12/10

Clear Channel Communications will switch ESPN Sports programming to WCKY-AM from WSAI-FM beginning Feb 15, the radio station chain said Friday. WCKY, which is branded as 1530 Homer: The Sports Animal, will carry all ESPN programming. That includes the "Mike and Mike Morning Show," which will be simulcast on both stations Feb. 15, from 6 am to 10 am, then switch over to WCKY, according to a news release. With the move, WCKY will continue as the flagship station for the Cincinnati Bengals and also will air relaxe. We work Series, NBA games and playoffs, and University of Kentucky and University of Louisville football and basketball games. WCKY's Web site, **1530homer.com**, will be relaunched as **homer247.com**. WSAI will be rebranded as Fox Sports1360, with full-time Fox Sports programming and on-air personalities like Jim Rome and Tony Bruno, according to the release. Clear Channel said it is switching the programming because WCKY has the eastern U.S. WSAI, which also dates to the 1920s, broadcasts at 5,000 watts and can be heard across the eastern U.S. WSAI, which also dates to the 1920s, broadcasts at 5,000 watts. San Antonio-based Clear Channel operates six radio stations in Greater Cincinnati, including WEBN-FM and WLW-AM. (DP-HI)

#### 590 WROW NY Albany

Talk is out, tunes are in at WROW – Times Union – Albany NY. The abrupt format change at 590 AM ended a 16-year run of news and information programming on the station owned by Albany Broadcasting Co. And it left the Capital Region with two remaining news talk stations: WGY (810 AM) and WGDJ (1300 AM). "There's a lot of competition in the news-talk format," said Chuck Benfer, general manager at Latham-based Albany Broadcasting. "Other stations are doing a good job with it, so we decided to move in another direction." On Monday, Albany Broadcasting began simulcasting its light-rock station Magic FM (100.9 FM) at the WROW frequency. Benfer said it would continue to do so for a few months before broadcasting the music only on the AM dial and launching a new (and undisclosed for now) format at 100.9 FM. WROW has faltered since the 2007 departure of host Paul Vandenburgh, who left to launch WGDJ. The station has since struggled in the ratings and has had a revolving door of local hosts, including Mark Williams, Scott Allen Miller and Sherman Baldwin. (DP-HI)

#### 1500 KSTP-AM going to all-sports talk, joining ESPN, Pioneer Press.com 2/11

There's a shakeup going on at talk station KSTP-AM 1500. On Monday, the Hubbard-owned station is changing to AM1500 The Sportstalk Station. But that name's only temporary. The station has entered into a partnership with ESPN Radio and will eventually take on the title of 1500 ESPN Twin Cities. A date for that change has yet to be announced because ESPN Radio currently has a contract with the Clear Channel-owned station KFAN (1130 AM) that could last up to 60 days. Starting Monday, listeners will hear ESPN radio's Colin Cowherd from 9 am to noon. Current morning show host Patrick Reusse will take over the noon to 2 pm timeslot and then join Pioneer Press columnist and KSTP host Joe Soucheray from 2 to 4 pm. Soucheray's "Garage Logic" will then be heard from 4 to 6 pm. In the short term, Joe Anderson and Scott Korzenowski will host the morning show, and once the ESPN moniker is in place, Anderson will move back to the 6 pm slot and the station will air ESPNs" Mike and Mike" show in the morning. Twins baseball will still be heard on the station, as well. After struggling in the ratings, it was time for a change at AM 1500, said Dan Seeman, a vice president at Hubbard who helped make the switch happen. (DP-HI)

George Noory says his popular "Coast to Coast" overnight radio show will be back on a **New York** station shortly. "Coast" was dropped by WABC (770 AM) two weeks ago for the **Doug McIntyre** show, which WABC program director **Laurie Cantillo** called "a better fit" in discussing the kinds of current and political topics dealt with by other WABC hosts. Noory said he was disappointed over the cancellation, but encouraged at the "overwhelming" support from New York listeners who see "Coast" as an alternative to almost everything else on the radio. "I've gotten thousands of e-mails," he said. He also said he has been contacted by other city stations and expects a new deal will be worked out soon. "Coast to Coast" is heard by about 3 million listeners, noted Noory. With 527 affiliates including KFI in **Los Angeles**, he has more stations than any host, except Rush Limbaugh. (DP-HI)

Glenn Beck, Sean Hannity on WXKS-AM lineup. By Jessica Heslam/Media Biz Thursday, February 18, 2010 – MediaBiz has the 411 on the lineup of Boston's new conservative talk radio station. Glenn Beck will be heard from 9 am to noon weekdays and Sean Hannity from 3 to 6 pm when WXKS-AM (1200) officially debuts as a conservative talker April 1. WXKS program director Bill George said his station's morning-drive show will be local, but he wouldn't divulge more details. George was also mum on Rush Limbaugh. The station's owner, Clear Channel, is in talks with its syndicator, Premiere Radio Networks, to pluck Limbaugh from rival station WRKO-AM (680). WXKS is already airing the paranormal program "Coast to Coast" from midnight to 5 am, a show that used to air on WRKO. "The Jason Lewis Show" will be on from 6 to 9 pm,

George said. Meanwhile, over at WRKO, yesterday's all-staff meeting with Entercom honcho David Field was canceled, but he did come meet with some sales staff, according to employees. (DP-HI)

#### Radio Jobs Lost in Transition Sault Ste, Marie Evening News 02/10

A half-dozen people are now out of work following Tuesday's announcement that Sovereign Communications has purchased the Upper Peninsula radio stations including WYSS-FM, WMKD-FM, and WKNW-AM formerly owned by Northern Star Broadcasting. The list includes Station Manager Doug Laprade. Program Director Paul "Junior" VanWagoner. News Director Scott Nason and Disc Jockeys Jason Mapes and Melissa Krahnke. VanWagoner was willing to go on record with an account of how more than a dozen local employees lost their jobs in the transition. "Northern Star Broadcasting laid the entire staff off at 10:15, yesterday," said VanWagoner effective 5 pm Tuesday. President Bill Gleich of Sovereign Communications said the purchase of Northern Star Broadcasting was strictly for its physical assets and not for personnel. As a result, those employees were all informed they were being laid-off by their employer before the transition was made. Gleich said that 10 of those people were subsequently rehired including Program Director Tim Ellis, Jessie Sims, John Gilbert and Frank Blissett. "We're not happy they lost their jobs," said Gleich, noting these folks were released by Northern Star Broadcasting and weren't rehired because there are not as many jobs available, because staff is already in place. "I wish we could have hired them all." Gleich went on to add that he had no such resources in the central and western end of the Upper Peninsula. "Everyone in Marquette has kept their job; everyone in Iron Mountain has kept their job," he explained. "We don't have people in place."LSSU Director of Athletics Kris Dunbar said Sovereign will likely continue Northern Star's contracts to broadcast Laker hockey and basketball, and the two sides are meeting Thursday to work out the logistics. NSB signed a two-year contract with LSSU last summer to broadcast the sports, breaking Sovereign's long-time run as broadcaster of LSSU athletics. Whether LSSU sports will continue to be broadcast on WYSS-FM and KNOW-AM, or be moved back to WSUE-FM and WSOO-AM is one of the details yet to be worked out between the sides. Gleich said that one decision has been made regarding the addition of a popular announcer who had been silenced when Northern Star Broadcasting took over university broadcasts. "What we have done is decided that Bill Crawford should be 'The Voice of Laker Hockey'," said Gleich, adding the 28-year-Laker broadcasting veteran will return to the booth for this weekend's games against Ferris. (DP-HI)

Cumulus Broadcasting of Poughkeepsie has announced the launch of the Hudson Valley True Oldies Channel. It can be found at 1340 AM WALL in Orange County and 1390 AM WEOK in Dutchess County. The channel will primarily broadcast songs from 1964-79, but will also air songs from 1955-63. All Army sports will be broadcast on WALL and WEOK. The channels recently hosted Radio Disney, but Cumulus Hudson Valley dropped that station. (DP-HI)

## 1420 KSTN Stockton, CA FROM: RECORDNET.COM

The last chords of Queen's "Another One Bites the Dust" were still resounding on KSTN 1420 at 6:14 pm Friday when chief engineer Paul Shinn and program director John Hampton took the microphone, saying they had an announcement: "Something I never thought would happen," Shinn said. "KSTN will be signing off the air tonight." Hampton recalled how he'd spent nearly 30 years at the station. "If I'm leaving now, half of me is gone." They briefly told the listening audience that KSTN broadcast its signal on the oldest transmitter in the country still on the air every day, then introduced the final tune: the opening theme song to "WKRP in Cincinnati." KSTN, Stockton's first music radio station, had broadcast for more than 60 years at 1420 on the AM dial. Its sister station, KSTN FM 107.3 FM, will remain on the air but will drop its regional Mexican music format and switch to a satellite feed of K-LOVE contemporary Christian music sometime Monday. As a result, the company will terminate about 20 employees, all on-air personalities and related staffers, said Robert La Rue, the station's president. He declined to go into the reasons behind the drastic changes, just saying it was a decision by the board of directors of San Joaquin Broadcasting, which owns the station. La Rue left open the possibility that KSTN might resume broadcasting on the AM frequency in the future."It doesn't mean it goes away forever. It could come back as something else, but nothing's been decided right now," he said. (DP-HI)

#### 1480 - KLMS Lincoln NE FROM: JournalStar.com

Three Eagles Communications confirmed Thursday that ESPN 1480 will return by March 8, maybe sooner. The Lincoln-based company had dropped sports talk in favor of oldies music at the radio station (KLMS 1480 AM) during the last week in January. "We listened to the public," Three Eagles general manager Joy Patten said. "We decided to make that decision." KLMS had been a sports talk station – Lincoln's only one – since 1997 and an ESPN affiliate since 2000. Patten said Three Eagles made the switch to music for financial reasons. But since the change, several listeners have called and e-mailed Three Eagles to express their disappointment, Patten said. "Which was good," she said. "We want to hear from the community. We are a locally oriented company." The KLMS lineup will be the same as before, including Jim Rome, who is not an ESPN personality. His show is syndicated by Premiere Radio Networks. The station also will continue to carry Lincoln Stars hockey and Kansas City Royals baseball. Patten said there will be no live, local show, but the station is open to producing another one. Its previous live show featured former Nebraska football player Jason Peter. "We're going to work on that," she said. (DP-HI)

The long-dark KUPA-AM 1370 will spring back to life March 15 with **Fox Sports Radio** programming from the mainland. To be branded Fox Sports Radio 1370, its weekday lineup will include the "Jim Rome Show" from 6 to 9 am, the "Dan Patrick Show" from 9 am to noon (a rebroadcast of the original 3-6 am airing), "Myers & Hartman" from noon to 1 pm, "Petros & Money" from 1 to 4 pm, "Tony Bruno" from 4 to 7 pm, "JT "The Brick" from 7 pm to midnight and the "Stephen A. Smith Show" from midnight to 3 am. KUPA also will air Fox Sports Radio's entire weekend lineup." KUPA is licensed to Broadcasting Corporation of America, owned by Utah-based Nupeto Associates LLC, led by Neuman C. Petty and several family members.

Malievsky got the station a long-term lease for a tower site in Mililani at the behest of the owners, who have now retained him to serve as general manager. The station went on the air with Fox Sports Radio about three years ago under then-operator Nathan Drage, but after a few months it lost its affiliation, its transmitter site and its ability to be on the air — and has been off the air since, with repeated requests to the FCC to remain dark. KUPA has not had a consistent on-air presence since Utah-based Diamond Broadcasting Corp. bought what was then KIFO-AM 1380 from Hawaii Public Radio in 2002. Its frequency changed shortly thereafter. Broker becomes buyer of Medford AMNoncommercial religious outfit Radio Cantico Nuevo brokers time on two Multicultural Radio Broadcasting stations, one in Newark NJ and the other in Medford NY – and it now has a contract to buy the latter. RCNI, under the leadership of Erick K. Salgudo, will pay \$150K, most of it via promissory note, for the Medford's 1440 WNYG-AM, which is considered to be part of the Nasau-Sulfolk NY Arbitron market. Since Nassau-Sulfolk is embedded into the New York City market, which includes Newark, RCNI will have de facto AM duopoly with Multucultural's 1430 WNSW-AM. The contract filed with the FCC included time brokerage charts for both stations. RCNI will pay \$2K/month plus expenses for fulltime use of WNYG. It has WNSW from midnight to 6AM seven nights a week, a total of 42 hours, for \$25 an hour (\$1,050/week). It has the station Sunday from 2PM-midnight, and M-F from 8PM-10PM, a total of 20 hours, at \$125/hour (\$2,500). Finally, it has the station Saturday 6AM-midnight, Sunday 6AM-noon and M-F 6AM-8PM for 94 total hours at \$250/hour (\$23,500/week). Add it all up, and RCNI brokers substantially all the time on the station for \$27,500 weekly. (DP-HI)

# WESTERN HEMISPHERE

**ARGENTINA:** 1650 LRI-227 Antares AM 1650 "La Radio de la Familia" inaugurated their new broadcast studios in Dec 2009. They are located at Calle Cjal. Manuel Martitegui 598, Fátima, Pilar, Buenos Aires. Telephone (02322) 49-9899. The station is operated by Radio Familia S.A. with Señor Norberto Eugenio Chindemi as its CEO. The station transmits with 1/0.5 kW of power and is fully licensed. (Marcelo A. Cornachioni, Lomas de Zamora and Arnaldo Slaen via Christer Brunström/ARC)

**COLOMBIA:** 1140 HJDL Radio Paisa, "Ia Cariñosa de Medellín" has moved to Edificio Coltejer in downtown Medellín. Online I found the name of the station manager. I passed the info on to Arnstein Bue, of Norway, who received a swift reply. It is believed that all RCN outlets in Medellín are operating from this skyscraper, which is kind of a "landmark" in Medellín. 1300 HJRB, according to online info, the name of the Tunja station is CRB, Cadena Radial Boyacense. 1390 HJZY Per online info, the name of the Bucaramanga station is La Primera. 1580 HJQT is now relaying "Candela" which is a popular FM outlet. The owner, William Vinasco Ch., has been leasing the channel to Radio Mar and then to Sonríele a Jesús Radio, but they have now left the frequency. The latter organization is instead heard at various times of the day and night on 1400 Emisora Mariana and 1430 AM 14-30 (ex-Emisora Kennedy). Vinasco also owns 1160 Ecos de Colombia, which has been leased to IPDA, Iglesia Pentecostal Dios es Amor. They offer independent programming but also, on occasions, relays from Radio Victoria, in Lima, Peru, and Radio Universo, São Bernardo do Campo, Brazil. (Yes, in Portuguese!). HAITI: January 20th, 2010-17:41 UTC by Andy Sennitt http://blogs.rnw.nl/medianetwork/us-military-delivers-radios-to-haiti-quake-survivors The US military is delivering 50,000 hand-held

radios to Haiti for survivors of the recent earthquakes. The US Department of Defense said today it expects the radios to arrive later this week. It said the joint task force will then distribute the radios to the public. The military said survivors can use the radios to receive news and important information concerning international relief efforts. It also says its forces are working closely with the Haitian government to broadcast public safety messages for survivors on FM frequencies of 92.4 MHz and 104.1 MHz and the AM radio frequency of 1030 kHz. The radios are powered by solar energy and hand cranks instead of batteries, a potentially helpful asset in a nation short on basic supplies. (Voice of America via RN Media Network weblog)

**TURKS & CAICOS:** 530 Radio Visión Cristiana, North End, So Caicos – remains the big oven element, running good power into the long wire 30 feet off the ground. Talk of the new tower construction is yet to materialize. 1020 Caribbean Christian Radio, Grand Turk – nothing new with 1020. (Jerry Kiefer 29.1.2010 DXLD via Arctic)

**VENEZUELA:** 740 YVNC CNB 7-4-0, "La Zuliana" seems to be the name of the station in Maracaibo according to online info and Max van Arnhem, who has been listening from Curaçao. 820 YVXG Radio Guadalupana is off the air says van Arnhem. 1020 YVMX The Maracaibo station is announcing Radio Calendario, not Radio Continente, van Arnhem reports in MWN. Also heard in Sweden on Dec. 25 by Fredrik Dourén. 1470 YVJW is no longer called Llanerísima according to van Arnhem and online info and actual listening but rather CNB 14-70, "La Valenciana". In the mid-80, this station was known as Radio Latina, and in their canned ID's they did not fail to mention their call letters, YVJW. With their new slogan, Latinísima and, later, Llanerísima the call sign is no longer heard. The omission of the station's call sign seems to be deliberate on many Venezuelans. (Klemetz, ARC)

# ASIA AND PACIFIC

**AUSTRALIA**: 3MP 1377 Melbourne is set to change to a talk format AND a name change (I suspect will be probably just be its on air ID as opposed to an official call sign change). Details here: http://www.radioinfo.com.au/. (Geoff Wolfe, mwoz 11 Feb)

I am hearing the new MW outlet in Canberra on 1323. Currently under test transmission. Playing C&W music w/pre-recorded announcements about the test. Gives ph No & postal address. (Geoff Wolfe, mwdx 1 Feb)

1611 The Goanna. I believe from a month of monitoring over Xmas and New Year that the Sydney transmitter is now off air. The station website doesn't reflect this, but has never been right since the station was started. I do hear the ads for the Tamworth area, so I am assuming that I am now just hearing the Tamworth station at usually a poor to fair level each night from around 0900. (Wright, ARDXC Jan 2010)

620 Rete Italia now believed to be the Toowoomba/Warrick area station In Italian. Good signal into the Sunshine coast Warana. Around 0100 20/12. Shows 400 watts. (Thwaites, ARDXC)

*CHINA:* Hubei PBS News & General Sce. is using 1566 kHz with 10 kW from Jingmen in addition to 774 and 1404 kHz. Liaoyang PBS. Traffic and Arts Sce. operates also on 1503 kHz in addition to FM. Web: **www.lyradio.com/jtwy**. Yanbian PBS Chinese Sce. is heard on 1566kHz and Korean Sce. on 1188 kHz. (WRTH Update 19 Feb 2010) (The Yanbian items are interesting, since the freqs are occupied by FEBC transmitters on 1566 & 1188 bp)

**INDIA:** All India Radio (AIR) has placed an order for the supply of two 1000 kilowatt DRM capable medium wave transmitters. These will replace old analogue transmitters of same capacity at Chinsurah (West Bengal) and Rajkot (Gujarat), with state-of-the-art solid state transmitters. The new Megawatt transmitters can be operated in analogue, in simulcast or in DRM mode with automatic change-over between these three operational modes. The transmitters shall provide coverage to very large areas in the Indian sub-continent as well to the West, North, East and Southeast Asia.

This significant purchase was revealed at the recently concluded Broadcast Engineering Society (BES) India's conference in New Delhi, attended by exhibitors and participants from all over the world. The need for cheaper digital radio sets and content innovation was highlighted by speakers during the event. All India Radio has already chosen DRM as the technology for converting its vast analogue network to digital. This is part of its digital radio switchover strategy where more than 40 transmitters are to be made DRM capable in the near future. AIR is already broadcasting in DRM from one of its high-power shortwave transmitter located at Khampur near Delhi that covers an area of approximately 800 kilometer radius. The DRM Consortium says the development underlines the commitment made by India to new technology in general and the DRM standard in particular. Last year I visited the SW & MW transmitters of AIR Panaji. Then I was told that they were changing their Vividh Bharati 20 kW transmitter from 1539 to 828 due to co channel interference from Voice of America. In Nov 2009 I heard them on 828 and reported to them. Recently I got an email reply from the Station Engineer that they were on low power at that time and that now they are on full power. They are interested in reception reports of this transmitter. Reception Reports may be sent to Mr.V.N.Page, Station Engineer, AIR Panaji at **panaji.spt@air.org.in**. By the way it is heard only very faintly at my location and there is co channel interference from Radio Pakistan. Incidentally the SW transmissions from AIR Panaji are not fully operational now. (Jose Jacob, dx\_india, 2 Feb)

**MYANMAR:** Myanmar noted today on new 693 kHz MW at around 2300 UTC. It's a bad choice as its neighbor Bangladesh is also operating on same channel with 1000 kW. Maybe it's to jam their signals? (Jose Jacob via dxld (27/2-2010) via **mediumwave.info**)

**SOLOMON ISLANDS:** In a letter to the Solomon Star, Cornelius Rathamana, General Manager of the Solomon Islands Broadcasting Corporation (SIBC) says that the BBC radio relay on the National AM service after midnight has had to be switched off. The people of the Solomon Islands have been receiving BBC World Service relays from the SIBC National Service since the beginning of this millennium from 11 PM to 6 AM local time next demur Rathamana says that due to high cost of electricity, SIBC will no longer be supporting the relay as it will have to shut down its transmitters as soon as the national broadcast finishes at 11 PM. He adds that SIBC has taken this decision with full understanding that the growing BBC audience in the Solomon Islands will be deprived of this service when it is switched off. However, Mr. Rathamana says that SIBC can restore the relay if the electricity is estimated at SBD\$90,000.00 (US\$11,471). (Solomon Star via RN media network weblog)
