Journal Broadcast Group is changing its KFTI-AM from a classic country format to oldies music. The conversion to True Oldies 1070 AM was effective at 12:30 p.m. Thursday. The station will operate under the call letters KLIO-AM. Journal Broadcast says the change was based on the large number of oldies music fans in the Wichita area. "There is a gap in the Wichita market that needs to be filled," said Eric McCart, Journal Broadcast Group-Wichita's vice president and general manager, in a statement. True Oldies 1070 AM will play oldies music from the 1960s, 1970s, and early 1980s. "A lot of the songs listeners will hear on True Oldies 1070 AM originally aired on AM radio, and we want to bring those favorites back for them where it all started," McCart said. Regular features will include the True Oldies Daily Countdown, the top five hits from a different year every day; the Rock & Roll Calendar, a quick look back at music history and the events of each day; and sets of One-Hit Wonders, Forgotten 45s and Cruising Classics. True Oldies 1070 AM remains part of the six-station radio cluster in Wichita owned by Journal Broadcast Group. The other five stations are: Today's KFDI-FM 101.3, Classic Country 92.3 (KFTI-FM), 104.5 The Fox (KFXJ), T-95 (KICT) and Radio Lobo 106.5 (KYQQ).

Action by: Norfolk Office, In this Notice of Apparent Liability for Forfeiture ("NAL"), we find that Hubbard's Advertising Agency, Inc., ("Hubbard"), licensee of station WLLL(AM), in Lynchburg, Virginia, apparently willfully and repeatedly violated Sections 11.35(a), 73.1745(a) and 73.3526 of the Commission's Rules ("Rules")1 by failing to maintain operational Emergency Alert System ("EAS") equipment, exceeding its licensed nighttime operating power, and failing to maintain and make available a public inspection file. We conclude, pursuant to Section 503(b) of the Communications Act of 1934, as amended ("Act"), 2 that Hubbard is apparently liable for forfeiture in the amount of twenty-two thousand dollars (\$22,000).

WPID 1280 PIEDMONT, AL: Monetary forfeiture in the amount of 1,100 to Piedmont Radio Co., licensee of Station WPID(AM), Piedmont, Alabama, for willfully violating Section 73.3539 of the Commission's Rules and willfully and repeatedly violating Section 301 of the Communications Act of 1934, as amended by failing to timely file its license renewal application and engaging in unauthorized operation of the Station. On February 27, 2007, the Bureau issued a Notice of Apparent Liability for Forfeiture to Licensee in the amount of seven thousand dollars for these violations. As noted in the NAL, Licensee's renewal application for the current license term should have been filed on December 1, 2003, four months prior to the April 1, 2004, expiration date, but was not. In fact, Licensee did not file the renewal application until April 7, 2005. On February 27, 2007, the staff advised Licensee of its apparent liability for a forfeiture of \$7,000 for failure to timely file the Station's renewal application and for unauthorized operation. Licensee filed a Petition for reconsideration on March 30, 2007. In its Response, Licensee claims that it attempted to file the application in early December 2003 and maintains that the application was not received by the Commission. Licensee indicates that it believed the filing had been successfully completed and is "unsure why" its uploaded materials were not submitted to the Commission. It also argues that paying the forfeiture would cause it financial hardship and could cause it to reduce programming or to close the Station.

From: The State Journal, Frankfort, KY: A memorial service for Bob Doll - a longtime community-minded radio broadcasting executive who recruited popular DJ Russ Hatter to Frankfort in 1965 - will be scheduled later. Doll died Wednesday of an illness at Texsan Heart Hospital in San Antonio. He was 77. Hatter, now a noted Frankfort historian and assistant curator at Capital City Museum, said Friday he worked with Doll at WKFY-AM and WKYW-FM about 10 years. "Almost everything I knew about radio came from him," Hatter said. Known as a small market radio guru, Doll "was really good at looking out for the common people, the little guy," Hatter said. "If you lost your wallet, he'd try to find it for you. I learned from him that radio is about people. If you're talking to them, you can make them mad like Rush Limbaugh, or you can help them and pull them together." Hatter said he became manager of the local radio station when Doll left. A resident of Seguin, Texas when he died, Doll had been connected to AM radio broadcasting for 59 years, working as a DJ, manager, co-owner, group owner and sole owner. Besides Kentucky, he operated in Indiana, Ohio, Michigan and Illinois. He was the author and publisher of three books on radio as well as a radio textbook. Hatter said Doll was "very interested in politics" and innovative in local election coverage. He created a governors' inauguration network to help small radio stations throughout the state broadcast the event, and a sports network. Doll would let his employees experiment with new ideas, Hatter said. "He trusted you as long as there was reason to do so," Hatter said. "He was smart, a common sense guy and fun to work with." Hatter was working as a morning announcer at WGOH in Grayson when Doll became interested in hiring him. "Bob's mother-in-law lived in Ashland and as he traveled on occasion from Frankfort to Ashland he heard my work," Hatter said. A year after Doll offered him a job, "I got comfortable enough to leave my rural setting and come to the bright lights of Frankfort," Hatter said. Like in "It's a Wonderful Life," the Christmas movie classic, "Bob's footprints are all over my life," Hatter said. "You see what one person can do. "I wouldn't have children, grandchildren, my wife, and I wouldn't be working at the museum. He brought me here. Everything that's happened to me since June 1965. Bob has played a part in because he opened that door." Former state Rep. Hank Hancock, of Frankfort, said, "Bob was a unique individual. He amazed me with his knowledge and tenacity for the real thing. "He did a lot of personal interviews, and you better know what you were talking about when you answered his questions." Doll willed his body to science and memorial services will be held later.

FROM: The Washington Post: The owner of WAGE (1200 AM) radio is pledging to deliver local content on the station and said new towers approved by the county last week could begin beaming a signal by October. The Loudoun County Board of Supervisors, in a 7 to 2 vote Wednesday, approved a plan by station owner James Weitzman to build three radio towers near Loudoun County and Russell Branch parkways in the Ashburn area. The station signed off in August after suffering heavy advertising losses. "We are determined to have Loudoun news, Loudoun weather and programs that address problems, needs and interests of the Loudoun County community," Weitzman said in an interview after the vote. Weitzman, president of Falls Church-based Potomac Radio, which owns the station, also promised to devote airtime to event and fundraising announcements for area nonprofit groups. The radio towers would boost the station's power level to 50,000 watts in the day, allowing the signal to reach across county lines and penetrate other parts of the Washington area. Before the station signed off, its wattage was 5,000 during the day. Supervisor Kelly Burk (D-Leesburg) and county planners opposed the location of the radio towers because it is in a flood plain. Burk, who with Supervisor Sarah R. "Sally" Kurtz (D-Catoctin) voted against the plan, also raised concerns about potential damage the towers might have on wildlife and water quality, as well as the station's plans for programming. "It's not going to be a local radio station," Burk said. "It's too big. There is too much money being invested in it." Supervisor Lori L. Waters (R-Broad Run) supported the plan. "If this goes away, we will not be able to get it back," Waters said. "For those reasons, (allowing construction) outweighs concerns over land use." WAGE was a Loudoun fixture, beginning in 1958 on frequency 1290 AM. For decades, it offered losses piled up. Weitzman said construction of the towers could begin in August. The towers could begin transmitting a radio signal by Oct. 1, he sa

FORT MOHAVE: A devastating fire at a Fort Mohave broadcast facility has temporarily silenced several Tristate radio stations. The building housed the studios and offices of Cameron Broadcasting. "All six stations were burned to the ground. It's a total loss," said Craig Powers, Cameron Broadcasting vice president for operations. The early Wednesday morning blaze affected K-Flag (95.9 FM), The Knack (107.1 FM), Lucky 98FM (97.9 FM), KZZZ (1490 AM), K-Star (1000 AM) and Kingman station KAAA (1230 AM). When news of the fire spread, Cameron's Mohave County competitors pulled together to offer assistance. "I can't tell you, when a radio station burns down, how bad it really is," said Chris Rolando, Mad Dog Wireless president and CEO, from his Lake Havasu City office. "There's a lot that goes into these things, between the computers, the computer records, all the different things," Rolando said. "Our company, along with Steve Greeley, who owns K-Triple J and KNTR, have already sent messages that we stand by to give them room in our buildings, any spare equipment we have, copiers, desks, tables, I mean anything we can donate to get them back on." "Its devastating to the community to lose that many (radio stations) all at once," said Dave Hayes, KTOX general manager. "It was shocking for me to hear about it," Hayes said. He said he couldn't imagine how he'd feel if it happened to him. "Anything Cameron needs, we're there for them." "Industry-wide, there's compassion and sympathy for a colleague in our industry," said Dave Hawkins, news director of KGMN, based in Kingman. "I couldn't imagine the challenge with elevating a radio station operation from rubble to get through all the engineering (and) technological challenges and get back on the air," Hawkins said. "We wish them good luck." Bruce Clark, tv2 general manager, offered the use of his facility for KAAA/KZZZ morning program "The Sheler Show." From THE WASHINGTON POST: GALVESTON, TEX: Cruise southeast out of Houston, past the NASA exits and toward the Gulf of Mexico, and you pick up something a little incongruous on the radio, amid country crooners, Rush Limbaugh, hip-hop and all the freewheeling clamor of the American airwaves. "China Radio International," a voice intones. "This is Beyond Beijing." Way, way beyond Beijing. Sandwiched between a Spanish Christian network and a local sports station, broadcasting at 1540 on your AM dial, is KGBC of Galveston, wholly American-owned and -operated, but with content provided exclusively by a mammoth, state-owned broadcaster from the People's Republic of China. Call it KPRC. Or as the locals quip: Keep Galveston Broadcasting Chinese. The little Texas station may be modest, but it is part of a multibillion-dollar effort by the Chinese government to expand its influence around the world. As China rises as a global force, its leaders think that their country is routinely mischaracterized and misunderstood and that China needs to spread its point of view on everything from economics to art to counter the influence of the West. Beijing's new response is typically massive and ambitious: a \$6.6 billion global strategy to create media giants that will challenge agenda-setting Western behemoths such as Rupert Murdoch's News Corp., the BBC and CNN. At a time when the Western media are contracting, China is pushing its government-run news services to expand from America to Zimbabwe. The Chinese are creating TV networks, pouring millions into English-language newspapers, leasing radio stations on all continents and broadcasting TV news to a worldwide audience in six languages. The stations don't broadcast outright propaganda, but rather programming with a Chinese focus and flavor, tailored for local audiences. In Galveston, the format mixes China-centric international news, talk shows about the status of China's women and a healthy dose of gangsta rap — all in English.

WKTR-840 Earlysville, VA from: DAILY PRGRESS.COM: Central Virginia radio listeners can soon swap sports for religion. WKTR-AM 840 — the Greene County-based, ESPN-affiliated AM radio station that covers local sports, as well — will go off the air June 30, to be replaced by a religious format, station officials confirmed. "Our parent company got an offer for the radio station that they just couldn't refuse, so they agreed to lease out the signal and facilities," said Mike Tingle, general manager of WKTR-AM, known locally as ESPN 840. "It is my understanding that the format will be changed to a religious format." ESPN 840's parent company, Base Communications, owns and operates the Sports Addict Network that includes ESPN-affiliates in Blacksburg and Martinsville. Company officials could not be reached for comment regarding financial considerations or the organization that would take over programming.

Rick, to answer your question about 1560 in Toledo, WTOD left the air at 1pm on 4/23/10, there was a 6 day silence until 7:45am on 4/29/10 when the signal was returned to the air. The 1560 calls are now WWYC. The station was sold by Cumulus to the Calvary Satellite Network and its license was transferred from commercial to non-commercial. Thus ended a 64 year radio legend and heritage station, the whole thing is sad since a monetary investment into infrastructure could have restored ex-WTOD's signal to its once proud self. Alas, Cumulus is so cash strapped that they could not afford to make those refinements and saw selling off WTOD as a more logical choice. Of course it seems the religious broadcasters are the real money stakeholders these days and are the ones able to buy up floundering AM stations just as EMF did with our 1520 and Swaggert Ministries did with our 730 or Crawford has done with both 1340 and 560 in the Detroit market as examples. We may not like this but such is the nature of the beast these days. Similarly I'm saddened by the state of our own club, IRCA. What exactly is the EIC's job? Does it merely entail being the guy who receives all bulletin input from various sources, assembles it into pages for publication and forwards those pages to our club publisher or is there even more to it? Hope this answer your questions about 1560 in Toledo, rce. 73s, Gary (P.S.-I pleaded with Cumulus's Marketing Directors 7 years ago to place a standards format on WTÓD which was abandoned by WCWA back in 2002. We had over 5000 signatures on petitions to make the case but alas to no avail. I thought had Cumulus taken this up WTOD could have been a very successful station and would have continued on as a key force in Toledo, but a \$1 million price tag to upgrade decrepit station facilities was too much for them to go forward-truly sad.)

By the time you read this, Classical music radio in St Louis will be a thing of the past. The Lutheran Church-Missouri Synod has sold KFUO-FM 99.1 Clayton, MO to Gateway Creative Broadcasting, which owns KPVR 94.1 Bowling Green, MO and KHZR 97.7 Potosi, MO. The Contemporary Christian format that is now on 94.1 and 97.7 will move to 99.1, where it will continue to be known as "Joy FM". St. Louis joins markets like Los Angeles, Philadelphia and Atlanta that have lost full-time Classical music stations (not counting low-quality "HD" signals). Classical music fans are scrambling to find a replacement signal; many don't want the format to end up on an AM station, like Kansas City's KXTR 1660. The two remaining all-sports AM radio stations will be under one roof shortly; the local ownership of KFNS 590 is buying KSLG 1380 from Simmons Communications of Salt Lake City. In recent months, KSLG has been running R&B Oldies on Friday and Saturday nights. Simmons sold WESL 1490 East St. Louis, IL (which was once known as WFFX) to Insane Broadcasting Company earlier this year, and converted it to Adult Standards WQQX. Sister station WQQW 1510 Highland, IL is being used as a back-up for KQQZ 1190 and WQQX 1490 in recent months. I was surprised to read that KZQZ 1430 has applied for a daytime power increase to 50 kW; I thought their 5 kW signal is sufficient to cover the metro area. Their 5 kW night signal has gotten stronger in recent months. KHOJ 1460 St. Charles, MO is now dominant at night; it sounds like their nighttime power increase is now on from their Boschertown transmitter site. I don't think the four-tower nighttime array in Hazelwood (north of Missouri 370 and Earth City Expressway) is being used by Covenant Network. WGNU 920 Granite City, IL is now broadcasting mainly talk and R&B Oldies on weekdays, continuing to be brokered Christian programming on the weekends. It's a far cry from the mix of talk, Adult Standards and brokered programming that symbolized the Chuck Normán era. One of the local minor league teams in St. Louis, the Gateway Grizzlies, have moved to KFNS 590 after two seasons on

WSIE 88.7, where I was a studio engineer for selected games until budget cuts forced me to leave the station (and the radio industry) last year. With my connections lacking above the middle levels of the industry hierarchy, I'm not going to pursue another opportunity in broadcasting other than maybe running an LPFM (and that's a big "if"). In reading Gary Siegel's Forum on the end of WTOD 1560, it shows that the radio industry doesn't care about the listeners, the people who work in the industry, and those who have struggled for years to get into the higher echelons of the radio industry. The current models for broadcasting have failed miserably, and have resulted in thousands of unnecessary job and career losses. The commercial broadcast industry sorely needs to be reregulated. The whole idea of a single owner owning up to eight radio stations covering an entire market instead of serving its city of license and surrounding areas, and cutting jobs at the same time, is absolutely absurd. The idea of trying to cover an entire metro area with a 100-watt FM or an AM station operating with as little as one watt at night is impractical. In the 22 years I was in broadcasting (minus time off to pursue other endeavors), I experienced discrimination on the basis of local origin more than anything else. When my QTH was along the Cobb-Cherokee County line in Georgia, I had faced prejudice because of the fact that I was born in the Midwest. The only stations I could work at there were a church-owned station and a college radio station that was unprofessionally run. In the St. Louis area, I had the misfortune of being labeled "homegrown talent". Many corporate radio stations were reluctant to hire me because I was born, raised and took my broadcast training in the St. Louis market. That's why I was restricted to working for single station owners, like Bob Howe (the former owner of WFUN-FM 95.5 and former co-owner of WRYT 1080) and the late Chuck Norman. The product that is being presented on commercial radio, and increasingly on public radio, is unlistenable. Three years ago, I became a Sirius Satellite Radio subscriber, primarily to get BBC World Service, CBC Radio One and World Radio Network. XM didn't have WRN at the time. Now that Classical music is gone from St. Louis radio, I still can get it on satellite radio. One of the results of the Sirius-XM merger is that I can now get Easy Listening music; something that hasn't been available in St. Louis since KEZK 590 dropped the format in November 1992. Those who don't have satellite radio in St. Louis would have to drive to Gibson City, IL to hear the format on WGCY 106.3. Satellite radio does have better sound quality than "HD Radio" (I've heard it in a demonstration; "HD" on AM is worse than analog AM, and "HD" on FM is no better than analog FM), and coverage that is only beaten by one medium: shortwave radio. I have managed to pull in some new stations, though; WSBM 1340 Florence, AL was noted at 0136 EDT on June 23 with a station promo, "Fox Sports Radio for the Shoals" slogan and ads for Florence and nearby Muscle Shoals. WSBM is the 15th station I've noted on 1340, and the 50th station noted from Alabama since I started my current log in 1992. WMOX 1010 Meridian, MS was noted at 0305 EDT on June 23 with a station promo, ID mentioning the fact that this is Meridian's News/Talk station, into Coast-to-Coast AM with George Noory. I was able to get this one over CFRB with KXEN's 500-watt night signal nulled. Another new one noted was WCDT 1340 Winchester, TN, noted on June 24 at 2138 EDT with local ads, weather forecast and call letters. I was able to do this after replacing the nine-volt battery holder on the Space Magnet 2. I added HF capability to my Amateur Radio station in January 2010, and have gotten some decent results with an ICOM IC-745 and the MFJ-1778 G5RV I had been using for shortwave listening (I've built a 150-foot dipole for SWL to take the G5RV's place). I've also been DXing TV (especially digital TV) and FM this summer as well. As of June 25, 1122 AM stations have been heard at this QTH. 73.

THE WORLD OF ULTRALIGHT DXing

100603 – From the very beginning of the Ultralight Radio boom in late 2007, inexpensive pocket radios have been ideal experimental platforms for upgraded antennas, sharper IF filters and other such performance improvements.

Recently China's Tecsun Company introduced their new PL-360 AM-FM-SW-LW DSP receiver, a very small Ultralight radio with a vertical-form cabinet. Although the tiny stock loopstick will leave an AM-DXer seriously unimpressed, the PL-360 does have one unique feature which saves the day – a plug-in antenna jack, which offers ULR experimenters the rare chance to try out upgrade DXing antennas without any need to modify the radio itself.

Two recent PL-360 antenna breakthroughs have included John Washburn's inductive coupling of his 900' Beverage antenna to the PL-360 using the 3" ferrite stick from his C.Crane Twin Coil Ferrite system (also described in the DXer.Ca ULR file section at http://www.dxer.ca/file-area/cat_view/87-ultra-light-radio-files-area/97-ulr-antennas, and also at http://www.mediafire.com/?kw4zkwow23u. John was able to obtain an excellent inductive coupling match (avoiding any overloading issues), in a system which provides an ideal way to enjoy high-gain antenna DX on Ultralight radios.

In another experiment, the PL-360's mediocre stock antenna was replaced by an effective 7.5" plug-in loopstick, greatly boosting AM and LW sensitivity in the model. The design was used to create convenient plug-in loopsticks for many non-technical ULR-DXers to enjoy greatly increased weak-signal performance on the PL-360, without the need to perform any radio modification. This experimentation is described at http://www.mediafire.com/?yummxhqeyjy, and also in the Dxer.Ca ULR file section at http://www.dxer.ca/file-area/cat_view/87-ultra-light-radio-files-area/97-ulrantennas.

100612 – China's Tecsun Company is certainly to be commended for their breakthrough success in developing reasonably-priced pocket radios offering outstanding, DSP-enhanced AM and FM selectivity. Unfortunately, the stock AM sensitivity of these DSP models rarely allows a user to take full DXing advantage of this superb selectivity. Tecsun stock loopsticks are not famous for their AM weak-signal performance.

While the Tecsun PL-360 model is the latest example of this performance mismatch, it is a rather unique radio because of the plug-in loopstick design, offering DXers a quick and easy way to upgrade the AM antenna. While very thankful for the positive reviews of the 7.5" plug-in loopsticks, I should mention that it's really only one way to boost up the AM sensitivity of the PL-360 model, and that the other methods may be even more advantageous to DXers with certain priorities.

Inductive coupling from both active (amplified) and passive tuned loop systems will not only boost up the AM sensitivity of the PL-360 and other DSP models, but will provide an additional tuned circuit to augment the DSP selectivity of these radios. For those urban DXers troubled by multiple local pests, careful tuning with one of these external loops can allow reception of weak AM stations very close in frequency to local pests – something that a sensitivity – boosting 7.5" loopstick alone is unlikely to provide. Kevin Schanilec has posted excellent articles to the Ultralightdx file site describing the advantages of tuned passive loops, all of which can be used without any radio "surgery" to the Ultralight radio. Beside's Kevin's convenient Crate Loop design, tuned passive loops have been constructed all the way up to a 9' (side) size, described in the "PVC Loop" article posted at http://www.mediafir e.com/?igw1zjwfz mw.

Besides external tuned loops, a DXer can also use an inductive coupling system to connect a Beverage antenna to the PL-360 and other ULR's, as described in John Washburn's excellent article posted at http://www.mediafire.com/?kw4zkwow2 3u. A DXer without such a high-gain antenna can simply plug a long-wire into the PL-360 antenna jack, and probably gain a major AM sensitivity improvement over the stock loopstick in most situations.

In the case of the PL-360, the antenna plug-in jack is a boon to experimenters of all types, offering a quick and easy way to run A/B signal tests on antennas of all types. This more than compensates for the mediocre design of the stock loopstick, which has probably inspired more antenna experimentation than any loopstick in history:-)

100613 – Tim Chandler of Memphis, Tennessee has proven that DX does exist in the noisy static of June – by qualifying for the 100 Stations Heard Award in the Unlimited Class. Taking full advantage of his new 24" PVC tuned passive loop, Tim has managed to qualify for the very first ULR Award Certificate issued so far this month – giving Rob and I some desperately needed practice!

We congratulate Tim on his outstanding accomplishment, and wish him the best as the band conditions improve later this year. Anyone checking the conditions lately knows that they have only one way to go!
