Woonsocket, Rhode Island 02895 Station WOON(AM), Woonsocket, RI We have before us an October 29, 2007, Response to Notice of Apparent Liability for Forfeiture filed on behalf of O-N Radio, Inc., licensee of Station WOON(AM), Woonsocket, Rhode Island . The Response requests the cancellation of the October 17, 2007, Notice of Apparent Liability for Forfeiture in the amount of one thousand, five hundred dollars issued to Licensee for willfully violating Section 73.3539 of the Commission's Rules, for its failure to timely file a license renewal application. By this action, we cancel the NAL and admonish Licensee for filing the renewal application in paper format without demonstrating good cause. As noted in the NAL, Licensee's renewal application for the Station's current license term was due on December 1, 2005, four months prior to the April 1, 2006, license expiration date. The Licensee did not file the renewal application until March 27, 2006. On October 17, 2007, the staff advised Licensee of its apparent liability for a forfeiture of \$1,500 for its

failure to timely file a renewal application for the Station. Licensee filed its Response on October 29, 2007. Licensee asserts that it should be excused from liability because: it timely filed a renewal application for the Station, although it did not do so electronically; and its failure to properly file the renewal application was not willful. The forfeiture amount proposed in this case was assessed in accordance with Section 503(b) of The Communications Act of 1934, as amended, Section 1.80 of the Rules, and the Commission's Forfeiture Policy Statement. In assessing forfeitures, Section 503(b)(2)(E) of the Act requires that we take into account the nature, circumstances, extent and gravity of the violation and, with respect to the violator, the degree of culpability, any history of prior offenses, ability to pay, and such other matters as justice may require. Licensee states that a paper copy of the renewal application was submitted in December 2005. The staff has determined that a paper application dated November 29, 2005, was timely submitted by Licensee. However, Licensee was required to file its renewal application electronically. Licensees are responsible for knowing and observing the rules affecting their activities, including the timely submission of required forms. Untimely or improperly filed renewal applications disrupt the orderly processing of renewal applications in accordance with the staggered filing set forth in Section 73.1020 of the Rules. Because Licensee did timely tender a renewal application for the Station, albeit in paper form, we will cancel the NAL. However, because it improperly filed the renewal application and did not provide a showing of good cause, we will admonish it. In light of this finding, we need not address Licensee's remaining argument. In view of the foregoing, the Notice of Apparent Liability (MB-200741410397) for violation of Section 73.3539 of the Rules is HEREBY CANCELLED. O-N Radio. Inc., is instead hereby ADMONISHED for filing the license renewal application for Station WOON(AM), Woonsocket, Rhode Island, in paper format without demonstrating good cause.

Ray R. Silva KMXO(AM) Merkel, Texas In this Forfeiture Order, we issue a monetary forfeiture in the amount of one thousand, five hundred dollars to Ray R. Silva , licensee of Station KMXO(AM), Merkel, Texas for willfully violating Section 73.3539 of the Commission's Rules , by failing to timely file a license renewal application for the Station. On January 31, 2007, the Bureau adopted a Notice of Apparent Liability for Forfeiture in the amount of one thousand, five hundred dollars to Licensee for this violation. As noted in the NAL, Licensee's renewal application for the Station's license term was due on April 1, 2005, four months prior to the August 1, 2005, expiration date. Licensee did not file the application until May 31, 2005, and provided no explanation for its untimely filing. Licensee submitted a response to the NAL on April 2, 2007. In the Response, Licensee asserts that the proposed forfeiture should be cancelled because his failure to timely file the license renewal application was not willful; and paying the forfeiture would present a financial hardship. We have considered Licensee's Response and the record of this case in light of the statutory factors, our Rules, and the Forfeiture Policy Statement. We conclude that Licensee willfully violated Section 73.3539 of the Rules and that no mitigating circumstances warrant cancellation or further reduction of the proposed forfeiture amount. IT IS ORDERED, pursuant to Section 503(b) of the Communications Act of 1934, as amended, and Sections 0.283 and 1.80 of the Commission's Rules,21 that Ray R. Silva SHALL FORFEIT to the United States the sum of one thousand, five hundred dollars (\$1,500) for willfully violating Section 73.3539 of the Commission's Rules.

Citadel Broadcasting Company WIBR(AM) Baton Rouge; WEMX(FM) Kentwood, Louisiana In this Forfeiture Order, we issue a monetary forfeiture in the total amount of eight thousand dollars to Citadel Broadcasting Company, licensee of Stations WIBR(AM), Baton Rouge, and WEMX(FM), Kentwood, Louisiana, for its willful and repeated violations of Section 73.3526 of the Commission's Rules. The violations involve Citadel's failure to properly maintain the Stations' public inspection files. On February 2, 2002, Citadel filed the captioned applications to renew the licenses of WIBR(AM) and WEMX(FM). Section III. Item 3. of the license renewal application form, FCC Form 303-S, requests that the licensee certify that the documentation required by Section 73.3526 of the Rules has been placed in the station's public inspection file at the appropriate times. Citadel responded "no" with regard to WIBR(AM). It disclosed that the station failed to timely place the following issues/programs lists in the WIBR(AM) public file: the issues/programs lists for the four guarters of 1999; the first three guarters of 2000; first guarter of 2001; the first guarter of 2002; and the first three guarters of 2003. Citadel also responded "no" with regard to WEMX(FM). It disclosed that the station failed to timely place the following issues/programs lists in the WEMX(FM) public file: the issues/programs lists for the four quarters of 1999; the first three quarters of 200; the third and fourth quarters of 2001; the third and fourth quarters of 2002; and the first three quarters of 2003. Citadel added that the majority of the initially absent quarterly issues and programs lists had been re-created and placed in the respective public inspection files and that steps had been taken to assure that in the future all quarterly lists are timely prepared and placed in the public files. On August 5, 2004, the Bureau issued two Notices of Apparent Liability for Forfeiture to Citadel in the amount of nine thousand dollars (\$9,000) to each Station for a total of eighteen thousand dollars (\$18,000) -- for willfully and repeatedly5 violating Section 73.3526 of the Rules. Citadel filed a joint response to each NAL on September 3, 2004, requesting cancellation of each of the proposed forfeitures. The proposed forfeiture amounts in these cases were assessed in accordance with Section 503(b) of the Act. Section 1.80 of the Rules, and the Commission's Forfeiture Policy Statement. In examining Citadel's Joint Request, Section 503(b) of the Act9 and the other cited authority require that we take into account the nature, circumstances, extent, and gravity of the violation, and, with respect to the violator, the degree of culpability, any history of prior offenses, ability to pay, and other such matters as justice may require. Section 73.3526 of the Rules requires that AM and FM broadcast stations maintain for public inspection a public file containing certain items, including guarterly issues/programs lists. Here, Citadel by its own admission was not in compliance with the public inspection rule. In its Joint Request, Citadel raises two arguments challenging the proposed forfeiture. First, Citadel asserts that the Commission has been inconsistent with respect to forfeitures assessed to similarly-situated renewal applicants. Specifically,

Citadel compiled a list of stations receiving smaller forfeitures than did the Stations for similar publicinspection file violations.10 Hence. Citadel contends that the Stations, too, should have received smaller forfeiture amounts. However, a brief review of recent precedent provides extensive Commission precedent for issuing the forfeitures as assessed for violations similar to those which Citadel has admitted in its Applications here. Recent NALs have consistently assessed forfeitures of \$10,000 for missing issues/programs lists involving 10 or more quarters, for periods of from three to four years.11 In the instant case, the Stations each have at least 12 missing guarterly issues/programs lists, involving a five-year period; the \$9,000 NAL issued for each Station here is consistent with the current \$10,000 forfeitures. Accordingly, we do not believe it appropriate to reduce the forfeiture amounts in light of these recent decisions. Next, we turn to Citadel's argument that it did not become licensee of the Stations until June 26, 2001, and therefore, it is not responsible for issues/programs lists' violations that occurred prior to that date. Specifically, Citadel argues that it is only responsible for four missing lists from the WIBR(AM) public inspection file and seven missing lists from the WEMX(FM) public inspection file. We agree. Section 73.3526(d)(1) of the Rules, "Responsibility in Case of Assignment or Transfer," states, in pertinent part: "[I]f the assignment [or transfer] is consented to by the FCC and consummated, the assignee [or transferee] shall maintain the file commencing with the date on which notice of the consummation . . . is filed with the FCC."15. In light of the foregoing, we have examined Citadel's Joint Request pursuant to the statutory factors above and in conjunction with the Forfeiture Policy Statement. As a result of our review, we conclude that Citadel willfully and repeatedly violated Section 73.3526(e)(8) of the Rules, and we find no basis for canceling the forfeitures proposed in the NALs for the violations. However, in light of the fact that the entity now controlling Citadel did not become the Stations' licensee until June 26, 2001, we will reduce the forfeitures to an amount commensurate with the violations of Section 73.3526 that occurred after June 26, 2001. Accordingly, we will reduce the forfeiture for each station from nine thousand dollars (\$9,000) to four thousand dollars (\$4,000). Accordingly, IT IS ORDERED, pursuant to Section 503(b) of the Communications Act of 1934, as amended, and Sections 0.283 and 1.80 of the Commission's Rules, that Citadel Broadcasting Company, SHALL FORFEIT to the United States the sum of eight thousand dollars (\$8,000)20 for willfully and repeatedly violating Section 73.3526 of the Rules.

Rodgson, Inc. WSDQ (AM) Dunlap, TN In this Forfeiture Order , we issue a monetary forfeiture in the amount of five thousand five hundred dollars to Rodoson. Inc., licensee of station WSDQ(AM), in Dunlap, Tennessee, for willful and repeated violation of Sections 11.35, 73.49 and 73.3526 of the Commission's Rules. The noted violations involve Rodgson's failure to maintain operational Emergency Alert System ("EAS") equipment: enclose the base of its AM antenna structure within a locked fence; and maintain and make available a public inspection file at its main studio. On August 19, 2009, agents from the Enforcement Bureau's Atlanta Office, accompanied by the station's general manager and other station staff, inspected the main studio of radio station WSDQ(AM). The agents found that the station's installed EAS receivers were not receiving audio from any monitoring assignment. Neither the station staff nor the general manager knew how to send an EAS test, and there were no EAS logs to confirm recent EAS functionality. The general manager and station staff admitted that the EAS equipment had not worked for at least a year. The agents asked to inspect the station's public inspection file and were told by the station staff and general manager that there was no public inspection file and that the station never had one. Furthermore, the station personnel were not familiar with the public inspection file requirements, and no one could produce any of the documents required to be in the public inspection file. The agents, accompanied by the general manager, also inspected the station's antenna tower fence. The general manager admitted that he had not visited the tower site in a long time. The agents observed that the station's antenna tower was energized during operating hours and therefore had radio frequency potential at its base. The agents observed that the lower planks of the wooden fencing surrounding the tower were missing and thus provided access to the base of the antenna structure. The agents also found that the gate for the fence was removed from its hinges and was propped up against the gate opening. There was no evidence of a working locking mechanism, except for a rusted metal linked chain that was wrapped around one end of the wooden gate and hung from a nail on the support post. Moreover, the agents did not observe any perimeter property fence. Accordingly, IT IS ORDERED that, pursuant to Section 503(b) of the Communications Act of 1934, as amended, and Sections 0.111. 0.311 and 1.80(f)(4) of the Commission's Rules. Rodoson. Inc. IS LIABLE FOR A MONETARY FORFEITURE in the amount of five thousand five hundred dollars for violations of Sections 11.35, 73.49 and 73.3526 of the Rules.

Stone/Collins Communications, Inc. WEPG (AM) South Pittsburg, TN In this Forfeiture Order, we issue a monetary forfeiture in the amount of three thousand five hundred dollars to Stone/Collins Communications, Inc., licensee of station WEPG(AM), in South Pittsburg, Tennessee, for willful and repeated violation of sections 73.49 and 73.3526 of the Commission's Rules. The noted violations involve Stone/Collins' failure to enclose the base of its AM antenna structure within an effective locked fence; and maintain and make available a public inspection file at its main studio. On August 19, 2009, agents of the Enforcement Bureau's Atlanta Office accompanied by the station owner and other station personnel, inspected the main studio of radio station WEPG(AM). The agents asked to inspect the station's public inspection file and were told by the station owner and personnel that there was no public inspection file requirements. The agents also inspected the fence surrounding the station's antenna structure. The agents observed that the station's antenna tower was energized during operating hours and therefore had radio frequency potential at its base. The agents observed that the gate on the chain link fence surrounding the base of the tower was wide open. There was no lock to secure the gate, and there was no evidence of any prior lock on the gate. The agents

also observed dense overgrowth of weeds and bushes inside the fence and in front of the opened gate. Moreover, the agents did not observe any perimeter property fence. Accordingly, IT IS ORDERED that, pursuant to Section 503(b) of the Communications Act of 1934, as amended, and Sections 0.111, 0.311 and 1.80(f)(4) of the Commission's Rules, Stone/Collins Communications, Inc. IS LIABLE FOR A MONETARY FORFEITURE in the amount of three thousand five hundred dollars for violations of Sections 73.49 and 73.3526 of the Rules.

**FROM INFORUM WZFG-1100** Scott Hennen is returning to The Flag. About five weeks after he parted ways with the Fargo radio station he helped get off the ground, the conservative talk-show host is returning to AM 1100. Hennen said he'll be back on the air next week and is shooting for a Wednesday return. His show will air in the 2 to 5 p.m. time slot now occupied by Sean Hannity's syndicated show, which will be moved to another time. Breck Von Bank, general sales manager for The Flag, said moving Hannity's show to a different time slot might take some time and that Hennen could be back next week or the following week. "I missed being on the air," Hennen said. "I decided early on that I had to be back on the radio. It's too important to me. It's such a fiber of my being." Hennen referred to his September departure from the station as the result of an "impasse with investors" and a "difference of opinion on the direction for management." He described the new arrangement as a syndicated show he is paid to produce and hopes to air on other Midwest radio stations. Hennen is looking to build studio and offices for his company, Freedom Force Communications, a marketing and public relations firm. Earlier this week, the Flag's morning show DJ Bruce Kelly hinted on air that Hennen would be returning to the station. Von Bank said Chris Berg has taken over the 8 to 11 a.m. time slot formerly held by Hennen.

FROM RBR DOT COM Not long after the announcement that ESPN Radio will be shuttered in Pittsburgh for Radio Disney, Red Zebra Broadcasting has pulled ESPN Depotes from its WXTR-AM 730 DC outlet and flipped it to Oldies, "730 WXTR: DC's Greatest Hits." Rick Carmean, Red Zebra EVP/Sales tells RBR-TVBR the syndicator is Citadel's ABC Classic Hits. Why the switch? "We felt there was a void in the marketplace and this might be a place where we can capture a decent share." Indeed, the closest thing in the market is Clear Channels' WBIG, "Big 100," but that leans heavily to Classic Rock rather than Oldies. Also, many listeners still miss the "Big AM Sound" that many stations used to deliver with these songs.

FROM Radio Info DOT COM Newcap Radio has officially moved CKVH-AM (1020) to the FM dial, creating CKVH-FM (93.5) "Prairie FM" in High Priaire, Alberta. It combines local information with oldies A/C music from the 60's through 2006. Listen to "Prairie FM" here ... The syndicated US-based John Tesh Radio Show adds Rogers Broadcasting-owned talk-formatted CKNI-FM (91.9) in Moncton, New Brunswick & CHNI-FM (88.9) in St. John, Newfoundland ... Country CJDC-AM (890) in Dawson's Creek, British Columbia imports Darren James for morning drive, says Milkman UnLimited ... The CRTC approves an application by Astral Media to operate a new station in Golden, British Columbia on the FM dial at 106.3 to replace their AM, CKGR-AM (1400). It will play A/C music with four hours of news weekly ... As Radio-Info previously reported, Ottawa's CIWW-AM (1310) officially flipped from oldies to all-news on Monday
