**FROM: GREATFALLSTRIBUNE DOT COM:** A new talk radio station planned in Great Falls already is prompting strong feedback — from Cascade County officials, who say station officials should have talked to them before erecting a 164-foot-tall signal tower. Commercial radio towers are not allowed at 83 Gibson Flats, where the tower is located, because the area is zoned a suburban residential area, said Carry Ann Shannon, a deputy county attorney. The radio station itself is located at 520 9th St. S. It's the county's position that the tower, which went up last month, either needs to be moved or Community Communication LLC, which owns the tower, needs to request the land be rezoned to agricultural, where towers are allowed with a permit, Shannon said. The county issued a cease-and-desist order Dec. 14. But by that time the tower was up, Shannon said.

**FROM: DAGGER PRESS DOT COM** New Owner Plans to Bring WAMD Aberdeen Radio Back on the Air "Live, local and responsive." That's the plan for WAMD when the Aberdeen radio station comes back on the air, pending FCC approval of a purchase by Radio Broadcast Communications Inc., according to company owner Bill Parris. WAMD 970 AM was silenced under the ownership of Salem Communications, which powered down the station under FCC rules to allow another of its stations to go to maximum power in the New York City market. Parris told *The Dagger* that Radio Broadcast Communications bought WAMD from Salem for a dollar and plans to bring it back with a broadcast mix of music and talk. The format will include a live morning show and DJ's discussing community news and issues that are "as local as local gets", Parris said, including high school sports. The music will be Top 40, up-tempo oldies, with "oldies" defined as hits from 1965 to the present. Specialized programming will be added on the weekend. The purchase of WAMD by Radio Broadcast Communications happened about a month ago, according to Parris. He said he expects word from the FCC in January and the new format could be on the air by late February. In the meantime, Parris said the aging Aberdeen studio is being gussied up for a comeback – offices are being refurbished, some new broadcasting equipment is being brought in, and DJ's are being interviewed. Parris said his Maryland-based Radio Broadcast Communications also owns WKHZ in Easton and is purchasing WYRE in Annapolis, in addition to operating a Pasadena TV and music production studio, and the entertainment website KHZTV.com.

FROM: Omaha dot com Get ready for changes coming to Omaha's two sports radio stations that sit at opposite ends of the AM dial. KOZN (1620 AM) is set to end its long-running affiliation with ESPN Radio, align with Fox Sports Radio and add the Jim Rome Show. KXSP "Big Sports 590" is going to become AM 590 and start promoting itself as "Omaha's ESPN Radio," and might look at bringing back a locally produced weekday show. The first of the changes for both will take effect Feb. 1. The KOZN Program Director Neil Nelkin said Tuesday that his station had been in negotiations with ESPN Radio since August before a recent decision to part ways. "Their effort was to get more of their network programming into the marketplace." Nelkin said. "We were reluctant to do away with any of our local programming, which we feel is the backbone of our station." Once separated from ESPN Radio, KOZN was able to pursue the popular Jim Rome Show, which it will air weekdays from 11 a.m. to 2 p.m. Rome is a Premier Radio Networks product, and Premier owns Fox. As for KOZN's local shows. Unsportsmanlike Conduct will stay in its 2 p.m. to 6 p.m. slot while "Schick and Nick" will move up an hour and run 8 a.m. to 11 a.m. "We feel our 8 a.m. to 6 p.m. stretch is the strongest it's ever been," Nelkin said. AM 590 goes from Fox Sports Radio to ESPN Radio and looks forward to all that comes with it, said Chris Sehring, vice president and market manager for Journal Broadcast Group Omaha. Although not all programming is set, Sehring said AM 590 will start each day with ESPN Radio staples "Mike & Mike in the Morning" and "The Herd with Colin Cowherd." He said the station also should attract listeners throughout the day with its ESPN Radio SportsCenter updates. KXSP has not had full-time local sports talk since March 2009, but it's something that immediately was discussed as the recent changes played out. "We have the platform. Now we just have to add the local element," Sehring said. "In the company's mind, the more local connection we have the better." Sehring also said no changes are foreseen with AM 590's broadcasts of Creighton basketball, Iowa football and the Kansas City Royals, saying "those partnerships remain important to us." Nelkin said KOZN will retain its other local programming and that the station will continue to have its same access to the NFL, NCAA basketball and the College World Series because they're properties of Westwood One. KOZN also will continue to broadcast Chicago Cubs baseball games. It will no longer have the ESPN Sunday night baseball game. "We've been with ESPN, actually, since they first started up as a weekend service back in the 1990s." Nelkin said. "But they've evolved, we've evolved ... and sometimes you go different ways."

From IDAHO STATMEN DOT COM KTIK 'The Ticket' adds FM signal Pop radio station 93.1 FM (licensed to New Plymouth, ID-EiC) has been swallowed up by KTIK "The Ticket." The sports station will now broadcast at two frequencies: its old home, 1350 AM, and its new home, 93.1 FM. KTIK is the ESPN carrier in Boise, and it features syndicated talent such as Jim Rome, Mike and Mike, Colin Cowherd and Scott Van Pelt. It also airs local sports-talk show "Idaho Sports Talk with Caves & Prater." The exception to the FM and AM simulcasts: Idaho Steelheads and Boise Hawks programming will only be aired at 1350 AM,

FROM: RADIO INFO DOT COM Stephen A. Smith will return to NY & LA radio with ESPN The plan for ESPN Radio is to bring back former syndicated sports talk host Stephen A. Smith to perform local talk shows on ESPN Radio's WEPN-AM (1050) in New York City and KSPN-AM (710) in Los Angeles. Smith, who left ESPN and joined Fox Sports Radio for about a year, will host separate two-hour evening shows in both markets, focused on local sports. He will also be a columnist for the station's *ESPNNY.com* & *ESPNLA.com*. Smith says "The five-plus years I spent here in my previous stint were unquestionably the best years of my professional career." The Radio-Info board in Los Angeles - **discuss it** - and New York City - **discuss it** - are both talking about Smith's return to ESPN.

"Greetings: 2010 was a good year for my family. My wife and I are now grandparents. Our first granddaughter was born in March. And, we are now empty nesters when in May my son entered the Air Force. He spent the past six months training as an Areo Space Medical Tech and also became a certified EMT. He is now stationed at Hill AFB outside Salt Lake City working in a medical clinic on the base. Here is a little radio trivia contest question. There is a Radio Station in the Chicago area that claims that it has one of the longest, if not the longest running radio program. This program has aired on this station for more that 80 years! There is no prize but whoever is first with the answer will get your name in print. One hint is that it's a graveyard station. So, what is the program and on which radio station? If you need another hint send me an e-mail at amdxer@core.com. The hints will not be easy, you will have to think a little. Had an interesting catch early this morning. During a routine band scan around 1am noted what sounded like a 1kHz tone tester on 1680 and passed the word out on the web lists. One of our DX'ers in Oregon picked up this tone on his eastern beverage. To me it sounded like a routine tone test but after listening carefully heard what sounded like garbled audio underneath, mixing with a couple of other 1680 stations. Another DX'er reported that WPRR in Ada, Mich was 1khz high in frequency. And, tuning 1 khz up on the R8A brought in the talk from WPRR and got rid of the 1khz het. Will listen this evening to see if they are still off frequency. A report is already in to CDXR. Over two years ago I started to monitor ground rod resistance and soil temperature with buried thermocouples in my backyard. Every few days I read the ground rod resistance from three rods. One is a 10 footer, one is 30" and one is 24". The two short, shallow rods are purposely short to see what effect wet/dry or frozen soil has on shallow ground resistance. Am using another 8 foot rod for a reference. These are not in any way connected to the power ground for the house. At the same time I read ground temperature at the surface, and at depths of 1 foot, 2 feet, 3 feet and 4 feet. So far have collected some interesting readings and perhaps after another year of data collection will publish the results. My aging Radio Shack cassette recorder is finally being retired. I have Total Recorder on my PC but recently purchased a Sony ICD PX820 digital audio recorder. Am still playing with it to learn all its capabilities. I consider this one step up from the low end but that is due to budget constraints. It has USB capability, creates MP3 files and It comes with its own software for playback and editing. Perhaps I'll create a review of this device in a month or so." 73's and good DX (Good to hear from you, Tom. Hadn't seen or heard the word thermocouples in years -- rce)

I recently rejoined IRCA, so a reintro is in order. I first joined in 1986 as a teenager living on Long Island and edited Eastern DX Roundup for a year or so before resigning because I moved out of EDXR territory for college. Fortunately I saved all of the DXMs, and I'm currently in the process of rereading them. Lots of good memories, and guite a few familiar names, including Patrick Martin, John C. Johnson and the guy who handed me the EDXR reins, Karl Zuk. I'm not sure if Bob Foxworth is still in the club, but we lived about 10 miles apart back in those days, although we never met in person. I'm currently in Columbia, Mo., which is halfway between St. Louis and Kansas City. I lived in Columbia from 1988 to 1998 while in college and grad school before taking a job in Kansas City. I still occasionally use the Drake R8 that I bought in 1994 or so, but my main rig at the moment is an Icom R70. I also have a Kenwood TS-570SG, but the receive audio pales compared to that of the R70 and R8, so I don't do much listening with it. I also still have the Palomar active loop that I bought in high school; a great piece of equipment. My main antenna is a beverage about 20 feet up and about 200 feet long, which is awfully short for a MW beverage but does guite well. I built it using Array Solutions' SWSD-1 product. I also plan to string up a few longwires in other directions once the weather permits. I welcome suggestions for off-the-shelf baluns so I can use coax for the feedline. I'd also like to know if there's a mod for enabling the R70's pre-amp below 1800 kHz or whatever the cut-off is. I recall hearing about such a mod in the '80s, but I haven't found it while reading back issues of DXM or Googling. I work from home, so I have the luxury of DXing during the day when conditions and workload permit. I work mainly in telecom, writing white papers and research reports for clients such as Tellabs and analyst firms. I also cover the professional audio-video industry and edit Entrepreneur magazine's guarterly Startups publication. (My full bio is at www.timkridel.com.) All of this goes back. more or less, to discovering DXing when I was 12 or so. I didn't enjoy math enough to go into engineering, but DXing gave me enough of a background in it that I'm able to have a career writing about it. My first paid writing job was the Broadcast DXing column for Popular Communications in the mid-1990s. shortly before I started grad school. It's good to be back, 73. (And it's good to have you back, Tim. I didn't know if you wanted all the phone numbers in the Forum report or not, though--rce)

In reading Gary Siegel's Forum on the destructiveness of "HD Radio", or IBOC, the approval of the inefficient "HD Radio" system is part of a bigger problem. For the past 30 years, we've had an FCC that has rubber-stamped the questionable agenda of the National Association of Broadcasters. The spectrum-destroying approval of "HD Radio" is not the only problem. The concentration of ownership in too few hands has led to a rapid decline in the quality of commercial radio programming. Listeners demand quality programming from their radio stations, and they're not getting it through their commercial radio outlets. Quality programming is now the exclusive domain of non-commercial radio. The broadcast industry should have never let the courts or the Reagan Administration abolish the Fairness Doctrine, which preserved and protected freedom of speech. Freedom of speech is now forbidden on American talk radio. Under the excuse of "free speech", the FCC has allowed secular, for-profit broadcasters, like Clear Channel and CBS, to own Christian radio stations. This should never have been allowed in the first place. Christian broadcasting should be the exclusive domain of the church and religious, not-for-profit broadcasters, Secular, for-profit ownership of Christian radio and Christian faith are not compatible, according to The Holy Bible. Concentration of ownership in fewer hands has also been job-killing. Tens of thousands of on-air positions have needlessly been eliminated, localism taken away from our radio dial, and there are too few opportunities for young broadcasters to get in on the ground floor at a small town radio station, such as WSMI 1540 Litchfield. IL, WJBM 1480 Jerseyville, IL or KWRE 730 Warrenton, MO. In addition, stations aren't recruiting new air talent where they should be doing it: at local colleges and universities. College radio is the only legitimate source of new on-air talent. The NAB's Employment Clearinghouse also does not place people in broadcast jobs in the right places. When I was living in Woodstock, GA during 1990 and 1991, I tried to find work through the NAB Employment Clearinghouse. I was looking in northwestern Georgia, as well as in the St. Louis area and the Portland, OR/Vancouver, WA area, where I had family. My tape and resume packages were not sent to the markets indicated. I had mine sent to Des Moines, Minneapolis/St. Paul and Santa Rosa (the latter being north of San Francisco). The practice of voicetracking has also killed jobs and severely limited opportunities for young broadcasters to get in on the ground floor out of a local college or a university. Voicetracking is also illegal, according to FCC rules. The biggest lie I ever saw in 22 years in broadcasting was on nearly every application I filed for employment at a radio station: "an equal opportunity employer." Broadcasters have never been equal opportunity employers. For example, many stations won't hire gualified people with even minor disabilities. In all the years I worked or looked for work in commercial broadcasting. I never saw a single wheelchair rolling around a station's studio and office complex; rarely did I go into a station that was accessible to folks in wheelchairs, under the guidelines of the Americans with Disabilities Act. Most broadcasters also won't hire anyone who isn't known to the station's General Manager. The policy of "it's not WHAT you know, it's WHO you know" is antiquated, leaves out many qualified

applicants (most who are hired are less qualified than those not known to station management), and is incompatible with 21st Century employment policies. All the radio jobs I found were on my own; before I came to work for the stations I worked at, I did not know a soul at these stations. If a broadcaster is to tell the truth about their employment policies, then "an equal opportunity employer" should be omitted from their job applications. It has become very clear to me that the deregulation of the commercial broadcast industry in the United States, as well as the NAB agenda, is a massive failure. What we need is an FCC that is not a slave to the NAB's spectrum-destroying and job-killing agenda. We need one that supports a total ban on secular ownership of Christian radio, restricting local radio ownership to local companies only, permanently bans voicetracking, and supports much stronger anti-discrimination policies. I don't see commercial radio getting better anytime soon. A good start, from a technical standpoint, is to take "HD Radio" off AM, and return to mandating the C-QUAM system as the only system for stereophonic broadcasting on AM. The next step would be to remove "HD Radio" from FM, and ban DRM from shortwave stations. The next thing is to find spectrum for a separate digital radio band. When will the NAB realize that deregulation is a massive failure? America's broadcasters are living in some kind of fantasy world, not in the real world. 73.
