F.C.C. FINES

Mattoon Broadcasting Company Stations WLBH and WLBH-FM Mattoon, Illinois In this Notice of Apparent Liability for Forfeiture we find that Mattoon Broadcasting Company, licensee of Stations WLBH (AM) and WLBH-FM, in Mattoon, Illinois, apparently willfully and repeatedly violated section 73,49 of the Commission's Rules by failing to enclose Station WLBH's towers within effective locked fences or other enclosures and section 73.1125(a) and by failing to maintain a management and staff presence at the stations' main studio. We conclude that Mattoon Broadcasting is apparently liable for a forfeiture in the amount of fourteen thousand dollars. On July 21, 2010, during normal business hours, an agent from the Enforcement Bureau's Chicago Office attempted to inspect Stations WLBH and WLBH-FM at their main studio at 5746 E. Country Road 1000 N, in Mattoon, Illinois. The agent found that the main studio building was locked and no one answered when the agent rang the doorbell. The agent called the stations' telephone number; no one answered and no voice mail system picked up. In the parking lot outside the main studio building, the agent observed two vehicles, both of which had flat tires. On the morning of July 22, 2010, the agent attempted to contact the stations by telephone and again no one answered and there was no voice mail. In the afternoon, the agent returned to the main studio to inspect the stations and found that the building was still locked. The agent rang the doorbell, knocked on the door, and still no response. The only cars parked in the parking lot were the two cars with flat tires observed the previous day. Before leaving the main studio, the agent tried, with no success, to reach someone at the station by telephone. After leaving the main studio on July 22, 2010, the agent inspected the series-fed, four-tower array used in the operation of AM Station WLBH. The agent observed that the fences surrounding each of the towers had either sections that were falling down or sections that were completely missing. In each case, the state of disrepair allowed unfettered access to the tower and there was no perimeter fence surrounding the property on which the towers were located. On July 30, 2010, James Livesay, President and General Manager of Mattoon Broadcasting, contacted the agent by telephone. Mr. Livesay conceded that the fencing around the four towers had deteriorated and stated that he would replace the fencing right away. With regard to staffing at the main studio, Mr. Livesay reported that the individual who is usually at the main studio has had a significant number of absences for medical tests. Mr. Livesay did not provide any other explanation for the absence of personnel at the main studio on July 21, 2010 and July 22, 2010, and did not indicate to the agent that he had any other station employees. Accordingly, IT IS ORDERED that, pursuant to section 503(b) of the Communications Act of 1934, as amended, and sections 0.111, 0.311, 0.314 and 1.80 of the Commission's Rules, Mattoon Broadcasting Company is hereby NOTIFIED of this APPARENT LIABILITY FOR A FORFEITURE in the amount of fourteen thousand dollars (\$14,000) for violations of sections 73.49 and 73.1125(a) of the Rules.

Daniel D. Smith Licensee of Station KANR Belle Plaine, Kansas In this Forfeiture Order, we issue a monetary forfeiture in the amount of eleven thousand five hundred dollars (\$11,500) to Daniel D. Smith, licensee of Station KANR and owner of antenna structure number 1033278 in Belle Plaine, Kansas, for willful and repeated violation of sections 11.35(a), 17.47, 17.50, and 73.3526 of the Commission's Rules. The noted violations involve Mr. Smith's failure to: (1) maintain operational emergency alert system equipment; (2) make an observation of antenna structure lighting at least once each 24-hour period;(3) repaint the antenna structure as necessary to maintain good visibility; and (4) maintain and make available a complete public inspection file.

A Radio Company, Inc. Licensee of Station WEGA Vega Baja, PR In this Notice of Apparent Liability for Forfeiture, we find that A Radio Company, Inc., licensee of AM radio Station WEGA in Vega Baja, Puerto Rico, apparently willfully and repeatedly violated an Enforcement Bureau order by failing to comply with the terms of the Order and Consent Decree entered into between the Bureau and A Radio 1 Based on our review of the facts and circumstances of this case, we conclude that A Radio is apparently liable for a forfeiture in the amount of twenty-five thousand dollars. On May 12, 2008, the Bureau adopted an Order and Consent Decree3 that terminated a Bureau investigation of possible violations by A Radio of sections 73.49. 73.1350(a), and 73.3526 of the Commission's rules regarding antenna tower fencing, public inspection file requirements, and operating with an unauthorized antenna pattern. Among other terms in the Order and Consent Decree, A Radio agreed to make a voluntary contribution to the U.S. Treasury in the amount of eight thousand dollars by June 14, 2008.5 A Radio also agreed to submit a Compliance Report certifying compliance with all terms of the Consent Decree by May 14, 2010. In response to a letter of inquiry7 issued by the Bureau's San Juan Office on April 16, 2010, A Radio admitted that it was required to make an \$8,000 voluntary contribution pursuant to the terms of the Order and Consent Decree and stated that the "original check for \$8,000 was not cleared by Western Bank because of insufficient funds." According to the Commission's records, as of May 10,2011, A Radio has not submitted its \$8,000 voluntary contribution to the U.S. Treasury. Similarly, as of May 10, 2011, A Radio has not submitted its Compliance Report.

Consolidated Radio, Inc. Licensee of Station KVOZ (AM) Del Mar Hills, Texas In this Notice of Apparent Liability for Forfeiture and Order, we find that Consolidated Radio, Inc., licensee of Station KVOZ (AM) in Del Mar Hills, Texas, apparently willfully and repeatedly violated sections 73.1125, 73.1745(a) and 73.3526 of the

Commission's Rules by failing to (1) maintain a main studio in the community of license; (2) operate consistent with the terms of its station authorization; and (3) maintain and make available a complete public inspection file. We conclude that Consolidated Radio is apparently liable for a forfeiture in the amount of twenty-one thousand dollars. We further order Consolidated Radio to submit a sworn statement certifying that it is currently in compliance with sections 73.1125, 73.1745(a), and 73.3526 of the Rules. On July 27 and 28, 2010, an agent from the Enforcement Bureau's Houston Office monitored the field strength for AM broadcast Station KVOZ in Del Mar Hills, Texas. The agent observed that the station's field strength remained the same both days after sunset. On July 28, 2010, an agent from the Houston Office also attempted to inspect Station KVOZ, but could not locate the station's main studio in Del Mar Hills, Texas, its community of license. The station had no published local or toll free telephone number in Del Mar Hills, so the agent called Consolidated Radio at its office in McAllen, Texas. Consolidated Radio provided the agent with a name of a contractor from Brownsville, Texas who handles FCC issues for Station KVOZ and advised that the contractor would coordinate an inspection of the station.

John F. Warmath Licensee of Station WIRJ (AM) Humboldt. TN In this Notice of Apparent Liability for Forfeiture and Order, we find that John F. Warmath, licensee of station WIRJ (AM), Humboldt, TN. apparently willfully and repeatedly violated sections 73.49, 11.35, and 73.3526 of the Commission's Rules by failing to maintain: (1) an enclosed fence around the base of the station's AM antenna; (2) Emergency Alert System equipment; and (3) a public inspection file. We conclude that Mr. Warmath is apparently liable for a forfeiture in the amount of twenty-five thousand dollars. On October 7, 2010, in response to a complaint, agents of the Enforcement Bureau's Atlanta Office, accompanied by the station's acting chief operator, inspected radio station WIRJ(AM) in Humboldt, TN. The agents found that there was no EAS equipment installed at the station. Both Mr. Warmath, via telephone, and the acting chief operator admitted that the EAS equipment had been missing for more than 60 days. The agents also observed that there was no fence surrounding the base of the station's antenna structure and no perimeter property fence. Neither Mr. Warmath nor the acting chief operator knew when the base fence was removed, but the acting chief operator estimated that the fence had been removed about a year prior to the inspection. In addition, the agents found that Station WIRJ(AM) had no public inspection file. Mr. Warmath and the acting chief operator stated that they had not filed any documents in the public inspection file in over two years, and that they were unaware of any other person maintaining a public inspection file for Station WIRJ(AM) during that period.

Patrick H. Sickafus Licensee of AM Station WWSM In this Notice of Apparent Liability for Forfeiture, we find that Patrick H. Sickafus, licensee of AM Station WWSM in Annville-Cleona, Pennsylvania, apparently willfully and repeatedly violated section 73.49 of the Commission's rules by failing to enclose two of Station WWSM's antenna towers within effective locked fences or other enclosures. We conclude that Sickafus is apparently liable for a forfeiture in the amount of seven thousand dollars. On May 26, 2010, an agent of the Enforcement Bureau's Philadelphia Office inspected the series-fed, three-tower array used in the operation of Station WWSM in Annville-Cleona, Pennsylvania. The agent found that the wooden gate to the center antenna structure was off its hinges and open. The agent also observed that the door to the center tower's tuning hut was unlocked and open, which allowed unhindered access to the live tuning coils feeding the center tower. Similarly, the agent found that the enclosure for the antenna structure located at the northern part of the site was missing the entire southside wall and the door to the tuning hut was unlocked. The agent concluded that the enclosures around the center tower and the northern tower were in such a state of disrepair that it could not have happened overnight. Immediately after the inspection, the agent attempted to contact the station's general manager, but was not able to reach him until June 1, 2010, at which time the agent advised the general manager about the problems at the antenna site.3 The general manager told the agent that he had visited the antenna site on May 24, 2010, and had observed the same problems as the agent. In an e-mail later that day, the general manager reported that the fence enclosures would be fixed that week and he admitted that he had not been maintaining the antenna site properly. On June 2, 2010, the general manager sent another e-mail to the agent advising him that the fence enclosures had been repaired. The agent confirmed that the enclosures were fixed during an on-scene inspection on June 7, 2010.

World Media Broadcast Company Licensee of Station WCLM (AM) Highland Springs, Virginia In this Forfeiture Order, we issue a monetary forfeiture in the amount of five thousand five hundred dollars (\$5,500) to World Media Broadcast Company, licensee of Station WCLM(AM), in Highland Springs, Virginia for willful and repeated violation of sections 11.35(a), 73.1400(a)(1)(ii) and 73.3526 of the Commission's Rules. The noted violations involve World Media's failure to maintain: (1) functioning Emergency Alert System ("EAS") equipment; (2) functioning transmission system remote control equipment; and (3) a public inspection file at its main studio, and make that file available upon request. As discussed in detail in the Notice of Apparent Liability ("NAL") in this case,2 on January 26, 2010, during an inspection of the main studio and transmitter site for Station WCLM in Richmond, Virginia, an agent of the Enforcement Bureau's Norfolk Office observed that the station's EAS encoder/decoder unit installed at the main studio was not operational. Both the station manager and the "technical representative" for the station admitted that neither of them knew if an EAS Encoder/Decoder unit was installed at the main studio or when the last EAS test was sent. In addition, World Media was unable to produce any evidence that required EAS weekly or monthly tests had ever been sent or received. In response to a request to inspect Station WCLM's public inspection file during regular business hours, the station manager was unable to make the public inspection file or any of the required contents of the file available for inspection. The station manager stated that Station WCLM's public inspection file was maintained at World Media's headquarters in Washington, DC. The agent also observed that the installed transmitter dial-up remote control system at the Station WCLM transmitter site was inoperative. According to

the station manager and "technical representative," the transmitter remote control unit was "hit by lightning" sometime in November 2009 and had not been repaired or replaced. In view of the record evidence, including World Media's admissions, the NAL proposed a forfeiture of \$21,000 against the licensee for violation of sections 11.35(a), 73.1400(a)(1)(iii), and 73.3526 of the Rules. World Media submitted a response to the NAL requesting reduction or cancellation of the proposed forfeiture based on its history of compliance with the Rules, its prompt action to repair its EAS equipment, and its inability to pay the forfeiture. World Media's response does not dispute the violations identified in the NAL.

Entertainment Media Trust, Dennis J. Watkins, Trustee Licensee of Station KZQZ St. Louis, MO

Licensee of Station KQQZ DeSoto, MO In this Notice of Apparent Liability for Forfeiture, we find that Entertainment Media Trust. Dennis J. Watkins. Trustee. licensee of AM Station KZQZ, in St. Louis. MO and AM Station KQQZ, in DeSoto, MO, apparently willfully violated section 73.1350 of the Commission's Rules by failing to operate Station KZQZ in accordance with the terms of its station authorization. We also find that the Licensee apparently willfully and repeatedly violated sections 73.1590 and 73.3526 of the Rules by failing to conduct required annual equipment performance measurements for Station KZQZ and failing to maintain and make available complete public inspection files for Stations KZQZ and KQQZ. We conclude that Entertainment Media Trust is apparently liable for a forfeiture in the amount of twenty-five thousand dollars (\$25,000). On April 20, 2010, in response to a complaint, an agent from the Enforcement Bureau's Kansas City Office ("Kansas City Office") took measurements from a location approximately one kilometer west of the KZQZ transmitter site and observed no change in the field strength of the station's transmissions after 6:30 p.m. CDT. According to the KZQZ station authorization, the station must switch from daytime to nighttime directional patterns at 6:30 p.m. CDT during the entire month of April. On April 21, 2010, an agent from the Kansas City Office conducted an inspection of the main studio of co-located Stations KZQZ and KQQZ. The agent requested to inspect both of the stations' public inspection files during normal business hours. The public inspection file for Station KZQZ was missing eight issues/programs lists, i.e., all issues/programs lists for the period after the licensee acquired the station in March 2008. The public inspection file for Station KQQZ was missing two issues/programs lists, i.e., both issues/programs lists for the period after the licensee acquired the station in November 2009. Station personnel also stated that Station KZQZ had received comments from the public on the station's webpage, but none of these comments was included in the public inspection file. An agent from the Kansas City Office also conducted field intensity measurements of the Station KZQZ signal on April 21, 2010, after the station had switched manually to a nighttime directional pattern. Measurements taken at the same location as on April 20, 2010 found the field intensity to be onetenth of the value measured the previous evening. According to station management, no remote monitoring equipment was installed or used at Station KZQZ, and no operator had made observations of the transmitting system to determine if the directional pattern was correct for the pertinent time of day. Station management also stated that the licensee had not established any monitoring procedures or schedules for the station and had not maintained any station logs, other than those pertaining to the Emergency Alert System. On April 27, 2010, the Kansas City Office issued a Letter of Inquiry to the licensee requesting copies of the last set of equipment performance measurements for Station KZQZ made to demonstrate the station's compliance with spurious and harmonic emissions requirements in accordance with section 73.1590(d) of the Rules. In its response to the LOI, dated May 6, 2010, Entertainment Media Trust stated that "arrangements [for the measurements] were in process but never coordinated because of time restraints on both sides" and that "this will be corrected as soon as possible." (EMT does business as Insane Broadcasting Company-EiC)

Media East, LLC Licensee of Station WLGT (AM) Washington, North Carolina In this Forfeiture Order, we issue a monetary forfeiture in the amount of ten thousand dollars (\$10,000) to Media East, LLC, licensee of Station WLGT(AM), in Washington, North Carolina, for willful violation of section 73.3526 of the Commission's rules. The noted violation involves Media East's failure to make available a complete public inspection file. As discussed in detail in the Notice of Apparent Liability in this case, on March 9, 2010, in response to a request by an agent of the Enforcement Bureau's Norfolk Office to inspect Station WLGT's public inspection file at the station's main studio in New Bern, North Carolina during regular business hours, Media East was unable to produce any public inspection file documents dated after 2006. Station WLGT's station manager told the agent that the current public inspection file documents were probably kept at Media East's headquarters in Statesville, North Carolina. In view of the record evidence, the NAL proposed a forfeiture of \$10,000 against the licensee for violation of section 73.3526 of the Rules. Media East submitted a response to the NAL denying that its public inspection file was incomplete and requesting cancellation of the proposed forfeiture.

Chattanooga's Oldest Radio Station "Goes Silent"; WDOD Sold To Baylor WDOD, Chattanooga's oldest radio station, has gone silent after 86 years on the air. The large, valuable WDOD property along the Tennessee River has been sold to Baylor School. WDOD's last day on the air was Tuesday. It most recently had a sports format. The station had moved to an Air America format in 2005 when longtime station fixture Earl Freudenberg left to join WDVN. WDOD later moved back to easy listening. Bernie Barker, station general manager, said, "The equipment at the station was very old and the parts were hard to get. The components had to be made in some cases." He said Baylor School needed the property for expansion so the deal was signed on Wednesday. Mr. Barker said the WDOD license was turned back to the FCC. He

said no employees lost their job. The deed says the property is 22 acres and the sales price was \$600,000. Barbara Kennedy of Baylor said, "Baylor has no immediate plans for the WDOD property at this time, but now that the purchase has been finalized we will factor the best use for the land into our campus master plan." The former station building at the property had not been used except as a transmitter since around 1999 when Bahakel also bought WDEF AM. Bahakel moved the station for WDOD and WDEF AM to the former Chattanooga Hardware on South Broad Street. Mr. Freudenberg, who was at WDOD for four decades, recalled, "WDOD is rich in history going on the air April 13, 1925. Co-owners Norman Thomas and Earl Winger had a crystal radio company. Mr. Thomas told me they got the radio station license so folks who bought the radios would have something to listen to. "Mr. Thomas said they got mail from as far away as Australia. I have a lengthy interview with him on tape. "The station was very special to me since I spent about 40 years working there. "It's a sad day for Chattanooga radio but I realize that good memories and nostalgia don't pay the bills." Mr. Winger and Mr. Thomas sold the station to H. Clay Evans and Interstate insurance in the late 50s. The Bahakals bought it in 1963. The station maintained its original call letters for its entire life. Mr. Freudenber said Cy N. Bahakal told him one time he would never sell the station, but he died several years ago and the station passed to his family.

FROM: LUFKIN DAILY NEWS DOT COM Townsquare Media to get Panthers' football broadcasts, ending Yates' 70-plus-year run After more than seven decades on the air. Yates Media will no longer be the official Voice of the Lufkin Panthers. Lufkin school district Superintendent Roy Knight said Tuesday that he will sign a new contract with Townsquare Media on Thursday. "Our two-year contract with Yates Broadcasting came to an end," Knight said. "We have reevaluated, and we are going with a different carrier." Townsquare Media Vice President and General Manager Tami Koonce said the company put in a proposal to the district to carry the games on their stations. "We are very honored and excited to be able to show our support for Lufkin sports, and we're excited to build on what's already been a winning tradition," Koonce said. She said Gary lvins, also known as Big Nasty, will continue to provide play-by-play for the games. He will also start a sports talk show on July 5 that will be aired on Q107 FM from 9 to 10 a.m. Monday through Friday. According to Yates Media's website, KRBA began carrying Lufkin Panther football games in 1938, the same year Daryl E. Yates signed on as the first radio station in East Texas. Yates Media continued that tradition since that time, as well as covering Lufkin basketball and baseball games. On the company's website, owner and general manager Stephen Yates said it has been his privilege to carry the games on his stations. "One of my most prideful memories was having the honor of being the voice of the Panthers, especially during their victorious journey to the 2001 5A State Football Championship," Yates wrote on the website. Ivins has been doing playby-play on Lufkin football broadcasts for four years. He said Tuesday he is happy to continue to do so, "First and foremost I would like to thank Stephen for giving me the opportunity to be on the radio." Ivins said. "The big reason I'm moving is I really like doing the Panthers games. I would like to thank Tami and Danny (Merrell) for the opportunity to come over and still do Lufkin sports, because that's what I like to do. The show is fun, but doing the games, and being with the kid and coaches, that's the best part of my show.

That's the same group that last year bought Long Island's WNYG, Babylon (1440) from Arthur Liu's Multicultural Radio Broadcasting. The change is notable partly because WRKL is owned Chicago-based Polnet Communications, which specializes in Polish language programming. WRKL's call letters derive from Rockland County, and it is licensed for 1,000 watts daytime and 800 watts at night.

He was one of the most gracious and genuine men that the Tacoma baseball family has ever known. As one of our founders, it's a sad day for the franchise but a great time to reflect and celebrate Clay and his accomplishments." Clay Huntington, the sports and civic icon whose contributions ranged from wooing Triple-A baseball back to Tacoma in 1960 to the formation of the Tacoma Athletic Commission, died Wednesday at Allenmore Hospital. He was 89. "It's a sad day for our community," said Tacoma sports historian Marc Blau. "When you think of how many people Clay touched, it's amazing.
