Limbaugh, Hannity, other shows leaving KMJ Fans of Rush Limbaugh, Sean Hannity and Glenn Beck will soon need to find their favorite talkers somewhere other than KMJ (AM 580 and FM 105.9). Peak Broadcasting, the parent company of KMJ, announced Friday morning that its 25-year relationship with Premiere Radio Networks, which syndicates Limbaugh and the others, is ending. Peak Broadcasting didn't say exactly when the shows would stop airing, only that they'd be phased out in the next 90 days. Premiere Radio Networks owns syndicated radio shows such The Rush Limbaugh Show, The Sean Hannity Show, The Glenn Beck Show and Coast to Coast AM. "We have a clear plan," said Peak Broadcasting marketing director Chris Miller, "but due to the obvious competitive situation, we are not going to divulge our plan at this time." Peak's announcement said Premiere Radio Networks decided to take its shows elsewhere. Where? That's still unclear at the moment. In its announcement, Peak said the future of the syndicated shows is unknown. Premiere Radio Networks is owned by Clear Channel, which owns its own cluster of Fresno radio stations. That seems like the most logical fit, but Tony Banks, Clear Channel's regional programming manager for Fresno, said on Friday afternoon: "We have no announcement at this time and no comment." Peak said KMJ will focus on local programming, like its already popular talk shows with Ray Appleton and Chris Daniel, among others. "We value program exclusivity and have long anticipated the opportunity to control our own programming locally rather than rely on national talk shows available in so many other places that can be taken from us at the whim of their owners," said Patty Hixson, Peak's senior vice president and market manager. Exact details of the new local-centered programming weren't announced.

Cumulus Media to add ESPN rival CBS Sports Radio to 47 stations ESPN Radio is about to get blitzed. After dominating for two decades, ESPN will take a big hit come January, when Cumulus Media will drop its programming from 47 stations and pick up rival CBS Sports Radio. In addition, Cumulus will syndicate CBS to other independent stations and work to woo Madison Avenue. The moves are part of the partnership Cumulus struck with CBS over the summer to help get the fledgling sports radio network off the ground. CBS also boasts a sizable radio presence with its own stations in big markets, including New York, Boston and Dallas. It owns WFAN-AM, one of New York's most popular sports stations. As a result, CBS Sports Radio will air on around 100 stations, reaching about 10 million households, when it officially launches on Jan. 2. It also claims it will be the "most listened to sports radio network in the top 50 markets." ESPN, however, will continue to beat in total audience by a long shot. The long-time leader boasts 350 full-time station affiliates and reaches an estimated 30 million households. It has 700 affiliates overall. Sports radio networks, while attracting just \$150 million in advertising, are fiercely competitive as they draw an attractive demographic. Thus, ESPN and CBS execs are already trash talking. "ESPN affiliates are in small markets. Maybe you find that adds up to a lot of audience," CBS Radio President Dan Mason told The Post. "Don't forget that CBS Radio owns most of the top 10 sports stations in the US, and with Cumulus that's formidable. "EŠPN has had the market much to themselves, we're the new entry and we think we put together formidable talent," Mason added. ESPN's Traug Keller, senior vice president of production and business, isn't worried. "This has no material effect on us," he said. "There's only three or four [Cumulus] stations in the top 50." What's more, Keller said ESPN Radio has already found new affiliates in Atlanta and Birmingham, Ala. Keller also emphasized that ESPN Radio's reach goes beyond traditional radio to include podcasts and online streaming. CBS Sports Radio has some resources to draw on as well. It will likely get some promotional help from CBS 2 New York and CBS's nascent cable outlet, CBS Sports Network. A mobile digital strategy is still being formulated, according to Mason. CBS's playbook calls for less live game coverage and more big personalities. CBS has already signed a slew of high-profile sports pundits, including Jim Rome, poached from ESPN in January, along with Doug Gottlieb and Scott Ferrall. CBS is also talking to the pro leagues about creating new specialty programming that doesn't focus on play-by-play coverage Of course, ESPN isn't standing still. In April it acquired and moved ESPN Radio to the Kiss FM slot in New York and converted its AM slot to a Spanish language channel, ESPN Deportes. ESPN Radio and CBS Sports Radio won't be alone on the playing field as NBC also launched its own sports radio network in September with NFL rights.

The obvious choice would be XEWA SLP, with 150,000 vs any other 540 Mexican ranging from 100 to max 2500 night-watts, and this is probably it, despite techno-rap not really being top-40 as per its latest incarnation in the "Los 40 Principales" mode. BTW, the other XEWA, 540 in Monterrey, with only 1 kW at night, is entirely separate now, "Dominio FM 96.5" per Cantú. Isn't it about time to grant it a unique callsign? Hoping for a definite ID at 0600 but then I get another station. (GH-OK)

- MÉXICO, XEJCC, Cd Juárez, Chih, Extremo 7-20. 1200 10/12, choral NA from WSW, 1202 segué to some rock music, R Centro ID, 1203 Banco de México, Diputados PSA. As previously researched, this is a relay via: XEJCC 1,000 1,0000 [sic.] (GH-OK) + 1209 10/17, talking about Morelia and Michoacán, suspect a national newscast eg XEJCC Juárez rather than: XEKN. This also looped WSW, vs a musical Mexican further to the south. (GH-OK)

- 780 MÉXICO. 1202 10/13, KSPI OK is kindly cooperating by not modulating its carrier, so I can catch this: "10,000 watts, Monclova" mentioned, so per Cantú it is: XEWGR Exa FM + FM 101.1 Monclova, Coah. 10,000 250. Lacking anything that definite but "Exa FM" ID could also have been: XEZN Exa FM + FM 104.5 Celava. Gto. 5.000 1.000. (GH-OK)
- 790 MÉXICO, XERPC, Chihuahua, Chih, Stereo Fiesta. 1201 10/18, choral NÁ, 1204 full ID amid CCI mentions Chihuahua 2, Grupo Radiorama, 99.3 FM, Estéreo – algo. Cantú: XERPC + FM 99.3 5.000 400. (GH-OK)
- 790 MÉXICO, XENT, La Paz, BCS, R Fórmula. 1232 10/18, Grupo Fórmula mentioned, headlines following credits to various newspapers such as Imagen de Veracruz, and also several in Europe and US; loops SW with CCI from another in SS. Cantú shows: XENT + FM 97.5 10,000 750. The other R Fórmula in Guadalajara doesn't fit. (GH-OK)
- 800 UnID. 1152 10/13, distorted-Donald-Duck transmitter is detectable under KQCV and XEROK, so it is on the air before 1200, presumably one of two stations in NE Mexico. (GH-OK)
 - + 1204 10/18, "Donald Duck" extremely distorted talk modulation has just started, QRMing clear XEROK, and atop whatever pre-sunrise signal there is from KQCV OKC. Presumed one of the NE Mexico outlets; standard remark. (GH-OK)
- 850t MÉXICO, XEM, Chihuahua, Chih, Milenio R. 0602 10/13, news quoting el gobernador de Coahuila, mentions Torreón, but there is no 850 in that state, and this is national news about the drug lord being killed and then kidnapped; loops WSW and even overrides KOA which has faded down or taken down by auroral. Very likely the usual one I hear, per Cantú: XEM + FM 103.7 5,000 500. (GH-OK)
- MÉXICO, XENL, Monterrey, NL, R Recuerdo. 1215 10/17, ad for Partido del Trabajo (Workers` Party, commie?), not something you hear every day from XE-land. Quick singing ID as Radio Recuerdo, temp in Monterrey, and time 7:15, live DJ greeting callers on the air including a kid voice. KKOW nulled. Cantú shows: XENL 5,000 2,000. (GH-OK)
- MÉXICŎ, XETC, Torreón, Coah, Kiuu. 1209 10/12, at least three mention of Gómez Palacio in local news, so it's the sister-city station across the state line: XETC + FM 91.1 10,000 1.000. (GH-OK)
- + 1208 10/15, YL with news, swooshes between items, categorized; apparently missed local and state segments, now nacional, and then internacional; 1212 hands over to OM for deportes until 1217, back to her with weather for "la ciudad" including chubascos. Federal PSAs for glorious government in general, and IFE's latest election management in particular, ads with passing mentions finally of Torreón, 1220 a university from Monterrey, campus Laguna; 1221 TC for 7:19, temp "en el centro de Torreón." Here's a station named for timechecks, and they're two minutes off, hi. Actually it's the one SS-spelling the EE letter 'Q,' but I haven't really heard either calls or that letter-name expressed on the air. (GH-OK)
- 900 MÉXICO, XÉWB, Veracruz, Ver, Los 40 Principales. 1154 10/12, mentions 98.9 FM, Los 40, from N/S, so it is per Cantú: XEWB + FM 98.9 50,000 10,000. No longer a repeater of cochannel behemoth XEW México DF, and thus much easier to tell apart. (GH-OK)
- 960t MÉXICO. UnID. 0500 10/13, local KGWA Enid provides another Fox-hole (could there be others at different hourtops? I need to check). During the pentaminute of dead air, manipulating the DX-398 to null the remaining very strong carrier as much as possible, this time the main inhabitant of 960 is Mexican music; lyrics seemed to mention "Lupe." rather than being a slogan ID. Prime suspect XEK Nuevo Laredo, Tamaulipas. Based on proximity, number two possibility would be XEKS in Saltillo, Coahuila but Cantú shows its night power only 100 watts. Based on frequent reception area, and more toward the KGWA null, #3 would be XEIQ Cd Obregón, Sonora, 500 watts. Based on highest night power, #4 would be XEHK Guadalajara, Jalisco, 2500 watts. Now, how about someone voicing a real ID during this window? It must radiate after 0500:00 and before 0505:00. (GH-OK)
- MÉXICO. UnID. 0500 10/15, just after local KGWA Enid goes to dead air for 5 minutes, among the mishmash I hear under its partially nulled carrier, one playing the four descending chimes which are the trademark of XEW and may well have played simultaneously on 900. Can it be that one of the thirteen XEs on 960 is relaying XEW overnight? Main website http://www.wradio.com.mx has no info on affiliates, but the show starting at midnite is 'Los Amos del Camino' for truckers. At http://www.mexicoradiotv.com I checked about half of the 960s, the more likely ones, and found no connections to XEW. (GH-OK)
- MÉXICO, XEYC, Cd Juárez, Chih, R Fórmula. 1215 10/18, string of PSAs, mostly federal including extolling the Presidencia of lame-duck Calderón, but amid them an ad or PSA mentioning Chihuahua, then Grupo Radio Net(?), and 1216 R Fórmula ID, so per Cantú: XEYC 5.000 500O. (GH-OK)
- MÉXICO. 0450 10/14, I find a sufficient signal to serenade me on the insensitive shower radio, XEG Monterrey. Turns out to be a preacher but not a screamer. I am paying more attention to the quena in the background looping 'El Condor Pasa' should this be filed under ECUADOR [non]? ECP even continued playing during his sign-off prayer at 0456 which was accompanied by louder sacred choral music. He's from a local Monterrey church, gave phone numbers on both sides of the border, and apparently is on every night at this time; XEG appended a standard disclaimer. (GH-OK)

- MÉXICO, XEG, Monterrey, NL, R Ranchera. 1050, UT Monday Oct 15 at 0430 10/15, XEG switches from music to preacher, apparently daily. Once again he is playing 'El Condor Pasa' constantly in background; seems to be more of a self-improvement/advice angle than strict gospel-huckstering, but really, MEGO. (GH-OK)
- 1090t MÉXICO, XEXE, Querétaro, Qro, Grupo Fórmula Querétaro. 1227 10/12, Full ID for some other station: XERFR, 970, desde Ciudad de México, "la Fórmula uno." Seemed to be from WSW, but IRCA and Cantú show the only such relayer on 1090 is: XEXE + FM 92.7 2,500 1,000. (GH-OK)
- MÉXICO, XEAÚ, Monterrey, NL, Milenio R. 1220 10/17, state-by-state headlines such as "Milenio: Hidalgo." and a few others, so per Cantú: XEAU + FM 103.7 5,000 500. (GH-OK)
- MÉXICO, XEP, Cd Juárez, Chih. 1300, Oct 14 at 1226 10/14, "R Trece, con la música de siempre" then rock song in SS. It's the usual XEP, not to be confused with another R "Trece" really on 1290 in the DF, XEDA. (GH-OK)

On the front page of Volume 50, Number 6 of DX Monitor, I asked a question about how many AM stations in the state you live in now have not made it into your log at your location. While I'm still in search of the last seven stations toward hearing 100 AM stations from Missouri, I thought about the number of stations I haven't heard that are located in Missouri. Over the past several months, I've been trying to pull in KDRO 1490 from Sedalia. It's the only Missouri graveyard station I have yet to hear. I've pulled in the two other 1490 stations from Missouri, KDMO Carthage and KTTR Rolla. The lowest channel unheard from Missouri is KGDN 890 Gladstone, near Kansas City. That may not be much of a possibility because their pattern protects Chicago on 890, Lexington, NE on 880, along with close in stations on 900. Another station I've been trying for from Missouri in recent months is KSWM 940 Aurora; however, with WMIX Mount Vernon, IL on 940 beaming their 1,500-watt night signal straight up I-64, I think that it may be a distant possibility. Another Missouri station I would love in my log is KBFL 1060 Springfield. It will be a real challenge at sunset with KYW Philadelphia dominating the frequency. KMIS 1050 Portageville is another Missouri AM that I would love to have in my logbook; another Illinois station (WDZ Decatur) dominates 1050 during the day. The closest unheard Missouri AM as I write this is KDEX 1590 Dexter, at 140 miles. What makes this station especially difficult is the digital interference from local KATZ 1600, as well as the dominance of WAIK Galesburg, IL on 1590 when the digital interference from KATZ is minimized. The ones I have a remote chance, at best, at hearing are those Missouri stations that are parked on channels occupied by locals, such as KCHI 1010 Chillicothe, the two on 1430 (KKOZ Ava and KAOL Carrollton), and KTTN 1600 Trenton. KXEN 1010 doesn't cut from 50 kW to 500 watts until sunset; I have only been able to put a

tight null on the station at sunset. Most of the time, I'm hearing either WINS or CFRB in KXEN's null. Another 50 kW powerhouse is on 1430; KZQZ also doesn't cut to 5 kW until sunset. I nearly heard KAOL, however, when KZQZ was off during the daytime due to transmitter problems on January 30. That was the day sunset conditions existed three hours before the sun went down; the frequency was dominated by WYMC, WPLN and WXNT that day. While KATZ cuts from 6 kW to 3.5 kW (beamed away from me) at sunset, I've primarily pulled in KRVA and WAAM at sunset in recent months. Many of the unheard AM stations from Missouri are either in the southern or western part of the state. In the state's major cities, I've heard every station licensed to Kansas City with the sole exception of KPRT 1590. In Springfield, KBFL 1060 is the only one I haven't logged. From Joplin, I've never logged now-silent WMBH 1560, although I've yet to log KQYX 1450 from its new city of license, Galena, KS. The only St. Joseph AM I have not logged at my location is KGNM 1270. It'll also be a challenge to log some of the lower-power AM stations on the other side of the state. Being on the eastern edge of the state, just eight miles west of the Illinois state line, my location is not as favorable for hearing Missouri AM stations as, say, the central part of Missouri. I would probably hear more Missouri AM stations had I been in Jefferson City or Columbia than I would on the ends of each state. From my suburban St. Louis location. I hear more Illinois AM stations than I do Missouri AM stations. It's no wonder I've heard sixteen more AM stations from Illinois than from Missouri. The same is true on the FM side of the dial; I've heard 162 Missouri FM stations versus 187 FM stations from the Land of Lincoln. From what I've logged over the years, the edge of a state could favor more stations in adjacent states than from within my own state. For example, someone in central Missouri could have 1360 dominated by the two Missouri stations, KELE Mountain View and KMRN Cameron, during the daytime, while in my part of Missouri, a weak KBKB Fort Madison, IA is a daytime regular. There have been a few days when I heard WSAI Cincinnati, OH several hours before sunset on 1360. Hearing the seven stations needed to hit the 100-station mark from Missouri is going to be a tough one, even if the two states that have recently hit the 90-station mark in my logbook, Tennessee and Texas, pass Missouri up. It's going to be interesting to see if the Volunteer State and/or the Lone Star State drop the Show-Me State into third or fourth place in my AM logbook. 73.

Reading Eric's Forum report reminded me that a few years ago I had started a list of all the AM stations in Indiana as well as the surrounding states of Ohio, Kentucky, Illinois and Michigan to see which stations I had heard as well as the ones I had not. The idea was to create a target list of stations to go after. Then, I started doing taxes and the list never got finished. I've told Block I will not be back this coming season (after eight years) but unfortunately still haven't pulled out the radio. I agree with Eric that being on the edge of a state makes a world of difference towards which states dominate in the log. I had the same problem when I was in northwest Indiana because I was right outside Chicago with all its stations plus only a few miles from Michigan. Even Wisconsin came into play because of the water path going that direction. From Indianapolis, which is a little bit south of the central point of the state, I know that probably most of the Indiana stations I have yet to hear are located in northwest and northeast corners of the state. There may be a couple in the Louisville area as well. I know that I have not heard WPGW-1440 Portland over on the east edge but I need to sneak it past my local 1430. From here, I have heard 62 Indiana stations even though I have been basically inactive on the radio since 2004. For Illinois, it's 52 and Ohio is 51. Kentucky is 61 which surprised me when I just checked it. From here, it's roughly the same distance to Ohio and Illinois going due east and west while Kentucky is further. However, I have noticed over the years that it's always easier to hear stations south of me as opposed to other directions. Sunrise and sunset skip alters that observation, of course. When I was living in northwest Indiana, I heard 62 Indiana stations and 92 Illinois stations, but my overall AM log up there was 620 stations more than my current total here in Indianapolis. I just ran a printout of Indiana stations from Radio-Locator and it shows 85 stations in Indiana. During the next week, I hope to check to see which ones I have not heard but it will be a little challenge as Radio-Locator has them in alphabetical order by call letters, not location or frequency. Gotta get to work, so hopefully in seven days....73

You'll be able to find upcoming Hamfests in your local area.
