LEARNING AND SHARING: 2013 - TWIN CITIES

The National Radio Club and the International Radio Club of America, in conjunction with the Minnesota DX Club and the Worldwide TV-FM DX Association, take great pleasure in announcing their joint "DXer" convention will be held in Minneapolis, August 1st through the 4th, 2013. Your hosts: Mark Durenberger (NRC), Mike Sanburn/Phil Bytheway (IRCA).

Called **LEARNING AND SHARING: 2013**, the conference will combine formal tutorials and technical sessions, gab gatherings, a DXpedition and ideas on how to enhance radio listening. Show-and-tell, new antenna designs and DX stories will be combined with information on receiver improvements and propagation.

The highlight of the convention will be one of its venues: The Museum of Broadcasting. There we'll see first-hand more than a century's worth of communications artifacts, operate a live Spark-Gap transmitter, learn about the history behind our hobby and see how broadcasts were made from the Museum's vintage radio studio.

The combined auction is going to be a big one this year; the Museum and others will be auctioning some nice communications gear.

Optional tours during the three-day Convention include area radio stations and the Mall of America.

The hotel selected for the 2013 Convention is the Holiday Inn Bloomington South Airport Mall in Minneapolis. Reservation and Registration information will be published shortly.

Volunteers are needed for the following:

<u>AWARDS</u>: Not much to do here except for printing out the HEALD award every year. No one has applied for the DX awards for many years.

<u>PUBLISHING</u>: Get address list from Lynn. Create labels and envelopes. Send (email) PDF file from the EIC to the printers, Pick up, Staple, Fold, stuff, then mail. It takes me about an hour to do the labels and envelopes. I usually do the envelopes on Wednesday morning before leaving for work. I pick up the DXM at the Printers on Wednesday night on my way to dinner. I staple, fold and mail on SATURDAY AM. It takes about an hour to fold and staple. It helps when you have a wife that assists you. You can set your own schedule as long as the issues go out on or before the masthead date. You will also need to send out sample issues as needed.

E.D.X.R.: Take email and mailed in DX reports and put in proper form for publication. Usually takes me about an hour to 90 minutes per issue.

I will be giving up these duties at the end of VOLUME 50. If no one comes forward during VOLUME 50, these features WILL go away. I will NOT extend my club duties past VOL 50.

I was reading, with interest, the Forums by Gary Siegel and DXF's editor while I was putting together Volume 50 Number 18 of DX Monitor. I can clearly understand the frustrations from the listener's perspective. As a former broadcaster, the changes have negatively impacted me and many others like me, too. Since the end of the 1990s, there has been a lot of resistance in the broadcast community (especially in corporate radio) to the hiring of talent who were born, raised and trained for the radio business in the same market a certain station or cluster is in (known in the industry as "homegrown talent"). In 22 years in broadcasting (not counting the time I took off in 1988-89, 1992, 1995-96 and 1999-2000), I had never worked for a corporate owner; I've mostly worked in public or Christian broadcasting. My non-commercial experience included two tours of duty at KCFV 89.5 Ferguson, MO, brief stays at WRFG 89.3 Atlanta and now-silent WGHR 102.5 Marietta, GA (which was the worst-run station I ever worked at), and a nine-year stay at WSIE 88.7 which ended in as a result of the fiscal mess left by the now-imprisoned Governor Rod Blagojevich in 2009. The only commercial experience I could get was for local owners. In 1996-97, I worked briefly as a backup studio engineer for the late Chuck Norman at WGNU 920 before going over to WFUN-FM 95.5 as a staff announcer and studio engineer. WFUN-FM's owner was an East Alton, IL businessman named Bob Howe: my boss was his son-in-law. Reed Hale. When the station was sold in 1999, one of the reasons given was that Mr. Howe didn't want to go head-to-head with Radio Disney. WFUN-FM had considered affiliating with Radio Disney after Aans World Radio ceased operations in 1998, but was turned down because of the station's sports commitments and the fact it was an FM signal (Disney has long preferred AM signals). Had Howe kept the station, Radio Disney would have been long gone from St. Louis. The top complaint many of us at WFUN-FM got from the listeners was that Disney's programming was inferior to the local programming that came from our old studios at Northwest Plaza in St. Ann, MO. When I was filling in at WGNU 920, I worked with talk show hosts and dealt with callers that had very diverse points of view. The most powerful AM radio station I worked at was a 10.000-watt daytime-only station in Marietta, GA. The most valuable lesson I got from working at WFTD 1080 is that Christian radio stations work on a different principle than the secular commercial stations. While the secular commercial radio stations were out to get as many listeners and sell as many ads as they can to satisfy their own greed, Christian radio stations were (and, for the most part, still are) primarily a ministry outreach to provide Christian music and Bible teaching programming (not to mention reaching people who have lost their way in their spiritual lives), operating on support from listeners and local Christian businesses. When I started in the radio field at KCFV 89.5 back in 1985. I thought doing a good program and keeping the listeners entertained were enough. I worked very hard to develop a style that was listenable, and I was taught that my hard work would lead to bigger and better things in radio. I did not want the six, seven and eight-figure salaries that folks like Rush Limbaugh made, I wanted just to make enough money to support myself, maybe get married and have a family of my own. What 22 years of hard work resulted in was a morning DJ shift that paid me, at my peak, \$9.00 per hour instead of an on-air job that paid a five-figure salary. By the time WFUN-FM was sold in 1999, many radio stations eliminated the airshift I really wanted: the overnight, or "graveyard", shift. I also did not have many connections in the industry beyond middle management. I never really agreed with the requirement that I know the station manager before I got a job in broadcasting. I knew no one at WGNU, and got a job there. I knew no one at WFUN-FM, and got a iob there. I knew no one at WSIE, and landed a job there. I also was able to use the knowledge I gained as a DXer at two of the stations I worked at: I wrote the verification form letter for WFTD 1080, which was signed by Rocky Payne. I was fortunate to get my own copy when I heard the station at my present QTH in January 1993. I was also the signer, under my on-air name of E.B. Stevenson, at WSIE 88.7 (while I was Public Service Director). I never expected to face the negative attitudes of corporate general managers and program directors, especially after Deregulation reared its ugly head. The radio industry doesn't value hard work anymore; it's all based on the antiquated policy of "it's not WHAT you know, it's WHO you know", which I believe devalues hard work, fosters

codependency and is psychologically unhealthy. I don't agree with this policy at all. I also don't think the words "an equal opportunity employer" should appear on broadcast applications, because they are NOT equal opportunity employers in the true sense of the words. It's one of the few businesses where discrimination on the basis of disability is still mostly legal. From a listener's perspective, I have the radio off most of the time while driving now. 15 years ago, I would find some good programming on local AM and FM stations. The lack of listenable programming on AM and FM got me to invest in a shortwave converter for the car radio at first; when that went kaput, I became a subscriber to Sirius Satellite Radio in 2007. One of the services that drew me to Sirius was World Radio Network, which carries programming from many of the world's leading broadcasters. The merger with XM which formed Sirius-XM added more programming, including the 24-hour Easy Listening channel Escape. I also listen to CBC Radio One and BBC World Service, as well as the Classic Country channel Roadhouse, the Mainstream Jazz channel Real Jazz, the Radio Classics old-time radio channel, and Top 40 channels '70s on 7 and '80s on 8. Talk radio has become too dominated by arch-conservative talkers, most music formats are intangible, and the kind of personalities on commercial radio are those who local listeners can't identify with. I am thoroughly convinced that the deregulation of the American media, especially radio, is a massive failure. If you were to ask me what AM radio really needs, it's a permanent ban on corporate ownership of local radio. It's also what FM radio needs. There should also be a permanent ban on the ownership of Christian radio stations by secular entities. I don't think it's right, from a moral and semantic standpoint, for Clear Channel to own a Christian radio station. Christian radio should only be the domain of the churches and Christian businesses. We need not only more local ownership of local radio, but also more public broadcasters, especially those that have open access policies. The business really needs to abandon the Wal-Mart or McDonald's approach to radio; it's a huge flop. Another good idea is to move "HD Radio" off AM and FM, and find much higher frequencies for the technology, such as the 5 and 10 GHz bands. AM radio should return to the C-QUAM standard for stereophonic AM broadcasting. No thanks to "HD Radio", I've never been able to hear WINU 870 Shelbyville, IL because of digital QRM from KFUO 850. If we had more owners with passion for radio, more owners who are willing to embrace more progressive employment policies, such as hiring more people with even minor disabilities and more homegrown talent, and owners more interested in developing listener loyalty than switching formats every year or two, then radio will have more listeners. NAB member stations, until you can prove you can support owners that are committed to serving the local areas instead of being dumping grounds for syndicated right-wing extremists, sex-driven "shock jocks" and intangible music formats, then you have lost me as a listener. Enough said.
