End of the world for Oakland's Family Radio? By Matthias Gafni Contra Costa Times

Family Radio ministry started with a wrong turn in Oakland

Two days before the date his boss had predicted as the Apocalypse, Matt Tuter made an auspicious decision: He canceled the skywriters.

Family Radio, the Oakland-based evangelical network run by Harold Camping, had already spent more than \$5 million on 5,000 billboards announcing Judgment Day -- May 21, 2011 -- according to tax documents. Now, Tuter said, he feared that the airplanes, which were to inscribe the warnings in the skies above major U.S. cities, were one expense too many for a business operating as if there really would be no tomorrow. Two years later, Camping's predictive powers have been thoroughly discredited. But the financial reckoning that Tuter foresaw for Family Radio may be coming soon, according to public financial documents and current and former high-level Family Radio employees who spoke to this newspaper.

Among the indicators: The nonprofit has sold its three largest radio stations, all cash generators. At the start of 2007, Family Radio was worth \$135 million, according to its tax returns, and by the end of 2011 its net assets had dropped to \$29.2 million, even though Family Radio received \$85.2 million in donations over that five-year period.

By the end of 2011, Family Radio reported \$282,880 in cash on hand, down from \$1.5 million at the start of the year and \$2.5 million at the end of 2008. In 2012, records show it took out a \$30 million bridge loan to keep operating while awaiting the station sales proceeds; it is not clear whether that loan has been paid off. Former and current insiders allege the situation may be even worse than it appears, claiming donations have dropped almost 70 percent since the Rapture prediction proved incorrect, leading to numerous layoffs of longtime Family Radio staff members. Those insiders say the nonprofit mishandled the sales of the stations, reaping far less than they were worth, and is on the hook for millions of dollars to devotees who have loaned them money over the years. Since the failed prediction, at least two letters have been sent to the California Attorney General's Office requesting an investigation into the station sales and Family Radio's handling of donations. The office does not confirm or deny investigations.

"You eliminate those three (FM stations) and, ultimately, the rest of it dies," said Tuter, a 55-year-old San Leandro resident and longtime right-hand man to Camping, who was fired last year. "I believe they are killing it off."

Not everyone predicts Family Radio's demise, however. Board member Tom Evans, who has taken over day-to-day operations since Camping suffered a stroke in June 2011, said Family Radio is hurting like any other nonprofit in this slow-to-rebound economy. But it is not closing, and the financial problems aren't nearly as serious as some allege, said the trustee, who instead envisions a downsized, more efficient ministry emerging.

"Sufficient funds were in the bank and, thankfully, we didn't spend everything (on May 21, 2011)," he said. "But it did force us to make quick changes."

At least some of those changes had an air of desperation: In a November letter to his followers posted on the Family Radio website, Camping wrote: "Either we sell (our biggest radio station) or go off the air completely." And Evans acknowledged the bridge loans, while insisting the nonprofit is not insolvent.

Camping, who hasn't been able to conduct his "Open Forum" radio show since suffering his stroke, still shows up for work and is involved in the nonprofit's operations, Evans said. The 91-year-old president was not available to comment for this story.

Tuter says Camping had long been telling him that when he dies, he wants the Oakland-based nonprofit to die with him. The ailing evangelist may get his wish.

The demise? Family Radio, founded more than a half-century ago, built itself into a powerful religious ministry with 66 full-service radio stations, more than 100 FM broadcast relay stations and a handful of television stations across the country. Fourteen shortwave transmitters allowed broadcasts to Africa, Russia and elsewhere in the world.

Its stations had no commercials, providing 24-hour, seven-days-a-week Christian programming in 30 languages -- including hymns, Bible teachings and gospel talk shows -- with Camping's "Open Forum" program airing every weeknight for 90 minutes. The nonprofit paid its bills through donors' philanthropy, amassing \$216.4 million in donations from 1997 through 2011, according to tax returns (2012 totals are not yet available). On its website and during broadcasts, listeners were told how to donate.

Camping became more engrossed with predictions of Judgment Day as the years passed, espousing multiple possibilities before ultimately focusing on May 21, 2011, as the highly publicized date. Contributions spiked, with stories surfacing across the country of followers donating their life savings, as Family Radio spent prodigiously to publicize the end of the world. Evans said it was a "buyer beware" scenario.

"We spent a significant amount and we didn't hide it. We were very open and the whole world knew what we were doing," Evans said. "None of us have any regrets." However, Evans said, in some cases where donors could show financial hardship, Family Radio has reimbursed up to half the value of their contributions. The free spending before May 21 combined with the drop in donations thereafter has left a shell of a nonprofit two years later. Earlier this year, Family Radio sold the last of its three powerhouse East Coast FM stations -- WFME in Newark-New York City, WFSI in Annapolis, Md.-Washington, D.C., and WKDN in Philadelphia -- the nonprofit's cash cows. The New York station was sold to Cumulus Media in January for \$40 million, the Philadelphia station went the previous month for \$22.5 million to Merlin Media, and the Annapolis station was sold to CBS in November for \$8.5 million.

Family Radio kept most of its significantly smaller radio stations and other assets -- even buying some smaller stations -- but has trimmed the on-air staff and cut its international schedule by 80 percent, sources said.

The programming remains similar, although they run only edited repeats of Camping's "Open Forum," with occasional brief live Bible study lessons by the founder. Still, in November, Family Radio posted a special message from Camping on its website about the WFME sale:

"Many listeners have heard news of this sale and are very concerned that it signals the demise of Family Radio. But, let me reassure you -- nothing could be further from the truth."

The critics: But some observers say the sale of the big three stations -- especially WFME, which served 14 million listeners -- is a disaster for the network.

Each of the stations was sold to a secular operator. Evans acknowledged Camping had a long-standing policy against selling radio stations to other religious organizations, saying such sales would "create confusion." But after these sales, Evans said, the board voted to reverse the policy -- with Camping's blessing.

To replace the FM stations sold, Evans said, Family Radio picked up AM stations, including Philadelphia's WKDN 950 AM. But critics call the AM station a "dog" with coverage problems and high overhead costs. Another challenge for Family Radio is that over the years it has taken a large number of loans -- one estimate puts the amount at \$22 million -- from devotees, exchanging them for promissory notes that pledge to use the money to "proclaim the gospel of the Lord."

On its 2011 tax return, Family Radio lists \$35.1 million in liabilities, but does not specify how much is owed toward the promissory notes. Evans would not say. However, he said, "The biggest concern of Harold and the rest of the board, if Family Radio went out of business, would be to pay off the promissory note holders." While some critics are surprised there have not been lawsuits or more complaints, others are not.

"People that follow religious groups think it's almost an affront against God to file a lawsuit or ask for their money back," said a longtime Family Radio manager, who requested anonymity fearing repercussions at work. "Bernie Madoff should have become ordained and made his operation a nonprofit and he probably would have gotten away with it."

Since the Rapture prediction flamed out, a religious freedom group and a part-time Family Radio employee wrote the California Attorney General's Office requesting a fraud investigation into Family Radio's handling of donations. Evans said the complaints were unfounded.

Meanwhile, Tuter -- Camping's former top assistant -- believes his ex-boss is running the ministry into the ground on purpose.

In 1996, about a week before Camping had heart surgery, Tuter said his boss confided in him his concern for Family Radio's future upon his death.

"He was very specific he did not want it to continue," Tuter said, quoting Camping in the meeting, "'God raised up Family Radio just as a platform for me!"

The future? What will Family Radio become? It depends on whom you ask. Some followers still debate future Rapture dates. But others hope Family Radio will return to its pre-Rapture roots as a more mainstream religious radio network.

"Most of us were sad to see the stuff happening, but we thought, 'OK, once the (Rapture) date goes by we'll get back to orthodox programming," said Craig Hulsebos, 70, Family Radio's longtime director of programming who was let go in September 2012. "But we didn't." Evans envisions a new mission.

"We feel we can be a comfort to listeners and a comfort to people affected by events, like the one in Connecticut or Hurricane Sandy," he said. "We want to be a comfort and reminder of God's strength and mercy. ... In the end, our founding mission is to proclaim the word of God."

End May Near for Calif. Evangelical Radio Network

SAN FRANCISCO May 13, 2013 (AP) - The end may be near for a California evangelical radio network used by a preacher to predict — incorrectly — the apocalypse, a newspaper reported.

Oakland-based Family Radio has sold its three largest radio stations, and tax records show the nonprofit network saw its net assets drop to \$29.2 million by the end of 2011, from a net worth of \$135 million four years earlier, The Contra Costa Times reported over the weekend (http://bit.ly/17hPOrP).

The radio network is run by Harold Camping, who predicted the world would end on May 21, 2011, only to later concede he had no evidence of an impending apocalypse. The network spent millions of dollars — some of it from donations made by followers — putting up thousands of billboards plastered with the Judgment Day message.

Some of Camping's followers quit their jobs or donated some of their retirement savings or college funds to support the ads.

Camping, 91, suffered a stroke after his prediction did not materialize and has since said he has no more interest in considering future dates for the end of the world.

By the end of 2011, Family Radio had a little less than \$283,000 in cash on hand, down from \$1.5 million at the start of the year and \$2.5 million at the end of 2008, the Contra Costa Times reported. In 2012, records show it took out a \$30 million bridge loan to keep operating while awaiting money from the sale of the stations.

Board member Tom Evans, who has taken over operation of the network since Camping's stroke, said the network is hurting during the economic slowdown like other nonprofits. But he said it is not closing. "Sufficient funds were in the bank and, thankfully, we didn't spend everything," he said, referring to the May 2011 prediction. "But it did force us to make quick changes."

Evans said the nonprofit would be more efficient going forward.

Family Radio, founded more than a half-century ago, had 66 full-service radio stations, more than 100 FM broadcast relay stations and a handful of television stations across the country at one point.

There were no commercials, giving listeners nonstop Christian programming, the Times reported. The network relied on donations.

- AUSTRALIA, 4QD, Emerald. First started appearing 1238 4/28, by 1240, man and woman talking DU EE and just kept getting stronger as 1300 approached, with the fanfare and ABC national news by woman, the news becoming almost perfectly understandable in spite of horrendous splash from 1550. There were moments where its carrier strength actually equaled 1550... amazing! (NHP-BC)
- REP KOREA, HLAZ, Cheju, FEBC. Man giving the full DXer ID, good strength at 1230 4/22: FEBC, HLAZeto, Nihongo, frequency and power mentions followed by "What a Friend I Have in Jesus" on piano, followed by woman in JJ wishing me a good evening, then dumped on by local noise. At 1245, even the noise hardly hampered the word for word readability. Also on 4/27, before the pattern change: supposedly CC broadcast, per PAL, but actually EE: "I am basically saying one of two things" "the Lord" by man etc at 1215. A deeper voiced man's speech was unrecognizable. I guess it could have been Australia instead, but absolutely no other sign of DU at this time, and the frequency was within 0.1Hz of the JJ broadcast after 1230UT. (NHP-BC)
 - + 1249 4/29 very weak with music. W-SW ewe. (DV-WA)
 - + 1212 5/18 assuming the station with poor signal just above threshold. In for about 30 seconds. W-SW ewe. (DV-WA)
- 1575 THAILAND, Rasom, VOA. 1515 4/29 weak signal with man in Asian language. Sky wire loop. (DV-WA)

I was wondering about the derivation of this strange name; no info on that in Wikipedia, but I do learn it is a town about the same size as Enid but four times as high; many emigrants from there are in Chicago. In the news lately for kidnapping. Googling, I don't find the name Papasquiaro applying to anyplace or anyone else. (GH-OK)
- MÉXICO, XEMÚ, Piedras Negras, Coah. 0549 4/23, promo for "Noticias Rancherita del Aire," singing ID for same, live DJ with timecheck and 26 degrees; often dominant over opposite WIBW Topeka KS with which it makes a 2 Hz SAH, ie XEMU, 5/2.5 kW. (GH-OK)
- MÉXICO, XEBU, Chihuahua, Chih. 0540 4/27, SS ad for an event mentioning 93.3, apparently an FM sponsor of it; hoped I had something other than XEBU, since its own FM is 91.7, but after some federal PSAs for Diputados, Suprema Corte, ID as Chihuahua, La Rancherita. The 93.7 there per Cantú is XHBW, Magia Digital, whose AM is 1280. Maybe they are same group? Or just a crossover commercial. (GH-OK)
- 650 MÉXICO, XETNT, Los Mochis, Sin. 1112 4/25, XETNT with 5:12 TC, unique show "Buenos Días, Yarderos." (GH-OK)
 - + 1155 4/27, Mexican music, fading at 1156 during R 65 sung ID, polca. Tuning down the band, XETNT, is the only XE still audible on lowband here, 12 minutes after our sunrise. (GH-OK)
 - + 1135 5/8, birthday greetings including to someone in Angostura, 1137 "Buenos Días, Yarderos" program ID, ie the reliable XETNT, the lowband XE most likely to hold up past sunrise which was 1131 today; also had one on 710, but not 730. Our earliest Enid sunrise in a month will reach 1114; while our latest sunset in two months will reach 0152. (GH-OK)
- 660 MÉXICO, XEACB, Ciudad Delicias, Chih, La Lupe. 0524 & 0536 4/34, IDs in passing for 98.9, La Lupe, mixing with others, so that's XEACB, not the hummer. (GH-OK)
 - + 0504 4/25, another station which is not the hummer, ID as La Lupe, ie XEACB, still on tho listed as sign-off at 0600 which would be 0500 during DST. (GH-OK)
 - + Tuning in even earlier at 0449 4/28 trying to sort out the one about to hum: initially preacher in SS on top; 0450 music station takes over, 0457 mentions 98.9 so that's XEACB, only now do I hear an XE NA weakly underneath and no hum after 0500; probably from the preaching one earlier. (GH-OK)
 - + 0501 4/20, probably XEACB, main signal of Mexican music looping SW, but in its null toward the SE, can hear some hum, which fits for post-midnite XEFZ Monterrey NL, which is considerably further east. (GH-OK)
- MÉXICO, XEÁR, Tampico, Tams. 0455 4/25, I am switching back and forth with 690 KGGF, here trying to nail down which XE is the one switching to a big hum heard several nights after NA finished at 0500. But now there are two or three stations mixing. Initially Mexican music is atop, not NA starting before hourtop. 0500 full ID for "La Mexicana, 12 en punto" and then short choral NA, 0501 another slogan ID. That's XEAR, 5/1 kW, listed as 24 hours by IRCA. I can barely hear some hum in the background from the other mystery station. (GH-OK)
- MÉXICO, XEDTL, México, DF, R Ciudadana. 1109 4/25, NA is ending late, in mix of several stations, then full sign-on by an IMER station with 5-letter call, also mentioning its HD channel, ie on FM. This has to be XEDTL, 50/1 kW (remember when it was commercial XERPM? That call is no longer in use anywhere per IRCA cross-reference). IRCA and Cantú do not list an FM for it, but probably refers to 660 programming being simulcast on one of their FM IBOC subchannels. Yes, explained here: http://imer.gob.mx/imerdigital/ with Ciudadana on 107.9 HD2. Looks like they have some good cultural programming. (GH-OK)
 - MÉXICO, XEFZ, Monterrey, NL. I tune in even earlier at 0450 4/29 to hear SS preacher finishing with Monterrey address, 0451 ID for R ABC, XEFZ in Monterrey and into choral multiverse NA. Mixing with others and they overtake by 0456, but this virtually confirms it's the station which had been broadcasting a big hum after the NA finished around 0500, but which is no longer heard. (GHOK)
 - + 0455 5/2, choral multiverse NA is playing, looping SSW, ends at 0457 and nothing further heard from this one, presumed XEFZ, while another one with Mexican music further west fades in, presumed XEACB Delicias, Chih. (GH-OK)
 - MÉXICO, UnID. 0500 4/23 the Mexican NÁ is playing, followed by dead air, open carrier with background hum surging to foreground. So we know the big hum being heard here is from a United States of Mexican rather than United States of American. Next will have to tune in a few minutes earlier to determine which one. Apparently they leave on not only the carrier after sign-off, but also the Optimod which stupidly brings up the hum on the circuit. Tonight it's worse than usual, with slow pulsing too. 0548 recheck I think it is off, but fades back in along with another SS station still modulating. My hunch is that the hummer is XEFZ in Monterrey NL, which is usually the dominant Mexican on this frequency; but based solely on the schedule hours in the 2012 IRCA Mexican Log, which cannot remain totally accurate after publication: it's 24 hours as are XEEY Aguascalientes and XEAR Tampico, while these close at 0600: XEACB Ciudad Delicias (which I have also heard before), XEWX Durango; while the others sign off at some other time. However altho presented in UT, those schedule times probably apply to winter non-DST rather than now. (GH-OK)

- + 0455 4/24 tuning in early trying to nail down the hummer post-0500: dominant is lively Mexican music, but by 0456 an under-station is playing choral Mexican NA, and that's likely to be the hummer; yes: 0500 NA stops and hum surges. (Every station signing off with an anthem, anywhere, should be required to insert a guick legal ID *after* it!) (GH-OK)
- + 0452 4/27, early NA already playing on unID station, presumably the one which has been followed by big hum; but losing out by 0454 to 'The Answer,' KSKY The Metroplex. Some checks after 0500 did not detect the hum, maybe no longer in effect? (GH-OK)
- MEXICO, XEN, México, DF. 0642 4/27, international exchange rates in SS, 0644 news about Tabasco. Main signal, with KTSM El Paso and KGGF Coffeyville OC more or less nulled, and peaks further east than most Mexicans I get. All adds up to presumed XEN, with its news/talk format. There is only one XE further east than that, in Veracruz but it's a Ke Buena, likely musical or not? IRCA shows XEAFA in Coatzacoalcos as News & Ranchera. Still, XEN most likely, especially if running 50 kW nights as claimed instead of 5. (IIRC, 690 used to be a major frequency from Cuba, but not anymore.) (GH-OK)
- 700 MÉXICO. XEDKR. 1045 4/25, ID for R Red on 1110, and FM. XEDKR, Guadalajara relay of XERED DF on 1110, per Cantú 10000/150 watts, but nevertheless the default station at night with WLW nulled. (GH-OK)
- MÉXICÒ, XEGÓ, Hidalgo del Parral, Chih, La Poderosa. 0517 5/2, YL in SS vs WLW but not in its null, so approximately opposite direction: that points to XEGD, 5/1 kW per Cantú, assuming XEETCH in Sonora is really a daytimer. I had just been nulling WLW and hearing a different station playing music in EE, probably previously heard XEDKR, R Red AM in Guadalajara, but there's also now-SS KHSE in The Metroplex TX. (GH-OK)
- MÉXICO, UnID. 1108 4/25, dominant signal now with FM frequency 102.5, "Noticias MBF" (or NDF? Or some combination of similar sounding letters). Cantú and IRCA show no 700 with an FM on 102.5, nor XERED 1110 either. However, Cantú does list in the DF: "102.5 Noticias MVS, Noticias, programas hablados. XHMVS 80,100 watts. Grupo MVS Radio: "So the question is, which XE on 700 would be relaying this? As far as I can tell from their website with lots of news and visuals, http://www.noticiasmvs.com/#I/home it's an independent company, and no affiliate list to be found. Search site on 700 and you get loads of news stories mentioning this figure. By now, it has 700 to itself, WLW faded out. (GH-OK)
- MÉXICO, XEDP, Chihuahua, Chih. 0546 4/27, béisbol with crowd noise, presumably a live late game if in Mexico too they are open-ended; loops SW and soon mentions Cuauhtémoc as one of the teams, so usual XEDP, breaking away from ranchera format. It's almost local midnite in the UT-6 zone. Surely more nite games to come when it's cooler around the diamond. (GH-OK)
- 720 MÉXICO, XEDE, Saltillo, Coah. 0549 4/27, timecheck as "48" and temp as 18 grados, back to music; typical automated time & temp format at every break of XEDE. Altho 50 kW WGN has as strong a signal as 250-watt(?) XEDE, WGN is totally nullable, avoiding slow SAH; not too far from collinear either, eg around Dallas, where listening to WGN must be quite a problem. (GH-OK)
- 730 MÉXICO, XEX, México, DF. 730, May 2 at 0519 5/2, SS talking over and over about pelotas, presumably sports format XEX as the DF fits; thought it might be a late béisbol game from further west, but then at 0521 talking about Barcelona. Tho they're mad about soccer there, unlikely to be a live game this early in the morning. (GH-OK)
- MÉXICO, XEHB, Hidalgo del Parral, Chih. With XEX nulled, another SS about "Las reinas de Radiorama" and "Ke Buena" ID, ie XEHB. XEX is allegedly 100 kW at night, and XEHB only 1, but their 50 kW day transmitter may be getting some extra usage. On the Ke Buena slogan, be aware that there is another one on 730, per Cantú, XEEBC in Ensenada BCN, 1/0.25 kW. Its FM is 97.9 while XEHB's is 107.1. (GH-OK)
- 830 MÉXICO, XEIK, Piedras Negras, Coah. 1215 4/28, SS weather in C, mentions 100.9 FM; 1216 TC for 7:17. No doubt it's XEIK, a semihour after sunrise here and soon to fade out. (GH-OK)
- 960 MÉXICO, XEK, Nuevo Laredo, Tams. 0501:25 5/13, KGWA Fox-hole of dead air except for hum when nulled, audiblized a mixture of stuff including ABC news, but clearly heard at this moment are the four descending "XEW" chimes which we know come on 960 from XEK. KGWA Enid continues to fill the hole unpredictably but most nights is clear for a pentaminute (GH-OK)
- 990tMÉXICO, XEER, Ciudad Cuauhtémoc, Chih. 0604 5/7, choral NA from SW or so, and anyway this midnite is an hour too late to be XET in the UT-5 zone. Likely XEER, in UT-6, though there is another beyond it, XEHZ in La Paz BCS, way down there where they also set their clocks the same in the summer as we do in the winter: XET soon resurged with music from south vs CBW. (GH-OK)
 - MÉXICO, XET, Monterrey, NL. 0506 5/2 after NA and full XET ID, produced opening of 'La Ruta Musical de la T.' address Apartado 203, Monterrey NL, then to live host welcoming 990 and internet listeners everywhere, referring to yesterday being workers` May Day, but no mention this time of his program number in the 18-thousands. His speech is quite slurred, not your usual glib radio announcer, but hey, he's just turned 98 on 4/15! Again could not copy his name. I wonder if he now has a home studio or goes to work at XET every night for 50+ years? The Multimedios website is no help for anything but streaming linx to its multitude of stations,

- MÉXICO, XEFV, Ciudad Juárez, Chih. 0540 5/16, "La Rancherita Mil AM, Ciudad Juárez," ie XEFV. No problem from KTOK OKC, which was on low power and/or not modulating, as I first noted a few minutes earlier on the bathroom radio when I could not hear it, despite WKY 930 loud as usual.

- XEFV can normally be heard at night with KTOK nulled on the DX-398 close to 90 degrees away.
- 1460 MÉXICÓ, XECB, San Luis Rio Colorado, Son. 0101 5/2, male announcer with ID in SS "XECB," and slogan "R Ranchito," to Mex polka and banda music. Fair. (RB-AZ)
- 1520 UnID. 0508 4/25, KOKC has QRM from vocal ballad Mexican music. Unfortunately, unlike other OKC signals I can't completely null KOKC so have to put up with the nonsense from Redeye Radio while trying to ID the QRM, from which I have yet to copy any announcement. At least I get a pretty good DF on it, SSW or maybe NNE, which if correct rules out the Californians as Greg Hardison helpfully suggested. There it is again at 1053, music making fast SAH with KOKC. I think we can also rule out KSIB in Creston IA, our closest 1520 to the NNE since it's a daytimer and still active in EE per website. Based on proximity and direction, the most likely one in Cantú is: XEVUC La Norteñita Allende, Coah. 1,000 D, with one little problem: listed as a daytimer, but as we know, that doesn't necessarily stop USA or USM stations from running all night. The IRCA Log 2012 has this one on 1050 instead, as "La Gigante," so recently moved? I can see how they would want to get off XEG's frequency, and maybe really operate at night on the new channel. WRTH 2013 also has this La Norteñita on 1520, as 1 kW fulltime, ie no "d" indicating a daytimer. (GH-OK)
- MÉXICO, XERF, Ciudad Acuña, Chih. 1142 4/27, XERF with 6:42 timecheck on "La Poderosa," brief Efemérides = day in history with Col. Bogey whistling theme, 1144 federal and Coahuila state PSAs; 1145 SS music CCl grows apparently as KZLI Tulsa icoses its 50 watt PSRA per NRC AM Log to 1000 watts day at official sunrise there; but I can still hear at 1145 XERF mentioning some cumpleaños and at 1146 an instrumental-only version of "Mañanitas," unlike last time. Anyhow this seems to be a regular morning ritual for them. But in May, KZLI goes to day power at 1115, and in June, 1100. Never mind the 50 watts: FCC AM Query shows PSRA is only 8 watts, limited by XERF every month except June when unneeded. Can anyone in Tulsa or even Catoosa really hear them on 8 watts atop XERF? (GH-OK)
 - + 1151 4/30, probably just finished 'Mañanitas,' XERF now in "Servicio Social" with missing-person "avisos personales" requests, including those last known to be in Coahuila, Chihuahua, phone numbers to be contacted. Have also heard this at other times on XERF. Good for a broad-coverage public radio AM station like this, and something you don't hear elsewhere on either side of la frontera. 1208, XERF still in with stocks in pesos, other Mexican tipoffs instead of SS KZLI Tulsa. (GH-OK)

ASIA AND PACIFIC

CHINA: As many monitors noted, Voice of Pujiang has already closed all its shortwave service since 2 May, 2013. That means, 1 May is the last day of Voice of Pujiang on the shortwave bands. In recent years, Voice of Pujiang has already transformed into a local station rather only focuses on Taiwanese audience. We still broadcast 18 hours daily on AM 1422. So, Medium wave DXers are still welcomed to submit their reception reports. (Victor Qian. China Business News Radio/Voice of Pujiang)

China Radio International (CRI) has set up a new radio service for countries around the South China Sea. The Voice of the South China Sea broadcasts in six languages, including Mandarin Chinese, English, Vietnamese, Malaysian, Filipino as well as Indonesian. You can hear the English programs of the Voice of the South China Sea at 0600-0700 UTC (14:00-15:00 Beijing time) on the frequency of 1008 kHz AM. CRI announced the launch on April 9. All India Radio, Chinsurah (near Kolkata) is testing its new 1000 kW DRM compatible transmitter on 594 kHz. Test txn carrying FM Rainbow program noted in AM mode around 10.30 IST (0500 UTC). (Sudipta Ghose, Kolkata, via Alokesh Gupta, dx_india 26 April)

Early this morning from 1910 UTC (mid night 40 IST), while tuning across the MW band I heard Hindi songs continuously on 1458 kHz without any announcements for many hours. Two AIR stations are using this freq via Bhagalpur & Barmer. Today morning when I contacted AIR Bhagalpur they informed it was not their station. However AIR Barmer in Rajasthan confirmed that it was their station testing new 20 kW transmitter! (Jose Jacob, dx_india 24 April)

14 May 2013, 0857 IST All India Radio, Chennai DRM noted on 793 kHz loud and clear, SNR 19, MER 15 MODE A, Bandwidth 9 kHz, SDC 4 QAM MSC 16 QAM, Service AAC mono, 8.1 kbps (Arun Kumar Narasimhan, Chennai) Looking at www.drm.org/wp-content/uploads/2013/05/AlR_DRM-Pres-to-ReceiverManufcts_-May-2013.pdf I noticed a 10 kHz spacing between the original AM frequency of the medium wave station concerned and the additional digital frequency. This seems to be confirmed by your monitoring. It would be interesting to know if or in which way these tests affect the regular 792 kHz channel (Pune A). If the roll out of simulcast transmissions goes according to the announced plan, "one" or perhaps several years from now you would have analog signals in the traditional 9 kHz spacing and DRM signals 10 kHz higher than the original frequency all over the Indian medium wave spectrum. (Dr Hansjoerg Biener, Nuremberg, dx india)

PHILIPPINES: VOA 1170 is gone. The transmission facility has been moved to a small tip when all the other grounds of the former US air base, closed in 1991, had been cleared for development. During this process the old transmitter was until 2005 used for a last time while the new solid-state transmitter, purchased already earlier, had been moved to its new location. This was possible because the identical transmitter from Thailand (1575 kHz, replaced in 1996) could be used as source of spare parts.

In fact the closure of 1170 kHz was already outlined in the original, now invalid budget request for 2013, as posted at http://www.bbg.gov/press-release/budget-request-reflects-long-term-strategy-changing-media-environment/

The transmitter was of pretty limited use anyway, with Radio Free Asia getting no license in the Philippines and the frequency now being blocked by a new high power transmitter in China.

This budget request also hinted at a closure of less efficient transmission facilities in general. So far I have not missed one when comparing the reduced VOA schedule with HFCC, but still I could have overlooked something.

In fact the closure of all VOA broadcasts in Spanish had been provided already by this budget request as well. It even went further and stipulated a closure of the VOA broadcasts for Tibet, too. Obviously management did not dare to really eliminate them even now, although Congress should have lost all real influence in such matters now, or can they even under the current legal situation safe specific services by restoring its funding?

Also stipulated in the 2013 budget request was the closure of Radio Free Iraq, apparently now executed as well. Some Radio Sawa programming has yesterday been reported on the Kuwait 1593 kHz transmitter instead, perhaps still carrying the same program output than the FM transmitters in Iraq. TAIWAN: Radio Free Malaysia 1359 kHz, Malaysia's newest independent radio station began broadcasting on Monday 25 March. Radio Free Malaysia will be available on 1359 kHz each night between 9pm and 11pm local Malaysia time from the Taiwan Tx site. (Alokesh Gupta dxld, 25 Mar)

EUROPE, AFRICA, AND MIDDLE EAST

FRANCE: It may have gone largely unnoticed but the France Info transmitter at Nice-Fontbonne (1557 kHz) was down for a few days in December. Rumors had been going around that it would be closed for good, but not so; it came back after a few days. Christian Ghibaudo from Nice now tells me that this was due to the fact that it was moved to yet another location, namely Col de la Madone. It had already been moved in 2003 from Antibes to Fontbonne. The Col de la Madone station now hosts four MW stations, the two TWR frequencies 702 & 1467 kHz as well as the "French" frequencies 1350 kHz (Radio Orient) and 1557 kHz (France Info). The Fontbonne towers have been dismantled. Regards, (Rémy Friess, Feb 21, BDXC-UK yg via WORLD OF RADIO 1658. DXLD)

GERMANY: The three mediumwave transmitters in Saxony are now silent. As last one left Wilsdruff the air at 0937 UT, as first one Reichenbach between 0805 and 0815. Wiederau has been turned off in between, also after 0900 or even 0910 I think.

The whole closure turned into a funny mess, caused by the elaborated approach to air a retune loop. At 0400 sharp the playout of this loop stopped (must have been programmed this way), leaving open carriers on 783 and 1044 while at Reichenbach the silence detector kicked in and put MDR Info on air again. Shortly afterwards the 783 carrier went off. It is not known so far if this was done manually by an engineer or, as I assume, by an automated system that cuts the carrier when there is no program audio, perhaps related to the DCC system installed only on this transmitter.

At 0700 sharp the playout of the loop resumed and Reichenbach rejoined the regular feed. So all three transmitters again carried that brainwashing stuff until they have finally been turned off as described above. And so ended the era of AM broadcasting in Saxony with a blunder that perfectly fits my opinion about MDR. Now we're curious what we may hear on 783 and 1188 (on 1044 it's San Sebastián anyway) when night comes... (Kai Ludwig, dxld 6 May)

GREECE: Changes to ERA mediumwave stations in Greece were observed on remote receiver locations in Greece and Italy. 927 kHz ERA, Zákinthos is confirmed to be inactive (18.05.2013), observed on a remote receiver situated directly in Zákinthos, close to the tx site. 1314 kHz ERA, Tripolis apparently has been reactivated, it was received (//981, 1008, 1260 kHz) today (May 18) on a remote receiver in southern Italy. (Björn Tryba 18 May via mediumwave.info)
