NRC Publications is now accepting orders for the 34th Edition of the **NRC AM Radio Log**. This began final production shortly after the Minneapolis convention, and should be shipping by the time you read this. The member price is good for NRC and IRCA members. The member price is \$22.95 (media rate); \$26.80 if you want this shipped via Priority Mail. The non-member price is \$28.95 (\$32.80 if you want this shipped via Priority Mail). Also new from NRC Publications is the 7th Edition of the **NRC AM Pattern Book**, which began shipping following the Minneapolis convention. Prepared by noted DXer Paul Swearingen, it is an all-inclusive book of day and night operation patterns for stations in the United States, Canada and selected foreign countries. The data sources for the information come from the 34th NRC AM Radio log and the comprehensive Mexican station listing put together by noted DXer John Callarman. A Quest to Save AM Before It's Lost in the Static By Edward Wyatt / New York Times – 12 hours ago

WASHINGTON — Is anyone out there still listening? The digital age is killing AM radio, an American institution that brought the nation fireside chats, Casey Kasem's Top 40 and scratchy broadcasts of the World Series. Long surpassed by FM and more recently cast aside by satellite radio and Pandora, AM is now under siege from a new threat: rising interference from smartphones and consumer electronics that reduce many AM stations to little more than static. Its audience has sunk to historical lows.

But at least one man in Washington is tuning in.

Ajit Pai, the lone Republican on the Federal Communications Commission, is on a personal if quixotic quest to save AM. After a little more than a year in the job, he is urging the F.C.C. to undertake an overhaul of AM radio, which he calls "the audible core of our national culture." He sees AM — largely the realm of local news, sports, conservative talk and religious broadcasters — as vital in emergencies and in rural areas.

"AM radio is localism, it is community," Mr. Pai, 40, said in an interview.

AM's longer wavelength means it can be heard at far greater distances and so in crises, he said, "AM radio is always going to be there." As an example, he cited Fort Yukon, Alaska, where the AM station KZPA broadcasts inquiries about missing hunters and transmits flood alerts during the annual spring ice breakup.

"When the power goes out, when you can't get a good cell signal, when the Internet goes down, people turn to battery-powered AM radios to get the information they need," Mr. Pai said. He admits to feelings of nostalgia. As the son of Indian immigrants growing up in small-town Parsons, Kan., he listened to his high school basketball team win a 1987 championship, he said. "I sat in my bedroom with my radio tuned into KLKC 1540," he recalled. On boyhood family road trips across the wide Kansas plains, he said, AM radio "was a constant companion."

But that was then. In 1978, when Mr. Pai was 5, half of all radio listening was on the AM dial. By 2011 AM listenership had fallen to 15 percent, or an average of 3.1 million people, according to a survey by Veronis Suhler Stevenson, a private investment firm. While the number of FM listeners has declined, too, they still averaged 18 million in 2011. (The figures are averages based on measuring listeners every 15 minutes.)

Although five of the top 10 radio stations in the country, as measured by advertising dollars, are AM — among them WCBS in New York and KFI in Los Angeles — the wealth drops rapidly after that. In 1970 AM accounted for 63 percent of broadcast radio stations, but now it accounts for 21 percent, or 4,900 outlets, according to Arbitron. FM accounts for 44 percent, or 10,200 stations. About 35 percent of stations stream content online.

"With the audience goes the advertising revenues," said Milford Smith, vice president for radio engineering at Greater Media, which owns 21 stations, three of them AM. "That makes for a double whammy."

Nearly all English-language AM stations have given up playing music, and even a third of the 30 Major League Baseball teams now broadcast on FM. AM, however, remains the realm of conservative talk radio, including roughly 80 percent of the 600 radio stations that carry Rush Limbaugh. Talk radio has helped keep AM alive.

"If it had to rely on music," said Michael Harrison, editor and publisher of Talkers magazine, "AM radio would be dead."

But why try to salvage AM? Critics say its decline is simply natural selection at work, and many now support converting the frequency for use by other wireless technologies. A big sign of AM's weakness is that one hope for many of its stations may be channeling their broadcasts onto FM

Not so fast, said Mr. Pai, who has been pushing the F.C.C.'s interim chairwoman, Mignon Clyburn, to put the revitalization of AM high on the agency's agenda.

"I'm obviously bullish on next-generation technology," Mr. Pai said. "But I certainly think there continues to be a place for broadcasting and for AM radio."

Mr. Pai said he was not promoting AM to advance conservative talk radio, but part of his prescription treads a traditional Republican path. He wants to eliminate outdated regulations, for example, like one that requires AM stations to prove that any new equipment decreases interference with other stations, a requirement that is expensive, cumbersome and difficult to meet.

Mr. Pai also wants to examine a relatively new technology known as HD Radio, which has allowed some stations to transmit a digital signal along with their usual analog wave, damping static. (HD Radio is a brand name; it does not stand for high definition, as in HDTV.) But some critics still fault the F.C.C. for allowing too many broadcasters to crowd into a relatively narrow AM band of airwaves. In the longer term, Mr. Pai said, the F.C.C. could mandate that all AM stations convert to digital transmission to reduce interference. Such a conversion, however, would cost consumers, who would have to replace the hundreds of millions of AM radios that do not capture digital transmissions. Finally, Mr. Pai wants the F.C.C. to consider what are called FM translators, which send duplicate AM broadcasts over FM airwaves and help to reduce interference. In 2009, the F.C.C. granted permission to AM stations to use such translators.

"Our business has improved rather dramatically" since the conversion to dual bands, said Bud Walters, owner of Cromwell Group, which operates 23 stations in four states, six of them on the AM band and five of which share translators.

The F.C.C. has said it is behind Mr. Pai, although it is a long way from committing to the overhaul he envisions. In August the commission approved a measure requiring the builders of any new radio tower to compensate an AM station if the tower interferes with the station's broadcast. Some station owners want more. David Honig, the president of the Minority Media and Telecommunications Council, said that the F.C.C. had before it 37 proposals that would expand opportunities for minority ownership but do not require giving minority-owned radio groups special rights. Two-thirds of minority-owned radio stations broadcast on AM.

The reality, however, is that even if the F.C.C. reduces regulation and provides compensation for AM stations, it cannot repeal the laws of physics.

Nearly every recently manufactured electronic consumer product — not just proliferating smartphones but televisions, home air-conditioning systems, refrigerators, computers and even energy-saving fluorescent light bulbs — emits radio signals that can interfere with AM broadcasts.

The economic boom of the 1980s and 1990s also contributed to the problem with an increase in the construction of tall buildings in suburban areas and beyond, blocking AM signals. Another issue is that the F.C.C. requires most stations to turn off or greatly reduce signals at night, a rule aimed at keeping high-powered AM stations from interfering with smaller local ones.

(The rule, which hardly engenders loyalty among listeners, was adopted because of the way radio waves in the AM frequency travel. Once the sun goes down, AM signals bounce off the ionosphere and reflect back down to earth hundreds of miles from where they originated. That is why listeners of WRDN-AM (1430) in Durand, Wis., for example, on some nights discover they are inadvertently tuned

in to a broadcast from St. Louis.)

Mr. Pai said that unless the problems with AM radio were fixed, people would keep fleeing. "There are plenty of other options," he said. "They will switch the dial to something else."

LAS CRUCES – A nearly \$4 million deal to sell the four Radio of Las Cruces stations could be finalized before the end of the year.

The stations are KGRT-FM-104 Great Country; KSNM-AM 570; KHQT-FM-Hot 103; KKVS-FM-Viva Vista 98.7.

Allen Lumeyer and partner Judy Hunt operate Radio of Las Cruces. Lumeyer said that there has been agreement for the sale but the FCC still must approve the transaction.

"When you deal with the FCC, things are complicated," Lumeyer said.

He hopes the approval will come within 90 days.

The stations are being sold to a new company called Adams Radio Group. Lumeyer said its owner, Stephen Adams, lives in Delaware, and new president Ron Stone, is based in Minnesota. He said that Adams Radio Group plans to build a larger company, but that the Las Cruces stations are their first purchases.

The actual price of the sale is \$3,963,625. There are 30 employees in the company. Lumeyer said that, as far as he knows, there are no plans to change the format of the stations or make major adjustments.

"They do not anticipate any changes," he said.

Luis Bautista is not concerned about any possible switch, except for one station.

"They can

charge Viva Vista, KGRT and KSNM, but leave Hot 103 alone," he said via the Sun-News Facebook page.

"I hope they will still broadcast NMSU sporting events," Brian Theodorson said.

Lumeyer said the stations are actually owned by two different companies. A company called Sunrise owns KSNM and KGRT while Richardson Commercial Corp. owns KHQT and KKVS. Brook Stockberger may be reached at 575-541-5457

- + 1203 9/19 choral NA finishes, full ID for XEPL on 91.3 and 550, 24 hours, "La Súper Estación;" 1204 consumer program with YL called 'R Express.' Cantú: XEPL + FM 91.3 5,000 150. (GH-OK)
- 560 MÉXICO, XEXZ, Zacatecas, Zac. 1151 9/8, after song lyrix "alma de niña, cuerpo de diosa," ID mentions 93-3, so the only match there in Cantú is: XEXZ + FM 93.3. 5,000 1,000. (GH-OK)
- 570 MÉXICÓ, XEBJB, Monterrey, NL. 0520 9/8, Mexican music is dominating, southwest-ish, then PAN ad, next break 0524 a promo for Monterrey Televisión, so it`s XEBJB, supposedly 500 watts night per WRTH 2013 and IRCA Mexican Log 2012. (GH-OK)
- + 1142 9/12, PSA string, mostly federales, "escucha Noti-R 570," sounder, then mentions Monterrey, so as expected it's XEBJB, aka just "R 570" en Cantú, IRCA and WRTH; and a departure from the NORteña/RANchera format as in IRCA Log. Also produces a low rumbling het, as it's slightly off-frequency to the hi side. Often it's just the het bothering other stations such as KSNM which I had suspected of being the culprit. It's not unusual for mostly musical XE stations to include a morning news block and this may be one of them. (GH-OK)
- 610 MÉXICO, XEGS, Guasave, Sin, La Ley. 0548 9/10, promo for 106.1 FM, maybe "La G-S," what a nice FM/AM match, as in Cantú: XEGS + FM 106.1 1,000 500. (GH-OK)
- 620 MÉXICO, XEBU, Chihuahua, Chih, La Norteñita. 1205 9/9, Mexican NA goes tó Chihuahua SA, so as expected, XEBU, dominant XE on 620 here; Cantú: XEBU + FM 91.7 5,000 1,000. Though this time it's under sports talk in EE, surely KTAR Phœnix; my nearest 620, KMIK Plano TX Disney (hijacked from KWFT Wichita Falls), is easily overcome, tho on daytime groundwave it conspires with 640 Moore to inundate 630 with IBOC noise; otherwise Denver or St Louis might barely make it. (GH-OK)
- 660 MÉXICO, XEABC, Cuidad Delicias, Chih, La Lupe. 1207 9/10, some Mexican is playing "Mañanitas;" 1209 TC for "6:07 en La Lupe," ie per Cantú: XEACB + FM 98.9. 3,000 1,000. (GH-OK)
- 670 MÉXICÓ, XETOR, Torreón, Coah, R Ranchito. 1201 9/9, just as I start SRS MW session, ID as "R Ranchito, del Grupo R México," revealed by Cantú as: XETOR 1,000 250. This signal quite weak compared to many more XEs still skywaving in the low band from further west. (GH-OK)
 - + 1159 9/12, Grupo R México has job openings, qualifications specified, then full ID for R Ranchito, street address, etc, Torreón, con mil vatios. (GH-OK)
- + 1201 9/19, XETOR, with full ID atop the channel but never very strong. (GH-OK)
- 680 MÉXICO, XEORO, 1210 9/11, local wakeup host with saludos a pescadores, ganadores (fishers, cattle-raisers), mentions Guasave, norte de Sinaloa, so it`s XEORO again, 1/0.5 kW per Cantú. 1212 promo a Saturday show at 11:30-1; 1215 losing to sportstalk in EE, presumably KNBR. (GH-OK)
- 700 UnID. 1200 9/11. I am again hearing that open carrier with a hum, while several NW Mexicans are still propagating in the 600s and 700s. (GH-OK)
- MÉXICO, XEGD, Hidalgo del Parral, Chih, La Poderosa. 1145 9/12, W&M with news in SS from datelines all over the country, loops SW (discounting NE). Suspect same station as I have been hearing recently with nothing but hum, likely this as in Cantú: + FM 90.3. 5,000 1,000. But can't completely rule out: XEDKR R Red AM Guadalajara, Jal. 10,000 150. Retune 1201, probably same station and now Jalisco is less likely, almanac for 12 de setiembre including: something about Katharine Hepburn with a movie clip in EE; 1953 Stalin to Khrushchev; 1989 Luna-2 launched; 1989 Germany algo; 1998 peace in N Ireland; 2010 Chile miners rescued; 1204 UT "Noticias MVS" acknowledging Canal 5 and 97.3 FM. This however originates with 102.5 in the DF, XHMVS. I also logged MVS news April 25 but couldn't find an affiliate on 700; see DXLD 13-18. (GH-OK)
- 710 MÉXICO, XEDP, Cuauhtémoc, Chih. 1210 9/11, discussion of August (or Sept?) 4+ Richter earthquakes near Parral and Jiménez [short versions of town names], no doubt usual XEDP, 7/0.1 kW per WRTH. (GH-OK)
- 720 MÉXICO, XEDE, Saltillo, Coah, La Kaliente. 1150 9/12, "La Kaliente" slogan with 105.7, ie this by itself now, but which all evening is the SAH nemesis of WGN, per Cantú: XEDE + FM 105.7, 8,000 250. (GH-OK)

- 720 MÉXICO, XEAVR, Veracruz, Ver, R Fórmula 1er Cadena. 1144 9/19UT, mentions Grupo Fórmula, SEP PSA, ad for ranchera CD to celebrate independence, 1146 a R. Fórmula full ID but too much QRM; includes an FM frequency with an 8 in it and 720 AM. Therefore per Cantú it can only be this one, sunrise now late enough for the east coast still to be propagating: XEAVR + FM 89.1, 10.000 250. (GH-OK)
- 770 **UniD**. 1141 9/11, just a hummy carrier, and still so at 1210; loops SW/NE. Suspect an XE; Chihuahua's XEGD would fit for that. Previously logged XEETCH further NW in Sonora with real modulation. (GH-OK)
- 780 MÉXICO, XEWGR, Monclova, Coah, Exa FM. 0502 9/14, Coahuila state anthem is playing, confirmed by later comparing to http://www.nava.gob.mx/documentos/ himnocoahuilense.mp3 courtesy of the city of Nava, which also displays the complete lyrix. Roughly opposite direction from WBBM which could not be nulled, but enough signal by comparison, unlike at 0505 when WBBM is starting `When Radio Was` with music theme. Therefore, it's the only Coahuilense on 780, XEWGR, 5/0.25 kW, 24 hours per IRCA Mexican Log. KSPI OK has been behaving itself lately without open carrier all night, tho it would be nullable. (GH-OK)
- 800 MÉXICO. 1149 9/15, big slow SAH between XEROK and KQCV OKC, 50 per minute equals 5/6 of one Hz separation. (GH-OK)
- 850 MÉXICO, XEM, Chihuahua, Chih. 0503 9/14, classic rock in EE, so it must be a Mexican: yes, 0505 ID as Milenio R and another CR tune in EE. XEM, 5/1 kW, KOA nulled but hardly necessary. (GH-OK)
- 870 MÉXICO, XÈTAR, Guachochi, Chih. 1206 9/8, tune-in, talk in Indian language, but pronounces XETAR in SS; soon live YL DJ back in SS mentions "La Voz de la Sierra Tarahumara." (GH-OK)
 - + 1213 9/10, obviously XETAR, playing a "Mañanitas" version by Chipmunks (double pitch voices), hee hee, including EE "happy birthday to you" twice or thrice. So there's another exotic language on this indigenoustation. (GH-OK)
- 880 MÉXICO, XEV, Chihuahua, Chih. 1158 9/17, "Grupo Fórmula" promo, slow SAH with KRVN. Ergo it`s XEV, 5/0.25 kW; by 1200 losing out to a cappella hymn, probably KLRG Arkansas. (GH-OK)
- 880 UnID. 1215 9/10, "La Rancherita de..." slogan, CST TC for 6:14, YL DJ, then 6:15 TC and federal PSA for reforma educativa, so no doubt it's a Mexican. Zone means it has to be a change for one of these two in Cantú: XEV R Fórmula + FM 101.7 Chihuahua, Chih. 5,000 250. XEPNK Planeta + FM 103.5 Los Mochis, Sin. 10,000 2,000. The "Rancherita" in Los Mochis is listed as 1450, XECU which might have swapped; however, Cantú has no Chihuahua-city AM or FM stations by that name, so it's a market ripe for its own Rancherita. At this time there was not much KRVN from north but nulled it anyway. Not to be confused with mere non-diminutive "La Ranchera," newish identity of WMDB in Nashville TN on 880 as heard yesterday a few minutes earlier. One is relying on neither station ever varying its slogan. (GH-OK)
- CUBA. 0515 9/13, SS discussion of cathedrals and their addresses in Habana; DF also fits for Cuba. WRTH 2013 shows 200 kW R. Progreso, CMBA from Chambas, Ciego de Ávila and one low-power elsewhere on 890; 200 kW, the highest MW power now listed for Cuba, also applies to one of the numerous Rebelde transmitters on 710 at same site, and another site on 1180. This 890 does not have the punch would expect from all those kW. Not much signal from WLS at the moment, and the CCI in SS is normally from gospel-huxter KVOZ Del Rio TX, thought to be failing to protect WLS at night and even running day power of 10 kW ND at night instead of 1 kW directional. Worse, it's almost opposite here from Chicago, making it hard to null in favor of WLS. CMBA soon fades and later KVOZ is back. (GH-OK)
- 900 MÉXICO, 1142 9/16, two M are chatting and laughing, good dominant signal, XÉW? Switch to reporter about crimes/accidents in the Estado de México, and an item about buses. This is Independence Day, so likely to be programming disruptions, more stations relaying output from the DF than usual, as heard on several other frequencies from other sources. Here, promo for "Siempre en 88.9," 1146 adstring. Of the six 900s in Cantú, five have other FM frequencies, no 88.9s, and one without. But in the FM list, that slogan checks out as: 88.9 XHM Siempre 88.9 México, DF 90,000 which I got on FM DX years ago when it had some other identity. So which station on 900 would be mentioning it more than once? The DF lineup shows XHM is in the Grupo Acir, so the 900 would unlikely be XEW. Which 900s are in Grupo Acir? 2012 IRCA Log shows the only one is XEOK Monterrey, 10/0.25 kW, which is certainly likely now on day power. (GH-OK)
- 900 MÉXICO. 1206 9/19, choral NA running late or a very long version, loops SW, 1207 full ID mentions Cuauhtémoc, 98.3, maybe ACIR R group, and maybe "R Impacto" ? Cantú has another but related slogan: XEDT Hits FM + FM 98.3 Cd. Cuauhtémoc, Chih. 5,000 1,500. Googling XEDT leads to yet other names, possibly outdated: R Divertida, and La Reina. However, not on the ACIR station list at http://www.grupoacir.com.mx/ cobertura_nacional.php nor any other in that city. (GH-OK)

- 920 UnID MÉXICO. 1201 9/17, instrumental NA, nonetheless multi-verse, and losing out to QRM before any ID. Which XEs are in the UT-6 zone, likely 6 am time to be antheming? One of these two per Cantú: XEQD Romance + FM 95.7 Chihuahua, Chih. 1,000 250, XECQ La Nueva Ranchera + FM 104.1 Culiacán, Sin. 5,000 500. (GH-OK)
- 980 MÉXICO, XEDCH, Ciudad Delicias, Chih, La Romántica. 1209 9/19, choral NA ends, either late or very very long version, long pause, and 1210 announcement does not seem like full ID but unreadable. Yet assuming it's in the UT -6 zone, playing NA around 6 am local, Cantú shows only this: XEDCH + FM 102.1 1,000 1,000. (GH-OK)
- 1000 MÉXICO, XEFV, Ciudad Juárez, Chih. 0600 9/6, choral NA playing here too, and it too is over by 0602 retune when back to other music; at times dominating KTOK OKC, and from experience I know this one is XEFV, no daytimer despite Cantú as such; altho there are another Chihuahuan and two Sinaloans also in UT -6. (GH-OK)
- 1030 MÉXICO. 0600 9/6, choral national anthem, with CCI and SAH, already over at 0602 retune and may have missed an ID. I was hoping there would be only one XE in the UT-6 zone since NA habitually plays at local midnite (except UT Mondays when it may accompany earlier 'La Hora Nacional' instead), but IRCA and Cantú show there are two: XEYC in Juárez, Chihuahua, and XEMPM in Los Mochis, Sinaloa. (GH-OK)
- 1180 MÉXICO. 1218 9/8, pause in music for nothing but a "6:17" TC in SS, with N/S Omaha nulled, but avoiding IBOC noise from E/W KFAQ 1170 Tulsa only by off-tuning to 1178 or 1179. In Cantú there are two in the UT-6 zone: XEUBS R UABCS La Paz, BCS, 10,000 D, XEJK Ke buena + FM 95.3 Cd Delicias, Chih. 5,000 1,500. Likely the latter as it unseemed non-commercial. Soon faded out. (GH-OK)
- 1190 UnID. 1207 9/17, SS with language lesson by YL about words: colateral; "protagónico" does not exist despite related words protagonista, etc. 1208 on to Mexican news about tormentas tropicales hitting both coasts with clips of various officials; 40,000 turistas affected in Acapulco; 1215 losing out to CCI. Certainly sounds like a Mexican, but some US stations do too; loops close to E/W indicating one of these unlikely XEs in Cantú: XEMBC Canal 1190 AM Mexicali, B.C. 250 100, XEPZ R Norteña Cd. Juárez, Chih. 5,000 100. Another possibility is the one US SS station westward: KNUV Tolleson AZ, Grupo Fórmula, La R Excelente, 5000/250 U4 per last year's NRC AM Log. Strangely, own website http://www.1190-am.com/index.php/programacion does not show any programming between 7 pm and 7 am (0200-1400 UT) as if it were a strict daytimer. (GH-OK)
- 1410 MÉXICO, XECÉ, Los Mochis, Sin, La Mexicana. 1217 9/17, SS ad in pesos, SAH of about 5.5 Hz with probably Wichita, loops WSW/ENE; ad for Universidad del Pacífico Norte with phone number, two or three gobierno del estado PSAs, mentioning Sinaloa, "información al momento" by calling phonumber. Then lists several AM and FM stations including 1270, 102.7, 94.3, 101.3, 93.3, 1410, including Mazatlán, Los Mochis, on "cadena en vivo," so doubtless it's the only 1410 Sinaloan, Cantú: XECF + 93.3 FM, 10,000 500. (GH-OK)
- 1520 UnID MÉXICO. 1158 9/16, KOKC OKC has heavy QRM making a fast SAH in SS, talking about el Día de la Independencia, 1159 YL wrapping up her show. Too much KOKC QRM to catch any ID as KOKC goes from WSJ to CBS World News Roundup at 1200. Can't null out one or the other, but by proximity likely one of these in Cantú: XEVUC La Norteñita Allende, Coah. 1,000 D, XEYP Imagen + FM 93.9 Cd. Mante, Tamps. 1,000 500. Not the first time I have had such an unID; unlikely to be a US station as none in the area, nor listed as SS even in TX. (GH-OK)

XEVT-970, Villahermosa, Tab (harmonic). 1131 9/11, M&M (instead of usual W&M) with news in SS vs noise level, and those annoying on-and-off local bursts every few minutes at 1134 and 1137; 1135 a bit stronger with 6:35 timecheck; 1138 mentions industria petrolera; 1139 peak with a string of addresses mentioning Villahermosa. XEVT, 3 x 970, is indeed still here for another season. Tnx to VL&T staying on 4910, now it's easy to home in on 2910 which is 2 MHz lower on the FRG-7. (GH-OK)
