Mike Sanburn of Bellflower CA sends along the following from Bruce Portzer of Seattle WA and Walt Salmaniw, via IRCA IO group dated 5/12/19:

According to the FCC website, KVOK went silent on May 7 and has a STA to remain silent while it finds a new transmitter site:

"KVOK (560 Kodiak AK – ye ed) has been forced to suspend operations due to loss of the station's transmitter site. KVOK has been operated using a more than 70 year old tower leased from the United States Coast Guard (USCG). The USCG has reached a decision to terminate that lease and dismantle the tower. Licensee is searching for an alternate site for the station, but must suspend operations until such a site is found and constructed." It sounds like they'll be off for at least a few months.

KVOK on 560 was NOT on the air when we spent the day last week in Kodiak. Not sure whether temporary or permanently off.

A poor to very poor signal was noted mixing with WMBS under CJCL before fading to the aforementioned stations. (PS-ON)
- 980 (WTEM) DC, Washington 5/20 0230 noted totally off the air on a rare silent period; the frequency was wide open for the first time in the few years in Laurel. (RW-MD)
 - WULRt SC, York 5/20 0315 tentatively noted with an ID that sounded like "Radio Nueva Vida" (their slogan is "Radio Cadena Vida", which makes it easy to mistake "Nueva" with "Cadena") in the mess; occasionally peaked with several stations mixing. The station's pattern shows a westnorthwest/south-southwest/east-southeast lobe pattern. WAZS 980 IDs as "El Sol Nueve-Ochenta", which doesn't match; noted rap music in
 Spanish at 0305. According to Radio Locator, WAZS and WULR are the only Spanish language stations on 980 on the East Coast. (RW-MD)
 (WULR has occasionally forgotten to cut to night power; I've heard them in the Saint Louis area – eb)
 PA, Oil City – 5/20 2316 noted on after sunset with plenty of Fox Sports Radio promos, local spots that included two that mentioned Pennsylvania, into The Jason Smith Show. A fair to poor signal was noted, mixing with KMOX. (PS-ON)

 KY, Florence – 5/20 2300 noted with "Christian Talk WCVX" ID into Through the Bible. A fair at times to very poor signal was noted, mixing with

- 1160 WCVX WCCS and WCXI. (PS-ON)
- MI, Kingsley 5/19 0043 noted on after sunset with local spots, mentions of WJML 1110, Traverse City and Petoskey. A poor to very poor signal 1210 WJNL was noted, mixing with WPHT. (PS-ON)
- 1220 WFKN KY, Franklin – 5/19 0055 noted with a Country format, missed legal ID at 0100, possible news, weather forecast by a female announcer, "WFKN"
- ID into another music set. A poor to very poor signal was noted, mostly under WHKW. (PS-ON)

 SC, Greenville 5/17 0031 noted with Christian music in Spanish, "Nueva Vida" mention into another music set. Possibly on day power. An occasionally fair to very poor signal, mixing with WCCR and WRIE; confirmed via Tune-In Web stream. (PS-ON)

 NC, Asheville 5/22 0052 noted with Community Calendar read by a male announcer, mentioning revivals, camps and other church-sponsored 1260 WPJF
- 1380 WKJV events; many mentions of Area Code 828 and North Carolina. "The King's Radio" mentioned at 0055, gave contact information for publicizing events on the *Community Calendar*, including a mailing address, fax number and the Web site; WKJW 1010 also mentioned before USA Radio Network news. A fair signal was noted at first, becoming poor to very poor. (PS-ON)

- OH, Fostoria 5/20 0046 noted with ESPN promos, ESPN Sports Center All Night sports talk program, local spots including one mentioning Area 1430 WFOB Code 419 and Ohio, missed legal ID at 0100. A fair to very poor signal was noted, mixing with CHKT, WXNT and an unidentified oldies station other than KZQZ. (PS-ON) (WVAM is also listed as ESPN; your Oldies station may be WYMC Mayfield KY – eb)

 NJ, Hackettstown – 5/11 1857 noted with "The Best Music; The Most Variety, WRNJ" ID by a male and female announcer team. The signal was noted mixing with WFAI, WLAC and WWSM. (KK-VA)
- 1510 WRNJ
 - WFAI NJ, Salem - 5/11 1916 noted with an Urban Gospel format, "Faith 1510, Home of the Charlie... Show; weekdays starting at 10:00 am on Faith 1510" mention by a male announcer. The signal was noted mixing with WLAC, WRNJ and WWSM. (KK-VA)
 - WWSM PA, Annville/Cleona 5/11 2000 noted with a Bluegrass music program, "This is WWSM" ID by a male announcer. The signal was noted mixing with WFAI, WLAC and WRNJ. (KK-VA)
- 1530 WLLQ NC, Chapel Hill - 5/11 2001 noted with a Regional Mexican format, "WRTG (AM Garner), WLLQ AM Chapel Hill... La Grande" legal ID in heavily accented English. The signal was noted mixing with WCKY, WCTR, WVBF and unidentified stations with vocal music and a Country format. (KK-VA) (Two possibilities for your unidentified Country station; WLCO Lapeer MI or WLIQ Quincy IL – eb)

AUSTRALIA: John Smith in Brisbane reports 1197 Brisbane is off air. 9 Feb. (ARDXC)

Listeners of commercial radio stations 2EC in Bega, 2XL in Cooma and 2GN in Goulburn may soon be retuning their radios if the ACMA accepts proposals by the stations. The proposals would see 2EC, 2XL and 2GN swap from AM to FM transmission in Bega, Cooma and Goulburn respectively.

'FM radio provides improved audio quality for listeners in regional areas and can be more cost-effective to operate than AM radio,' said ACMA Chair Nerida

A number of regional commercial radio stations are seeking to convert their services to FM under an industry-led conversion program. The ACMA will facilitate a conversion after taking a number of issues into account. These include availability of suitable spectrum and being satisfied that audiences in regional areas do not lose radio services under that proposal,' Ms O'Loughlin said. (ARDXC)

COOK ISLNDS: Radio Cook Islands to close AM. The following has just been posted to the NZ Radio DX League's club newsgroup by Adrian Sainsbury of RNZI: From Radio Cook Islands, "The Cook Islands Investment Corporation will begin dismantling our AM Radio mast out at Matavera. The mast was installed around 1970 and I remember seeing it being worked on around 1990 but since then no maintenance has been done on it. Government owns it and Bluesky maintains it. Anyway, it is a hazard at the moment as sections of it are rusting and so it needs to come down. It will affect our radio service reach. We have FM around the island and in the Outer Islands via the Government but the reach is not that good. I think radio is kind of like a low priority for anyone these days. The AM has been useful in that in can reach all the way to Penrhyn." This news is in contrast to Samoa where 2AP 540AM has had a reprieve thanks to AusAid replacing the AM Mast in Apia. INDONESIA: Japanese DXer Hiroyuki Okamura reports a new Radio Republik Indonesia outlet at Ranai in the Riau Islands [located between the Malaysian mainland and Borneo. BC] heard on 1467 at 1800 on 10 February. Research by Jari Savolainen has uncovered a report that Indonesian telecommunications company Catur Mitra Adhikara completed the transmitter installation on RRI Ranai in 2018. RRI Ranai is located on Natuna Island. The transmitter installed by CMA for RRI Ranai is the Gatesair transmitter for AM of 10 KW and Gates for FM for 10 KW. The installation is also equipped with Orban audio processor. The Orban Optimod 9300 is used for AM and Orban Optimod 5700 for FM. The 10 KW Gatesair AM transmitter provides unmatched audio performance, better coverage, simple operation, lowest operating costs and the highest reliability from any medium-wave transmitter. (DXing.info via NZDXRL)
On 24 February we had propagation to Western Australia, Indonesia and Thailand. That Indonesian on 1584.7 could be Radio Suara Kemal, but I have heard

JAPAN: According to March 27 edition of Sankei Shimbun and April 4 edition of Tokyo Shimbun, Japan Commercial Broadcasting Association (JBA) required the following main items at the meeting of experts in Ministry of Internal Affairs and Communications (MIT) held on March 27.

1) System modification before 2028 to enable AM broadcasters to convert FM by their own judgment,

2) Permission before 2023 to enable AM broadcasters to stop AM broadcasting experimentally for a long period.

It is said MIT fears China will occupy and dominate the vacant AM (MW) band. The president of NHK, Ryoichi Ueda, said at the press conference on April 4. NHK will continue to broadcast on AM, because, by the Japanese broadcasting law, NHK is under the obligation to completely cover the whole territory of Japan. According to JBA, there are 207 members in April 2018. Among them are 15 MW, 1 SW, 32 AM+TV broadcasters. (Takahito Akabayashi via wwdxc BC-DX TopNews April 6)

KOREA, NORTH [non]: Communist North Korea is about to get hit with a massive new radio signal carrying the message of Christ's love like never before. "It's an AM station, 250,000 watts, which will clearly cover North Korea," said Ed Cannon, president of Far East Broadcasting Company, also known as FEBC.

For over 75 years, FEBC has been using radio signals to send the message of Jesus Christ around the world.

Cannon says this new "super station" will be erected close to the border of North and South Korea.

"We've secured a location on the western coast of South Korea just a few miles south of the Demilitarized Zone," Cannon told CBN News. "It's a perfect location because the signal goes across the ocean for a few miles and then goes right into North Korea.'

FEBC's president says the radio signal will launch in a few months and will carry gospel programs produced from neighboring South Korea.

"The strategy of our organization is to use indigenous people in their native language to produce programming," Cannon said. "We have a large segment of South Korean people broadcasting and we also have a number of escapees, refugees from North Korea, who've come to our organization."

Cannon claims the signal will be "unblockable" by North Korea's regime and will "reach far past the northern boundary of North Korea covering the entire

country with the message of Jesus Christ."

According to its website, FEBC's broadcasts can be heard in 107 languages and 49 countries from 149 stations and transmitters.

"Our goal in North Korea is the same as it is in all of our other countries: to share the gospel through radio so that people will be inspired to follow Jesus

Christ as their Savior," Cannon told CBN News in an earlier interview.

North Korea is the most dangerous country in the world for Christians. Cannon says anyone caught listening to FEBC programs faces severe consequences. "The {North Korean} refugees themselves say 'pray for courage, pray for perseverance' because the Christians are reaching out in ways to gather together in the Name of Christ, to pray together, to listen to the radio together, and they are willing to endure severe persecution," Cannon told CBN News.

Each year, Open Doors USA releases their World Watch List, a ranking of the 50 countries where Christians face the most persecution. North Korea has

taken the top spot for 18 years in a row.

"If Christians are discovered, not only are they deported to labor camps as political criminals or even killed on the spot, their families will share their fate as well," Open Doors asserted on their website. "Christians do not even have the slightest space in society, on the contrary, they are publicly warned against." NEW ZEALAND: Radio Reading Service on 1602 went off the air on Saturday morning 23rd February after a last-ditch plea to the Broadcasting minister failed. In a final attempt to save the service's funding, Radio Reading Service founder Allen Little wrote to Broadcasting Minister Kris Faafoi, in an appeal to change NZ On Air's decision to cut the station's funding of \$110,348 a year. The Levin-based station provided news and entertainment to the print-disabled community. In a letter to Little, Faafoi said he was unable to intervene in NZ On Air's funding decisions. The letter explained NZ On Air fund a number of services available for the to Little, Faariol said ne was unable to intervene in NZ On Air's funding decisions. The letter explained NZ On Air fund a number of services available for the disabled community, including access radio stations and audio descriptions of screen content. The service has not been able to secure another significant source of funding. NZ On Air spokeswoman Allanah Kalafatelis said there are now a wider range of accessibility services available to the disabled community, and the Radio Reading Service's small audience made justifying funding difficult. Levin's Radio Reading Service has been providing news and entertainment for the "print disabled" since 1987. A print-disabled person is anyone who cannot see, hold, understand or access printed literature. NZ On Air stopped its funding of \$110,348 last June after giving notice in June 2016. Update on Henderson (Auckland) Transmission Masts: To keep RNZ on-air, a massive amount of work is regularly being done behind the scenes by a small transmission team. The recent re-guying work on the masts at the Henderson AM site is a notable major project. Henderson is one of the six high power AM sites serving a population of more than 1,400,000. It has 13 co-siters. There are two masts at the Henderson AM transmission site: 153m mast, built in 1956 and 122m mast. Services on the 153m again mast, were closed down for up to 7 hours.

mast, built in 1955. Both RNZ National and Parliament are transmitted from the 153m mast. Services on the 153m aerial mast were closed down for up to 7 hours last week (25-27 February) to allow rigging and maintenance work to be carried out to ensure we maintain 100% compliance and capacity of the structure. The work involved adding new guy attachment steelwork to the 153m mast at all levels. It was a major undertaking and very time pressured. The downtime was significant to RNZ and our co-site clients (and cricket season was starting Thursday). Steve White, Transmission Engineering Specialist, the Kordia team and their sub-contractors did a brilliant job, and safely. Work on the 122m mast will start shortly. "The news of our channel is the World Radio Network. Unfortunately, from May 1, we will have to temporarily suspend the broadcasting of our broadcasts at a medium wave frequency of 738. The reason is the consolidation of state structures in our country; therefore, the transmitting center on which our technical facilities are located has lost its independence and entered into a larger structure. And in the process of consolidation, as usual, an inspection was carried out. This check revealed that, in addition to the main facilities, there are technical means of third-party organizations, including ours, at the radio center. And if these funds of third-party organizations for more than two decades did not prevent the transmitting center from successfully operating according to its basic purpose, now they have sharply prevented the new owner. Thus, from May 1, all broadcasting from Kurkino stops. To date, these are just the two remaining transmitters. At a frequency of 612, this is the "Narodnoe Radio" and "Radonezh" and at a frequency of 738, the World Radio Network. As for us, the World Radio Network, we are doing everything possible to find a new place to accommodate our facilities and resume broadcasting on medium wave 738." SYRIA: Possible changes to MW broadcast scheme in Syria. In the near past, medium wave transmitters in Syria, which are owned by the Syrian government, used to relay feeds from dominant state-run radio stations (eg Radio Damascus/Domestic and Voice of Youth). However, that formula might have changed without

Radio Damascus/Domestic Service usually broadcasts on three medium wave frequencies, 567 (primary), 783 and 936. Yesterday (3-Apr-2019 at 1330) I noticed a mismatch in programming between 567 and 936. 936 relayed something different. It didn't take much time till I realized that I was listening to Zenobia FM. Zenobia FM is a local radio station owned and managed by ORTAS (General Organization of Radio and TV – Syria). Originally, it covers the city of Homs on a single FM frequency of 98.0 MHz, with programming specially curated to Homs's population. 3-Apr-2019 at 1830, things got really weird. 936 was relaying a feed from a privately owned radio station, Ninar FM. Till this moment, Ninar FM is still live on 936.

Note that SRTV General Program has "recently" (couple of months ago) changed its frequencies announcement. The updated one states that 567 is the only MW frequency and it's covering the entire Syrian geography. That might mean there are plans to use the other two frequencies (783 and 936) to, presumably, relay different types of programs other the main one. It's not clear yet if this move will be permanent, or whether 936 will be used to relay both stations at different times. We have to wait. (Rawad Hamwi to WOR lo group 4/4-2019)

UNITED KINGDOM: The UK regulator Ofcom has approved the frequency swap of Love Sport (558) and Panjabi Radio (1584) following a consultation. Panjabi Radio will change to 558, thus expanding its coverage area to Greater London. Love Sport, in the future on 1584, will have a smaller coverage in the north of the British capital. The station started broadcasting in 2012, but its fate in more recent years was unclear. WESTERN HEMISPHERE

ANGUILLA: In former times it appears that the local regulators in various British Overseas Territories would sometimes allow operations that were, to put it mildly, in contravention of the ITU regulations or applicable bilateral and regional agreements. This no longer seems to be the case. Per info from Ofcom, it is clear that Ofcom now has overall regulatory authority, and is responsible for such broadcasting allotments/operations and their consistency with ITU regulations. It therefore seems likely that the high power 1610 Anguilla and 530 Turks and Caicos operations no longer are in operation due to Ofcom's determination that they are inconsistent with the ITU frequency use requirements. Most particularly, use of 1610 is limited to 10 kW day and (under most circumstances) 1 kW night, and 530 broadcasting use is limited to 1 kW day, 250 watts night. So I am told. (Glenn Hauser, DXLD)

ARGENTINA: Recently while searching for information on a station, I came up with a link to a .pdf of station information for Tierra del Fuego province. With a little sleuthing and Google searching I was able to find similar .pdfs for all of Argentina. MÉXICO: At 11:30 am on Wednesday April 10th, the owner of 1090 XEPRS suddenly pulled the plug on the "Mighty 1090" (leased) sports talk format, and immediately began simulcasting 104.9 KJAV "Ultra 104.9 FM" from Alamo-McAllen, Texas, complete with Rio Grande Valley ("RGV") weather and local ads. It had been reported several months ago that BCA, the lessee for 1090 XEPRS, 105.7 XHPRS, and 1700 XEPE had been failing to make the exorbitant lease payments to the owners of those stations, reportedly at least \$100K per station per month. In December, the Tijuana politician who owns XHPRS and XEPE had kicked the BCA. (NRC's IDXD 86/15)

No one is willing to pay the ridiculously high lease payments that BCA was paying for XEPRS-1090, XHPRS-105.7, and XEPE-1700. DXpedition #3 - Sioux Passage County Park near Florissant MO By Eric Bueneman (NØUIH)

Early in the evening of May 17 2019, I decided to take my radios on another DXpedition; this time, I set up at Sioux Passage County Park north of Florissant MO, about seven miles north of my shack. Sioux Passage Park is run by the Saint Louis County MO Parks department. I set up in a gravel parking lot on the northern end of the park. This was my second choice, as my first choice, the camping and boat launch area at the northernmost end of the park was closed due to flooding on the Missouri River. It was a partly cloudy evening at Sioux Passage, with temperatures in the lower 80s Fahrenheit, dropping into the 70s by 2100 ELT, with a cooling breeze coming from the west.

This DXpedition gave me the opportunity to finally try out a homebrew longwire antenna I made for the shortwave bands; it outperformed the antenna that came with my Tecsun PL-600 receiver. This time, shortwave reception conditions favored Europe, Asia, the Pacific and the Americas. Once again, I brought the General Electric Superadio III for AM broadcast band DX. The two receivers were used for the two previous DXpeditions to Babler State Park and Marais Temps Clair Conservation Area.

When I started monitoring around 1900 ELT, daytime conditions were the rule, with mostly Missouri and Illinois AM stations being heard. During the first hour of the DXpedition, I concentrated on the shortwave signals. Sunset skip conditions set in by 2000 ELT, noting several stations carrying either the Saint Louis Cardinals baseball game vs Texas (the Rangers won 7-3) or Game Four of the Western Conference Finals between the Saint Louis Blues and the San Jose Sharks (the Blues won 2-1). Stations were heard primarily from the Midwest, but a couple of stations from the Mid-South were logged. Adjacent channel interference from the local stations were minimal to fair; stations on 830 and 860 poked through the digital sidebands from the lone digital AM station in town, KFUO 850. After 2045 power cut/pattern change, two other stations were mixing with KHOJ on 1460. I concluded monitoring around 2115 ELT. All AM stations were logged on a General Electric Superadio III; all times are ELT.

NOTES

Located in a null of KHOJ 1460's night pattern, I was able to hear WROY pretty much take over the frequency after sunset at Sioux Passage. KFNS 590 and WBGZ 1570 were stronger at Sioux Passage as they were at Marais Temp Clair, especially since the park is more in KFNS' beam toward Saint Louis. At my home QTH and at Marais Temps Clair, I can null out KFNS to pull in KXSP Omaha. The park closed for the night around 2135 ELT; all Saint Louis County parks close 30 minutes after sunset. By contrast, Marais Temps Clair Conservation Area (when it's not flooded) is open from 0500 to 2300 ELT. This was my first DXpedition since December 2018. 73 and good DX from NØUIH, the Florissant Valley Dial Twister.

DXing in Hong Kong - the Overall Verdict

5/20. In November 2013 I spent 3 nights in HK after concluding a 12-day Mainland China tour. I agree with Gary that HK is so crowded and too many "observers watching" that rolling out a Beverage antenna on an HK beach (as I have loved to do 100s of times in Hawaii when I lived there between '86 to '91 on and off) and elsewhere is nigh impossible. So loops - for their gain/directivity/noise-nulling abilities are wonderful and have nulling capabilities "on the fly" that Beverages do not. In Hawaii, a long Beverage really knocks down the high-angle Honolulu cram of signals to the point that DX overwhelms them in comparison to a loop or short-wire "A/B" testing I did there.

Hong Kong is really a tough venue for long range AM-DXing, and I had multiple warnings from Japanese, Australian and NZ DXers to lower my expectations. "Conventional" DXing with sensitive portables in a motel room is unlikely to accomplish very much, and attempting to set up a gain antenna on a public beach will definitely make you the "center of attraction" for multiple onlookers (some of whom may not have your best interests in mind). In addition to all of this are the 5 Hong Kong Locals, and a maze of Mainland Chinese stations plastering the band from 531-1593 KHz.

On the last couple of days I discovered that if I stuck the 7.5 inch loopstick CC Skywave SSB model outside the security window of our 12th floor apartment in a Shatin high rise building I could track down long range DX from Eastern Europe (1413-Vesti FM and 1548-TWR), Africa (1431-Radio Sawa in Djibouti) and the Middle East (1413-BBC in Oman) around sunrise. If I had known that trick from the beginning the long range DX results would have been much better – but we do plan a return trip next April :-)

Back to HK DXing: "I found it fascinating to DX in HK with just via a barefoot Sony ICF-SW7600GR (all I could take - three recorders/two radios but no loop, alas) but never heard the farther out stuff Gary scored there simply as I was just recording what MWDX just sounded like in HK w/o trying for exotic DX (the novelty!!). Just would "stumble" upon it as I band-scanned. I did enjoy several clear receptions of Philippine Island DX in HK (Kowloon) and that was really neat (711/1350/etc.)!

Yes the Philippine stations are fairly easy to track down in HK, as long as you choose frequencies that aren't plastered by Chinese locals. Many of the Philippine stations were daytimes on the Cape D'Aguilar ocean cliff (at the southeast tip of HK island), and on the somewhat polluted public beach of Macau. But several Philippine stations (on 666, 702 and 1530) became real pests in covering up long range targets around sunrise, since they tend to boom in with their salt

BTW, re Hawaii - get land blockage to Honolulu by all means to knock down the obnoxious amount of those "locals" there - Kona is not good for that nor Poipu either (re HNL overload) - I used to go to east Hawaii - Kamoamoa (now gone under lava!) or the fab MacKenzie SP (still there for now!) and rolled out

Beverages to k/o Honolulu signals *dramatically.

BUT. Malaekahana Bay on Oahu's north Shore near Kahuku/Laie is wonderful to get rid of HNL overload and have DX as fine as on an Outer Island locale (but NOT facing a water-path to Honolulul) and quick and cheap to get to (I spent one week in a tent at Malaekahana (Friends of Mal. Bay CG – private) and no noise/quiet and easy to taxi too). There in the north Oahu shore, the groundwaves from HNL are really attenuated and DX creams them! Not in Kona though, but Kona is wonderful for DU DX unlike North Oahu's windward side (island attenuation to big there for DU).

Honolulu QRM is a major issue throughout the Hawaiian Islands, and after two trips to Kona and one to Poipu, I can almost tell you the formats of all the Hawaiian pests. No Hawaiian location is perfect for DXing in all directions, although Poipu is fairly unique in having a straight salt water shot to most long range DX continents, as well as a far westerly location to take advantage of extended sunrise enhancement into the Middle East and Africa. Poipu does also have a salt water path to the Oahu pests, but I discovered that very late in sunrise enhancement pests like 690-KHNR do taper off enough to track down DX like 693-Bangladesh. On the frequencies with no Honolulu pests you can really run wild in Poipu, with Oman, Egypt, Iran, India, Bangladesh, Myanmar, Cambodia etc. all Different Follows with the deleter with a first part of the state of t we should score some serious fun :-)

Loops NE/SW. The only possible Spanish around here (no more San Antonio) is KCTO, CoL Cleveland MO (address in Liberty, le Kansas City market), and in fact Rio Bravo Supermarket chex out in Kansas City KS (also Wichita). KCTO is 5 kW aiming only north, so hard to believe I'm getting it so well, as I have a few years before.

CANADA. 1610, May 17 at 0500, music seems Spanish, and also a second carrier making a slight beat, both looping NE/SW. CHHA Toronto, Voces Latinas, is usual dominator here. 3-year-old program grid at http://chha1610am.ca merely shows 'All-Night Music', but as of last August log, heard in Portuguese Portuguese, and could also be Punjabi which is hardly Latin.

I would love to get XEUACH, but probably has migrated to 1130 by now. More likely than a TIS is CHRN Montreal in almost the same direction as Toronto which easily blocks it. How far apart are they? MW Offsets as of Oct 2018 showed CHRN on 1609.9987, CHHA on 1609.9995, ie only 0.8 Hz difference.

OKLAHOMA. 1640, May 20 at 0050, KZLS Enid is S9+40 of dead air; recheck shortly after 0100, had resumed with talkshow, presumably far-right. See also

WORLD OF RADIO 1982 monitoring: Confirmed Sun May 19 at 0340 on WAORCR, 1860-AM, barely audible vs storm noise level, about 27 minutes into, so started circa 0313. Had to quickly plug in the external longwire to hear enough.
