(This report was mislaid by your Editor & should have been in last week - sorry! -ERC) After a terrible 2/11, things got a bit better. 2/13 found KDFN on 1500 very strong until 6:45pm s/off, heard quite often now. 2/15 was KLMR's r/c bouncing past KQEO AN, & WOKY off. Also in the evening, KTCB-1470 s/off @ 6:43. 2/16- WWCA-1270 has a 2:00 s/off, so I heard KFJZ do the same a minute later. Then KRAC-1270 with r/c @ 2:16 & on. 2/17- Possible KIUP with TT from 2:00-2:15 but WKY was tough. Heard only one ID & it was poor. WSVS-800 5kw. s/off @ 5:45pm, & WJCO-1510 s/off @ 6:15. 2/18- WDEA-1370 TEST generally, only ID though @ 2:45. KMJ-580 on top of CKY for the first time since 1/61 & they stayed there until their 3:00 s/off. I heard something that sounded like "KTOE" on 1440 from 2:10 to 3:02 SSB s/off, I'm not sure what it was. (KDON??-ERC) I have plenty of other info, so if someone knows I can report them. KXEX-1550 was no surprise at S-9 with KMJ coming in so well. WPTW-1570 difficult, only a few minutes here & there due to XERF. WSGO-1440 strong on TEST.
