- 550 KTZN AK Anchorage Is now on with U1 3100/5000 is now on the air. The reduction in day power is necessitated as they moved to the taller tower of co-owned KENI-650 at 61-09-58/149-49-34, retaining the same daytime coverage area.
- 720 WHYF PA Shiremanstown Is operating under a Special Temporary Authorization (STA) with D1 2000/0 (no change) from a 342' cable 60' off the ground at 40-12-58/76-58-08. The station has recently been sold.
- 980 KGLN CO Glenwood Springs Is now on with U1 2000/225.
- 1110 WGNZ OH Fairborn Is now on with U7 5000/2 CH 1700 is on the air. This increases their day power and adds night service. The Critical Hours operation remains as it was.
- 1150 KRMS MO Osage Beach Is now on with U1 840/55 after relocating their daytime transmitter to a new tower at 38-05-17/92-44-17. The night transmitter remains at 38-07-20/91-40-42.

- 1440 WNYG NY Medford Is back on, after moving here with D1 1000/0 after relocating the transmitter to the site of WLIM-1580 Patchogue at 40-47-45/72-59-32.
- 1480 WYZE GA Atlanta Is now on with U1 10000/44.

- 1510 KMYN NM Isleta Is now on with U1 5000/25 CH 4200 after relocating from Alamo Community on 1500.

- 1220 KDDR ND Oakes Licensed for U1 1000/327, KDDR's tower was toppled by a tornado and the station is now operating with U1 250/250 from a temporary dipole antenna.



- 1230 NEW UT Beaver New station granted with U1 1000/1000 from a 186' tower at 38-12-55/112-38-45. Beaver is located on I-15 about 50 miles north of Cedar City.
- 1250 WBRM NC Marion CP granted for U1 5000/51 after moving to a new transmitter site at 35-41-08/82-02-05.

- 1490 KJNT WY Jackson CP granted for U1 1000/1000 from a relatively short (50 foot) tower with a unipole top-loaded antenna at 43-28-28/110-46-07.
- 1520 WSVX IN Shelbyville CP granted to reduce both day and night power and go non-directional, as they become U1 250/6. Even with the lower powers, they will do well, since the single tower (of their three) that they will be using is 351' tall.

The FCC has cancelled a \$10,000 to WLBK-1360 DeKalb, Illinois for Public File violations.
- News Item: The National Association of Broadcasters (NAB) says the FCC should look at not only how low-power FMs have affected existing full-power commercial FMs economically, but also at their potential impact in the future. It filed comments with the agency for a congressionally-mandated report associated with the practical details of implementing the Local Radio Community Act. NAB said Congress directed the commission to examine the impact that Low-Power FMs (LPFM) "will have" on full-service stations. deliberate choice of those words indicates that it wanted the FCC to focus on the future impact of LPFM after the changes required by the Act are implemented," the trade association stated. NAB presumes Congress required the report so lawmakers could consider further changes to the LPFM rules if operation of the low-power stations would hurt full-power FM service. The FCC should focus on the impact of niche-format stations, because the agency's assumptions that LPFMs would serve audiences with programming not available from mainstream stations may be wrong, the association said. "As LPFM stations are licensed in larger urban areas, they may choose formats that compete with existing full-service stations already serving the same niche audiences," stated NAB. It included a format study by BIA/Kelsey's Dr. Mark Fratrik finding that stations with foreign-language, ethnic, bluegrass and other non-mainstream formats are located mainly in urban areas where there have been few LPFM stations up to now. Fratrik found these stations have much smaller audiences, and therefore revenue, than mainstream-format stations in large markets. "These stations, which may serve similar kinds of niche audiences as LPFM stations will, are economically fragile," according to NAB and Fratrik. "If they lose significant parts of their current audience, their survival — or their survival with their current formats — may be in doubt." Many of these urban niche audiences are served by AM stations; Fratrik and NAB suggest the FCC also consider the impact to the public interest if licensing new LPFMs results in a loss of service from AMs. NAB suggests the FCC look at changes in the size of both audience and ad revenues as it considers the impact that increasing the number of LPFMS may have had, or could have, on full-service FMs. An issue on which the FCC had asked for comment is how to measure the impact of LPFMs in markets un-rated by Arbitron. NAB suggested the commission use the population within a station's protected contour as a proxy for audience size and revenues. It suggests the FCC seek revenue and audience information from LPFMs themselves. NAB urges the agency to look at cases in which LPFMs' underwriting efforts siphon ad revenues, and audience, from full-service stations. Some LPFMs have sold commercial ad time, and the FCC should look at that, states NAB, which emphasizes that, "This record, and the fact that LPFM licensees often have no prior experience with the commission's rules, means that the commission cannot simply assume that new LPFM stations will not also try to sell advertising." NAB states a discussion of appropriate LPFM enforcement should be part of its report to Congress.

- ❖ News Item: The CRTC has asked for applications to fill the frequencies of 690 and 940 kHz, vacated in Montreal. When received, the potential applicants will be judged on several factors including: programming proposals; their business plan; Canadian content; contributions to Canadian content development; and, where applicable, the percentage of French-language vocal music. The initial plan to make these frequencies All-Traffic stations was withdrawn due to opposition from the public and interventions filed by several broadcasters citing that the frequencies could be put to better use.

Did someone forget how to patch in the NNdR feed on the board? Yep! Metro audio back up at 1731 re-check. [Krueger\*C-FL]

#### **THE DX TIME MACHINE**

<u>75 years ago</u>: From the Aug. 27, 1936 *DX News*: It is anticipated that the purchase of WGL and WOWO by Westinghouse will result in improved programming; from the Sept. 2, 1936 *DX News*: The German dirigible Hindenberg is sometimes audible on 5280 k/cs.

50 years ago: From the Aug. 19, 1961 DX News: Bill Feidt, on a ship midway between New York and France, reported US and European stations on his 9-transistor portable.

<u>25 years ago</u>: From the Aug. 18, 1986 *DX News*: The top finishers in the NRC Contest were Bill Moser, Niel Wolfish, Nancy Hardy, Jim Renfrew, Bill Hardy, and Bruce Conti.

### Improving your DX skills – tips from new and veteran members

Greetings once again from the Heart of the Continent and welcome to the DX Tool Box Column number 31.

It is the summer and the AM DX may be poor but there are still things to do for the radio hobbyist. I just finished off some summer time antenna maintenance. It is more fun doing it at 80 F than at -20 F.

The first thing I did was give my longwire a good look over to see if there was any visible damage. You would be surprised what Mother Nature can do to a wire antenna over the winter and spring. It was all good so I was happy. No bare spots in the coating, no loose wires or visible breaks. I did have to adjust the tension a bit to balance it off. If there are areas between supports that are too tight, heavy winds could snap the antenna.

Next it was off to check the three ground rods. One is for the outdoor long wire; the other is for the buss bar in the radio room in the house and finally one for the Discone antenna. I took the ground wires off the ground rods to look them over. Two of the ground wires showed some corrosion from the weather as did one of the connectors on a ground rod. I got some fine sandpaper/emery cloth and cleaned off the bare wire leads and the connections on all the ground rods. Then I put the wires back onto the ground rods and made sure the connections were good and tight. Solid connections are a must on all ground rods to insure good contact.

After that I gave the stone pits that the ground rods sit in a good watering. Each rod is set in a separate ground rod pit with about two feet of loose rock in the pit around the rod. This allows for better drainage of rain water to the ground rod. In our crazy climate here ground rods can end up in dry soil. By watering the rods I insure that they have enough moisture to give me a good ground. In summer this may have to be repeated several times depending on the weather. This last time due to the heat it took 20 minutes before the pits were full so I know the ground rods were wet.

Next up was a check of the coax leads for the antennas. The coax runs from the antenna to the lightning arrestor and from the arrestor to the radio room in the house. I used my good old radio Shack multi-tester that has to be over 20 years old and it detected no shorts, so that was good. All the connectors were nice and clean so that was good. I did the same for my Discone antenna that I use on the ICOM IC-R7000 and found a problem. The connector from the lightning arrestor to the house showed some blue corrosion on it. I went into the house tried some stations on the radio and noted their signal strengths. I went back out and cleaned up the coax connectors with emery cloth and some CLR cleaner. I then put the antenna lead ins all back together and headed for the radio room. Nice surprise all the stations were stronger and I got two stations that I could not get before the cleaning process.


Maintenance is well worth the time spent so you can get every little bit of signal out of your antennas by making sure your ground systems are working well.

On the way back from a visit to Wisconsin, I did a bit of daytime DX'ing in southern Illinois. Noted an interesting phenomenon at the very southern tip of the state. I was listening to WSCR-670 – it was just strong enough to be identifiable, frequent fading into the noise. As I entered the I-24 Bridge across the Ohio River, the WSCR signal increased considerably. Probably about 10dB. It

disappeared again going under the metal superstructure (as is normal with metal bridges) but came back for the center (uncovered) section and on the southern uncovered approach. After leaving the bridge & getting into Paducah, Kentucky, WSCR returned to its just strong enough to identify signal. (Until I reached Whitehaven when local line noise clobbered everything but the locals .....) I've heard railroad tracks enhance AM signals before but this is the first time for a bridge. BTW, WGN was almost as strong as



WSCR. WBBM, I could get a word every once in awhile. WLS, you could tell it was there. WMVP-1000, not a hint. Tried for WTMJ-620 (heard at just-IDable level in Effingham around 9:30am) no luck, just Alabama and St. Louis splash. Doug Smith W9WI Pleasant View, TN EM66

Hello All, From July 12-18 detailed DXpedition testing was conducted on two new Ferrite Sleeve Loop antennas (FSL's) in the ocean beach environment of Lincoln City, Oregon. Both a 6.5" diameter Longwave-optimized model and an 8" diameter MW-optimized model (both about one cubic foot in size) were tested in their ability to provide competitive reception of long-distance DX stations throughout their frequency ranges. The 6.5" diameter Longwave FSL composed of 35 Amidon type 33 (American-made) 4" x 1/2" ferrite rods managed to provide the first Ultralight radio reception of a Trans-Equatorial South Pacific beacon from North America-- 270 FA in Apia Upolu, Samoa (1,000 watts at over 5,000 miles distance from the Oregon beach). The astonishing performance of the new

FSL is described in the full DXpedition report posted at <a href="http://www.mediafire.com/?9snw5mr2f504wzv">http://www.mediafire.com/?9snw5mr2f504wzv</a>, including background details on development of the new antennas. The report also contains MP3 recording links for the 7 Alaskan and 2 Hawaiian beacons received, as well as a day-by-day report of the challenging conditions at the beach. The companion Medium-Wave DXpedition report is also being compiled, describing the South Pacific DXing performance of the new 8" diameter FSL model at Lincoln City. The antenna managed to provide reception of the all-time new Ultralight DX'ing country of 666-



New Caledonia, as well as several other new South Pacific DX stations. Full details on the construction and development of the new FSL antennas will be contained in an experimental report to follow. 73 and Good DX, Gary DeBock (in Puyallup, WA, USA)

## NOAA Space Weather Outlook

Issued August 2 – For the period August 3-29, 2011

Solar activity is expected to be at low to moderate levels during August 3-8, with a chance for M-class flares greater than M5 from Region 1261. Activity is expected to decrease to very low to low levels during the rest of the period as Region 1261 departs. A chance for M-class activity increases on 20 August when Region 1261 rotates back around the east limb.

No proton events are expected at geosynchronous orbit.

The greater than 2 MeV electron flux at geosynchronous orbit is expected to be at moderate to high levels on August 3-4. Normal to moderate levels are expected during August 5-7. Moderate to high levels are expected during August 8-13 due to effects from a recurrent coronal hole high-speed stream (CH HSS). Normal to moderate levels are expected on August 14-15 followed by moderate to high levels from August 16-25 due to a second CH HSS. Normal to moderate levels are expected for the remainder of the period.

Geomagnetic field activity is expected to be predominantly quiet during August 3-4. A CME observed on August 2 at approximately 0706 UTC on LASCO C3 imagery is expected to arrive late on August 4 and increase activity to unsettled to active levels with a chance for minor storm conditions through the first few periods of August 6. Major storm periods are possible at high latitudes during this time. Quiet to unsettled conditions are expected for the rest of August 6-11 due to effects from a recurrent CH HSS. Activity is expected to decrease to mostly quiet levels from August 12-13 as the CH HSS effects subside. Activity is expected to increase to quiet to unsettled levels from August 14-22, with a chance for active levels on August 15-17 due to another recurrent CH HSS. Conditions are expected to decrease to quiet levels until the arrival of a third CH HSS anticipated to become geoeffective on August 26. Quiet to unsettled conditions with a chance for isolated active periods are expected to prevail for the remainder of the forecast period.
