The DX Time Machine

75 YEARS AGO – From the December 14, 1937 issue of *DX News* – Club president Arthur Parfitt in Cleveland, Ohio reports that his best catch of the month was XEDF-810 Nuevo Laredo, Mexico, with 75 watts; the first part of the NRC

"Europe and Africa" MW station list (up to 1393 kc/s) was published.

50 YEARS AGO – From the December 15, 1962 issue of *DX News* – Herbert Campbell in Athens, Penn. noted that he's been an NRC member for 25 years, and that while BCB DX isn't as good as it used to be, his "DXing inspiration has been almost solely derived from the pages of *DX News*"; Executive Secretary Pop Edge commented on some NRC governance issues that had been matters of recent controversy.

25 YEARS AGO – From the December 14, 1987 issue of *DX News* – The FCC authorized more daytime stations on some regional channels, plus 940 and 1550, to broadcast with low power at night; a "Broadcast Technology" column detailed the many Canadian stations that have been able to move to more desirable frequencies after the 1984 agreement with the United States.

10 YEARS AGO – From the December 16, 2002 issue of *DX News* – The DX test from WLCR-1470 Shepherdsville KY was well heard from Colorado to Florida to Ontario; Paul Harvey mentioned NRC member Scott Fybush's tower calendar on his 11/18 broadcast.

CALL CHANGES

1050 WBNC NH Conway – Changes calls to WPQR.

1340 WPQR NH Conway – Changes calls to WBNC.

1570 WNSH MA Beverly – Changes calls to WMVX.

RadioInsight says WTDY-1670 plans to change calls to WOZN and format to sports ("The Zone") after the holidays; currently stunting with Christmas music as reported in recent *DX News* issues.

RadioInsight also speculates that Cumulus is holding the WNSH calls (now parked on the former WGVY-105.3 in Cambridge MN) for a new national "Nashville Country" brand, maybe for WFME-NJ-94.7 (the New York Family Radio affiliate being acquired by Cumulus).

980 WJYK VA Chase City – FCC says CP for D1 1000 is on the air (ex-D1 500); but we had thought the CP was for U1 1000/26 – not sure exactly what happened here.

1060 WCOK NC Sparta – **CP** for D1 1100 is on the air (ex-D1 800).

1070 WCSZ SC Sans Souci – Granted program test authority for CP for U2 50000/1500 (licensed for U4 50000/1500); FCC also granted modification to adjust coordinates to 34-55-12/82-27-25.

1170 WAVS FL Davie – Granted program test authority for CP to modify antenna pattern.

1240 WTWA GA Thomson – CP for U1 600/600 is on the air (ex-U1 1000/1000).

1330 WKTA IL Evanston – Granted program test authority for CP for U4 5000/110 (licensed for U5 5000/17).

1550 WBSC SC Bennetsville – FCC notified station on 11/29 that it was cancelling the station's license; the FCC wrote the station on 5/9 to inquire whether it was still on the air and never got a response.

1100 KQNM NM Milan – Granted CP to move to 1090 kHz with D1 250 from a new transmitter site (35-09-05/107-52-34) (currently licensed, albeit silent, for U1 250/20 on 1100 kHz). The station will exchange transmitter sites with KMIN-980 Grants NM, which has a CP to move to the existing KQNM site.

Headphones that perform best for DX applications can be hard to find. I've been using Sony MDR-G45 for a couple years, the best I've found since my old '70s Radio Shack headphones disintegrated from decades of abuse. I've tried all types over the years, from dollar store specials to \$100 professional models and various types sold by 'shortwave/amateur radio' retailers. The Sony headphones always beat the rest in terms of readability of hard-core DX signals. However, still not completely satisfied, the search for the perfect headphones continued. Now I may have found the penultimate. Headphones were advertised on sale for \$15 in a Guitar Center mailer; "Powerful and accurate studio headphones, \$29.95 list," Sennheiser model HD 201. The sale price made it worth a try. So far, I'm impressed. Dare I say the best I've found for DXing in decades.

Last year, I went out on an adventure to track down line noise problems in this area. One source I found was an automatic night light, when it came on, the band was ruined, located at a store in front of our building. I talked to the owner, told him the dimmer waas bad and might start a fire, he let me change it out and end of noise. Now another store installed some noise generating lights that really wreck the band with noise. Again, it's another store located in the same building. I talked to the guy, said the lights were bad and may catch on fire. Apparently it hasn't worked, they're still making noise, to the point that the AM band is worthless while they're on. Now the other apartment has added some low level noise generating lights which make things pretty bad. So I've made my mind up that I'm going to move, find a place that is RF quiet, no noise, think its possible? We'll see. I did catch WHB-810 a few nights ago topping WGY at 5:45 PM, last heard as KCMO in the 60's. Everyone please have a safe and happy holiday!

- 930 KOGA NE Ogallala 11/26 1740 Out of song:" And I Love Her;" Harry Connick Jr. AM Nine-Thirty" followed by commercials including Rent-A-Center, Sam Adams Lager, Corn Husker Glass in Ogallala, and Ogallala True Value Hardware. Then fades out. (JDS-MN)
- 930 WLBL WI Auburndale 11/21 0835 Deep-nulling of groundwave from WKY OKC continues to be productive: news in English about record harvest of bears (???), Wisconsin Public Radio news, wpr.org mentioned. This is 5 kW when on day power, from Auburndale. FCC AM Query topo map shows: ESE of Marshfield in Wood County, a significant 19-kiloperson town, in turn SW of Wausau in the center of the state. But only 70 watts at night . (GH-OK)
- 940 KPSZ IA Des Moines 11/26 1758 Focus On The Family program ends, into Zerorez carpet cleaning commercial. Followed by "KPSZ Des Moines Iowa's Christian voice. Nine-Forty KPSZ, and on-line at faith940.com. (JDS-MN)
- 960 KMA IA Shenandoah 11/26 1805 Out of ABC news "Good evening, Mike Peterson with KMA local news brought to you by Page County Federal Savings Association of Clarinda. Our KMA On-Track weather forecast for tonight..." (JDS-MN)
- 960 KGWA OK Enid 11/17 0100 KGWA Enid with another Fox-hole, (dead air) occupied by mixture of ABC News and Mexican music, i.e. likely KMA and XEK. 11/18 0100 KGWA stays on a minute longer than usual with commercials, and only at 0601 starts the Fox-hole of dead air, modulation cutting back on at 0605 after only 4 minutes, during which nothing notable could be heard from understations. 11/21 0100 Fails to stop modulating; Fox news heard. Again no understation DX. 11/22 0100 Manages to modulate instead of providing a Fox-hole, for the second night; is my understation DX window done for? Will keep checking. (GH-OK)
- **1000 KTOK OK Oklahoma City** 11/22 0708 Replaced its morning newstalk on this holiday with a 2-hour musical program for Thanksgiving, featuring various US military bands playing instrumental inspirational music, starting with "God of Our Fathers" by the US Marine Band, then "Shaker Melody," by a US Army band. Announcer gives scriptural background for each piece. **(GH-OK)**
- **1010 KXXT AZ Tolleson** 11/16 0129 Sermon, or at least a religious talk in Spanish with consecutive translation to English, phrase by phrase. Likely on day power of 15 kW rather than night power of 250 watts. **(GH-OK)**
- **1010 KSIR** CO Brush 11/26 1832 NEW. Weather forecast ending with "I'm meteorologist (inaudible) Farm Radio Ten-Ten KSIR." Followed by "Welcome back to *The Rural Route.*" (JDS-MN)
- 1020 KJJK MN Fergus Falls 11/26 1900 Instrumental music ending, followed by female voice "KJJK Fergus Falls, a family friendly station in west central Minnesota, the new family Ten-Twenty." Into song: "Jingle Bell Rock." (JDS-MN)
- **1030 KCTA TX Corpus Christi** 11/17 0728 Woman named Alicia in pretty good Spanish but gringa accent, some stresses on wrong syllables, closing with address in San Antonio. 0729 no ID and 0730 into all-English, *Through the Bible* with the very late J. Vernon McGee. Dominant VG signal from N/S; certainly not the 217 watts its PSRA allows in November from 0700 to official sunrise at 0745 but the full 50 kW ND. **(GH-OK)**
- **PA** Philadelphia 11/27 1731 Out of weather forecast "That's the latest from the CBS-3 eye witness weather center on KYW news radio." Followed by traffic report. (**JDS-MN**)
- **1070 WCSZ SC Sans Souci** 11/17 0116 "El sonido joven, La Jefa es más música," loops E-W, announcement between music. So this Spanish I have been hearing vs. KNX, and more or less in null of KLIO. NRC *AM Log* says "La Jefe" which is a contradiction in gender, but close enough. It's been widely reported recently, suspected 50 kW day power at night. **(GH-OK)**
- **1100 WZFG** MN Dilworth 11/27 1759 Commercial for Vision Bank in Fargo followed by "Serving faith, families, freedom, and free enterprise at AM Eleven-Hundred,

- and flagfamily.com. This is the flag WZFG Dilworth, Fargo Moorhead. Into the news. **(JDS-MN)**
- 1120 KEOR OK Catoosa 11/17 0819 On with Mexican music. Seems to be starting at 0819 most days, which is official sunrise in November, and maybe on until 1815 sunset. 11/20 1944 Spanish music audible with KMOX nulled, thanks to tip from Bruce Winkelman in Tulsa who found daytimer KEOR had kept transmitting after sundown tonight. NEVER any IDs or other announcements. (GH-OK)
- **1180 WHAM NY Rochester** 11/27 1848 Out of sports talk "AM Eleven-Eighty." Into commercials including Hyundai, The Total Transformation, Advanced Hearing Centers, and a spot for Michael Savage on WHAM 11-80. (JDS-MN)
- **1200 WRTO** IL Chicago 11/21 0823 Plug for some Univision (TV) show, news reports mixing English and Spanish. Dominant over WOAI. A Univisión América. affiliate; not only the single one listed on 1200 in the 2012 NRC AM Log, but the only 1200 SS in the US. Previous unID of a Mexican here could have been this too. Other Chicago clears were still audible shortly after sunrise here at 0815 but 0748 in Chicago per gaisma.com (**GH-OK**)
- **1360** KLSD CA San Diego 11/26 2320 Fair signal in local KPXQ null. Ad string, promo for "Ko-go news and talk radio," simple "Sports 13-60" slogan heard. (CK-AZ1)
- **1400 KWUF CO Pagosa Springs** 11/15 0859 Out of C&W song with ID by gal at 0859:50: "...KWUF 1400 AM...Pagosa Springs, Colorado;" NBC news followed, I think; soon submerged into the pileup. **(JW-CO)**
- **1400 KODI WY Cody** 11/22 0851 Briefly on top with Cody ads; singing ID at 0853 and into music...noted again with legal ID at ToH, just partially readable in the muck. (JW-CO)
- **1450 KVSL AZ Show Low** 11/27 2319 Just above jumble. Ad for "homeadvisor.com," ID: "KVSL AM 14-50 Show Low" by man. Back into jumble. **(CK-AZ2)**
- **TX** Dallas 11/16 0839 With its characteristic SAH against KQAM et al., woman talking about aid projects such as clean water wells, consecutive translation to unknown (African?) language. 11/21 1548 Skywaving in with gospel music, frequent IDs with variety of slogans including "The answer to your prayers," and plugging their 50 kW power. Way over KQAM Wichita groundwave on car radio, but fading down to nothing and back up. At 1600 into *Financial Survival* with Cedarstrom which isn't exactly religious. KQAM might even have issues with this in their coverage area? (GH-OK)
- **1530 KDSN IA Denison** 11/18 1657 Fair with light multi-station QRM, including KQSP (see below). While waiting for KQSN to ID, I caught an off-hour legal ID from KDSN, apparently attached to no programming before or after, suggesting that it ID'ed during an unscheduled dead-air period. NEW! **(BD-WI)**
- **MN** Shakopee 11/18 1703 Fair with light QRM, with UC oldies, frequent "Magic 1530" ID's and a legal ID (cities Shakopee-Minneapolis-Saint Paul) at 1703. A needed call change dating back to 9/2006, so this station is rare indeed here. **(BD-WI)**
- 1590 KDAV TX Lubbock 11/27 2250 Fair peaks above jumble, song "I'll Never Fall In Love Again," simple legal ID by man and immediately back to music. "Oldies 15-90" slogan heard. Logging possible since local 1580-KMIK's IBOC has been off for two weeks now! (CK-AZ2)
- 1600 KDAK ND Carrington 11/28 2159 Fair to poor, moderate to severe QRM from KPNP, KGYM and others, with C&W and ads, four station "Dakota Country Radio" legal ID (// KOVC 1490 Valley City, KQDJ 1400 Jamestown and KDDR 1220 Oakes, all ND) into Minnesota Timberwolves basketball. NEW! Station is only 90 watts at night, 500 watts days. (BD-WI)
- Cockrell Hill 11/17 0809 National anthem, just ending, presumably South Vietnam's, then Vietnamese announcement mentioning Dallas AM and Houston AM, http://saigondallasradio.com. Het from the off-frequency Kansan is bothering; at 0813 mentions "phát-thanh" i.e. radio station; then to some more triumphal choral music. That website works, but labelled instead Radio Saigon Dallas, shows KRVA 1600, though the listen-live link says 890, which we know was recently acquired by China Radio International instead. BTW, our closest 1600, KUSH in Cushing OK has an application to raise day power from 1 to 5 kW. (GH-OK)
- **1640 KFXY OK Enid** 11/16 0840 Dead air from KFXY Enid, but with strong carrier nulled as best I can, no understation audible at this hour. Didn't last until 0900 1400

- UT). Wish KFXY would start a regular dead-air hole in darkness like KGWA at local midnight. 11/17 0059 (0559 UT). With dead air, before firing ID and 0600 SRN "News." Doubt the deadness lasted long, but worth further checking; this time, no time to pull WTNI or any other understation. (GH-OK)

- **1660 WQLR MI Kalamazoo** 11/10 0559 "Sports headlines right now on Sixteen-Sixty WQLR Kalamazoo, Sixteen-Sixty, The Fan." Into sports headlines. **(JDS-MN)**
- **1690 WVON IL Berwyn** 11/27 0800 NBC news; call letter ID and traffic at 0803. Briefly fair but fading away as it was past sunrise in IL. Local KDDZ mostly nulled. (JW-CO)

- 930 UNID -- 11/17 0759 Again getting another station with Spanish music when WKY OKC groundwave is precisely nulled. Maybe this time an ID?? Grrr, at 1300 only a non-ID, but clearly: ``Radio Cumbre 9-30`` by SHVA (super-hype voice actor), right back to another upbeat song in Spanish. Cannot find anything by Googling or in all the references for USA or Mexico. (GH-OK)
- **1070 UNID** -- 11/16 0134 Music in Spanish, 0635 announcement maybe mentioning ``Radio Acción``. Then KNX fades up. Suspected WCSZ Sans Souci SC (Greenville market), as has been widely reported out of whack and getting out at night. Seems WCSZ has no website and no stream. **(GH-OK)**

Errata

In 80-09 I inadvertently changed time format to UTC (and generally butchered) John Wilkins' logging of KBXD 1480 Dallas. The corrected log is:

1480 KBXD TX Dallas – 11/14 0909 – Gospel songs; ID's after every song or two, e.g. "The more you listen, the better you feel - 1480 KBXD Dallas". Fair peaks but fadey; lost for good around 0922. Also heard on 11/15 with "Old Time" Gospel songs to 0815, then a series of 15-minute religious programs. One ID went like this: "With 50,000 watts, this is the North Texas Powerhouse 1480 KBXD Dallas". Generally fair, with good peaks. Not noticed here until the past couple of days, so they may have just begun using (testing?) the 50 kW. Still licensed for 5 kW on the FCC website, with a 50 kW C.P. A needed call change here, ex-KNIT, and the 9th call logged for this station, going back to KBOX in the 1980's. (JW-CO)
