NRC Antenna Pattern Book: The 7th Edition of the NRC Antenna Pattern Book is now available. This all new edition prepared by NRC'er Paul Swearingen is an all-inclusive book of patterns for both Day and Night operation of stations in the USA, Canada and selected foreign stations. The data for this comes from the forthcoming 34th edition of the AM Radio Log and NRC'er John Callerman's comprehensive Mexican Station listing.

The book comes shrink wrapped in 8½ by 11 three hole punch format for placement in your own three ring binder. There are 240 pages and the book has maps covering 530 through 1700 kHz depicting the lower USA, Canada and Mexico. Hawaii and Alaska are shown on separate maps at the of the book.

NRC AM Radio Log: And we are accepting pre-publication orders for the 34th Edition of the NRC AM Radio Log. The 34th edition of the Log will contain approximately 285 pages of data and cross references and 18 pages of instructions in 8-1/2" x 11" size, 3-hole punched, U.S. loose leaf format. This publication fits nicely into a 1" three-ring binder. Over 8,000 updates have been made since last year's 33rd Edition of the log! Additional reference include call letters of FM simulcasts with the AM Stations listing, listings of regional groups of stations in the groups section (separate section of the log book), a cross reference of those stations that are licensed to use IBOC (In Band On Channel) digital audio

and a comprehensive list of FM translators that are now simulcasting AM broadcasters.

Unreported DDXD Stations: In this issue, one new station (WKAJ-1120) and one longstanding station (WZAB-880) were reported for the first time in DDXD this millennium, while two stations on our unreported list (KPBL-1240 and KIHN-1340) no longer exist and have been dropped for that reason. This is a net drop of three, leaving 566 stations (out of a total 4844) U.S. and Canadian stations (not counting TIS and LPRT stations) not reported to DDXD since at least Volume 67 (1999-2000)

Note that it is often the case that when a station "fails to file for renewal," there may be extenuating circumstances that will lead the FCC to grant an STA to continue operations until the

licensing issue is worked out, or even to the FCC eventually granting a license (sometimes for a shorter period, and usually with a hefty fine). Sometimes the check to the FCC bounced, sometimes the person who was supposed to do the renewal filing at a small station was out sick, sometimes the station's operations are just dysfunctional. So cross these out with a pencil for now.



Solar activity is expected to be at low levels with a chance for M-class (R1 minor on NOAA Scales) flares through the period.

No proton events are expected at geosynchronous orbit.

The greater than 2 MeV electron flux at geosynchronous orbit is expected to be at high levels on 05-09 August and again from 14-27 August in response to coronal hole high speed stream activity.

Geomagnetic field activity is expected to be at mostly quiet levels in the absence of any transient solar wind features. Recurrent coronal hole high speed streams are expected to bring unsettled to active conditions on 5, 6 and 8 August, 18-19 August, 21-23 August and 31 August. There is a slight chance for minor storm conditions on 5 August and again on 31 August.

AUG 4 1144 Rock music in English is audible with KOA nulled (hardly necessary weak, SAH), fades completely out at 1145, surges 1148, partial ID as "Radio Alegre," fades out again. Looped approx northeast/southwest. AUG 5 0600 Rock music in English with KOA easily nulled; fortunately roused at 0607 to hear non-ID as "Milenio Radio en medio de la noche," so it's XEM as suspected. I haven't got a handle on what format Milenio employs, as have heard a variety. Anyhow, this one is not news as in IRCA Mexican Log 2012; it does have the correct slogan, unlike 2013 WRTH showing the former "Renacimiento 850." Cantú just shows *Milenio Radio* + FM 103.7 5000 500 while IRCA and WRTH claim the powers are 5000/1000. [Hauser-OK]
- **CUBA** *R.Reloj*, Jovellanos JUN 2 0100 Reloj program; dominant with Brazil under. [Connelly-MA]
- **CUBA** *R.Reloj*, multiple sites JUN 2 0100 Wobbly frequency control noted on this Reloj outlet; over unID Latin American music station and WLVP. [Connelly-MA] JUL 2 0801 Double RR code with significant delay between two stations. [Conti-NH]
- **CUBA** *R.Progreso*, San Germán JUN 2 0059 Parallel 640 with dance/hip-hop vocal that had the words "we got the beat" in it (though unrelated to the Go-Go's song); over other Latin Americans. [Connelly-MA]
- **MEXICO** XEW *W Radio Música 96.9*, México DF JUN 30 1014 Simulcasting "W Radio Música 96.9" FM. Mostly continuous English indie rock with "Almost Violent" by Rotersand; "Temporary Touch" by Selebrities; "Breathing Underwater" by Metric, etc. Occasional "W Radio Música 96.9" canned ID's, brief spot for an online university at 1058, into national anthem at 1059, ID, back to music and fading out rapidly. Audio perfectly parallel to their website streaming. [Krueger-FL]
- **CUBA** *R.Cadena Agramonte*, Camagüey JUL 22 0800 Fair; four ascending notes marking the hour, canned ID, "Desde el cuna de el mayor, transmite Radio Cadena Agramonte, Camagüey, Cuba," into music program, "...a travéz de Radio Cadena Agramonte." [Conti-NH]
- **CUBA** *R.Metropolitana*, Villa María JUL 27 1205 Nice light classical music program block with announcer fairly often. Another guy joined in at 1247, surprisingly with a fast, accented, "Good morning, good morning, good morning." So Spanglish has migrated south. Female canned "Radio Metropolitana, la Radio de Casa" at 1301. After that for the remainder of the day, Cuban pop-ish vocals. Excellent all day signal here as long as WTWD

- Plant City is tightly nulled. And they're still airing Noticiero Nacional de Radio news patch at 1300 local time, so all is well. [Krueger-FL]
- 939.88 **MEXICO** XEQ *Bésame*, Mexico, DF JUN 29 1038 Spanish ballads, hetting Miami. No ID in my brief listen. Reported for quite some time as "Bésame" slogan but Fred Cantú's site states "Radio La Q" however the station web site states "Lo Mejor de La Radio Apasionada Bésame..." [Krueger-FL] JUL 22 0501 In 930 WBEN splatter with 940 WMAC nulled; promo ending with frequency and chimes, then choral national anthem. [Conti-NH]
  - **PUERTO RICO** WIPR *Máxima 940*, San Juan JUL 16 0300 Fair; canned ID, "Esta es WIPR AM San Juan, Máxima 940..." and classic salsa music. [Conti-NH]
  - **CUBA** *R.Reloj*, two sites AUG 4 0800 Over/under WIBX; syncopated clock and loud wobbling. [Conti-NH]
  - MEXICO XEJ Cd. Juárez, Chih. JUL 20 0504 Full ID with street address for XEJ "La Jota Mexicana." I often notice the national anthem playing at 0500 next to the Fox-hole I am checking from 960 KGWA and assume it's XEJ, now confirmed. JUL 27 0524 Soon as I tune across, music stops and "La Jota Mexicana, 970, nunca igualada." [Hauser-OK] JUL 28 1107 Very good with Mexican ballads and ID between them, "…en La Jota Mexicana, nueve setenta." Nice to hear this old blowtorch again. [Dau-NE]
- **COLOMBIA** HJAQ *RCN* Cartagena JUN 2 0101 Fast-talk sportscast with Colombian teams, apparently same game as on 650 HJKH though possibly a different announcer; dominant. [Connelly-MA]
- **CUBA** *R.Mayabeque*, Güines JUL 3 1039 Under local WHBO Pinellas Park but fairly strong with end of traditional Cuban vocal, female. Parallel 1140, which was co-channel *R.Musical Nacional*. [Krueger-FL]
- **MEXICO** XEG Monterrey, NL JUL 1 1144 Still in, some guy making a funny voice and repeatedly mis-gendering "la programa," ha ha, in taking phone calls from people with normal voices. [Hauser-OK]
- **CUBA** *Radio* 26, Jovellanos JUL 21 0601 Over/under KYW; signature piano music and time marker a minute behind top of the hour. [Conti-NH]
- MEXICO XEEP *R.Educación*, México DF JUN 30 0500 In a three-way jumble with KYW and presumed Cuba; choral national anthem. [Conti-NH] JUL 2 1050 Traditional jazz piano solo till 1058 when mostly lost to *R.Rebelde*. Bits of jazz piano surfacing again from 1102. No trace of 6185 shortwave. [Krueger-FL] JUL 14 0529 Beethoven's Ninth Symphony is playing, peaking NNE/SSW or so in interference. Surely it's XEEP as no U.S./commercial station would be caught dead transmitting that; and so it is as in detailed advance schedule www.radioeducacion.edu.mx/domingo-14-de-julio-de-2013 starting at 12:02 a.m. local. [Hauser-OK] JUL 21 1050 Thought I had a domestic flipped to a nostalgia format at first. Dolly Parton "Coat of Many Colors" then an ID and URL at 1100, back to Dollyfest with "I Will Always Love You"; "Jolene"; and "In My Tennessee Mountain Home" at tune-out. No sign of 6185 shortwave. [Krueger-FL] JUL 22 0500 Under KYW; choral national anthem. [Conti-NH]
- **CUBA** *R.Rebelde*, unknown site JUL 2 1059 ID, Rebelde sounder theme, into news. I've never heard a Rebelde on 1060, and no sign of *Radio 26*, normally heard well here. Same transmitter shifting networks today? You just never know what Arnie's surprise antics will bring. [Krueger-FL]
- **COLOMBIA** HJAH *Emisora Atlantico*, Barranquilla JUN 2 0101 Colombian sportscast, seemed parallel 1000 HJAQ; over jumble and growl from something on 1070.127 kHz. [Connelly-MA]
- **CUBA** *R.Guamá*, Guane, Pinar del Río JUL 15 2348 Male and female with light news patter, multiple ID's. Moderate WKII Solana, Florida (C&W format) co-channel. [Krueger-FL]
- CUBA R.Cadena Habana/R.Ciudad de la Habana, Villa María JUL 24 0300-0400 Lively Cuban music and R.Cadena Habana ID's. 0400 national anthem; over a second Cuban station with a different national anthem. Then romantic ballads which carried through the next two hours with R.Ciudad de la Habana ID's at 0500 and 0600 UTC. Prior to the anthem a clear R.Cadena Habana ID, then the first ID after the anthem is R.Ciudad. [Saylor-NC]
- **COLOMBIA** HJAT *Caracol Radio*, Barranquilla JUL 16 0038 Briefly fair, parallel 1170 on sunset grayline. [Krueger-FL]
- **COLOMBIA** HJCN *BBN Radio*, Bogotá JUN 30 0800 Under WTAM dead air; canned ID followed by "las buenas noticias" news from BBN. Thanks to Henrik Klemetz at RealDX for help with ID. New log. In the past *Caracol* Barranquilla was the signal received from Colombia on 1100 kHz. [Conti-NH]

- **CUBA** *R.Angulo*, Holguín JUL 2 0700 Fair; canned ID with "Bella Cubana" music followed by chimes and time check. [Conti-NH]
- **VENEZUELA** YVQT *R.Carúpano*, Carúpano AUG 2 0059 Under WBT; "...en Venezuela ¡Carúpano!" [Conti-NH]
- **CUBA** *R.Rebelde*, multiple sites JUN 30 0800 Under WRVA; news sounder. JUL 21 0759 Over WRVA; sounder and music program intro,"...hasta las seis de la mañana." [Conti-NH]
- **CUBA** *R.Surco*, Morón JUL 20 0300 Over WRVA in lightning noise; usual canned ID on the hour, "Transmite CMIP Radio Surco, desde Ciego de Avila, capital de la locución cubana." JUL 25 0301 Over/under WRVA and *R.Rebelde*; Eagles "Lyin' Eyes" then canned ID. [Conti-NH]

- **COLOMBIA** HJNW *Caracol Radio*, Cartagena JUN 10 0200 Fast Spanish talk with Colombia and colombiano mentions, CARACOL ID; over WWVA. [Connelly-MA] JUL 16 0034 "...en Cadena Colombia, Caracol" male and female trading off news items, remote reporters, commercials. Good on sunset grayline, parallel 1100, about the only Colombians regularly heard on this side of west central Florida, sadly. [Krueger-FL]
- **CUBA** *R.Rebelde,* multiple sites JUN 10 0201 Dance-club music parallel 710, some echo; dominant. [Connelly-MA]
- **CUBA** *R.Sancti Spiritus*, Trinidad JUL 20 0055 Spanish dance/pop, Celine Dion "My Heart Will Go On" and ID 0101. Back to dance/techno vocals and ID's, parallel 1210 which was co-channel Radio Rebelde with baseball coverage. [Krueger-FL]

Male and female Matanzas Province history items, Nutcracker Suite filler music between items. Mostly poor, but again surfacing at 1105 re-check, now with kiddie program and singing. [Krueger-FL]
- MEXICO XECPN Piedras Negras, Coah. JUL 9 1204 Checking hi-end MW for remnants of skywave, 42 minutes after sunrise, something in Spanish with 7:04 timecheck before fading. Loops northeast/southwest, rather than northwest/southeast, so not KXYZ Houston which could be in Spanish instead of Chinese at this hour, and no known Spanish in other neighboring U.S. states, so most likely XECPN. A minute later on 1350, then found Univisión América, i.e. KCOR San Antonio so that ties in. [Hauser-OK]
- **CUBA** *R.Ciudad del Mar,* Aguada JUL 8 1045 Male light news items mostly Cienfuegos, ID at 1050. Good but crunched by local 1340 WTAN. [Krueger-FL]
- MEXICO XERF Cd. Acuña, Coah. JUN 28 1150 Concluding a mañanitas song mentioning San Juan, and starting "servicio social" notices of missing persons (extraviadas) with phone numbers on both sides of border, including toll-free 877s. I assume a lot of these are about illegal immigration attempts which may have gone bad; or successful ones with the personas in hiding. JUL 1 1150 Still in with mañanitas and servicio social announcements, mostly missing persons, but also a dog and a job opening; fading out by 1155 UTC. [Hauser-OK]
- **CUBA** *R.Rebelde,* La Habana and Guantánamo JUN 10 0201 Dance-club music parallel 710; fair. [Connelly-MA]
- **CUBA** *R.Bayamo*, Bayamo JUN 30 0300 Over/under *R.Rebelde*; *R.Bayamo* ID, but no doorbells this time. [Conti-NH]

Convention host Mark Durenberger e-mailed daily updates from this year's joint convention of the National Radio Club, the International Radio Club of America, the World TV-FM DX Association, and the Minnesota DX Club, "Learning and Sharing," August 1-4 in Minneapolis.
