740 KBOE IA Oskaloosa – Call change to KMZN (10/15).

1260 KBLY ID Idaho Falls – Call change to KEIR (10/21).

1280 WFAU ME Gardiner – Call change to WJYE (10/22).

1380 WTJK IL South Beloit – Call change to WBEL (10/13); had these calls until 1998.

1440 WDRJ MI Inkster – Call change to WMKM (10/6); had these calls most of 1990-2006.

1500 WTNE TN Trenton – Call chamge to WPOT (10/23).

NEW STATION WATCH

WY Pine Bluffs – FCC rejected an appeal of the 2009 denial of license to cover this new station CP. The FCC found that the applicant had falsely certified the station, including five 344-foot towers, was built when it applied for the license to cover at the end of the 3-year construction window, when it had only completed 225 feet of one tower and 125 feet of the others.

1550 CP TX Midland – **CP** for new station expired, deleted.

In addition to the two additional outstanding CPs that technically expired in October (Paradise NV 1590 and Fritch TX 1570), four more CPs are set to expire in November: KCKQ-1180 Sparks NV (11/9); KMCA-1450 Hilo HI (11/29); CP-1400 Paukaa HI (11/30); and WIVS-1560 Village of Superior WI (11/30). Under FCC rules, the permitee must subatntially complete the building of the station and file for a license within the three-year deadline, otherwise the license automatically expires.

Radio Insight

As part of the restructuring that saw Westwood One drop ABC News for a new CNN powered news service, Westwood One has notified affiliates it will also drop distribution of NBC News to affiliates on December 15. Affiliates will have the option to switch to the new CNN fueled Westwood One News following the ceasing of NBC News Radio operations. In an ironic twist, the current incarnation of NBC News Radio was established by Westwood One (then Dial-Global) as a replacement service following CNN's closure of its radio network.

Council PSAs and some specific to Arizona, such as "don't drive into a dust storm"; 0829 non-ID as "ESPN Phoenix, 620-AM"; the sad fate of a oncegreater talk station, KTAR. If they had been smart, Bonneville might have used their legacy call sign as an inducement to become an Aljazeera outlet. Or, what's the equivalent of a Tarheel west of the Miss? And since there is a pretty deep null toward us on the night pattern, we dare assume the 5 kW is running on ND day pattern already, more than hour before official October sunrise of 0930. Dominant as long as KRVN is nulled. Obviously illegally on 10 kW ND day power yet again from. Interesting to compare with another Indian language, Tarahumara, on neighbor 870 XETAR. (GH-OK)
- **880 WCBS** NY New York 10/18 0556 The Wall Street Journal ending with "I'm (inaudible) with The Wall Street Journal on WCBS. News Radio 8-80." Followed by stock market numbers. "Traffic and weather next. WCBS news time 5:57." (JDS-MN)

- **970 KZNO ID Rupert** 10/20 0900 Tuned in just in time for legal ID: "ESPN Radio 970 and 97.5 The Zone is KZNO Rupert," followed by *Sports Center Update*, then *Mike and Mike*. Briefly fair before submerging into the noise. Ex-KFTA. **(JW-CO)**
- 990 WCAZ IL Carthage 10/15 0759 Poor; "thank you for listening to WCAZ Carthage" weather, LID. Alone. (JJR-WI)
- 990 KWAM TN Memphis 10/18 0705 Commercials for Feeding America, and television show *Shark Tank*. "Memphis wakes up with Chris Wade on Memphis This Morning, six to eight a.m. on AM 9-90 KWAM." Into show: *Today's Homeowner*. (JDS-MN)

1090 KAAY AR Little Rock – 10/18 0740 – Out of commercial for I-Heart Radio app. Station ID: "KAAY." Followed by song: You'll Never Walk Alone. (**JDS-MN**)

1140 KCXL MO Liberty – 10/16 0857 – Spanish ad for Frontera Supermarket in Kansas City, Kansas, then ID as "La Poderosa 11-40" so not-so-powerful 4 kW KCXL (KC market) is still partly-Spanish. NRC AM Log 2014-2015 lists formats: TLK/NOS/SPT/SS! Hearing grocery ad at first might equally have led to KLTK Centerton AR, fully Spanish and owned? by Mercado Las Américas. (GH-OK)

1140 WRVA VA Richmond – 10/9 2135 – KRMP OKC is not to be heard, not cheating tonight, and XEMR Monterrey is unusually weak, allowing me instead to copy "News radio 11-40, WRVA". 50 kW from Richmond VA is seldom heard here with its day & night figure-8 pattern of NW/SE, far from ideal for here although not in deepest null. Southerly conditions are subnormal, with XEMR weakened, although fading up some at 2156 about salvación, but still nullable. I compare to other Regiomontana bigsigs: XEG 1050 is OK but not as strong as usual; and XET 990 is way under CBW Winnipeg, far too unusual but very welcome: CBW is ND, while XET is supposed to be directional south at night. - **1200 WOAI TX San Antonio** 10/22 1921 Out of commercials including BBQ Outfitters. "San Antonio sports, plus breaking news, traffic and weather. News radio 12-00 WOAI." **(JDS-MN)**
- **MN Stillwater** 10/22 1927 Out of nostalgic music "That's Johnny Mathis and Lawrence Welk, Wonderful, Wonderful. On the station that plays America's best music. I don't know if that's true, but it sure sounds like it could be. 12-20 KLBB." (JDS-MN)
- **TX** Weatherford 10/20 2000 Good to poor in extreme auroral conditions, Double Kaz pointed west (280 degrees). Ads into South Asian music. One ad in English read by a woman with a heavy South Asian accent was for the Spicy Cuisine restaurant in Irvine, and she said mention Radio Hot Pepper (matches listed NRC AM Log slogan) for a discount. Station is only 1600 watts day 200 watts night and was heard just at power changeover time. NEW! (BD-WI)
- **1230 WIBQ IN Terre Haute** 10/16 2234 Poor "...8 stores in Indiana." "News Talk 1230 and 1440 WIBQ." (JJR-WI)
- 1230 KMRS MN Morris 10/10 0905 Poor with calls, MN news in mess. (JJR-MI)
- **1230 WYTS OH Columbus** 10/14 1859 Poor but in the clear with a legal ID, then back into the GY jumble, Double Kaz pointed east (100 degrees). NEW! **(BD-WI)**
- **1240** KDEC IA Decorah 10/13 0916 Poor "Good Time Oldies 1240 KDEC." Lost. (JJR-MI)
- **1240 WFTM KY Maysville** 10/11 2259 Poor with OLD music, legal ID: "You're listening to Cool AM 1240 WFTM Maysville," then possibly into an unID newscast. NEW! One thing that the Double Kaz does well when pointed east is to considerably null local WHFA, which is not true when it is pointed west or I'm using a loop. This was my first new station logged on1240 since 2001! **(BD-WI)**
- **1240 WJON MN St. Cloud** 10/13 0830 Poor Political ad, calls, local news in mess. (**JJR-MI**)
- **1240 KCCR SD Pierre** 10/11 0619 Poor ESPN content, "...from the South Dakota Broadcasters" No calls. (JJR-MI)
- **1260 KSGF MO Springfield** 10/23 0130 With local calendar of events, briefly atop the jumble, . Night pattern is supposedly circle tangent south major lobe, and small ellipse opposite north minor lobe, i.e. null toward us. I at first took it as KSPF which would make more sense, but that's a call for no US AM station. **(GH-OK)**
- **1270 KXQZ ID Twin Falls** 10/10 0853 Comedy routines; voice-over legal ID at 0900:40: "Comedy 12-70 KXQZ Twin Falls," then more of the same. Fair at best in the group. Ex-KTFI. (**JW-CO**)
- **1270 KLXX ND Bismarck-Mandan** 10/21 0359 Poor, somewhat distorted signal in noisy auroral conditions. Double Kaz aimed west. NEW! **(BD-WI)**
- **1280 WGBF IN** Evansville 10/18 0206 "Tri-state area -talk 1280 WGBF," then fade out. I wasn't sure of the W+ calls but this is the one that slogan matches in NRC AM Log. NRC Pattern Book shows one of its three lobes is westward, enough for us. Has anyone compiled how many "tri-state areas" there are in the US a lot! Hardly distinctive and how many actually go by that moniker? There are even more bi-state areas but no one seems to care about them. **(GH-OK)**
- **1300 KGLO IA Mason City** 10/22 1950 Local weather ending with "That's your weather eye forecast powered by wetherology.com for AM 13-00 KGLO. Right now it's 57 degrees." (JDS-MN)
- **1300 WQPM MN Princeton** 10/10 0835 Poor with news, write to community@ WQPMradio.com. The Big Q, Oldies. (JJR-MI)
- 1310 KGLB MN Glencoe 10/22 1959 Out of song: "Lovers Live Longer." "AM 13-10 KGLB. Glencoe classic hits country." Into song "The Devil Went Down to Georgia." (JDS-MN)
- 1340 KDTD KS Kansas City 10/20 2034 Fair to poor in auroral and graveyard QRM conditions with messages in SS and slogan "La Gran D 1340, la Mas Mexicana." Double Kaz aimed west. NEW! (BD-WI)
- **1380 KCII IA Washington** 10/15 0811 Poor; news with male, female anchors. Very localized, "Washington ... here in Washington." No calls. (JJR-WI)

- **1400 WGIL** IL Galesburg 10/17 0725 Poor but loud in WRJN null. "6:25, no...6:26. WGIL Morning News." (JJR-WI)
- **1400 KLIN NE Lincoln** 10/20 2159 Fair and almost completely in the clear with ads for Servpro Lincoln and others, into Fox news at ToH. NEW! My sixth new graveyarder since the start of the season. Double Kaz pointed west. **(BD-WI)**

No Chinese accent evident, and hard to believe CRI would cover such news from Beijing, so this pair also get news on hour from elsewhere?? 2202 fading in and out. Must keep KXEL nulled. But at 2203 UT, 1540, KEDA San Antonio overrides with ad in English for Oktoberfest event at
- a Catholic church in Lyman(?) TX, Tejana music. (GH-OK)

 1550 WPFC LA Baton Rouge 10/23 2201-2205 Tenative; good to fair over/under many UNID's with Black Gospel music. No announcements. I have heard this one

many nights for a number of years but have never had a positive ID. They run 5 kW day with slightly directional signal and 42 watts night. (JEL-MO)

1560 KEBC OK Del City – 10/15 1459 – "KEBC Del City" ID and no mention of any translator, into NBC Sports radio. Last March while in OKC, I had heard it duplicated on 92.9, and so listed in the 2014 NRC AM Log, but that has since changed, with the 92.9 presumably reassigned to another station in the group. I was checking this out for Log editor Wayne Heinen. **(GH-OK)**

1580 KREL CO Colorado Springs – 10/18 0159 – Ads for barracuda.com and Australian Dream, then "KREL, Colorado Springs, 15-80 sports, all sports all the time." Dominating frequency despite "140" watts at night vs 10000 watts day power, both non-directional. Listed as "ESPN 1580" but I did not hear ESPN mentioned in this ID. (GH-OK)

1580 KOKB OK Blackwell – 10/10 0850 – KOKB Blackwell with talk show interviewing State Rep. Cory Williams, Democrat! of Stillwater, about the insane push for allowing guns on campus. Conversation continues past hourtop until a break at 0906. Evidently Williams is a regular guest on this show Friday mornings, not all just stupid sports talk on the Triple-Play stations, with 1020 KOKB Perry and 105.1 originator in Stillwater. (GH-OK)

1620 WTAW TX College Station – 10/18 2134 – Professor Michio Kaku's 'Science Fantastic' show as he discusses fusion vs fission, the theory of H-bombs, and how he was a protégé of Edward Teller. 2158 wrap-up. Good, dominant signal. Seems WTAW is the only station where I run across his multiple-affiliate show again and again. **(GH-OK)**

TX Richardson – 10/14 1014 – Weak, but was able to catch a phone number of "214-782-9951" twice and a "Kick 1700" slogan ID during a promo in English, then into Tejano music. Phone # matches what's on their Facebook page. **(RD-KS1)**

UNID

1300 UNID -- 10/16 0854 – Under XEP Juárez, Gounod's 'Ave Maria' is sung, so likely a Catholic station. The only EWTN I find in the NRC AM Log on 1300 is far too far in South Carolina. At the EWTN.com website I can't find any affiliate lists; Spanish leads to SW only. Ave Maria could be on an English affiliate. A couple of Texans are SS:REL, KKUB Brownfield, and KLAR Laredo. Probably too late for WNQM Nashville which is part Spanish, and would be on 50 kW ND. (GH-OK)

10/23 1858 – Something looping NW/SE with CCI, 1-800-MYSOLAR ad, just can't make out any 1859 ID before CBS bong and news sounder at 1900. I'm here seeking any trace of KGNO Dodge City KS on SSS, since I can't hear it on daytime groundwave and suspect it's off the air. But NRC AM Log doesn't have CBS on it; the most likely one in neighboring states would be KJCE Rollingwood TX (Austin market). I've been monitoring since 1830 during the partial solar eclipse, in case there's anything of interest. Skywave is in at top end of band, but not really unusual. Clouds cleared for less than a minute, not long enough to set up a projection for a glimpse of the Moonbite. (GH-OK)

10/21 0142 – As I am monitoring Anguilla, a noise blob is very slowing crossing 1610 and moving upward. It's not like IBOC; an ionosonde? Or some new local device? By 0143 it's crossing 1620 R. Rebelde and a SAH. 10/23 0124 – Same thing is happening again, noise blob gradually moving upward from 1610 across 1615, by 0125 across 1620 stations. What is this? (GH-OK)



INTERNATIONAL NEWS

ALGERIA: Noted testing new transmitter on **252 kHz**, OCT 17 0030 with a 1 kHz test tone. s9+45dB -29dBm, tremendous signal. RTA Algerian long wave 252 kHz refurbished in past months, a new solid state LW unit of TranRadio/former Telefunken Berlin Germany unit and rebuilt also long wave antenna by Ampegon Schifferstadt Germany. [Wolfgang Bueschel, *mwoffsets*]

IRELAND: RTÉ is postponing the closure of its 252 long wave radio transmitter, the Managing Director of RTÉ Radio has told the Joint Committee on Transport and Communications. Jim Jennings said what was evident was that more time was needed to engage with groups affected. The closure has been postponed to 19 January 2015. RTÉ had previously announced that it would be ceasing its service from the Clarkstown long wave transmitter on 27 October and migrating its Radio One service to digital platforms. Mr. Jennings said the decision to cease any RTÉ public service is not something that RTÉ takes lightly or without serious consideration. He said, "We know that such decisions affect audiences who enjoy and rely on RTÉ's services. However, we also know that the public expect us to manage our operations and services efficiently and evolve our services as technology changes and audiences adapt. In balancing these broad considerations we have come to the decision that now is the right time to cease our long wave Radio One service after ten years on air." Mr. Jennings said an RTÉ delegation will travel to the UK to meet organisations and see if there is a better solution to the long wave issue. He said RTÉ is doing all it can to engage with community groups. RTÉ accepts that the window given for closure was too short and a longer window was needed, he added. [www.rte.ie/news]

MEXICO: In most parts of Mexico, DST ends on Sunday, October 26, when clocks are set back one hour from 2 a.m. to 1 a.m. local time. However, the northern Mexican border towns, like <u>Tijuana</u> and Ciudad Juárez, follow the U.S. DST schedule, and set their clocks back one week later, on Sunday, November 2, 2014. A few Mexican cities, like Hermosillo do not observe DST at all. [www.timeanddate.com via Steve Ponder, *ultralightdx*]

UNITED KINGDOM: All of the *Magic AM* stations in the north of England are to change format and name from January in a major re-branding by Bauer Media. They will take the name of their parent FM station with an oldies format targeting the 45-65 age group. In each of these areas a new local DAB station based on The Hits Radio (currently only on Freeview) and aimed at the 15-25 age group will become available also taking the parent FM station's name with a current hits format. At the same time London's Magic 105.4 will go national on Digital One replacing Absolute 90s. The name changes due to take place in January 2015 will be as follows: 828 Magic (Leeds) - Radio Aire 2; 990/1305/1548 Magic (S Yorkshire) - Hallam 2; 999 Magic (Preston) - Rock 2; 1152 Magic (Manchester) - Key 2; 1152 Magic Newcastle - Metro Radio 2; 1161

NOAA Space Weather Outlook
Issued October 20, 2014 – For the period October 20-November 15, 2014

Solar activity is expected to be at low to moderate levels (R1-R2, Minor-Moderate) during the forecast period, with a slight chance for X-class flaring (R3-Strong or greater) for 20-29 Oct and 11-15 Nov due to potential significant flare activity from Region 2192 (S13, L=251).

A slight chance for a greater than 10 MeV proton event (S1-Minor and above) at geosynchronous orbit exists for 20-29 Oct and 11-15 Nov due to potential significant flare activity from Region 2192 (S13, L=251).

The greater than 2 MeV electron flux at geosynchronous orbit is expected to be at normal to moderate levels with high levels possible from 21-25 Oct due to CH HSS influence.

Geomagnetic field activity is expected to be at quiet to unsettled levels from 20-21 Oct and 24 Oct-15 Nov. Unsettled to active levels are expected on 22-23 Oct due to CH HSS activity.
