

610 KARV AR Russellville – 11/17 1800 – Fading in loop null of WDAF (Kansas City). Fair reception with health talk and interviews with veterans along with call ID. Previously unreported station. (JR-OK)

**610 KNML NM Albuquerque** – 11/5 2130 – Sports talk with ID. Good signal in loop null of KCSP. (JR-OK)

**640 KTIB LA Thibodaux** – 11/11 1914 – Oldies, local weather at 1916 and ID at 1917. **(FO-OK)** 

**680 KNBR CA San Francisco** – 11/27 0138 – Bay Area ads, 0141 KNBR ID, into basketball scores. Best with IBOC from 670 WSCR nulled, i.e. aimed NW instead of W. Fast SAH of about 10 Hz from something, maybe San Antonio? Despite the silly sports format, I'm always pleased to hear KNBR which is the most distant domestic MW 'regular' here, over 1300 miles from San Francisco, slightly further than NYC, whose 'clears' hardly ever make it. **(GH-OK)** 

**730 WZGV NC Cramerton** – 11/30 0800 – Poor with LID, "ESPN 730" in w/3 others. (JJR-WI)

**730 WPIT** PA Pittsburgh – 11/30 0759 – Very poor; way underothers. LID jingle "730 WPIT Pittsburgh." Not heard in while. (JJR-WI)

730 KKDA TX Grand Prairie – 11/25 1922 – Korean talk show with two males, can only be KKDA. (FO-OK)

740 WNOP KY Newport – 11/28 0645 – Poor; EWTN Sunrise Morn Show, Sacred Heart Radio cut in. CFZM nulled. (JJR-WI)

- **790 KOSY AR Texarkana** 11/18 1750 Difficult reception needing careful orientation of loop antenna and phasing with active whip. UC gospel music and partial ID. New here. Previously unreported station. (**JR-OK**)
- **790 KFYO TX Lubbock** 11/25 1949 Local news story about a county employee who urinated on another employee's office chair??? WOW, are they hard up for news in Lubbock. ID at 1957 as "Newstalk 7-90, KFYO." **(FO-OK)**
- **790 WAYY WI Eau Claire** 11/21 1923 In briefly with call letter ID, not uncommon here. **(FO-OK)**
- 800 CKLW ON Windsor 11/19 2130 News, weather and call ID. Good reception in phase null of KQCV (OK City). New here. (JR-OK) 11/26 0154 Tentative; Jesse Ventura-like voice and probably JV himself on Coast to Coast AM // countless other frequencies like 840, 850 but never synchronized; with KQCV OKC nulled. Presumed CKLW Windsor, Ont., though also listed as on CJAD Montreal, and low-night-power stations in AL, MO, WV. CKLW does have a minor lobe toward us out of 50000/50000 U4, while KREI Farmington MO in between is 1000/150 U1. (GH-OK)
- **810** KLVZ CO Brighton 11/25 2003 Religious program "right here at KLVZ." Ad for Denver Rescue Mission at 2004. Several ID's heard and new for me. (FO-OK)
- **880 KHAC NM Tse Bonito** 12/4 0800 Very good signal with ID "Thanks for listening to KHAC, The Voice of Hope," and then nothing, almost as if signing off at this odd hour. Obviously still on ND day power from Tse Bonito NM. No sign of KLRG AR. **(GH-OK)**
- **900 KTIS** MN Minneapolis 11/30 1729 Good; RZIM.com, Austin Hall in Morning, KTOS weather. "Faith 900." (JJR-WI)
- **900 WATK WI Antigo** 11/27 0724 Poor; no CHML. "564 Antigo Classic Hits 98-7." (**JJR-WI**)
- **920 KYFR IA Shenandoah** 11/22 1754 Religious program with "Wilford Fisher of Men," and ID at 1759. **(FO-OK)**
- **920 KYST TX Texas City** 11/22 1749 SS talk show, call letter ID at 1801. **(FO-OK)**
- **930 KAPR** AZ Douglas – 11/27 0759 – With WKY OKC Spanish music nulled, I am getting Spanish talk from another, soon ID in Spanish for KAPR, 930 en Arizona, "Ésta es Qué Vale" (? Not certain of that slogan). Makes SAH of about 5 Hz. KAPR is nowhere listed as Spanish! It had been Christian and/or talk in English, and apparently duplicating 1030 KVOI Cortaro (Tucson). A recent format flip. How recent may account for the Spanish I had been hearing several months previously around sunrise in WKY null, not with definite ID but hoped to be KHJ Los Angeles (which is no longer Spanish ranchera, but Immaculate Heart! in English since Nov 17). I had not considered KAPR since was supposedly English. It's in Douglas AZ, right on the border, appropriately owned by Sonora Broadcasting, U1 = non-directional, 2500 watts day, 71 watts night, and "day" doesn't officially start there until 0845 in Nov. However KAPR does have a PSRA of 500 watts starting at 6 am local = 0800 ELT, all year except unneeded when sunrise is even earlier, so maybe it just powered up, though soon fading. (GH-OK)
- 960 KCGS AR Marshall – 11/29 2153 – In MW bandscan I try nulling local KGWA, and voilà, there's another station I normally can't hear even during Fox-holes: program is 'CCM Magazine' pausing for ads, including 1-800-990-6976 to become debtfree; chia(?) seeds for Omega-3; 2155 back to the first of four Xmas editions of the CCM Radio Magazine, i.e. Christian, kid singing. Remains steadily audible as long as I keep KGWA tightly nulled, very little fading. 2200 quick ID sounds like KTCS, into SRN "news." Uplooked later, it has to be KCGS in Marshall AR, 5 kW daytime, 44 watts at night, non-directional; yeah, right. Finally fades out (or powers down?) at 2205 as I strain to hear another ID after news. Marshall is in north-central Arkansas on US 65 between Little Rock and Branson. NRC AM Log lists as merely talk format. Wiki claims KCGS has southern gospel format, more like this. Own website kcgsam.com has expired. CCM is a Salem thing, standing for Christ, Community, Music: But no KCGS found searching there. Another night, another cheating razorback: 25 hours earlier, it was 1530 KVDW. (GH-OK)
- 970 WGTK KY Louisville 12/2 0202 WGTK ID for information, and promo for 94.7 FM and 900 AM, "The Spirit." Must be sibling stations; NRC AM Log shows 900 is WFIA Louisville KY, religious, but no listing for 94.7 FM //. Nor is there any 94.7 in KY around Louisville; instead, WFIA-FM is licensed to New Albany IN across the Ohio. Nor does WTFDA FM Database mention that it's also on 900

- AM. Although jointly promoted, I suppose that AM & FM could be separately programmed? Anyhow, 970 WGTK itself is licensed to Louisville KY, né WAVE, 5/5 kW U4: major lobe at night goes broadly SSW, minor NNE, with notches to the NE and NW, so some signal our way to the WSW. All of these are now owned by Salem, purveyor of various Christian-right formats. Soon followed by a KCFO Tulsa ID in passing on 970. **(GH-OK)**
- 990 WDCX NY Rochester 11/30 0700 Poor; REL preacher. Pastor Walker ... Rochester. No CBW! (JJR-WI)
- **1010 WKJW** NC Black Mountain 11/25 1705 Fair to good with IRN/USA news at tune-in, legal ID // WKJV 1380 Asheville NC, ad for Foothills Baptist Bible College classes into local news. Slogan given as "Pure Gospel Radio and Christian 1010." Needed call change, ex-WFGW. (BD-WI)
- **1030 WWGB MD Indian Head** 11/27 0653 Poor to good with light to moderate WBZ QRM, with religious sounding SS music, "Radio Poder 10-30" ID in SS at 0653 and LID in EE at 0701. Needed call change, ex-WNTL; call change dates back to 8/22/97, so this is a station that doesn't make it here very often! My thanks to fellow WI DXer Bob Brossell who tipped me off on this one. **(BD-WI)**
- **1050 CJNB SK North Battleford** 12/1 0745 "Frosty the Snowman" song; CST time check at 0748 followed by CJNB/CJNS ID and weather; then, a "Today's Country" slogan and more music. Fair at best with fading and QRM. **(JW-CO)**
- **1060 CKMX AB Calgary** 11/30 1934 Poor, steady, clear. KYW nulled. "All Comedy, Funny 1060AM." (JJR-WI)
- **1070 CHOK ON Sarnia** 11/30 2031 Poor with calls after sitting thru 3 songs. WTSO nulled. Oldies. **(JJR-WI)**
- **1090 WTNK TN Hartsville** 11/28 0557 Good and in the clear under an OC, probably KAAY, with C&W music, legal ID "The Heart of Tennessee, AM 1090 WTNK Hartsville" back to music. Needed call change dating back to 4/1/03, ex-WJKM. **(BD-WI)**
- 1120 WKAJ NY St. Johnsville 11/30 1936 Poor in KMOX null. "AM1120 WKAJ" It's Too Late" Carole King. (JJR-WI)
- 1160 KVCE

  TX Highland Park 11/27 2058 In bandscan I pause here expecting it to be KSL vs KFAQ Tulsa IBOC noise, but ID right away as "KVCE, Highland Park, Dallas-Fort-Worth's business authority." Not sure I've heard this one before; NRC Pattern Book shows 35 kW day lobe goes ESE, 1 kW night lobe goes SE. Previous reports in DXLD mention that it has two different sites day and night, the latter being near KSKY on a golf course. It was late enough for KSL to be propagating, and at next check 2142, I am only hearing KSL with sapphire jewelry ad from Shane.com (? Everyone in SLC must know how they spell Schön?), which is at State Street and 7200 South giveaway street grid pattern for SLC and other ads. (GH-OK)
- **1160 KRDY TX San Antonio** 11/25 0758 Sounded like news in progress (Spanish) and a couple of ads; legal ID at 0801:15, then a "Radio Luz" slogan and more news. Rough copy with blowtorch KSL only partly nulled. **(JW-CO)**
- 1170 KRUE MN Waseca 11/30 1844 Poor though steady in tight null. "KRUE1170.com" Oldies. (JJR-WI)
- **1190 KDMR MO Kansas City** 11/27 0847 Fair signals fading up on top with EWTN religious programming. No WOWO or CFSL for a change. NEW! Another station removed from my target list. Have to love that! **(SMA-MB)**
- **1220 KZEE TX Weatherford** 11/17 1929 Asian music, unreadable ID at 1937, another unreadable ID at 1941 that sounded like Weatherford, Texas, and finally at 2000, good ID as "Hot Pepper 12-20 AM." **(FO-OK)**

- **1280 KCOB IA Newton** 11/30 0718 Poor. Loews ad, "Your Hometown Station-KCOB" alone on frequency. **(JJR-WI)**
- **1310 KZRG MO Joplin** 11/28 0706 Poor, steady in WIBA null. "31 degrees at News Talk KZRG." (**JJR-WI**)
- **1310 KGMT NE Fairbury** 11/29 0723 Poor; "All the great hits play here! 1310 KGMT." No WIBA. **(IJR-WI)**

- 1380 KSRV OR Ontario 11/28 0958 Oldies tune "My Guy;" legal ID at 1000:35: "Always Good Times and Great Oldies you're listening to Oldies 1380 KSRV Ontario," followed by ABC news; back to music at 1004. Fair peaks on post-sunrise skip. (JW-CO)
- 1380 KBWD TX Brownwood 11/20 0559 Simple legal ID in QRM, not much else readable. (JW-CO)
- **1380 KRCM TX Shenandoah** 11/20 0759 Legal ID at ToH, I think there was an ID for sister station KJOZ-880 but can't be sure due to QRM. Spotty reception with Spanish religious programming. A new one here, TX #181. **(JW-CO)**
- **1390 KJPW MO Waynesville** 11/12 1800 Ads for Ozark travel locations with call ID. New here. **(JR-OK)**
- **1410 WRTZ VA Roanoke** 11/21 1654 Fair to poor with light to moderate unID QRM, with oldies, promo for station website <u>trueoldieswrtz.com</u>, LID at 1700: "This is 1410 WRTZ Roanoke, a radio service of Metromark Media" back to oldies. NEW! **(BD-WI)**
- **1440 WPRS** IL Paris 11/27 0715 Poor; "News Talk 1230 & 1440 WIBQ," Dave Ramsey promo. Others nulled. (JJR-WI)
- 1440 WZYX TN Cowan 11/27 0700 Poor with LID over others. No WNFL, WJJL. (JJR-WI)
- **1460 KZUE OK El Reno** 11/26 2000 "La Tremenda" slogan and legal ID by man: "This is KZUE 1460 AM El Reno, Oklahoma," followed by news from Canal Continental de Noticias. Fair peaks but usually under the QRM. Supposed to be a daytimer but this was at least 90 minutes past their sunset. **(JW-CO)**
- **AZ** Show Low 11/28 0902 Ads and program note; at 0903 gal says "The temperature at your KVSL Weather Center is 43 degrees," followed by Oldies music. Generally fair for the next 20+ minutes, with music, northern Arizona ads, and occasional call letter ID's. The FCC database still shows the move to 1470 as a Construction Permit, with operation still on 1450, so maybe they were testing. Heard a few more times on subsequent days. A new one here, AZ #67. (JW-CO)
- **1470 KWSL IA Sioux City** 12/2 0402 Man with EE/SS legal ID at 0402: "Desde los estudios de Bargain Bedding, esta es KWSL Sioux City, La Preciosa Catorce Setenta, con sus éxitos favoritos," followed by tropical-style music, including some traditional Christmas songs done cumbia-style. Generally fair with not much QRM. **(JW-CO)**
- **1470 KHND ND Harvey** 11/20 0906 Program notes for area basketball teams; call letter ID. Poor. (JW-CO)
- **1490 KDMO MO Carthage** 11/12 1810 NOS music and call ID. Twilight reception the signal was fading and weak. **(JR-OK)**
- **1510 KNNS KS Larned** 11/21 1335 On car radio, tell-tale het caused by KCTE Independence MO being perpetually off-frequency, audible at local mean noon (1332 ELT), with the solar insolation angle approaching its wintry nadir allowing

skywave. The hetee is presumably on-frequency KNNS barely by groundwave. At least we haven't heard daytimer KCTE's het at night lately. 1431 recheck, IDs as ESPN 1510 (and 1660 Kansas City, Bloomberg Radio is also audible); 1443 UT ad for Hendrix Buick-GMC on Stateline Road, which is a dead giveaway for Kansas City MO/KS market. (GH-OK)

1510 WLGN OH Logan – 11/21 1855 – Fair below WLAC QRM, with oldies and a quick singing jingle ID "WLGN AM Logan." Station is a 1 kw daytimer, so on late this night. NEW! (BD-WI)

1530 KVDW AR England – 11/28 2053 – On car radio, string of ads with AC 501- phone numbers, mentioning Little Rock. Also may listen on Smartphone via tune-in to KVDW; ID as "Z 100.9 and AM 1530." Not sure about the Z. It's obviously the station listed in NRC AM Log as KVDW, England AR, 2500 watts daytime non-directional and no PSSA, // K265EO, 100.9, "Victory 1530," UC:GOŚ/REL format. England is just southeast of Little Rock. Another daytimer on late and thus DXable despite all the other cheaters and WCKY. I thought the translator might be in Little Rock itself, but FCC FM Query shows it too in England with 250 watts, and a CP MOD to put it in Stuttgart with only 50 watts --- that doesn't make sense as Stuttgart is twice as far from Poca Roca than England is. (GH-OK)

1530 KXTD OK Wagoner - 11/27 2053 - Romantic music in Spanish, with WCKY easily avoided, but hard to get a directional fix on this; surges to very good level at 2056 for "Qué Buena" plugging Navidad; 2100 music keeps playing thru hourtop vs ESPN from WCKY. 2103 apparent full ID but during fade, caught only Qué Buena again. Anyhow, it's KXTD Wagoner (Tulsa), 5 kW daytimer again on way past sunset. (GH-OK)

1550 KLFJ **MO Springfield** – 11/10 1715 – Branson information radio. News about Branson attractions and shows. (JR-OK)

WI New Richmond – 11/27 0835 – Poor to fair signals in a mix of stations with 1590 WIXK their new Hmong language and music programming. No longer country music. Much easier to spot with this format as the language and music is very distinctive. **(SMA-MB)** 

Algona – 11/28 1700 – Poor signals faded up on top with country music then **1600 KLGZ** IA full ID on the hour by a woman. NEW. (SMA-MB)

**1600 WULM OH Springfield** – 11/22 0900 – Fair with moderate unID QRM, with a multistation legal ID at tune-in which turned out to be that of the Radio Maria Network. Listed were 10 stations, six FM and four AM including 580 KJMJ LA, 1250 KDEI TX, 1360 KNIR LA and WULM. Needed call letter change, ex-WBLY and dating back to 7/30/02. (BD-WI)

NE Bellevue – 11/30 0130 – KOZN, "The Zone" with KETV-7 weatherperson on 1620 KOZN what's "coming up Friday afternoon in Omaha"!! But this is Sunday morning already. O well, blame the automation. Or rather the human supposed to be in charge of it. (GH-OK)

1680 KRJO LA Monroe – 11/24 0205 – Playing Xmas music already, country-accented; and another one later. Not sure if it's all-Xmas music. It's before Thanksgiving yet, but in some other markets the radioed Xmas music started after Hallowe'en. Enough already! (GH-OK)

#### MISSED OPPORTUNITIES

1520 ---



11/20 1950 – On car radio, KOKC is absent! Nothing else except enough weak carriers to audiblize the 1521 het from Sa'udi Arabia. Tsk, tsk, a golden opportunity for WHOW or KOLM, but neither audibly cheating tonight. Would have been nice to hear WWKB Buffalo NY, which is 50/50 kW U3, but with deep null to the west day and night. (Only as a DX catch since it's just another ESPN nonentity.) WWKB has been erratically off due to the snowstorm, allowing Rob Ross in London, Ontario at one point to hear nothing but KOKC on 1520, but KOKC is supposed to be westward only at night, although granted an STA of 12.5 kW due to antenna problems, so maybe also non-directional? If WWKB has been damaged, or due to emergency, it might also be non-directional temporarily. At 1954 KOKC pops back on, amid anti-American diatribe by Michael Savage who's on until 2000. (GH-OK)

- GERMANY Europe 1, Felsberg DEC 2 0550 Man in French continue to woman in French 0603. Using 746Pro and NRD 525 both modified by Dallas Lankford for MW and LW. [Wilkner-FL]
- SAUDI ARABIA *BSKSA* Duba NOV 21 0137-0305 With 1520 WWKB off the air due to the massive Buffalo snow storm, I see a spike at 1521 kHz in the SDR spectrum display. Difficult with interference from 1510 WLAC and 1520 stations (WSVX, other talk, Spanish singing, religious singing and foreign singing). Switch to USB. Hearing Arabic talk and male singing on 1521 kHz. Listen until 0300 when station leaves the air. Matches WRTH for BSKSA. Nice surprise and new station for me. [Krist-VA]

- MEXICO XEETCH Etchojoa, Son. NOV 14 1305 Local music; ID at 1307, followed by talk and announcements by male announcer until 1315; another call letter ID was followed by indigenous fiddle music; noted one "La Voz de Los Tres Rios" slogan. Fair signal, with another Spanish-speaker underneath, probably XEGD. [Wilkins-CO]
- 810 **BAHAMÁS** ZNS3 Freeport NOV 23 0010-0020 Sport talk about Miami Heat then into weather conditions of the islands. [Wilkner-FL]
- 870 XETAR Guachochi, Chih. NOV 27 1303 - Mexican choral national anthem is playing, replacing weak Vietnamese from The Metroplex I had been hearing before 1300. At 1304, XETAR sign-on, first by man in Spanish, then by woman in presumed Tarahumara - and then another man in apparent third language. Many IDs follow, by calls and by La Voz de la Sierra Tarahumara. 1305 local vocal ensemble starts singing same national anthem in non-Spanish, but faded down for more talk in Spanish, station's mission statement, etc. 1306 mentions 10,000 watts on AM 870 and no mention of any FM which I thought I heard previously; and via complicated website "llegamos a todos los países del mundo." Sked is still 12 hours daily 6 a.m. to 6 p.m. Complicated email address; 1308 heard 'interval signal' of percussion for second time, not exactly drumming. 1309 talk in TT with heavy echo imposed, 6:08 time check in Spanish, temp -4; 1311 history of station, started in 1982 on 860 with 5 kW; at some point stayed on air until 8 p.m.; 1314 starting to fade. So now is good time to get this on SRS: Enid sunrise today 1321, with another 25 minutes to go before its latest in early January. XETAR website with much more info is www.cdi.gob.mx/index.php?option=com\_content&task=view&id=872&Itemid=44 including about languages: "Un claro propósito de la XETAR es el fortalecimiento de las lenguas indígenas. Así, promueve el rarámuri (o tarahumara), el odami (o tepehuano) y el o'oba (o pima) en sus transmisiones diarias." [Hauser-OK]
- MEXICO XEQ *La Q Mexicana*, México DF NOV 28 1055 "Hey (Hey!)" by Julio Iglesias, male DJ, "Todo Cambio" by Camila, female canned, "Escuchado... XEQ Radio... México DF... estéreo... MHz... www-punto-xeqradio-punto-mx... La Q Mexicana." Parallel their live stream. Right on frequency, so did they fix the forever off-frequency (939.88) or do they have a second transmitter that works correctly? [Krueger-FL] Likely temporary, a back-up transmitter. Logged on-frequency a couple weeks last season too. [Conti]
- MEXICO XEFV Cd. Juárez, NOV 26 0642 With KTOK nulled, hearing not only the usual Mexican music from XEFV, but also some sports talk in English: don't see how this could be anything but WMVP Chicago despite unfavorable nite pattern. Also ~1 Hz SAH but not clear between which pair of the trio. At 0659 try to get an ID of sports station, but mainly Mexican dominating with Juárez mention again at 0702. Now I measure the SAH at 42/minute = 0.7 Hz. Anyhow, no KKIM which would be preaching, evidently no longer cheating with 10 kW ND day power. [Hauser-OK]
- MEXICO XEYC Cd. Juárez, Chih. NOV 17 1257 National anthem in progress; canned ID at 1259 by fast-talking male voice: "Escucha Radio Fórmula Ciudad Juárez XEYC Diez Treinta AM con cinco mil wats de potencia..." with address also given, sounding like "Garrota numero 5385" or similar, and not matching any of my references. Soon faded, with

XESDD taking over a few minutes later. All this, of course, way under pest KTWO. [Wilkins-CO] DEC 4 1256 – Looping roughly east-west, full ID for *R.Fórmula*, XERFR, 970 in México DF, i.e. flagship of far-flung network in Mexico and the U.S. – at first I wonder if it could be the 50 kW Spanish in Memphis, but it's still supposedly its own *R.Ambiente*. No, it must be the only real XE *R.Fórmula* affiliate on 1030, per Cantú XEYC 5000 500. IRCA Mexican Log agrees except power as 1000/1000. WRTH 2014 went with 5000/500. [Hauser-OK]

- 1100 **COLOMBIA** HJAT *Caracol Radio*, Barranquilla NOV 24 1103 ID's, Latin American news by male and female. Fair, parallel 1170 Cartagena. [Krueger-FL]
- MEXICO XERED Tlalnepantla, Edo.Mex. NOV 28 1115 Spanish ballad, male and female news headlines (Honduras, Mexico items), Mexican anthem at the odd time of 1124. Mention seemingly of "La Tremenda Corte" or similar. La Tremenda Corte is a program carried by XERED per online schedule. Poor with WBT co-channel and destroyed by WTIS Tampa up from 1141 with big carrier, into programming shortly thereafter. [Krueger-FL]
- MEXICO XEQIN San Quintin, BC NOV 20 1308 Mariachi and other Mexican music, man and woman announcers, occasional ID. Rough copy under megapest KSL, only partly nulled. [Wilkins-CO]
- 1170 **MEXICO** XEMDA *La Ley 1170*, Monclova, Coah. NOV 24 1059 Ad for store in Monclova, call letters but no slogan at 1100 into Spanish ballad, co-channel *Caracol* Colombia. [Krueger-FL]
- 1289.78 unID NOV 24 1123 Fairly big low end het, no audio. Being this far off channel, probably deep Central American, with more-or-less north/south LOB. Reading approximate. [Krueger-FL]
- MEXICO XEQI Monterrey, NL NOV 29 0132 On car radio, dominant signal is Spanish, news headlines mentioning "estado de Nuevo León" which is more evidence it's Monterrey's XEQI, lacking a real ID. Man and woman continue conversing. This on vertical car antenna not directional, with no nulling capability, yet this is atop WLAC, but losing out to it by 0135 UTC. [Hauser-OK]
- 2910.0 **MEXICO** XEVT Villahermosa, Tab. NOV 28 0219 When the noise level is rarely lower, I strain to rehear the third harmonic of 970 XEVT. Something is here, but it turns out to be mixture of local overload 1390 KCRC and something else, right on frequency, while XEVT x 3 was slightly off. Getting this only on the DX-398, not the PL-880, which is a bad sign. Better time to get XEVT would be pre-sunrise on the FRG-7. [Hauser-OK]

#### **INTERNATIONAL NEWS**

**BERMUDA**: The Emergency Broadcasting Station is now only on FM 100.1 MHz during emergency situations in Bermuda. The old **1610 kHz** is no longer operational. [Stig Hartvig Nielsen, *World Radio TV Handbook* FB group]

**FALKLAND ISLANDS**: The Falkland Islands government has advised that following storm damage earlier in the year, the service transmitted from Mount William has been repaired and is now back on air at **530 kHz**, broadcasting Falkland Islands Radio Service (FIRS) and BBC World Service when FIRS is not on air. However, British Forces Broadcasting Service (BFBS) has advised that the *BFBS Radio* 2 channel preciously transmitted on **550 kHz** from the BFBS Bush Rincon site will no longer be available as the equipment is beyond economic repair. [J.Brock, *Falkland Islands News Network* via mediumwave.info]

**GERMANY**: The longwave stations of *Deutschlandfunk* at **153** and **207 kHz**, and *Deutschlandradio Kultur* at **177 kHz** will close at the end of 2014. The public broadcaster is moving to FM and DAB+. *Deutchlandfunk* medium wave stations are scheduled to close at the end of 2015. [various sources

**GREENLAND**: NOV 27 0345 – Greenland is back on MW! KNR heard on **650 kHz**. [Jorma Mäntylä, Aihkiniemi, Finland DXpedition]

**GRENADA**: Grenada has left medium wave. In April 2014 transmission on **540 kHz** was terminated and 'Klassic AM' was renamed 'K105' – broadcasting on FM 105.5 and 105.9 only. [Stig Hartvig Nielsen, *World Radio TV Handbook* FB group] What happened to 1400 *Harbour Light*? [Conti]

**MARTINIQUE**: *Martinique Première* is inactive on **1310 kHz** and broadcasting on FM only. It is undecided if 1310 will be reactivated. [Stig Hartvig Nielsen, *World Radio TV Handbook* FB group]

**ST. KITTS & NEVIS**: *Radio ZIZ* has ceased broadcasting on medium wave **555 kHz**. It has been "eliminated" as stated by the station itself. ZIZ is on FM only now. [Stig Hartvig Nielsen, World Radio TV Handbook FB group]

**ST. KITTS & NEVIS**: *Radio Paradise* is due back on the air on **820 kHz** (50 kW) early 2015. Has been off air since mid-2013. The problems connected to a transfer of ownership from Trinity Broadcasting Network to Flowing Streams Church have been resolved now according to the new owner. [Stig Hartvig Nielsen, *World Radio TV Handbook* FB group]

**ST. VINCENT**: *NBC Radio* ceased regular operations on **700 kHz** (10 kW) in 2011, but kept the transmitter operational as a backup and reactivated for disaster purposes only. Now *NBC Radio* no longer maintains the medium wave transmitter for disaster purposes. [Stig Hartvig Nielsen, *World Radio TV Handbook* FB group]

**UNITED KINGDOM**: Eagle's AM licence on **1566 kHz** is now broadcasting the programmes of *Premier Christian Radio* after a sale was agreed on November 28. The move follows the successful format change request by owner UKRD to drop all local programmes from the Surrey and

Hampshire local station. Premier has now added the license to their portfolio of stations, adding extra analogue coverage to their three AM frequencies of 1305, 1332, 1413 in Greater London. At least in theory, the QRN should be \*less\* in all-digital mode. The digital signal "spills over" because the station has to protect its own analog signal. If there's no longer an analog signal to protect, the digital signal can be placed where the analog used to be, not in the adjacent channels. It would certainly make life easier for DXers! (as well as making it easier to DX in HD mode) It dawned on me last night (when it was way too late..) that the FCC should consider relaxing multiple-ownership restrictions in order to encourage conversion to all-digital mode. It might work like this:

Right now, in the largest markets, one firm may own as many as eight stations, with no more than five in the same service. Five FM and three AM, for example.

Maybe, you could count HD on the AM dial as a third audio service. And increase the total cap to twelve stations.

A hybrid station (with both analog and digital on the same frequency) would count as \*two\* stations. One AM and one HD. If you owned four FM and four AM with "on-channel" HD, you'd be at the 12-station limit. But.. if you turned off the "on-channel" HD on your AM stations... you could run four \*more\* stations, as long as they were operated in digital-only mode.

I've read that all digital signals on the AM band are still 20 kHz wide which will still ruin the two adjoining frequencies. That and all we will get is noise on that frequency and don't let them fool you, what they really want is an all digital AM band. Read what Glynn Walden said in Radio World on 9/10:"Glynn Walden, senior vice president for engineering for CBS Radio and former iBiquity Digital engineering executive, noted that the current hybrid digital system was always meant to be temporary, as stations would make the digital transition when it made economic sense. Going further, Walden says he fears there's not much indoor listening to AM happening much anymore due to the ever-rising noise floor. "Offering digital service is imperative. Analog's time is past. It's time to move on," Walden declared."

Subject: RE: Radio World: All-Digital AM Testing Begins Oct. 2 in Seattle

First of all, two stations, co-owned KRKO-1380 in Everett WA, and KKXA-1520 in the same county, will be testing in all-digital mode for several periods between now and Tuesday morning.

Both stations will test for one seven-hour period during the day and two four-hour periods during the night.

The first test will be on KKXA-1520 Thursday night from 9 PM to 1 AM. No test will begin on Friday. The second test will be on KRKO-1380 on Saturday from 9:30 AM to 4:30 PM. The following two tests wil be on KKXA-1520: Saturday 9 PM-1 AM and Sunday 9:30 AM-4:30 PM.

And the final two will be nighttime tests on KRKO-1380: Sunday and Monday nights from 9 PM to 1 AM.

I have no doubt that the daytime tests for both stations will please station owners and the IBOC proponents. Both stations are currently well-received in Seattle via IBOC in the daytime, with 50,000-watt signals coming from an adjacent county. The night signals may be trickier. Even though 1380 has other occupants, it may decode at night. It has a better signal with less fading and interference. KKXA-1520 has strong interference at night from a station in Lake Oswego, Oregon near Portland. I believe some areas of northern California get KKXA better than we do in Seattle, but the interference from the pre-existing Oregon station is formidable. I'll be very surprised if KKXA consistently locks in Seattle at night, but that's what tests are for. The meaningful real-world test would be for all-digital on KKXA and the Oregon station. Anyway, it will be fascinating. This is no WBT situation at night! I haven't received either station via IBOC at night, although both are received well on day pattern. I hope to be recording at least some of each test in HD mode, using nothing fancy--a Sony XDR S3HD radio with its supplied AM loop.

#### November 2014 Grayland Ultralight DXpedition

Saltwater Beach Escape from Dreary Asian Propagation By Gary DeBock, Puyallup, WA, USA November 2014

<u>Introduction</u> After Graham Maynard's introduction of the Ferrite Sleeve antenna in February of 2011 its DXing progress and refinement have been closely identified with ocean side cliffs, where its combination of exceptional sensitivity and exceptionally small size has proven to be fairly unique. The solid rock cliffs provide some measure of back side signal rejection for the figure-8 pattern antenna, as well as apparent transoceanic signal enhancement. All of these factors have contributed to the FSL's reputation as a serious DXing performer on the ocean side cliffs—at least in the category of single-optimized-frequency antennas.

After suffering through a rather dreary Fall Season of lackluster Asian signals at my landlocked home location I was dreaming of a salt water escape, however. A sudden opportunity to get away on America's Veterans Day weekend (November 8-10) opened up at the last minute, but it was impossible to schedule a visit to one of Oregon's ocean cliff sites on such short notice. After some quick consideration a decision was made to head for the flat ocean beach in Grayland, Washington—quite famous as a DXpedition spot for large single-loop wire and beverage antennas but hardly ideal for the figure-8 pattern FSL. My wife had visited the Grayland Motel with me 5 years ago, and had indelible unpleasant memories of the place. She pronounced the facility as unfit for human habitation – which meant that I would not only be going alone, but could also cram all kinds of fanatical DXpedtion equipment in our compact Toyota Corolla—such as the new 17" (43 cm) diameter Medium Wave FSL antenna and a 30" loopstick Sony ICF-2010.

30" Loopstick ICF-2010 SSB Spotting Receiver A classic example of the risk in having too much time and ferrite on your hands, the 30" loopstick ICF-2010 was designed to check transoceanic MW station carrier strength on ocean beaches for suitable Ultralight radio DXing targets. The monster loopstick is comprised of four Amidon 7.5" ferrite rods, with the two coils matched to the inductances of those on the original Sony loopstick. The finished product can track propagation changes on 32 transoceanic DX frequencies stored in memory, providing a typical sensitivity boost from 2 LED signal strength lights (on the stock model) up to 7 LED signal strength lights. Although it performs like a dream, attempting to fit it in a compact car fully loaded for a family vacation is like a nightmare. Since my wife and son had no interest in a return trip to the Grayland Motel, this would be my first chance to actually take it along on an ocean coast DX-pedition.

17 inch DXpedition FSL Antenna Graham's original ferrite sleeve article included a comment that the antenna would probably become the best portable MW antenna—ever. While some hobbyists may still may be unconvinced of this fact, the antenna's ultimate status as the heaviest and priciest MW antenna now seems to be in little doubt © At 17" (43 cm) diameter, 35.5 lb. (16 kg) weight and a construction cost of over \$1 K, the monster FSL antenna taken on this DXpedition was another oversized item that could never be accommodated in our compact Toyota Corolla when crammed for a "family vacation." With 129 Russian surplus 200mm x 10mm ferrite rods and a dual coil system to boost middle and high band MW sensitivity, the antenna has an extremely sinister appearance – making it highly unlikely to ever pass through any airport or border security checkpoint without raising a serious panic. Although the antenna was designed as the ultimate weak-signal magnet for narrow ocean side cliffs, its huge size makes it a deal-breaker for family trips to Oregon. As such, its first ocean coast test would ironically be on the flat beach at Grayland during this trip, where it would be without any cliff-provided propagation boosts or back-side signal attenuation. The hope was that the huge FSL's sensitivity would provide a decent variety of Asian DX when set up near salt water, despite the lackluster solar conditions, potentially dicey weather and unimpeded domestic station splatter. After all, what could be worse than the landlocked TP-DXing conditions at home, where the Fall Season had dropped off to the point where vibrant audio from even the big gun Asians was becoming a rare occurrence?

<u>Fanatical Ferrite Hits the Beach</u> November TP propagation had been dreary at home, so DXing expectations were fairly low as I took the 2-hour trip to Washington's Pacific coast. During the two hour trip to Grayland I was especially careful to obey all traffic laws – primarily to avoid the need to explain to local police what the multiple subversive-looking items in my car happened to be. Arriving late in the evening, my Spartan-looking room at the Grayland Motel motivated me to head directly for the ocean beach, foregoing any sleep before the first morning session.

<u>Day One (November 8)</u> The deserted beach was clear and cold at my 1115 UTC (0315 local) start time, but the big gun Japanese and Koreans on 594, 747, 972, 1134 and 1566 had already reached S9 levels an hour before inside my Grayland Motel Room 11 (\$65 a night, with absolutely no frills). Hurrying to the cold beach I had brought along the 30" loopstick ICF-2010 spotting receiver, a 12" Longwave FSL and the new 17" DXpedition FSL – all of them very large items that could never be accommodated in my Toyota Corolla during previous "family vacations." Despite Grayland's lack of

any ocean cliff and uncertain solar conditions, the fanatical gear was going to be pushed to the limit. The new 17" FSL antenna was set up at the end of Grayland Beach Road near a picnic table (photo above), apparently a spot which the local authorities intended for use starting at 0600 local time (which was only about 3 hours away). Powerful Asian signals were all over the band in total darkness at 1115 UTC, three full hours before sunrise. Temporarily ignoring the Japanese and Korean big guns I went after some second-tier Asians like 603-HLSA, 657-Pyongyang, 1044-CRI and 1323-CRI, all of which pounded in with serious strength. Wild S9 snarls were on 1044 (CRI and KBS) and 1134 (JOQR and KBS), while the multiple 1035-CNR1 stations sounded like an echo chamber. Almost all the usual Asian big guns were at blowtorch levels, including the high band TP's on 1566 and 1575. As the wild session continued a sunrise enhancement boost around 1430 brought up the strength of Chinese middle and high band stations, with 936-Anhui, 981-CNR1, 1377-CNR1 and 1593-CNR1 all getting somewhat of a boost. The Japanese second-tier stations like 954-JOKR also tapped into the boost, while an apparent 603-China finally managed to show up weakly under an S9 HLSA. The CRI stations on the middle and high band were at awesome levels after the sunrise enhancement boost, and quickly took over contested frequencies like 1044. The big gun Japanese and Korean stations were still going strong in bright daylight after 1600, but I was not. My MP3 recorder was maxed out, and four hours in the 41 degree cold and wind had taken its toll. After returning to Room 11 at 1615 I checked 972-HLCA's signal, and it was still pounding in at an S9+ level right up until 1635.

The first morning had featured fairly good reception from Japan, Korea and China on the middle and high band, with 5 of the Chinese CRI stations being received (963, 1017, 1044, 1206 and 1323)—the last three at very good strength. A mix of three TP stations was received on 1044, and quite a few Chinese second-tier stations had shown up. The low band didn't seem to share much in the bonanza, however, with only 603-HLSA and 657-Pyongyang having potent signals besides the Japanese big guns. Overall, the first morning's ocean beach session was just what I had hoped for, though—the perfect transformation for a land-locked DXer seriously bored by mediocre inland TP propagation. I wish that all the other inland TP-DXers could have been along for the wild ride—as well as the inland TA-DXers.

<u>Day Two</u> Murphy's Law made a serious ocean beach comeback on the second morning as heavy rain and wind combined with an Asian propagation drop off. The big gun TP's were still at huge levels, but the nasty weather seemed to scare away anything remotely exotic.

Although the Asian big guns sounded vibrant during their sunset period around 0900 propagation seemed to hit the skids shortly thereafter, with signals greatly reduced by 1200. The weather had also turned nasty during the same period, and my ocean beach setup at 1300 required plastic tie wraps for the FSL antenna base and rain covers for the radios, antenna and MP3 recorder. Despite this serious hassle the second and third tier Asians seemed to have little interest in showing up, and I ended up recording S9+ signals from the likes of 828-JOBB and 1566-HLAZ (which I had ignored the day before, in the DXing bonanza). After a serious search I came across weak NHK2 English lessons on 1593 – pretty routine DX, but just about the best that I could do in the wind, rain and noise. With conditions so awful at 1400 I decided to pack up everything and head back to Room 11 of the Grayland Motel, which at least was warm and dry. Setting up the 17" FSL on its PVC base next to the Room 11 window was a desperate measure, which resulted in a serious reduction of Asian signal strength compared to the beach (and a serious increase in RF noise pollution). Despite this I was able to track down a fair to good signal from 1593-CNR1 (mixing with the NHK2 Chinese lessons at the time), a fairly good 1134 mix of KBS and JOQR (but nothing like the day before), and the NHK2 sign off chimes on 774-JOUB at 1424. From what I could tell during the nasty weather the middle and high band had most of the limited action that morning, with the low band stations like 603-HLSA and 657-Pyongyang very anemic at best. The Japanese and Korean big guns did survive the propagation slowdown quite well, of course, with the usual ocean coast blowtorch signals on 594, 693, 747, 774, 828, 972, 1053, 1566 and 1575. They weren't exactly what I was looking for, though, after dealing with serious rain, wind and the Grayland Motel's little quirks (like no paved driveways, phones or cleaning service). The second morning had turned out to be a clunker, with both dreary propagation and weather making the DXing effort pretty miserable.

<u>Day Three</u> The propagation deep freeze on the Grayland beach let up somewhat on this morning – to be replaced by an arctic deep freeze moving in from Canada. While some moderately interesting DX showed up on frequencies like 846, 864 and 873, the 37 degree ocean beach temperature and 15 mph wind chill was anything but moderate. After the previous day's clunker session I was highly motivated to track down some good DX on this last day of the trip, and made every effort to hit the cold beach very early at 1030 UTC (0330 local time) – a big mistake. The wind chill's punishment increases by the hour, and Asian signals can propagate for a very long time on west coast ocean beaches.

After the solar-challenged session the day before the Asians at least made a halfhearted recovery, although most of the TP signals were nowhere near their first day levels. The Japanese and Korean

big guns were potent as usual on the ocean coast, but the second-tier Asians on 558, 603 and 657 had trouble managing any real energy. Checking the band for any special propagation trend was tricky in the subfreezing wind chill, but it certainly seemed like the middle and high band had the edge over the low band, with the Japanese and Koreans doing better than the Chinese. 864-HLKR was mixing with an apparent Japanese station at 1347 but nailed down the frequency in a big way by 1527, pounding in with good strength. 873-JOGB had an apparent mix with a Chinese station just before the 1300 TOH, and 846 had a mystery station at a fair level around 1353 (which sounded Japanese). The major challenge after two hours on the beach was not tracking down exotic Asian DX, but tracking down some warmth from the car heater (to thaw out stiff fingers and toes). The Asian propagation was nothing to shout about, but a moderate sunrise enhancement boost around 1500 did prolong their pedestrian signals long enough to make me deeply regret having ever shown up to face the bitter wind chill as early as 0330 local time. After four and a half hours my frozen ICF-2010 spotting receiver's frequency readout went on the blink, and my PL-380's battery display showed empty (although the radio had fresh batteries installed, right before the session). The frozen radio breakdowns gave me a convenient excuse to finally retreat from the frigid beach— without feeling guilty about wasting valuable ocean beach DXing time (and the \$65 a night I was paying for the Grayland Motel's luxuriant Room 11).

Summary By the standards of the current lean solar year the weekend's ocean beach Asian propagation had turned out to be a mixed bag— above average on the first morning (the 8th), below average on the second morning and somewhat in between on the third. Dicey weather on the last two days contributed to the challenge of DXing outdoors at the picnic table near the end of Grayland Beach Road, with heavy rain and wind on the second day (the 9th) and a subfreezing wind chill on the third (the 10th). In comparison to Oregon cliff locations like Rockwork and Cape Perpetua the flat ocean beach at Grayland was most noticeable in the increased splatter from domestic stations, which blasted in without any attenuation from solid cliff rock. Overall the weekend DXpedition was an enjoyable experience, though, with the new 17" FSL antenna tracking down some interesting DX despite nasty weather, solar flares and other distractions. Although exotic signals weren't really part of the expectations, proximity to the salt water did provide far more TP-DXing variety and signal strength than watered-down inland propagation. For a DXer who had been bored chasing wispy signals from the big gun TP's at home in Puyallup, Washington, the impromptu weekend of ocean beach DXing was just what the doctor ordered.

The following stations were received on a 7.5" loopstick Tecsun PL380 Ultralight radio inductively coupled to a 17" FSL antenna at the end of Grayland Beach Road in Grayland, WA from November 8-10, 2014. MP3 recording links are given for most of the stations, and the TP stations which pegged the PL-380 S/N display at the 25 maximum at least one time during the MP3 recording are identified with a **bold and underlined** frequency.
