From Radio Insight: Hackers shut down Michigan station.

For the second time in three months a small market radio station has been silenced by a hacker. The latest incident occurred outside Kalamazoo, MI where adult standards WAKV, Otsego, MI (980) had its computers held hostage with the hackers demanding cash.

The so-called ransomware software attacked WAKV on January 9 leaving owner Jim Higgs unable to access any of the audio files on the station's hard drive. He tells the Kalamazoo Gazette that they were demanding \$500 to release the files on his computer. WAKV — which is operated out of Higgs' home — was off the air for more than a day while engineers worked to get around the hackers. All the station's music files, jingles and commercials were wiped clean, as well as some business files. Higgs says it's a good reminder to back-up a computer and avoid suspicious looking websites.

In October a similar incident silenced a Louisiana station. Cybercrime costs businesses \$445 billion worldwide each year, according to a study released last year by the Center for Strategic and International Studies and McAfee.

From RadioWest.ca: Whatcom County upholds radio tower denial (from radiofan)

Whatcom County council has upheld the county examiner's decision to deny BBC Broadcasting's application to erect five transmission towers in Point Roberts. Nancy Beaton, a Tsawwassen resident with the Cross Border Coalition to Stop the Radio Towers, said the decision was unanimous.

BBC Broadcasting Inc. wants to erect the 45-metre (150-foot) steel towers at an undeveloped lot on McKenzie Way in Point Roberts just south of the border. The towers would transmit South Asian radio station KRPI, AM 1550, which broadcasts from studios in Richmond to a Lower Mainland audience. Also known as Sher-E-Punjab AM 1550, the station currently uses antenna in Ferndale, Wash., but wants to relocate them for a stronger signal. The Federal Communications Commission (FCC) granted a construction permit but a zoning permit is required from Whatcom County. Residents on both sides of the border have rallied against the proposal for more than a year.

NEWSJacksonville – 1/19 1736 – Nice local-like signal with "News, weather and traffic 24 hours, 104.5 WOKV" ID into traffic report with Jean Rexler, ad for Volkswagen of Orange and Sean Hannity show. (LW-NY)

KWPM IBOC is also on, but the splatter is more analogic. (GH-OK)

What an ideal call sign: the other half of it, OLIC, would have to be in Czechia. NRC Pattern Book shows in daytime it's NW/SE, and nighttime SW, neither much good for us. (GH-OK)
- 920 KVEL UT Vernal 1/15 0142 Coast to Coast AM is still audible here from the NW, presumably KVEL and still nothing from KYFR IA Family Radio to the northeast, off the air? But by 24 hours later it's back as usual. 1/16 2150 about a talent search during halftime at the Utah Jazz, ads, presumably KVEL again, which really gets out for its 1 kW at night allegedly aimed northeast, at 690 statute miles from Enid to the southeast, further than Chicago. (GH-OK)
- 930 WSEV TN Sevierville 1/20 0658 Fair to poor with light to moderate unID QRM, with a comedy routine by Milton Crabtree, ad for Wahoo Zip Lines, and plenty of info about the Smoky Mountain Welcome Center. This one reminded me of KLFJ 1550 Springfield MO, which I understand is owned by the same company as WSEV and hawks Branson attractions. NEW! Thanks to Richard Lauhead of MN whose posts of recently hearing WSEV got me interested in trying for it. NEW! (BD-WI)
- 950 KRWZ CO Parker 1/26 0722 Poor; Chicago, Detroit nulled. "Crusin' 950" tween oldies. (JJR-WI)
- **960 KMA IA Shenandoah** 1/26 1815 News in Shenandoah area with call ID, over/under KGKL and others. New here. **(JR-OK)**
- **960 KGKL TX San Angelo** 1/26 1810 News and call ID, over/under KMA and others. New here. **(JR-OK)**
- **1010 WSPC** NC Albemarle 1/26 2100 Fair for a bit with no WMOX for once. NC Tar Heels BKB coverage. Only station on net on 1010. New! (NK-IL)
- **1010 KTNZ TX Amarillo** 1/27 0659 Good with "KTNZ" clearly heard at legal ID time amidst ESPN programming. Also heard second set of CLs mentioned, but didn't catch who they were....perhaps KICA? Texas logging #66 here. **(RD-NE)**
- 1140 WRNA NC China Grove 1/16 1845 Poor way under WRVA, with multi station ID at tune-in: "Your home for the best, home of Southern Gospel music, AM 1140 WRNA and AM 1460 WRKB" into a religious talk by Pastor James Pauley. NEW! WRKB's CoL is Kannapolis NC, licensed for full-time operation, while WRNA is a daytimer and was scheduled to leave the air at 1730. (BD-WI)
- **1150 WIMA OH Lima** 1/26 0715 Poor; no WHBY, CKOC. News Radio 1150 WIMA storm info, closings. (JJR-WI)

- **MN Mankato** 1/17 0510 Poor signals fading in and out under KTRF with Fox Sports // their web feed. My closest target finally heard. First new one of 2015! A slow start to 2015 but I finally nabbed this one. KTRF is a bit of a pest here but they do fade out at times leaving the frequency useable. **(SMA-MB)**
- **1230 KHAS NE Hastings** 1/21 0759 Weather forecast and legal ID, followed by CBS news. Fair, just above the competition. **(JW-CO)**
- **PA** Erie 1/24 1659 Fair and in the clear with promo for the 13th annual Erie's Best Wings Chicken Wings Cook-off sponsored by "1260 the Score," LID at 1659 into CBS Sports Radio Sports Flash. NEW! I caught this one at just the right time, 15 minutes before their power-down. (BD-WI)
- **1270 WKBF IL Rock Island** 1/16 1954 Mexican music; legal ID at 2001, followed by more music. Fair with QRM. (**JW-CO**)
- **1340** KGGS KS Garden City 1/12 1900 Fair over others with Big Dog Sports announcement and call ID. (NK-IL)
- **1360 KBKB IA Fort Madison** 1/26 0726 Poor; no WTAQ. "?? Country 1360 KBKB." (JJR-WI)
- **1360 KNIR LA New Iberia** 1/24 2300 Poor but audible in mix with multi station Radio Maria ID // very strong KJMJ. New! **(NK-IL)**
- **1370 KAWL NE York** 1/21 1815 Fade in about 1810 with oldies and call ID. This station sure gets out good with only 500 watts. **(JR-OK)**
- 1370 WXXI NY Rochester 1/26 1700 Poor to fair with light QRM, with a markets report, a four-station LID including FM's and FM HD sub channels, notice of a concert at Roberts Wesleyan College into NPR news at 1701. Signal soon disappeared at scheduled pattern change time. NEW! After all these years I finally heard Scott Fybush's station! (BD-WI)
- 1410 WNER NY Watertown 1/17 1805 Poor with Syracuse Orange men's basketball postgame vs. Clemson (Clemson won 66-53), LID at 1805 including slogan "Fox Sports Radio 1410." NEW! (BD-WI)
- **1410 KNTX TX Bowie** 1/13 0829 Gal with "Exclusive Sky Watch forecast"; time check for 7:30, then "Morning News Break" from Texas News Network. Fair at best in the mix. **(JW-CO)**
- **1440 KRDZ CO Wray** 1/26 1946-1949 Excellent to good with a gradual fade, "We love to play classic hits... ," gardening tips, ads for O'Reilly auto parts, Burger King. New! (**JEL-MO**)
- **1480 WBBP** TN Memphis 1/18 1805 UC gospel music with call ID. Good signal on fade-ups. New here. (JR-OK)
- 1510 KBED TX Nederland 1/20 1955 Same ad as heard underneath 1520 KOKC, then 1510 with CBS Sports Minute, loops NW/SE. Good signal on 1510, and CBS Sports online list displays on 1510 only KBED in Nederland (Beaumont) TX, and KGA Spokane WA, surely the former, although KBED is supposedly a 5 kW directional daytimer despite official January sunset at 1845. Conveniently its pattern is US-ward, NNW/SSE. As for 1520, CBS Sports displays two stations there too, KOLM in Rochester MN, and WHOW in Clinton IL. KOLM is the well-known cheater on 10 kW day power, causing heavy QRM to ailing KOKC now at 1956 and on other dates. (GH-OK)
- **1540 KEDA TX San Antonio** 1/15 2303 On car radio between OKC and Enid on I-35, Tejano music interrupted for ID in English from KEDA San Antonio, which contrary to authorized patterns and power, 5/1 kW U4, continues to dominate the frequency at night, including on this non-directional vertical receiving antenna. **(GH-OK)**
- **1560 KGOW TX Bellaire** 1/16 1550 Yahoo sports talk with Texas and Louisiana ads. New here. **(JR-OK)**
- **1580 KREL CO Colorado Springs** 1/21 1800 Fox sports, news and call ID. Good signal here. (JR-OK) 1/26 0724 Fair; no CKDO. Fox Sports Radio 1580, weather, calls. (JJR-WI)
- **1590 WFTH VA Richmond** 1/24 2300 Fair atop with accented gal giving ID. Gospel format. New! **(NK-IL)**

530 UNID -- 1/19 1535 – On car radio at a quiet location in Enid, very weak fast SAH meaning two stations here. One is likely Kansas Turnpike Authority, perhaps the closest at South Haven, which I think relays NOAA/NWS all or part of the

time, but the other? Could be another KTA transmitter. Or? AFAIK, 'K530AM' at Vance AFB south of Enid is off, although it could be microwatts. Need to drive right up to the Vance gate and find if I can hear any trace of it there. Checked the FCC online lookup, which shows only one 530 in OK: WNWU499, of the Oklahoma Dept of Transportation in OKC, allegedly active, but does not give location, only address of the control point, which is ODOT HQ at 200 NE 21 St.! I should have sought it during latest visit to OKC, as K530AM used to reach almost to the NW edge of OKC. But then, FCC never listed 'K530AM', as it was a USAF pirate, outside its jurisdiction. 1/20 1440 – No Vance any more, but trace of a weak talker, probably Kansas Turnpike Authority HAR. (Glenn Hauser, from a full MW bandscan on car radio at the parking lot of the Visitors Center, Vance AFB, south of Enid. (GH-OK)

1/20 1443 – SAH of 480/minute = 8 Hz between two very weak stations. One must be nearest groundwave, KFJZ Fort Worth, probably in Vietnamese, but the other? There are three other possibilities, so which one is 8 Hz from KFJZ? No place to look that up easily. I have noted this situation previously. WWL New Orleans would be the obvious first choice, some 600 miles by groundwave over middlin' ground conductivity. 50 kW with a pattern pushing more of it north avoiding the Gulf waters. Somewhere in east TX someone could confirm whether WWL is the one 8 Hz from KFJZ. KPRM Park Rapids MN, 40 kW ND in daytime (CP for 50, yet?) is a bit further, but has the northerly advantage in case winter skywave is involved a month after Solstice. KAAN Bethany MO is only 930 watts but closest, over 300 miles beyond Kansas City. (GH-OK)

1240+ UNID -- 1/15 2307 – On car radio between OKC and Enid, I can still hear the weak het from some off-frequency station originally estimated at 1240.13, and DFed to WNW/ESE. **(GH-OK)**

- 549 **ALGERIA** *Jil FM*, Les Trembles DEC 28 0300 Man in Arabic, synthesized dance music. [Connelly-MA]
- 783 **MAURITANIA** *R.Mauritanie*, Nouakchott DEC 31 0200 Arabic man preaching, crowd noise; by far the strongest TA at the time. [Connelly-MA]
- 1530 **SAO TOME E PRINCIPE** *VOA* Pinheira DEC 28 0300 Yankee Doodle sign-on music, man with VOA news in English; mixed with WCKY. [Connelly-MA]

- CUBA *R.Enciclopedia*, La Habana-Villa María DEC 31 0159 Woman with *R.Enciclopedia* ID with reverb, "Touch the Wind" song from Disney's "Pocahontas."  - 590 **CUBA** *R.Musical Nacional*, La Julia NOV 11 0348 Strong most times with a hint of rock interference from (probably) WAFC. Program of classical piano music in brief periods of mostly Rebelde interference but with an easy 5-6 second delayed web parallel. Good music! DEC 3 0318 Alone and good. [Funkenhauser- FL] DEC 31 0200 Music from "The Nutcracker"; under WEZE. [Connelly-MA]
 - 600 **CUBA** *R.Rebelde*, San Germán-Urbano Noris JAN 15 0201 Rebelde ID; dominant. [Connelly-MA]
 - NICARAGUA YNA3MD *Radio Ya*, Managua DEC 23 0408 Surprising with a strong Rebelde here. First noted mentions of Nicaragua in talk with novelty music bridges, also mentions of 'Mister Pacifico' then at 0415 'deportivas de Nicargua' with punctuated 'Radio

- Ya' spots. JAN 17 0241 Best signal from east/west in full null of Okie SSE, rapid national Mexican news in Spanish referring to Iguala, CNDH, whales, with stingers; 0243 music bit, swishes, 0245 interview about violence toward women. No doubt it's XEJUA, listed by IRCA as Milenio TV audio simulcast, 5 kW daytimer. Cantú agrees on daytime, nombre as BM Radio, which is a major group in the state. So when do they sign off? WRTH shows power as 5 without a d, implying it is really full-time. During this, hardly any KFI to be heard underneath. [Hauser-OK]

- MEXICO XEVG *R.Fórmula*, Mérida, Yuc. NOV 24 0450 Male and female alternating with international and local news, then temperatures and a solid "Radio Fórmula! Primera Cadena! Mérida!" ID. [Funkenhauser-FL]
- **CUBA** *R.Progreso*, Jovellanos DEC 27 0203 Parallel 640 with instrumental disco version of John Paul Young's "Love is in the Air"; slightly under WFAN. [Connelly-MA]
- MEXICO XEACB Cd. Delicias, Chih. Shillong transmitter sunset and Nashua receiver sunrise line up almost too nicely. Also, South Korea is listed at 839.999 kHz, and no other South Korea signals such as 972 and 1566 were observed. I have high confidence in the accuracy of the 864.000 kHz measurement. [Conti-NH]

INTERNATIONAL NEWS

MEXICO: Here is important news about the migration of AM stations to FM in Mexico, maybe explaining the abrupt disappearance of some MW stations (like XEJ 970?). Summarizing: AM stations of under 1 kW must continue on FM only; AM stations of more than 5 kW have the option of moving only to FM or continuing on both. (This does not make sense. And what about stations at exactly 1 or 5 kW?) The previous cutoff was 10 kW. Stations in Hidalgo del Parrral, Chihuahua which do not meet the power requirements will have to close down AM on January 15. 25 kW mentioned is the typical power (ERP?) of new FM replacement transmitters. This story mixes in with the television digital transition which ought to be an entirely separate matter.

Añadió que ahora con el apagón analógico la transmisión en Amplitud Modulada o AM como se le conoce también se verá afectada por lo que los concesionarios de la radio deberán hacerlo únicamente por FM, recordando el caso de la estación XEAT pionera de la radio en Parral la cual a partir del primer día de este año únicamente trasmite en FM. De igual forma señaló también el apagón se dará la televisión analógica e iniciara la transición en la Televisión Digital Terrestre TDT, de manera simultánea en Parral y prácticamente todo el territorio Chihuahuense. De esta manera aclaró que el apagón no solo afectara la trasmisión de televisión sino también las estaciones de radio que tengan cobertura menor a los mil watts, toda vez que las que tiene más de 5 mil watts podrán continuar, aunque es opcional para el concesionario, puntualizo.

"Piso parejo para todos, antes había más de 10 mil watts, ahora 25 mil parejo para todos y con ello traer mejor calidad de radio sobre todo para una competencia en general."

Insistió que en el caso de Parral, la radio que no pueda continuar sus trasmisiones en amplitud modula tendrá que salir del aire apagando su transmisor a partir de este jueves 15 de enero. Cabe destacar que para el 31 de diciembre de 2015, el resto del país deberá de culminar la transición de la señal analógica a la Televisión Digital Terrestre, luego de que el ex presidente Felipe Calderón propusiera el cambio, pues la fecha para la finalización de la señal análoga estaba contemplada para el año 2021. El apagón analógico refiere a la finalización de las emisiones analógicas de señal de televisión y su sustitución por una emisión digital. Esto implica que al concluir el proceso, los televisores deberán disponer de un sintonizador digital o en su defecto de un sintonizador, que procesará la señal digital y la enviará al televisor mediante un cable para poder ver los canales de televisión. Este cambio es provocado por la creación de nuevos televisores por parte de las nuevas tecnologías, televisores que funcionan a través de la Televisión Digital Terrestre (TDT), que ofrece mayor calidad, nitidez e interacción para disfrutar de la televisión y también de la radio. Solar activity is expected to be at low to moderate levels through 09 February with the return of Regons 2255 and 2257 on 27 January. Low levels of activity are anticipated from 10-17 February before increasing to low to moderate levels with the return of Region 2268 on 18 February.


There is a slight chance the greater than 10 MeV proton flux at geosynchronous orbit will exceed the 10 pfu threshold through 09 February and after 18 February.

The greater than 2 MeV electron flux at geosynchronous orbit is expected to reach moderate to high levels on 31 January-03 February, and again on 08-10 February due to recurrent coronal hole high speed stream (CH HSS) influence.

Geomagnetic field activity is expected to begin at quiet to unsettled levels. Active periods, with a slight chance for minor storm levels, particularly at high latitudes are expected on 29 January-02 February, 06-09 February, and again from 15-21 February in response to recurrent coronal hole high speed solar wind streams.


