Just when I was thinking of writing something about how few call letter changes there seem to be on AM lately compared to former years, the FCC lets loose:

1110 WWBJ PA Martinsburg – Call change to WJSM; back to legacy calls dropped in 2009.

1120 KEOR OK Catoosa – Call change to KETU (changed in database Feb. 2015 where it says the effective date was Nov. 21, 2012).

1130 KQRR OR Mount Angel – Call change to KXET (Feb. 12).

1150 KXET OR Portland – Call change to KGDD (Feb. 4).

1400 KKZZ CA Santa Paula – Call change to KUNX (Feb. 2).

1520 KUNX CA Port Hueneme – Call change to KKZZ (Feb. 2; station is silent).

KGDD OR Oregon City – Call change to KXET (Feb. 4) and to KQRR (Feb. 12).

1530 KCMN CO Colorado Springs – Call change to KKHI (Feb. 5).

1550 WMSK KY Morganfield – Call change to WUCO (Feb. 12).

NEW STATION WATCH

1240 KEWE HI Kahului – CP for new station, U1 5000/5000, 1240AM is on the air (has been on with temporary authority for some months).

STATIONS GOING DARK (OR NOT)

970 WERH AL Hamilton – License cancelled per FCC letter to station dated Feb. 12; as we noted last issue, this was expected as station recently admitted to the FCC that it has been silent since Nov. 8, 2012, i.e., more than one year.

1480 WCHZ GA Augusta – License cancelled Feb. 5, no explanation on FCC web site.

1550 WZRK WI Lake Geneva – Station's lawyers filed a letter asking for the license to be cancelled Jan. 15, and (as noted last issue) station was deleted from CDBS in late Jan. However, on Feb. 9 the FCC without explanation added the station back to CDBS as an active (i.e., non-silent) licensed station.

1570 KBRI AR Brinkley – Silent since Oct. 8, 2013 (i.e., more than a year), and notified FCC Feb. 2 it does not intend to return to the air in any case, so license is cancelled.



Loggings of U.S./Canadian stations heard by DXers in the Central, Mountain, and Pacific time zones

REPORTERS

BD-WI Bill Dvorak, Madison, WI. Drake R8B, 140-foot Double Kaz antenna bearing 280 or 100 degrees.

ES-CA Edmund Smith, Various locations in CA. Toyota car radio.

GH-OK Glenn Hauser, Enid, OK. Mostly DX-398 with internal antenna only; or Sony SRF-59 as specified; Nissan stock car radio as specified; FRG-7 as specified. Glenn's complete reports, with extensive commentary, are originally published in *DX Listening Digest*.

JR-OK John Reed, Shawnee, OK. NRD-525 with Pühler Electronics 70.455 roofing filter, Eska post IF filter board, quiet display power supply and numerous other mods; Two homebrew tuned ferrite loops, Clifton Labs active whip, phase

JW-CO John Wilkins, Wheat Ridge, CO. Drake R-8, 4-foot box loop.

RD-NE Rick Dau, South Omaha, NE. Kenwood R-5000 + Quantum QX Pro loop // 945 heard overall.

DX Logs

570 WNAX SD Yankton – 1/30 1416 – WNAX ID and Accuweather for Yankton SD, clearly audible under KLIF Dallas. WNAX is always there on GW, but skywave may be helping a bit now. SAH counted as 212 per minute or 3.53 Hz. **(GH-OK)**

640 KWPN OK Moore – 2/2 1853 – ESPN programming to legal ID at 1859, mentioning 2 or 3 stations but largely unreadable; a few ads were followed by Oklahoma Thunder pre-game show ("Inside the Paint"). Fair with not much QRM, other than local noise. Signal disappeared at 1914 power cut. A long-needed call change, ex-WWLS. (JW-CO)

670 WSCR IL Chicago – 1/30 1415 – CCI between sports talk and another station. Sports must be WSCR Chicago, but as also on rare groundwave it's considerably weaker than WGN. Other station is KLTT Denver which normally reaches here barely on GW. 1/31 1302 – Woman singing the Star Spangled Banner, no doubt inaugurating a silly ballgame on WSCR. (On car radio at powerless kite field in Enid. (GH-OK)

690 WOKV FL Jacksonville – 1/25 0102 – As KGGF is wrapping up with Taps, I start seeking WOKV, which Bob Smoak, Bamberg SC had first reported on listserves earlier in the evening. Ad in news which at 0105 outros as Fox, 0105 weather but can't catch any local refs (seemingly from a TV station meteorologist), 0106 into C2CAM theme. During C2C break at 0130, PSA for something in "Jacksonville," so that's it! and Fox news headlines. (GH-OK)

OH Cincinnati – 1/31 1306 – Sports discussion involving Seton Hall and Xavier, way over KHSE The Metroplex; apparently originates from NJ. There are several Xaviers, but WLW schedule for today confirms it's them at 11:30-2:30 EST. Cincinnati-Enid city to city distance is 1213 km = 754 miles. Car radio at powerless kite field in Enid OK. 1/31 1419 – Station in English almost zero-beat with KHSE TX groundwave; 1420 clear ID for WLW, Cincinnati. Unlike WGN, the 700 station suffers from ACI splash de 690 KGGF if not 710 KCMO or KGNC. 2/5 1424 – Spanish from the Metroplex, but under it is a station in English, surely WLW Cincinnati, Scanned the entire band, but nothing much unusual in the 1500s or 1600s. (GH-OK)

720 WGN IL Chicago – 1/30 1413 – Good & steady signal from WGN Chicago, almost 700 miles. Under very quiet conditions even in the summer I can sometimes pull it by groundwave, but this is much stronger. Talk host is discussing wings and football games, mentions Órion Samuelson in passing. (WBBM 780 and WLS 890 are blocked by Okies.). (GH-OK) Editor's note: This log is part of an interesting set of midday skywave receptions. See DX Listening Digest #15-05 for a detailed chronicle of Glenn's logs.

- **760 KMTL AR Sherwood** 1/27 0841 Nulling KCCV Overland Park KS and thus getting rid of fast SAH, the other station is playing praise music, 0844 segué, 0848 country gospel; 0850 weather for somewhere in Arkansas, 41 degrees; therefore: KMTL. Not a trace of Denver yet. **(GH-OK)**
- **810 KXOI TX Crane** 2/1 0838 Rosary in responsive Spanish, roughly east/west. Listed *in NRC AM Log* as "Radio Alabanza" and that's exactly what they are doing. 0842 losing to music from the NW/SE, presumably KLVZ Brighton (Denver) CO, but still separable for a few minutes. Not a hint of WHB Kansas City yet. **(GH-OK)**
- 830 WGUE TN Memphis 1/27 0838 Just after sunrise here, non-ID twice as "99-3 Jazz[???] FM," music style classic rock, loops E/W. NRC AM Log has the answer: WGUE, W257CY "99.3 Guess FM" and it's in AM \$tereo. WTFDA FM database agrees on the //, i.e. translator tail wagging this dog of an AM, but as a K-Love, apparently no longer that. (GH-OK)
- 950 KRWZ CO Parker 2/6 0945 Colorado ads, oldies music, mixing with SS music station then faded out soon after. New here. (JR-OK)
- 950 KTNF MN Saint Louis Park 2/10 1859 Fair to good with light unID QRM, with a talk program just ending, ads, LID imbedded within a promo for the Jack Rice program Sundays 4-6 PM, slogan "Progressive Voice of Minnesota." This was followed by an unID TOH national newscast, probably from new WW1 news service. Needed call change, first logged as KSGC in 2000. Since then station has had the calls KDOW (2001), KCCO (2001), KSNB (2004) and the current KTNF (2004). Needless to say, it does not make it to this QTH often. (BD-WI)
- 960 KLTF MN Little Falls 2/6 0752 Local ads, call letter ID, program note for an upcoming bluegrass program. Fair/poor in QRM. (JW-CO)
- **1050 KJBN AR Little Rock** 2/2 1800 News, sports and call ID. Heard well during a brief fade in. New here. (JR-OK)
- **1050 KLOH MN Pipestone** 1/27 1745 C&W with Pipestone sports announcements, Minnesota lottery ad. (JR-OK)
- **1080 WRYT** IL Edwardsville 1/27 1800 Religious talk, Catholic Radio Network and call ID. Station must have reduced power at 1800 and signal was lost. New here. (JR-OK)
- **1130 KQNA AZ Prescott Valley** 2/5 1934 Ads; ID as "The Talk of the Quad Cities KQNA." Fair/poor signal. (JW-CO)
- **1130 KRDU CA Dinuba** 2/10 0900 Ad for Palm Village; water conservation PSA; legal ID at 0901:45: "KRDU Dinuba-Fresno-Visalia, your Inspiration Station" and into *Revive Our Hearts* program. Fair signal. **(JW-CO)**
- 1130 KWKH LA Shreveport 2/5 1840 Pre-game show, LSU vs. Auburn basketball. Fair. (JW-CO)
- **MN Minneapolis** 2/6 0700 ID, spoken very fast: "From the ..??...Warehouse.com studios, KTLK AM Talk 1130, 103.5 and 100.3...??..." and into Fox news. Fair. Last heard as KFAN here (never heard KTCN). **(JW-CO)**
- 1130 KBMR ND Bismarck 2/5 0956 C&W music; legal ID at ToH: "For over 50 years, North Dakota's country legends KBMR Bismarck-Mandan," and into ABC news; local news followed at 1005. Fair. (JW-CO)
- 1130 WISN WI Milwaukee 2/12 0759 One or two ads, then legal ID at 0800:30: "...stay informed all day, every day on News Talk 1130 WISN Milwaukee" and into "The 7:00 Report" (news/wakeup fare). Fair signal and alone on the frequency ... for a minute or two. (JW-CO)
- **1230 KWTX TX Waco** 2/5 2259 Fair but readable with "...KWTX...Waco...an iHeart radio station" heard in legal ID. Logged this on the 23rd anniversary of the last time that I heard it, which was from Iowa City, and a GYDX distance record (for this station) at that time. **(RD-NE)**
- **1240 KLOA CA Ridgecrest** 2/7 1700 "All new sports leader KLOA AM." Logged in Ridgecrest, CA. **(ES-CA)**

- **1330 KCKM TX Monahans** 1/30 1800 C&W music with call ID and "West Texas Powerhouse" ID, in loop null of KNSS (Wichita). **(JR-OK)**
- **1360 KFIV CA Modesto** 2/4 0959 ToH ID: "KFIV Modesto, KWSX Stockton, Power Talk 1360 and 1280." Rough copy, with QRM from KHNC, KDJW, and others. (**JW-CO**)
- **1360 KWDJ CA Ridgecrest** 2/7 1600 "Cool Gold 1360 KDWJ Ridgecrest" followed by 60's music. Logged in Ridgecrest, CA. **(ES-CA)**
- **1360 KKMO WA Tacoma** 2/4 1002 Gal talking in English with a mention of "Tacoma" and two mentions of "western Washington." Fair signal underneath the QRM seemed too good to be a 5 kW station from that distance, but anything is possible. Furthermore, KKMO is listed as Spanish. **(JW-CO)**
- **1420 KBTN MO Neosho** 1/28 0844 Tune-in, ID in passing for KBTN, C&W music, fading, along with slow SAH and hum. Neosho MO is not that far away in the SW corner; logged once before, May 26, 2012 at 0744 ELT. **(GH-OK)**
- **MO St. Charles** 2/2 0915. Catholic Radio Network religious talk. Difficult reception since KGFF, 1450 KHz, is ½ mile from my house and I can see the antenna from my yard. My modified NRD-525 gave the best reception among several other high performance receivers, among them AR7030, Racal RA6793A and RA6772E and NRD-545. Some of these high performance receivers are not loop friendly since they generate lots of noise, as I'm sure SDR receivers with a computer also would. The loops are by far the best antennas. **(JR-OK)**
- 1470 KWSL IA Sioux City 2/5 2202 Good signal strength, aggravating splatter from local WLMV 1480 (but no sign of usually dominant WMBD), with SS:MEX and LID including slogan "La Preciosa 1470." NEW and a real pleasant surprise! (BD-WI)
- **1470 KYYW TX Abilene** 2/5 1856 Good and alone on the channel with "Join us on Twitter ... 1470 KYYW" heard in liner. **(RD-NE)**
- **1480 KCZZ KS Mission** 1/29 0844 Spanish ad for AutoLite in dólares, another for Goodwill, so obviously a US station, CCI from KQAM Wichita in English about 4 Hz away. Probably the closest one, KCZZ Mission KS (Kansas City), 1000/500 watts U4, a Radio Luz, i.e. religious. Close to same direction as Wichita but somewhat separable. **(GH-OK)**
- **1510 KBED TX Nederland** 1/23 2254 I'm after a definite ID from the CBS Sports station I have heard a couple of times, presumed to be this. Not a word of Dutch, but 2256 ad or PSA for some "Southeast Texas Coalition," so that's it. **(GH-OK)**
- KOLM MN Rochester 1/22 2326 Good signal with sports talk; at first strong enough to be taken as KOKC but not their format. DFing confirms KOKC is OFF again! Allowing thru unimpeded 10 kW day at night cheater KOLM Rochester MN. At 2331, like previous log, the sports talk is // 1510, i.e. both CBS Sports Radio (but not // 670 WSCR). 1510 (presumed another cheater, KBED, as previously) is about one word ahead of 1520. 1/23 2254 Local sports talk, post-game show? Not // 1510 with CBS Sports. KOKC OKC is OFF again!! So this is obviously the cheatin' Minnesotan again with the frequency all to itself. 2358 PSA for Rosacea; 2359 PSA for adopting cats, and "powered by CBS Sports Radio, Sports Radio 15-20, The Ticket," weather by YL, and finally legal ID as "KOLM-AM Rochester." (Note: it's not legal; there is no -AM suffix!), and joins CBS Sports Radio for news now // a word apart from 1510 KBED. News on hour from CBSSR is all about sports too; can't be bothered with the real world which CBS otherwise covers competently. (GH-OK)
- **1520 KOKC OK Oklahoma City** 1/22 2326 Maybe these nighttime absences mean they are really working on getting back up to 50 kW on proper westward night pattern, instead of 12.5 kW ND STA. Instead, KOLM MN cheater is in the clear, as above; and once again in its null some weak Mexican music is audible, which I would dearly like to ID before KOKC is back in whack. KOKC is certainly back on at 1240 check. **(GH-OK)**
- 1520 KYND TX Cypress 1/29 0841 KOKC is on, but with tough CCI in English mentioning Hong Kong, "program from G&E Studios." It's KYND, almost the same angle as OKC from here, making usual slow SAH just after sunrise. Same programming is on 1540 KGBC Galveston, but not audible now with KXEL dominant on day pattern. They also run KXYZ 1320 in Houston, but in

- Chinese language; I wonder how much if any of that is locally originated. **(GH-OK)**
- 1530 KVDW AR England 1/29 0154 Listing gospel musical or worship events in Little Rock and several other Arkansas cities, losing out to CCI in Spanish, with medium SAH. Supposed to be a daytimer! KVDW, England AR, 2500 watts D1, UC:GOS/REL format, // 100.9 translator as "Victory 1530." (GH-OK)
- **1550 KDCC KS Dodge City** 1/16 2259 Fair with light unID QRM, with promo for the Dan Patrick Show, LID including slogan "Sports Hound Radio 1550 AM," into Fox news at TOH. NEW! Station is 1 kw days, 90 watts nights. **(BD-WI)**
- **MN Blue Earth** 2/7 1910 Detailed weather for the area; sign-off announcement by Kevin Benson (station manager) at 1913, with an invite to listen to 98.1 FM. Listed as sunrise-sunset, so they were about 35 minutes late. Fair signal. (**JW-CO**)
- **OK Del City** 2/2 0900 Legal ID: "KEBC Del City, your home for NBC Sports Radio 1560 AM The Franchise" and into NBC Sports Radio Update; soon faded. A needed call change here, ex-KOCY. **(JW-CO)**
- 1570 KBCV MO Hollister 2/5 0158 Prayer leading up to legal ID at 0159: "KBCV AM 1570 Hollister, Branson, and Neosa(?), a service of Bott Radio Network"; this was followed by a network ID listing all of the 25 or so affiliates; into program "Running to Win" program at 0200. Fair peaks with XERF nulled and semilocal KPIO silent. (JW-CO)
- **1590 KVTA CA Ventura** 2/6 1900 Lakers Basketball but no ID. Definite KVTA ID at 0005 followed by news talk. Logged in Upland, CA. **(ES-CA)**
- **1590 WNTS IN Beech Grove** 2/7 1735-1737 Fair to good under KVGB with stopset of 4 ads in Spanish, all of which mentioned Indianapolis, and one of which was for a local florist. Had been after this one for a while. **(RD-NE)**
- **1590 WPVL WI Platteville** 2/6 1759 Fair under WAIK with "...AM 1590, WPVL, Platteville" heard in legal ID. 50th logging from Wisconsin at this QTH. **(RD-NE)**
- **1650 KYHN AR Fort Smith** 1/27 2000 CBS News from KYHN, but checking 1120 KMOX, not //, 2004 KMOX already back to local while KYHN has another minute of national news. **(GH-OK)**
- **1660 KWOD KS Kansas City** 2/5 1847 Business talk; legal ID at 1852: "You're listening to the KMBZ Business Channel AM 1660 KWOD Kansas City," then more talk; soon faded. Ex-KUDL. **(JW-CO)**
- **1690 WVON IL Berwyn** 1/27 0105 "Talk of Chicago, WVON" ID, and program opening including WVON in Morse code, once, then soul music theme. Also accompanied by IBOC noise, audible vs 1680 weak KRJO, not so much vs 1700 stronger pileup. **(GH-OK)**

UNID

- 760 UnID -- 1/30 1417 KCCV's religion has unID CCI. Could it be 50 kW non-directional WJR Detroit? 50 kW KKZN Thornton (Denver) is half as far, but day pattern westward, null eastward, and rare here at any time. During midday skywave DX opening definitely from as far as Chicago, Louisville, Cincinnati. Again 1/31 1307. (GH-OK)
- 960 UnID -- 1/30 2030 As local KGWA is covering a silly ballgame, I find I can null it very precisely with the DX-398 flat on an easel, to hear a musical station also making a fast SAH. Slow romantic song by YL in English, maybe Celine Dion but not her titanic hit; 2032 & 2037 segúes, classic rock, all at slow pace. KGWA SBG includes long pauses which help; must not be much of a crowd at the game. I hope for an ID at 2100 from the under station, but it's XEK in Spanish; immediately followed by a PSA for veterans by American Legion in English: hard to believe it was from the same station, although possibly XEK was playing tunes in English like some Mexicans do. (GH-OK)
- 1/30 1419 KTOK is strong as usual, but I can hear something under it, unusual. Since Chicago is in on 670 & 720, I suspect WMVP, which has a lopsided day pattern favoring east, but considerable west too. There's nothing on 1000 between here and Chicago. Sioux Falls beams NW away from us. 1/31 1309 Same, weak. (GH-OK)
- 1/31 1420 Rush. NRC AM Log shows him on three 50 kW ND stations: WTAM Cleveland OH, KNZZ Grand Junction CO, and WZFG Dilworth MN (Fargo). My first choice would be WTAM, city to city 1509 km or 938 miles. All

three stations' websites confirm Rush still on live, the other two with superpatriotic hype branding. **(GH-OK)**

1250 UnID -- 1/31 1427 – English talk show, soon fading vs Spanish music, the latter surely KYYS. Too many possibilities. (GH-OK)

1680 UnID -- 2/4 1025 – Weak talk station is making fast SAH with KRJO Monroe LA in music. The unID loops further north, or counterclockwise. Likely either WOKB in FL or WPRR in MI, although I have pulled KGED before. (GH-OK)

1370 WFEA NH Manchester – Flipped from automated adult standards format to syndicated talk, including Dennis Miller and Howie Carr. Current slogan is "Talk Radio 1370, WFEA." So Manchester now has two talk stations, "News talk 610 – WGIR," and WFEA. (TF-NH)

UNID

-- 2/8 0450 – presumed a domestic station with Spanish ballads and reggae, looping seemingly N/NNE, quickly lost in all the co-channel. - **1630 WPAN997 NY Buffalo** 2/13 0000 Repeating ID as "WPAN997 and ...broadcasting on 1630 AM Buffalo," also mentioning traffic or accident on Ontario Street. Very poor under KCJJ. **(PS-ON)**
- **PA** Pennsylvania Turnpike 2/6 2315 seems to be about a two-minute loop with mentions of 814 area code, PA Turnpike and PSAs to "drive responsibly." Peaking in and out with UNID station believed to be in Illinois. (HF-MI1)

- NL Grand Falls-Windsor 1/31 1909 The two hour rock music program "Vinyl Tap" hosted by Randy Bachman was the focus to find a way for something to break thru the noise floor and log CBT. Adele's "Rolling in the Deep" had the energy to do just that and establish the internet delay time of 10 seconds. Both the radio and CBT's internet stream were recorded to verify the radio. Two more positive events occured during the first hour. Nothing from the second hour except CBK fading in with a song from the first hour of "Vinyl Tap" starting the program one hour after CBT. Looking at the WLFJ website, today it was "Science, Scripture & Salvation" listed to 0745, then the Radio Bible Hour with Dr. Harold Smith. Signal lost by 0750. D1 50 kW. (TLK-FL)
- **690 WOKV** FL **Jacksonville** 1/25 0559 Good; "WOKV-FM Atlantic Beach, WOKV Jacksonville, listen live everywhere you go with the new 104-5 app, 104-5 WOKV," and United Way PSA. (**BC-NH**)
- **820 WBAP TX Fort Worth** 2/8 0713 Local weather, mid-Texas city temperatures, into talk show. Mixing with CHAM and others. **(HF-MI1)**
- 910 WAEI ME Bangor 1/26 2135 Rock music, "104 FM" slogan then "Another 30 minutes of hits from the 60's, 70's and 80's on Big 104 FM," followed by more rock music, atop frequency. Big 104 FM is WBAK-104.7 in Belfast and WBKA-107.7 in Bar Harbor. (TF-NH)
- **920 WHJJ RI Providence** 2/6 1725 Over usual CKNX groundwave with PSA for giving blood, "Providence's news, traffic and weather, News Radio 920" slogan. QSLed as WJAR circa 1976. **(MKB-ON)**
- 930 WEOL OH Elyria 1/30 1701 Warriors v. unknown opponent (*probably Cleveland Cavaliers*. *Mike*) basketball game call, WEOL and WEOL.com IDs. One in the mix, WBEN Buffalo NY also there. (HF-MI) [The NBA Warriors played in Utah that night; maybe a high school game? WEOL carries a lot of them. DY]
- 970 WRCS NC Ahoskie 2/7 0500 Over/under WNYM; Black gospel music, "...AM 970 WRCS." New log. (BC-NH)
 - **WBGG PA** Pittsburgh 1/25 0100 Over/under WKCI and others; "This is 970 ESPN, Pittsburgh's home...WBGG AM..." and FM ID. (BC-NH)
- 990 WNML TN Knoxville 2/3 2020 CBS Sports audio, big Radio Progreso co-channel. Knoxville store ads at 2032, back into net with CBSSports.com promo. Progreso crushing them by now. (TLK-FL)

- **MA Boston** 1/25 1728 In with mention of upcoming blizzard Juno in New England area. Brief segment on Pirate radio phenomenon in the UK: "16% of radio listeners are hooked on Pirate radio in the UK!" **(LW-NY)**
- **1040 WHO IA Des Moines** 1/30 0635 Way atop the frequency with detailed weather for Iowa, "News Radio 1040 WHO" ID, female announcer. No sign of WCHR or usual CJMS. **(TF-NH)**
- **1060 WILB OH Canton** 2/13 1735 Fighting KYW and CHUM-1050 slop with EWTN Catholic programs, "Living Bread Radio" slogan, ad for Ave Maria Mutual

- Funds (investing in pro-life stocks), local ads mentioning 330 area code. (MKB-ON)
- **1070** WTWK NY Plattsburgh 1/31 1905 End of Bloomberg Radio News, with Jennifer Logan. "Bloomberg Radio 1070" slogan. Last heard when they were WKDR. (LW-NY)
 - +++ 1/26 2155 Business talk, discussion of new home sales, Bloomberg News at 2200 with Charlie Rose reporting, into more business talk. Daytime only, presumably on for emergency reasons because of threatened blizzard. (TF-NH)
 - WFLI TN Lookout Mountain 1/31 1739 Good; promo, "...on AM 1070 WFLI," and gospel country music. (BC-NH)
 - CHOK ON Sarnia 1/31 1900 "Your station for sports, CHOK" ID. Mention of NASCAR Today program on CHOK into Super Bowl talk show. Weak-fair, under WTWK. (LW-NY)
- **1080 WKJK KY Louisville** 2/2 0100 Under WTIC; "Talk Radio 1080 WKJK Louisville, available anywhere you go on the iHeart radio app, download it now," and CBS news. **(BC-NH)**
- **1100 WHLI NY Hempstead** 1/26 2207 Daytime station on at night because of blizzard emergency, equal strength with WTAM. Noted with usual (non-emergency) programming, i.e. "Long Island's Hits of a Lifetime," Lloyd Price record "Personality" and other oldies. **(TF-NH)**
- **1110 WJML MI Petoskey** 1/30 1658 Very weak signal with non-ID for AM 1110 and 1210 (WJML simulcasts with WJNL-1210), commercial for credit card debt reduction, CBS News. Soon lost to WBT; the usual stations on 1110 were missing. **(TF-NH)**
 - WCCM NH Salem 2/7 1800 Over usual WBT with "WCCM 1110 AM and 102.9 FM, Eagle Radio" ID into Fox news. Given the patriotic slogan and Fox affiliation, I presume format is right-wing talk. (MKB-ON)
 - WKQA VA Norfolk 1/31 1655 Weak signal with preaching, ToH ID at 1700: "This is Freedom 1110, WKQA Norfolk, serving Eastern Virginia and North Carolina with 50,000 watts of power and world wide at WKQA.com," and into another preacher's time block. (TF-NH)
 - +++ 1/30 1700 In WBT mix with ToH ID: "This is 'Freedom 11-10' WKQA Norfolk. Serving eastern Virginia and North Carolina with 50 thousand watts of power and worldwide at..." (KK-VA)

I can't find any phone number on the site except for boilerplate at the bottom, sales office of Grupo Radio México, "Ventas Juárez (656) 6131314" so at least that area code looks close. The other Chihuahuan on 970, XESW Cd. Madera, per its website has a 614 prefix. By the way, my local 960 KGWA splatters very little upon adjacents day or night, unlike 1390 KCRC. [Hauser-OK]

NOAA Space Weather Outlook

Issued February 9, 2015 – For the period February 9-March 7, 2015 Now at http://www.swpc.noaa.gov/products/weekly-highlights-and-27-day-forecast

Solar activity is expected to be at predominately low to moderate levels throughout the period with only low levels of solar activity expected for 14-15 Feb. Low to moderate solar activity is expected for the remainder of the period as Region 2280 (S07, L=283) continues its transit of the visible disk and as Region 2268 (S11, L=048) and Region 2277 (N08, L=330) return on 16 Feb and 22 Feb, respectively. Regions 2268 and 2277 were previously credited with R1 (Minor) radio blackout event production during their previous appearance to the visible disk.

No proton events are expected at geosynchronous orbit.

The greater than 2 MeV electron flux at geosynchronous orbit is expected to reach moderate levels on 09-11, 17, 19-21, and 25 Feb as well as 01 and 05-07 Mar with high levels anticipated on 02-04 Mar in response to coronal hole high speed stream (CH HSS) influence.

Geomagnetic field activity is expected to be at predominately quiet to unsettled levels throughout the outlook period with periods of active conditions expected on 15, 17, 22-23 Feb and 02 Mar with isolated periods of G1 (Minor) geomagnetic storm conditions likely on 28 Feb and 01 Mar, all due to recurrent CH HSS effects.

It allowed the user to set a "Home" position and then set a city in the area of the continent that the DX'er was interested in hearing. Pushing the "Calculate" button returned a look at the propagation conditions that existed between the two points for the given frequency. The app. now seems to have become obsolete with the advent of recent changes at NOAA, from where the app. pulled its info and made its calculations. Is anyone aware of a website where one can enter the Solar Flux values, the A-Index numbers, and the Boulder K Index numbers, the Home and the desired DX location, and then press a button to find out how the numbers will affect propagation conditions for BCBDX? Especially something that is user-configurable, with "Home" and a DX area being user specifiable? I'm looking for a replacement for DX ToolBox. CBQM and many other NWT-repeaters have been heard in Finland during DX'peditions to Lemmenjoki and Aihkiniemi. 40 Watt-stations like 540 CBAK Aklavik, 990 CBDW Norman Wells, 1150 CBAC Tuktoyaktuk, 1280 CBQG Wrigley etc. have been logged from time to time during exceptional conditions. Personally I managed to hear a NWT-station on 690 relaying CHAK-860 but it was impossible to say whether it was CBQM or CBDO from Fort Simpson. Also some 40 W-stations from Alberta have been heard. Sadly, most of these challenging low-power stations are now gone for good from the AM-band.

Paul, Thanks for sharing. It reminds me of many of the small stations I heard from AK, Yukon, and NWT. Now this is real radio! Never heard CBQM 690, but I do have CHAK Inuvik QSL'd from AK in the mid 60s. They were a regular all day in the winter. I have seen some of the LPRT's while driving in BC in the 70s and for 20 or 40 watts they covered the little towns pretty well. Some even were received several miles out of town. It is amazing what a few watts will do at times. KOHI St Helens OR 1600 kHz has 11 or 12 watts at night and that covers St. Helens fairly well at night. I could easily hear it dominant several times on each side of St. Helens. FM quality would be better, especially if a mountain top location could be found for the tower though. By the way, the CBQM video is also on You Tube.

This was one of the old LPRT stations which used to be scattered across Canada, hundreds of them and they were all listed in the NRC Logbook. They would be plentiful on frequencies like 540, 690, 990 (often, but not exclusively on Canadian clears). I believe they were built by the railroad and later taken over by CBC. Most of them simply relayed a primary station such as CHAK-860 or CBM-940, etc. (they were not limited to the territories).

Although they frequently used simple longwire antennas which would have caused them to radiate lots of sky wave, their low powers, high latitude, and remote location combined to make them very challenging DX targets for American and even Canadian DX'ers, as you could imagine.

Thanks very much for the tip about the movie, Paul. I thoroughly enjoyed watching it in its entirety. I didn't realize they had so much local programming (at least in this case). I'm sure everyone spotted the GE Superadios sprinkled throughout the movie. I didn't realize they were so popular that far North, but of course it makes sense. The fact that so many people seem to own Superadios makes me think many of them may be occasionally tuning to stations outside of town, perhaps CHAK or Whitehorse stations CFWH or CKRW.

Truly a shame the LPRTs are all moving to FM, but I totally understand why. Although I hate to admit it, it does make sense. 40 watts just is not enough to cover more than a small town, so if you

have no plans to reach anyone over the horizon, FM does make sense with its superior sound quality, and frankly, familiarity to people.

Sometime back I mentioned that I was getting a lot of harmonics up and down the band from the cable modem. The noise was pretty bad. We had an outage the other day and after the phone and internet came back, I was having issues with the phone. The modem (Arris) is for both phone and internet. I called Charter and the CSR sent down a "ping" and it did not return correctly, so a Charter tech was out here yesterday and in the process I mentioned the noisy harmonics I had been getting. Anyway, Charter had been replacing the modems with newer ones with better filtering and people were complaining that the modem noise was getting into their rotors. The new modem is much more quiet. In fact when he hooked it up and the phone/internet came back online the noise was down over 50%. After he left, I decided to see if I could knock the rest of the noise out. I wrapped the box in tin foil and grounded it at the coax connection. The noise was totally gone. However, I could not leave it that way, as the box has air holes. So I had an old metal converter box (analog) I would never use again. I took the top off and started to experiment. I set the cover over the modem. It has the sides, but the back and front are open. Little difference, until I grounded the coax shield to the box. The noise is pretty much gone, unless I put a portable within 5 feet of the modem. I plan to place the modem in the box, with screening, and ground it. That should take care of the rest of the noise. That old modem must really have had a noisy power supply.





AM radio: no longer the sound of the city

Steve Tarter's "Minding Business" blog for the Peoria Journal-Star (Feb. 6, 2015)

In 2015, it's not exactly a news flash to say that AM radio has faded from the scene. We all know that the top 40, transistor-powered, fast-talking deejay-drenched hit parades are nothing but blasts from the past.

We know that FM basically took over in the 1980s but once the Big 89s and the WABCs of the world turned off the music and moved to news and talk, yawn, there was the understanding that your heritage AM stations found their place in Metropolis, right?

Wrong-o. Check out the latest rating reports of the top 10 U.S. markets and there are only a few bright spots when it comes to AM powerhouses. Let's take it city by city.

New York City: WINS (the station that featured Murray the K as the fifth Beatle) is the highest-rated AM station in NYC in eighth place; WABC (number-one or two throughout the 70s; home to legendary deejays like Harry Harrison (who once broadcast in Peoria) and Cousin Brucie (still heard on XM satellite radio): 19th in the market.

Los Angeles: AM stations KNX (news) and KFI (news/talk) rank 8th and 9th.

Chicago: News station WBBM is ranked third but WGN is no higher than 11th, just ahead of the Score 670 (ranked 12th). As for the Tribune Broadcasting's vaunted new FM station? It finished out of the top 20, beaten handily by the Moody Bible Institute station in the market. As for WLS, the Big 89? 25th place.

San Francisco: All-news KCBS takes second in this market with sports KNBR in the seven spot.

Dallas: News station KRLD tops the AMs in this market in the number 19 spot.

Houston: KTRH is a news/talk station that finished 9th in the market.

Washington, **D.C.**: best here is sports WTEM at number 17.

Philadelphia: News station KYW hangs in there in the number-four spot. Next best is WPHT, a talk outlet, at number 20.

Atlanta: News/talk WSB is fifth in the market but, after that, it's sports WQXI in 28th place.

Boston: News/talk WBZ is ranked fourth while WRKO is next in 17th place.

Overall consensus: no number-ones on this hit parade; nothing bubbling under the Top 40; and nothing with a bullet (except AM radio, itself).


