Radio Insight

CBS Chairman Les Moonves told investors today that the company intends to divest its radio holdings in the coming year. The plan would "unlock value for our shareholders" in a division that

Moonves called "slow-growth and a drain on resources that can be better directed to content production." CBS Radio maintains 117 stations in 26 markets with a focus on the largest ones. Moonves intends to explore options including a spin-off, merger, or outright sale of the complete radio division. In recent years the company had focused on narrowing its radio holdings to markets where it also owns television stations, but outside of its swap of its Charlotte and Tampa stations to

Beasley for Miami and Philadelphia in October 2014 it had not completed any deals. In the meeting today with investors, Moonves stated that the company's radio revenues dropped by 6% in 2015 due to "continued softness in the radio advertising marketplace as well as fewer radio stations and lower political revenues." The company also took a \$484 million impairment charge on the value of its radio group due to the stations nolonger being worth as much as the company previously valued them.

BTW, KGGF is being bought by the cross-border Bartlesville OK station group including little KWON-1400 and KPGM-1500, so look for possible format change on KGGF; also getting three FM stations in the deal. **(GH-OK)**

760 KMTL AR Sherwood – 3/12 2027 – Country gospel song about Jee-zus, very good signal looping ESE/WNW, slightly on low side making fast SAH with WJR, which can only be heard by nulling this. More segués of such tunes, with 7-second pauses between them; 2041 "Old-Time Religion" by Willie Nelson. Finally long announcement at unexpected break of 2051, full unashamed ID from "KMTL, Sherwood-Little Rock-North Little Rock, Arkansas, United States of America" pimping for new gospel program clients, also streaming via http://kmtl760am.com. Yes, I said it's a daytimer, nor do they mention any FM // wagger as an excuse for "accidentally" being on AM at night. (GH-OK)

810 WSJC MS Magee – 3/3 1900 – Poor with WHB, unID SS in back. REL, LID including Mississippi. Not heard in long time. (JJR-WI)

890 KTLR OK Oklahoma City – 3/5 1521 – Quick check, KTLR is indeed still in Spanish gospel on a Saturday afternoon, as on various schedule segments, otherwise in English. (GH-OK)

900 KFAL MO Fulton – 2/14 0658 – CWM song into TOH ID "...commitment to Callaway County... The Big 900, KFAL, Fulton, Columbia (maybe), Jefferson City, service of Zimmer Radio..."; and into ABC news. (RV-TX)

910 KATH TX Frisco – 2/14 0658 – EWTN Global Catholic Radio Network programming into ad, followed by TOH ID "Thanks for listening to KATH 910 AM Frisco, Dallas,

- Fort Worth, on the Guadalupe Radio Network. Catholic Radio for your soul in north Texas," and back into EWTN. (RV-TX)
- 910 KRIO TX McAllen 2/21 0751 Ad by woman for a beauty salon (Bianca's) in Reynosa (on Calle Benito Juarez telephone 899-937-1247), and followed up with "Radio Esperanza" slogan ID and SS inspirational tunes. (RV-TX)
- **920 KPSI** CA Palm Springs 3/17 0900 ID by woman "Newstalk 920 KPSI Palm Springs." Poor, no sign of KXLY or KVEL. (NJ-AZ)
- 950 KKSE CO Parker 3/15 2303 Ex-KRWZ, over KDCE with ID "KWOF Denver, KKSE Parker." Also heard country music and "The Wolf" slogans. According to my husband John, the station had been sold, new owners took over 3/14 and are simulcasting FM'S country music until they change format to sports on 4/11. (NJ-AZ)
- **1010 KIHU UT Tooele** 3/6 0900 Over local KXXT with ID: "KIHU Tooele, Salt Lake City." New logging. **(NJ-AZ)**
- **NM** Roswell 2/18 2041 Praise music in Spanish owns frequency, i.e. KCKN still not nulling toward KDKA; but there is also a heavy SAH of 2.5 Hz, with DF fitting for my semi-local KOKP Perry OK. I conclude that KOKP is in dead air instead of Triple-Play Sports. Listening further, I hear a weak country(?) music station which seems to be close to the KOKP direction. Not that many 1020s in the USA, and format doesn't match any of them, near or far, in NRC AM Log. DF is no good for Mexico either. Maybe it was really one of the three Cubans in WRTH. **(GH-OK)**

- **1070** KHMO MO Hannibal 3/6 2044 Poor, no WTSO. "News Talk 1070 KHMO" into talk format. Alone. (JJR-WI)
- 1080+ KSLL UT Price 2/24 0213 Country music is ripping up KRLD Dallas talk, loops NW/SE, and only by nulling this can I get KRLD more or less clear from the SSE. Can't be anything but KSLL, 10 kW daytimer! once again on air at night. Listed as Rock/OLD, so maybe crossing over a bit. It's also slightly off frequency to the hi side making fast SAH with KRLD. 2/25 0034 C&W music vs KRLD, i.e. KSLL still functioning 24h. Does KRLD care? (GH-OK)
- **1100 KDRY TX Alamo Heights** 2/29 0832 Gospel in English, not Joplin since it's north/south, which means it has to be KDRY (San Antonio market), gone by 0827. Its February sunrise was 0815. The only other N/S 1100 is a news/talk in Minnesota. **(GH-OK)**
- **1210 KGYN OK Guymon** 2/20 1250 On car radio, very poor signal from KGYN Guymon on groundwave. If I recall correctly, it used to be better, so continue to suspect something is amiss, like power lowered from 10 kW, or sticking to night pattern in day, nulling toward Philadelphia and us; it used to be the other way round, ND day pattern at night, when I don't hear much from it either now. **(GH_OK)**
- **1210 KHAT WY Laramie** 2/21 0855 CWM and ID announcement at 0857, //-92.3 FM (K222BL), "Buckin' 92" slogan; then back into CWM. **(RV-TX)** 3/16 0852 Ad for something in Cheyenne & Laramie, "New Country Buckin' 92," C&W music, 1302 ID as "KHAT, Laramie, and K222BL, 92.3, we're Buckin' 92." Another AM station degrading itself to be a mere appendage of a tiny FM translator which gets top branding. KHAT night pattern is supposed to favor the west. Nothing much from our closer country 1210, KGYN. **(GH-OK)**
- **1240 KDGO CO Durango** 3/6 0905 Popped up with "1340 KDGO" ID then into talk. Had been trying for KJAA (Globe, AZ) but heard this one instead! (**NJ-AZ**)
- **1290 KMMM KS Pratt** 3/7 0831 Rock tunes, man announcer; ID's as "The Mighty 1290 KMMM." Good peaks, mixing with KOWB. (**JW-CO**)
- **1300 KBRL NE McCook** 3/13 0931 A brief bit from ABC news, 0933 UT Fox Sports talk, from NW/SE, ID in passing as 1300 KBRL. *NRC AM Log* confirms that both networks are among its many affiliations. Yet there has been heavy QRM and not sure both I heard were from same station. **(GH-OK)**
- **1300 KVET TX Austin** 3/2 0848 "Back to *The Bottom Line* on Austin's Sports Talk Leader AM 1300 The Zone," then sports talk, as promised; no other ID heard. Fair/poor. **(IW-CO)**

- **1310 KLIX ID Twin Falls** 3/7 0755 "AM Idaho" in progress with typical wakeup fare: news, weather, ads, etc.; legal ID and Fox news at ToH. Fair in KFKA null. **(JW-CO)**
- **1310 KOKX IA Keokuk** 3/1 0723 Poor. IL announcements, Gov. Rainer announcements. "KOKX news time" No WIBA. (**JJR-WI**)
- 1310 KNOX ND Grand Forks 3/12 0817 Area news, weather, ads, etc., Minnesota news at 0823. Signal up and down with KFKA running open carrier. Noted KNOX legal ID at 0900; KFKA came back on at 0904. (JW-CO)
- **1320 KCTC CA West Sacramento** 3/12 0845 Up and down with ESPN programming; fast-spoken legal ID at 0859:52 for KCTC and one other station, probably an FM translator; the ubiquitous ESPN Sports Center commenced at ToH. Fair at best but pretty much alone on the frequency with no sign of usual KFNZ. **(JW-CO)**
- **1320 KHRT ND Minot** 3/3 0824 Weather, ending with "I'm meteorologist Tom Churchill on K-heart," followed by a call letter ID and religious vocal music, hosted by male announcer. Not strong but QRM-free for a while. **(JW-CO)**
- **1360 WLBK IL De Kalb** 3/9 1752 Fair with "…on 1360 WLBK" heard at the end of a promo. Illinois #59 and overall logging #995 at this QTH. **(RD-NE)**
- **1370 WLLM IL Lincoln** 3/5 1950 Poor. USA news after 3 So. GOS songs. Weather; no calls, promo, LID(!) Ranger Bill. Only thing there. No usual WSPD. **(JJR-WI)**
- 1370 KXTL MT Butte 3/4 2004 With local weather, ID at 2005 "Your number one source for news, sports and weather in Southwest Montana, your Talk Radio Leader, thanks for joining us at AM 1370 KXTL." Strong over KSOP. (NJ-AZ)
- 1370 KWTL ND Grand Forks 3/11 0750 From NNE/SSW, ad in English for Aquinas, a Catholic college in Nashville; 0757 Catholic talk and EWTN mentioned, lost before 0800 ToH. Therefore it must be the only EWTN Radio affiliate on 1370, KWTL Seems I have not logged KWTL before. Meanwhile, I still can't get *anything* from my nearest 1370, the alleged 5000/230 U1 KGNO Dodge City KS. (GH-OK)
- **1370 WDEF TN Chattanooga** 2/29 1906 Poor. "Q 97-3, 99-3" and Cl Country announcement. In 25 mins, no WSPD. "The WUUQ app." Thought I had this. Not! TN#104 1370#25. NEW! (JJR-WI)
- **AZ** Parker 3/7 0904 "The last medium of freedom, KLPZ 1380 AM" was the ID noted at 0904, followed by area news. Briefly good and alone on the frequency but soon faded. (JW-CO)
- **1380 KSRV OR Ontario** 3/4 0959 Elton John song to 1002 legal ID by man: "...Good Times and Great Oldies, you're listening to Oldies 1380 KSRV Ontario," followed by news (ABC, I think); back to music at 1005. Heard also on 3/8 with LID at 1004. Generally fair post-sunrise here after the eastern signals have faded away. **(JW-CO)**

- **1480 KBXD TX Dallas** 3/4 0301 Series of gospel tunes starting with "Put your hand in the hand," still at 0320 as I am dozing off. This may be reactivated KBXD, which NRC DX News says finally came back on the air Feb 20. Needs further checks here. **(GH-OK)**
- **1490 KRUI NM Ruidoso Downs** 3/12 0905 Fair with end of Fox News followed by weather "...right now at 1490 KRUI, I'm meteorologist Ron Roberts." **(NJ-AZ)**
- **1520 WHOW IL** Clinton 3/1 0736 Poor; IL political ads, IL in web addresses, "WHOW farm show...." Alone.(JJR-WI)
- **1520 KYND TX Cypress** 3/2 2140 Oldies music with call ID. Over/under usually strong KOKC, Oklahoma City. New here. **(JR-OK)**

- **1520 KKXA WA Snohomish** 2/28 0610 CWM mixing with KOKC remnants; ID at 0612 after Hank Williams Jr song "There's a new sound along the shoreline ...You've found Classic Country, 1520, KXA" then back into mx. Local ads for Everett businesses after "Classic Country 1520 KXA" ID at BOH. **(RV-TX)**
- **1530 KQSC CO Colorado Springs** 2/28 0855 CWM mx, ToH ID "This is Mountain Country, KQSC Colorado Springs AM 1530 and K94CH Fountain at 107-3," then back into CWM, new calls for me. **(RV-TX)**
- **1530 KQNK KS Norton** 3/13 2140 Oldies with call ID and "Your Hometown Radio Station." Heard in loop null of WCKY. New here. **(JR-OK)**
- **1540 KZMP TX University Park** 2/28 0855 SS sports talk, ID at 0857 as "ESPN Deportes Dallas" in SS. Never caught a clear ID. (**RV-TX**)
- 1550 WPFC LA Baton Rouge 3/4 2200 UC gospel music with call ID. (JR-OK)
- **1550 WDLR OH Delaware** 2/28 0643 Poor; "News weather sports & more, 1550 WDLR," 70s oldies. No CBEF (JJR-WI)
- **1550 KNSH TX Canyon** 2/28 0856 National ads, TOH ID "You're tuned to Talk 1550, KNSH, Canyon, Amarillo." New calls for me. **(RV-TX)**
- **1560 WRIN IN Rensselaer** 3/5 1920 Poor, national 1-800, "The Bear, Country 1560" & no semi local WGLB. (JJR-WI)
- **1560 KKAA SD Aberdeen** 2/24 1810 Hymns, prayers and prayer requests, ID as "Family Radio." Looping N-S, over/under several other signals. (JR-OK)
- **1580 KFCS** CO Colorado Springs – 2/19 2026 – Dominant signal playing Christian hymn by full orchestra, loops NW/SE, soon announcement for 58 degrees in Colorado Springs, time 6:27; Vonage ad read by local announcer, then ones for healthmerchant.net and grasshopper.com phone systems; female ID: "Thank you for listening to the all-new AM 1580, KFCS, Colorado Springs-Pueblo; now on with the music" and 2030 into a hymn on piano. The all-old KFCS had an oldies/shopping format per NRC AM Log. No echo as Larry Godwin, MT, was reporting Jan 18 at 2030 making him wonder if there were transmitters in both cities? If so, unknown to FCC AM Query showing licensed to same single site, day and night, 10/0.14 kW, both non-directional. It's obviously on 10 kW day power now, despite official Feb sunset an hour earlier at 1930! I can remember when the 1580 in C.S. was KPIK (until 1987y). After several more changes, it only became KFCS last May. From Colorado Springs? (GH-OK) 3/12 2200 – Call ID, Colorado ads, preaching by Michael Youssef. Good signal on fade-ups. (JR-OK)
- **1590 WIXK WI New Richmond** 3/3 1905 Poor; LID as "Classic Country 1590 WIXK New Richmond" over others. (JJR-WI)
- 1610 CHHA ON Toronto 2/24 2349 Announcement in Spanish over PMS Anguilla, and 0000 'O, Canada' national anthem, i.e. CHHA, Voces Latinas. Do any other or all Canadians play NA at local midnight? I haven't noticed it before, certainly not from CBC; optional unlike Mexico? Getting the new 1610 in Montreal past CHHA will be tough here. (GH-OK)
- 1640 KZLS

 OK Enid 2/26 2100 Nominal with some talkshow, but at 2116, retuning, now in open carrier/dead air. With just a little manipulation of bandwidth and passband on the NRD-545, via the E-W ALA330S antenna, I have perfect copy of WTNI Biloxi MS (which is always audible as understation to KZLS at night), during a silly baseball game yes, baseball, for sure, on a Friday night in February. The Golden Eagles are a team, mentions having lost to New Orleans, Pensacola. Also refers to the Northwestern State Angels (?). We continue to suspect WTNI is running more than 1 kW night power most or all of the time. 2/26 2116 Mixing with WTNI thru KZLS dead carrier, an English station plugging Jesus, presumably WSJP, EWTN in Sussex WI (one other religionist on 1640 is KDIA Vallejo CA, twice as far but 10/10 kW U2 rather than most X-banders, 10/1 kW U1; but KDIA night pattern nulls to the east, throwing most to the south and west). 
2/19 2034 – The warbling is still weakly audible, and KSTP is not too strong, so another attempt to DF it. It now seems a couple degrees above due east. In case there is something in the shack skewing the ferrite in the DX-398, I then go outside to the yard and the street, but get the same results. This has been narrowed down to three possibilities, the little stations in NW KY, SE MO, and NW TN. Closest to due east is WPOT Trenton TN, 250/6 watts; slightly CCW is the nearest, KDFN Doniphan MO, 1000/0 watts; slightly more CCW is the farthest, WMJL Marion KY, 175/0 watts. Still need someone to visit one or three of these towns at night, as we are too close to the margin of error. (GH-OK)

1610 UNID -- 3/16 0207 – Open carrier/dead air, loops NE. No TIS normally heard here at this level; suspect it's CHHA Toronto; vs ESE a bit of PMS from Anguilla. **(GH-OK)**

[Krueger-FL]
- 1210 **CUBA** *R.Reloj*, unknown location MAR 10 0109 A new one, if I recall correctly, and not listed in EcuRed, or my stale list until now. Very poor under *R.Rebelde* and *R.Sancti Spíritus*. [Krueger-FL]
- CUBA *R.Caribe*, La Fe MAR 10 0150 Cuban pop/jazz, news summary 0159-0201, female canned, "Esta es CMBY, Radio Caribe, desde la Isla de la Juventud, Cuba." As always, audio way over-modulated. Haven't heard the briefly existing and unlisted 1210 parallel in a few years, presumably long gone. [Krueger-FL]
- CUBA *R.Mayabeque*, Santa Cruz del Norte FEB 26 0042 Very poor in the co-channel jumble, but a clear parallel to 1140 (also in a mess with other Cubans) with Cuban pop vocals. Never an easy catch, listed 1 kW. This on post-sunset enhancement and soon to bubble under and gone. [Krueger-FL]
- MEXICO XEUR Extasis Digital, México, DF FEB 28 1316 Caught ID by a woman, "Extasis Digital, en 1530 AM, XEUR en México DF..." then back into some Quarterflash (U.S. pop/rock). [Vance-TX] MAR 7 1100 Tune-in to Samantha Fox "Touch Me (I Want Your Body)," male canned, "XEUR, Extasis Digital... México, Distrito Federal..." at 1102, into Thomas Dolby "She Blinded Me with Science" and another slogan ID, into Queen "Your My Best Friend." Parallel the tunein.com stream. Excellent, obviously running 50 kW and not the 1000 watts night power. [Krueger-FL]
- 1540 **BAHAMAS** ZNS1 Nassau MAR 18 0959 Caught partial ID through KXEL and CHIN, "...of the Bahamas," then lost to WDCD sign-on. Also noted hets against domestics from 1521 and 1559 kHz spurs. [Conti-NH]
- 1610 **ANGUILLA** *Caribbean Beacon*, The Valley MAR 16 0607 Parallel 6090 kHz, while 11775 kHz was noted off all day. [Hauser-OK]
- MEXICO XEARZ ZER Radio, México, DF MAR 6 1029 End of instrumental, male canned Spanish ID, back to smooth jazz instrumentals. Good, mostly over KSVE, the Tampa I-275 HAR, and the unID "beeper" HAR/TIS. [Krueger-FL]




