- **1230 WIBQ IN Terra Haute** 8/22 2048 Up out of the mess with "...WIBQAM.com advertise with us ..." and "... and Whiting news 1440 WPRS Paris" which is their parallel. Rare here. **(RR-IL)**
- **1230 KFJB IA Marshalltown** 9/16 0709 Poor; "News Talk 12-30 KFJB" Steady, no WCLO. HSFB promo. (**JJR-WI**)
- **1230 WNAW MA North Adams** 9/14 2030 During a mix-up of stations, male announcer with decent copy "... radio ... sports ... and all that ... 1230 WNAW" then fell back into mix-up. **(RR-IL)**
- **1230 WMPC MI Lapeer** 8/21 2058 Suddenly on top of a jumble with male announcer "...WMPC Lapeer..." then lost. **(RR-IL)**
- 1230 KWIX MO Moberly 8/23 2058 No ID but up out of a mess with female announcer "...serving Clark & Macon counties for over 6 years ... Waste Removal ..."

- **1330** KNSS KS Wichita 9/17 0705 Poor; calls weak in with others. Not strong as in past. (JJR-WI)
- **1330 KOVE WY Lander** 8/31 0807 "Ridin' the Range and Ropin' the Rockies, 1330 Country KOVE," followed by LeAnn Rimes' version of the *Star Spangled Banner*. Fair/good. **(JW-CO)** 9/18 1000 "1330 KOVE Lander" poor through others then quickly covered by KGAK. New for me. **(NJ-AZ)**
- **1340 KIKO AZ Apache Junction** 9/16 0855 One of my locals noted completely off the air, still off 9/20 1300. **(NJ-AZ)**
- **1340 KTOX CA Needles** 9/16 0900 ID "KTOX Needles," 0905 station promo followed by "KTOX news, sports, K-TOX on 1340 AM." Poor with KIKO off the air. New. **(NJ-AZ)**
- **1340 WSOY** IL **Decatur** 8/30 2017 Male announcer with "Your home for the Redbirds, WSOY," referring to the St. Louis Cardinals. Rare here. **(RR-IL)**
- **1370 WLLM IL Lincoln** 8/29 2002 Male announcer jumped out of the jumble with "... at WLLM.org, good news and good music twenty-four seven, WLLM" into music. Rare here. **(RR-IL)**
- **1400 WMAN OH Mansfield** 9/22 1934 Out of a big pile up male announcer with "... WMANevents.com(?)....here on WMAN" clear ID, then fade to gone quickly. **(RR-IL)**
- **1480 WRSW IN Warsaw** 9/1 2030 No ID but playing Chicago Bears coverage of 4th preseason game, Tom Thayer and Jeff Joniak announcing. This is the only Bears affiliate station on 1480, so presumed. **(RR-IL)**
- 1480 KBXD TX Dallas 9/15 0814 Peppy male and female announcers mixing English with South Asian language (Hinglish? Engjabi?), VG from SSE, i.e. KBXD. So they have finally become a real station after stunting for months with nothing(?) but South Asian pop music. Promos/ads for somethings in the 469 area code, which

is one of the overlays around 214 Dallas. ID at 0818 as "Radio Salaam Namaste," introducing a music break; now losing a little to KQAM Wichita with a 2.5 Hz SAH. At 0822 "This is Radio Salaam, 1480 AM, Bollywood Channel," so sometimes leaves out the "Namaste." Ad for some event Sept 18 at the Irving Convention Center. Ad for bridal jewelry from Mark Samuel Jewelers. "Radio Salaam Namaste, 1480-AM, music with a beat"; generic birthday wish. (GH-OK)

- 1480 KLVL TX Pasadena 9/22 1645 Very weak with East Indian music, daytime DX. (JR-OK)
- **1490 WBTA** NY Batavia 9/5 2036 Extremely excited sounding male announcer over the mess with clear "WBTA" id then back to a pile up. Local WPNA nulled with Kiwa. (RR-IL)
- **1490 WRMT NC Rocky Mount** 9/6 2100 Popped up out of nowhere with male announcer "on WRMT ..." very clear then faded to gone. Local WPNA nulled with Kiwa. **(RR-IL)**
- 1550 WPFC LA Baton Rouge 9/19 2015 UC religious talk, fading with interference. (JR-OK)
- **1600 KATZ MO St. Louis** 9/21 2020 UC religious talk and gospel music. Mild fading with fair signal. (JR-OK)
- **1610 CHHA ON Toronto** 8/28 2003 Very clear male announcer out of dead air with "... and 647-227-4734 (phone number). You can also visit YouTube ... CHHA 1610AM and also at ... podcasts ... Toronto.org and channel5.com" into talk show. **(RR-IL)**

OTHER

Glenn Hauser submitted a narrative and DX logs from his recent road trip to The Gathering, the combined convention of the National Radio Club (NRC), International Radio Club of America (IRCA), World TV and FM DX Association (WTFDA) and Decalomania. As usual, Glenn's submissions span most of the radio listening spectrum. For this edition of DDXD-West, we are only including selected AM loggings. For a complete report, see *DX Listening Digest* 16-37 at http://www.worldofradio.com/dxldmid.html.

This report, with one exception, covers what I heard on the way to, during, and on the way back from The Gathering, joint convention of IRCA, NRC, WTFDA and Decalcomania in Kansas City MO, Sept 9-11. There was not much opportunity to monitor SW during the event, but for sake of completeness I am leaving in my SW observations. (Editor's Note: They are not included here.)

I really enjoyed attending my first DX convention in many years, renewing old acquaintances, matching faces to names I knew but never had met. Thanks to Ernie Wesolowski and crew for organizing it all! And to Carl Mann for inviting me in particular. Several blind people attended from as far away as Miami and Los Angeles. Surely a greater proportion than in the general population.

They and we were pleased that several sighted people were always there to assist them when needed. Tech talks Saturday morning were especially interesting, mostly about MW and FM antennas; and the FCC's Grand Island NE monitoring station, which may be still in use although remote controlled (but where are the antennas?)

My only diversion from The Gathering was a couple hours at the great Nelson-Atkins Museum of Art, which I last visited many years ago.

- KS Kansas Turnpike Authority 9/9 morning Somewhere around Wichita or south of there, 100% relaying NOAA Weather Radio, Wichita (as usual, JBA in Enid), during flood warnings in the Winfield KS area, after very heavy rains. The Turnpike is elevated enough not to be inundated unlike some highways, such as US 77, but large lakes of water were right alongside the right-of-way. Never heard a KTA ID or a NOAA ID during this. Two days later, 9/11 on the way back along the same route, back to more normal weather radio, but still including flood warnings, as rivers are above flood stage for at least another day or two, e.g. at 29 feet, flood stage being only 18 feet.
- **570 WNAX SD Yankton** 9/11 1530 "KFAN Minnesota Vikings Radio Network," so it's really WNAX, still making it easily as far as El Dorado area of southern KS, and atop anything from KLIF, unlike in Enid.
- **640 WOI IA Ames** 9/11 1512 Near Cassoday KS on I-35, 5 kW KWPN Moore OK is dominant with stupid sports talk, but fast SAH from understation, which must be 5 kW WOI, public radio in Ames IA. Wish I had thought to check for it while in Kansas City, where presumably WOI would be audible at least weakly, the ONLY public radio left on AM anywhere around here, since Kansas State saw fit to sell out share-timer KSAC-KKSU 580 to WIBW so it could be full-time.
- **920 KYFR IA Shenandoah** 9/11 1537 Religious music as KYFR is still making it as far as mile 64 of the Kansas Turnpike between El Dorado and Andover.
- 1130 KLEY KS Wellington 9/11 1523 Along the Kansas Turnpike, open carrier/dead air, still at 1539, but music modulation at 1610 check. It's KLEY, which I also get at home in Enid, sibling station to KKLE 1550, both of them horribly managed/operated.
- 1230 UNID -- 9/10 2127 Enumerating roster of tall sports players, but surely not BKB, mentions New Mexico, making me wonder if it's KFUN Las Vegas? But then also mentions Nebraska. Probably the closest 1230, KTNC Falls City in the SE corner, although format listed as OLD. BTW, as revealed in the Sunday morning quiz at The Gathering, 1230 is the one graveyard frequency lacking any Kansans, though there are such right across the borders, e.g. WBBZ Ponca City
- **1550 KKLE KS Winfield** 9/11 1442 Still along the Kansas Turnpike, overmodulation/distortion, program cut off for a Wounded Warrior/USO PSA. At 1527, still O/D in talk show.
- **MO Kansas City International Airport** 9/9 At the Kansas City Airport Hyatt, so not far from Kansas City International Airport (KCI), continuous TIS from KCI with IDs as WQI284, info on parking, etc. But also audible on the freeways at considerable distance.
- **KS** Wichita 9/11 1543 Unexpected station here, surely not KCJJ from Iowa in early afternoon. It's a mixture, the dominant audio being a talk show, soon found matching 1330 KNSS Wichita, so this is a leapfrog mixing product over another Wichitan, 1480 KQAM, another 150 kHz higher! Audible only between miles 54 and 50 on the Turnpike, near Andover on E side of Wichita; presumably closest to shared(?) transmitter site? No, sites and ownership are different, per FCC.
- 1680 WQCW625 KS Flint Hills 9/11 1424 I find two signals on the X-band at mile 107-106 on the Kansas Turnpike, where I finally find a place to pull off with undivided attention to the Nissan car radio. Historical lecture by non-professional announcer about Chase county history: "Welcome to Chase County long and illustrious railroad history," a onetime cattle-shipping location. Then also about Tallgrass Prairie, National Scenic Byway. No call letter ID heard on the first one, but says there are three transmitters on 1680, in Council Grove, Cottonwood Falls, and Cassoday (from north to south along state highway 177, not hearing the first one). The other two are making a SAH with each other of 110/minute or 1.83 Hz, and are programmed completely separately, self-QRM. At 1431, I can hear the understation with a female ID. I drive on a bit further and by mile 99-100, the Cassoday station is overtaking Cottonwood Falls. Talking about

walking tours along the Flint Hills Scenic Byway; several different amateur voices, some lo-fi with clix as if recorded off a phone; and not the same ones heard on C.F. The female ID is better produced, appearing every few minutes: "You are listening to Flint Hills Scenic Byway Radio Broadcasting System at 1680 AM on your radio dial. The call sign is WQC-W625" [the - indicating a pause in the wrong place]. At 1448, I stop at the Kansas Turnpike service area a few miles north of Cassoday, where of course, the Cassoday transmitter rules. One of the repeated spiels begins, "Here it is, spring of 2007, wild flowers in bloom." This thing hasn't been updated in almost a decade! But I am not complaining; it's new to me, and kudos for keeping the transmitters operational all this time. They must have been operative two days earlier on my way up to KC, but I must not have been X-bandscanning at the right time. There is NO sign notifying us of these along the I-35/Kansas Turnpike. Sounds like an interesting side trip, but I allowed no time for such, coming or going. Maybe next time. BTW. I have never heard any trace of these back in Enid, at least 213 km or 133 miles away. Has anyone ever reported them as DX or as travel catches? No hits on the call in the IRCA mail archive.

1690 (HAR) -- 9/11 – Signs along the KC freeways say "Tune 1690 for traffic info when flashing" – but never active when I check. There are also lots of electronic signs along the way with info on lane closures, how many minutes to this and that exit, etc. I haven't seen anything like that in Tulsa or OKC.

John Reed from Shawnee, OK describes his latest DX receiver: "...Brigantina, made in the USSR in the 1990s. I spent most of the summer translating the Russian technical manuals which I found online for this receiver and getting it going. Beautifully made with an innovative design. It's better than anything else I have here, including my NRD-525, NRD-545, Racal RA-6793A and Harris RF-590.



- MEXICO unID SEP 15 1159 Loops southwest, 6:59 time check, "Mundo Deportivo" segment in news, something in the Estadio Jalisco. There are no tapatíans on 560, but most likely XESRD in Santiago Papasquiaro, Durango; or XEGIK in Monclova, Coahuila, although the only 560 with a purely news format in the 2015 IRCA Mexican Log is XEOC México DF. But many musical stations include a morning news block, which can throw you off. [Hauser-OK]
- 570 **MEXICO** XEBJB Monterrey, NL SEP 19 0347 Seems same show as on 660, q.v., "En Escena" segment about new film releases, but not synchronized with sibling station to this. [Hauser-OK]
- MEXICO XETNT *Radio 65*, Los Mochis SEP 22 1215 Ad for John Deere, Sinaloa, so XETNT in agropecuaria wake-up show. Not a big dominant signal it used to achieve at sunrise. [Hauser-OK]
- MEXICO XEFZ ABC Radio, Monterrey, NL SEP 19 0345 Segment about cine estrenos in Monterrey, not parallel 1050, or at least not synchronized. SEP 21 1202 Canned ID for XEFZ and introducing 'Las Noticias Como Son' (son is a play on words); 1203 live newscaster also mentioning FM 91.7. Neither IRCA 2015 nor Cantú 2015 matches that or any FM with XEFZ; instead Cantú showed the AM of 91.7 XHXL Monterrey is AM 1340. Rather than full-time duplication, could be only this morning news block is matching among stations in the same local cluster. Then he reminds us that mañana at 9:21 a.m. Central Mexican Time will be the "equinoxio de verano" oops, he means otoño. Time is correct = SEP 22 1421 UTC. [Hauser-OK]
- MEXICO XEDKR Guadalajara, Jal. SEP 8 1153 Radio Red ID, presumed XEDKR which relays XERED 1110 México DF; thought I heard an FM 92.1 mentioned, but not listed as such in Jalisco, and in the DF it's on 88.1 MHz. [Hauser-OK] XHRED and XHFO swapped formats in June, so you heard 92.1. I suspect Red FM is not much longer for this world. [Raymie Humbert, WTFDA Forum via DXLD]
- MEXICO XEDP Cd. Cuauhtémoc, Chih. SEP 11 0138 DKAZ antenna nulling the east is sufficient to audiblize the tell-tale het from XEDP while using their off-frequency transmitter site, as frequently noted back in OK where KCMO on 710.0 is not a local! [Hauser-MO]
- MEXICO XEJCC Cd. Juárez, Chih. SEP 11 0140 Spanish music, likely XEJCC rather than 720 anything from WGN Chicago, thanks to the DKAZ antenna aimed west. [Hauser-MO] SEP 14 1200 - Usual sequence of National Anthem, State Anthem, prayer, and ID, which included their new address of Elisa Dosamantes 400 (actually an old address occupied by the station years ago); into "Buenos Dias" program at 1204, a relay of Radio Centro in Mexico City, with a talk format; "El Reporte Vial" (Mexico City traffic) at 1214. Good peaks, mixing with KSAH, also Spanish. [Wilkins-CO] SEP 17 1158 – Open carrier from WSW/ENE atop a weaker Mexican music station, the latter mentioning "La Raza" at 1202, so no doubt KSAH San Antonio. I wait and wait for something to start, until 1206 Mexican choral national anthem finally fires; 1208 Chihuahua state song; 1209 inspirational "un nuevo día" recitation about "amor, y sólo amor" with music bed. 1212 weakening but finally brief canned sign-on as "El Fonógrafo 720 AM," street address in Ciudad Juárez, "mil watts, Grupo Radio México"; then switch to live announcer with 6:12 time check, and calls mentioned for first time, XEJCC, plugging algo at 9 a.m. from México DF, 1213 into music. Calls pronounced "equis-e-jotacéce," i.e. emphasis on the first C, rather than equal or even more stress on the second, so at first it sounded like "efe" or "ese." CC could be interpreted as cese, "stop it." SEP 22 1210 – Lots of "felicidades" birthday greetings from family members; unseem particular to Cd. Juárez, so maybe national hookup from parent station El Fonógrafo 1150 XEJP in the DF via XEJCC. 1213 finally music expected to be "Mañanitas" but something else. Very poor signal from west/southwest, much weaker than neighbor 730 XEHB Parral. [Hauser-OK]
- MEXICO XEHB Hidalgo del Parral, Chih. SEP 4 1215 Program note for "Country Time," followed by full ID at 1216: "Escuchas XEHB-AM 50 mil wats de potencia 730 AM y XHHB-FM con 25 mil wats efectivo 107.1 FM. Estereo Fiesta..." followed by address; into a program of eclectic music, from English pop/adult contemporary to traditional ranchera. Very good signal. [Wilkins-CO]
- MEXICO XEROK Cd. Juárez, Chih. SEP 21 1206 Nulling semi-local KQCV gospel huxter as much as possible, Spanish ad string is surely XEROK, but still cannot overcome 2.5 kW even at sunrise; makes SAH of 51/minute = 0.85 Hz. Rather KQCV should be on night power of only 1 kW until 1215 UTC in September (1230 in October). [Hauser-OK]

- MEXICO XEABCA Mexicali, BC SEP 19 1206 ID as "820, ABC Radio," music making usual slow SAH with WBAP nulled. [Hauser-OK] AUG 22 1128 Segued trio and romantic vocals; frequent canned "Canal 820 ABC Radio" slogans; no other announcements or ads; full ID at 1208: "XEABCA Radio Frontera, transmitiendo en la señal 820 de amplitude modulada con 3500 wats de potencia..." followed by address; more música romantica followed. Fair/good with WBAP slowly fading away. [Wilkins-CO]
- MEXICO XETAR Guachochi, Chih. SEP 11 National anthem, followed by ID's in two Indian languages and Spanish, with traditional fiddle music in the background; more talk followed, mainly in Spanish but occasionally switching to local languages; frequent call letter ID's and "La Voz de la Sierra Tarahumara" slogans. Fair signal, mixing with KJMP. [Wilkins-CO] SEP 15 1201 National anthem is playing, and at 1207 recheck, XETAR is just now signing-on in Spanish, neat rustic music breaks, and same in other native languages but they still pronounce the calls and website as in Spanish, and the sponsoring agencies. Lema: "Cuatro pueblos unidos en una sola voz." As usual, good signal from 10 kW daytimer, dominating frequency until fadeout by 1220 UTC. [Hauser-OK]
- 990 **MEXICO** XET Monterrey, NL SEP 19 0335 Playing music, not parallel 1050 kHz. [Hauser-OK]
- unID SEP 21 1222 Spanish station discussing some event in El Paso, with person on phone but there is no El Paso/Juárez station on this frequency. Closest in Chihuahua, not very, is Cuauhtémoc, closest in U.S. is Artesia NM, not Spanish. XECL Mexicali really gets out, so maybe this was it referring to a concert. Loops westward rather than southward, too late for XET Monterrey. [Hauser-OK]
- 1050 **MEXICO** XEG Monterrey, NL SEP 19 0334 Talking about events in Monterrey and Nuevo León, as it's doing its own local PS to La (Media) Hora Nacional. [Hauser-OK]
- MEXICO XEP Cd. Juárez, Chih. SEP 16 0220 8 y 19 minutos time check, from "Radio Mexicana, la música..." XEP as usual dominant signal at night, but plenty interference too. Impossible to believe it's 200 watts at night rather than 38,000 watts day power. SEP 19 0333 "La Hora de Chihuahua" is starting, "complementaria de La Hora Nacional." so of course it's XEP as usual the dominant night signal here despite listed 200 watts. It seems that LHN is really "Media Hora Nacional," the second half being turned over to state/local government programs. Will I hear the same thing on other Chihuahua stations? First to check is 800 XEROK, but can't get enough signal past 2.5 kW KQCV, despite a close to 90-degree null. Which reminds me, that XEROK for quite a while now has seemed to be underpowered again, far less than 50, let alone 150 kW, wasting its exalted clear-channel status across western North America. [Hauser-OK]
- 1310 **CUBA** *R.Enciclopedia,* Nueva Gerona, Isla de la Juventud SEP 17 1048 Fair with instrumentals, parallel 530 kHz. WYND co-channel. [Krueger-FL]
- 1450 **CUBA** *R.Mayabeque*, La Sierrita, Mayabeque SEP 18 1014 "De Vuelta a Casa" by Carlos Valera into another one of his songs, female live ID 1020 UTC. [Krueger-FL]
- MEXICO XEQI Monterrey, NL SEP 19 0331 "La Radio Alternativa" mentioned several times in station promo roughly from south amid heavy interference, the newish XEQI in IRCA Log as "La Nueva Radio" but now Alternativa is its name per NL government roster www.nl.gob.mx/radio-y-television-de-nuevo-leon. IRCA and WRTH list as 10 kW daytimer, but IRCA adds it's 24 hours. This might have been preceding a local PS to La Hora Nacional as on several other stations. Same page also links to streaming and download of "Nuevo León en la Hora Nacional Descarga y escucha aquí este programa conducido por Gregorio Bernal y Roció Zubiria." 1510 program schedule www.nl.gob.mx/publicaciones/programacion-de-radio-alternativa-1510-am. [Hauser-OK]

TRANS-PACIFIC DX

- 693 **JAPAN** JOAK Tokyo SEP 21 1220 English language lesson parallel 774, both *NHK-*2 network. Spotty reception at best but enough to determine the parallel with 774 JOUB which is always the best Japan signal here. [Wilkins-CO]
- 702 unID SEP 15 1147 The only transpacific carrier I can detect is this, from the west, presumably 2BL Sydney, Australia. [Hauser-OK]
- JAPAN JOUB, *NHK-2* Akita SEP 17 1140 On my mere DX-398 and ferrite loopstick, JBA carrier when I could also detect a carrier on 693 kHz. At 1154, 774 and 828 JBA carriers. [Hauser-OK] SEP 19 1144 Gal talking in Japanese parallel 747 kHz. Heard later around 1220 UTC with English language lesson. Other hets from presumed Japan heard on 594, 612, 693, 828, and 873 kHz. 774 JOUB almost always is the most reliable signal from Japan, with 747 JOIB a close second. [Wilkins-CO] SEP 19 1158 A few minutes before sunrise, JBA carrier here looping northwest, so NHK; then find others on 684, 693, 828. Only 684 is not a

superpower NHK; could be North Korea or China. SEP 21 1155 – JBA transpacific carriers led by this one from the northwest, so NHK; also on 747, 693, 828, all of which are superpower NHK frequencies. Now I have audio on one of them! 774 at 1200, clear time signal ending with last pip at higher pitch and resounding. All are 500 kW, except 828 only 300 kW. I used to get Osaka in the old days when it was still on 830 kHz. [Hauser-OK]

Additional report from Hauser at The Gathering, Kansas City, MO: Pre-sunrise bandscan for transpacific carriers, Sunday, Sept 11 at 1147-1159 UTC on the DKAZ antenna into DX-398: 765, 774, 828, 837, 882, 1035, 1098, 1548 kHz. Intriguing 765 still in at 1207. No DFing with this, to distinguish between DU and FE, but I suppose DU more likely now? But generally much higher powers from Asia. 1098 is of particular interest, likely V7AB Marshall Islands, with new 25 kW Nautel transmitter as reported by Brian Clark, NZ; he says it signs off circa 1130 but leaves carrier on. Neil Kazaross, DXing at the same time from his DX truck was getting more of these with his SDR. The DKAZ had three hookups available simultaneously. Nick Hall-Patch from BC was on the other one. And I am indebted to Mark Durenberger who came up with a proper adapter so I could use it. That antenna really too much for the DX-398, but at least it has an RF gain control to minimize the overload, including SW signals such as CW from WLO.

No loggings for *DX News* this time. I went in the radio room the other night to see what I could find, and found *only* the strong local stations (this was at about 2130 local time here in Tucson – 0030 ELT). I went outside the next morning to find that my end-fed long wire antenna was down ... the support line finally gave out. I guess there is some antenna work in my near future. I am thinking about changing the antenna to a delta-type configuration. I will keep you all posted on how it goes.

Harry J. Hayes - 9 Henry Street - Wilkes-Barre, PA 18702

This location was a pretty quiet for DXing until about 9 or 10 years ago. Along with the IBOC noise that became most apparent in 2007 was a growing QRN problem caused by various known and unknown sources. If I may describe my noise problems, they go like this. Every 147 khz there is a very strong signal source which sounds like an open carrier. I have it on 590, 730, 880, 1030, 1170, 1320, 1470 and 1620. Locals on 590 and 730 are unlistenable. I've had this for about 10 years and this noise source is pretty much all over the city area. On occasion it moves down 10 khz (how nice of it!) which means it's on 580, 720, etc. Next I have what I will call an ambient hiss that peaks between 1000 and 1250. Then I have a "saw-tooth" type buzz which is constant and peaks on 650, 790-800 and 940-950. If all this isn't enough there are a least 2 large screen TV's from neighbors roughly 25 feet away which really messes up the band from top to bottom.

Last year I purchased a C. Crane Skywave radio. To my delight this radio dealt with the noise pretty well especially when used with an external, passive, large ferrite bar that I have. After seeing George A. Santulli of VA rave about the Wellbrook ALA antennas in a Musing a month ago I decided to purchase an ALA-1530 indoor antenna which I placed in my attic. I ran 50 ft. of RG-58 down to my DXing area in an unused bedroom on the second floor and connected it to my old Grundig S-350. I would have loved to use the Skywave had it an external connection. The result was quite amazing. The most noise free orientation aims me southwestward toward Harrisburg. I am able to null the "ambient hiss" about 80% which brings daytime signals in from WTIC-1080, WBAL-1090 and WCAU-1210. The signals are very weak but on the Skywave with ferrite bar they were always below the noise floor. Other daytime results, WHLM-930 Bloomsburg, PA, 35 miles distant from a hissy signal to noise free. WEEU-850 Reading, PA 80 miles distant from very hissy to loud and a very light hiss. WADV-940 Lebanon PA, 1000 watts, and WWSM-1510 Annville PA, both 90 miles distant from just about audible to clear and listenable.

When properly oriented to null the large screen TV interference it takes out about 95% of it. The "saw-tooth" buzz mentioned above, now non-existent. It doesn't do too much about the very strong 147 khz "carriers" but they seem weaker and nighttime signals are audible through them. After only 5 days I have not even begun to discover the potential here so I am looking forward to this over the upcoming season. I do need to upgrade from the S-350 as this radio tends to overload and produce whistles and images across the band but don't know what my next radio will be at this point. Thanks Dave for putting up with this long missive.

KRSL AM 990 Heard in Finland

We at KRSL Russell Radio received a very cool email this week. KRSL AM 990 was heard in Finland by an AM radio enthusiast.

The following is an email from Hannu Niileksela (pictured) of Helsinki, Finland we received on September 5, 2016:

Hello Mike – and very warm greetings to you from Northern Finland – 200 miles beyond the Arctic Circle!

Would you ever have imagined that your station KRSL 990 AM might be heard as far away as in Finland, almost 5000 miles? In any case that is what seemed to happen one dark night back in February this year – provided that you can agree to the details of my reception...Let me take a moment of your precious time to explain in a bit more detail...

I am an enthusiast for distant AM radio reception, every now and then spending a week or two 200 miles north of the Arctic Circle here in Finland – with a hope for distant signals with my communications receiver and 3000-foot longwire antenna. And sometimes miracles happen!

Back in February I spent again 2 weeks "up there" with intensive listening. After returning back home here in Helsinki, I have gradually been "combing through" the vast amount of recordings created. In the early morning hours of February 28, 2016, between 1 and 1.30 am your time I had been monitoring 990 AM.

Over here, if something is heard from your direction on 990 AM, most often the Canadian Broadcasting Corporation station in Winnipeg, Manitoba is heard due to their northerly location and the fact that they have 50.000 watts of power.... But this time I heard bits and pieces of nice classic country songs pushing "through" every now and then, as well as some announcements, which I hope would be recognizable to you. The signal was truly weak and interfered, but twisting my ear, I'm hearing pieces like this:

1.17 am: a country tune ended and a male voice announced: "Eddie Arnold and "Make the world go away". It's Kevin Freeman, thank you for making us a part of your weekend...". In a while country music again, but too weak.

1.19 am: A male voice something like: "...KRSL...your source 24/7...local news, sports... ...call us 483-3121 or email comments at krsl.com...krsl.com..." followed by a "live" commercial for "Gregwire Drugstore" in downtown Russell.

1.20 am: "KRSL weather brought to you by ---"

1.28 am: After country music by Highway 101, announcement: "...I'm Kevin Freeman, thank you for making us part of your weekend..." followed by a Johnny Cash song.

1.32 am: Very weak, but I think the announcer says "Hometown Classic Country – KRSL". Then music again, but I lost the signal.

To give you an idea of how you sounded over here at its best, I am enclosing an mp3 recording. (*That recording can be heard below.*) I have recorded and repeated the end of the "Gregwire Drug Store" commercial and "KRSL weather brought to you by ---". I have repeated this 3 times...

However, you must listen to this with good speakers or headphones, since it is truly weak with interference and static atmospheric noise, as the signal has traveled truly far, a path close to the magnetic North Pole.

This place is Lemmenjoki, Finland. If you want so see exactly how far north I was listening, just Google "Lemmenjoki Finland".

Even if the recording is very weak, with good equipment you might well hear what I am describing above, and maybe even recognize the announcers personal voice. In case I am "right on target" with this tiny reception, thank you very much for extending your signal all the way over here.

Should you confirm back to me this being your station, it would definitely be one of my greatest success stories in this hobby!

NOAA Space Weather Outlook

Solar activity is expected to be at very low levels with a change for C-class flares throughout the period.

No proton events are expected at geosynchronous orbit.

The greater than 2 MeV electron flux at geosynchronous orbit is expected to reach very high levels on 02-05 Oct with high levels expected on 21-25, 29 Sep-01 Oct, and 06-11 Oct following solar wind enhancements associated with the influence of multiple coronal hole high speed streams. Electron flux is expected to be at normal or normal to moderate levels throughout the remainder of the period.

Geomagnetic field activity is likely to reach G2 (Moderate) geomagnetic storm levels on 28-30 Sep and G1 (Minor) storm levels on 19-20 Sep and 01 Oct due to the anticipated influence of multiple, recurrent coronal hole high speed streams. Active conditions are expected on 21 Sep and 02-05 Oct with generally quiet or quiet to unsettled conditions likely throughout the remainder of the period.

As an experiment, we will try to preview the uncompleted applications that are due to expire each quarter.

One new station CP – Sanger CA on 1040 kHz (U4 250/1000) will expire on December 3. The majority of new station CPs these days expire unbuilt, and with no call letters having been assigned this CP, it's likely that it will face the same fate.

There are 12 existing station CPs scheduled to expire during the fourth quarter of 2016. It's much easier to replace an expired CP for an existing station than it is for a new station, so the construction deadline is less of a "hard" deadline for existing stations.

Of some note are the two frequency change CPs. WNWF has been reported on its new frequency of 1140 kHz, but there's no indication on the FCC web site of a license to cover application being filed. And WOMN, which has mostly been silent since it lost its licensed site years ago, claimed in its latest STA extension request that it wanted to operate briefly so as not to be silent for more than a year, "pending anticipated completion of the three tower array authorized" by the CP. So perhaps these CPs will actually see some action in the coming weeks.
