Going to their website and stream, they are now "Boomer 102.5" with rock/pop oldies, still simulcast to the W273CW translator but with the ex-C&W format gone. Next best candidate is WHGS, Hampton, SC. (TLK-FL)

-- As reported by TLK-FL in DDXD-E 84-01, "Mexi-tunes while pointed N/S," my guess is WZHF Arlington, VA which broadcasts a Mexican format with the slogan Fiesta 1390. (BC-NH)

1650 WQQJ297 FL I-275 Tampa – 9/29 1036 – Compu-man, loop begins with "You are listening to the Florida Department of Transportation Highway Advisory Radio System, station WQQJ297 at 16-50 AM." Then generic construction zone warning. Loud and alone where the Sunshine Skyway HAR's on both ends should have been easily audible and a bridge in full view. Off? **(TLK-FL1)**

1570 WNCA NC Siler City – 9/23 2150 – Fair to very poor in station mix with sports talk, "...on 1570 WNCA Siler City" ToH ID, ads all mentioning Siler City. (PS-ON)

1580 WJFK MD Morningside – 9/25 1858 – Ads (Direct Tax, moisture control company), "CBS Sports Radio 1580" slogan, sports news, CBS Sports promo, CBS Sports radio IDs. Fair to very poor, fighting with CKDO. (PS-ON)

1590 WRXB FL St. Pete Beach – 9/29 1040 – Urban gospel, singing jingle ID. Mediocre signal barely five miles SW of the stick and with day pattern showing as thrown right at me and deep into the gulf. This could be fully nulled with WPSL, Port Saint Lucie then audible weakly. So, this is indeed on the air, but has to be running a couple of watts best, as never even the weakest trace at the house. Matches DXN 84-01 "AM Switch" column of "applies to extend STA, reduced power" status. (TLK-FL1)

1600 WTZQ NC Hendersonville -10/2 2057 – Fair with Kenny Rogers "Love Will Turn You Around," "Q95.3 FM and 1600 AM WTZQ Hendersonville, Ashville..." ID, "Want a great update for your home in Summer?" (ad for The Outlet on Kanuga Bend, 401 Kanuga Road). **(JK-WV)**

WAYC PA Bedford – 10/4 0759 – "WAYC Bedford" ID clearly popped out of the scrum! (JK-WV)

Unreported Domestic Stations



720 KDWN NV Las Vegas – 9/17 0814 – As XEJCC Juárez is fading out, something in English from E/W, talking about César Chávez and Harvey Milk; 0817 several ads to 0821 fading with toll-free numbers, starting with anti-IRS Tax Shield. Hard to see how this could be anything but KDWN; nothing else out there {besides Kauai . . .} on 720. Per web site, Jerry Doyle Show scheduled 0600-0900 Saturdays. I do occasionally hear them around sunrise here, always wondering if they are really on ND day pattern. (GH-OK)

730 CHMJ BC Vancouver – 10/1 0904 – "This is AM 730 Vancouver's traffic and information station," that slogan again at 0908 into bridge and tunnel report. 0909 "AM730.ca" into "AM 730 construction update." Totally covering XEHB. New logging. **(NJ-AZ)**

800 WSVS VA Crewe – 10/4 0623 – Poor; ad for Taylor Tires at 1414 ??? Avenue in Crewe. Time check, calls, no CKLW. (JJR-WI)

800 WDUX WI Waupaca – 9/27 0746 – C&W music; canned ID at 0747: "Classic Country AM 800 WDUX - we play the...?.." and into more music. Briefly fair but soon faded. A semi-rare 'W' call here. (**JW-CO**)

810 KSWV NM Santa Fe – 7/31 2215 – Romantic music in Spanish loops east-west, which rules out México and makes it very likely KSWV. Dominant signal making fast SAH with something, CO or MO? Segués 2216, 2220 with no announcements at all, but the final tune cut short at 2221 to dead air, 2223 off the air, or maybe cut from 5000 to 10 watts night power. FCC official July sunset was 2215; August 2200. (GH-OK)

810 WDMP WI Dodgeville – 9/23 0709 – Poor; C&W song & "D99.3" jingle. Not heard in a while. (JJR-WI)

880 WIJR IL Highland – 9/22 2244 – Ranchera music looping E/W, need to listen on LSB to avoid strong day-power cheating KHAC NM/AZ in English which is USB only (almost, some bleed over into LSB?). That leaves KRVN-NE on DSB which I can't null completely so still a lot of QRM for this one. Live DJ gives his cabina phone number; 2247 another announcement, 2250 fading down. 2302 fading up

a bit for music, 2304 time check I can't copy. From previous experience it is probably WIJR. (GH-OK)

890 KDXU UT St. George – 9/22 0818 – With KTLR OKC nulled, understation mentions southern Utah, USU, "here on KDXU," at sunrise here, so should still be on night pattern with a cardioid null toward Chicago. We are somewhat off that bearing, but still not getting much from KDXU unless it's really ND day pattern. (GH-OK)

910 WHSM WI Hayward – 9/23 0708 – Poor; "Lite Hits, 910 WHSM" after song. ?? tires, Hwy 63 S of Hayward. Alone. (JJR-WI)

930 KAPR AZ Douglas – 10/3 0831 – Spanish ID: "...todo en KAPR 930 AM transmitiendo desde Douglas ["DOOG-lahs"] Arizona con exitos de los 80's, 90's, y exitos de hoy" and into Mexican music. Been hearing this daily pre-sunrise, and definitely stronger than listed 71 watts night power. (JW-CO)

930 WBEN NY Buffalo – 10/2 0602 – Poor; "...at 1 o clock on WGR 550"; weather "WBEN" @:05. (JJR-WI)

930 WKY OK Oklahoma City – 9/18 08/52 – WKY's indominatable (indominable?) banda music is suffering IADs every few seconds (intermittent audio dropouts). No one aware at station? No one at station? (GH-OK)

930 KLUP TX Terrell Hills – 10/3 0759 – Legal ID at 6:59:50: "Stimulating talk - this is 930 AM The Answer....Salem Media Group KLUP Terrell Hills-San Antonio," News from TownHall.com at ToH was followed by local news and weather headlines. Fair peaks with fading. New here, TX #184. (JW-CO)

940 WYLD LA New Orleans – 9/17 2149 – Big dominant signal with no QRM. Bunch of ads, finally a local one for something in Gretna, and 2150 ID as "Amen 940 with fresh new music now!" Gospel music, that is. Both day and night lobes this way, but sure sounds more like 10,000 than 500 watts. (GH-OK)

960 KGWA OK Enid – 9/25 0115-0120+ – Local KGWA is in dead air, giving me a rare chance to null what's left of it and DX something else, but nothing identifiable in the jumble. KGWA used to provide an occasional "Fox-hole" during the news block 0100-0105, but not tonight nor any night caught in many months. So I dare not keep listening longer lest my ears be blasted with the volume way up, without a predictable restoration time like 0105 was. (GH-OK)

960 KLAD OR Klamath Falls – 10/2 0847 – ESPN programming; Legal ID at ToH: "KLAD Klamath Falls and K227CU Klamath Falls"; pregame coverage of the Jaguars-Colts NFL game from London followed. Chased this one for several days with tantalizing "mybasin.com" and "ESPN 93.3 and 960" non-ID's before getting LIDs on 9/30 and 10/2. No sign of closer KOVO in the same loop direction. A new catch here, OR #19. (JW-CO)

990 WCAZ IL Carthage – 10/3 0723 – Poor with farm commodities, RFD-Illinois, Illinois Ag weather. No calls and CBW nulled! (JJR-WI)

OK Oklahoma City – 9/17 2143 – KTOK OKC is in baseball, and it's Dodgers! Half a continent away from L.A., but with ad for CHLA.org and talking about Dodgers, but whence? Finally, "here in Phœnix." One week ago in Kansas City, KAZ asked me if KTOK carried Dodgers, as he was hoping he was getting one of the Californians on 1000. I thought KTOK unlikely, but there it is. Neil Kazaross replies, "Yep, I did some googling and OKC's minor league teams is the Dodgers affiliate so this may explain KTOK. 73 and thx KAZ PS hoping some TP audio can make it to you. 'It never occurred to me that there could be a Dodgers BB team other than the one in Los Angeles. (GH-OK)

1010 WHIN TN Gallatin – 10/5 0711 – Poor; detailed weather, obits "in Gallatin." CFRB nulled. (JJR-WI)

1020 KCKN NM Roswell – 10/2 0600 – Poor with KDKA nulled. LID, string of affiliates. (JJR-WI)
1050 KGTO OK Tulsa – 9/22 1621 – On car radio I finally get around to checking these out: I am not hearing any QRM, but there are two weak signals making a SAH of 6 to 7 Hz during music. I don't hear any echo so the two must be well-synchronized. 1638 a commercial for Walgreen's, no QRM and no echo. 1640 now there are conflicting commercials during local cutaway. Recheck at 1656 now one is in music and the other in talk, continuing past 1700, can't hear any IDs but obviously these are the two Okie stations near limits of groundwave. KGTO Tulsa, approx. 102 miles, is 1 kW non-directional; KXCA Lawton, approx. 125 miles, is 0.25 kW directional away from Tulsa. Both have negligible night powers, pace XEG. (GH-OK)

- TX Farwell 9/19 2131 Praise music in Spanish with slight edge over the CCI; 2134 as "KIJN, desde Farwell, Tejas testimonios, adoración," website and postal address, "y mil bendiciones." Call letters pronounced in Spanish. Not exactly a gringo accent, but not true Mexican accent either. So confirmed reactivated after almost two years. Is 10 kW daytimer, slightly directional circular pattern favoring the WNW, but plenty this way too. Guess what? Official FCC sunset for KIJN in September was 2100. Back to their old tricks; will carrier and/or modulation stay on all night? 1060+, 9/20 0158 Praise music in Spanish about a mujer, from WSW making fast SAH and I can tell this one is offset to the hi side of 1060; 0203 ID as "KIJN, 1060 AM, Farwell, Texas, donde el espíritu [vive?]." So just as I suspected when hearing it a few hours earlier but definitely after sunset, this 10 kW daytimer is once again running all-night. 9/21 0209 24 hours after last log, there KIJN is again, same fast SAH and praise music (GH-OK)
- **1070 WINA VA Charlottesville** 10/2 0605 Poor; CBS news, WINA Newsradio 1070 & 98.9 FM thru others. **(JJR-WI)**
- **1070 CHOK ON Sarnia** 10/3 0719 Poor, though WTSO not a factor today. "... presented by CHOK." (JJR-WI)
- **1250 KCFI IA Iowa Falls** 10/3 0711 Poor; sat through 2 songs and heard calls. Tight WSSP null. First heard here 2001. Rare! **(JJR-WI)**
- **1310 WTLC IN Indianapolis** 10/3 2039 Poor with WIBA tightly nulled. "AM 1310 the Light" (JJR-WI)
- **1310 KOKX IA Keokuk** 10/05 0000 Out of C&W, "KOKX 1310 Keokuk" fair under KFKA (WH-CO)
- **1340 KIKO AZ Apache Junction** 10/5 My local has been off the air most of the past three weeks, returned 10/5 with Spanish programming. **(NJ-AZ)**
- 1340 WXFN IN Muncie 9/27 2058 Station break during Cincinnati Reds game male announcer with "...on the Reds Radio Network" then different announcer "Fox Sports Radio heard on WXFN Muncie 1340 AM and W275AJ Muncie 102.9 FM." (RR-IL)
- **1370 KDTH IA Dubuque** 9/24 1936 Out of a jumbled mess jumps up a lady singing a jingle "...... KPTH" into nostalgic type music. Couldn't make out what she sang but it wasn't "the voice of the Tri-States" as listed in NRC AM Log #37 but very clear KPTH ID. **(RR-IL)**
- 1370 WLJW MI Cadillac 9/24 2026 Mixing with Indians-White Sox ball game on WSPD with religious talk and mentions of "northern Michigan." Presumed as no ID, but only other MI station on 1370 is WGHN from Grand Haven & that's not "northern Michigan," but Cadillac is. Plus NRC AM Log #37 lists WLJW format as religious. (RR-IL)
- **1370 KWRT MO Boonville** 10/2 1933 Poor; "1370 AM KWRT" between C&W songs. No usual WSPD. (JJR-WI)
- **1410 KLEM IA Le Mars** 10/05 0000 "This is 1410 KLEM Le Mars and 96.9 FM." New log & taped. **(WH-CO)**
- **1440 CKJR AB Wetaskiwin** 10/02 0659 "... Radio Station AM 1440 CKJR..." faded up in lull of KPUR & KMAJ. Call change ex-CJOI. Taped. (WH-CO)
- **1460** KHOJ MO St. Charles 9/28 0852 Local talk, phone number 314-752-7777. (FH-OK)
- **1470 KYYW TX Abilene** 10/1 2155 News, talk and ID "News talk" with call ID, over/under SS signals. **(JR-OK)**

KOKB Blackwell OK, while sibling 1020 KOKP Perry OK is sports-talking). Dominant signal on 1580, and 2128 recheck, preacher closing 'Our Daily Bread', 2129 ID like WBSS?, but that's wrong. Ad for used Mercedes-Benz; 2130 AM 1580 into 'Leading the Way with Dr. Michael Youssef'. Researching the likeliest, I soon come to KFCS Colorado Springs CO, and their schedule matches well enough in MDT: 6:00 Great Music of the Church Dr. Molly Snell; 7:00. Turning Point, David Jeremiah 7:30. Leading The Way with Michael Youssef, Ph.D. I previously tried the Leading The Way site, but find-a-station requires entering zip codes rather than just displaying a list of their "thousands" of outlets. (GH-OK)

- **1580 KGAF TX Gainesville** 10/2 2200 Oldies and ID "Hometown Radio." Brief good reception then signal was lost in a fade out. **(JR-OK)**
- **1600 KUSH OK Cushing** 9/25 1923 Local ad promoting use of natural gas in Oklahoma, call letter ID at 1938. New for me, but it should have been logged long ago. **(FH-OK)**
- 1670 KQMS CA Redding 9/28 0908 Local news, local ad, station promo "...KQMS streaming online..." Poor with KHPY. Ex-KNRO. New logging. (NJ-AZ) 9/29 0758 LID at 0758:53 by man: "KQMS Redding-Shasta Lake City, K289BT Anderson," followed by Fox news. Generally fair with some good peaks and occasional light QRM from KHPY. A needed call change, ex-KNRO. (JW-CO)

- 990 UNID -- 9/21 0822 Spanish station discussing some event in El Paso, with person on phone, but there is no El Paso/Juárez station on this frequency. Closest in Chihuahua, not very, is Cuauhtémoc, closest in USA is Artesia NM, not SS. XECL in Mexicali really gets out, so maybe this was it referring to a concert. Loops westward rather than southward, too late for XET Monterrey. (GH-OK)
- 1060 UNID -- 9/18 0808 "Buenos días" song, loops WSW, makes fast SAH with others, perhaps KIJN Farwell TX, which John Johnson, AZ, reports hearing again; had been off for a year or two, but before that was also significantly off-frequency. QRM from another SS talking at 0813. Probably getting both KIJN and KXPL El Paso TX, but no definite ID yet for either. Last time I logged any audio from KIJN was Oct 7, 2014. (GH-OK)
- 1420 UNID -- 9/25 2334 Local break sounds like "here on C-Q" and weather without local clues, back to financial advice show; best from E/W bearing? KJCK Junction City KS is talk, but WOC Davenport IA is too, and a regular here. I check the WTFDA FM Database for Davenport, anything with CQ in it?? Yes! KCQQ, 106.5, classic rock, as Q-106.5, and no FM duplicate for WOC is listed. Are these two related anyway? Yes! FCC Queries show KCQQ and WOC are both licensed to Citicasters. (GH-OK)
- **1500.5 UNID** -- 9/22 2237 The mystery whine is louder than I've ever heard it, really QRMing KSTP SBG, still loops east/west; harder to detect on lo side 1499.5. Thought to be somewhere around the New Madrid Fault multi-state area. **(GH-OK)**

Signal just after 1000 degraded to lower power and audio has been a bit scratchy since last evening. With power somewhat reduced, KZMP University Park, Texas, cochannel with Mexi-tunes. ZNS1 off the air shortly after Matthew's eye passed near, still off as of OCT 7 1030 check. [Krueger-FL]

- 1552.03 unID OCT 7 1000 Het against 1550 CBEF. [Conti-NH]
- MEXICO XERF *La Poderosa*, Cd. Acuña, Coah. OCT 3 0332 Coahuila en la Hora Nacional, first topic "inicio de rock y roll en Coahuila." Heavy interference de Missouri and plenty of other U.S. stations abolishing this as a clear channel. [Hauser-OK]
- ANGUILLA Caribbean Beacon, The Valley SEP 6 0100 Gene Scott preaching; over Bollywood Canadian. [Connelly-MA] OCT 3 0111 Religious talk by woman. Very good signal peaks throughout the evening. [Beu-TX]
- MEXICO XEUACH *R.Chapingo*, Chapingo, Edo.Mex. OCT 3 0112 Very good signal with regional folk music and "Radio Chapingo" ID's. Station plays a wide range of music you name it. [Beu-TX]
- 1660 **PUERTO RICO** WGIT Canovanas OCT 1 0551 Religious programming with talk by man. Good signal. [Beu-TX]

SOUTH KOREA HLAZ Jeju OCT 7 0900-1002 – Presumed this with talk at times barely breaking through 1560 WFME and 1570 WMVX splatter. Faded out with local receiver sunrise by 1050 recheck. [Conti-NH]

Transpacific carrier searches. SEP 25 1153-1215 – Japan/East Asia (loops northwest) 693, 774, 747, 882 kHz; Australia/New Zealand (loops west/southwest) 594, 612, 702, 828, 882 kHz. At 1209 UTC, 1098 kHz west, between the bearings of most of the others as fits for Marshall Islands; Majuro is 277 from here. Enid sunrise 1222 UTC. SEP 28 1211-1223 – Australia/New Zealand 594, 657, 675, 693, 702, 774, 828, 1548 kHz. Marshall Islands (west) 1098 kHz. Enid sunrise 1225 UTC. SEP 29 1212-1214 – Australia/New Zealand 594, 612, 702, 774, 828 kHz, and maybe Tahiti 738 kHz. SEP 30 1159-1221 – Australia/New Zealand 585, 594, 612, 702, 747, 774, 792, 882, 1035 kHz. Japan/East Asia 1557 kHz. OCT 3 1207-1223 – Australia/New Zealand 702, 774, 882, 891 kHz. 738 (southwest) likely Tahiti. I continue to detect these on the DX-398 with internal ferrite only. A complete 9-kHz bandscan (1 kHz offset with BFO) on the R75 with 100+ foot east/west longwire could not hear any of them. [Hauser-OK]

75 Years Ago – From the October 4, 1941 issue of *DX News*: 10 DX Tests were on October's calendar, from Venezuela, Colombia, Brazil, Canada, and the US. Fred Van Vorhees edited the SW column; countries heard included Mozambique, Philippines, and 'Aden Arabia.' Randolph Hunt provided a listed of DU MW stations; 10 kW was the max for all

AU stations. Similarly, NZ's cap was exceeded by only 2YA-570 at 50 kW.

50 Years Ago – From the October 15, 1966 issue of *DX News*: Ernest Cooper said veries were "hard to come by" (in 1966), but he added several to up his total to 3,526. Pittsburgh's Hanciko Brothers noted an Aurora and caught Radio Barbados-780 at 10 p.m.! Binghamton, NY's Tom Birch noted Montanan KXLF-1370 "in the clear" circa 1 a.m. He also logged 2YC-660 on his Hallicrafters SX-99/loop-33' doublet array. John Hoogerheide (OR) logged LV3-1210 Córdoba, Argentina for an hour!

25 Years Ago – From the October 14, 1991 issue of *DX News*: Canadian loggings in Domestic DX Digest East included CHYR-730 ON, CKLY-910 ON, CJCH-920 NS, CFOR-1570 ON, CFJR-830 ON, & CHOW-1470 ON, all of whom have moved to FM, as well as defunct CJMS-1280 QC (a rare 50 kw NA station so fated) & CJRP-1060 QC. Of this week's loggings, only CKNX-920-ON remains on AM. Ray Moore (MA) reported TPs on 738, 747, & 1620. Bahamian beacon ZLS-526 (500 w) reported in FL.

10 Years Ago – From the October 9, 2006 issue of *DX News*: New Brunswick, Canada's Neil Wolfish reported Gambia-648, Azores-693, Madeira-1125, Lesotho-1197, & Sao Tome-1530! Connelly (MA) & Conti (NH) heard Turkey-1062. Hawaii's Richard Wood drew a comparison of his Alaskan loggings 80s vs. 2005. Twenty-eight AKs logged in 1980s compared to only 4 in 2005! (I'd settle for one, Ed).

Geomagnetic field activity is expected to be at unsettled to active levels on 03-05 Oct, 16-18 Oct and 23-29 Oct. G1(Minor) field activity is possible on 17 Oct and 23-29 Oct with G2 (Moderate) activity possible on 24-26 Oct. This activity is due to the anticipated influence of multiple, recurrent CH HSSs. Generally quiet to unsettled conditions are expected throughout the remainder of the period.
