



I don't spend a lot of time doing this with only the DX-398 internal antenna, as I know I need more gain to succeed. Maybe if I ever get some signs of TP audio I will be motivated to get out of bed and fire up the NRD-545 and Wellbrook. [Hauser-OK]

FIJI: "The Project for the Rehabilitation of the Medium Wave Radio Broadcasting in the Republic of Fiji," a documentary video by the Fiji Broadcasting Corporation, covers construction of the new 10 kW transmitter site for 558 and 990 kHz and demolition of the old site. "The one thing that's really exciting about this is getting the whole coverage... we're talking about those who have not been able to get our AM frequency, or FM frequency," said Karalaini Koroi, Program Director, Gold. "So with this, even when you're traveling along the highway, when you reach a certain place where the FM signal drops, on the AM signal you're still able to hear us because it's that powerful." SLOVENIA: 918 R. Slovenija, Domzale was switched off September 4th, 2017 at 1205 local time. Here's the info I got from the engineer at Domzale: "It's true, yesterday at 12:05 locally we switched-off our central MW transmitter (918 kHz), mainly due to economical reasons. I'm afraid that it will stay switched off in the future, but - for now - in a stand-by mode (ready for transmission in a short time, if necessary). Our FM and DAB+ network is already sufficient for practically complete coverage of the country, plus there are other ways of delivering programme to our listeners abroad. This fact, relatively high costs of energy and maintenance, and diminishing audience of listeners on MW band led to the decision to cease with transmission on 918 kHz. That said, a few other MW transmitters will continue to operate - on location Beli Križ (549 and 1170 kHz) and Murska Sobota (558 and 648 kHz). These are transmitters with lower power output and smaller coverage, transmitting mainly radio programme for Italian and Hungarian minorities in Slovenia. Best Regards, Primož." With the most recent eclipse, my interest was not so much viewing, as DXing. Parked in the driveway with my back to the sun, first I found about 8 frequencies that are blank during the daytime: 850, 1200, 1220, 1270, 1500, 1510, 1580, 1590, and set car radio buttons for each. Though occasional photos taken like selfies out the window towards the sun over my shoulder never did show any sun blockage, those frequencies came alive around 1430. Most of my catches were stations that come in at sunset anyway, but it was interesting to hear them at this hour in the summer: WLBR-1270 Lebanon PA, WFED-1500 DC, WJFK-1580 Morningside MD, WHGT-1590 Maugansville MD. The latter is a fairly new station, having somehow replaced WCBG Chambersburg PA in the region (that station also often came in at sunset). No sign of WMIZ-1270 Vineland NJ, which is one of the few NJ stations I haven't heard. (And I see them listed in the unreported stations list so it's not just me). At times, there were 2 stations fighting on 1590, also 1540, 1500, 1510. By about 1515 there was still some enhanced conditions, but it was also very hot so called it a day at that point.

[8/29/2017] Been a couple of years since I last visited this column, so this one's overdue. Traveled to Tim & Jill Noonan's place in Oak Creek, Wisconsin on August 19th for the 24th Annual Madison-Milwaukee Get-Together for DXers and Radio Enthusiasts. I was part of a group of about a dozen DXers that were treated before the GTG to a tour of Entercom Milwaukee's WSSP-1250, WMYX-99.1 "99.1 The Mix", and WXSS 103.7 "Kiss FM" by group CE Chris Tarr. Some interesting observations made by Chris about the imminent merger of CBS Radio and Entercom, why young college grads in the engineering field aren't being educated about how AM ground systems work, and about the future of AM radio in general. One of my favorite parts of the day was a sunset visit to nearby Bender Park on the Lake Michigan shore with DXers Chris Kadlec and George Greene and spending about a hour doing FM bandscans. With Chris' car facing the lake and backed against a cliff that hindered (if not outright blocked) many FM signals from metro Milwaukee making it to where we were, lots of FMs from the other side of the lake (Grand Rapids, Kalamazoo, Battle Creek, Michigan City, South Bend) were heard. Already looking forward to next year's Silver Year GTG in Madison, which has some special meaning to me as I was part of the original "Gang of 9" that attended the first GTG in 1994. I also attended Madison-Milwaukee GTGs in 1997, 1998, 2000, 2011, 2014, and 2015. Took a recent inventory of my MW DXing exploits over the years from various QTHs in the Midwest. My tallies are as follows -- from Iowa City, Iowa (10/26/1985-9/18/2013): 1375 domestics, 1430 overall (both numbers are estimates, but both are within 5 stations, give or take, of being on the money); from Spirit Lake, Iowa (5/20/1995-7/31/1996): 596 domestics; from Lafayette, Indiana (8/1/1996-8/1/1997): 150 domestics (estimated, but that's pretty close to being correct); from South Omaha, Nebraska (9/13/2010-present): 951 domestics, 1001 overall; from Davenport, Iowa (5/12/2014-present): 306 domestics, 313 overall. Many of you who've been in the NRC for a number of years will recall that my best success as a MW DXer came from Iowa City in the early and late 1990s, and the numbers above for that location bear that out. The best QTH, however, in terms of lack of interference from semi-local stations (since the 3 closest locals - all 5 kw or under - were 9-19 miles away!), was unquestionably Spirit Lake, Iowa. Had I spent more time there than just the 14+ months during which I was a resident, I surely would have topped 1000 by the spring of 1997 and could have reached 1500 with just a couple more years of DXing beyond that. The Iowa City and Spirit Lake logbooks are now retired, but the Davenport/Quad Cities logbook remains active, as I leave open the option of perhaps relocating there sometime before the end of 2019. 73, and see you all somewhere down the road.

DXing During the Solar Eclipse from Lake Wallowa, Oregon Karl D. Forth, koolmotor@comcast.net

While most people were focused on the sky during the August 21, 2017 solar eclipse, I was after a new experience: BCB-DXing during an eclipse.

My wife and I were on a weeklong road trip to Idaho, Montana and eastern Oregon. We listened from Wallowa Lake State Park in northeastern Oregon, at the southern end of Wallowa Lake. We set up on a picnic table in the state park, using only a Sangean DT-200VX radio, small clock, and eclipse glasses. There were some people nearby, but not the large crowds and traffic that had been forecast for Baker City, father south. Lake Wallowa is in a valley with mountains on most sides, and limited groundwave signals. A few general observations:

Most skywave was observed about 20 minutes before and after the maximum of the eclipse (10:27 a.m. PDT, or 1327 EDT) At 1350 the skywave had noticeably decreased.

We noticed stronger signals from some of the stations that could be heard weakly before the eclipse, especially within 200 miles or so, but not a large amount of other skywave signals. Groundwave was limited mostly to Spokane and Lewiston signals, a few other Washington and Idaho stations, and few Oregon stations.

The only local station was KWVR-1340 Enterprise, Oregon.

The five other graveyard frequencies all had some activity. We heard one or two weaker signals on each graveyard frequency. The strongest was KRPL-1400 Moscow, Idaho, heard with ESPN ID 8/21 1256 with possible local ID, heard again 1337 with ESPN programming. This was the only GY signal that was readable during the eclipse.

On the regional frequencies, we noticed stronger signals from the nearby stations, but not more distant signals. For example, KKOO-1380 in Ontario, Oregon, was a station audible on groundwave, but enhanced and fairly strong at the eclipse peak. Many of the regional and clear channels had no readable signal during the 45 minutes of eclipse enhancement.

I was interested in hearing signals as far away as possible, so much of the limited time was spent in trying for the northwestern U.S. clear channels. KFBK-1530 and KSL-1160 were the farthest I was able to receive. Two others that I tried for but were not heard were KKOH-780 (420 miles) and KTWO-1030 (570 miles).

750 KERR MT Polson 8/21 1315 weak with vocal C&W music, looping NE and heard at the same time as KOFI. Presumed.

1000 KOMO WA Seattle 8/21 1318 presumed with ABC news coverage of solar eclipse, poor-fair.

1160 KSL UT Salt Lake City presumed 8/21 1335 fair signal with eclipse coverage, may have been network program. This was the second-farthest signal (410 miles) received.

1180 KOFI MT Kalispell 8/21 1309 fair signal with Vanity Fair, 70s music, KERR-750 heard at the same time, also heard 1340 with AM-FM ID, Bread and 70s mx.

1190 KEX OR Portland 8/21 1321 fair-good with local reports from several western Oregon locations about the eclipse, then Mark Steyn on Rush Limbaugh program.

1530 KFBK CA Sacramento 8/21 1338 Presumed good signal for a few minutes with Rush Limbaugh program with Mark Steyn. This was the farthest signal (515 miles) received during the eclipse.

An interesting article, and it helps to answer (to an extent) what I thought AM might sound like at the height of the eclipse. One thing I had wondered about was the fact that all stations along the affected path will obviously be on day power while being heard, and if the regional channels would wind up sounding like a cacophony of signals stepping all over each other as a result. Doesn't sound like that will happen. I will be in Iowa City, Iowa on the day of the eclipse, where the sun will be 92% obscured at the eclipse's peak. I'm still pondering whether to spend that entire time DX'ing AM or spending it chasing beacons on LW, just to see how many 25-watters from mid-Missouri and southern Illinois will be able to make it up there at 1:00 in the afternoon.

One interesting thing about the article: the photo of the shadow of the moon on the Earth during the August 11, 1999 eclipse in Europe. It was an interesting 24 hours on Earth in regards to cosmic and meteorological happenings. The eclipse peaked at 1100 UTC in Europe. Roughly 7 hours later, a tornado rated F-2 struck downtown Salt Lake City, a place where tornadoes are virtually unknown. And, of course, the Perseid meteor shower peaked in the wee hours of August 12th. The tornado was Art Bell's lead story during his open on that evening's edition of "Coast To Coast AM" which I listened to on a farm road about 15 miles east of Iowa City while watching the Perseid.

We were at about 96% magnitude here in the Springfield area, and for about 15-20 minutes either side of the local 1:13 p.m. maximum. I did a manual bandscan (no SDR) and found conditions to be similar to what I'd get maybe an hour or two before LSS in November or December. Most all the skip reception seemed to be from the north, to about 300 or so miles out – stations I otherwise don't normally hear in daytime conditions. Strongest were things like WHO-1040, KFAB-1110, KTIC-840 West Point NE, and Chicagoland stations like WLS-890, WMVP-1000, and WVON-1690. Also KMOX-1120, normally very poor down here in SW MO during the day, was doing well. Certainly nothing "exotic," but interesting at 1 or 1:30 p.m. in late August. I took the day off to DX the eclipse and peak darkness here (about 85% so not really dark) was about 1:20 pm CDT. Things were late developing as even 1 pm ID time was worthless, unfortunately. But by 1:10 things started hopping especially the high end. I used my Perseus and South DKAZ noting cx were likely still somewhat AU and noting the long path of totality to my south. At about 1:10 1700 had KKLF's SS mx in nicely, but 25 minutes later it was WEUP all alone. By 2 pm ID time, I recorded but think almost anything DX worthy had faded away. I needed this eclipse to be half an hour earlier or later for hourly ID's. I have much to go over as I recorded the entire band for a long time. Only things of merit 100% ID when listening live were WKJV NC loud and WZYX TN, but I had Carolina mentions on other channels and plenty of southern accents. 73 KAZ Barrington IL with a lot of playback ahead

In this area the eclipse maximum was approximately 65% around 2:50 p.m. EDT / 1850 UTC. The visual difference versus full daylight was just slight. I made MW Perseus captures of 2 to 4 min. duration at 15 minute intervals between 2 and 4 p.m. EDT (1800-2000 UTC). Antenna was a cardioid pattern SuperLoop with maximum gain south, -5 dB relative to forward (approx.) west and east, and -15 dB approx. north. Captures other than 2:30, 2:45, and 3 p.m. EDT (1830, 1845, 1900 UTC) show little evidence of skip effects. On the 1830, 1845, and 1900 UTC captures, the following were noted. The catches are mostly short skip rather than long haul items from the totality zone far south of here.

1660 and 1680 NJ, 1650 VA, 1690 MD, and 1700 NY better than typically weak groundwave.

1600 WWRL NY beating up WUNR MA; usually it's under.

1560 WFME NY much better than its typically weak groundwave.

1550 WSDK CT skip blowing out WNTN MA groundwave.

1540 graveyard like jumble rather than usual WXEX NH over WADK RI.

1530 "stuff" occasionally under WVBF MA ... WOBX NC?

1520 WIZZ MA good, obviously skip as groundwave is typically nil to mush.

1500 WFIF CT much better than usually weak groundwave level. WFED DC under.

1410 WPOP CT skip over groundwave WZBR MA / WHTG NJ.

1400 blob of stations before reverting to normal WOND NJ / WGIN ME blend.

1360 WDRC CT about even with usually-alone WLYN MA groundwave.

1350 WINY CT at much-better-than-groundwave. Bit of background growl probably WGPL VA which could be groundwave or skip.

1310 WICH CT fading up to loud and then down into jumble, so obviously some skip there.

1210 WPHT PA occasionally 5-10 dB better than its typically weak groundwave. Much like winter midday.

1050 "Stuff" under WEPN NY probably WVXX VA.

Little of note below 1050 kHz. Other observation: 830 WCRN MA seemingly off air at all times checked. Threshold level 830 carrier probably WEEU PA. Mark Connelly, WA1ION South Yarmouth, Cape Cod, MA.

This is EXTREMELY preliminary. I have recordings of the entire band (plus LW and the 160meter ham band) running for several hours. It sounds like maybe 30-45 minutes will be worth reviewing. The improvement surrounding totality is dramatic. I used a SDRPlay RSP1, connected to a 160-meter dipole. (center-fed antenna 264'/80m long, center about 20m/65' high) I recorded DC to 2MHz from 1645z (11:45am CT) to 2000z (3pm CT). For software, I used HDSDR to record (because it has a good scheduler. I work for a TV station which planned extensive eclipse coverage; staying home from work was not going to be an option.). I used Microsoft Remote Desktop to connect to the computer at home from my laptop at work 25 miles away. Strictly to verify the recording was working, although I did also sample the audio and take a few screengrabs of the waterfall display. I didn't listen during peak conditions - we had eclipse glasses & there was no way I was going to be indoors during totality. :) For playback I'm using SDRUno. There's no scheduler but Uno makes it much easier to jump around the recordings in the time domain. (to jump to totality, or to jump back a few seconds if one just barely misses an ID). I've not (yet) encountered anything drastically distant on the BCB, but I'm hearing a bunch of stuff I ordinarily only hear at night or on SSS/SRS. I did hear London, Ontario (VE3CSK) on the 160-meter ham band; he was talking to WD5R near Little Rock which is a pretty good haul for summer broad daylight on 1800KHz! My location is 25 miles/40km northwest of Nashville.

BCB catches so far: WXLW-950 Indianapolis, KWAM-990 Memphis (vs. local 980), WCRV-640 Memphis (vs. local 650 WSM), WIRL-1290 Peoria, WMBD-1470 Peoria, KSIV-1320 Clayton (St. Louis), KCJJ-1630 Iowa City.

Again, I have recordings and will certainly be pulling more stuff out of here. The X-band is normally empty at this site, except for a very weak signal from Huntsville, Alabama (1700) and weak but readable signals from the Tennessee DOT TIS stations on 1680 in Nashville. During totality, the band essentially filled -- no CHHA 1610 (the only full-power station on the frequency) but every other channel was full, usually with strong signals. Remember On A Clear Day You Can Hear Forever

August 2017 Rockwork 4 Ocean Cliff DXpedition

Perfect Weather Combines with Breakthrough Propagation By Gary DeBock, Puyallup WA, USA September 2017

Introduction: Once in a great while everything seems to fall perfectly into place! After 12 Medium Wave DXpeditions to the sheer ocean side cliff near Manzanita, Oregon we had

experienced everything from dicey weather, touchand-go propagation and even turf claims by "sleeping squatters" as we set up our antennas in the predawn darkness. Despite the challenges we had established Rockwork 4 as the premier west coast location for chasing New Zealand MW-DX, even to the extent that the site had gained the nickname of the "Kiwi Cliff." But I was personally convinced that the location had far more to offer – and it was certainly going to prove it in a major way this time.



From August 1-9 an all-out effort was made to chase South Pacific DX at the sheer cliff, along with my DXpedition partners Tom Rothlisberger (from August 2-7) and Chuck Hutton (from August 1-3). Despite the ocean cliff's reputation as a magnet for dicey weather all 9 days were free of any rain, and practically free of wind. During each predawn antenna setup session we were treated to dazzling displays of the Milky Way galaxy in the skies above our DXing venue. This was far and away the most favorable weather any of us had ever experienced at this highly exposed site, and it almost seemed bizarre in comparison to the vicious wind and rain that pounded the Japanese visitors as we welcomed them in last year's July 2016 DXpedition.

My own DXpedition started with an overnight drive in from Puyallup, Washington in the early



morning of August 1st, during which the largest collection of ferrite this side of the Ukraine rolled over the Columbia River bridge at the bizarre hour of 0200 local time. My Toyota Corolla was absolutely crammed with 5 very large FSL (ferrite sleeve loop) antennas, a creation of the U.K.'s Graham Maynard introduced in 2011 (which has probably provided early retirement options for the Ukrainian ferrite sellers on eBay). After arriving at the wild ocean cliff site at 1020 UTC (0320 local time) I set up the first FSL antenna to chase 1017-Tonga – which was very cooperative. As daybreak approached Chuck drove up, and we proceeded to check out the MW propagation on

other frequencies. The very rare 2 kW Kiwi station 531-More FM (which has never been heard anywhere on the west coast except here) was pounding in at the strongest level I had ever heard, pretty much setting the tone for the propagation that we would experience for the rest of the week. Tom joined us on the next day, and participated in the Australian propagation bonanza on August

4th (during which we tracked down two Western Australia stations at over 9,000 miles, or 14,000 km).

Overall this August 2017 DXpedition has been far and away the most productive Rockwork 4 trip ever, with the two Western Australians (531-6DL and 558-6WA) received at decent levels, five stations received on 531 kHz alone (PI, More FM, 2PM, 4KZ and 6DL), 558-Fiji completely restored and reaching S9 levels, an S9 recording of 585-2WEB (confirmed by David Sharp), the best-ever signals from the Kiwis on 531 (More FM), 603, 657, 765, 936 and 1503, monster signals from 585-7RN and 639-5CK, multiple receptions of 1017-Tonga, etc. Even when we needed to dodge the "sleeping squatters" it was a lot of fun to share the cliff with my DXpedition partners Tom and Chuck, especially during the phenomenal August 4th session (when Tom and I both made out like bandits). I'm sure that both of us will remember that wild and wacky session for years to come!

All of these and the other South Pacific loggings below were received with Ultralight radios and huge "airport unfriendly" FSL antennas (guaranteed to cause security alerts at any TSA screening checkpoint). Signals which reached an S9 level are listed with a double asterisk (**). Special thanks is in order for Theo Donnelly, Andrew Brade, James Niven, Todd Emslie, Bill Whitacre, David Sharp, Walt Salmaniw and any others who assisted in the identification of the following stations (and especially to my DXpedition partner Tom Rothlisberger, who researched parallel stations for the two Western Australia loggings). You guys rock!

AUSTRALIA 2PM, Kempsey, 5 kW. Good signal at 1242 on 8/8 with call-in talk format and mentions of SRN member station 2LM at :11 and 1:11 into the recording (thanks to Andrew Brade for listening). https://app.box.com/s/jztickg7d207ykg2re1c9jtvtjokznf5

One of the most amazing signals of the entire DXpedition, this rock music pounded in at an S9 level at 1335 on 8/8, soon after propagation had collapsed to most stations.  - **NEW ZEALAND** Star Timaru/Wanganui, 5 kW/2kW. Although the low powered Kiwi network was occasionally competitive with the Oz big gun 3WV, it rarely dominated the frequency.  - ** NEW ZEALAND Radio Waatea, Manukau, 5 kW. Significantly stronger than in recent years (throughout the week), this Maori network powerhouse managed its best signal ever at 1303 on 8/8 with island music and Maori chants.

- 702** **AUSTRALIA** 2BL, Sydney, 50 kW. The Oz LR network big gun usually had the edge over the Kiwi big gun Magic, such as during this ABC talk program at 1310 on 8/8. https://app.box.com/s/ur43ihfmgka0d1p6bupbhch9ixc1nvrv
 - ** NEW ZEALAND Magic, Auckland, 10 kW. - NEW ZEALAND Radio Kahungunu, Napier-Hastings, 2.5 kW. Although generally an underperformer throughout the week, freakishly good Kiwi propagation at 1258 on 8/4 propelled this Maori net 2.5 kW wonder to an overwhelming level with R&B music and a Maori net ID at the 1300 TOH (at 1:36 into the MP3). This meltdown-level recording was the strongest ever heard during 15 DXpeditions over 6 years https://app.box.com/s/qvu2atw8b22qvi8xwkgp95riigd5mlca. Another potent signal at 1258 on 8/5 features lots of Maori-accented Kiwi English.

 - TONGA A3Z, Nuku'alofa, 10 kW. Another major target of the DXpedition, this island station cooperated with decent signals most of the time, but its sign off times were all over the map.
