- 1110 WMBI IL **Chicago** – 12/24 0900 – ToH ID in Spanish followed by light Christian music sung by woman. (NjW-ON)
- KFAB NE **Omaha** – 12/26 0810 – Wiping out WBT with "7:10 on News Radio KFAB" ID into talk about Nebraska's football recruiting class of 2019. (MKB-ON)



- 1120 WUST DC **Washington** – 12/3 1637 – Spanish talk, actually yelling, mixed with WBNW, WPRX (with SS music) and WKAJ (with C&W), new here. (TF-NH)
- 1160 WVNJ NJ **Oakland** – 12/18 0439 – "Celebrate Christmas for who and what it was always intended to be" then "wishing you a blessed Advent, this is Relevant Radio" by woman at 0442. Lots of static and fading. (GL-NH)
- 1200 WTLA NY **North Syracuse** – 11/26 2158 – Local ads for a car dealership, a sub shop, and Mastro's Restaurant in Syracuse, promo for football, into Tennessee v. Houston Monday night football. Way over WXKS, CFGO, new for me. (TF-NH)
- 1230 WGUY ME **Veazie** – 11/26 1620 – Way atop frequency with old rock music, "This is the legend, WGUY – I'm Michael O'Hara", into more rock oldies, an almost night regular, incredible for 640 watts from a site 200 miles from me. WGUY was once a 5000 watt daytime station on 1250 in Bangor, was the sister station for WGAN-560 in Portland with CBS feed, before going dark in the 1960's, I believe. It was one of Maine's first radio stations, was owned by Guy Gannett Publishing, which also owned four daily newspapers in Maine. Before going silent, the old WGUY got permission for 5000 watts at night, moved its operation to a two tower antenna system across the Penobscot River in Brewer, went full time and then went silent. (TF-NH)
- WCMC NJ **Wildwood** – 12/18 1707 – Caught slogan "We're South Jersey's station for Classic Oldies, AM 1230 and 1340..." into 1950s oldie before fading into graveyard mush. (MKB-ON)
- WENY NY **Elmira** – 12/21 1703 – Out of mush with "...and now back to Frankly Speaking on News Talk 1230 and 1450 WENY". (MKB-ON)
- 1280 WHTK NY **Rochester** – 12/20 1627 – In strong with Padillo's Fitness Gear ad, Palmer's ad: "900 Jefferson Road, Henrietta", then "Fox Sports 1280" slogan. Faded at 1629. (GL-NH)
- 1290 WWTX DE **Wilmington** – 12/20 1630 – "We power Delaware" and "WWTX" by man popped out of slop and immediately disappeared. (GL-NH)
- WNBF NY **Binghamton** – 12/4 1622 – Sean Hannity Show, over/under Howie Carr on WKBK. Not noted here before, maybe should pay more attention to 1290! (TF-NH)
- WHIO OH **Dayton** – 12/20 1802 – Creaming usual CJBK with "WHIO Triple Team traffic", "WHIO news time is 6:02" into local news. (MKB-ON)
- 1300 KGLO IA **Mason City** – 12/26 0859 – Local weather forecast and ID in the Tim Fleming Morning Show. Mixing with UNID religious station (presumably WNQM in Nashville). No sign of usual WOOD-Grand Rapids. (NjW-ON)
- 1310 WRVP NY **Mount Kisco** – 12/3 1625 – Atop with Spanish Christmas music, same as on 1330-WWRV, lost at 1630 with power drop to 33 watts. Also noted 12/14 1604 with Spanish preacher, same as on more audible WWRV. (TF-NH)
- 1330 WKTA IL **Evanston** – 12/24 0900 – ToH ID: "AM 1330 WKTA Evanston-Northbrook-Chicago and FM 95.9 W240DE Evanston". (NjW-ON)
- WBGW IN **Evansville** – 12/24 0700 – ToH ID: "this is 13-30 WBGW Evansville – the finest in Christian Bible teaching and preaching..." into gospel show. (NjW-ON)
- 1340 WTRC IN **Elkhart** – 12/25 0800 – ToH ID: "WTRC Elkhart, your music, your memories, 1340 AM and 101 point 9 FM". (NjW-ON)
- 1350 WINY CT **Putnam** – 12/17 0702 – Woman with news, local weather (rain/snow showers, temps 40-45), ad for Premiere Chevrolet, man interviewing woman who says "we moved to Putnam in..." Interview with a funeral home owner, then "making your mark in Northeast Connecticut" by man. Lots of fading. (GL-NH)
- +++ - 12/23 0720 – Over all comers with "WINY Putnam...happy holidays" jingle into sappy version of White Christmas. (MKB-ON)
- KRNT IA **Des Moines** – 12/26 0900 – ToH ID that mentions FM 102.1 and usual ESPN stuff. (NjW-ON)
- WOYK PA **York** – 12/22 1300 – Fair mid-day signal with promo for Washington Capitals hockey on "Sports Radio 1350 WOYK". Tis the season for daytime skip. (MKB-ON)
- 1360 WYOS NY **Binghamton** – 12/14 1620 – Sports talk, nice ID at 1625 for "AM 13 60 Sports Radio, WYOS", mixed of course with WDRC and WTOC. (TF-NH)



- 1370 WJIP NY **Ellenville** – 12/11 1633 – "I'm George Morris with news on 1450 and 1370, WKIP" briefly atop frequency. WKIP-1450 in Poughkeepsie is simulcast by Ellenville's WJIP. George Morris and others sit in a studio somewhere and tape local news, often day old stories, before feeding it to a bunch of iHeart stations including WGIR-610 in Manchester, WTAG-580, WELI-960, WHJJ-920, and probably others. Talk about being cheap! Often the names of local towns and geographical features are amusingly mispronounced by this low budget news delivery from a remote point. **(TF-NH)**
- WCCN WI **Neillsville** – 12/24 0858 – Man reading scores from the NFL games that took place on Sunday (including the Green Bay Packers game), followed by ID: "this is your home for American classics, 1370 AM WCCN Neillsville" and then a MYL-ish instrumental cover of "Jingle Bell Rock". **(NjW-ON)**
- 1380 WABH NY **Bath** – 12/28 0701 – Over usual CKPC C&W with "The greatest country hits of all time...WABH Bath" ToH ID into CBS news. Fairly recent format flip from sports. **(MKB-ON)**
- WKDM NY **New York** – 11/30 1615 – Spanish music over/under usual WNRI, unusual as the very directional signal from the multi-tower antenna farm next to New Jersey Transit's Met Life Stadium rail line goes out across Long Island and into the Atlantic. **(TF-NH)**
- WKJV NC **Asheville** – 12/21 0215 – Atop the channel playing quiet Christmas Carols like you would find in a church. Between carols, listeners were wished a Merry Christmas from WKJW-1010 and/or WKJV-1380. **(JF-NJ)**
- 1390 WEOK NY **Poughkeepsie** – 12/14 1557 – Spanish music at local strength, nice ID for WEOK and a couple of FM repeaters, including one in Middletown at 1600 by a very good announcer, into more Spanish music. **(TF-NH)**
- WRIV NY **Riverhead** – 11/30 1642 – Distinct ID for WRIV by male announcer and some nostalgic stuff (this tiny station's format) emerging from the mush. First time heard here! WRIV is where my late friend Jim Guthrie, for a while an NRC member, got his broadcasting career start. **(TF-NH)**
- 1400 WDTK MI **Detroit** – 12/24 0733 – Drop-in ID by Mike Gallagher: "FM 101.5 and AM 1400, the Patriot" into some Salem talk programming. **(NjW-ON)**
- WSAM MI **Saginaw** – 12/10 2110 – Surfacing briefly with "104 FM, The Bay" slogan. **(HJH-PA)**
- WDUZ WI **Green Bay** – 12/20 0759 – ID: "Fan Nation Fan Morning Show on Sports Radio 107.5 and 1400, the Fan". **(NjW-ON)**
- 1410 WHLN KY **Harlan** – 12/23 0608 – In fairly well around this time with clear ID. Partial ID around 0600. Current pop music after the hour with Nat King Cole "Adeste Fideles" after ID at 0622. **(JW-PA)**
- 1440 WNYG NY **Medford** – 12/11 1620 – Heard preacher yelling in Spanish for two minutes under WVEI and others, soon was gone, only station with that format on 1440 within hundreds of miles, new for me. **(TF-NH)**
- WAJR WV **Morgantown** – 12/23 1727 – Fair at times with ads for Pizza Hut, WV Natural Gas Association and Morgantown Printing. **(HJH-PA)**
- 1470 WSAN PA **Allentown** – 11/26 2020 – Nice steady signal with Monday night football in Spanish, with a little mix from WLAM. **(TF-NH)**
- WLMC SC **Georgetown** – 12/18 1900 – Good with slow fades. "True Oldies" format. Had mix of oldies and Christmas music at this time. Full ID at ToH with mention of 101.1 FM and Georgetown and another area, "... Island". **(HJH-PA)**
- 1490 WMRN IN **Marion** – 12/25 0800 – Call letter ID heard in the graveyard jumble. **(NjW-ON)**
- 1530 WVBF MA **Middleborough Center** – 11/26 1629* – Discussion about marijuana and the history of the New Haven Railroad (do the two mix?) followed by sign-off filled with odd comments about the sound of excellence, listening to the station on cable, and tipping your waiter, followed by announcing that the station is signing its local programming off for the night and "This is WVBF, 1530 AM, the Voice of Middleborough-Taunton" and gone. Also noted 11/30 1625 with discussion of historical events, celebrity birthday announcements, mostly by an older male who referred to his female partner as a "sweet young thing," and added all kind of corny and inappropriate comments. He then announced the sign-off of live programming (mercifully!), telling listeners to put "your cable straight up, tip your waiter, and tune in tomorrow. This is WVBF, the Voice of the greater Taunton area" and the power was dropped from 5000 watts to four watts. Most bizarre sign-off and announcer that I have heard in quite a while! **(TF-NH)**

- 1570 WUBG MA Methuen** – 12/18 0359 – Nice ID at this time with call sign and slogan "the biggest hits of the 60s and 70s". Then into news. "Uncle Albert" by Paul McCartney at 0408; confirmed by internet check. (JW-PA)
- 1590 WCSL NC Cherryville** – 12/15 0503 – Very nice full ID: "1590 and 93.5 WCSL Cherryville Gastonia" then an ad for Pine Mountain Golf Course. Blasting in with "Red Necks, White Socks and Blue Ribbon Beer" by Johnny Russell at 0515. Call to station confirmed night time power; freakishly loud this AM. (JW-PA)
- WKTP TN Jonesborough** – 12/17 0436 – ESPN Radio coming in periodically from 0400. A few stations, including WAKR, on top of a rolling sea of undifferentiated RF. Finally a Tri-Cities ID at 0458. (JW-PA)
- 1700 WEUP AL Huntsville** – 12/24 0710 – over sports talker with "right here...on your WEUP" station promo into urban gospel. (MKB-ON)
- WJCC FL Miami Springs** – 12/27 1658 – Good, alone on channel with infomercial for home restoration company translated from English to unknown language after each couple of sentences. Two call letter IDs at 1701. Heard on car radio at local supermarket. (MD-MA)

- 1380 WMJR KY Nicholasville – 12/19 0758 – Poor, with “Relevant Radio a pp. . . .”. LID and newscast. With others. NEW! (JJR-WI)
- 1380 KAGE MN Winona – 12/20 0728 – Poor, with “Real Country Kay-Gee 1380 & 101.5 FM” after Charlie Rich song. No usual WOTE. (JJR-WI)
- 1380 WKJV NC Asheville – 12/18 0741 – Poor, with calls and religious songs. In/out, not steady. (JJR-WI)

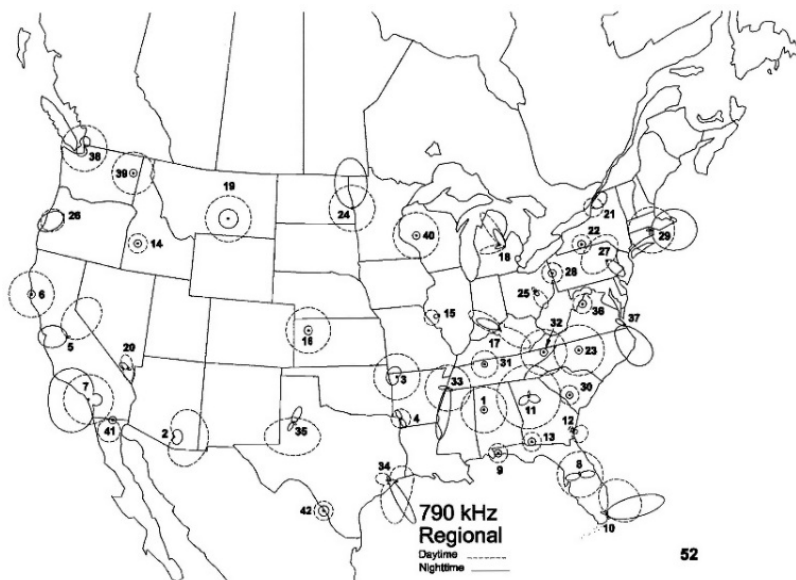

- 1350 WCMP MN Pine City – 12/2 2104** – Over/under WPDR with liner: “The only place to find live local sports . . . 106.5 . . .”, then into Aerosmith's version of 'Come Together'. Heard a slogan ID 'Pine Hits 106' after the song, which is what Todd Skaine informed me WCMP uses for an ID. [Rick, that's what the **AM Log** says is the slogan – Ed.] Finally cleans up Minnesota on 1350 for me in the Iowa City logbook, after all these years. (RD-IA2)

- 800 **BONAIRE** PJB *TransWorld Radio*, Kralendijk NOV 12 2300 – Man (Bill Early) in English with "7 o'clock Atlantic Standard Time" and mention of "TransWorld Radio Bonaire here in the Caribbean Netherlands"; good.{A} [Connelly-MA]
- 820 **MEXICO** XEBA *La Consentida*, Guadalajara, Jal. DEC 23 0601 – Under XEABCA with uptempo adult choral version of Mexican anthem, "Consentida" slogans. Relog. [Hall-CA]

- 850 **ALASKA** KICY Nome DEC 17 0703 – Tentative. Faded up under KOA (which is barely audible on the south/southeast-north/northwest antenna) after XEMIA faded out. Man who sounded like a pastor gave the history of "Away in a Manger" then played the song. This was almost surely KICY running the "Songs in the Night" program from Moody Radio. Nome is almost exactly on the main beam of this antenna (332° vs. 341° antenna angle) and half of it is water path. KHHO is conservative talk and sports, so have to think this was needed KICY. I have sent an email to Moody Radio inquiring about the content of "Songs in the Night" that weekend, to see if it matches what I heard. [Hall-CA]
- 880 **MEXICO** XEAAA *R.Mujer 92.7 FM*, Guadalajara, Jal. DEC 17 0600 – High choral version of Mexican anthem, under KKMC and KCMX. This is the last Mexican station left on 880 AM (at least until the CP for XECHEP Chihuahua comes on). Formats have been swapped between the 880 and 1040 stations, presumably because XEAAA has an FM but XEBBB does not (i.e., they moved the leased Catholic programming to the station which didn't get an FM allocation). Relog. [Hall-CA]
- 900 **MEXICO** unID DEC 23 0602 – While XEW was playing the national anthem, another station faded up with a male announcer in Spanish. He seemed to mention "su estación" and XH call sign before an ill-timed fade. This would almost have to be needed XEOK, but I heard nothing that sounded like *R.Disney* programming or their main slogan "La radio que te escucha." They also did not run a Mexican anthem. [Hall-CA]
- 910 **COLOMBIA** HJMY, RCN, San Andrés, Islas San Andrés y Providencia DEC 18 1058 – Presumed the one, being the only RCN listed on 910 kHz and from the DF. Orchestral morphing into choral Colombian national anthem from 1058 while sitting on the frequency, then male, "Noticias en RCN Radio..." and fade into mix of domestics and Cuban stations. Pointed the same bearing as Nicaraguans on (nominal) 540 and 720 kHz. Listed as 30 kW, though I would be surprised if it's really that these days for such a small geography and never having heard from here before. First time log for this one, save for probably about 35+ years ago when it was appearing on the third harmonic. [Krueger-FL]
- 910 **CUBA** *R.Cadena Agramonte*, Camagüey-Tagarro DEC 17 1000 – Male, "Esta es Radio Cadena Agramonte, Camagüey," into brief light piano tune, then traditional Cuban vocals. In tight, mostly nulled local WTWD plus someone with an open carrier and 60-cycle hum, possibly *R.Metropolitana* Cuba. [Krueger-FL]
- 910 **CUBA** *R.Metropolitana*, Villa María DEC 17 1103 – Female, "Esta es Radio Metropolitana," into easy listening clarinet solo, then traditional Cuban vocals. Open carrier 60-cycle hum seemingly vanished with the ID, as if maybe this one popped on the modulated air at this time. [Krueger-FL]
- 940 **MEXICO** unID DEC 17 0707 – Children's choral version of Mexican anthem under KFIG in massive 950 XEKAM IBOC slop. XEKAM runs IBOC 24/7 except during the National Hour and occasionally other times on evening weekends. Normally on this wire I get XERLA, but I have yet to hear them running the anthem around local midnight. They do occasionally run the long children's choral version around 6 a.m., so it could well be them, but I suppose it could also have been XEMMM coming out of the National Hour in Pacific time. [Hall-CA]
- 970 **MEXICO** XERFR *R.Fórmula*, México, DF DEC 23 0559 – Children's choral version of Mexican anthem (as used on all *R.Fórmula* outlets) parallel 1370 XEMON. Relog, but fairly rare here. [Hall-CA]
- 1000 **MEXICO** XEOY *Mil AM*, México, DF DEC 23 0601 – Faded up under KOMO and KCEO with slightly uptempo adult choral version of Mexican anthem. (My local 1310 XEC appears to have stopped relaying XEOY recently.) [Hall-CA]
- 1010 **MEXICO** XEHL, *W Deportes*, Guadalajara, Jal. DEC 17 0601 – Faded up under KCHJ and KIHU (which was running day rig again) with adult choral version of Mexican anthem parallel 730 XEX. Relog. [Hall-CA]
- 1050 **MEXICO** XEBCS *La Radio de Surcalifornia*, La Paz, BCS DEC 17 0657 – Blasting in with U.S. rock oldies, adult choral version of Mexican anthem (this is a change; they previously ran the children's choral version), followed by long version of BC Sur state anthem, which I have also never heard them run before. Usual full ID mentioning FM 99.1, then into Sinaloa-style regional Mexican music. Relog. [Hall-CA]
- 1070 **MEXICO** XESP *Rock and Soul 91.9*, Guadalajara, Jal. DEC 17 0600 – Under KNX with children's choral version of Mexican anthem. Relog. [Hall-CA]
- 1100 **MEXICO** XETGO *R.Cañon*, Tlatenango, Zac. DEC 17 0600 – Faded up under KFAX and KWWN with slightly slow tempo children's choral version of Mexican anthem as logged at the Border Inn. New, Zac #11, Mexico #311, station #1450 from home. [Hall-CA]



- 1150 **MEXICO** XEAD *Metrópolis*, Guadalajara, Jal. DEC 23 0559 – This station's unusual slow time pips (2 seconds apart) were easily heard through XEUAS and KEIB. Faded up a minute later with Notisistema news in progress. They eventually got around to running their slightly uptempo adult choral version of the Mexican anthem at 0606 UTC. Relog. [Hall-CA]
- 1150 **MEXICO** XEUAS *Radio UAS*, Culiacán, Sin. DEC 17 0657 – Steady signal under KEIB with overnight classical music program and full (4:40) children's choral version of Mexican anthem. Relog. [Hall-CA]
- 1180 **CUBA** *R.Rebelde*, multiple sites DEC 17 0700 – 9-note Rebelde attention signal heard from at least 2, and possibly 3 transmitters, the third one coming a second or so after the first two. If I were a bit more sure about the third signal, it would be new. Relog. [Hall-CA]
- 1190 **MEXICO** XEWK, *W Radio*, Guadalajara, Jal. DEC 17 0600 – Mexican government PSA, *W Radio* slogan, into slightly uptempo adult choral version of Mexican anthem. Relog. [Hall-CA]
- 1300 **MEXICO** XEXW *La Bestia Grupera*, Nogales, Son. DEC 23 0600 – Mixing with XEP, with pre-recorded ID's by female announcer, "La bestia grupera," followed by male announcer, "1300 AM." They really seem to be getting out better this year. Not sure if it was this station or XEJL that played the adult choral version of the Mexican anthem an hour later. Relog. [Hall-CA]
- 1310 **MEXICO** XETIA *R.Vital*, Tonalá Jal. DEC 17 0600 – Nice signal through local XEC open carrier with ID by female announcer: "Usted escucha XE-Tia AM, Radio Vital, desde Guadalajara, Jalisco, México." This was preceded and followed by a brief oboe theme. XEC returned in mid-sentence a few seconds later with brokered religious programming. [Hall-CA]
- 1310 **MEXICO** unID DEC 23 0600 – Children's choral version of Mexican anthem audible through local XEC open carrier, under XETIA after its anthem ended. XEC came back on the air before it finished. This is almost certainly XEHIT, logged at the Border Inn but still needed from home. XETIA was still audible even after local XEC came back on. [Hall-CA]
- 1370 **MEXICO** XEPJ *R.Ranchito*, San Pedro Tlaquepaque, Jal. DEC 17 0602 – Distinctive slow orchestral version of the Mexican anthem (other stations in this ownership group, such as 1340 XEDKT, use this version, which slows down even more at the end). At the top of the following hour, I caught most of an ID, including very clear mentions of their slogan and location, so they are 24h now. Relog. [Hall-CA]
- 1380 **MEXICO** XECO *Romántica 1380*, México, DF DEC 17 0557 – Children's choral version of Mexican anthem in progress, *Romántica 1380* slogan, Mexican government PSA's. Caught a nice full ID the following hour with call letters, slogan, studio location, phone numbers, and mention of 50 kW. Announcer wished listeners "Feliz Navidad" and ended the announcement with Santa Claus "Ho ho ho!" Relog. [Hall-CA]
- 1410 **MEXICO** XEKB *Canal 1410*, Guadalajara, Jal. DEC 17 0600 – Faded in during ID, mentioned studio address Avenida Francia 1783, Guadalajara, into fast choral version of Mexican anthem (possibly the same version used on XEBS). Relog. [Hall-CA]
- 1440 **MEXICO** XEEST *Quiéreme 1440*, México, DF DEC 17 0557 – Spanish religious programming, possible mention of Grupo Siete. Children's choral anthem at 0601 exactly as heard on XEEST web stream recently. I would normally expect to hear XEABCJ on this antenna, but they run a grupera program at this hour, and have not been running an anthem at midnight recently. When they do run one, it's usually about 5 minutes after the hour. XEABCJ web stream sounds terrible this week; I wonder if it's actually going out over the air like that? XEEST format is an odd mix of talk, religious, and motivational programming. They temporarily moved this format to 1560 XEINFO (which had been silent for 9 years) from May-October 2017 before returning to 1440 kHz. According to one of the churches whose programs run on XEEST, this move was temporary to allow XEEST to upgrade their facilities. Speaking of 1560 XEINFO, they apparently re-emerged in November as 105.3 XHINFO, the only FM migration allocation granted in Mexico City, despite seemingly being one of the least deserving stations. They appear to have launched the FM "Aire Libre" (see <http://airelibre.fm/>), seemingly without ever restarting the AM and going through a simulcasting period. XEEST is new, DF #25, México #314, station #1453 from home. [Hall-CA]
- 1480 **MEXICO** XEZJ *Simplemente Supérate*, Tonalá, Jal. DEC 17 0601 – Distinctive slow orchestral version of the Mexican anthem (other stations in this ownership group, such as 1340 XEDKT, use this version, which slows down even more at the end). Relog. [Hall-CA]
- 1480 **MEXICO** unID DEC 23 0600 – High choral version of Mexican anthem barely audible through massive 1470 XERCN slop. It sounded like high adult voices in the chorus, but it

was hard to tell through all the slop. If it was a children's chorus, then this was likely needed XETKR. The only other possibility is XEVIC, also needed, but even less likely on this antenna. [Hall-CA]

- 1500 **MEXICO** XEDF *R.Fórmula*, México, DF DEC 23 0557 – Alone on the channel tonight with full ID, promos, and children's choral version of Mexican anthem from *R.Fórmula* network feed. Conditions sure seemed auroral this week! Where was KSJX? [Hall-CA]
- 1510 **MEXICO** XEQI *Opus 1510 AM/R.Nuevo León*, Escobedo, NL DEC 17 0601 – Instrumental version of Mexican anthem, ID by male announcer. Relog. [Hall-CA]
- 1520 **MEXICO** XEEH *La Primera*, San Luís Rio Colorado, Son. DEC 17 0557 – Regional Mexican music, slogan-ID, "La Primera, San Luís Rio Colorado." Lately I've been hearing KMPG (daytimer staying on all night) on this channel instead of XEEH. Relog. [Hall-CA]
- 1530 **MEXICO** XEUR *Extasis Digital*, México, DF DEC 23 0558 – Way under KFBK with children's choral version of Mexican anthem, ID by female announcer. Relog. [Hall-CA]
- 1560 **MEXICO** unID DEC 17 0601 – Suddenly appeared over KNZR and 1700 XEPE image (the Perseus picks up a mixing product of 1630 XEUT and 1700 XEPE, two of my closest locals) with start of children's choral version of Mexican anthem. This could be unneeded XEJPV, unneeded XELAC, or needed XECHZ, all of which might air this version at this hour. I did not hear XECHZ piccolo/marimba theme, or anything else, after the anthem, which would tend to point to XELAC (they go off the air right after the anthem). A few seconds before this station faded out, a third Spanish station briefly faded up before KNZR eventually took over. I think the third station might have been XEJPV. [Hall-CA]
- 1570 **MEXICO** XERF *La Poderosa*, Cd. Acuña, Coah. DEC 15 2009 – Checking for early skywave from XERF, like the past two afternoons, 3+ hours before sunset – but listening until 2023, it does not emerge from the jumble. Shows how variable conditions can be even for daytime MW DX. [Hauser-OK]
- 1590 **MEXICO** XEVOZ *Arroba FM*, México, DF DEC 23 0557 – Alone on channel with children's choral version of Mexican anthem in progress, *Arroba FM* slogan, followed by what sounded like a Mexican government PSA (audio became distorted for some reason), ID by female announcer, and pop music. Relog. [Hall-CA]
- 1600 **MEXICO** XEGEM *R.Mexiquense*, Metepec, Edo.Méx. DEC 17 0600 – Faded up under KGST with adult choral version of Mexican anthem (multiple verses) in progress. A few minutes later, they ran the Himno Estatal del Estado de México (state anthem). Couldn't find any of the parallels on 1080, 1250, or 1520 (1520 may have moved to FM). Relog. [Hall-CA]
- 1650 **MEXICO** XEARZ *Zer Radio 1650*, México, DF DEC 23 0558 – Barely audible under KBJD and KSVE with children's choral version of Mexican anthem. Relog. [Hall-CA]
- 1700 **MEXICO** XEPE Tecate, BCN DEC 17 0557 – Since December 12, this station (one of my closest locals and biggest pests) has been relaying co-owned 1030 XESDD (Spanish language political speeches, brokered religion, and who knows what else), reportedly due to Broadcasting Corporation of the Americas failing to make the rather exorbitant lease payments for 1090 XEPRS, 1700 XEPE and 105.7 XHPRS. Oddly, XEPRS and XHPRS have different owners; the owner of XEPRS has allowed BCA to keep broadcasting sports talk "Mighty 1090" on XEPRS, but reportedly wants to either find a new lease client, or sell the station if anyone will give their asking price \$11M. [Hall-CA]

TRANS-PACIFIC DX

- 657 **NORTH KOREA** *Pyongyang Broadcasting Station*, Kangnam DEC 23 1400 – Poor with higher-pitched North Korean 3+1 time pips. They were the only recognizable signal at the top of the hour (a few of the high-powered Japanese and South Korean stations were barely audible a few minutes earlier). Relog. [Hall-CA]
- 774 **JAPAN** JOUB, *NHK2*, Akita DEC 17 1400 – Poor with usual NHK time pips. Relog. [Hall-CA]
- 873 **JAPAN** JOGB, *NHK2*, Kumamoto DEC 17 1400 – Very weak with NHK time pips. Relog. [Hall-CA]
- 972 **SOUTH KOREA** HLCA, *KBS*, Hanminjoki DEC 17 1400 – Weak with *KBS* pips, but faded up a minute later with fairly good audio. Relog. [Hall-CA]
- 1566 **SOUTH KOREA** HLAZ, *FEBC*, Jeju DEC 22 1343 – Straining to follow the JBA carrier from the northwest, as *FEBC* is scheduled to change from Japanese to Chinese circa 1345 when the signal toward North America drops dramatically with pattern change toward the west rather than east. And it does: fortunately a slight fade-up first, making the cut at 1344:31 more obvious, but during the following minute I can still detect it. There was little doubt about 1566, but lacking any actual audio, this bit makes it even more definite. This is not a good TP morning, as only 3 other carriers were detected lowband. And local sunrise

here is 1340, creeping to 1344 at the latest in a biweek, so a few more better chances to observe this. I wonder what the true bearings are of the major lobes as both Japan and China cover large portions of the compass from so close? If centered on Tokyo it would favor Argentina beyond, while the direct path to Enid goes west of Japan as far north as Anchorage. [Hauser-OK]

Transpacific carrier search: DEC 22 1328 – Pre-sunrise: not much from northwest except 747, 774, 882 and 1566 kHz. [Hauser-OK]

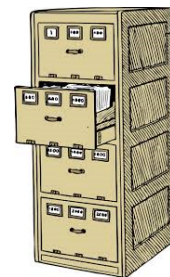

STATION NEWS

BELGIUM: RTBF leaving 621 and 1125 on December 31 – Since this morning DEC 17 0459, the following message is broadcast at the end of each hour (on 621 kHz); "A compter du 31 décembre, La Première va cesser d'émettre en ondes moyennes. Pour continuer à nous écouter, basculez votre récepteur radio en FM sur la fréquence de votre ville. Vous pouvez également nous écouter en direct en DAB+, via l'application radio player, ou sur auvia." (From December the 31st, La Première will cease transmitting on the medium wave. In order to continue listening to us, switch your radio receiver to FM on your city's frequency. You can also listen to us live on DAB+, through radio player app, or auvia.) The message seems to be only broadcast on MW, as it is followed by the end of the advertisement. Curiously, the second sentence is (almost) the same as in Allouis's equivalent announcement in December 2016. I did not hear any such message on VivaCité (1125 kHz); neither did I find any information about the time of the last transmission. [Vincent F4HPZ, mediumwave.info]

NETHERLANDS: 1008 *Groot Nieuws Radio* leaving MW on December 31 – Het christelijke radiostation Groot Nieuws Radio neemt na ruim elf jaar afscheid van de middengolf. Na 1 januari 2019 gaat het radiostation digitaal verder via DAB+, de vernieuwde app, satelliet en interactieve televisie. In de laatste weken van 2018 voert het presentatieteam nog volop actie en worden luisteraars geholpen om de overstap te maken naar digitale radio... Groot Nieuws Radio is het laatste landelijke radiostation dat op dit moment uitzendt via de AM-band. De eigenaar van de zendmast in Zeewolde wil de zendlocatie ontmantelen... De uitzending via de middengolf stopt op 1 januari om 01:00 uur. Vlak daarvoor klinkt nog een keer het lied 'Word of God Speak' van de band MercyMe op 1008 AM. "Met dit lied zijn we begonnen. Ons gebed was dat Gods woord zou spreken. We blijven doorgaan met onze missie via de verschillende digitale kanalen", vertelt Wilfred Hardeman. [www.grootnieuwsradio.nl]

50 Years Ago – From the December 7, 1968 issue of *DX News*: One of the club founders, Henry M. Gordon, passed away suddenly on November 16, 1968. Harry was the editor and publisher of *DX News* in the 1930s.

Bits and Bites from the NRC listserv: An FSL Extravaganza

Re: Puyallup WA Wild and Wacky TP's

A tiny 5 inch antenna isn't really supposed to track down multiple second tier TP's at good levels in a mediocre inland valley-- but when propagation gets this enhanced, all odds are off!

The exceptional Asian conditions reported by Colin, Nick and Walt were repeated down here, with the "Frequent Flyer" FSL flying high with the reception of audio on 783 (Chinese), 837 (Japanese and Chinese), 936 (Chinese) and multiple other frequencies at the noise-free local park. 963-CRI hit an awesome S9 level just prior to the 1400 TOH, and 864-HLKR did the same around 1420. 1143-BEL3 was potent with S7 Chinese around 1425, while 531-JOQG, managed its best signal ever here in Puyallup. As if that weren't enough, the S9+ performers on 603, 639, 657 and 738 repeated their thunderous romps again this morning, while a separate 5" FSL was set up in the back yard to record 657-Pyongyang from 1030-1500. There was so much S9 programming from the "Dear Leader" that the neighbor's electrical noise was totally swamped, as if it didn't exist (or maybe it couldn't tolerate the programming, and decided to throw in the towel?).

The wacky session started off in the predawn darkness at 1030. After a lackluster TA report from Victoria expectations were not high, but there were 603-HLSA and 657-Pyongyang, already hitting S9 peaks in the noisy back yard. After setting up Craig Barnes' 5" FSL to record 657 I headed for the local park at 1320, to be greeted with an astonishing variety of unusual Chinese, Korean and Japanese signals on second-tier frequencies. Most of these stayed at modest levels until after 1400, but 963-CRI's traditional Chinese music right before 1400 was a legendary S9+. Shortly thereafter the Chinese signals on 756, 783, 837, 936, 1017, 1035 and 1044 started managing decent audio, and 864-HLKA went on an S9 romp around 1420. Late on in the session 1143-BEL3 reached its best audio level ever here (S7, in some splatter), and 531-JOQG did the same (it is on a frequency usually covered by a semi-local 530-TIS station here). The awesome performers from yesterday were back in force-- 639-CNR1 repeated its S9+ signal with Chinese news at 1430, while 603-HLSA did the same at various times over its Chinese co-channel. 738-BEL2's Chinese totally shut down the Frisco splatter for most of the session, while the 657-Pyongyang signal (mentioned by all the Victoria DXers) had a four hour run from 1030-1430 at overwhelming strength. If I was as dedicated as Nick, Colin, Walt or Nigel this report would be a lot more detailed, but for a live DXer "living the dream" with a 5 inch FSL tracking down an astonishing variety of TP-DX in a mediocre valley, it was definitely a session for the ages!

531 JOQG Morioka, Japan Best signal ever here with male speech //594 at 1425; usually this station is covered by a semi-local TIS transmitter <https://dreamcrafts.box.com/s/j595mcuuhym84ly64xmek4jg41pcxp2>

639 CNR1 Chinese Synchros Repeating its S9+ signal from yesterday with Chinese news at 1431 <https://dreamcrafts.box.com/s/foijf4ehpltehuq2jzaw8icfxne8r4r>

657 Pyongyang BS Pyongyang, N. Korea Sweet-voiced lady with soothing speech at 1309... NOT! <https://dreamcrafts.box.com/s/utd5uw7z96agi6y4vf34w90v5z2iadq1>

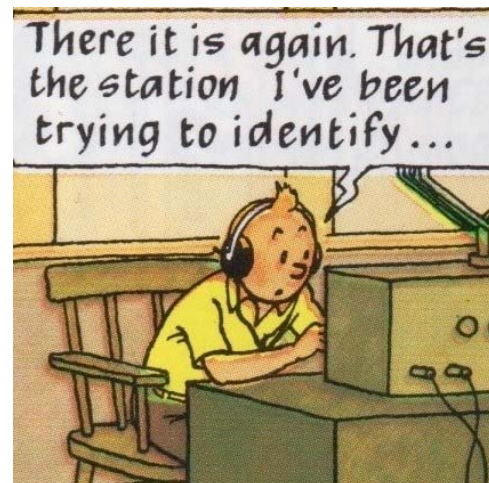

Re: A Phasing Story: Greenland-720 Logged in IL

A phasing story from last night. I live 12 miles NNW from WGN's Xmtr. I put down a 288 ft BOG at about 35 deg // a 177 ft one. Phase null of WGN peaked at about 50 dB and it was down close to S6 on Perseus. Sure enough there's audio seeming // KNR web stream which was mostly talk. Then from 0104-0108 a couple of bouncy tunes sung by females clinched it leaving me no doubt. This using the Quantum Phaser which I think I'd like 2:1 or even 3:1 Vernier knobs for.

When I got Greenland at my WI DX paradise a decade ago, WGN and KNR were about S7-8 using longer terminated BOGs. At 12 miles distance I have no skywave to worry about.

I couldn't get Greenland on 650 where even though WSCR and WSM are close together on the dial and in similar directions, WSCR IBOC crept up during best null on WSM and visa-versa.

IBOC sucks but phasing ROCKS. Short BOGs aren't impressive 'til you phase them to create good back nulls. 73 KAZ
