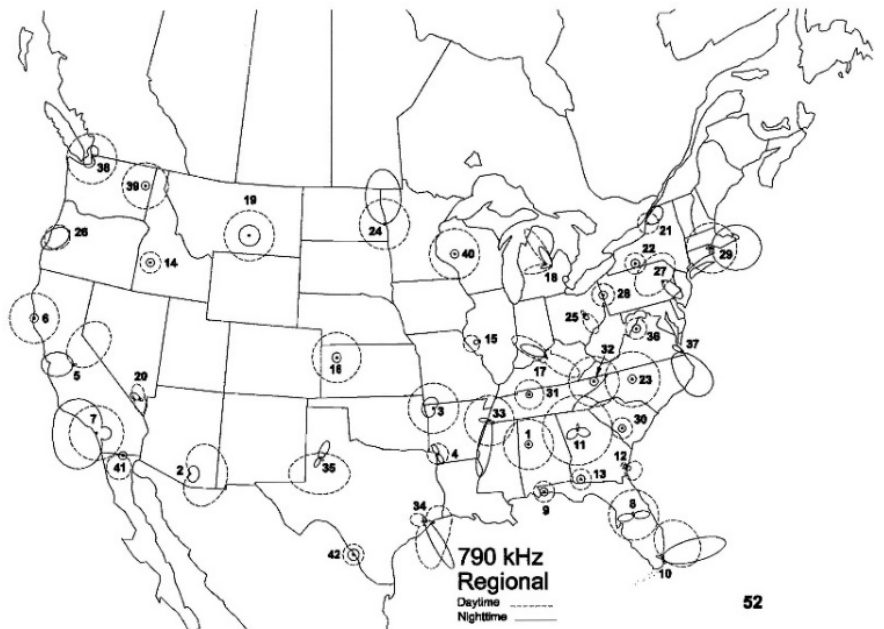

Those ramps closure should put it in Manatee County. Possibly a temporary or portable transmitter. (TLK-FL)

- 1310 **MEXICO** XETIA *R.Vital*, Guadalajara, Jal. APR 19 1100 – Tune in to beginning of choral full version of anthem until 1105, then male "XETIA Radio Vital... mil wats..." Rapidly lost to WYND DeLand with preacher. So, this one hasn't migrated to FM – yet. [Krueger-FL]
- 1500 **MEXICO** XEDF *Grupo Fórmula 1500*, México, DF APR 9 1053 – "The Love I Lost" by Harold Melvin & the Blue Notes, Spanish woman at 1057, choral anthem from 1059, calls ID, news. [Krueger-FL]
- 1570 **GUATEMALA** TGVE *Radio VEA*, Guatemala APR 16 0241 – Religious programming with talks/music. Audio matched internet streaming. Typically under XERF but peaking to good signal throughout the evening. [Beu-TX]
- 1620 **CUBA** *R.Bayamo*, Bayamo APR 20 1001 – Under *R.Rebelde*; chimes and six bells marking the hour. [Conti-NH]

TRANS-PACIFIC DX

- 576 **AUSTRALIA** 2RN Sydney APR 20 1100 – Steady signal but only 10 dB above the noise floor, not enough to produce audio in local 580 WTAG splatter. Presumed Australia based on frequency measurement of 576.000 kHz. [Conti-NH]

Transpacific carrier search: MAR 21 1236-1245 – 594, 774, 828, 882, 972, 1098, 1422, 1548, 1566 kHz. Very likely sources of all these from Australia, Pacific and East Asia should be obvious. Should have started earlier before LSR 1234 UTC, while I was trying to get back to sleep, but finally upgave and intuned. APR 25 1146-1152 – As I happen to awaken just at LSR 1145; 792, 864, 882, 1035, 1548 kHz, but by far the strongest is 1098 from west, the all-night open carrier from V7AB Marshall Islands. The others are too weak for a definite DF, but probably from west/southwest = South Pacific, rather than northwest = East Asia. APR 26 1138 – 702, 774, 837 with two beating, 1098 kHz. [Hauser-OK]

INTERNATIONAL NEWS

MEXICO: At 11:30 a.m. on Wednesday April 10th, the owner of 1090 XEPRS suddenly pulled the plug on the "Mighty 1090" (leased) sports talk format, and immediately began simulcasting 104.9 KJAV "Ultra 104.9 FM" from Alamo-McAllen, Texas, complete with Rio Grande Valley ("RGV") weather and local ads.

It had been reported several months ago that BCA, the lessee for 1090 XEPRS, 105.7 XHPRS, and 1700 XEPE had been failing to make the exorbitant lease payments to the owners of those stations, reportedly at least \$100K per station per month. In December, the Tijuana politician who owns XHPRS and XEPE had kicked the BCA programming off of those two stations, and it was reported that the owner of XEPRS planned to do the same as soon as they could find a new lessee or a buyer for the station, for which they wanted \$11M.

The "ultra 104.9" format is a bizarre mix of U.S. and Mexican urban contemporary with U.S. classic rock and random 90's junk. Announcements and ads constantly flip back and forth between English and Spanish. As soon as the new simulcast began, a (Spanish language) announcer immediately began welcoming listeners from San Diego listening on AM 1090. Pre-recorded announcements throughout the hour (English and Spanish) mention 840 AM, so they must still be simulcasting KVJY Pharr, Texas, but the legal ID at top-of-hour mentions only KJAV 104.9 Alamo-McAllen. Around the bottom of the hour they cut away for 1090 XEPRS ID (in Spanish) along with the obligatory Mexican government PSA's and political ads (still badly translated into English by the same guy who seems to have been doing it for about 30 years now). "The Mighty 1090" had only 3 local weekday shows left; of these, the "Ben and Woods" morning show continues on the Mighty 1090 website for now. The other two shows, Darren Smith and "Scott and BR" have not announced similar plans, but "Scott and BR" host Scott Kaplan says he plans to create a "new modern media company" that will lease time on some other station, allowing this format to return to the San Diego airwaves.

XEPRS was reportedly doing poorly in the ratings, but better than the other sports talk stations in the market (1360 KLSD, 97.3 KWFN, and until last December, 1700 XEPE). The future of XEPRS' large staff is unknown at this time, and based on the comments made by the on-air personalities and their manager, it sounds like additional legal actions may be on the horizon. As for the new format, it's hard to imagine how a KJAV relay in San Diego would make any money. The slogan will cause some confusion, because Tijuana already has a 104.9 FM that has nothing to do with Ultra 104.9 FM. [Tim Hall, NRC]

Bits and Bites from the NRC listserv

From: Mark Connelly, WA1ION

Re: Incompetence = Opportunity

I think many DX'ers have noticed increasingly sloppy operation by AM broadcasters over the past few years. This can take numerous forms:

(1) Station is silent when it should be on. This can range from a few minutes to a few weeks. Recent outages of 680 (WRKO), 1240 (WBAS), and 1330 (WRCA) in this area bear this out.

(2) Dead air / blank carrier for extended time compared to what would be considered normal. This can allow weaker station audio to sneak through in the background.

(3) Station on the air when it should be off, wrong power/pattern, etc. Sometimes this is intentional (a.k.a. "Special High School Football Authority") and sometimes it's just human operator ineptitude or a computer automation snafu.

(4) Two or more audio feeds at the same time. Automation glitches that cause the same segment of audio to be repeated again and again. This one from 1560 WFME NYC is a doozy. In the nation's largest city, on a 50 kW clear, this rubbish went on for hours (... maybe days).

(5) Gross over modulation or under modulation or distortion.

(6) Frequency well off nominal.

Conditions that in the '60s/'70s were mostly associated with Latin America have now come to the USA and Canada.

With radio press articles such as "AM is dead" etc. and AM stations using their peanut power FM translator frequencies in their branding slogans, is it any wonder that broadcasters are sinking to new lows in quality control?

The flip side of this AM malaise is that every day can present new opportunities for DX'ers as the landscape dynamically shifts around by stations being off when they're supposed to on, on when usually off, wrong power/pattern, other assorted technical gaffes, whack-a-doodle programming, etc. Many of these faults are very short term and you have to be listening at the right time to milk out the potential DX bonanza.

So as the message subject suggests, broadcaster incompetence can translate to DX'ing opportunity, seemingly on an increasingly regular basis as poorly managed stations teeter-totter towards the brink of oblivion. Much of the same applies to shortwave as well.

I personally take offense to the use of the word incompetence ... that comes from DX'ers who think they know what they're talking about when it comes to radio and have no idea what actually may be going on.

Even as a broadcaster, I've made guesses as to what's going on when I hear a station with a problem and have been wrong.

Sometimes things are completely out of the stations control for any number of reasons. Should someone be listening and catch problems sooner than a few hours? Absolutely. We had a station here broadcast dead air for a few days because their STL failed and we were in the midst of a big blizzard and they had no access to the tower site.

I work for a station that has a back up automation computer, more than one way to get a live feed from an outside location back to the studio and things still happen.

Re: Incompetence = Opportunity

Don't take offense; in a number of cases it's absolutely true.

As a broadcast engineer (Radio) since 1983, an SBE Member and CSRE, incompetence accurately describes a number of the operational situations Mark pointed out. "Lifting the hood" of the average broadcast station to see the general condition of and attention to, the maintenance and quality of engineering can be a real eye opener.

How many AM directional patterns are within the terms of the license? Maybe ... 2 out of 5? Do they even know at what times the station must set the night time power and pattern change? Some

on air folks think "Critical Hours" = evening drive. How about something even simpler like tower lighting? Are they all working and if not, has a NOTAM been called in to the FAA? Tower lights are pretty simple, go out one night and look at the towers, the lights are either all operational or not.

I once contracted to an AM station in NC. Upon arriving at the transmitter site (they had a Harris MW-5) there was a man sitting on a stool in front of the transmitter with one of the two front doors open. When asked what his job was, the answer was "whelp, every now and again the transmitter will pop a breaker and knock off. I sit here and cut the breaker back on. Can't nobody figger out what's caus'in it."

Turns out the arc-gap for the HV feeding the modulator tube was set too narrow. Many, if not all of the Harris MW series transmitters used PWM modulation which not all understood. 10 minutes with the manual, a small ruler and an Allen-wrench set that problem to rights.

Work in radio long enough, you meet some very different personalities (to put it kindly) and hear recounts which in a word, are unbelievable. Like the fellow who did overnights often enjoyed "female guests" during his shift that is, until 2 of them showed up at the same time for a visit and started a fight in the studio.....

Re: Incompetence = Opportunity

This link is of a reception on 24 MAR 2019 of the UAE station on 1170 from two sites here on Cape Cod, MA. The demonstration shows how much difference there is between a shore site and one only a short distance inland.

The file runs 45 seconds. The first 30 seconds is from an Elad capture made by Roy Barstow at Sandy Neck Beach near the Sandwich-Barnstable, MA town line, approximate coordinates 41.739 N/70.381 W. Time 2300:30 to 2301:00 UTC. The last 15 seconds (31-45 sec.) is from an Elad capture made by me at my home site in South Yarmouth, MA: approximate coordinates 41.6931 N/70.1912 W. Time 2301:00 to 2301:15 UTC.

The two receiving sites are about 15 km/9.3 miles apart. The path to UAE is on an approximate azimuth of 49-50 degrees, distance 10717 km/6665 miles. The map linked here shows that the route on 50 deg. is a direct overwater shot from the Sandy Neck Beach site whereas from my site the path towards the UAE station crosses about 24 km/15 miles of land before reaching the shore in the Orleans, MA area. The terrain is relatively flat but is sandy soil (mostly pitch pine forest) of relatively low conductivity.

Receivers used were the same Elad FDM-S2 model. Capture files played back to Total Recorder were set at the same mode and bandwidth (upper sideband, approx. 2.5 kHz). Times were matched on the two capture files by checking the top-of-hour Morse Code "V" (...-) pips on 1080 WTIC.

The antenna gains and patterns were comparable. Both were SuperLoop types. Roy used one 1.82m tall by 3.66m wide (6 x 12 ft.) with a 15 dB amplifier and mine was 9m tall by 20m wide (30 x 66 ft.) with no amp. Both were set-up with a cardioid pattern nulling roughly to the west.

The difference between the two sites should be quite obvious when playing back the audio file. The beach location appears to have 20 dB or more signal-to-other-junk ratio. This is a result not too different from that observed with midband daytime groundwave signals.

I may have some more of these demo recordings as I check files covering the same time intervals (my site versus beach sites). Path heading south will differ much less as it is only about 5 km/3 miles to the ocean going that way from here.

This one is of 1215 Absolute Radio UK on (UTC) 25 MAR 2019. Bearing, about 50 deg., is similar to that of the 1170 UAE station of the first comparison. Distance only about 5000 km / 3100 miles, less than half as far as UAE.

Sec. 0 to 38 = 0000 to 0000:38 UTC = Sandy Neck Beach (41.739 N / 70.381 W)

Sec. 38 to 55 = 0000:38 to 0000:55 UTC = WA1ION house/S. Yarmouth (41.6931 N / 70.1912 W)

Map is linked here.

The Sandy Neck site is about 10 dB better in signal-to-junk in this instance. Compared to the UAE log, not as dramatic a change on the shorter distance signal. This says that the higher the incoming arrival angle, the less drastic the difference between the shore and somewhat-inland sites. Not too surprising.

Re: DXing in Hong Kong April 2-9

Most DX'ers are aware that Hong Kong is extremely overcrowded, with the highest population density on the planet. When the British administration turned the territory over to China in 1997 its residents became somewhat unwilling participants in a deal beyond their control, and expressed their dissatisfaction with Beijing's rule in notorious "Umbrella" demonstrations in 2014. Beijing's response to Hong Kong's dissatisfaction has been to use the "Tibet and Sinkiang" solution-- flood

the enclave with Mainland Chinese supportive of Beijing's one-party rule. This has made a bad housing situation much worse.

For a DX'er looking to set up gain antennas on salt water beaches, Hong Kong is about as bad as it gets. Almost every beach is either privately owned and/ or restricted, and the ones that aren't are typically overcrowded, with almost no privacy and dubious security. Although I had brought along a 5 inch "Frequent Flyer" FSL antenna and 4 foot PVC base, because of the difficulties mentioned above these were only deployed on 1 night out of 7-- to a public park on the Hong Kong waterfront.

It was an interesting experience, in more ways than one. Groups of Chinese onlookers stared me down at their leisure, with several of them curious enough to sit and watch. Park joggers ran right next to my makeshift DX'ing setup, causing me to grab the "Frequent Flyer" FSL before it took a terminal flight. Concentrating on security made concentration on DX'ing pretty tough, but during the 90 minute session (starting an hour after local sunset) I was able to record Southeast Asian stations from 531-729 kHz, using the gain boost from the 5" FSL antenna during sunset skip from Vietnam to Bangladesh.

Overall the waterfront experience was a memorable one, but in retrospect, I would have to conclude that Hong Kong is the perfect DX'ing environment for a 7.5" loopstick-enhanced Ultralight, which for me tracked down decent signals all the way from Japan (729-JOCK) to Africa (1431-Djibouti), including 1413-Oman, 1413-Moldova and 1548-Moldova. An FSL gain boost works wonders when almost all your DX is long range, but in Hong Kong a lot of the interesting DX is short range, and a hot-rodged Ultralight is definitely the most convenient tool for the job-- especially when you don't want to be the "center of attraction" on a public beach.

With a 7.5" loopstick CC Skywave SSB Ultralight I could do almost everything I wanted to do in Hong Kong-- stick it away in a backpack to make daytime DX trips to Macau and HK's awesome Cape D'Aguilar, investigate sunset skip across Southeast Asia in the evening, and stick it outside the jail-like security window on the 15th floor of our high-rise apartment to track down long range signals from Eastern Europe, Africa and the Middle East around sunrise. The overall DX'ing results from the trip were much better than expected, given the severely overcrowded venue, the overload of Chinese signals on almost every MW frequency and the impracticality of deploying gain antennas on salt water beaches.

In retrospect, Hong Kong is far from the ideal DX'ing venue, but it is a great place to investigate the exotic Southeast Asian stations, eat some awesome food and enjoy a fascinating culture. For a DX'er with a sensitive AM-DX'ing portable (or a hot-rodged Ultralight) willing to get up around sunrise enhancement, it will give you all the long range DX'ing excitement you can handle!
