Dear Mr. Geary,

I am very pleased to verify your reception report of Medium Wave Broadcast Station WILD, heard on 1090 kHz., 22 January, 1990, at 02:00 to 02:30 EST (07:00 to 07:30 UTC). Thank you for your response to our test.

The test was not without a visit from Murphy! You may have noticed a "squealing" of sorts during breaks in the audio during the first portion of the test. This was the result of RF feedback into the mixer used for the test! It was several minutes before the problem was solved. Also, circumstances being as they were, we transmitted a 400 Hz. tone instead of a 1 kHz. tone as usual.

This DX test would not have been possible without the efforts of Chief Engineer, Grady Moates. Grady and I conducted the test at the transmitter site, as opposed to the studio, so the transmitter could be excited directly, and the waveform monitored for optimum modulation. Grady has been very supportive of many aspects of Amateur Radio and DXing in general, and his contributions to our hobby are greatly appreciated.

Some DXers have asked about me, and my role with WILD. I hold the Amateur Extra Class Licence and my personal callsign is NV1L. I have worked for Grady as a contract engineer for about nine years, during which time we built the new studio complex for WILD. My Amateur Radio hobby is CW DXing, and my home station includes a Yaesu FT 757GX transceiver and a 3 element triband (18 foot boom) Yagi antenna for 10, 15, and 20 meters operation which is mounted on a guyed roof tower and rotator at 65 feet above street level.

Since this test was conducted independently by myself and Grady, all requests for memorabilia have been forwarded to the station management. Thanks for your patience while waiting for verification.

It was really nice to hear from such a seasoned DX'er, such as yourself. The signal you heard was indeed WBET/1460. I myself have heard WCMB while at my home QTH while using a Field Strength Meter and nulling out WBET.


It was really a great piece of nostalgia hearing from someone who heard and actually remembered our interim 990 kHz operation back when WBET was using the silent facilities of the late WBKA until our own 1460 kHz operation was being completed. The 990 kHz operation was intended to just get us on the air until we could go fulltime on 1460 kHz. You may be interested to know that the Fuller family still owns and operates WBET and sister station WCAV-FM Stereo 97.7. Myron Fuller, son of the late Charles A. Fuller is the President of The Enterprise Publishing Company, parent company to WBET/WCAV-FM.

Could you possibly make me a photocopy of your 1946 verification of WBET. I'm sure it would be of personal <sup>value</sup> to both myself and the Fuller Family. I realize this is a rather big request, but it would be most appreciated.

Our FM Stereo sister station, WCAV-FM (97.7 MHz) has a 3-bay array mounted atop our eastern tower, with an E.R.P. of 3,000 watts.



We have checked the information given us in your recent letter and are very happy to verify your reception of our special test program broadcast from 4:15 AM to 4:48 AM, Monday, January 18, 1954.

WGAW is one of the KBR Stations of New England and operates with a power of 250 watts on a carrier frequency of 1340 Kcs. We are affiliated with the American Broadcasting Company and carry all the important ABC programs, together with local sports and events, plus disc jockey presentations. Regular operating time is from 6:30 AM to 11:30 PM.

The transmitter is a General Electric BT-20-A Broadcast Transmitter with two 125 watt tubes in the final using high level modulation. Antenna is a 150 foot tower, uniform cross section, series excited. Ground system consists of 120 radials 150 feet long of buried copper wire.

Operation of the transmitter is entirely by remote control from our studios located in the heart of the business district of Gardner, Massachusetts. Remote control equipment was manufactured by the Rust Industrial Company of Manchester, N.H., and enables us to turn the transmitter on and off, read all necessary meters, turn controls up or down to adjust voltages, antenna loading, switch circuits for network programs, etc. A telephone type dial, one switch and one meter comprise the controls at the studios. In case of failure of the control circuit the transmitter is shut off within three seconds.

Your report of the reception of WGAW is greatly appreciated, and the response to the program has been far beyond our expectations. To date we have received letters from listeners as far south as West Virginia, west to Nebraska, and north to Northern Quebec.

WPNI has a rather unusual relationship with us and with WFCR, the public radio station in Amherst. It is a commercial licensee operating as a non-commercial station under special permission from NPR and PRI, the two major suppliers of public radio programming. As you noted (and your recording demonstrated), they carry our programs "The Connection" and "Here and Now" each weekday, and they credit us and WFCR with assistance in making this arrangement possible.

Your reception of the station is remarkable given its very low power at night. It has 5,000 watts daytime, but almost nothing after dark. You perceptively noted that it may have switched to daytime power at 5:58. Before the atmosphere heated up enough to lose the signal, WPNI may have gotten enough of a bounce to get to you.

This letter is to confirm your reception report of WPZE on 1260 kilohertz on 14 April 1997. It is a real blessing to know that our signal is so strong even 270 miles from Boston.

Although we are billing ourselves as Boston's Newest Christian Station, in fact WPZE is one of the oldest continuously operating stations in the market, first licensed as WNAC back in 1922. For many years, the station on 1260 served as the flagship of the old Yankee Network. Subsequently, the call letters were changed in 1953 to WVDA, and in 1957 to WEZE. The original WEZE was one of America's first "Beautiful Music" stations and commanded a large audience for quite a long period of time.

In 1978 the station was sold to New England Continental Media, Incorporated, a division of Salem Communications Corporation of Camarillo, California. Salem owns and operates some 45 radio stations in markets including WMCA and WWDJ in New York, WAVA-FM in Washington, DC, and KKLA-FM Los Angeles.


Early this year Salem had an opportunity to purchase another "old stick", the former WEEI at 590 kHz, which was owned for many years by CBS, Incorporated. The 590 station was WBNW until our purchase. We simulcast for a period of weeks until technical operations could be optimized, and split the stations on March 3, 1997. The 590 station took the WEZE call sign, and the 1260 station is now WPZE. (Hope this isn't too confusing!)

WPZE operates at an assigned carrier power of 5000 watts daytime and 5400 watts night, from a transmitter site on the Quincy/Milton town line, near Boston. We operate non-directionally daytime and from a directional array of three self-supporting towers 206 feet in height, arranged in a dogleg configuration. Our transmitter is a Nautel.

Boston supports many other Christian broadcasting stations, including WROL at 950 kHz, WNRB at 1510 (for many years WMEX) and a relatively new one kilowatt station WJLT at 1060 kHz.

Thank you very much for your letter of October 12 with a complete report of receiving our signal on 1230 Kc. The log you submitted was correct in all respects.

It was quite a suprise to hear from a DX fan as far away as you considering we are only operating with 100 watts power. It was also interesting to read you letter and hear about the communications equipment and antenna system yourwere using. We are very pleased to hear from listeners and DX fans regarding our signal strength. Incidentally we expect to be on the air late the night of November 8 with final election returns and music.

With regard to our equipment, the majority is RCA. We are operating a 250 watt AM transmitter at 100 watts output power on 1230 Kc., which covers greater New Bedford; also a 10 Kw FM transmitter on 97.3 Mc. feeding a Raytheon two-bay antenna which is 386 feet above sea level. That gives us an effective radiated power of 20,000 watts. Our studio and transmitter building was completed the first of this year and we began regular programs February 22, on the air from 7:00 AM until midnight except Sundays when we go on at 8:00 AM. Our building is complete in every detail housing offices, three studios, shop, recording room, control and transmitter rooms. We are located on Pope's Island between New Bedford and Fairhaven. Although it is an island it is connected to the mainland by a four lane highway.

We appreciate receiving your letter and any future reports regarding our signal would be welcome. If, at any time, you are again in the vicinity of New Bedford, feel free to come and visit us.

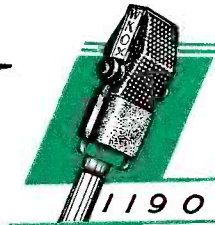

2 CAMBRIDGE, Wixerland (March 20--UPT) -- A combination of left-wing Harvard students and members of the John Birch Society headquartered in Belmont completed their uprising today and proclaimed the Autonomous Republic of Wixerland. The revolution began a week ago with a call to arms by the rebel Radio Free Wixerland, which broadcast code messages erroneously attributed to CIA sources.

Col. P.V. Taylor, commander of the Free Wixerland Forces, and Captain J.A. Callarman, leader of the Somerville command, posted patrols every 10 yards along the boundaries of Watertown, Cambridge, Arlington, Somerville, and Belmont to protect the integrity of the new republic. The Wixerland Navy, under command of Admiral G.P. Nelson, ~~XXXXX~~ streaked down the Charles River, up the Mystic River, then hand-carried the vessels cross country to the Charles again. The strategy, known as the Admiral Nelson Loop, already has military experts buzzing.

Taylor, Callarman, and Nelson, reached for comment on the successful coup, said -- in unison -- "We seek no glory. We seek no power. We only seek --" and here the trio split. Taylor said "advertising revenue," Callarman said "complete news coverage," and Nelson said "reception from Bolivia." The Wixerland triumvirate announced their plans to be the power behind the scenes, and named Nathan Pusey and Robert Welch to head the Wixerland government as Co-Presidents.

Pusey and Welch issued the following statement: "In an effort to reach a consensus form of government, we have decided to institute a 100% welfare state without taxes. We have named J. Paul Getty Finance Minister and Ronald Reagan Minister of Education. The new republic will be run by a series of Neighborhood Councils, who shall elect delegates to a District Council, who shall elect delegates to a regional council, who shall elect delegates to a city council, who shall elect delegates to a republic council. These delegates shall have the authority to rubber-stamp our decisions."

The Co-Presidents immediately decreed their official radio station, WXHR, is authorized to transmit with a 250,000-watt non-directional transmitter, on 735 kilocycles. In the words of Welch, "This will allow the totally-unbiased Wixerland story to be told throughout North America."

A small number of listeners throughout the Eastern Seaboard, apparently tipped off by an informer inside the Wixerland movement, monitored the initial coded broadcasts from the illicit transmitter. Wixerland secret agents reportedly are roving the countryside, wiping out these monitors and destroying their notes.

"We hate to indulge in Castro-style reprisals," Welch told this news reporter, "but the notes these monitors took would be invaluable in the wrong hands. They contain the recipe for a combination grape juice/Molotov cocktail."

There was one sour note in the establishment of the new republic. Admiral Nelson, reached for comment late today, said through the bars: "Just as I was about to log the 100-watt Bolivian on 799.977, on came the WXHR carrier and destroyed my opportunity. The Canadian Government jammer has been repaired, and is now on the air once again with its high-frequency program of classic slopover."

The co-presidents also issued a joint statement denouncing the United Nations and applying for admission. Meanwhile, Washington circles had this comment: "We'll wait and see. It isn't worth fighting a civil war over. Dissident factions are bound to cause dissent."

So much for the continued whimsy. Your report was the most delightful and most complete I've ever seen ... and I, too, want the opportunity to verify it: "This verifies your reception of WXHR on March 13, 1967, between 2:56 and 4:29 a.m., EST, on 740 kilocycles."

Further, in my efforts to upgrade musings with creative, adult fare, I hope I can talk you into contributing once again. The teeny-boppers stuff is okay, but there's nothing like good, intelligent narrative to entice some of the other veterans into the contributing fold ... and to set the example for the youngsters. I also intend to reproduce your first paragraph in toto in the bulletin! It was beautiful!

Gordy and I both hope that we can get together with you some time, and discuss possible improvements in the bulletin. Obviously, you read it closely, hi!

Thanks again for the report ... pardon me, that's the first thanks this letter ... and best wishes for continued fine DX.
