Country's latest crisis is losing NY

Yet another edition of country "WYNY" is biting the dust (there's probably a country song in there somewhere), and Nashville's Music Row is facing bad news. Big City's decision to go Spanish on its failed New York-area quadrocast is bad for country music sales, bad for concert ticket sales, and it deprives Nashville of promotional opportunities in the country's biggest market. But playing devil's advocate:

New York was never country's biggest market. And maybe the fast-changing demographics of New York and other big metros like Los Angeles mean that country is truly being squeezed into a niche. Some New Yorkers hope that Infinity will ditch talk on WNEW (102.7) and pick up the banner for country. We won't be shocked if Infinity does a format flip on 102.7 – but maybe it's not ready to do country.

Remember when we thought FCC Chairman Michael Powell would re-visit newspaper-broadcast cross-ownership by year-end – of LAST year? Now the Powell FCC signals that it might get to cross-ownership by the end of 2002. And Michael Powell tells a Harvard audience that far from being the rip-out-the-pages kind of deregulator, he's a "good, middle-of-the-road moderate" on media

issues. And insists he's not an ideologically-driven deregulator. M Street believes him. There's no doubt that Powell's also hearing the public-interest clamor about too much consolidation, including the radio sector. But he says most Americans don't actually care about media concentration, per se: "I do have regular Americans who write me complaining about the concentration of the media and

WASHINGTON THIS WEEK

Sen. Hollings says he was just joking about wanting to "eliminate" FTC chairman Tim Muris.

No, the Senate Democrat hasn't been watching too many episodes of "The Sopranos." His spokesman



says Fritz Hollings was speaking in jest when he made the controversial comments to Advertising Age. But they underscore the growing feud between the two men. Hollings has been battling the FTC over its handing-off of media deal reviews to the Justice Department (at the behest of President Bush). The South Carolina Democrat is the chair Senate **Appropriations** Committee, which oversees the FTC's budget, and he's been talking about cutting staff positions out of Muris' budget. Muris says he's "surprised that Sen. Hollings, being such a strong advocate of consumer protections, would consider a measure that would virtually eliminate the FTC's ability to protect consumers." Meanwhile Hollings is refusing to meet with Muris. Hollings says "What action would I meet with him about? I am opposed to FTC giving on communications [mergers]."

FCC finally busts a Brooklyn pirate FM operator.

A knock on the door by U.S. Marshals have finally ended broadcasting career of Paul Dorleans maybe. The FCC says Dorleans was running an unlicensed FM on 87.9 in Brooklyn, NY, and they'd paid him a number of visits warning him to power down - but he kept broadcasting. This time the feds came with a warrant and left with all of Dorleans' broadcast equipment. It's worth noting that the agents had seized his equipment once before - but Dorleans was easily able to jury-rig a new set-up. M Street continues to hear from broadcasters frustrated at how long it takes the FCC to actually shut down a pirate.

Everybody's got ideas about the FCC's proposed new EEO rules.

AFTRA wants public hearings on age discrimination, to accompany the new third-edition and hopefully legal - EEO AFTRA claims women and minorities have been knocked out of jobs disproportionate numbers consolidation, deregulation and industry cutbacks. Meanwhile a coalition of 45 groups asks the FCC to toughen up the proposed EEO rules, contending that Internet job postings aren't enough, and word-of-mouth recruitment is ineffective. The Minority Media Telecommunications Council, NABOB, American Hispanic Owned Radio Stations and others petition the FCC to require broadcasters to prove they're doing more to recruit women and minorities. They want managers more involved with the EEO outreach, as well as doing a better job with discrimination complaints. The coalition also asks the FCC to require placement of EEO records on the Internet for public review. The FCC's Second Notice of Proposed Rulemaking on EEO is an effort to adopt rules that will finally clear the courts maybe.

The newest SEC Commissioner will be El Dorado Communications principal Roel Campos.

Bush finally takes Sen. Tom Daschle's advice from last January, and nominates Democrats Campos and former SEC General Counsel Harvey Goldschmid to take the vacant seats on the Securities and Exchange Commission. Before Campos and Tom Castro founded El Dorado, Campos was an assistant U.S. Attorney in Los Angeles. He and Goldschmid should enter Washington wearing asbestos suits – the SEC is juggling the investigation of Enron and Arthur

The "old boy network" is alive and well in the NFL - and so is territoriality.

No sooner had the Charlotte Business Journal hit the street, with a story about the Washington Redskins soliciting Charlotte



affiliate for Redskins football - than they pulled back faster than a dropback quarterback during a blitz. Right in the backyard of the Charlotte Panthers, the Skins were practically giving the games to Infinity's WFNZ for about \$2,000 a season. That's peanuts, compared to the huge marketing fee that Clear Channel's WRFX pays the Panthers. "Poaching" isn't supposed to happen in the NFL.

After a six-year fight, a California judge awards Sacramento's KWOD (106.5) to Entercom.

State Superior Court Judge Sheldon Grossfeld had previously ruled that KWOD licensee Royce International was in breach of contract, and then he heard testimony from expert witness Larry Patrick and Entercom exec John Geary — and ordered Ed Stoltz to file the FCC paperwork to transfer modern rock KWOD to Entercom. That's what Entercom's been seeking since it cut a deal with Stoltz in 1996, a deal Stoltz has been resisting ever since. Entercom will place \$25M — the originallyagreed-on price — in escrow. \$15M of that will be released immediately to Stoltz. The balance remains while the damages are being worked out. Stoltz can appeal Grossfeld's ruling, but it looks as if Entercom may finally take ownership of KWOD by this Summer.

Arbitron needs to romance Nielsen to get the People Meter into the marketplace.

The People Meter is Arbitron's top new business priority — but it's trying not to push Nielsen too fast. Talking to analysts, CEO Steve Morris says there's a "continued high level of investment in PPM", but says the "easy part" of the development is over. Now begins the intensive analysis of the numbers. Wilmington-Philadelphia testing partner Nielsen will also give the financials a thorough review before deciding whether to proceed with



Arbitron. "No decision is going to be made before mid-summer," says Morris, who's using the gentle approach with Nielsen: "Too much pressure on our part would be counterproductive."

Arbitron's also got romance on its mind for its Webcast Ratings services.

With webcasting threatened by the May 21 Library of Congress/ Copyright Office decision on streaming fees - and the drying-up of online ad dollars - Arbitron is searching for a partner for its Webcast Ratings. Steve Morris tells analysts "We have narrowed our focus," but he's looking to partner with another company on the effort. They've lessened the amount spent on the Webcast Ratings — \$250,000 less in Q1, compared to last year. Morris, however, insists he hasn't succumbed to the "rampant pessimism" on webcasting.

Would you run paid ads for the Saudi-funded "Alliance for Peace and Justice"?

Sandler & Innocenzi, the Arlington, VA-based firm that's handling the account for the Saudi Arabian Embassy, says it placed buys on about 100 U.S. stations, and the pro-Palestinian ads have reportedly aired in markets like Denver, Atlanta, St. Louis, Tampa, Milwaukee, Phoenix, and San Francisco. Also Cincinnati - though Clear Channel's WLW and WKRC pulled them after receiving complaints. reports Enquirer columnist John Kiesewetter. Five other Clear Channel stations (WEBN, WOFX, WVMX, WCKY and WSAI) continued to air them - though Randy Michaels tells Kiesewetter he required the spots to run with a disclaimer that the message "does not reflect the views" of the station. Michaels says "the copy was reviewed before the spots aired. We sell issue advertising if the content is not too inflammatory." But he says he left the decision to clear the Alliance ads up to each station. A Jewish leader in Cincinnati charges the Alliance ad is "intentionally deceitful", because while it satisfies the FCC's sponsor ID requirement, "It doesn't say who sponsored the ad."

At nearly \$10 million a year, did Fisher over-pay for the Mariners?



Fisher's KOMO is paying just about what Infinity's

WCBS paid to get the Yankees - and Seattle is a far smaller market than New York, and the Mariners have struck gold only recently (unlike the Yanks). The Seattle Times says Fisher's bid "overwhelmed the KIRO people." Entercom's Steve Oshin tells the paper the

Andersen, and also options accounting for execs. Like the FCC, the SEC operates with five members, with three members (including the chairman) coming from the party that controls the White House. The FCC continues to do business with just four Commissioners, as Sen. Trent Lott wages a vendetta over the Senate's failure to confirm his friend Charles Pickering as a federal judge. The Commission should have a second Democrat to make up a full complement. Footnote on El Dorado: Campos is free to take the SEC post because he and Tom Castro are selling

Houston's KQQK and KEYH to Liberman for \$30M, and cashing out themselves and their investors. (Full story in "Transactions.")

Chairman Powell takes the highpercentage shot, and the FCC asks the full D.C. appeals court to re-hear TV and cable ownership rules.

The FCC asserts that it's "an issue of exceptional importance" and we'll bet the D.C. Circuit Court of Appeals does agree to reconsider the case that FCC Chairman Michael Powell lost back February. That double-

bidding "blew past" the line of profitability, "and that still wasn't enough" to match KOMO. Fisher's Bill Krippaehne was obviously willing to pay whatever it took to wrest the hot Seattle baseball franchise away from KIRO, which has held it for the past 18 seasons.

Why is ABC suddenly buying affiliates for Radio Disney?

Because it has to. Jacksonville, Mobile, Kansas City, Norfolk, Flint, and now Wichita — Those are all markets ABC's bought stations in, just in the last month. Why? Convincing owners to add Radio Disney can be a tough sell - Kids radio is a different



paradigm from typical AM formats like sports or standards. You don't live off of selling fourweek flights of spots — you go

the local **McDonalds** marketing group and pitch 12month packages for nontraditional marketing sponsorships. And you don't get an immediate revenue hit. Disney knows how to do it. Michael Eisner and radio chief John Hare are backing Radio Disney to the hilt - but this recent buying spurt means they've concluded that covering the entire country is going to require a much higher proportion of O&Os. So - they're buying. You'll read about several recent acquisitions in "Transactions."

Houston, TX

Just days after El Dorado's Roel Campos is nominated to the SEC and after El Dorado exercises its purchase option on ranchera KEYH (850) following a sevenvear LMA - El Dorado sells KEYH plus its "Tejano 107.9" KOOK to Liberman for \$30M. Those two stations are all that's left of the ambitious Hispanic media group that at various times owned stations in Los Angeles, Miami and Dallas, plus Houston. KQQK is a full Class C licensed to Beaumont, and KEYH, Houston has 10-kw day and 180 watts night. In its LMA for KEYH, El Dorado has been paying \$31,693 a month, of which \$26,693 was applied toward the purchase price. El Dorado's paying \$727,307 to consummate the purchase from Artlite Broadcasting. Now, going forward, the buyer of the KQQK/ KEYH combo is veteran Spanish operator Liberman Broadcasting, whose other Houston operations include regional Mexican simulcast KQUE (1230) and KJOJ (103.3). Brokers: Houlihan Lokey for seller El Dorado, and Kalil & Co. for Liberman.

Kansas City, MO

ABC pays \$3.8M for a future Radio Disney O&O in Kansas City, which will replace the financial talk format of KPHN (1190). KPHN has a robust 5-kw daytime signal, non-directional. But a less-impressive 250-watt nighttime directional signal. It should work just fine for Radio Disney. Brokers are Bill Schutz and John Pierce.

Wichita, KS

Another ABC purchase on behalf of Radio Disney, as John Hare prepares to buy sports KQAM (1480) from Entercom. It's a decent signal — 5-kw day,

1-kw night, directional both day and night. KQAM's been doing sports since it pulled out of a simulcast with country "Kissin' 102" KZSN in the Fall of 1997. The 1480's recent ownership history includes Triathlon, a limbo period in the Capstar Trust II, and then on to Entercom.

Honolulu, HI

Cox Radio's Bob Neil is giving up an AM in Honolulu, reports the Honolulu Star-Bulletin's Erika Engle. Cox deals KCCN, a 5-kw fulltimer at 1420, to Hawaii businessman Duane Kurisu. Cox retains KCCN-FM, which means Kurisu needs new calls for the AM under the FCC rules.

Birmingham, AL market

Don Crawford gets a fourth Birmingham station, and it's AC "Spot" WRRS, Cullman, AL (101.1). Seller is STG Media, which has only owned the FM for a couple of years. Crawford adds WRRS to its existing cluster: contemporary Christian WDJC, talk WYDE and standards "Legends 1260" WLGS. Broker was Mike Bergner.

Newton, IL

Terry Forcht buys hot AC "Hits 103.5" WIKK from S. Kent Lankford. WIKK is a Class B1 (25-kw at 328 feet). Forcht files this \$600,000 cash deal as V.L.N. Broadcasting, and his Key Broadcasting owns 18 other stations in Kentucky, Illinois and Indiana. Broker: Louisville-based Ed Henson.



It's not politics as usual

M Street sees a lucrative new advertising category: national and statewide political ads, made possible by the huge geographical reach of some of today's groups and also by Arbitron's new "national database" product, which we'll start to see in July and August with the release of the Spring Arbitrons. Clear Channel's Lowry Mays tells analysts that by using CC's "trading zone" organizational structure, "for the first time we can put together a package for statewide candidates that offers them enormous reach as well as frequency." Tops on the list is Texas, a state gearing up for hugely expensive gubernatorial and senate campaigns. Other states where Clear Channel is looking for a bump in political spot sales include Florida, Ohio, California, and New York. Statewide races can now be pitched using the new Arbitron cross-market software - by groups with strong regional concentrations like Cumulus, Citadel, Nassau, NextMedia and Commonwealth. For radio. it's no longer "politics as usual" - at least in the sales office.

Two format trends to watch

Dance music has never gone away, of course, but the pitched battle between Cox and Beasley in Miami and the new Spanish Broadcasting English-language "Party" in San Francisco are both bringing it more attention from programmers. Any resurgence in dance is usually bad news for mainstream CHR, which is comprised of hits from dance, pop and rock. And indeed CHR is experiencing a paucity of mass-appeal tunes, while the dance scene is thriving. Meanwhile, Bonneville has basically replicated its Chicago "Drive" soft classic rock format in San Francisco - replacing the former mainstream KZQZ. M Street issues its usual cautionary note about copying new formats: Radio tends to copy other stations incompletely. "The Drive" is more than just tossing in an oldies by the Monkees, and allowing songs to nearly run out, and featuring what Airplay Monitor's Sean Ross calls

Wall Street hears a "happier tune" from radio stocks

They love us, they love us not now they love us again. Radio stocks are back "in" on Wall Street, as radio is leading the recovery of media stocks in terms of revenue and earnings bouncebacks. (Radio is clearly ahead of outdoor.) Analysts are raising their estimates, and the financial press is paying attention to radio again. WASHINGTON THIS WEEK

If you doubted the FCC was serious about re-instituting EEO, this should clear up the confusion.

Michael Powell - yes, Republican Chairman Michael Powell - has just scheduled an unusual "en banc" meeting of all four Commissioners, key FCC



staffers and outside experts. That's on the docket for June 24, and if you can't be there, you can monitor it live on the web at "www.FCC.gov." AFTRA had recently asked the Commission to hold just such a hearing, and it turns out that one was already in the works. A reminder that the FCC is still taking reply comments on its EEO rulemaking (FCC 01-363) until May 29.

Women and minorities are getting pinkslipped in disproportionate numbers, claims AFTRA—especially at upper levels. That's why the American Federation of Television and Radio Artists (AFTRA) has filed in support of the FCC's new EEO rules. The union says since the D.C. Circuit



Court ruled the EEO regulations unconstitutional last year, it has witnessed a marked increase in the number of women, minorities, and those over the age of 40 losing their jobs.

And this claim is surprising: AFTRA says upper levels of management have been especially impacted. Also: AFTRA wants the FCC to add age discrimination to its next set of EEO rules, saying it's seen an increase in the number of older broadcasters fired. The union asks the FCC to continue investigating charges of discrimination inside the agency, instead of deferring to the Equal Employment Opportunities Commission. It would also like a station's public file to include information about its outreach and recruitment efforts — data that would be compiled for an annual industry report on employment diversity.

The FCC is strict with Viacom: It can buy independent KCAL-TV in Los Angeles for \$650 million, but must spin off an L.A. radio station within six months.

In markets with at least 20 independentlyowned media voices, you can own two TV stations - but just six radio stations. FCC Chairman Powell wasn't inclined to give Viacom/infinity more than six months to divest. Commissioner Copps says he expects Viacom to find a buyer and file the deal to sell one of Viacom/Infinity's seven radio stations without having to ask for an extension. All-news KFWB (980) may be the station in the on-deck circle - but we're sure Sumner Redstone and Mel Karmazin will try everything to prevent that from happening. And especially so since KFWB is slated to get the Dodgers starting next season (after five years at Clear Channel's KXTA). Once again, Michael Powell demonstrates that he's not intent on tearing up the media ownership rules.

N/4B BROADCASTERS Hands off, says the NAB.

In its reply comments on the FCC's local ownership proceeding.

NAB contends the Commission has no authority to restrict radio cluster size. It contends that Congress already set the limit — and besides, NAB argues that consolidation has been a good thing, and not anti-competitive. It disputes the filing by the United Church of Christ, and says the public interest group has failed to present concrete evidence that consolidation is harmful.

A non-compete bill appears headed for passage in Arizona, following 2 to 1 votes in the state House and Senate.

Banning non-compete clauses in radio and TV employment contracts is one of the top items on AFTRA's agenda this year, and on the heels of its success in Illinois, it appears close to getting a bill in Arizona. The House vote was 39 to 18 — almost exactly the same 2 to 1 margin by which the Senate had already approved S.B. 1042. The legislation now needs just a cursory final vote in the Senate before moving on to Governor Jane Hull for signing.

Venture capitalists and other radio backers are pushing for further cutbacks.

a screeching halt to There's acquisitions at most companies - ask the brokers - and that leaves some toplevel people vulnerable to budgetcutting because of their big paychecks. The most recent victim is Ivan Braiker, President/COO of New Northwest Broadcasters. Braiker's deal-making talents are no longer in demand, since NNB hasn't done any acquisitions since early 2000 - and somebody noticed that, at the level of financial backer. We're also seeing cuts at the operational level, as New Northwest lops off the job of VP/ programming and operations Scotty Brink. Over at Citadel, Farid Suleman continues to hack away at the "salary" line of his budget, with a couple of regional execs gone along with VP/ programming Ken Benson and the corporate sales training initiative. One dealmaker tells M Street that "most venture capital firms think in five-year timelines, and New Northwest was founded in 1998." In the case of Citadel - it's widely expected that Ted Forstmann at Forstmann Little is looking to sell it or merge it, and it's not interested in waiting even five years.

Dramatic changes in U.K. media ownership laws could attract U.S. broadcasters.

Clear Channel or Infinity would be able to buy a station on its own without a local investor as partner. A CC spokesman tells M Street "If it does become law, we believe that it provides opportunities for both buyers and sellers of radio properties and we will evaluate our position at that time." Viacom says it welcomes the UK's move toward deregulation. One company that won't be heading across the pond is Emmis. Kate Healey tells us "While we are extremely pleased with the successes we have experienced in Buenos Aires and in Hungary, our primary focus continues to be radio in the United States."

That's what those who follow agriculture spending tell M Street though there's no way to know for sure. since there's no firm that tracks it. What we do know is that a major consolidation in the ag chemical business is hurting advertising. For example, two more big players (Beyer and Advantis) just announced plans to merge. Meanwhile, bio-genetics has sent other familiar names in the ag business belly-up. One ag ad rep says that five years ago there were 40 major advertisers — and today there are about 20. He points to one client that cut its radio ad budget from \$1M a year to \$80,000 this year. Gene Millard of Eagle Radio's Ag-Info Network tells M Street "the chemical companies have spent so much time with internal organization that they're just trying to get a handle on their size." Consequently, advertising fell

CBC a verdict for \$9.5 million. For ABC, that's better than the first jury's award of \$20 million, back in 1998. But ABC is still interested in

contesting the outcome. A Minnesota judge rejected the 1998 award, which was later reversed by a higher court, and then Children's principal Chris Dahl got back into court for a trial on just the charges of breach and trade secrets. ABC's Julie Hoover tells the Minneapolis Star-Tribune that ABC "intends to seek further review" of the

latest verdict. So — it's still too early to write "The End" to this strange fairy tale about kids radio.

Bill O'Reilly brings new visibility to radio.

We thought it was a smooth debut on May 8, and Bill is a natural for radio – something that you just can't tell until the show actually hit the air. All the stink about how Westwood gained affiliates (or didn't) raised by Matt



Drudge probably just generated more publicity and tune-in for O'Reilly. And Bill stuck to his promise not to focus on politics, but to spend time

on social issues and general-interest topics, including his second-hour "no spin zone", a feature unique to his radio show. Westwood was clawing for affiliate clearances and is having trouble keeping Detroit (with Crawford's WLLZ balking at a mere one-year deal). But the publicity's good. And the fact that Crawford likes the show enough to try to lock it down for a two-year term tells you that they want it. Talent moving to radio is a good thing - and we predict O'Reilly's radio venture will also be a boon to Fox News Channel. Meanwhile, the NAB knows a good thing when it sees it, and has booked Bill O'Reilly to keynote the NAB Radio Show in Seattle.

Jimmy Swaggart's group is re-focusing away from FM translators and toward full-power stations.

His broadcast associate David Whitelaw phones M Street to explain why the Family Worship Center Church is





The Arizona Broadcasters Association says the bill amounts to government interference in the private sector. And Rep. Carol Somers, a Republican from Tucson, tells the Arizona Republic the bill will hurt smaller stations more: "They are vulnerable to having their best people hired away."

18 LPFM stations are now on the air - quietly.

That's the latest count from Christian Community Broadcasters, which is tracking the LPFM rollout very closely. CCB's John Broomall tells M Street that 256 construction permits have been issued out of the 3,249 applications filed. So far, 134

sets of call letters have been issued and 100 applications have been dismissed. The latest grants all belong to the State of Colorado: There's a 107.9 in Aspen, a 99.1 in Gunnison and a 107.9 in Leadville.

Pirates may not get a shot at LPFM licenses, after all.

This could be a win for the NAB: The full D.C. Circuit Court of Appeals has agreed to rehear its own ruling that favored former pirate operators. Congress got tough in the "Radio Broadcasting Protection Act" and wrote language into the law prohibiting any pirates from obtaining a Low Power FM license. But in February a three-judge panel of the appellate court said the ban

was too broad. The FCC sided with broadcasters on this one, and it asked for, and has now won, a re-hearing before the entire court.

Cox Radio's Dick Ferguson will receive this year's NAB National Radio Award in Seattle.

A popular choice: NAB Radio EVP John David says Ferguson is "Radio inside and out, and he's led the way in helping solve regulatory, political, technology and financial issues for our business." The NAB Radio Show runs September 12-14 at the Seattle Convention Center. Last year's National Radio Award recipient was Citadel's Larry Wilson, who's now out of a job. We don't expect that will happen with Cox Radio's Dick Ferguson.

withdrawing over a hundred FCC apps for translators: It's "far from pulling back", he says. Instead, the group is going for full-power facilities where possible. In fact Family Worship Center has bought six full-power stations since November. Whitelaw says it makes sense to devote resources that way instead of the more than 100 translator CPs the group's holding. If you think Swaggart's group has been busy in the past, you're right: Whitelaw says "in the past 20 months we've installed 51 translators, all over the country, from

California to Key West." Now the church is looking for faster ways to get more coverage. Are there some bigger deals ahead?

Talk America gives listeners a "Second Thought"

IDT-owned syndicator Talk America adds the Mort Crim stable of talkshows, which brings it Mort's five-minute daily "News You Care About" and his "Second Thoughts." Interep and SBS prepare "SBS/Interep" Interep and Spanish Broadcasting System agree to re-structure Hispanic rep specialist Caballero Spanish Media as "SBS/Interep" – with possibly more input from SBS, we'd conjecture. Current clients of Caballero, such as Mega Communications, come along under the SBS/Interep banner.

Saginaw-Bay City, MI

Big-dollar deal here, worth \$55.5 million, and a textbook case of consolidation and cashout by Wicks-backed Wilks Broadcasting. In fact, Wilks literally doubles its money by dealing its fivestation cluster to Cumulus, which has stations in nearby Flint (and actually used to own one of the five stations it's acquiring from Wilks). By M Street's math, Wilks Broadcasting assembled its cluster in three separate deals for just under \$26 million. If \$55.5M sounds like a lot of loose change for Saginaw — it's about a 12-times-cash flow price. That's based on what we hear is cash flow of about \$4.6M to \$4.7M. Here's the history: In 2000 Wicks-based Wilks Broadcasting acquired news/talk WSGW (790), soft AC WGER (106.3) and hot AC "Fox" WTCF (100.5) from Citadel for \$16,180,000. It then tacked on country "Moose" WCEN-FM for another \$6M and urban WTLZ for \$3.75M. There was once a WCEN-AM, by the way: It was a news/ talker licensed to Mt. Pleasant, MI at 1150 and is now dark. Broker on the Wilks-Cumulus deal: Mike Bergner.

Amarillo, TX

Former owners and operators Norm Feuer and Herb McCord turned heads by partnering up and committing \$3 million to acquire "La Picosita" KPQZ (100.9) from the court-appointed receiver. Since they left active ownership, Feuer and McCord have been working quietly behind the scenes as consultants, and plotting their return to operator status. Now the Amarillo

Globe reports that "Feuer-McCord Communications" has won a judge's approval to buy the assets of KPQZ. It's been under the control of court-appointed receiver Roger Cox, who last year was asking the judge to keep onetime owner Coco Medina and her supporters at least 150 feet away from the station. The most immediate previous owner was Mandujano y Asociados. The receiver retains control until FCC approval — though Cox hopes to work out an LMA with Feuer (pronounced "FOY-er") and former Granum principal McCord.

Another sale in Arbitron market #191 -

The FM that's the "Home of the Blues" is getting a new owner. Chuck Brooks-led Amigo Broadcasting – ultimately related to Marcos Rodriguez — pays \$1.1M for the combo of "Twin Tens" talker KTNZ at 1010 and "Home of the blues" KBZD, a class C3 at 99.7. And yes, KBZD really does program blues music. KTNZ has 5-kw day, 500-watts night, DA-2. Seller is the Acker family's Metropolitan Radio Group. Mark Acker took over the company when his father Gary Acker died in August 2000. Broker: John Pierce of John L. Pierce & Co.

Mobile, AL

Thanks to a lawsuit, an Alabama jury and a Virginia bankruptcy judge, Mobile's three-year-old ownership mess is finally over. The result? Cumulus gets oldies WAVH, while Ken Johnson gets adult alternative "92 Zoo" WZEW. The \$7 million sale of the two Baldwin

Broadcasting FMs should end the bitter feud that started when Baldwin principal Barry Wood fired GM Bill Phillips and Phillips filed a lawsuit in 1999 claiming that Wood had made a verbal agreement to give him 40% ownership. Last year a Mobile County Circuit Court jury agreed with Phillips. The stations wound up in Chapter 11. There's finally a resolution in the U.S. Bankruptcy. Court for the Eastern District of Virginia - and it came as an agreement between Wood and Phillips. The Mobile Register reports the final settlement and says 73% of the \$7 million sale represents the price Cumulus is paying for "Oldies 106" WAVH, Daphne, AL. That works out to \$5,110,000. Meanwhile Ken Johnson, as "Dotcom Plus", pays \$1,890,000 for adult alternative "92 Zoo" WZEW, Fairhope. Baldwin's Barry Wood tells the Register "The truth is, if it had not been for the Phillips lawsuit I would not have had to sell." But he did, and Phillips says "I got what I was due." "Oldies 106" WAVH becomes the sixth local station for Cumulus, joining the cluster of urban WBLX, hot AC WYOK, black gospel WGOK, urban AC WDLT-FM, and all-news WDLT. The other Baldwin station goes to longtime Mobile-market GM and owner Ken Johnson, who adds "Zoo 92" to his sports FM, WNSP.



Experimenting with talk

Big clusters pull big shares


New M Street study: Who's winning the cluster wars? The Big Guys, mostly, based on M Street's analysis of cluster shares from the Winter 2002 Arbitrons for continuous-measurement markets. Clear Channel owned the toprated cluster in 47 markets. It was the #2 cluster in another 32. Total those up, and CC was either the #1 or #2 cluster owner in 79 Winter book markets. Meanwhile Infinity was the top cluster in 14 markets. Citadel was #1 in 7 markets. Cox was #1 in 5 markets. Entercom was #1 in 4

markets. And we're not kidding when we say "big shares": In nearly half the Winter markets, the top two clusters did a 50share or better. In Toledo, Cumulus and Clear Channel pulled a combined 71.2. The top two players in New Orleans, Louisville, Mobile, Des Moines, Jacksonville, Shreveport, Honolulu, Little Rock and Greenville (NC) did at least a 60-share between them. Some smaller owners are hanging in: Journal wins in Omaha and Wichita. AGM is #1 in Bakersfield. QueenB is

The Summer Forecast: Heavy merger rumors

Remember way back in 1999 and 2000, when radio stock prices were soaring along with revenues, and groups were gobbling up mom-and-pop operators - and talking about mergers and "rollups"? Well, that's back. Not as strongly as before, but that environment is back, and if you're working for somebody other than the Big Two (CC and Infinity), chances are you'll be hearing merger or big-deal rumors. Could Citadel and Entercom merge? Citadel and Cumulus? Big City and anybody? Radio revenues still aren't back to boom times, but stock prices are firmer - and that gets Wall Street thinking about M&A activity: merger and acquisitions. Why? Partly because Wall Street can bank fat fees for their M&A services. So get ready for another round of rumors from the Rumor Mill - this Summer and probably well into Fall.

WASHINGTON THIS WEEK

Infinity can't change the FCC's mind over a \$2,000 fine for playing "You Suck" on L.A.'s KROQ – and here's why you should care.



This is a case you should watch, because of what's at stake in future in decency complaints.

Infinity's not really fighting so much over the \$2,000 fine — it's probably more concerned about the FCC's process. The complainant didn't offer a tape or complete transcript, either of which the FCC usually requires before moving ahead. Instead he cited the lyrics from the CD, leaving doubt whether an edited version aired. Since Infinity didn't produce an aircheck, the FCC staff went with the complainant. The Enforcement Bureau later upheld the fine, so Infinity took it upstairs to the Commissioners. But the Eighth Floor rules that the listener's signed statement was enough. It's convinced by the letter's inclusion of indecent words from the unedited version of Consolidated's "You Suck." If that's what's going to happen in future cases - airchecking is an option some operators will reluctantly embrace. As for KROQ-FM licensee Infinity, it can pay up — or go to the courts.

Indecency activists pay a house call on Michael Powell.



They claim 8,000 people have filed indecency complaints triggered by what they heard on radio and TV— but never heard back from the Commission. They

even had the names of the 8,000 complainants. A coalition of 18 religious groups met with the FCC Chairman on May 23 to discuss their concerns that he's not doing enough to crack down on radio and TV indecency. Powell vowed to look into their allegations, but didn't offer to step up scrutiny of radio and TV content. Among the groups were Focus on the Family, Morality in Media, the Christian Coalition, and the Southern Baptist

Convention. Once again, M Street notes that Powell does not seem anxious to get into content regulation.

Senator Hollings forces the Bush Justice Department to abandon its scheme to split up merger reviews.

There's an important anniversary here: the one-year anniversary, just past, of Vermont Senator Jeffords defecting from the Republican Party to become an independent. That action gave



Hollings enormous power, because it made him (again) Commerce Committee Chairman. M Street previously reported Hollings' threats to use his power to cut the pay of DOJ employees — and now Assistant AG Charles James surrenders. James says it's still "good public policy" to give the DOJ merger review authority for radio, TV, cable, newspaper, publishing, advertising and music, while sending other industries to the Federal Trade Commission. The FTC is an independent agency (like the FCC) that's perceived to be less tied to the Bush Administration. Hollings charged in a recent hearing that "this administration has run amok."

After 10 months, the FCC finally clears the \$90M Nassau-Millennium deal at the Jersey Shore.

As you read along with the FCC's 17page opinion, you become convinced they're about to send this app straight to the paper shredder. The staff dwells on the impact on the advertising marketplace and says Millennium would hog 64% of the local ad share in the Jersey Shore areas where these five stations operate. Then - the opinion gives Charlie Banta what he wants. His Millennium Radio Group can acquire WOBM (1160), WOBM-FM (92.7), WADB (1310), WJLK-FM (943.) and WBBO (98.5). Lawyers will be watching the logic and using it in their own filings, because the FCC states that it believes listeners will benefit from Millennium's statewide radio network based in the newsroom at WKXW, Trenton ("New Jersey 101.5"). Not surprisingly, Commissioner Michael Copps voted against the Nassau-

EAS will get a thorough check-up from the FCC's new Media and Security Reliability Council.

And a lot of broadcasters tell us it's overdue. A Council workgroup chaired by NBC president of network operations John Eck is specificallycharged with reviewing ways to get news out to the public after an attack or disaster looking at whether the Emergency Alert System is effective. M Street's hearing a growing chorus of dissatisfaction with some parts of EAS — and not just from radio. We know of one major-market TV GM who's steamed over how cable systems handle EAS, by completely blacking out his signal.

Homeland Security czar Tom Ridge



will keynote the June 10 NABEF symposium in D.C.

His talk sets the tone for the day, which explores ways broadcasters and the government can work together

in the face of tragedy. Ridge is the former Pennsylvania governor who's now the director of the Office of Homeland Security — and not wielding a lot of clout at the bureaucratic level, though he's got plenty of friends. Former New York City mayor Rudy Giuliani will be on hand for the annual awards ceremony to honor the public service efforts of broadcasters. The National Association Broadcasters Educational Foundation symposium will be held Monday, June 10 at the Reagan Building in Washington, D.C.

The next big People Meter issue is — money.

Arbitron hasn't disclosed how much the People Meter's going to

cost, and some potential customers are getting nervous. Steve Morris and Owen Charlebois may be working on pricing plans, but some operators tell M Street they're



concerned about the potential "surcharge." They feel the important Wilmington-Philadelphia field testing makes radio the guinea pig for the People Meter product development. In their minds, radio's cooperating to build a product that Arbitron will use to romance Nielsen into signing an agreement covering TV and cable. And there's no doubt on that score: Arbitron must have an outside partner to make a go of the People Meter. There are about a million issues revolving around the People Meter — and some of them have dollar signs on them.

June 20 is the new red-letter date for webcasting.

Webcasters got a one-month reprieve from the Librarian of Congress, but his cryptic statement of May 21 has left all combatants wondering what his "final decision" will be on June 20. So. could a voluntary settlement be the next step in the fight over webcasting royalties? Kurt Hanson of Save Internet Radio tells M. Street that RIAA's member record labels have a reason to settle: "They have an interest in getting airplay to promote their records and selling their records." There have been rumors of the RIAA with meeting individual webcasters to reach an agreement. We suspect that effort may step up rather quickly in the next few weeks. It may be that Librarian of Congress James Billington's decision to reject the proposed CARP royalty rates propels the

record industry and webcasters toward hammering out an agreement without government interference.

Clear Channel is asking its employees to support its lobbying efforts by forming a PAC.

The "Clear Channel Political



Action Committee" will be used to lobby on CC's behalf in Washington and beyond. Like just nearly every

other corporate PAC, San Antonio is asking its rank-and-file employees to make a contribution, under the rules of the Federal Election Commission. That money will, in turn, be used to support candidates and causes that are seen to benefit Clear Channel. In a letter to employees, Chairman/ CEO Lowry Mays calls the formation of CCPAC "long overdue." The move may also signal that the company is tired of being the punching bag for consolidation. Mays says "The new CCPAC will give us the tools to work on issues that are important to us."

AFTRA wins another one, as Republican Governor Jane Hull

signs a state-wide non-compete ban in Arizona.

Shehad misgivings, apparently. Her spokeswoman says "The governor had a lot of questions



about why should government be looking at private contracts in business arrangements, but she finally decided that negotiations should actually be true negotiations with people able to put ideas forward and not be handed



Millennium deal, asserting that the combination of stations will make it impossible for any new competitor to take on Millennium.

Here's why the music industry wants a federal probe into payola allegations.

Radio has found a way to put record company payments to stations on the books legally, with exclusive contracts with independent promoters — and the record industry doesn't like it one bit. Labels, artists, and several unions have asked Congress and the FCC to update federal payola laws for the first time since the scandals of the 1950's. They are "deeply concerned about payola and payola-like practices,

as well as the problems caused by radio station ownership consolidation. New rules must be written by the FCC to prohibit payments from 'independent promoters' unless such payments are announced." The letter's signed by the RIAA, AFTRA, American Federation of Musicians, and others. It's estimated the record industry spends \$150M to \$300M a year in payments to indies – but nobody really knows for sure.

After screening for pirates, the FCC accepts 192 more LPFM applications.

It took more than 11 months, but the FCC has finally processed all the apps filed during the fourth LPFM filing window, which dates back to June 2001. The courts can be blamed

for part of the delay: A D.C. Circuit Court ruling said that a provision in the **Broadcasting Preservation Act** barring former pirates from obtaining LPFM licenses is unconstitutional. Although the Commission is appealing that decision, it was forced to go back through the apps to determine if any were pirates. The latest batch covers stations in Oregon, Tennessee, Texas, West Virginia, Vermont, and the U.S. Virgin Islands. Most are in small towns, and most have been filed by religious organizations. The FCC is accepting petitions to deny through June 24, so M Street makes the usual suggestion: check 'em out.

something, take it or leave it." That's what AFTRA was saying. The Arizona Broadcasters Association lobbied hard to kill the bill, which passed both House and Senate by 2-to-1 margins. AFTRA continues to wage its state-by-state fight to prohibit non-compete clauses in employment contracts for radio and TV.

This buyer is paying the seller's FCC fine, to get the deal done.

We've seen lots of unusual things in sale contracts, but this one has KRQX/KYCX-FM buyers Robin and Susan Cholopisa agreeing to "pay a Commission citation heretofore levied against the stations in the amount of \$3,000." Guess everybody wants things to go smoothly to closing for the country simulcast combo in Mexia, TX, east of Waco. The Cholopisa's MJ Communications is also going to pay off Groveton Broadcasting's \$10,000 bill to ASCAP, plus some debts to the landlord and others. Beyond those items, this station sale for KRQX (1590) and KYXC-FM (104.9) is worth \$100,000 at closing.

The principal of seller Groveton Communications is Hughes Dillard.

Macon, GA

Cumulus starts writing big checks in the Southeast again, and this time it's for the dominant U.S. Broadcasting cluster that has literally done 60% of the market revenue in years past, according to Jim Duncan. We'll watch to see how the FCC staff treats the proposed transfer of this formidable eight-station combo: "Good times, great oldies" WAYS (105.5); black gospel WDDO (1240); "Best Country" simulcast WDEN (daytimer at 1500) and WDEN-FM (99.1); "News/talk 940" WMAC; CHR "B95.1" WMGB; classic hits "Rock 92.3" WMKS; and AC "Z93.7" WPEZ, licensed to Jeffersonville. M Street remembers that Doug Grimm-run U.S. Broadcasting did some business with Radio One last year that produced an Atlanta move-in, and now it's selling its entire Macon cluster. Brokers: Tom McKinley and George Reed of Media Services Group, for the seller.

Fremont, OH

Six weeks after selling his WFRO-AM (900) to ABC for Radio Disney duty, Tom Wolfe deals the FM half of his "Nines" combo to James Lorenzenrun BAS Broadcasting for \$1.3M. That's WFRO-FM, a class B1 at 99.1. The selloffs break up a simulcast with an unusual name: "The Nines", so-called because of the frequencies of 900 KHz and 99.1 MHz. Broker is the same as for Wolfe's AM: Greg Guy of Patrick Communications.

Jamestown, NY

For \$5.9 M, Jim Embrescia's Clevelandbased Media One Group — which includes his brother Tom Embrescia and onetime Cleveland owner Lee Zapis acquires soft AC/talk WJTN (1240) and hot AC "Mix 93.3" WWSE. Seller is James Broadcasting, now run by Michael Goldman, the son of the late founder Si Goldman. WJTN's got the unusual facility of 500-w day and 1000-w night, non-directional - more power at night than days. WWSE is a class B FM. Broker: Pittsburgh-based Rosenblum. And talk about heritage: Simon "Si" Goldman owned WJTN from 1940 until he died in 1999 – an amazing 59 years.

New Orleans, LA

Clear Channel and Wilks swap FMs in the Crescent City, plus a check for \$12.5M. JeffWilks just recently acquired classic rock WRNO-FM (99.5). Now he's shuttling it off to Clear Channel. What does Wilks get out of this? Modern rocker KKND, Port Sulphur (106.7) from the large Clear Channel collection of stations there. Plus the \$12.5M cash. M Street notes that the FCC has – inexplicably – red-flagged this deal, which is a swap of very similar technical facilities.

Breckinridge, MN

KBMW's slogan is "A Friend You Can Count On" — and its new best friend is

David Benjamin of Triad Broadcasting. He's paying WB Broadcasting \$2.5M to add KBMW (1450) to his cluster. That's not all: Triad will do a Joint Sales Agreement with its sister, oldies KGWB, Wahpeton, ND. KGWB is taking steps to upgrade from a Class A to a C2 and change frequencies from 107.1 to 106.9. To make things more complicated, WB principals Thomas Vertin and Robert Comstock are simultaneously buying out the stake of current GM Dean Aamodt and Jay Schuler.

U.S. Virgin Islands

A classic rock station named "Mongoose" is worth \$1 million to buyers Richard and Rita Friedman, who obviously like the weather in the Caribbean. That's because they own romantica WMDD, Fajardo, Puerto Rico, and now they're adding Jonathan Cohen's WVPI. It's licensed to Charlotte Amalie, and it's a Class B at 104.3.


Clovis-Portales, NM

For \$1,150,000, Steve Rooney's "Rooney Moon Broadcasting" is acquiring Sandi Bergman's three properties in the Portales valley, on the Texas border. Those are hot AC "Mix 107.5" KSMX, a class C1 licensed to Clovis. And the Portales-licensed combo of "1450 Gold" adult standards KSEL, with 1-kw fulltime, plus "K-Sell Country" KSEL-FM, a Class A. Broker: Doyle Hadden.


