Radio's chance to shine



For all the bashing radio's taken in the press mindless morning stunts, show

indecency, payola and consolidation in general - it's nice to see radio be a hero, in several recent cases involving the Amber Alert system. M Street's written about this EAS-based system for broadcasting child abduction alerts for over a year now. But suddenly politicians have discovered it and it's being adopted from coast to coast. It's truly a chance for radio to shine in public service - even if some state lawmakers are trying to dictate specific details of its implementation. And even if law enforcement authorities don't activate it soon enough (five hours elapsed between the time police got to the Quartz Hill abduction site and the activation of the alarm about the two kidnapped California teenagers on August 1). Putting the system in place can be a pain - but building good relationships with local authorities is a good thing. And performing a public service like rescuing a kidnapped child is why the FCC still hands out those licenses.

WASHINGTON THIS WEEK

Field agents are taking Summer field trips – so be prepared for a drop-in visit.

The cynical theory – we've heard it for years – is that the Commission sends out field agents this time of Summer to find violations that will bring in cash to the FCC's piggybank before the end of the fiscal year (September 30). That's always seemed like an Oliver Stone movie plot to us – but if an FCC field agent is demanding maintenance logs and rattling the lock on your transmitter fence, the motive really doesn't matter, does it? Suffice it to say that we've heard from numerous states that the FCC's on the move. And remember: neatness counts. If things look orderly and well-managed, the visitor's more likely to decide that things are okay.

A sampling of recent FCC fines:

On just one recent day, the Enforcement Bureau handed down these fines - WRHC, Miami owner WRHC Broadcasting was fined \$4,000 for failing to have working EAS equipment. KPOI, Honolulu owner New Wave Broadcasting was fined \$2,000 for failing to transmit the required monthly EAS test. KNAK, Delta, UT owner Sam Bushman was fined \$7,000 for failing to have a locked fence around the station's antenna structure. And those NALs fit the recent pattern: Lots attention to EAS, both the system and the records for requred tests. Lots of attention to the public file (and it's important to train those up-front to know where it is and how to access it on a timely basis). And lots of attention to transmitter sites - gates, fencing, locks, etc. There's also apparently a new focus on RF human exposure limits at tower farms, but the recent Mt. Wilson happenings merit a whole story, another time. Speaking of fines, but not radio-related ones: the FCC's proposing a \$5,379,000 fine against "Fax.com" for violating the "junk fax" prohibition.

Pleading poverty helps cut M&R Enterprises' fine in half.

Back on April Fools Day, the FCC fined WESL, East St. Louis, IL (1490) after two staffers refused to show the public file to three different members of the public on two separate occasions. M&R didn't contest the fine, but in its response to the FCC it said it's a small station in a highly-depressed area. After reviewing M&R's tax returns for the last three years, the Enforcement Bureau agreed.

It cut WESL's fine from \$10,000 to \$5,000. By the way: we've seen the Commission turn down similar pleas because the licensee failed to produce the financial back-records the staff asked for. M&R did the right thing by producing all three years of its tax returns.

VOA governors say "Don't mess with our credibility."

Outgoing Broadcasting Board of Governors Chairman Marc Nathanson and BBG member Norm Pattiz quickly fire off a response to a report from the Council on Foreign Relations. Sure, they say, it's important for America to get its message out to foreign countries. But Nathanson says the BBG shouldn't be part of the proposed new "Public Diplomacy Coordinating Structure." You'll be hearing lots more about "public diplomacy." It's something Washington has been getting failing grades at lately (witness polls showing America's growing unpopularity in the Middle East and Europe). The BBG governors say that for reasons of journalistic integrity and credibility, they shouldn't be sitting with Colin Powell, Donald Rumsfeld and other key cabinet members to formulate America's public message. The BBG oversees Voice of America, Radio Free Europe/Radio Liberty, Radio Free Asia and Radio/TV Marti. Just in: the Senate approves former VOA director Ken Tomlinson as the new Chairman of the nine-member Broadcasting Board of Governors.

Two Commissioners and counting (with one invitation ready to mail).

The NAB Radio Show's traditional breakfast with Commissioners will offer at least Kathleen Abernathy and Mike Copps. At presstime, the NAB hadn't announced whether Kevin Martin will also make the flight to Seattle. And we're waiting to see whether Chairman Powell books the trip. Meanwhile, Commissioner-in-waiting Jonathan Adelstein bides his time, waiting for a Senate vote on his nomination to become the FCC's fifth Commissioner, and its second Democrat. He performed smoothly in front of Sen. Inouye's subcommittee hearing and got the Commerce Committee's endorsement - but Senatorial politics have kept him from getting confirmation from the full Senate. That could come in September - just around the time of the NAB Radio Show.

THE TAYLOR REPORT

Philadelphia's new "Sunny 104.5" will be a timely lab test for the Arbitron People Meter.

Clear Channel's flip of the former hot AC "Alice" WLCE to soft AC "Sunny" is the first real format



change in the market since Arbitron began its PPM testing. (Radio One adjusted WPHI from urban to dance earlier this year.) Researcher Julian Breen says it's an "exciting opportunity" to see potential listening shifts in the August People Meter results. Breen figures there's a lot of FM dial-scanning, and that should earn the new WSNI some curiosity tune-in. "Sunny" launched with a celebrity endorsement from Barry Manilow. Whether Barry knows it or not, his music (and even concert ads) can't be heard on Jerry Lee's marketleading AC, "B101", WBEB. The AC marketing scramble is well underway: Clear Channel bought a round-the-clock schedule of 10-second spots on Infinity's all-news KYW (1060), whose GM says he wouldn't have taken the buy if "Sunny" were competing with an Infinity sister station. Meanwhile Gary Berkowitzconsulted AC WMXW (95.7) has its own plan, we're sure - and master marketer "B101" is reportedly opening its checkbook for a big new TV campaign. Julian Breen's working theory is that the People Meter will pick up the swings ahead of the diary – which relies partly on recall.

October 20 is the deadline to mail webcasting royalty checks, and soon only the big guys will be left in webcasting.

200 small fry are already extinct, and it could soon be 10,000, thanks to the new webcasting royalties. RAIN's Kurt Hanson tells USA Today just about all of the 10,000 webcasters will go dark, "with the exception of Yahoo, AOL, Microsoft and other deep-pocketed conglomerates who can afford a loss leader." The first checks must arrive at the Copyright Office on October 20. And remember that this is a retroactive situation, as webcasters eventually pay for all webcasts dating back to 1998. How about a congressional cavalry rescue? Rep. Rick Boucher (D-VA) says don't expect help any time soon. Boucher says "Any legislative process will be staunchly opposed by the people who benefit from the high and exorbitant rate." In other words, the Recording Industry Association of America, SoundExchange, the group formed by the RIAA to collect the royalties. Sound Exchange's John Simson says they'll try to work out a deal before the October deadline. And Congress is in its Summer recess. There was another deadline, just past: the August 7 deadline for webcasters to appeal the CARP webcasting royalty rates to the U.S. Court of Appeals.

Susquehanna plans to be a webcasting survivor.

While other broadcasters are pulling their webcasts down off the net, Susquehanna has just signed new streaming and adinsertion agreements for all their markets. Adsertion Technologies will provide exclusive ad-insertion services, and the compnay (which recently purchased the CoolLink Broadcast Network assets) will provide its server-side ad targeting, replacement, and delivery tools, and automated back-end technology. For streaming, Susquehanna has inked an agreement with ChainCast Networks as its bandwidth provider. Susquehanna says they're sticking with the Internet, because listeners demand it. Susquehanna is simulcasting 29 stations on the web - and was a very early believer in streaming, dating back to even before the "Merge" radio/streaming simulcast in Dallas, which debuted around Labor Day 1999.

Sirius fast-forwards to secondgeneration chipsets for satellite radio. Makes sense: Both it and rival XM were headed toward newer, more powerful chipsets, and Sirius has a much smaller installed basis — so it may be able to claim a technological advantage over XM, which got to market sooner and has a much larger customer base. Sirius CEO Joe Clayton says the new Agere Systems 0.13 micron, 6-layer metal technology-based chipsets will shrink the size of the digital portions of the receiver circuitry "to the size of a credit" card - from the current videocassette-size. He claims the secondgeneration chipsets are not only smaller, they use 50% less power and have better thermal management - so they'll reduce Sirius' cost of manufacturing by almost 50%. Both XM and Sirius have taken hits from Wall Street analysts concerned about

the financial plans - but both have their marketing machines in gear.

Frank Osborn is back as a buyer with "Qantum" [sic].

Yes, the veteran station owner and operator wants to be distinctive, and he isn't spelling the group name the usual way, which would be "Quantum." But CFO Michael Mangan assures us they're pronouncing it the standard way. The new group includes former Aurora Communications President/CEO Frank Osborn. Former Aurora exec Michael Mangan. And Frank Washington, the Sacramento-based attorney and station owner. Aurora recently sold its suburban New York and southern Connecticut stations to Cumulus, after a stalled deal with Nassau. With Qantum, Osborn and company are targeting "medium and smaller-sized markets." Qantum Communications has backing from Banc of America Capital Investors and Nautic Partners, LLC. Phone number for "Oantum", based in Stamford, CT: (203) 388-0048.

Future watch: iBiquity wants to develop a radio version of Tivo "ondemand" content.

Digital radio developer iBiquity has acquired an exclusive worldwide license to Command Audio's intellectual property and technology for on-demand radio listening devices. The acquisition has set the stage for radio broadcasters to provide consumers content-on-demand, including options that will allow users to listen to their favorite radio show at a time convenient for them - though we predict this is far in the future. What may be more immediately possible is service add-ons so listeners can retrieve information about specials offered by advertisers, or station promotions and PSAs. iBiquity has established a Redwood City, California office and hired the former software engineering employees of Command Audio to develop the technology. Financial terms were not disclosed. Ibiquity CEO Bob Struble says they plan to integrate the Command Audio technology with their digital AM and FM system. That will give broadcasters the ability to offer additional ad-supported content, like news, weather, or traffic, along with their current audio. It's something else to ask the iBiquity folks



about next month - at the NAB Radio Show in Seattle, September 12-14. M Street will be there to cover it for you.

You can't listen to a basketball game without benefiting from Chick Hearn's wordsmithing.

Legendary L.A. Lakers announcer Chick Hearn just died at 85 (of damage to his brain stem following an August 2 fall at his home). But what a wealth of language he leaves behind: the "slam dunk." The "finger roll." The "air ball." The "alleyoop." And plenty more. The radio playby-play announcer's job is the make the game come alive in the listener's mind and nobody ever did that better, in any sport, than Chick. He promised to bring listeners a "words-eye view" of the Lakers, and he delivered. Numerous sportscasters use Chick's phrases (including "turnaround jumper") without knowing where they came from. So M Street wants to acknowledge Chick Hearn as a pioneer who made sports - and radio better for everybody. Just like the early traffic-reporting pioneers and their "gaper blocks", he helped create a vocabulary that makes radio useful. We need more of that.

The IEEE holds its 52nd Broadcast Symposium in the the onetime remote broadcasting home of the Mutual.

There's no big-band dining and dancing scheduled for the Omni Shoreham in Washington from October 9-11 – but you never know. The Institute of Electrical and Electronic Engineers promises everything "cutting-edge" from tutorials on DAB (in-band on-channel Digital Audio Broadcasting) to Digital TV. The IEEE also snagged the FCC's technology chief, Edmond Thomas as its keynote speaker on Thursday, October 10. More at www.ieee.org.

Sorry, XM's not looking for extra programming help on its new premium "Playboy Channel."

What's new here isn't the spicy content (get the kids out the car before tuning in the advice talk show channel) - it's the fact that it's XM's first-ever premium channel. That means it's using its addressable receiver capabilities to wring some extra money out of the subscriber (\$2.99 a month). If XM can do that with sexy talk and jokes - it could make money from a range of more mundane things. Meanwhile, XM seems to be having no trouble hitting its subscriber numbers, through the end of Q2.

Seven months after the rumor surfaced, former Radio One chief programm Steve Hegwood expands his "On Top Communications" into New Orleans. This deal, first rumored in January, is for urban KNOU (104.5), from JP Broadcasting. Seller JP is owned by the busy Chris Devine and Bruce Buzil, also the principals in Marathon Media. They get a sweet cashout: they paid \$3.5M for KNOU in December 2000. Now On Top pays them \$8.5M. KNOU is a class C2 licensed to Empire, LA.

Tuckerton, NJ

Press Communications, which recently sold "New Jersey 101.5" and some siblings to Charlie Banta for \$110M, held on to the Eatontown, NJ combo of WHTG-AM/FM. Now Press adds a second FM to the group: classic rock WBHX, a class A at 99.7 licensed to Tuckerton. The Press ownership group is Bob McAllan, Alfred Colantoni, Jules Plangere, Mark Lass and Richard Morena. Seller of WBHX, one of New Jersey's newer stations, is Beach Haven Communications (Richard Lee Harvey).

Mineral Wells, TX

West of Ft. Worth, "Radio Ranch of North Central Texas" KYXS-FM sells for \$6M. With a name like "Radio Ranch", you can be sure it's a country station: currently a class C1, and being sold by Jerry Snyder to first-time buyer "LKCM Radio Group." LKCM is Luther King, Jr., Bryan King, Chad Muir and Kevin Prigel. Jerry Snyder's holding onto his "Music of Your Life" KJSA (1120).

Ravenswood, WV

18 months after they announced they were acquiring "Golden V" oldies WMOV (1360), Larry and Susan Patrick (Legend Communications) sell the 1-kw daytimer to Dayton-based Harold Parshall. It will be his first station, and the price is \$60,000. The Patricks will retain country "Wolf" WLWF (93.), the onetime WMOV-FM. Broker on WMOV-AM: Larry Patrick.

Southeastern Indiana

Hoosier State operator Marty Pieratt grabs the traditional country simulcast combo of WSCH, Aurora (99.3) and WXCH Versailles (103.1), from John Schuler's Dearborn County Broadcasters. They're both Class A FMs in the territory west of Cincinnati. Marty Pieratt's doing this purchase under the name of Columbus Radio, which also has standards WNVI, North Vernon, IN (1460). Marty's various radio interests include country WJCP, Austin, IN (92.7) and "Wickie Country" WIKI, Carrollton, KY (95.3).

Oklahoma City, OK

The Rev. Jimmy Swaggart's operation told us earlier this year they'd be concentrating more on AMs and FMs, instead of extending their empire of FM translators. Now Swaggart's Family Worship Center Church enters Oklahoma City with the purchase of long-silent KOKC, Guthrie. It's licensed to be a 1-kw fulltime facility at 1490, and the seller is Fox Broadcasting. Swaggart's paying \$150,000.

Jonesboro, LA

This is another situation where the Rev. Swaggart's group buys currently-silent facilities. In northern Louisiana between Shreveport and Monroe, the Family Worship Center Church is paying \$200,000 for the combo of KTOC-AM/FM. In this situation, we've got one religious group operator — Bishop Willis — selling to another. KTOC-AM's licensed for 1-kw day and 175 watts night at 920 KHz. KTOC-FM is a Class C3 at 104.9.

Ashtabula, OH

We're slightly amazed, but Clear Channel locates another property to buy in an Ohio market, though this one hasn't seen the light of day yet. For \$525,000, CC's purchasing the Construction Permit for a new Class A at 98.3, from Ashtabula Broadcasting (Richard Rowley).

Forecast for the Fall: No de-reg, no re-reg.

Right now both sides are frustrated with FCC Chairman Powell — which means nothing will happen ahead of the delivery of the big "global review" of media ownership rules next Spring. Free-market conservatives may have engaged in wishful thinking when Bush named Powell Chairman early last year. Keep an eye on two major factors: #1 the Congressional elections on

November 5. If Democrats win the House, Powell will need to pay much more attention to calls for investigations into the effect of the 1996 Telecom Act. If the GOP wins back the Senate, Powell's probably got more breathing room. #2, the second major factor that's hit Powell is the D.C. Circuit Court of Appeals (where Michael Powell once law-clerked). It's now demanding strong

fact-based justifications from the Commission for its media rules. The global review is designed to build a strong record that Powell can use in his court defenses. But for now – don't expect much change. Commissioners Abernathy and Copps will be among those making the flight to Seattle for the NAB Radio Show – we'll be there to report what they say.

WASHINGTON THIS WEEK

An outraged FCC Commissioner Mike Copps wants to "fast track" the investigation of Opie & Anthony.

He even raises the specter of license revocation for WNEW, New York - though we think that's highly unlikely at the end of the day. The crusading Commissioner says the August 15 sexin-St. Patrick's stunt generated "many outraged e-mails and phone calls" and he's forwarded them all to the Enforcement Bureau with a recommendation to "consider the strongest enforcement action possible." Catholic League head William Donohue says "nothing would make us happier than for WNEW's license to be revoked." Infinity quickly pulled the controversial syndicated afternoon duo off the air and is hunkering down - even suspending GM Ken Stevens and PD Jeremy Coleman. While Infinity probably faces nothing more than a \$7,000 fine for broadcast indecency, the incident fuels the mainstream media's obsession with "shock jocks" - and gets more decency groups fired up. If you missed the story, the August 15 on-air play-by-play was closer to Meat Loaf's "Paradise by the Dashboard Light" than a baseball game. And the two participants in the alleged carnal act in the cathedral claim they weren't actually having sex.

Religious broadcasters employ a new federal law to triumph over zoning boards.

The Clinton-signed Religious Land Use and Institutionalized Persons Act of 2000 is "divine intervention in land use", Harvard Design School prof Jerold Kayden tells the Boston Globe — "It's powerful stuff." Congress and the president were probably thinking more about communities attempting to exclude churches with strict zoning laws. But it turns out the RLUIPA works just fine for religious broadcasters, too. The Globe writes up the case of Elmer Murray's Living Waters Church in Enfield, NH. He wants to build a studio for a Christian station on his 52-acre plot of land. The zoning board originally turned him down — then got a stinging education in the Religious Land Use Act.

A founder of the Amber Alert system warns against over-using it.

Tarrant County, TX sheriff Dee Anderson tells the Dallas Morning News "It's become such a magic bullet for child abduction." But he cautions "the plan works, but it's not that easy. . If you use it too often, you can lose it." The Amber Alert partnership between authorities

and broadcasters began in the Dallas area and has been championed by the National Center for Missing and Exploited Children and the NAB. Anderson was part of the genesis of the plan following the 1996 abduction and murder of 9-year-old Amber Hagerman in Arlington, TX. We've already seen Amber Alert problems in the Washington, D.C. area, after WTOP radio properly triggered an alert which got converted on some local TV stations into a "crawl" message warning about an identified potential civil emergency. Meanwhile Senators Kay Bailey Hutchison and Dianne Feinstein propose a nationwide Amber Alert - and we'll go ahead and predict an eventual Senate vote of 100 to 0 on this one. In the meantime, if you're in an area where Amber Alert is being implemented, we hope your promotion department is getting the word out to local newspapers and TV news crews. The system needs public awareness, and radio could use a little good publicity.

The FCC "dockets" the \$3.5 billion Univision-Hispanic Broadcasting merger.

That, says communications attorney John Garziglia, is a good thing: "What 'docketing' does here is to provide electronic access through the web to all filings made in this proceeding." Some Hispanic activist groups have signaled they're uneasy about combining the largest Spanish radio group with the dominant TV group. Deadline for petitions to deny is September 3, and the Docket No. is MB 02-235.

Dealmaking, not numbers, will be important in Seattle.

Any convention is having tough sledding these days, and the NAB's fighting factors like post-9/11 travel fears and the effects of consolidation (and the Viacom/Infinity pullout). But it's clear to M Street that group heads, brokers and vendors intend to be there, doing business. It's not the numbers – it's who the numbers represent.

It's admission time at "FCC University."

Both Chairman Kennard and Chairman Powell talked about the brain drain from the ranks of the FCC professionals, and the need to keep staffers clued in to the latest technology. Now Michael Powell officially announces the "FCC University" to provide in-service training to polish his agency's knowledge and skills. There will be both "generally applicable subjects", plus specific classes for engineers, economists

And the protesters

outside the convention center (and the Marconi Awards) two years ago in San Francisco certainly provided a more electric atmosphere to the proceedings (though they didn't cause any real problems that we saw). Now it's time for Seattle (September 12-14), and activists are labeling the NAB "the WTO of broadcasting." They have a list of beefs with the radio industry that includes LPFM, deregulation and payola. Amazingly, the protesters are quite public with their plans. They hope to disrupt a keynote address by Fox News/Westwood host Bill O'Reilly, the annual congressional breakfast, and the annual the **FCC** breakfast featuring Commissioners. The protests will tie in to a media conference billed as "Reclaim the Media." Says an invite: "Join us in Seattle this September as we confront the National Association of Broadcasters and their ongoing quest for greater consolidation of corporations' power over the public airwaves."

Going "off the grid" for good.

Small market non-coms, always cashhungry, continue to look at alternative methods to power the station, and several have gotten national publicity recently. Up in Woodstock country, WJFF Jeffersonville, NY (90.5) runs its transmitter from water power, using a \$100,000 hydro-generator that taps the power of a nearby trout stream. Across the country, KBSJ Jackpot, NV, (91.3) uses three windmills atop an 8,600-foot mountain (named "Ellen D") to power the 5,000-watt station. Both KBSJ and WJFF have back-up systems, and both stations' studios still run from old-fashioned electricity. Going off the electrical grid for good may be an elusive dream - but in areas where there's no practical electrical feed (Jackpot, NV) or for stations want to push the envelope (WJFF), there are some fascinating experiments going on.

The 25-54 demo continues to lose its luster with ad buyers.

Though we'd caution that it's still far too early to conclude that ad buyers are comprehending the importance of the baby boomers aging up into the 35-64 demo. The phenomenon seems to be that the long-sacred 25-54 demo buy is splintering in many different directions much like America itself. Here's the bottom line: A new Interep study finds that 44.7% of last year's national spot ad dollars went to the 25-54 demo - down from 48.5% the year before. That's a huge drop, percentage-wise, and maybe the biggest single-year decline in six years. Back in 1995 Interep estimated that various 25-54 buys together took 55.5% of national spot dollars. The "gold standard" 25-54 demo has dropped every year since then. So who's gaining? 18-49, which was #2 with 19.3% of all radio dollars, up from 17.5% in 2000. And various 35+ demos like 35-64, and 35+. They're still a much smaller piece of the pie, up from 7.7% to 9%. Interep compiled the stats using its Performax database, covering the top 25 radio markets, excluding Puerto Rico and the embedded markets of Nassau-Suffolk and San Jose.

The legendary KPIG back, RealNetworks debuts radio new subscription service. "RadioPass" may be that way



webcasters will surmount the CARP streaming-fee situation - though at the price of being in a subscription service. RadioPass is just part of Rob Glaser's highly-ambitious new "RealOne Player", dubbed the "world's first universal media player." For a monthly fee of \$9.95, RadioPass subscribers have access to thousands of Internet stations. One of them is famed progressive country KPIG in Monterey (whose website proclaims "CARP is CRAP"). RadioPass also includes "50 ad-free pre-programmed radio stations" and "instant access" to talk radio schedules. RealNetworks is betting that enough people are willing to pay for Internet radio, as well as other premium services - like the ability to burn music

onto CDs. The new software also allows users to listen to any audio using the RealOnePlayer, even if the station's using rival Microsoft's Windows Media.

A hacker boasts he's defeated the encryption of XM.

Has he truly demonstrated that it's possible to get the service without paying the \$9.95 monthly fee? The hacker's 7page pdf claims you can do it for about \$100 — though it requires the right gear and some soldering skills. The tech stuff's available on EBay, he says. After showing diagrams and photos, he says "please be aware that this is for testing purposes, not for you to avoid a payment of a service, [because] this could send you to jail. This test is to prove the XM engineers were lying about the unit to be unhackable." We've cleaned up some of the syntax, but you get the idea. This could be a nightmare for XM: Subscribers going "off-service." Even so, it's not quite as easy as changing the batteries in your flashlight. We doubt many folks would be tempted to even try this. And — there's always the chance this hacker's statement is questionable.

Entercom's Seattle employees get a choice: a raise, or they don't have to sign a non-compete.

It's a novel solution to what could have been a nasty fight between AFTRA and Entercom. After seeing some of its salespeople cross the street, Entercom asked its Seattle staff to sign new employment agreements containing a non-compete clause. AFTRA stepped in, and Entercom agreed to give a raise to any employee who signs the noncompete. AFTRA/Seattle executive director John Sandifer says "It's now an individual's choice if the additional income is worth it to them to sign the noncompete." How big a raise they get depends on how badly Entercom wants to protect the individual, and any new employee will have to sign the clause. Sandifer believes Entercom was motivated more by "competitive pressures" than by recent efforts in the state legislature to ban non-competes. Entercom's cluster includes news/talk KIRO, talk KNWX, and business news KQBZ.

Consolidation hits the wall.

And that situation won't change until money and egos start loosening up. Precisely the same 10 groups in almost exactly the same order were in Jim Duncan's Top 10 list of "Highest Billing Groups" in both 2000 and 2001 a phenomenon we certainly didn't see in the consolidation-crazy late-

1990s. In the 2001 top 10, the only difference in ranking is that Radio One bumped Emmis out of #7 place. The same faces kept most of the same places in the top 35 ranking, too: Beasley's up from #15 to #13. Regent moved #27 to #20. Lotus went from #28 to #25. And Pamal debuted at #31. What's going on?

It's not just about money – or the lack of it, in the form of slumping stock prices and capital markets "not cooperating", as one expert tells us. The brokers say it's very much about "control issues" - in other words, CEOs can't agree on who would be #1 in a rolled-up group.

and lawyers. It's a new age of "adult learning" at the Portals.

Is Bush venting his anger at VOA by cutting foreign bureaus?

Or is the plan to close bureaus in Hong Kong, Mexico City, Tokyo, Brussels and Geneva just belt-tightening? VOA's news division angered the White House last year by airing part of an interview with Taliban leader Mullah Mohammed Omar. The Washington Times — usually attuned to the White House - quotes a VOA staffer saying he and his colleagues believe "the news cuts are in part a

vendetta by some Bush administration officials" over the Mullah Omar interview. The bureau shutdowns aren't a done deal - Congress would have to approve them.



Failure to register and paint towers costs WLVA \$12,000 —

even though it's silent.

The FCC says then-licensee Madison Broadcasting Group didn't maintain the

five radio towers once used for Lynchburg's WLVA (590), and it doesn't care that the station was off the air. The FCC says none of the five towers had the required registration numbers posted, and the field agent found the paint faded and chipped. Madison just sold WLVA to Kovas in a deal that closed in June and despite pleading a shortage of funds. it's still liable for the standard \$12,000 fine. Once again, this is a case where the licensee didn't supply sufficient evidence to document its financial situation. If the Commission asks for something like the last three years worth of tax returns - don't submit just one.

Spanish-language broadcasters keep the pressure on Arbitron.

"Methodology" is the word that inevitably pops up - and Radio Unica's Joaquin Blaya was just the latest group head to complain about it in his Q2 conference call. Entravision had the same gripe on its call. It's a thorny question because it involves finding Spanish-dominant speakers. Getting them to agree to participate in a survey (something they may be suspicious of). Then adequately capturing their listening. You'd think the People Meter would be a great solution since there's nothing to write down and no issues about literacy or language But Spanish-language problems. broadcasters have an even bigger fear about that: Will Spanish speakers be especially reluctant to be "tracked"? That's one reason the groups want a

second test market besides Philly, which isn't a typical big-city Hispanic market.

"XM Satellite" entries are showing up in diaries — and Arbitron's counting them.

Counting them as "radio listening", that is, contributing to "PUR" (Persons Using Radio). XM is probably years away from "making the book" by meeting Minimum Reporting Standards. But we've talked to a researcher who spotted several diary entries for XM — one for over a hundred quarter hours. And the diarykeeper wrote down specific channel numbers and had enthusiastic comments. Arbitron's position is that unlike Internet-only radio, XM and Sirius are FCC-licensed broadcasters. They're selling themselves as radio. So they should be in the measurement soup along with AMs and

FMs. You always see enlightening things when you do diary reviews (a good idea) - don't be surprised if you see something that Arbitron codes as "XMSR-FM."

Peter Smyth will chair RAB2003 and says "New Orleans is a great convention town."

For its \$5.5M, NextMedia gets a nice cluster of 3 FMs and I AM: ESPN affiliate KVSO, Ardmore (1-kw fulltimer at 1240). "Texoma Country" KKAJ-FM, Ardmore (Class CI 95.7). Hot AC KYNZ, Lone Grove, OK (going to Class C3 at 107.1). And classic rock KTRX, Dickson, OK (Class A at 92.7). NextMedia told analysts on its August 6 conference call that it had acquisitions in both radio and outdoor chambered and ready to go in the next 30 days. They weren't lying. Broker: Doug Ferber of Star Media Group for seller Chuckie Broadcasting (Ken Taishoff).

Jonesboro, AR

Ed Christian sails into Jonesboro with the acquisition of 3 FMs from Pressly Partnership Productions for \$12 million The new stations are rock "Z100" KDEZ (a class C2 at 100.5). Country "Fox" KDXY (a C3 at 104.9 licensed to Lake City). And AC "Mix" KJBX (an A at 106.7 licensed to Truman). Pressly says its three management team members —Trey Stafford, Bill Pressly and Kevin Neathery — will continue operating their local group and become stockholders in Saga. Meanwhile senior partners Bob and Betsy Pressly are retiring. And yes, Bill Pressly is Bob's son. Saga's also inheriting an Internet newspaper named NEALink.com. Bob Mahlman steps

up to say he repped Saga – and the FCC quickly red-flagged these transfer apps.

Milwaukee market

Filling an important void, ABC is paying \$2.6 million to get Radio Disney into Milwaukee, via expanded-band WKSH, Sussex, WI (1640), which will convert from contemporary Christian. Like almost all expanded-band facilities, WKSH has 10-kw days and I-kw nights, non-directional. Seller is L&L Pewaukee Ventures.

Laredo/McAllen-Brownsville, TX

Tom Castro's buying again, it seems. We thought the El Dorado principal would be out of the ranks of ownership following the closing of the sale of KQQK, Houston to Liberman — but M Street spotted Castro's name as the president of Border Media Partners. And Border is a buyer, picking up FMs in Laredo and McAllen-Brownsville, which both qualify as "border" areas of Texas and Mexico. Seller is Sendero Multimedia, and the Laredo station is KBDR, Mirando City (class C2 at 100.5). Over near the Gulf, the McAllen-Brownsville station is KILM, Raymondville (class B at 102.1). They're both doing the same format — regional Mexican, as "La M" — because they're simulcasting. Castro and partner Rafael Garza are paying \$8M for the two markets.

Pittsfield, MA/Hoosick Falls, NY

In the scenic Berkshires, Tele-Media sells its combo in Pittsfield and an FM near Bennington, VT to Vox Radio (Jeff Shapiro and Bruce Danziger) for \$4.3M cash. The Pittsfield combo is talk/sports WBEC at 1420 (1-kw fulltime) and hot AC "Live 105" WBEC-FM, a Class A at 105.5. The Bennington property is "Point" WZEC, Hoosick Falls, NY, a class A at 97.5. Broker: Frank Boyle.

Fargo, ND market

Midwest operator Tom Ingstad strikes a deal for recent oldies convert KVMI, currently a Class A at 96.7 licensed to Arthur, ND. The play here is that licensee Vision Media's got an app to upgrade KVMI to a C3 on another frequency (103.9). Tom Ingstad is making Jim Babbitt's Vision Media a \$150,000 construction loan to do the upgrade. Then Ingstad pays another \$650,000 at closing, for a total of \$800,000.

South Bend, IN

Say goodbye soon to "Cow Country" on WGSN, Ligonier, IN. John Dille's Pathfinder is paying GBC Media \$550,000 for the class A at 102.7. We suspect they'll drop country and perhaps go AC. Seller GBC Media retains its Warsaw, IN combo of WRSW (sports) and WRSW-FM (classic hits).

The Other Las Vegas

Yes, there's one in New Mexico, too. Meadows Media (William R. Sims and Don Davis) will acquire "New Mexico's Fun Country" KFUN and AC KLVF for \$1 million. Seller is KFUN/KLVF Inc. (Dennis Mitchell). KFUN is a full-timer 1-kilowatter at 1230. KLVF is a class C3 at 100.7.
